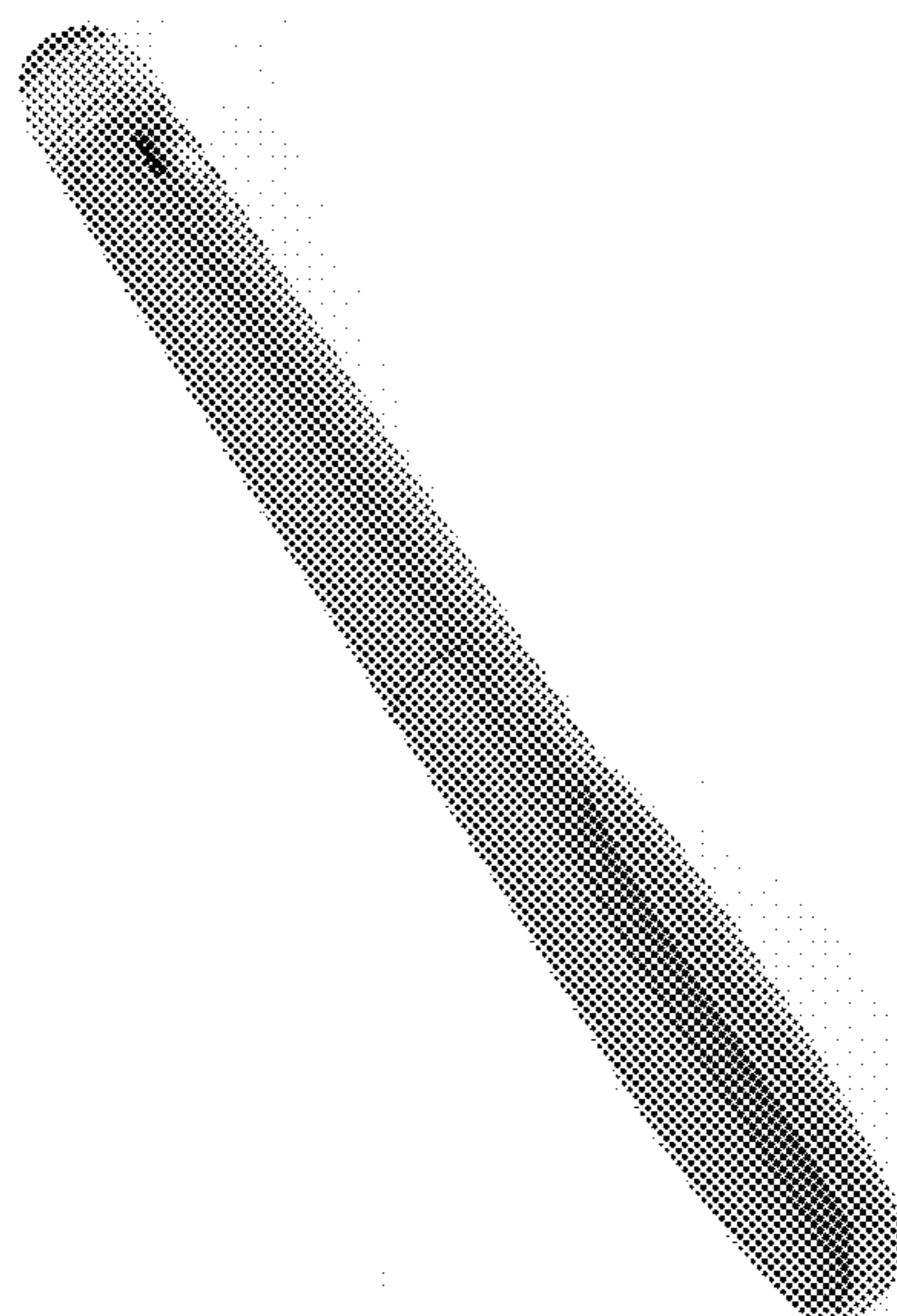
The ornamental design for a drug delivery device, substan-

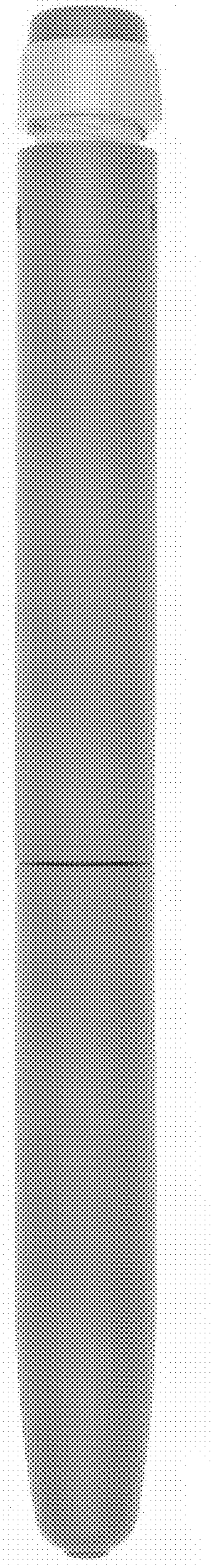

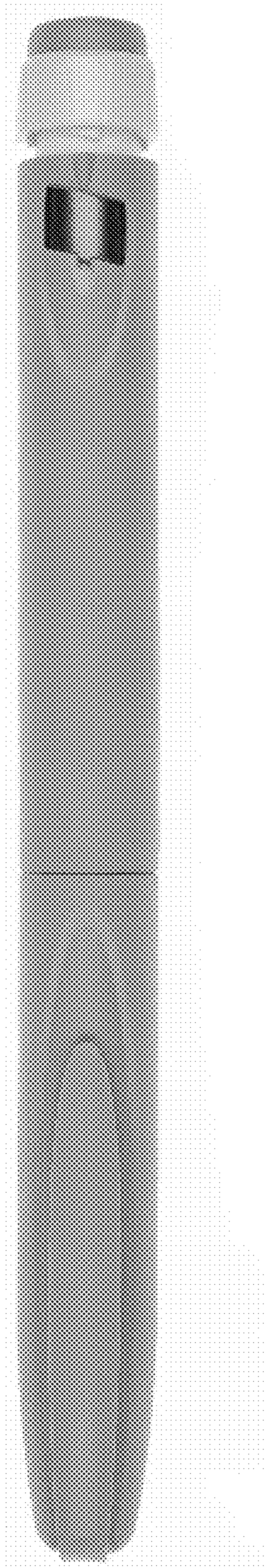

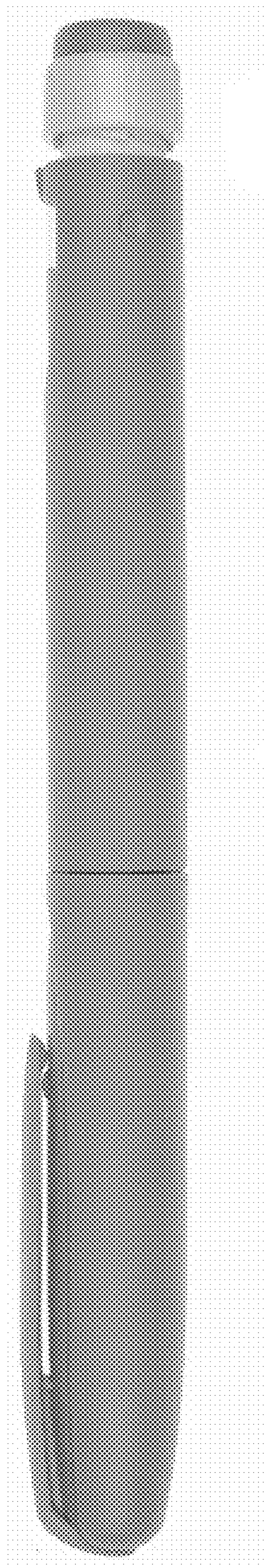

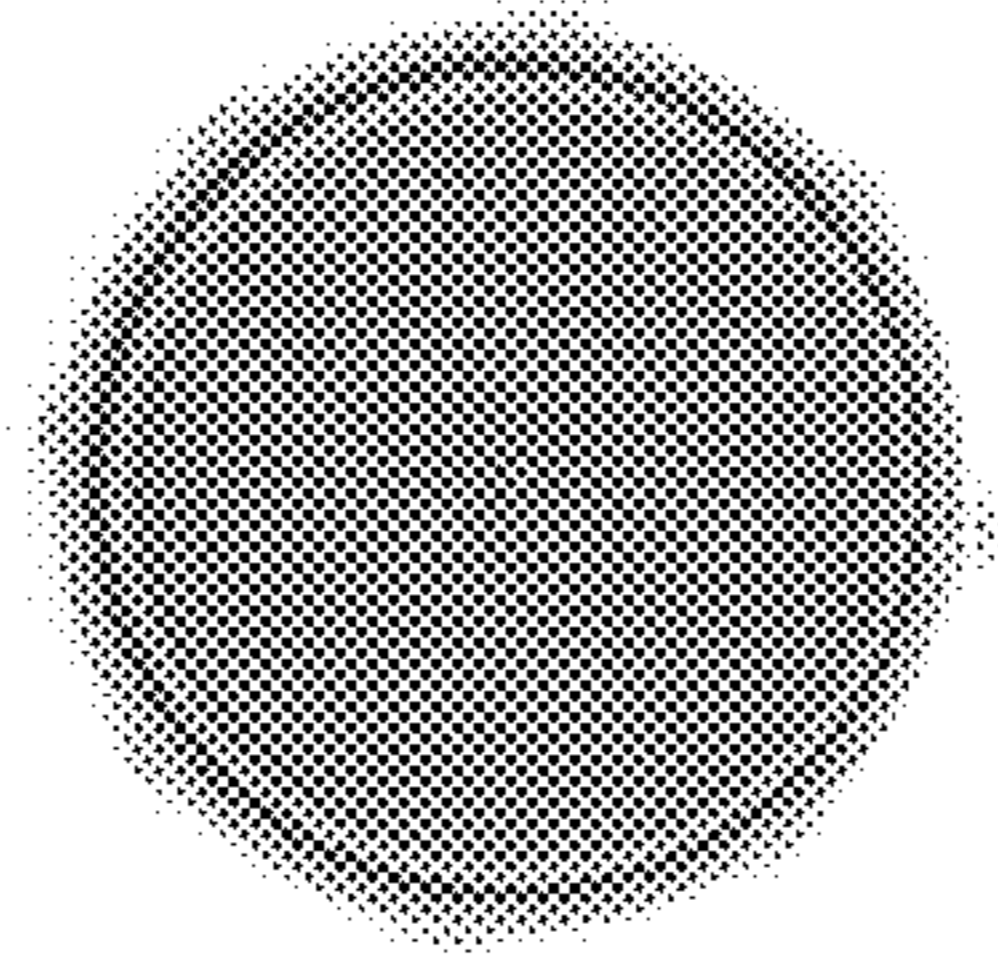

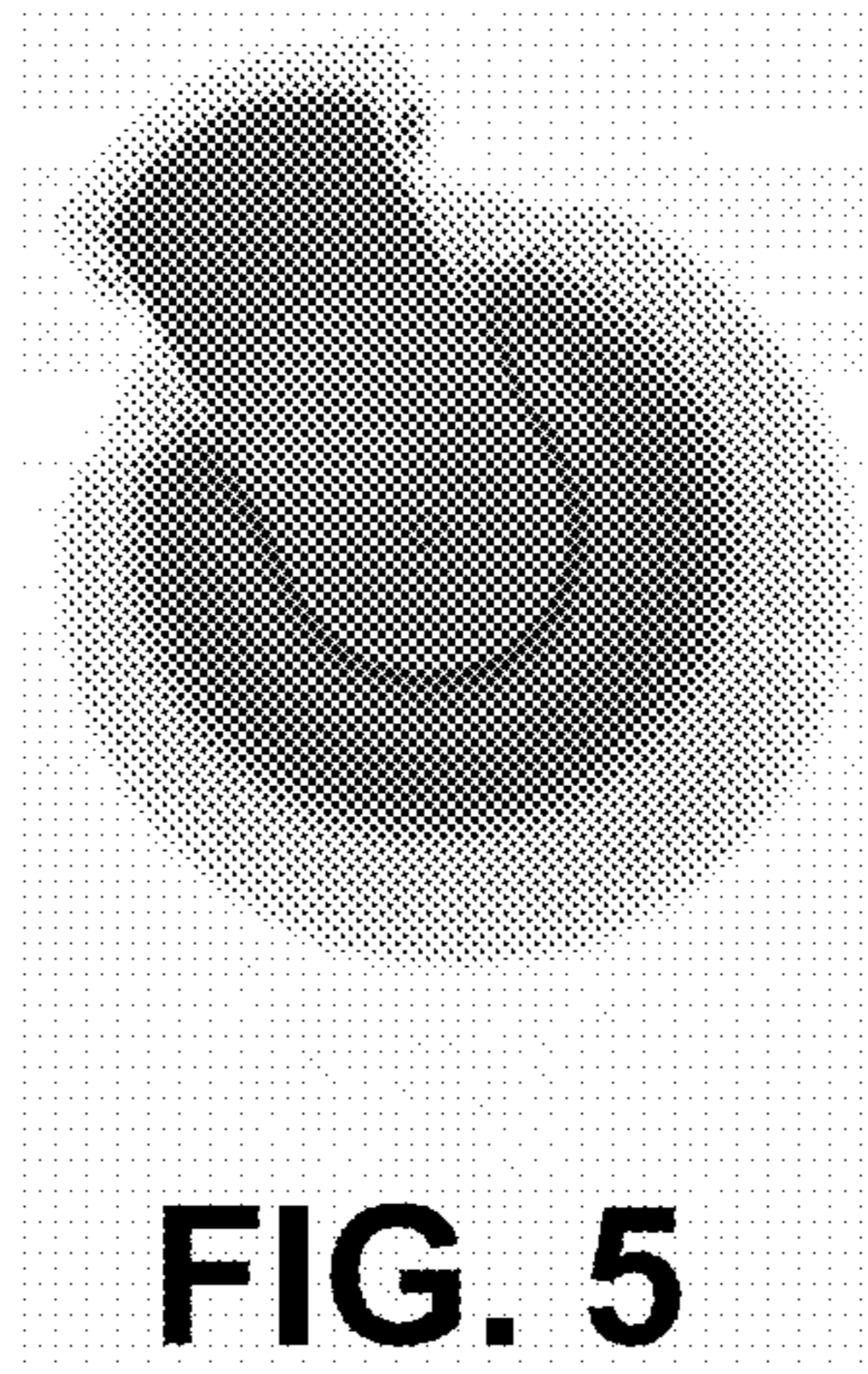
