(57) **CLAIM**

I claim the ornamental design for a hair piece and clip, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of a hair piece and clip; FIG. 2 is a lower perspective view of the design shown in FIG. 1;

FIG. 3 is a front plan view of the design shown in FIG. 1; FIG. 4 is a rear plan view of the design shown in FIG. 1; FIG. 5 is a left side plan view of the design shown in FIG. 1;

FIG. 6 is a right side plan view of the design shown in FIG. 1;

FIG. 7 is a top plan view of the design shown in FIG. 1;

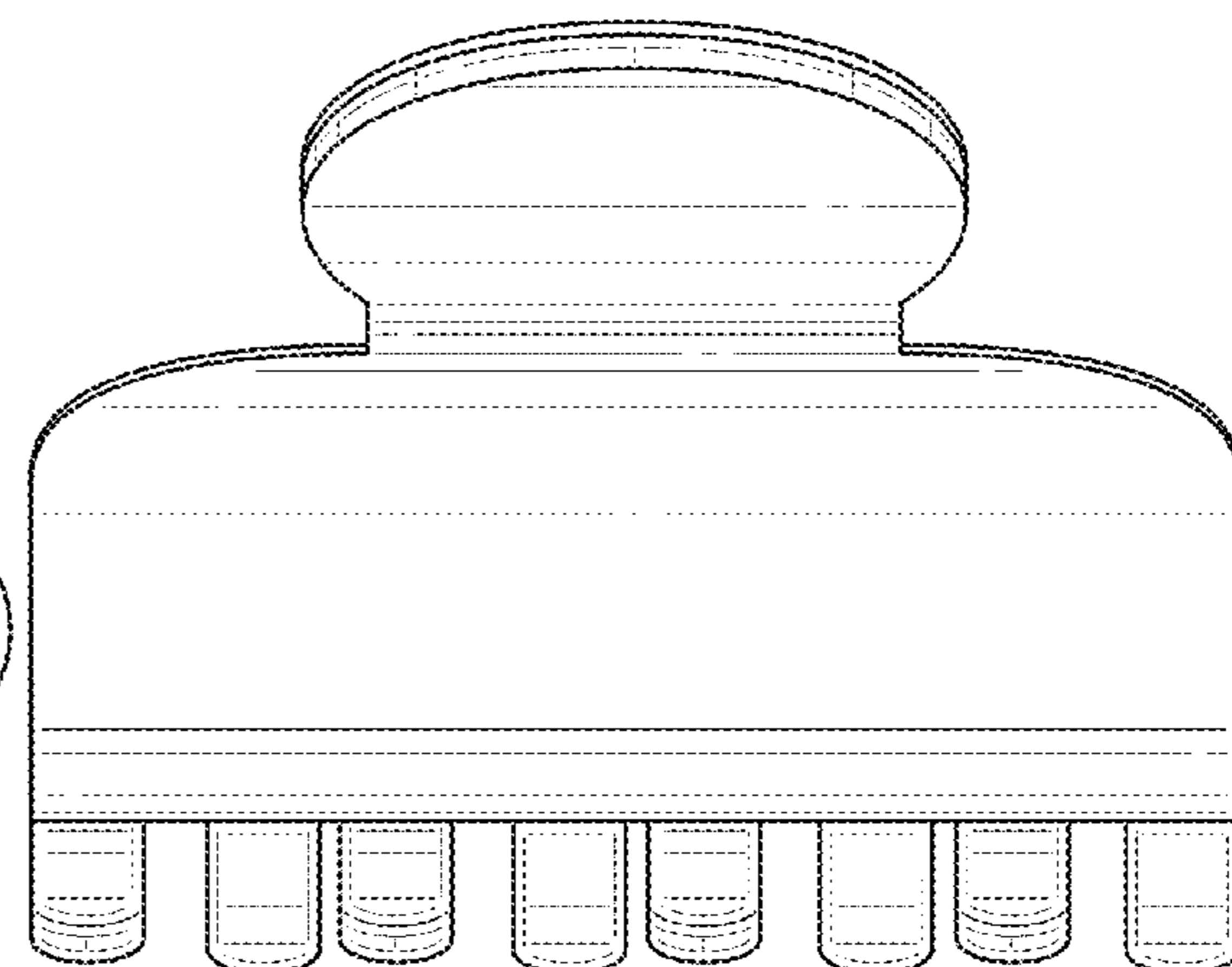
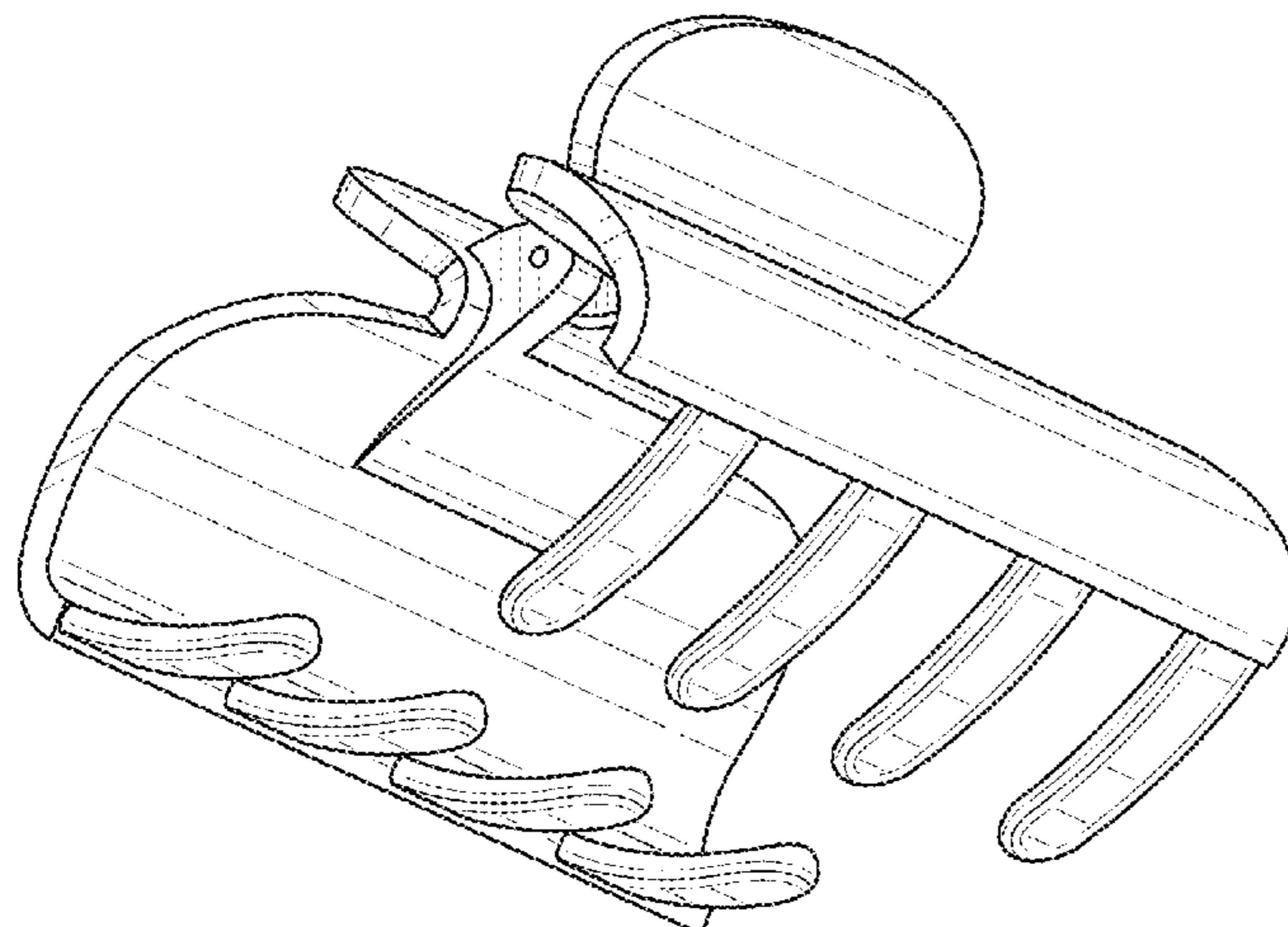
FIG. 13 is a right side plan view of the design shown in FIG. 9;

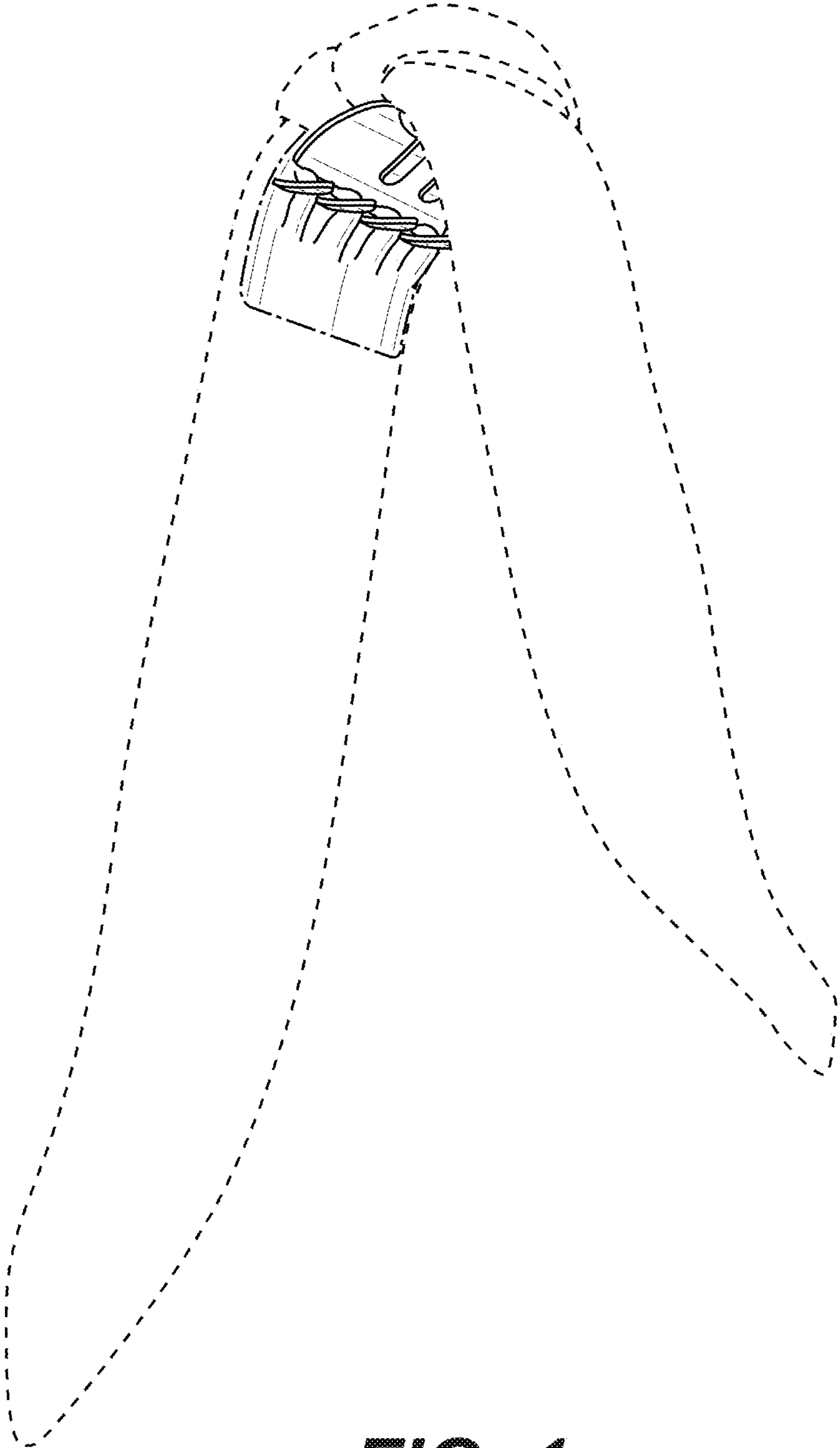

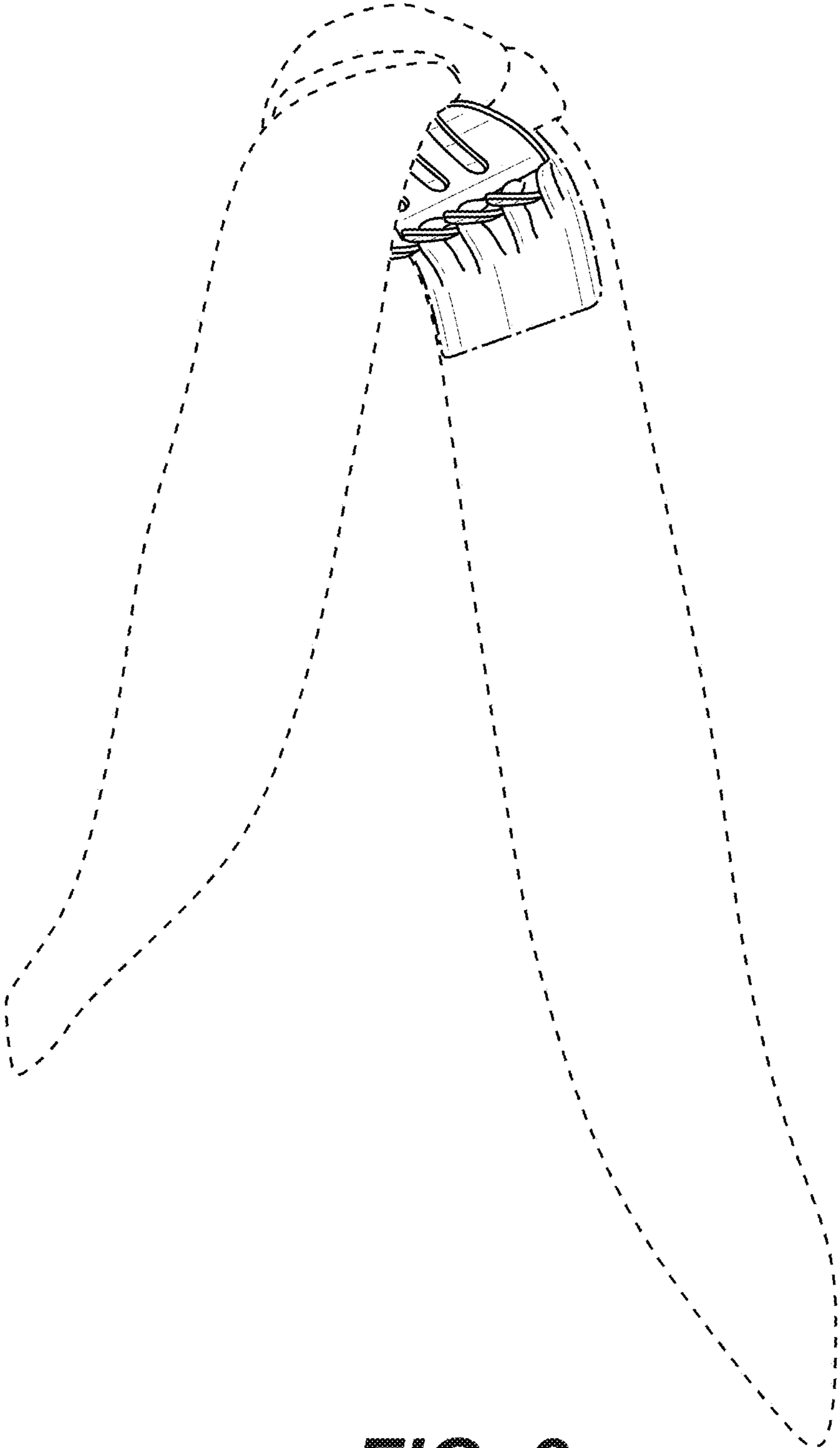

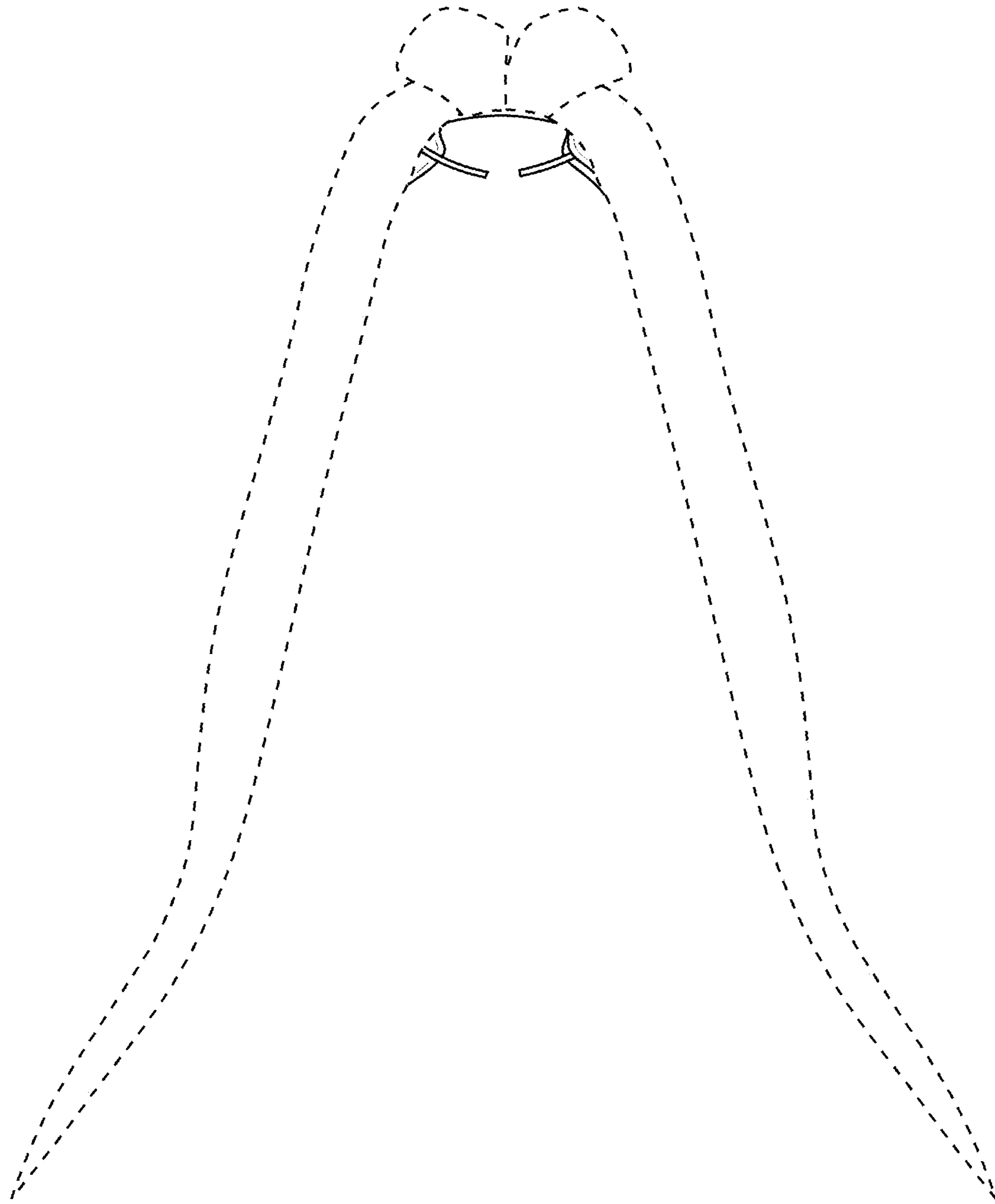

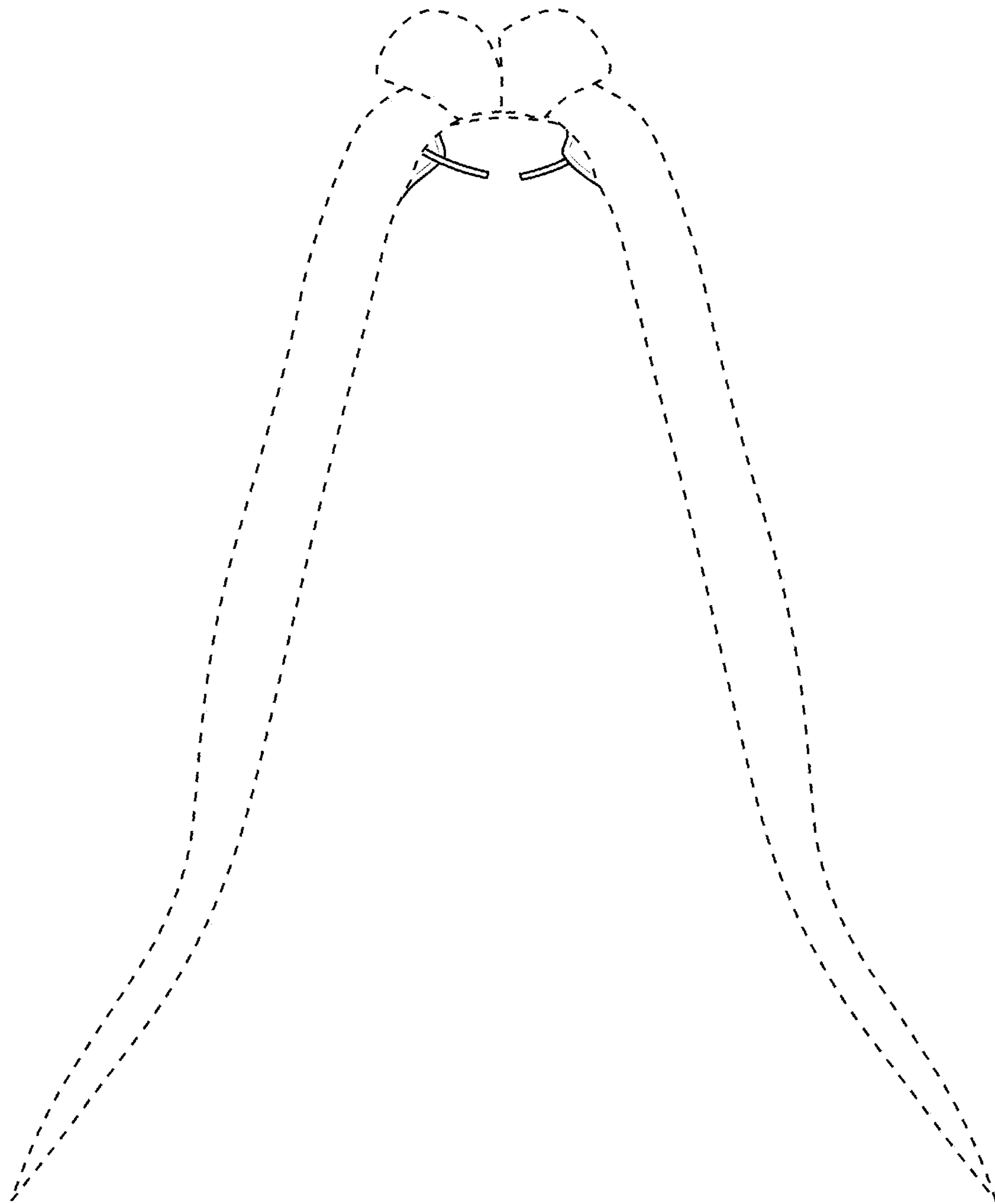

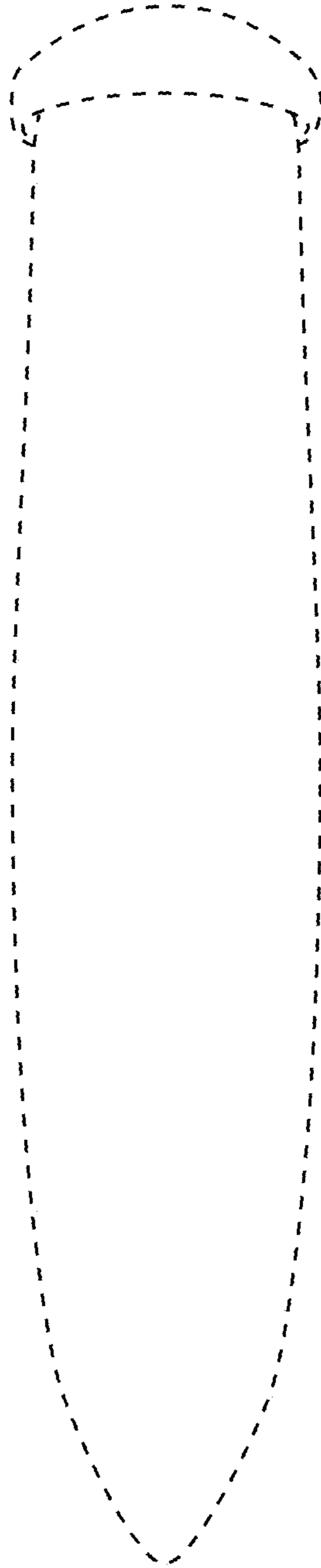

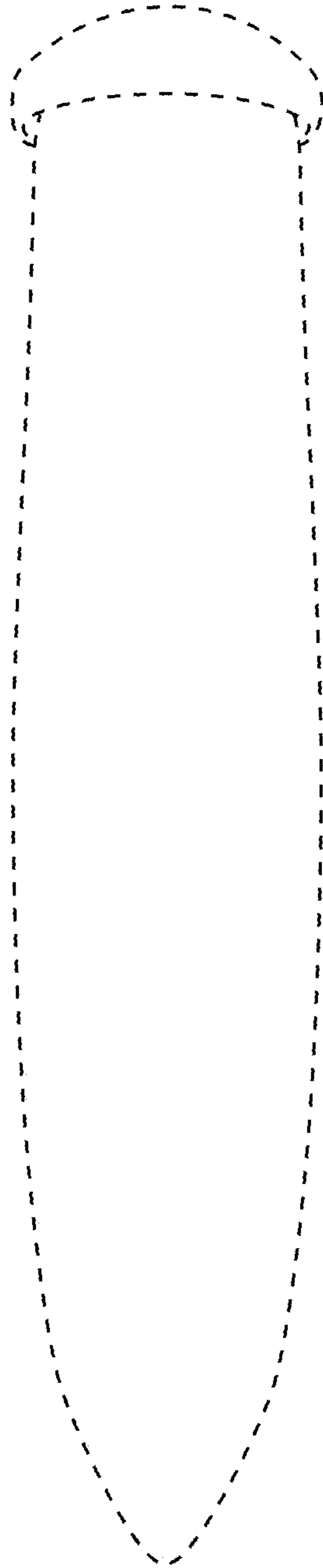

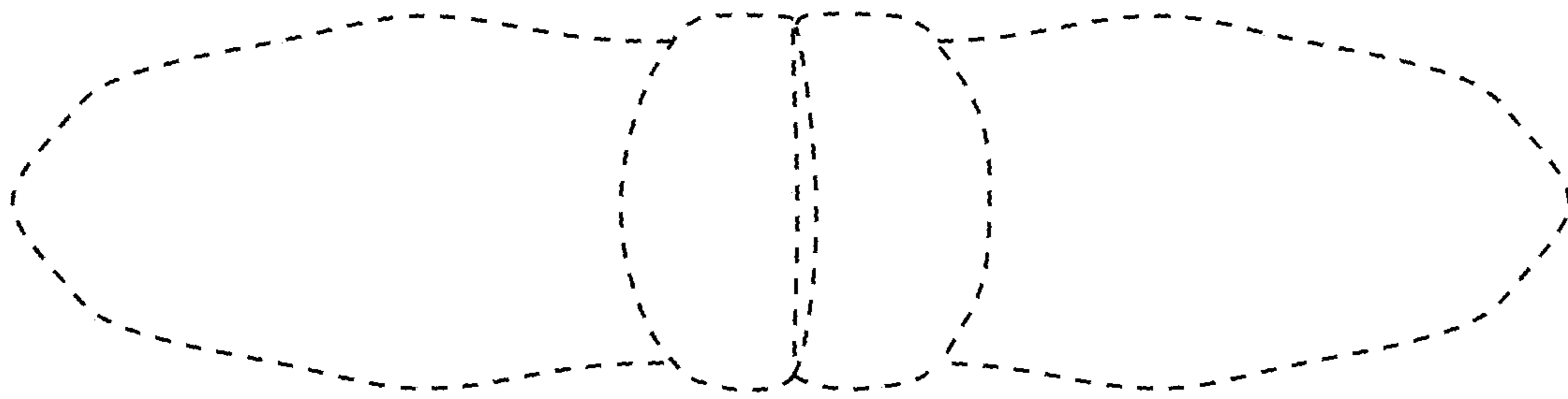

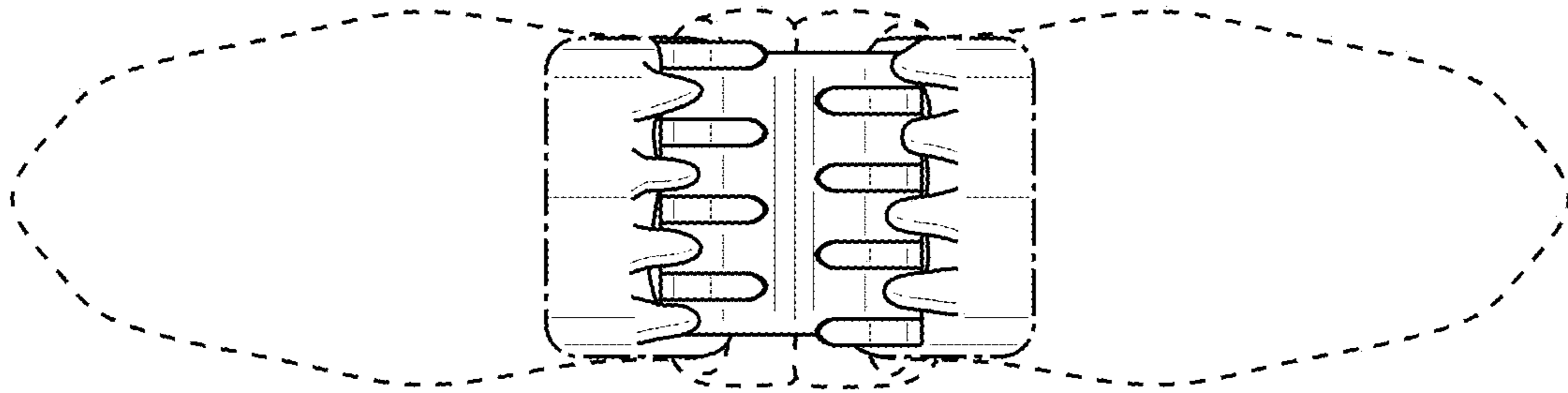

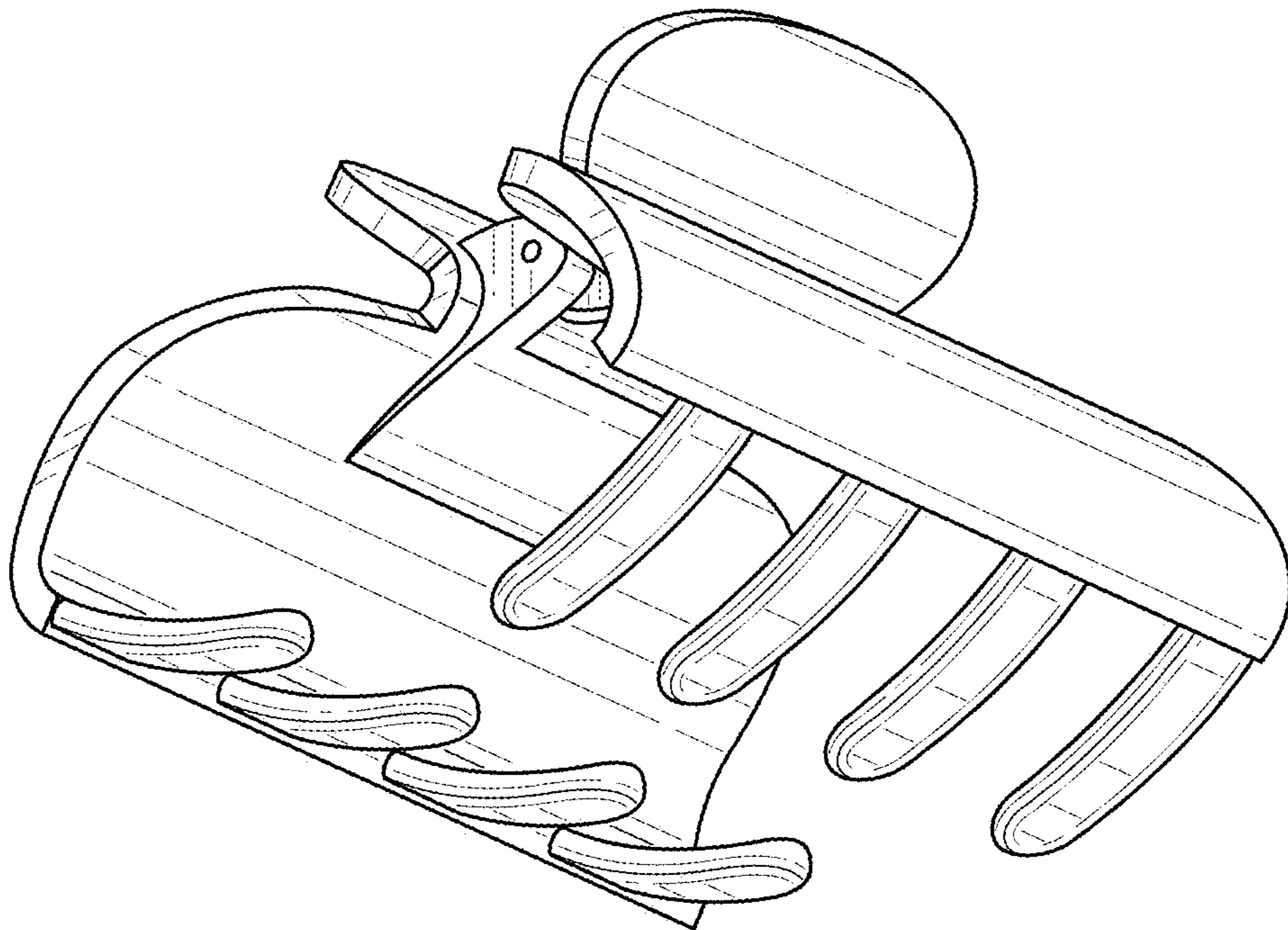




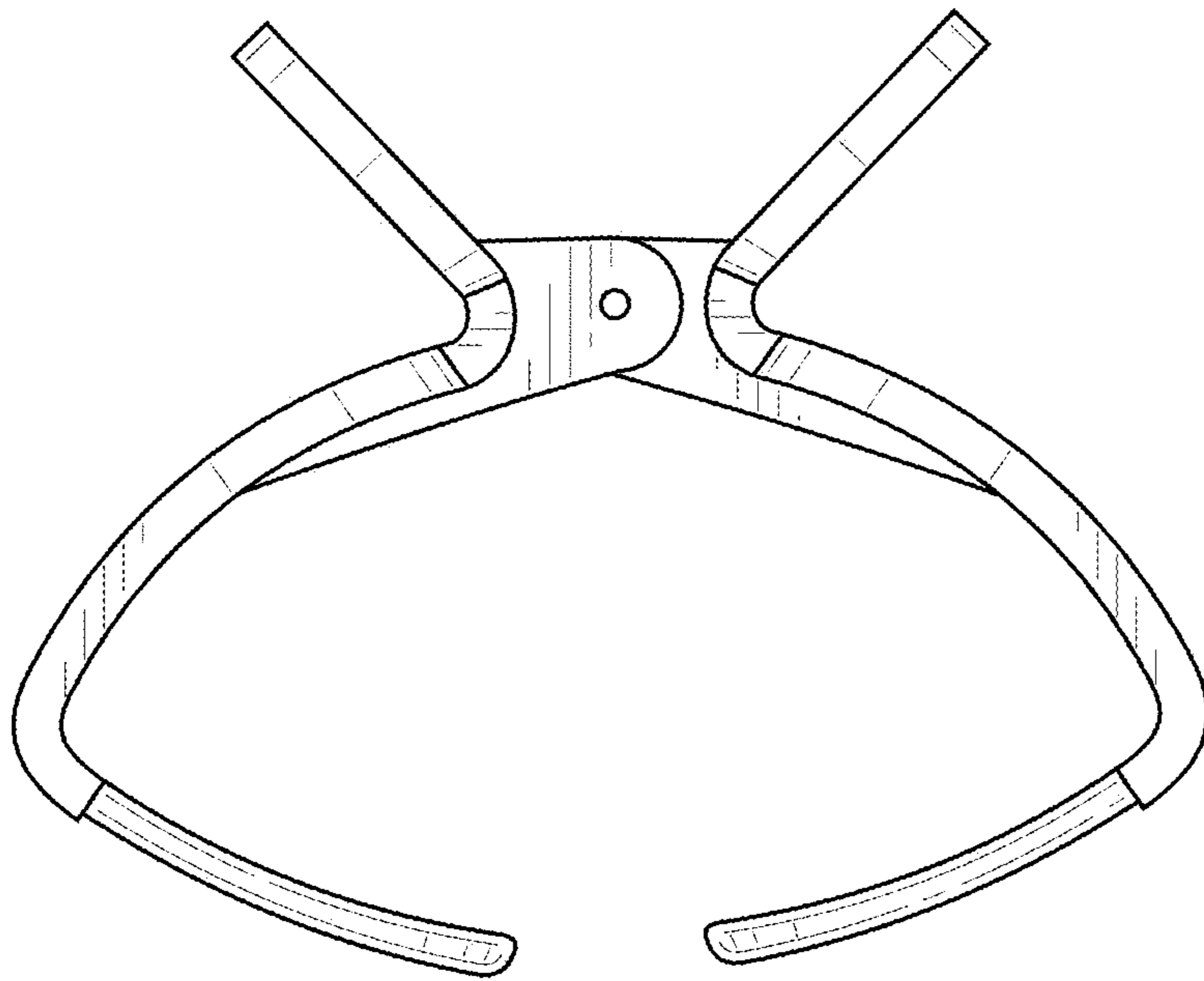

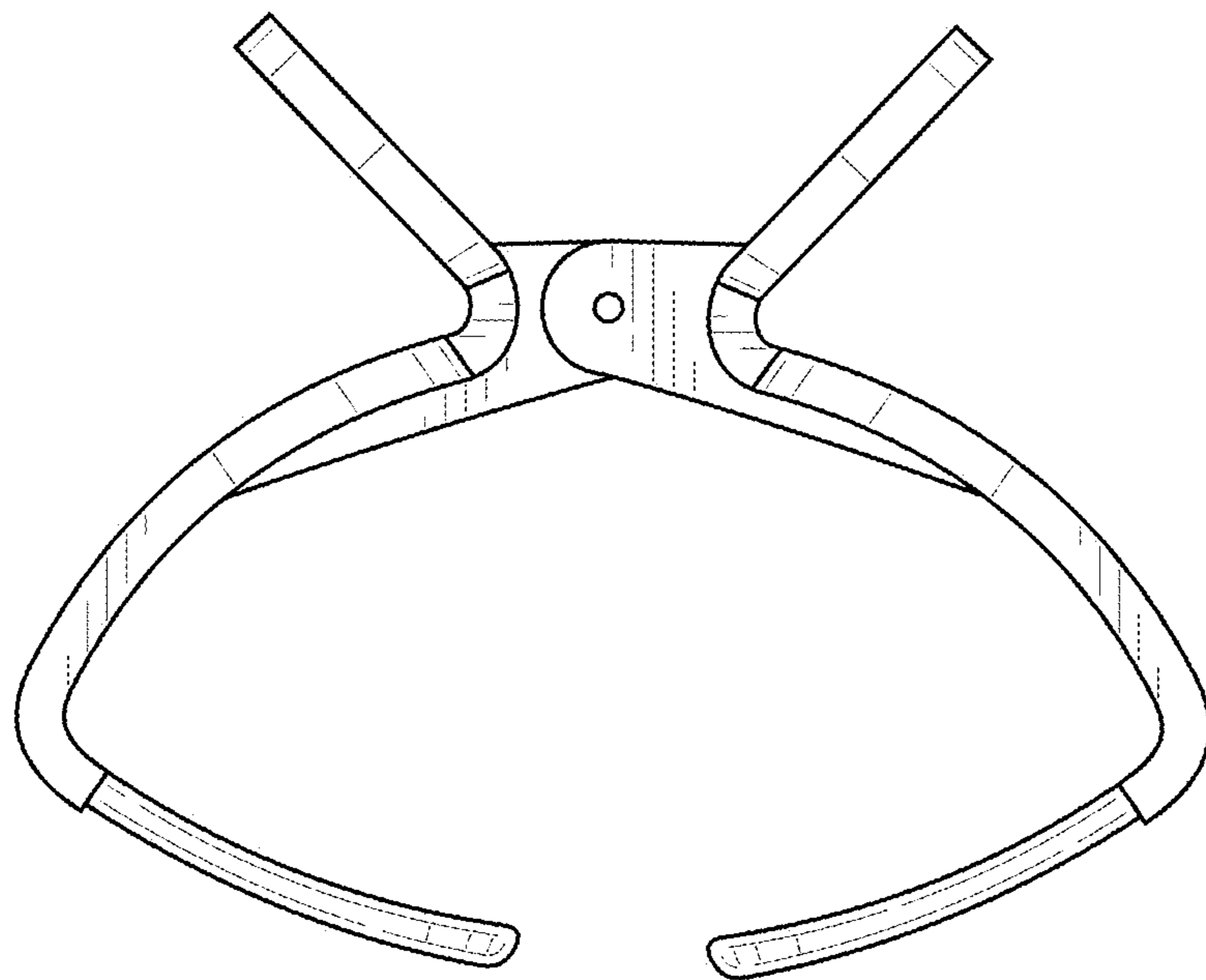

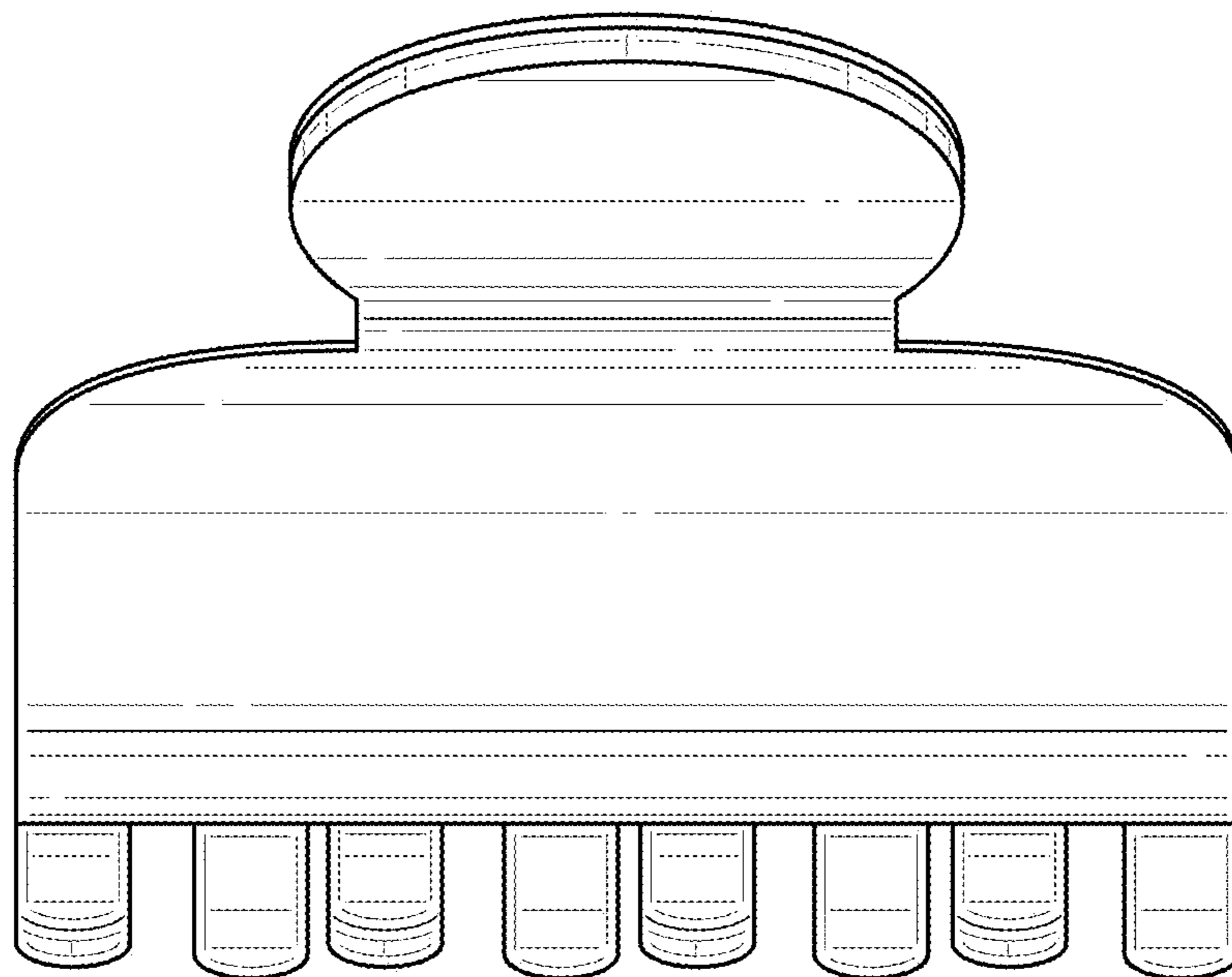

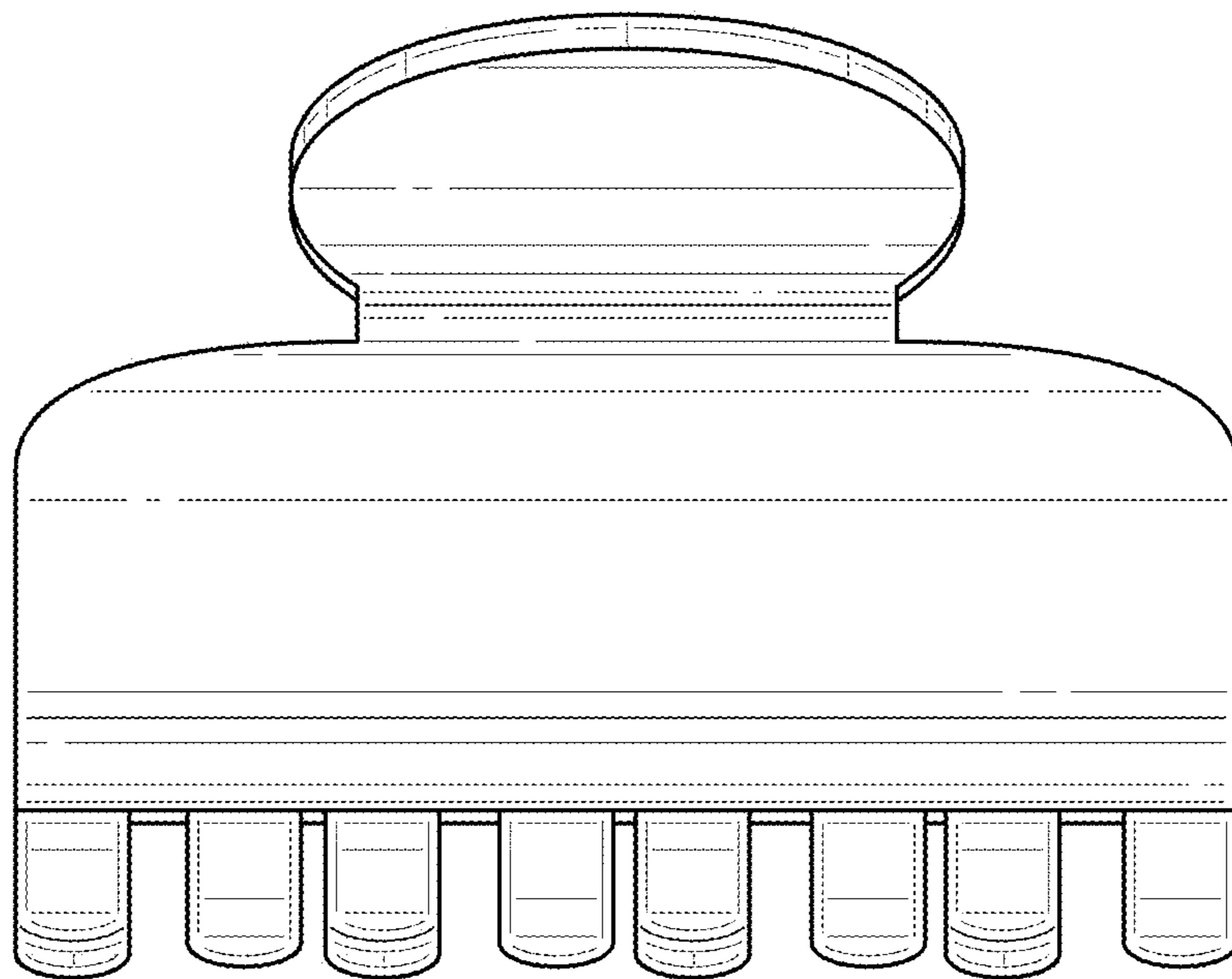

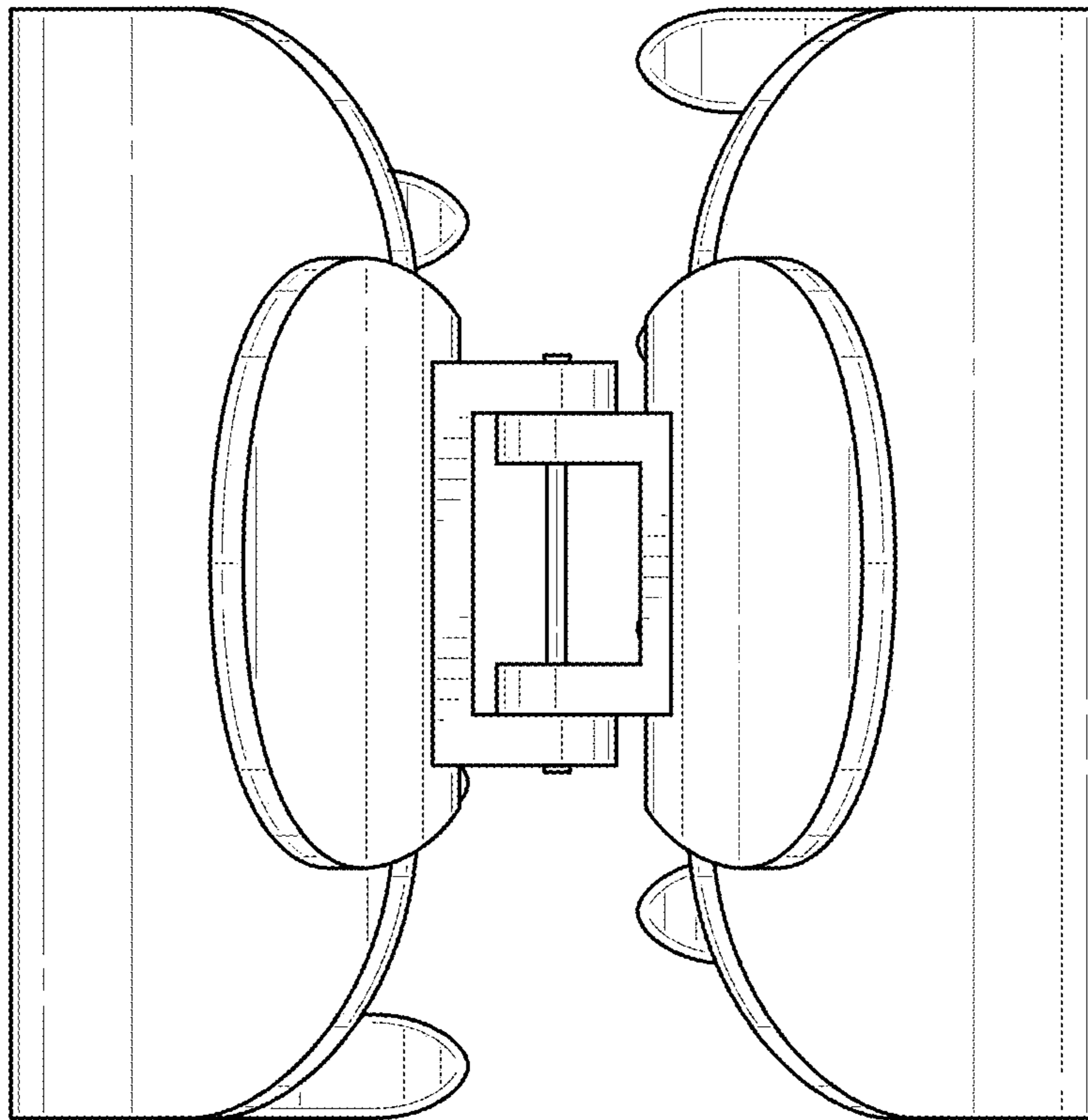

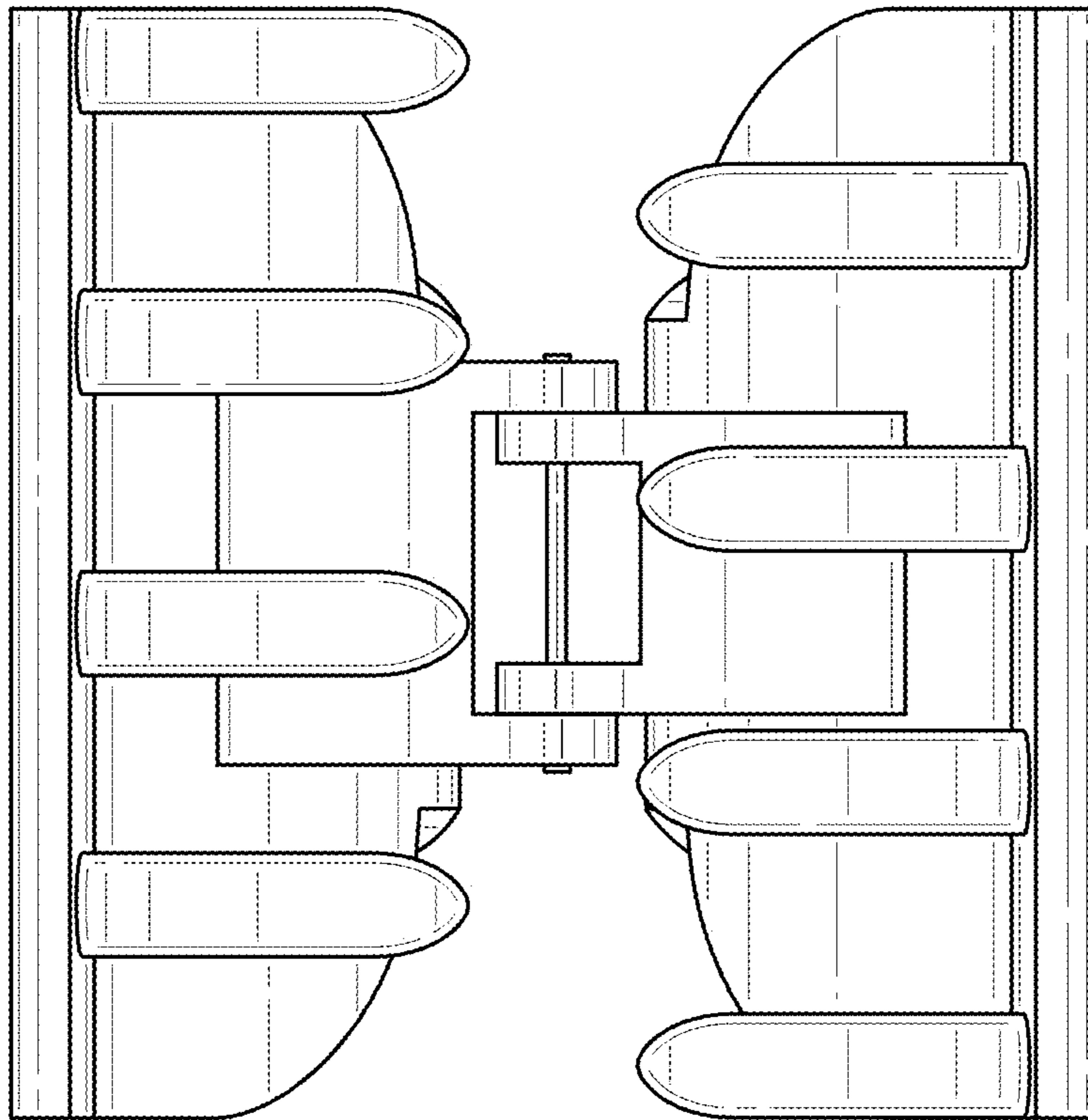


***FIG. 13***
