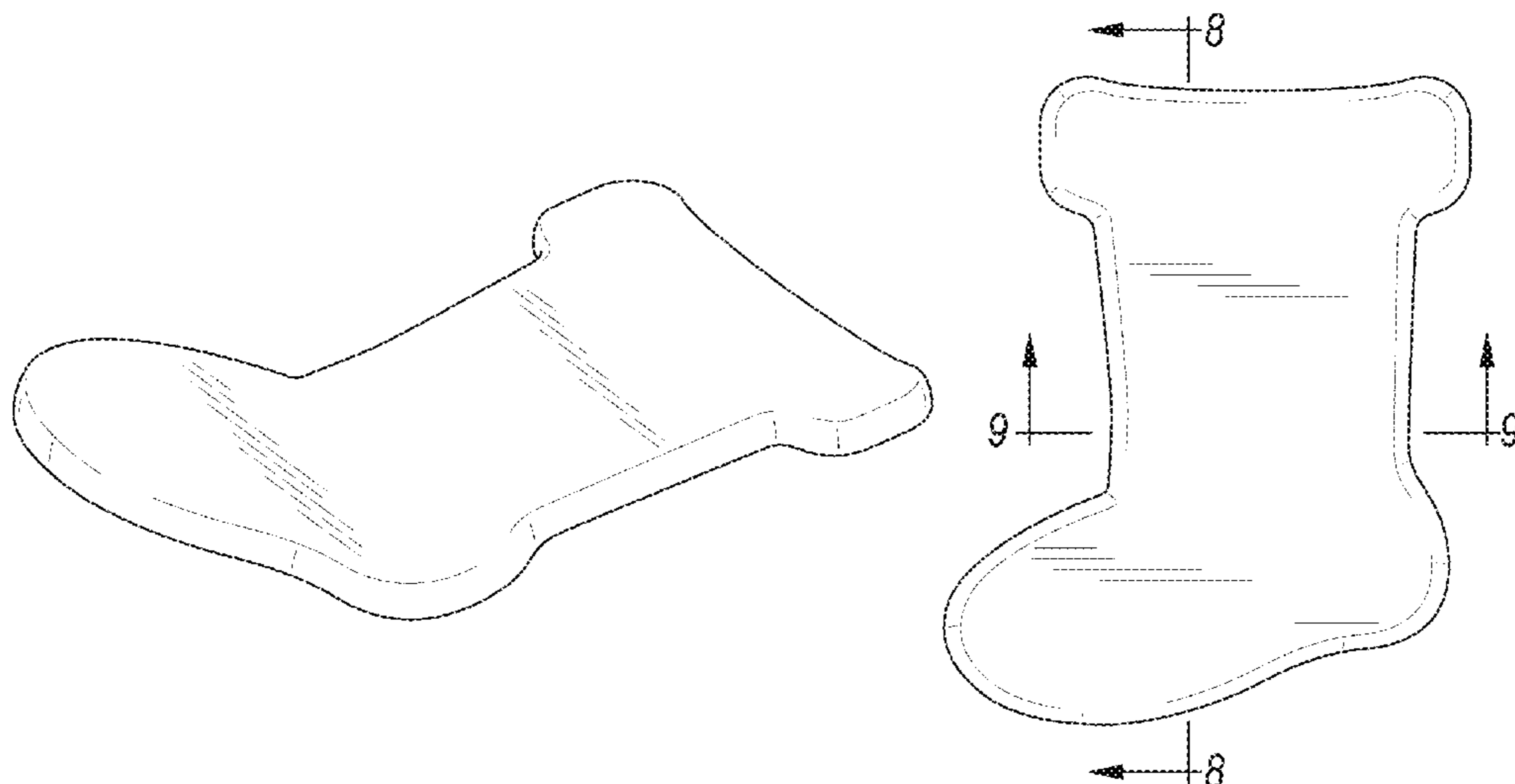
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right, front, bottom perspective view of a stocking-shaped foodstuff, showing our new design;

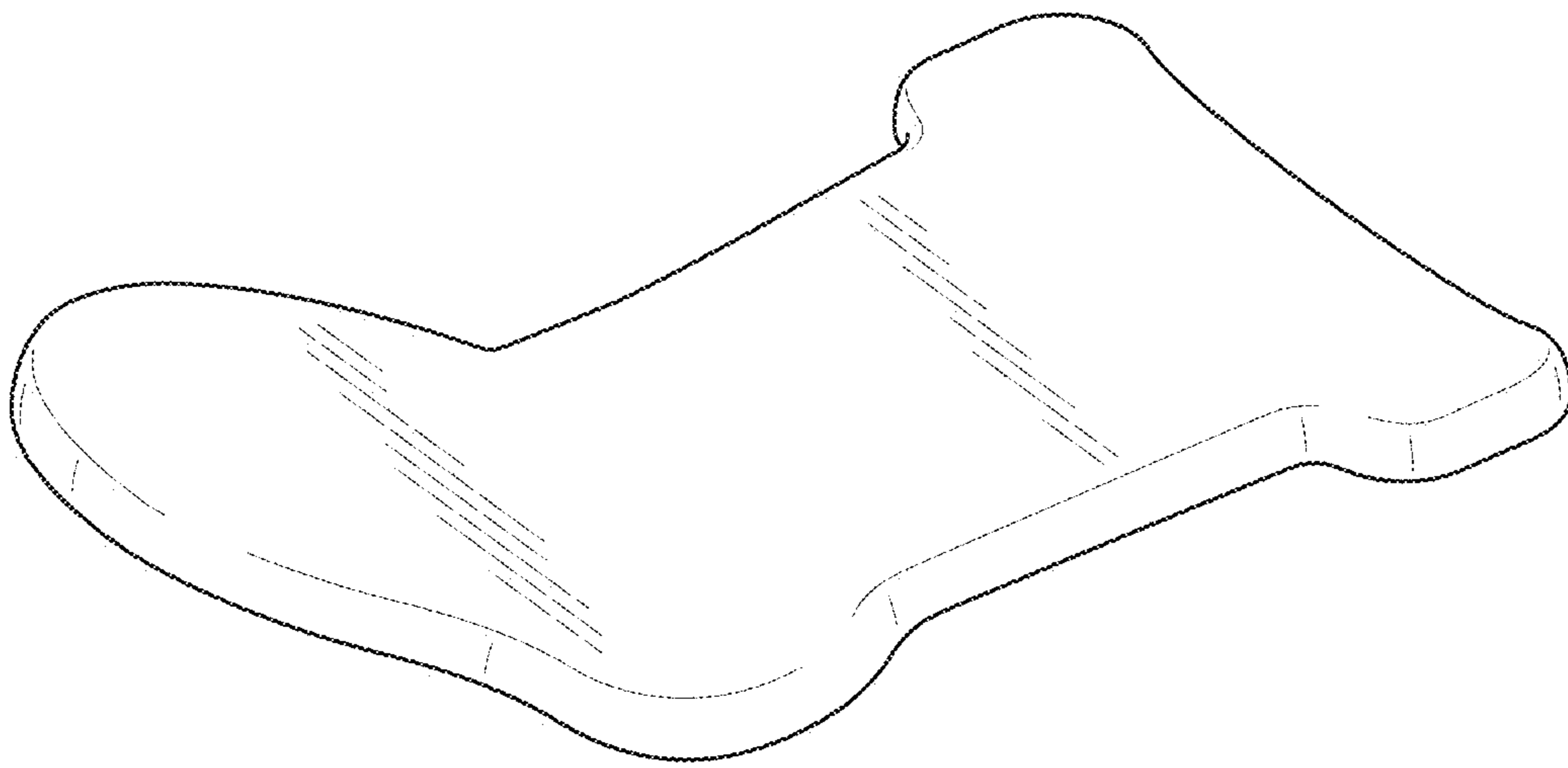

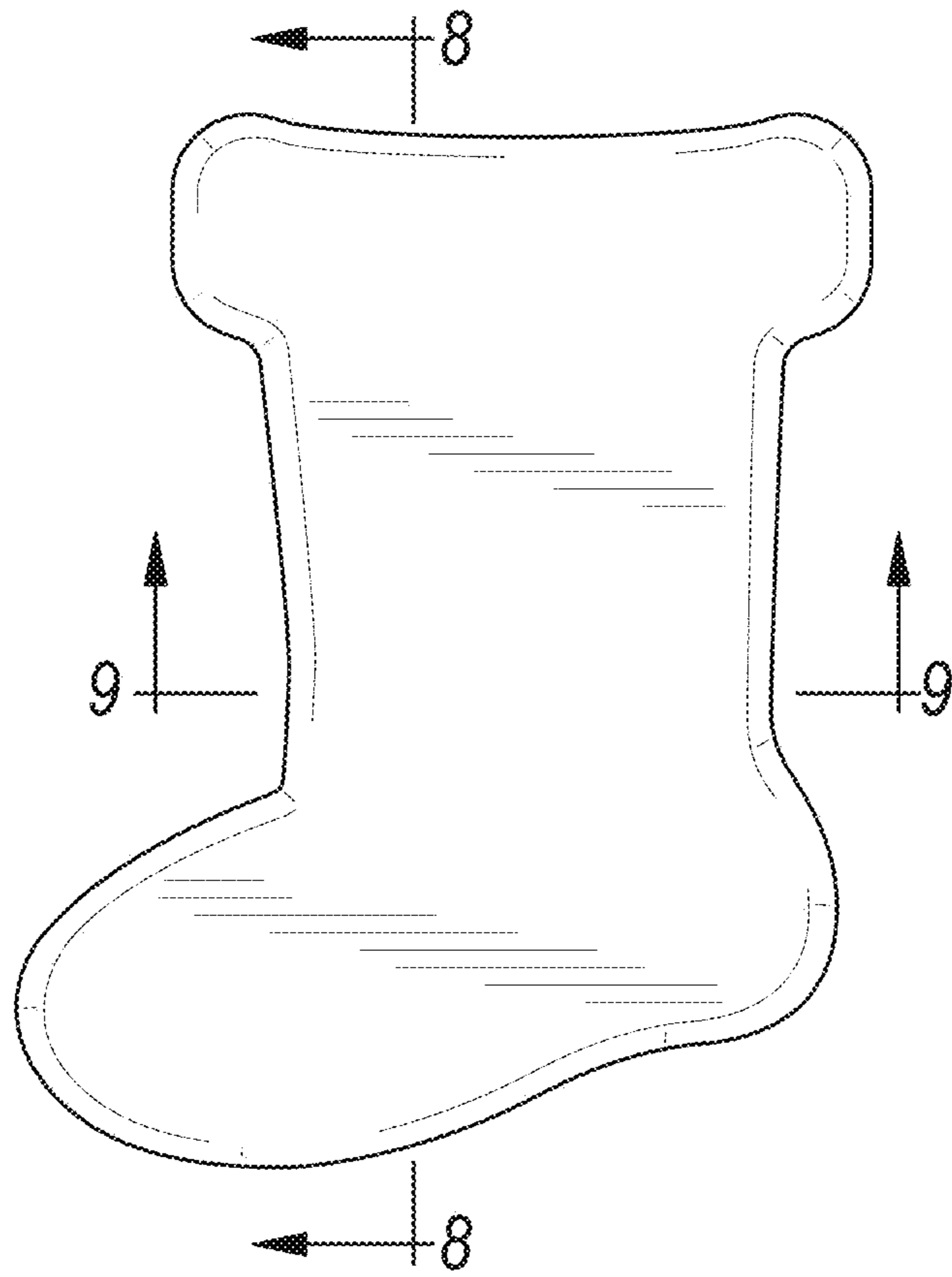

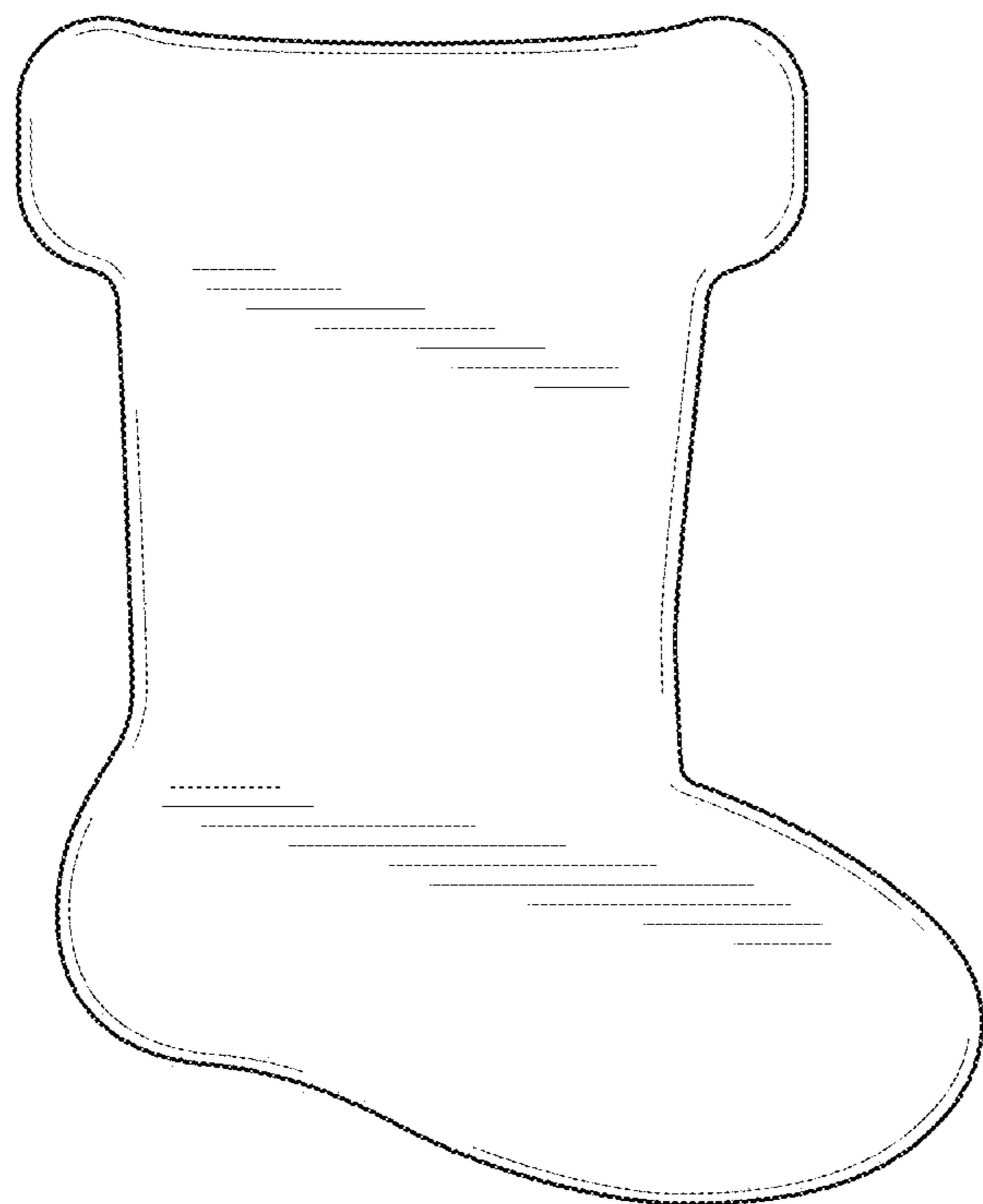

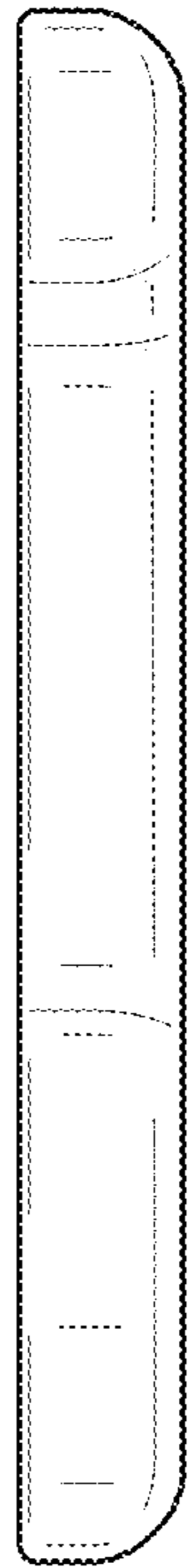

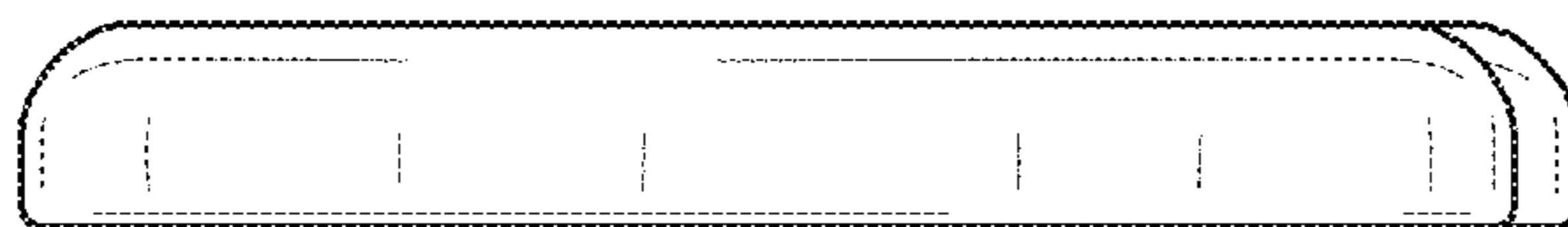

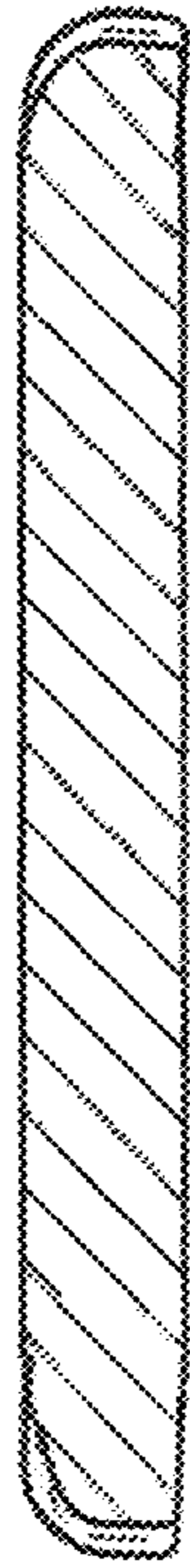
