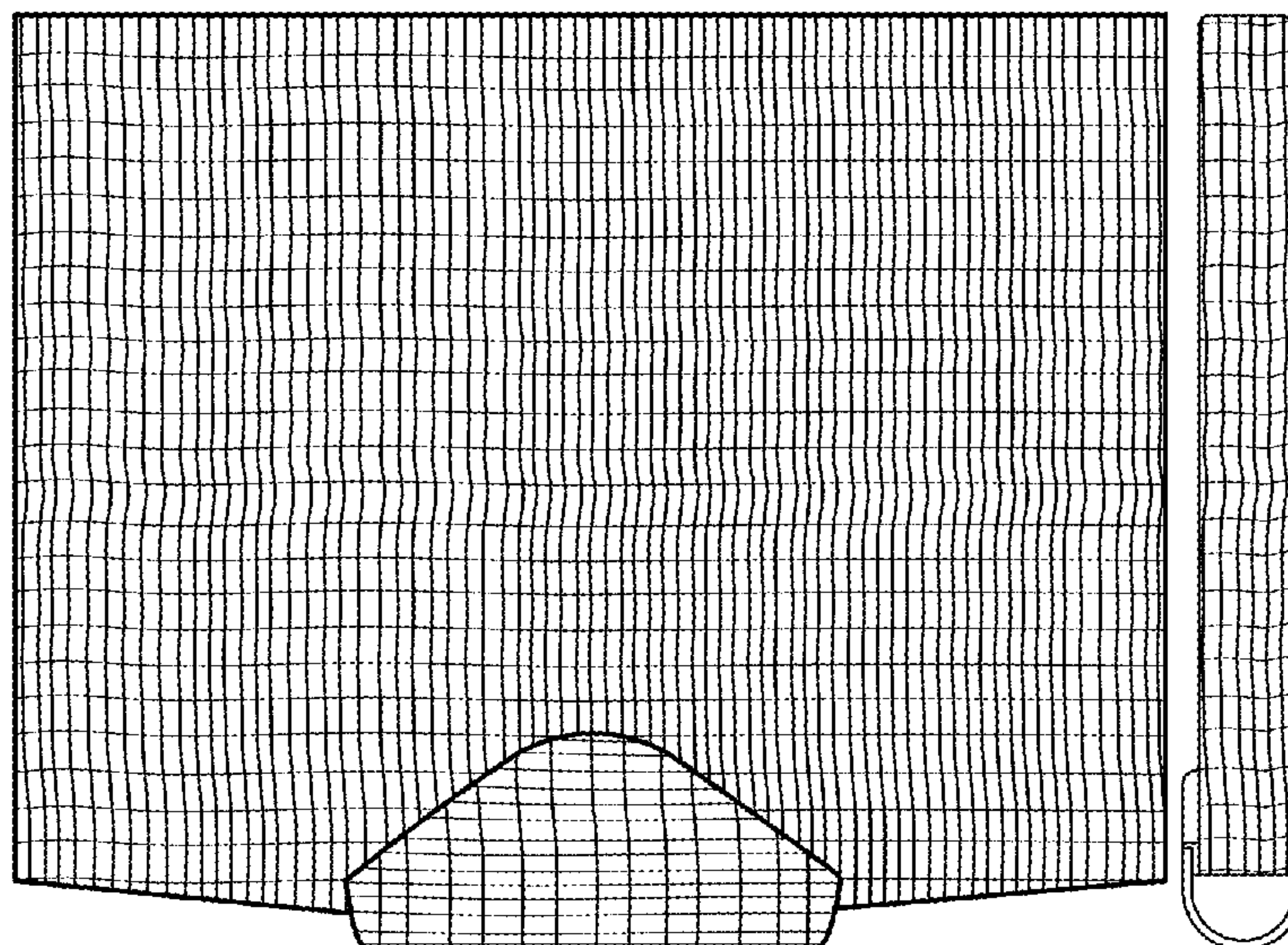
(57) **CLAIM**

The ornamental design for disposable underwear, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of disposable underwear according to my design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevational view thereof, the left side elevational view thereof being a mirror image of the right side elevational view;
FIG. 6 is a sectional view thereof at lines A-A of FIG. 1;
FIG. 7 is a sectional view thereof at lines B-B of FIG. 1;
FIG. 8 is a sectional view thereof at lines C-C of FIG. 2;
FIG. 9 is a sectional view thereof at lines D-D of FIG. 2;
FIG. 10 is an enlarged view of a portion thereof at section 10 of FIG. 1; and,
FIG. 11 is an enlarged view of a portion thereof at section 11 of FIG. 1.
The uneven broken lines in each of FIG. 10 and FIG. 11 represent a boundary line and form no part of the claimed design.

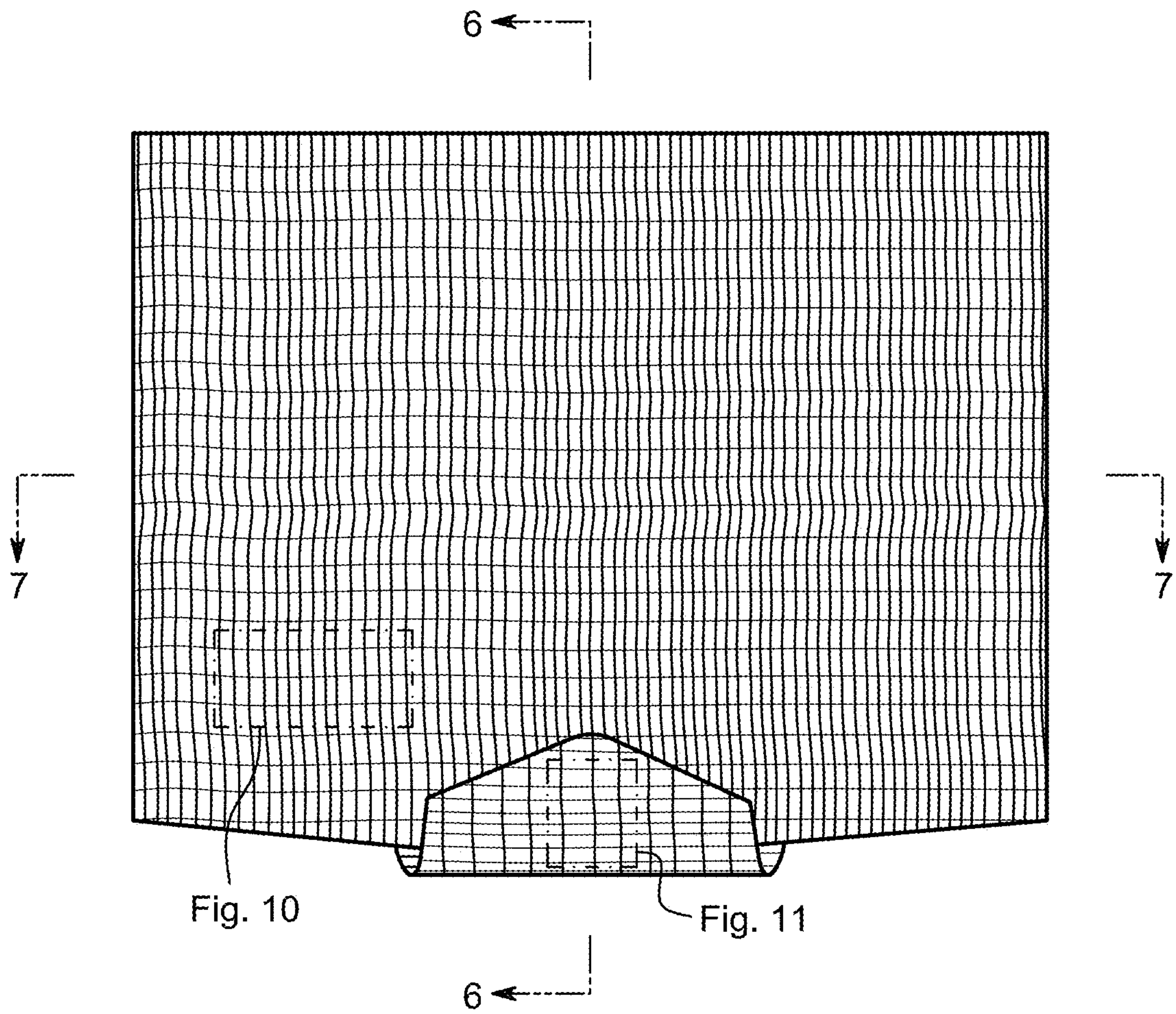

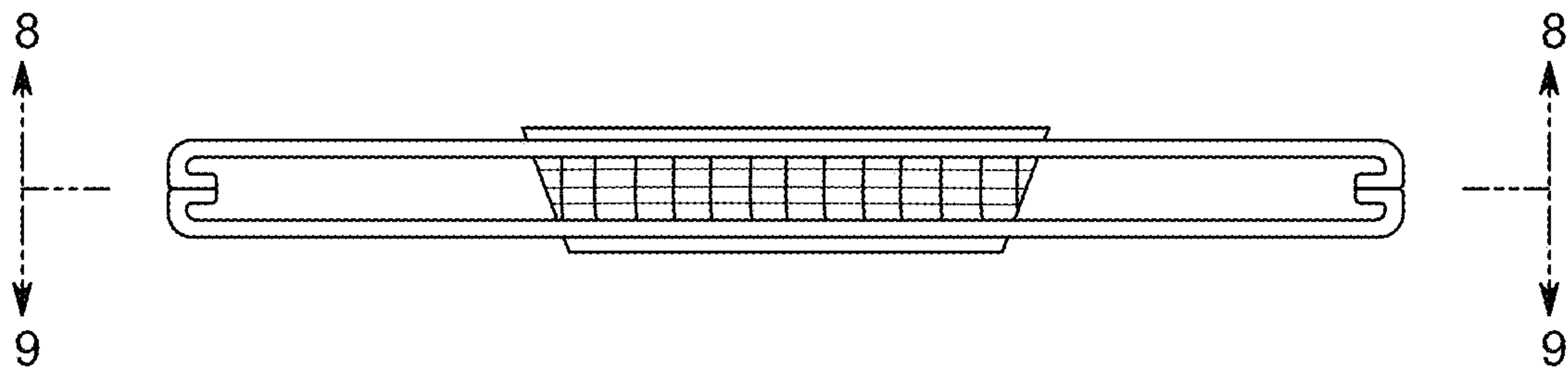

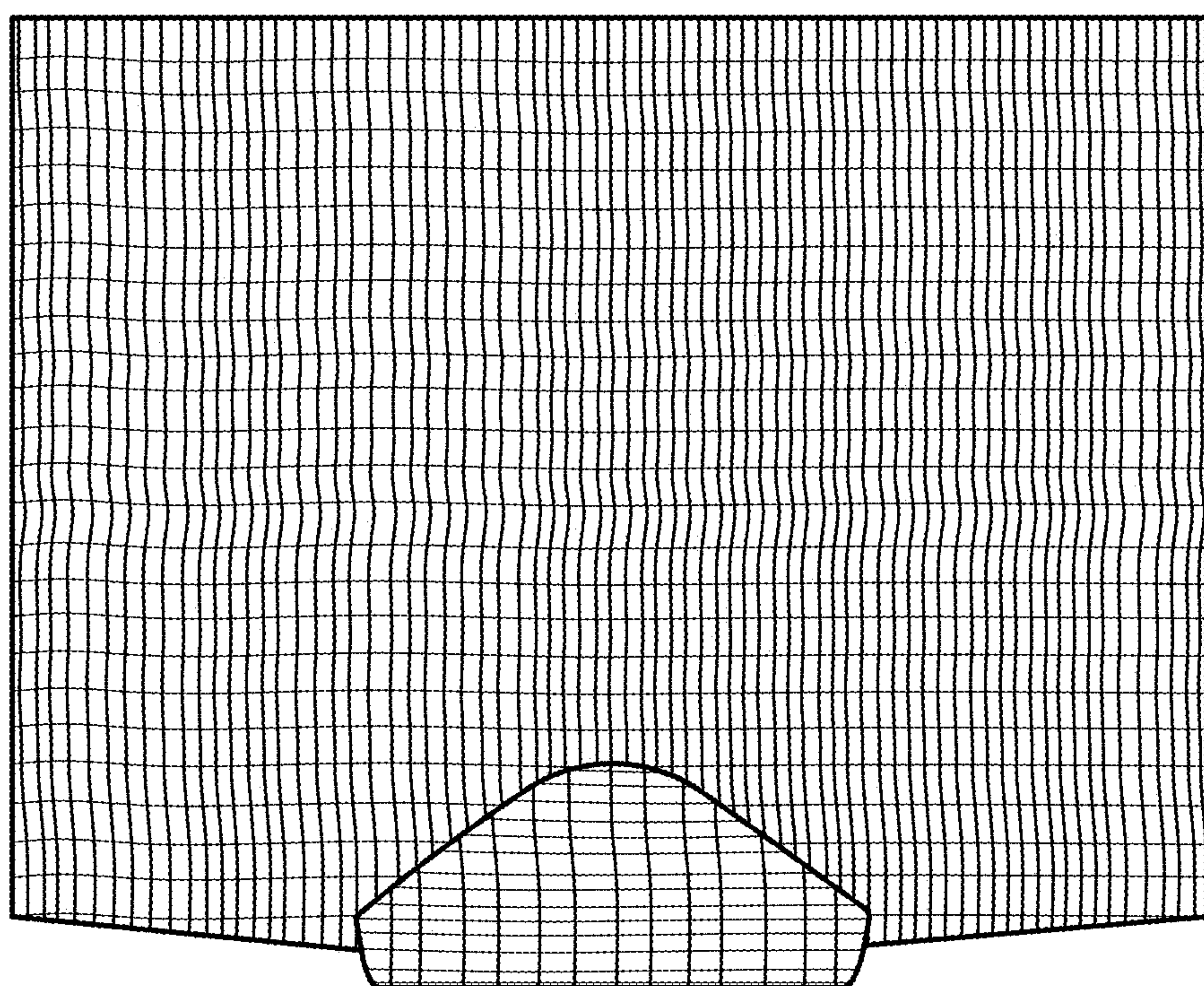

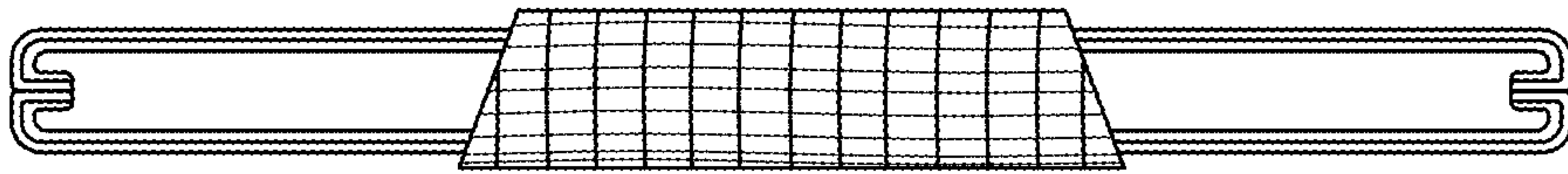

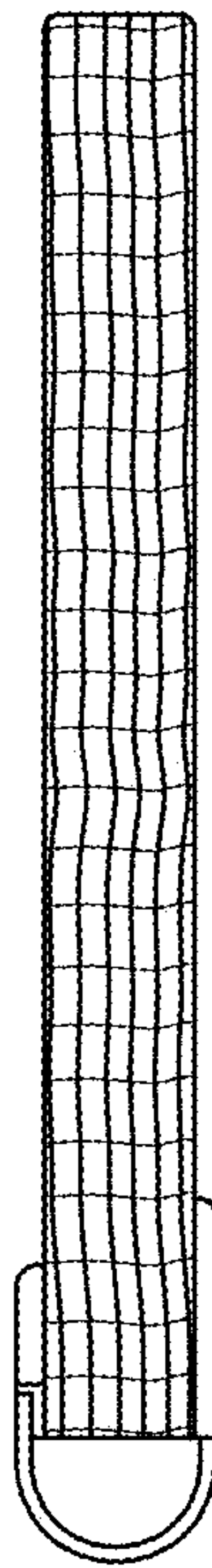

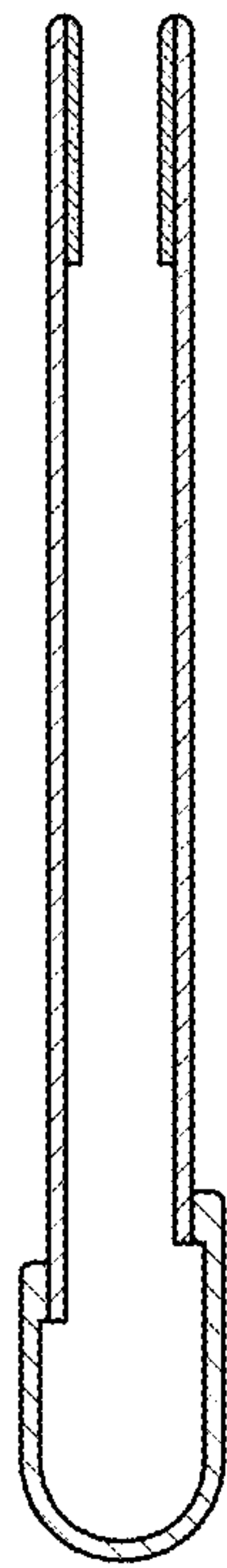

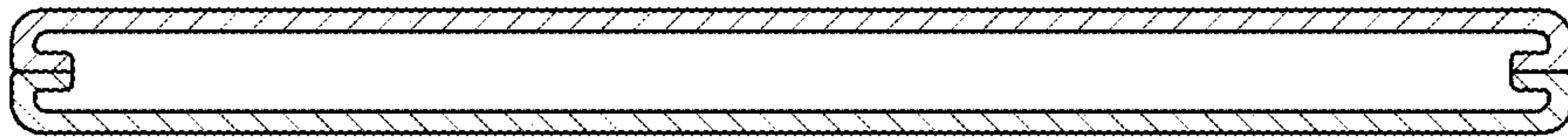

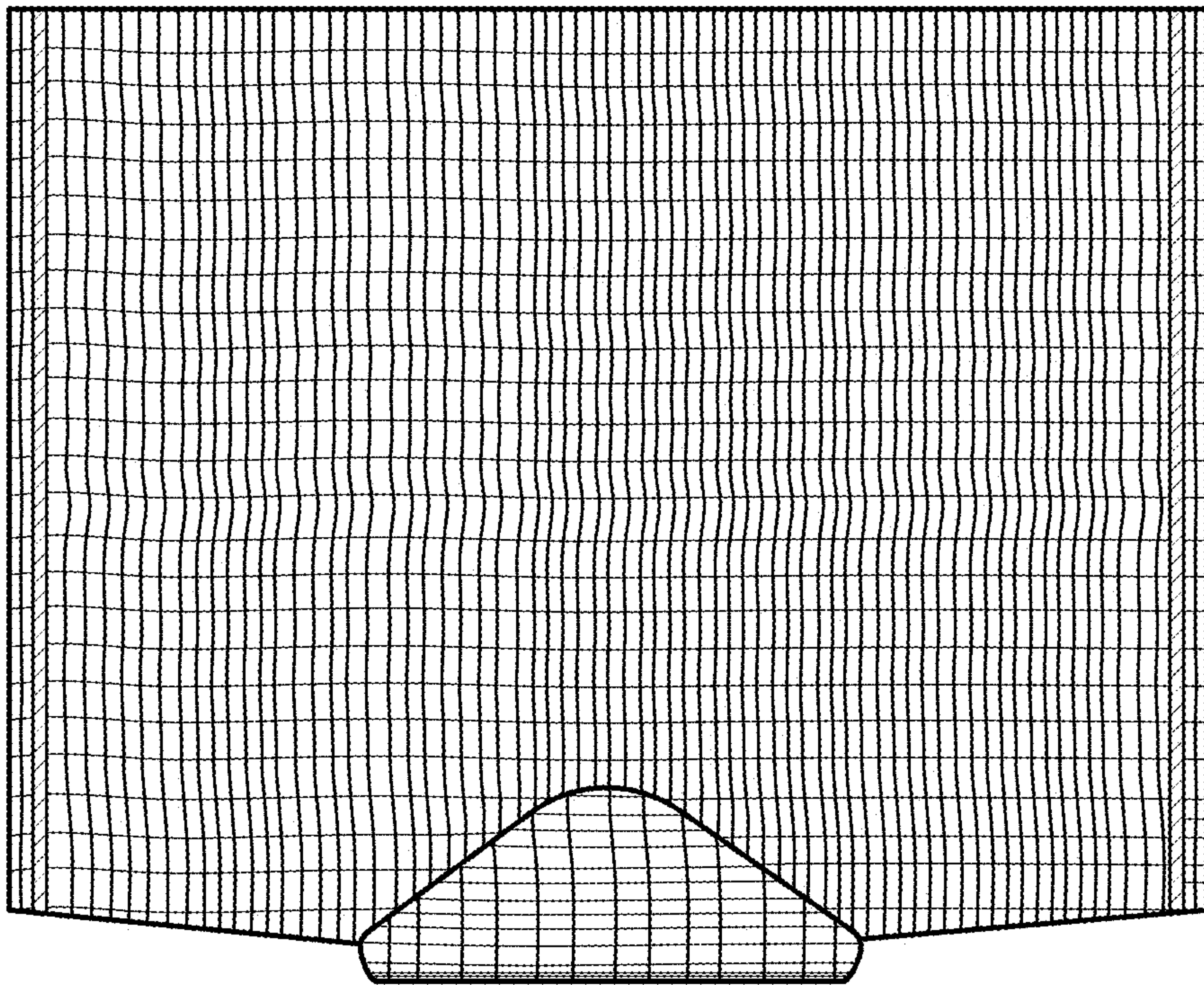

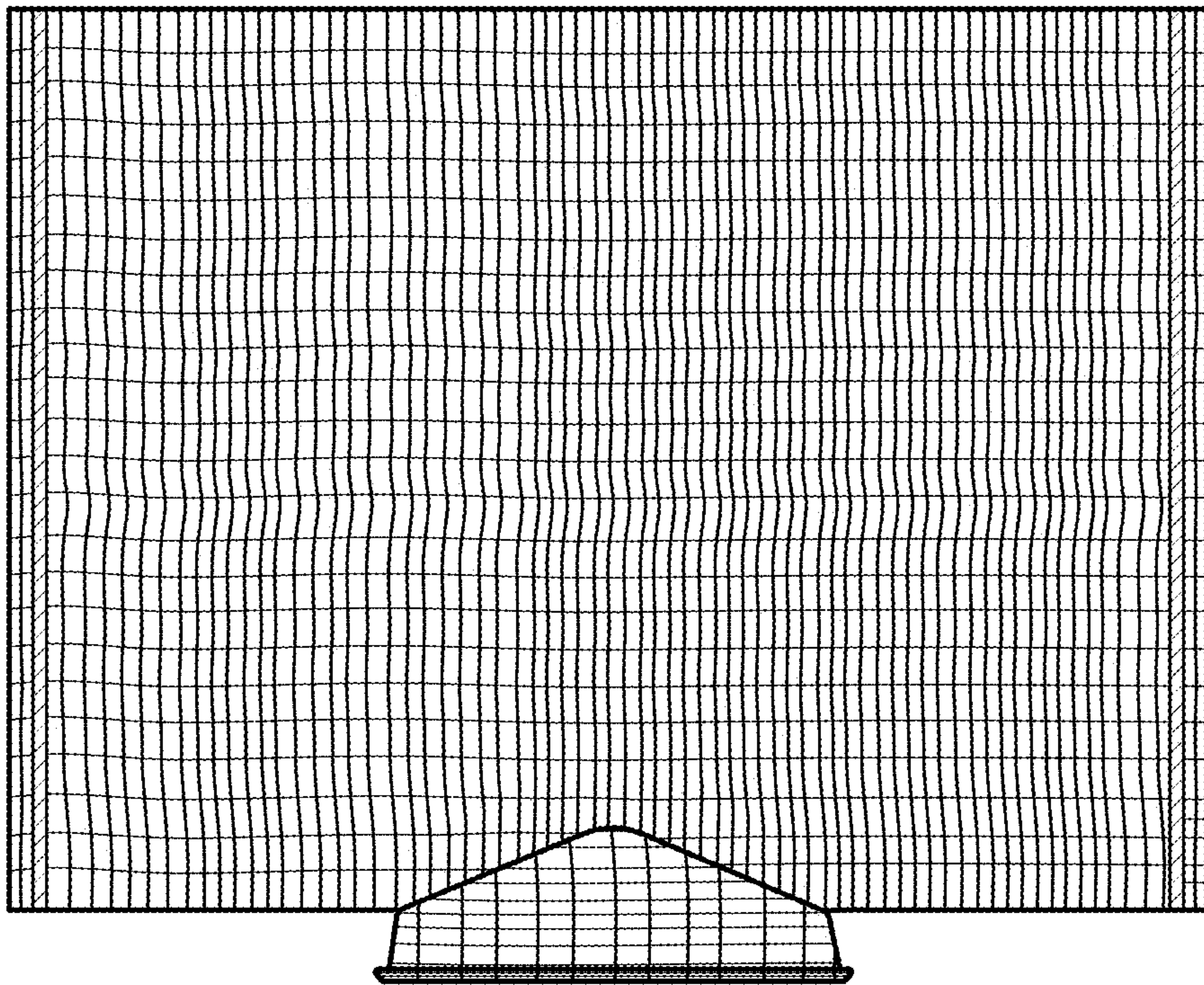

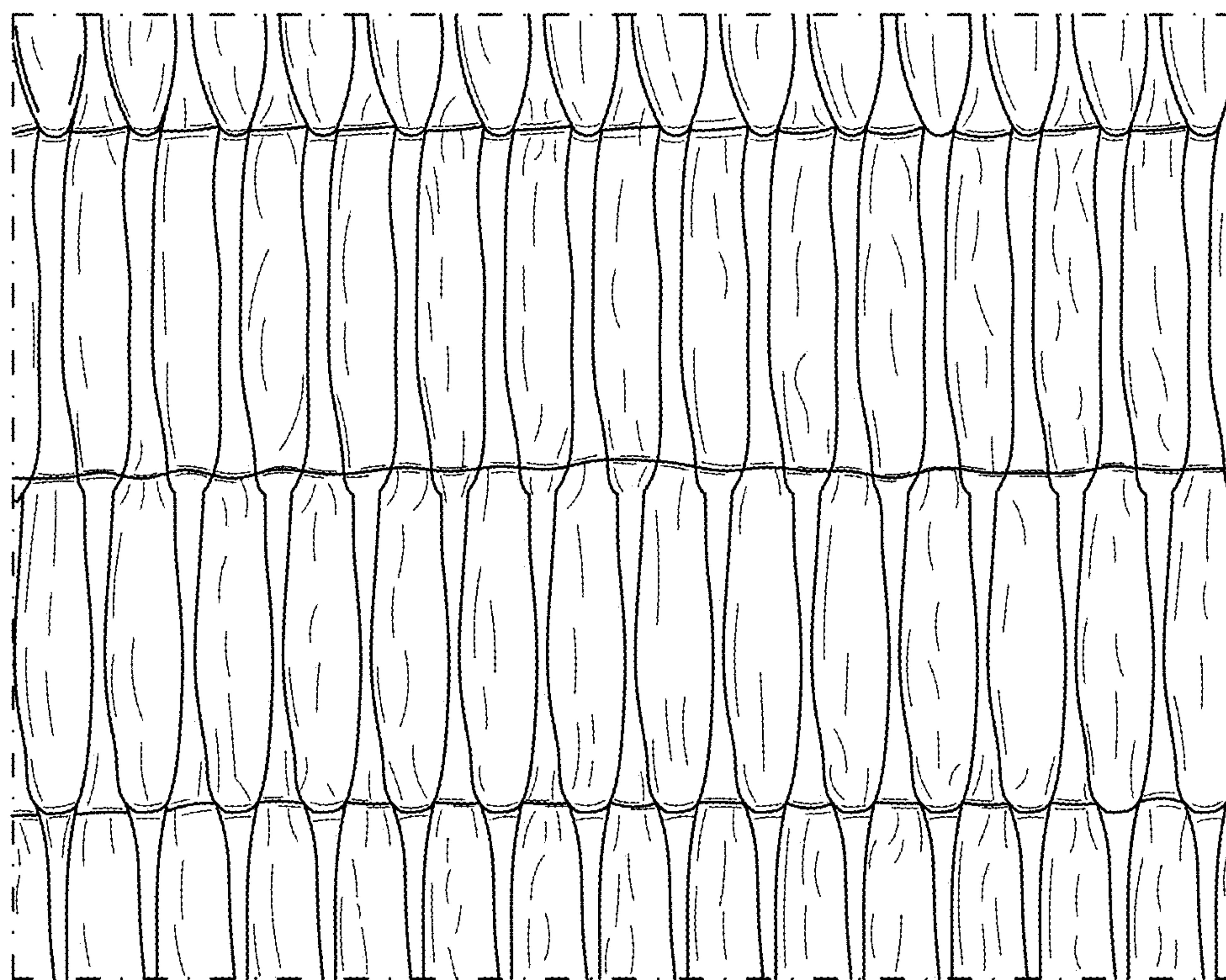

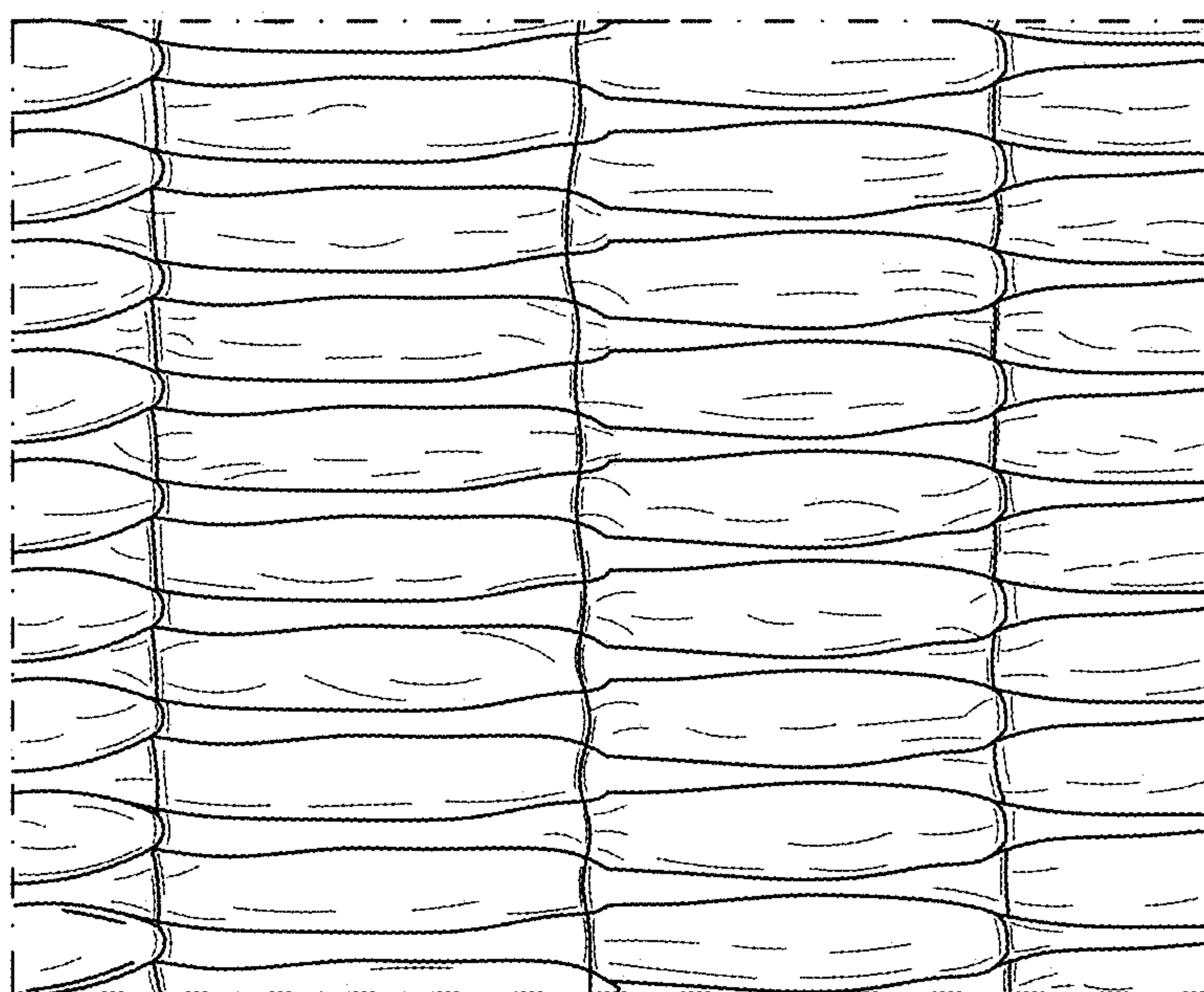
