The ornamental design for a detergent capsule, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first detergent capsule embodying the new design;

FIG. 2 is a front side elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 11 is a right side elevation view of the second detergent capsule;

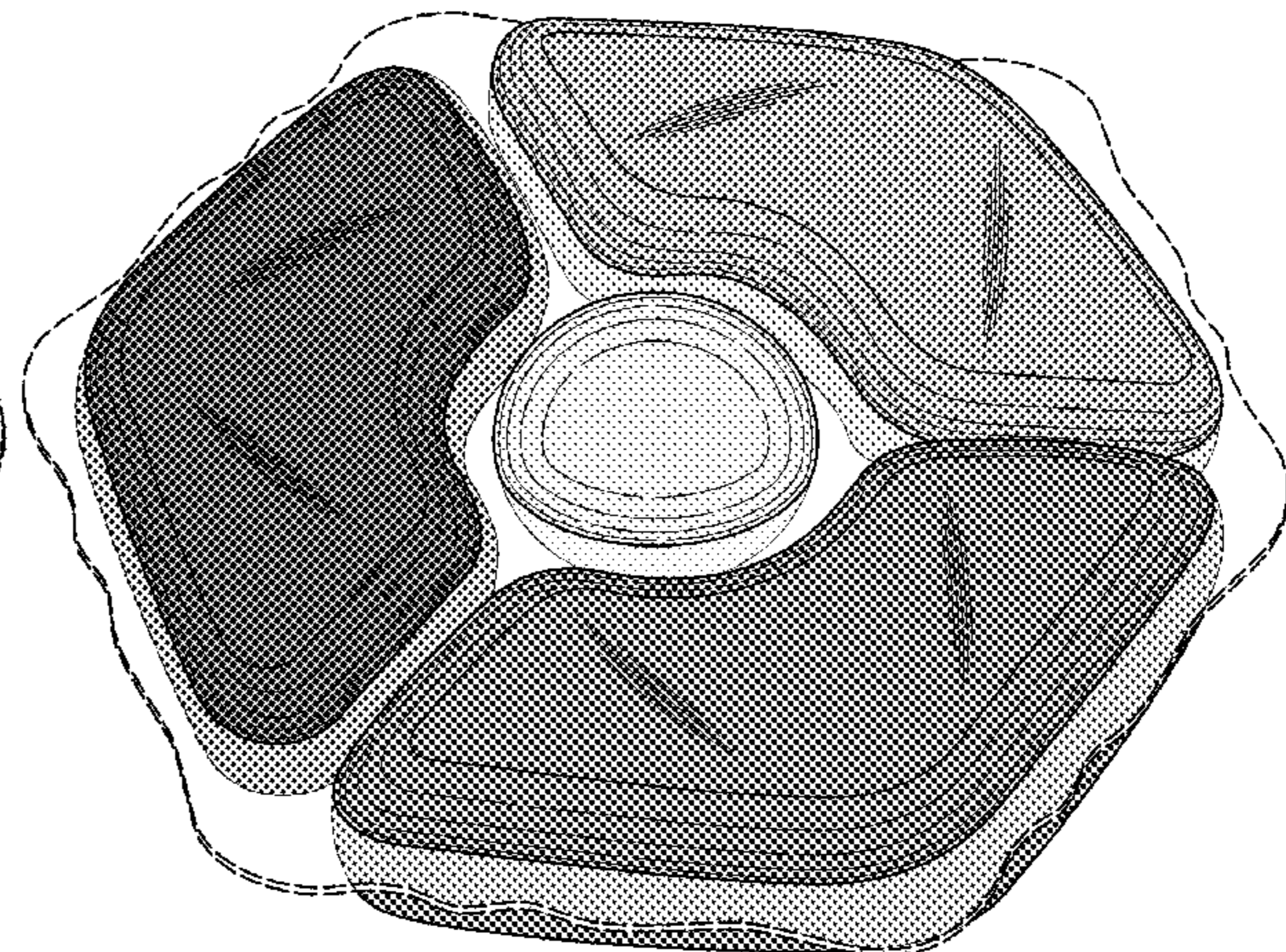
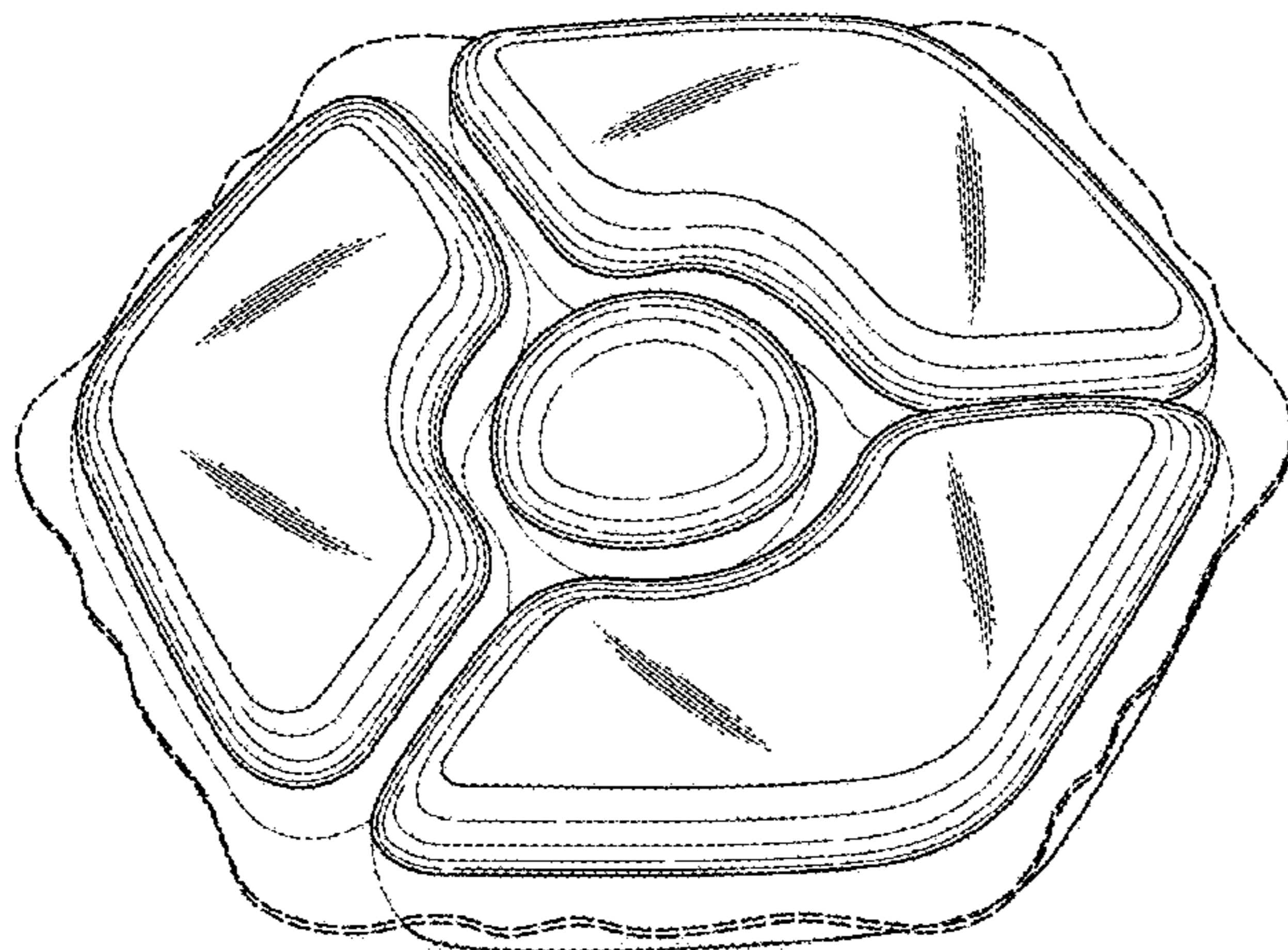
FIG. 12 is a left side elevation view of the second detergent capsule;

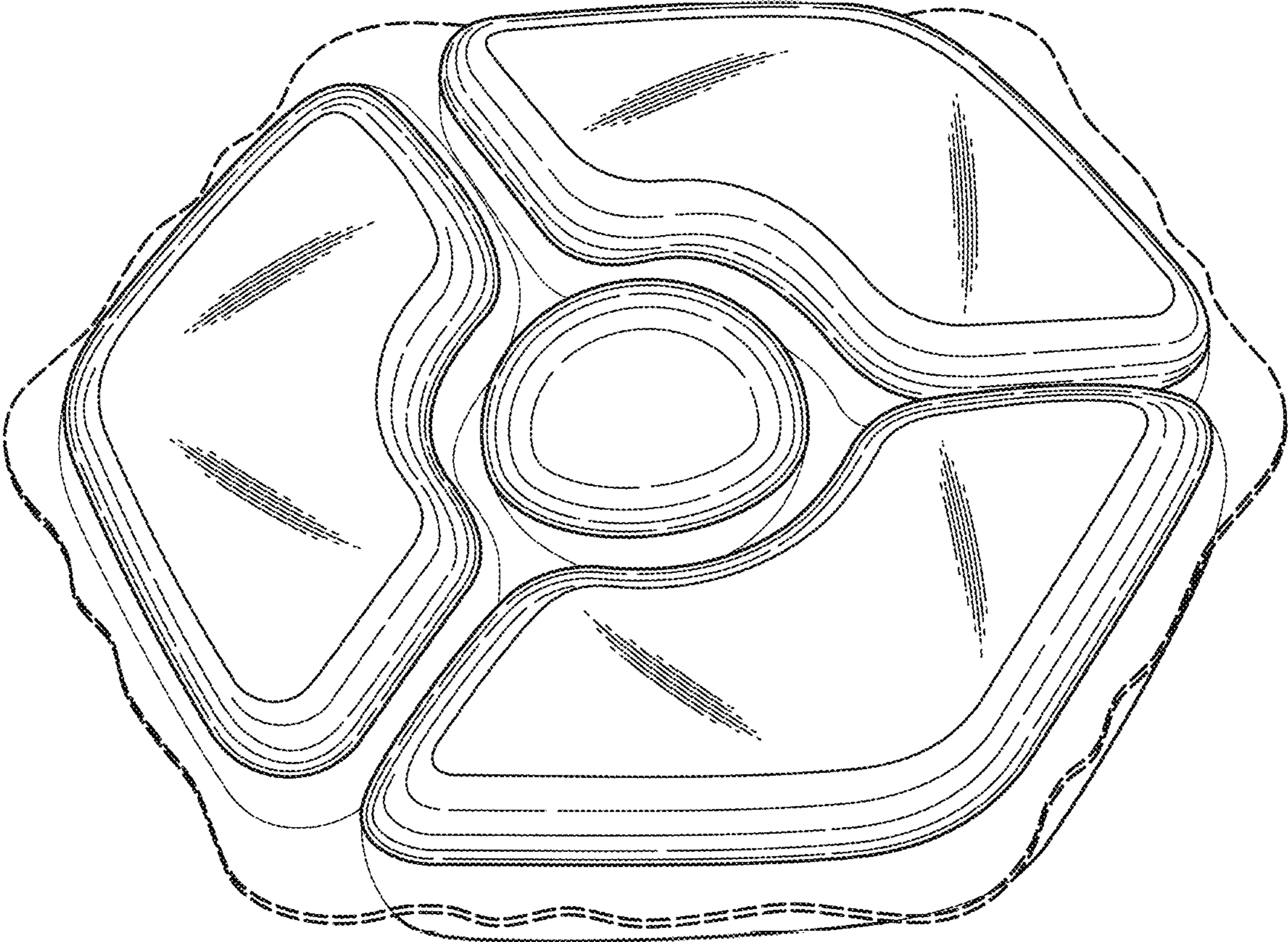

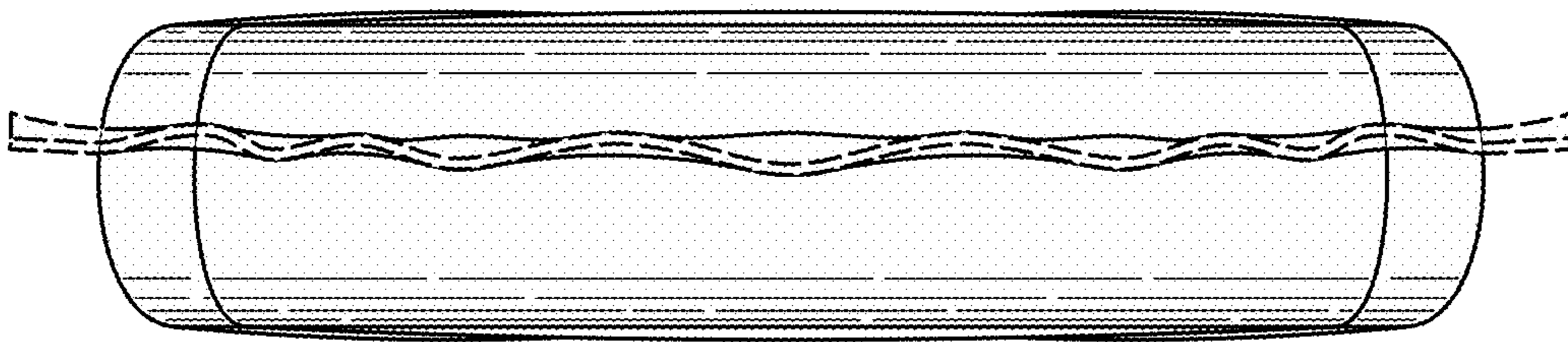

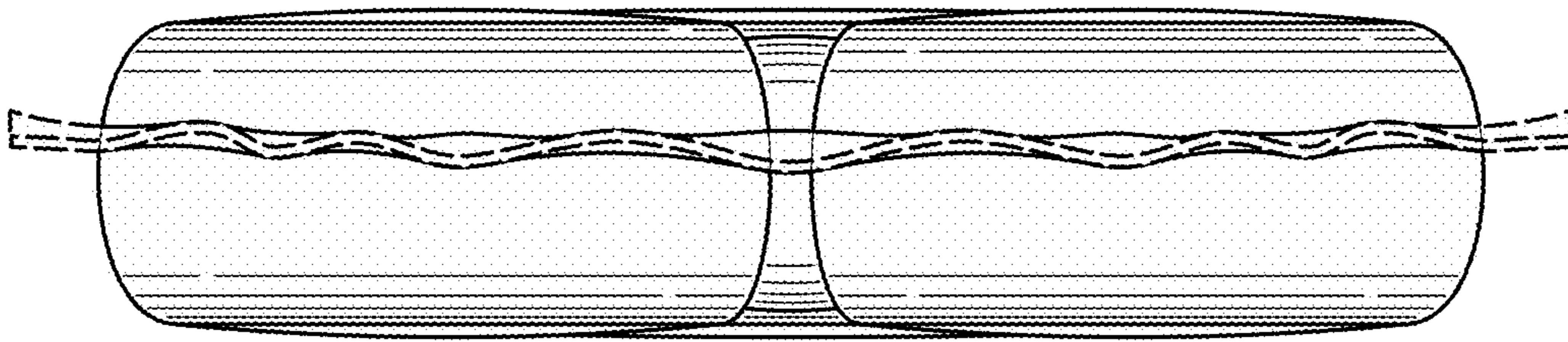

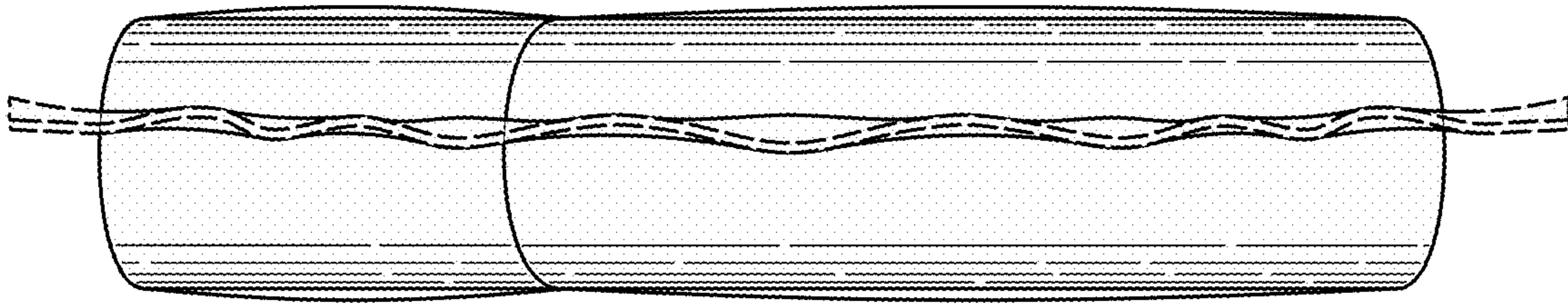

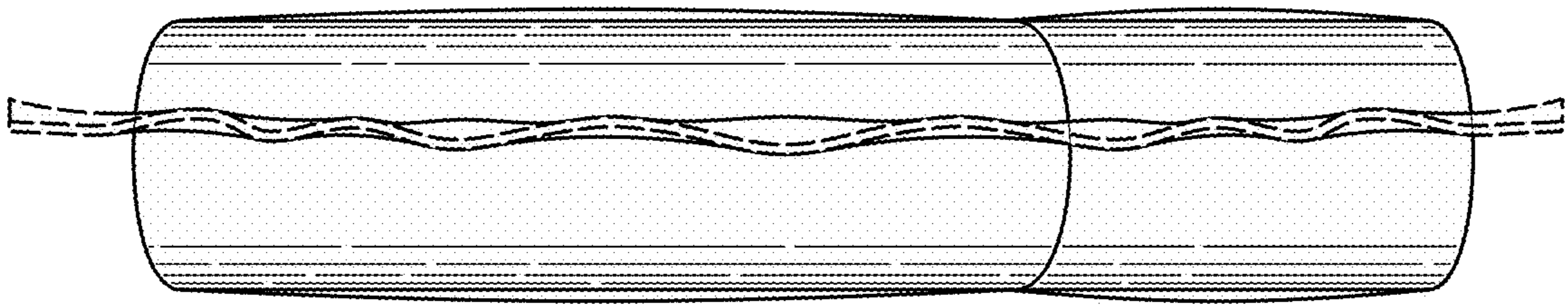

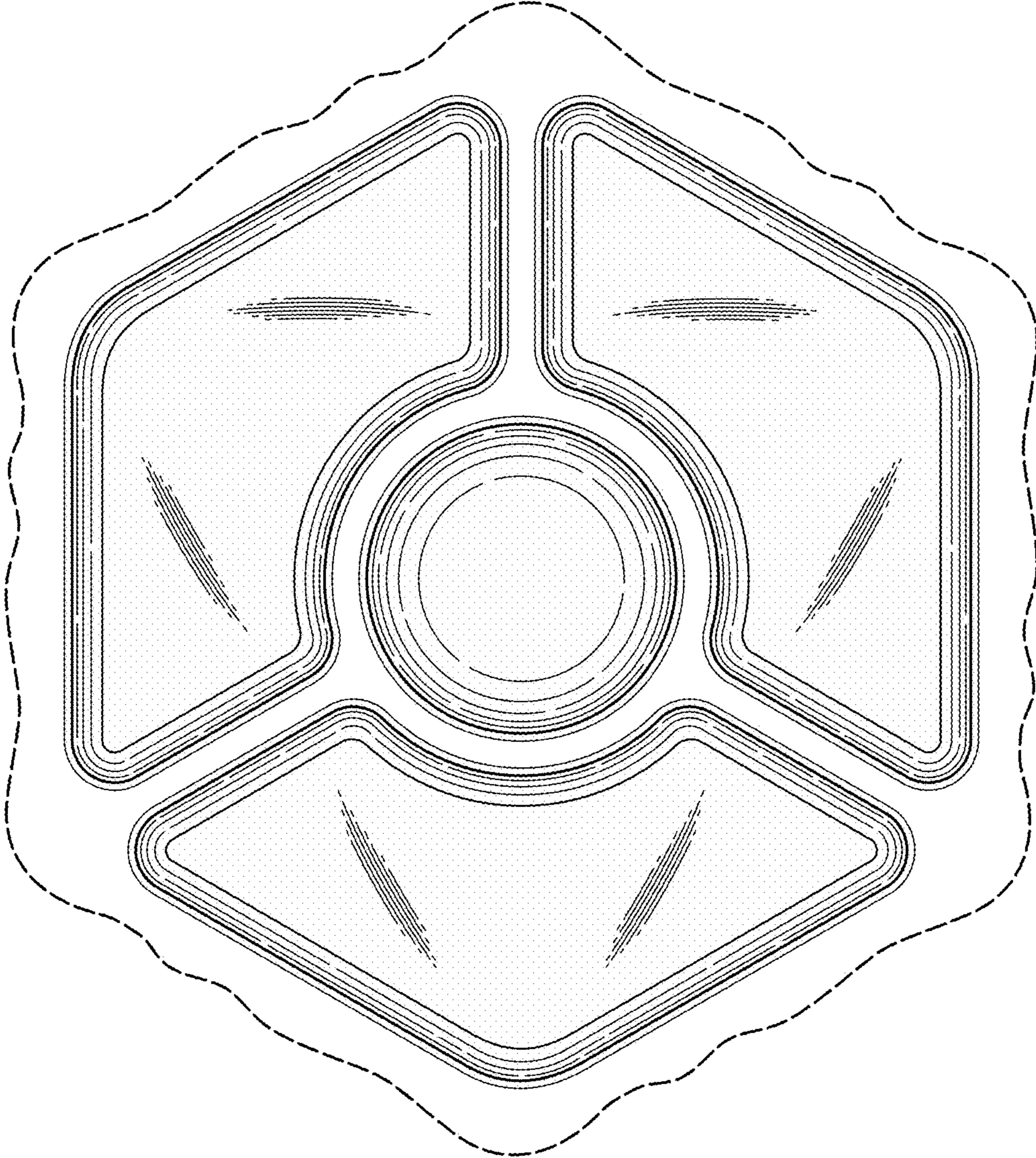

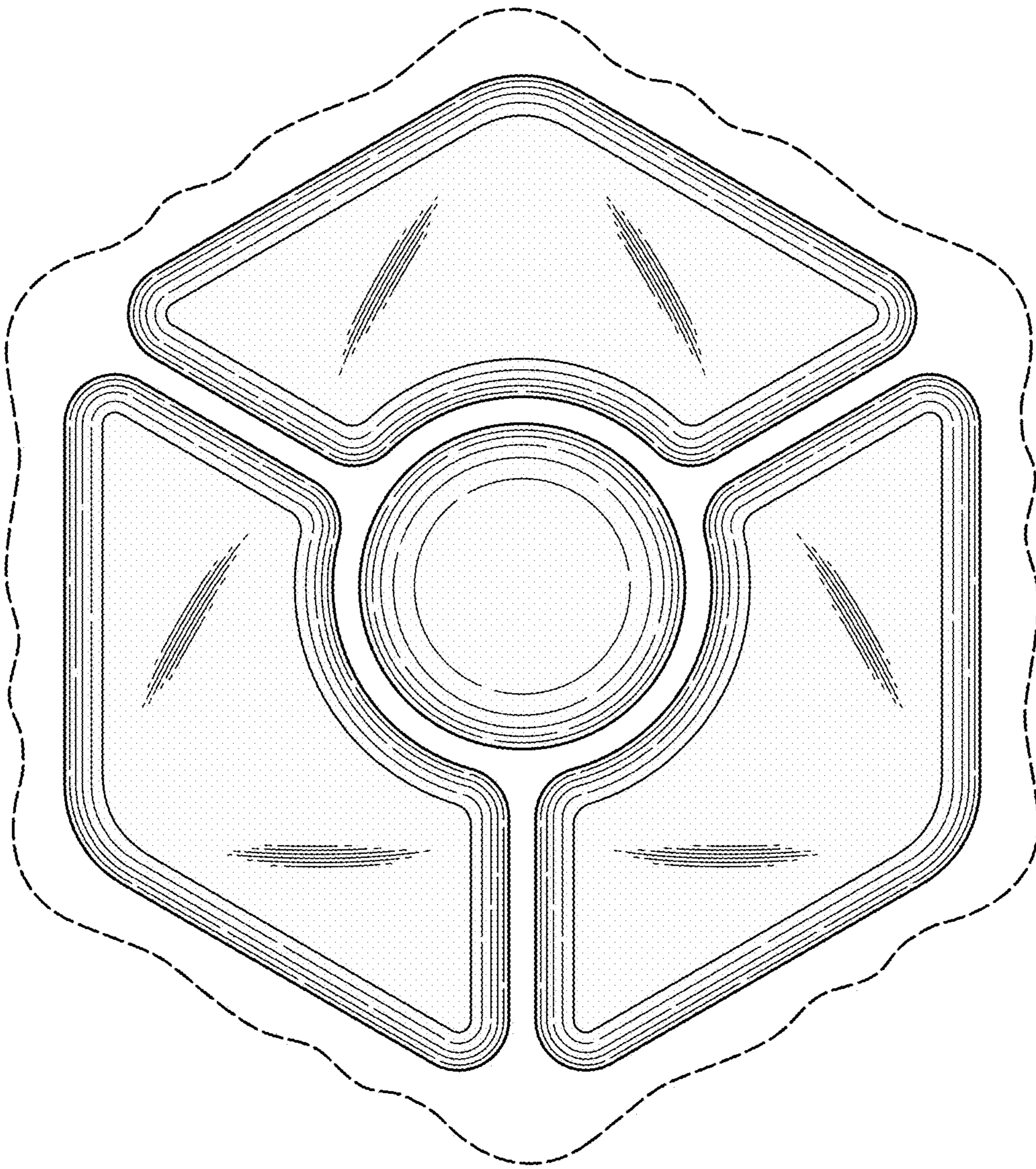

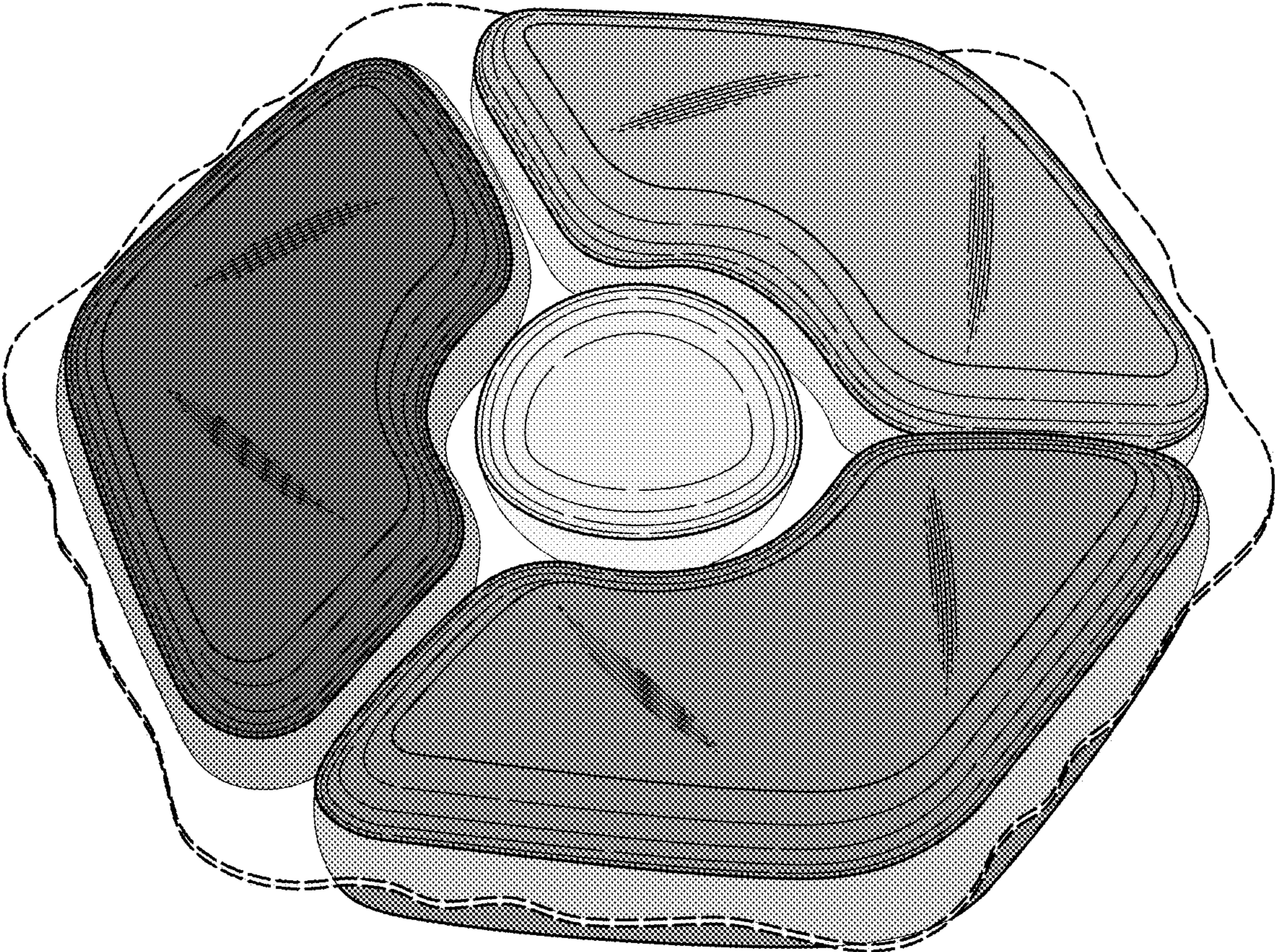

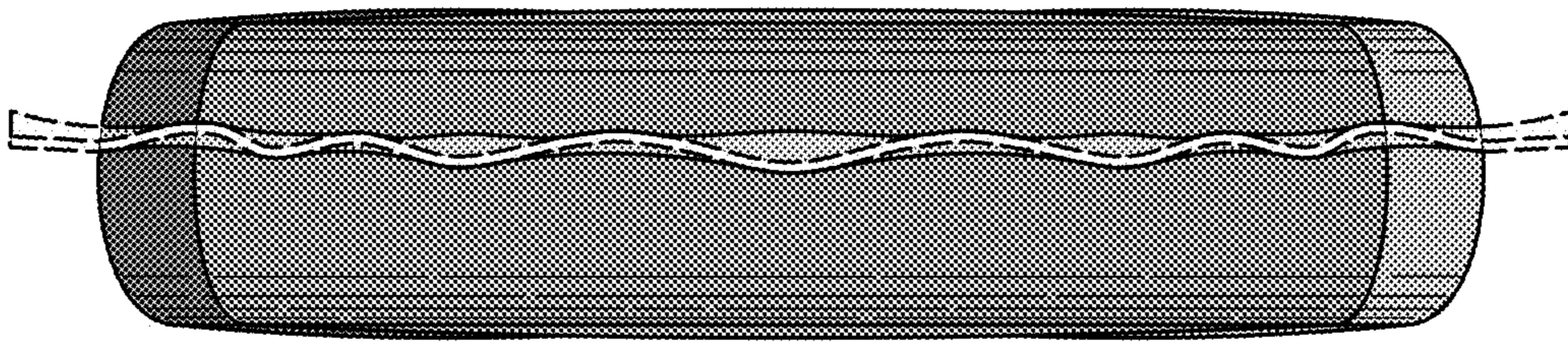

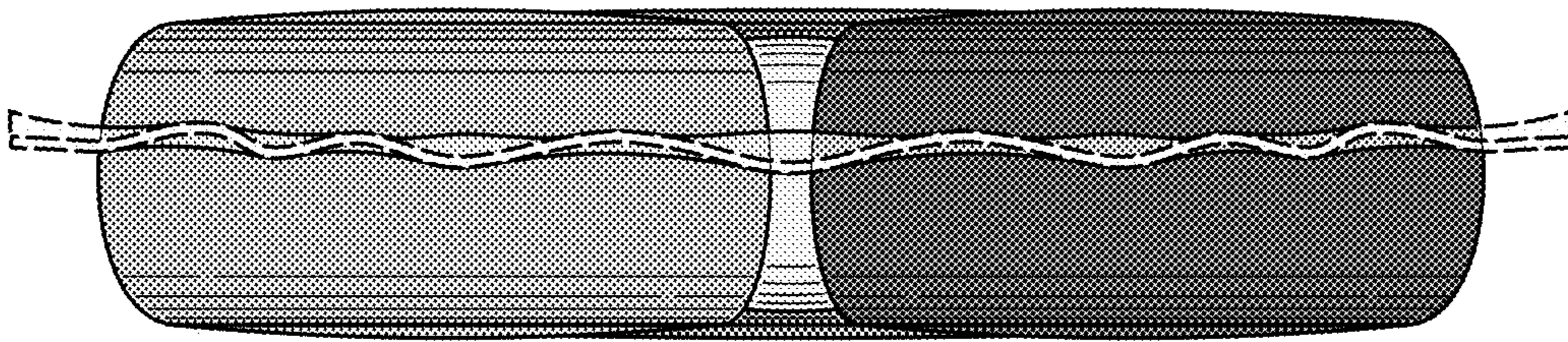

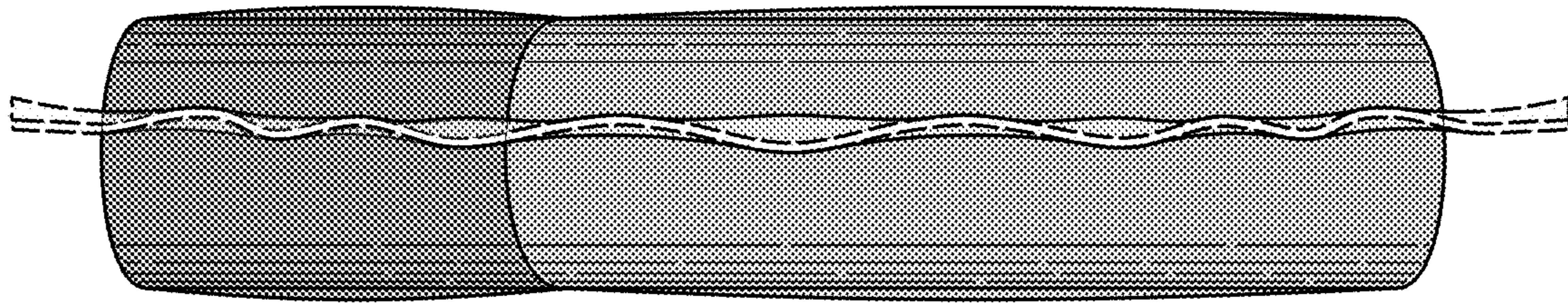

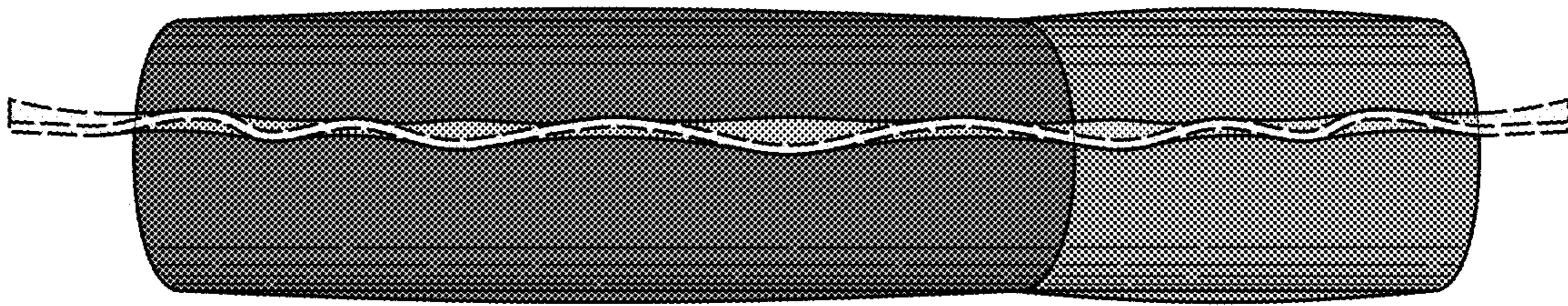

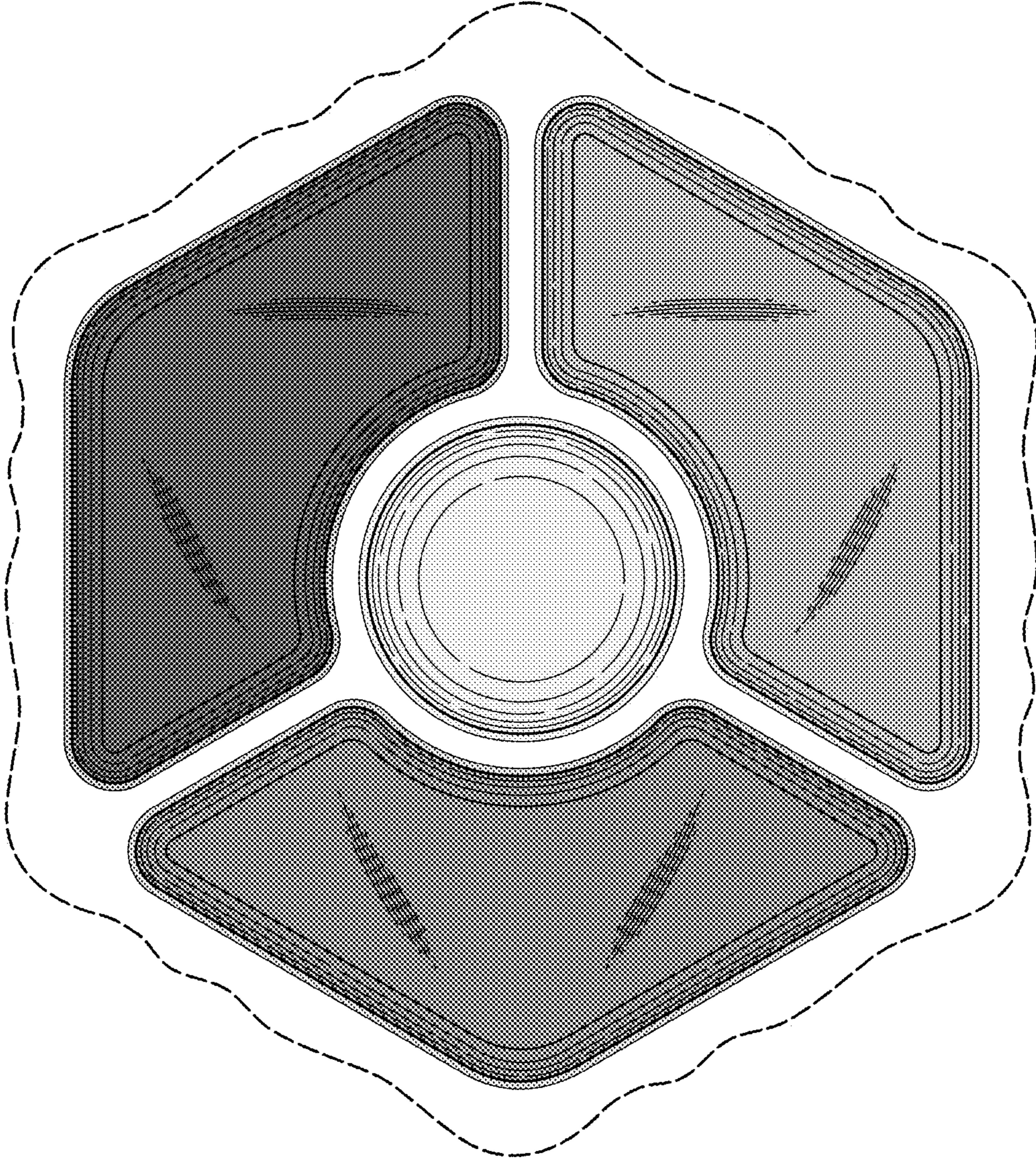

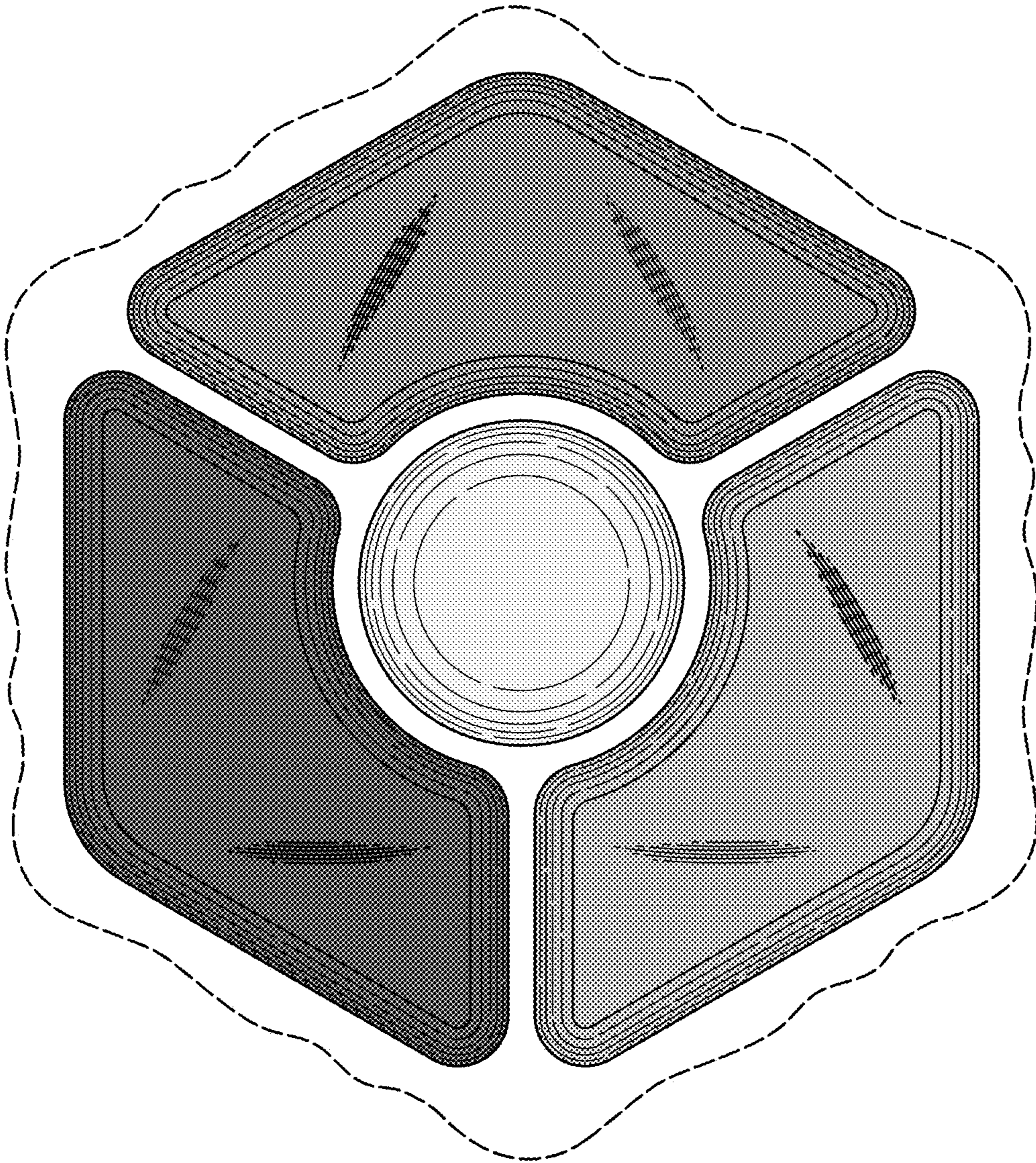
