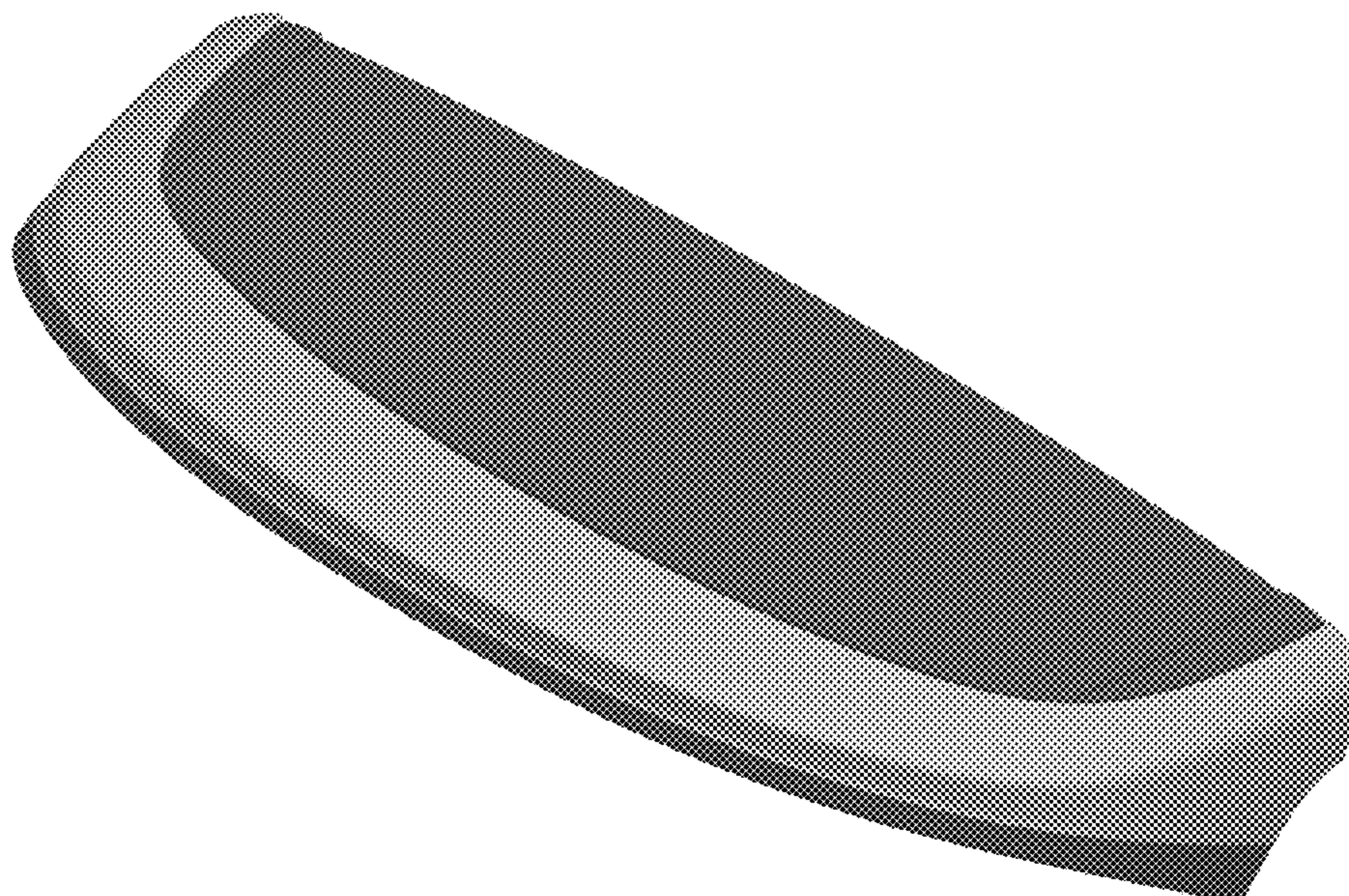
(57) **CLAIM**

The ornamental design for a rear spoiler for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front right top perspective view of a rear spoiler for a vehicle according to the present invention.
 FIG. 2 is a rear right top perspective view of the rear spoiler shown in FIG. 1.
 FIG. 3 is a rear left top perspective view thereof.
 FIG. 4 is a rear right bottom perspective view thereof.
 FIG. 5 is a front view thereof.
 FIG. 6 is a rear view thereof.
 FIG. 7 is a right side view thereof, enlarged for ease of illustration.
 FIG. 8 is a left side perspective view thereof, enlarged for ease of illustration.
 FIG. 9 is a top view thereof.
 FIG. 10 is a bottom view thereof; and,
 FIG. 11 is a top view of the rear spoiler shown in FIGS. 1-10, shown in a condition of use.
 The broken lines shown in FIG. 11 illustrate environmental structure which forms no part of the claimed design. Further, the broken lines shown in FIGS. 2, 3, 4, 6, and 10 depict portions of the rear spoiler for a vehicle that form no part of the claimed design.

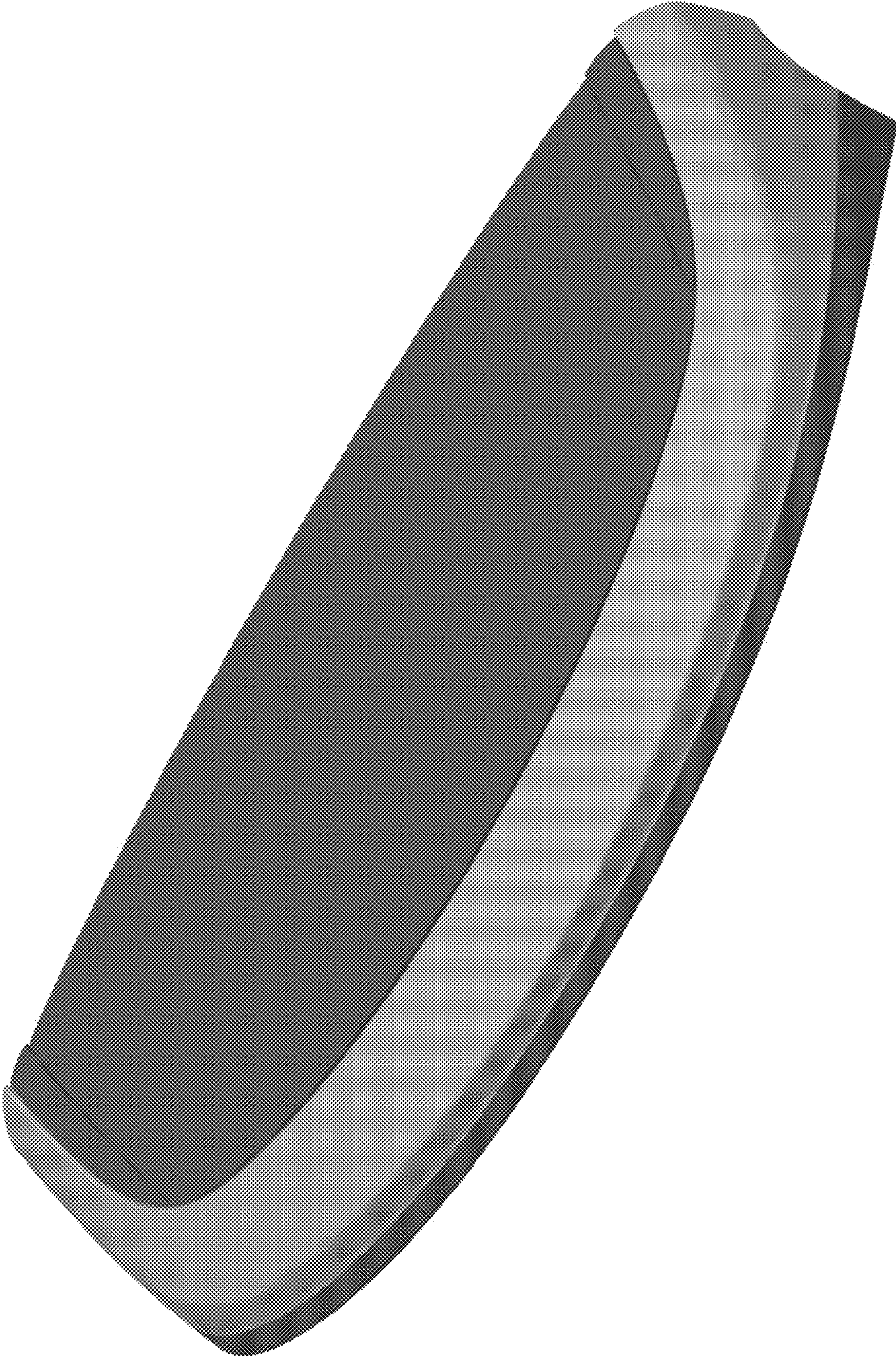

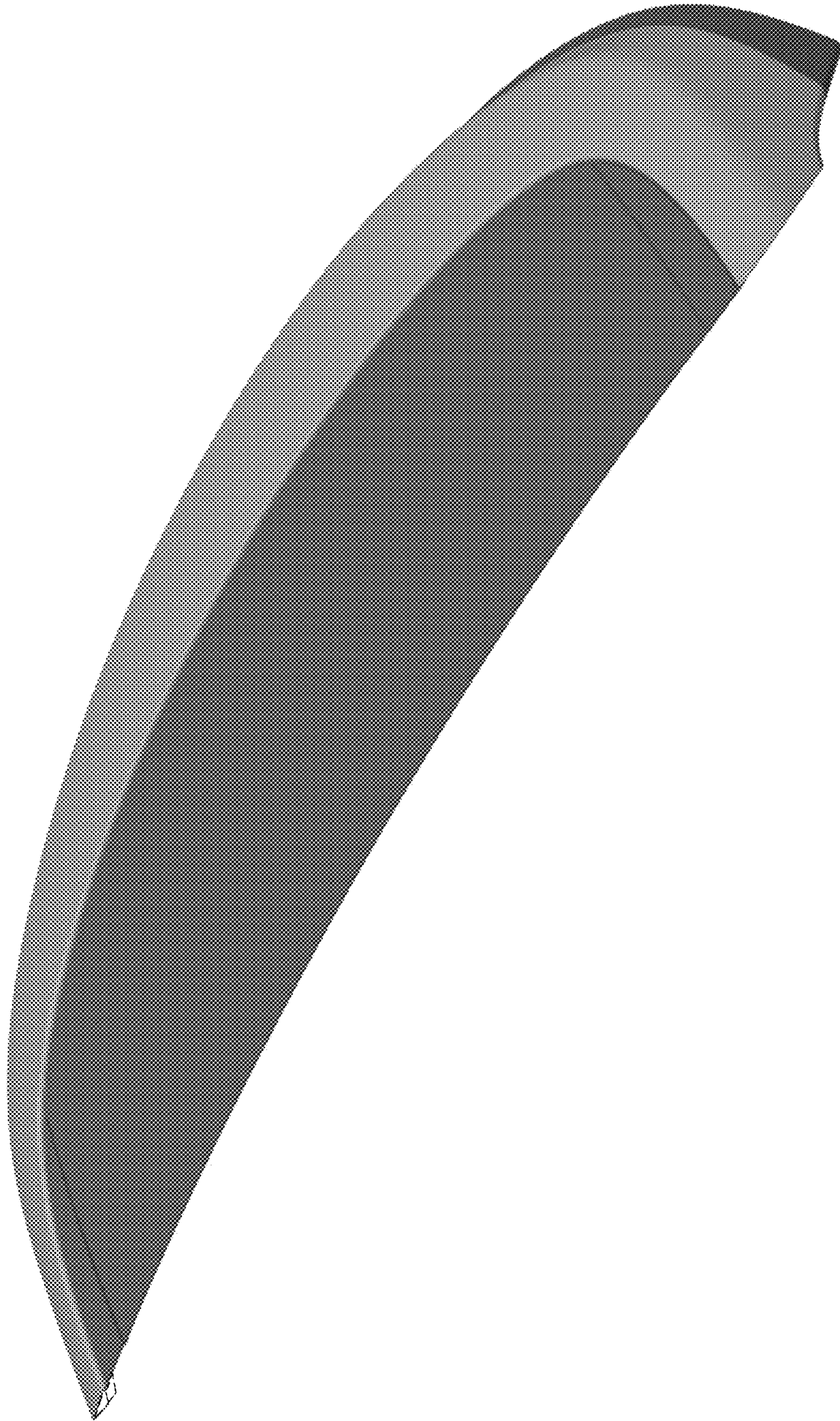

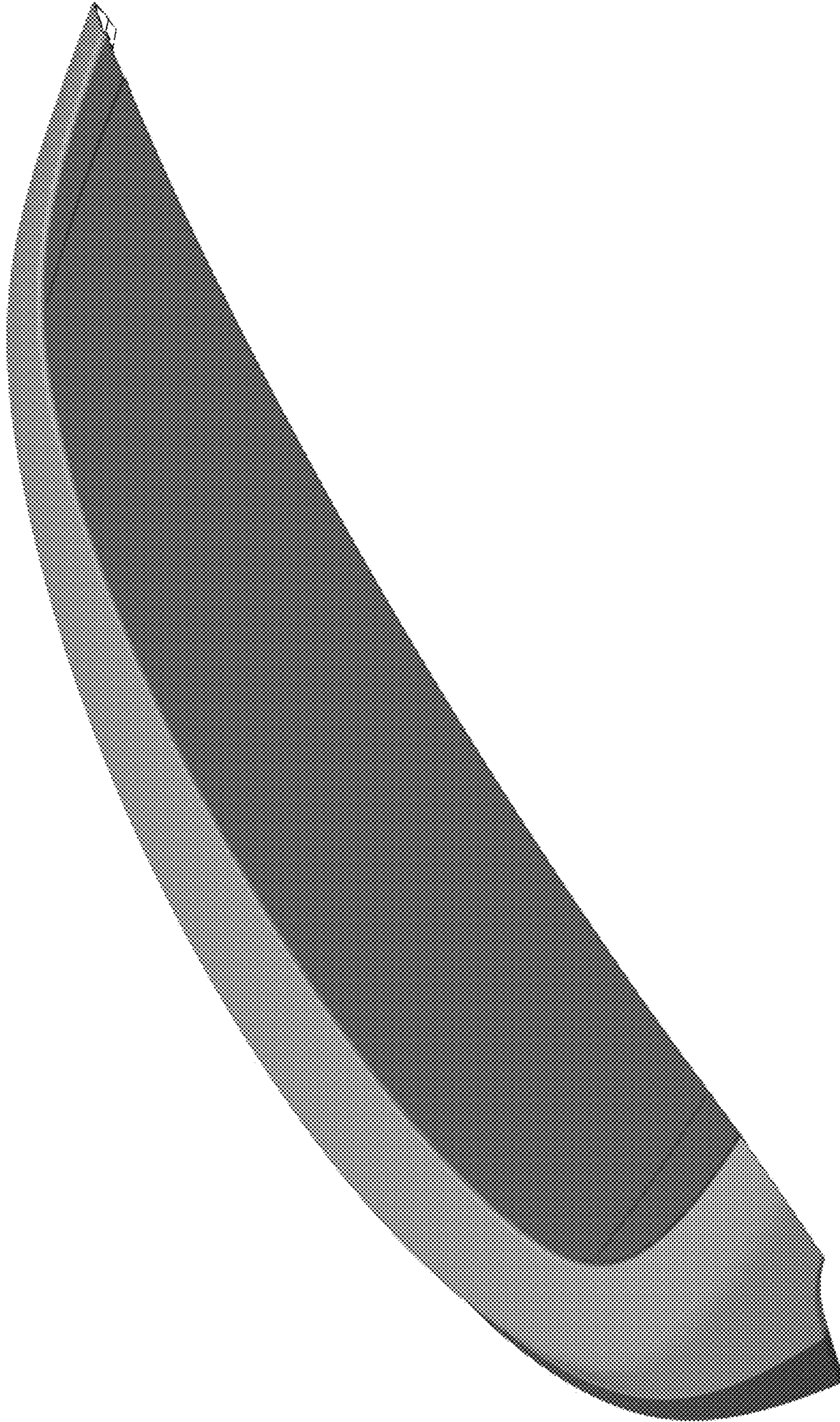

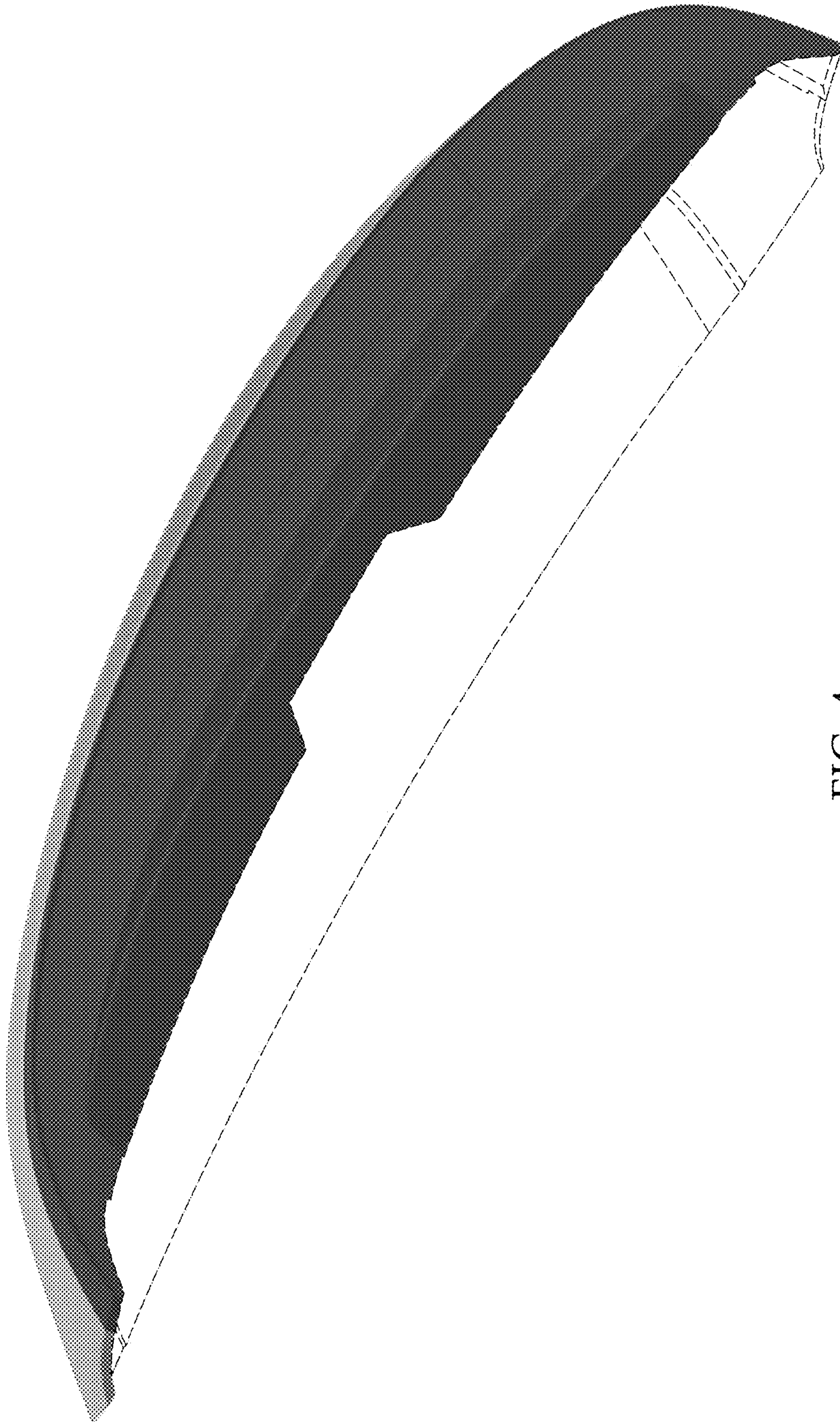

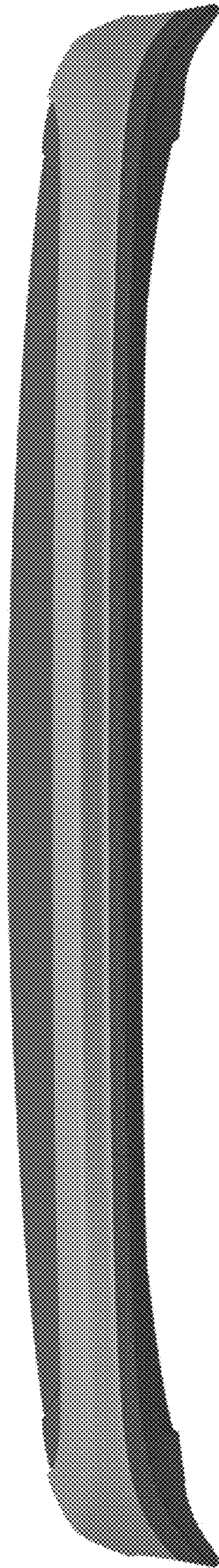

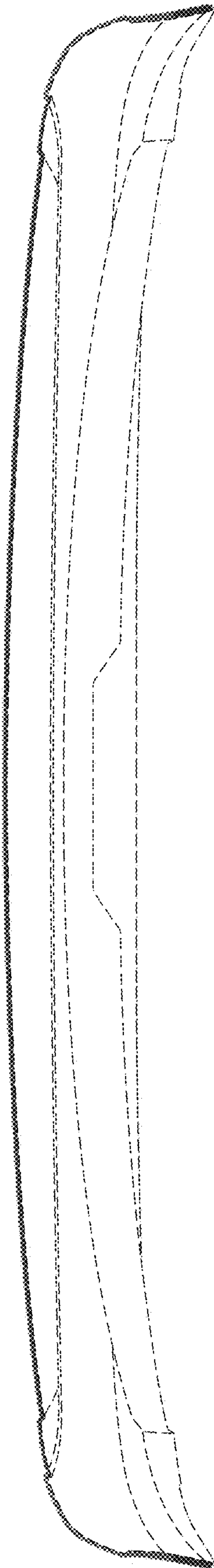

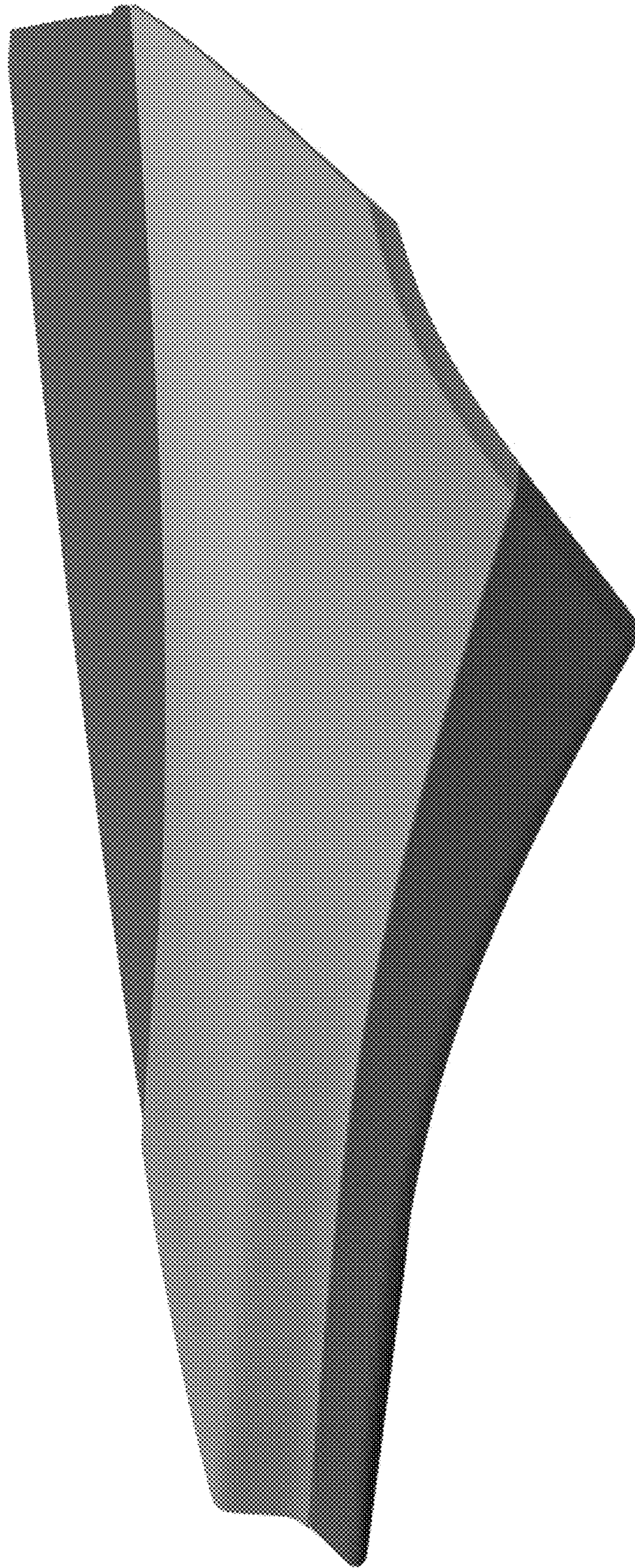

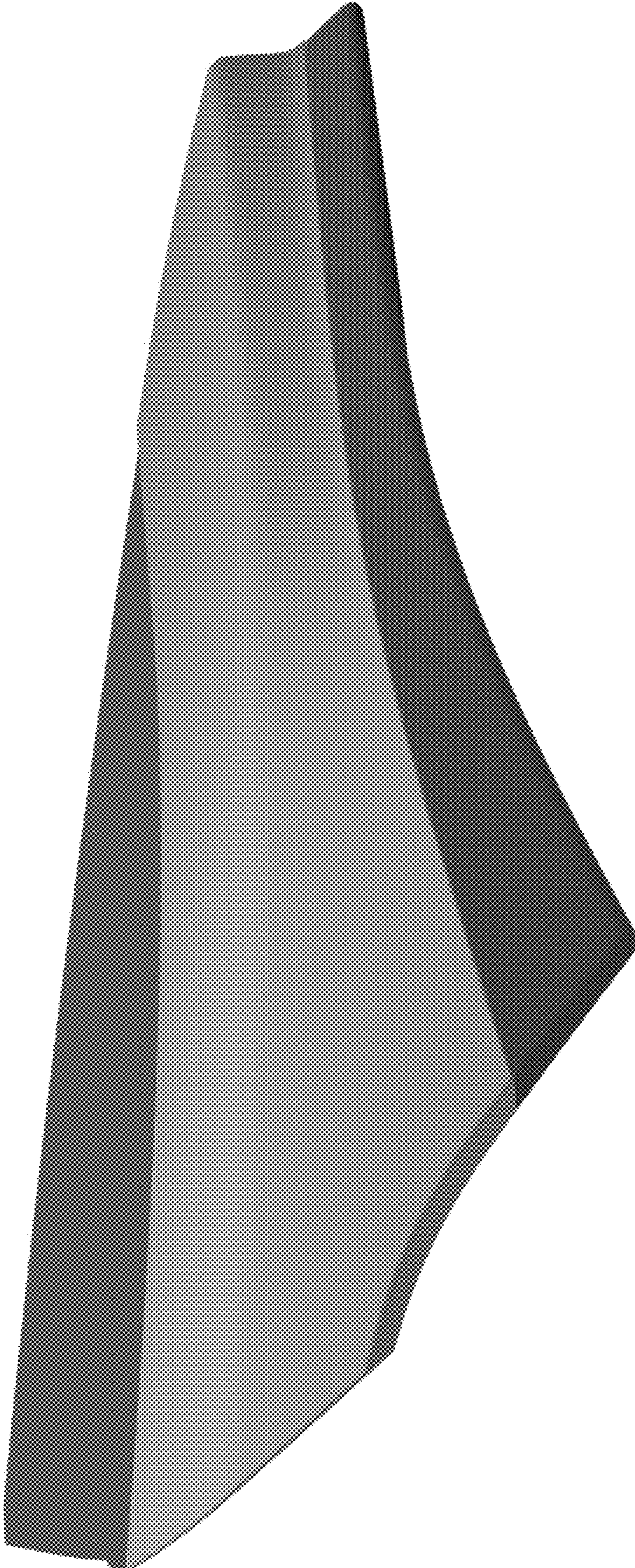

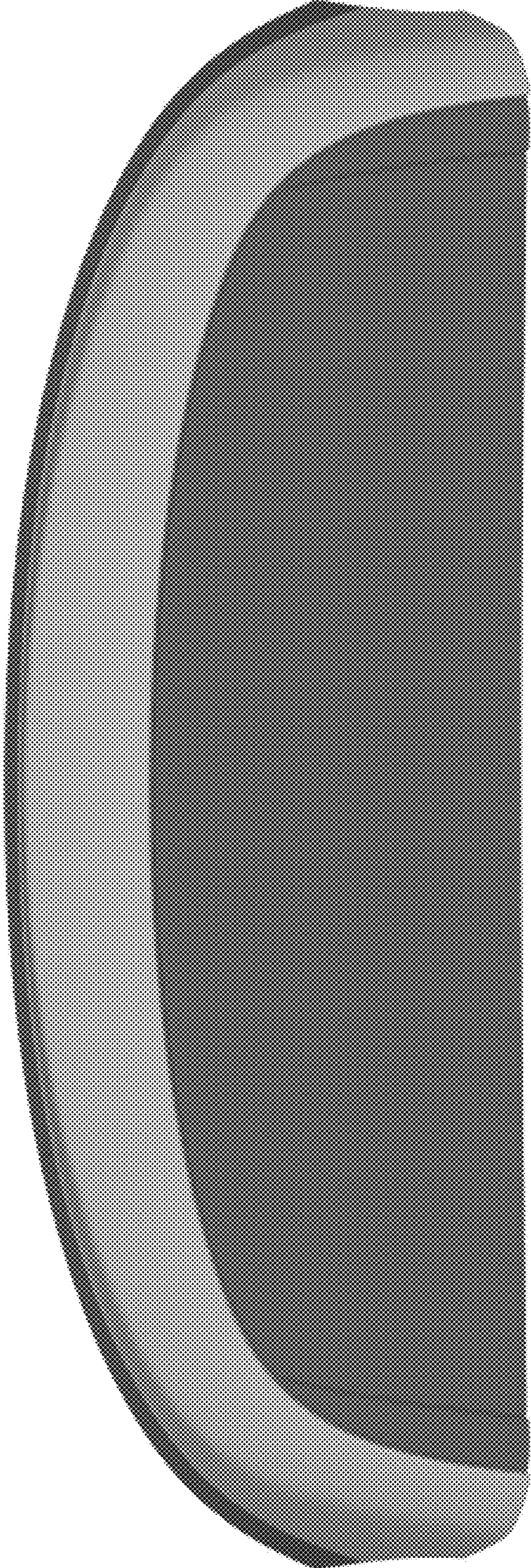

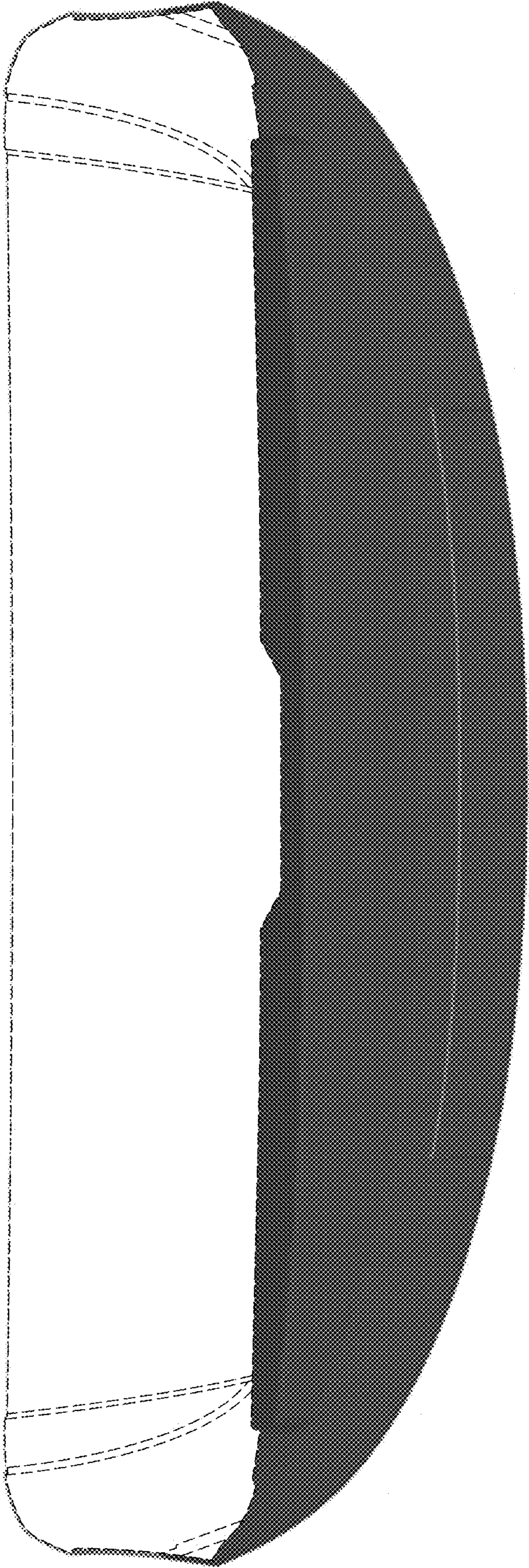
