(57) **CLAIM**

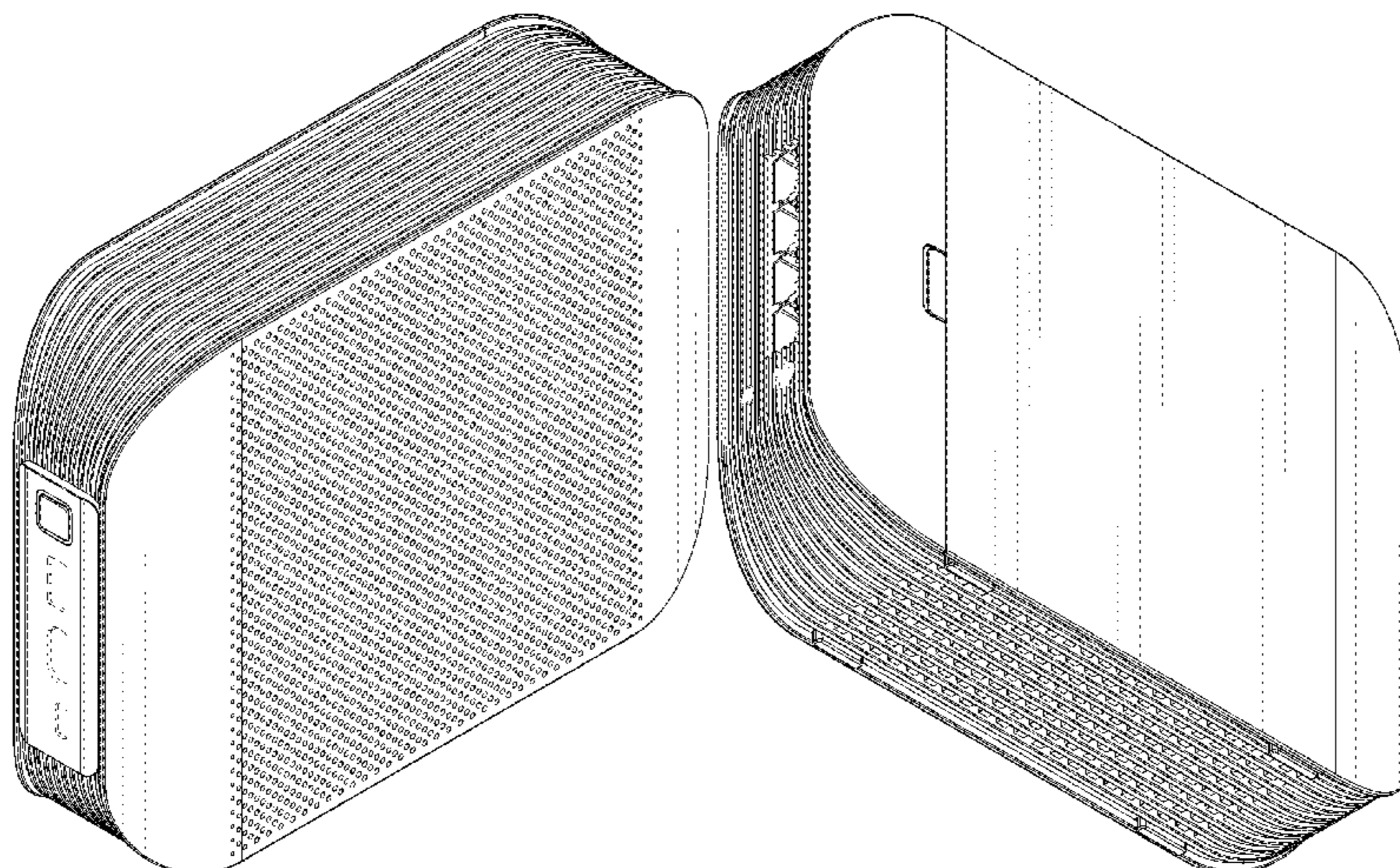
The ornamental design for a network storage device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front top right perspective view of a network storage device, showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a rear, left and bottom perspective view thereof;  
FIG. 9 is a partial enlarged view of the area '9' designated by the dash-dot region in FIG. 2; and,  
FIG. 10 is a partial enlarged view of the area '10' designated by the dash-dot region in FIG. 3.

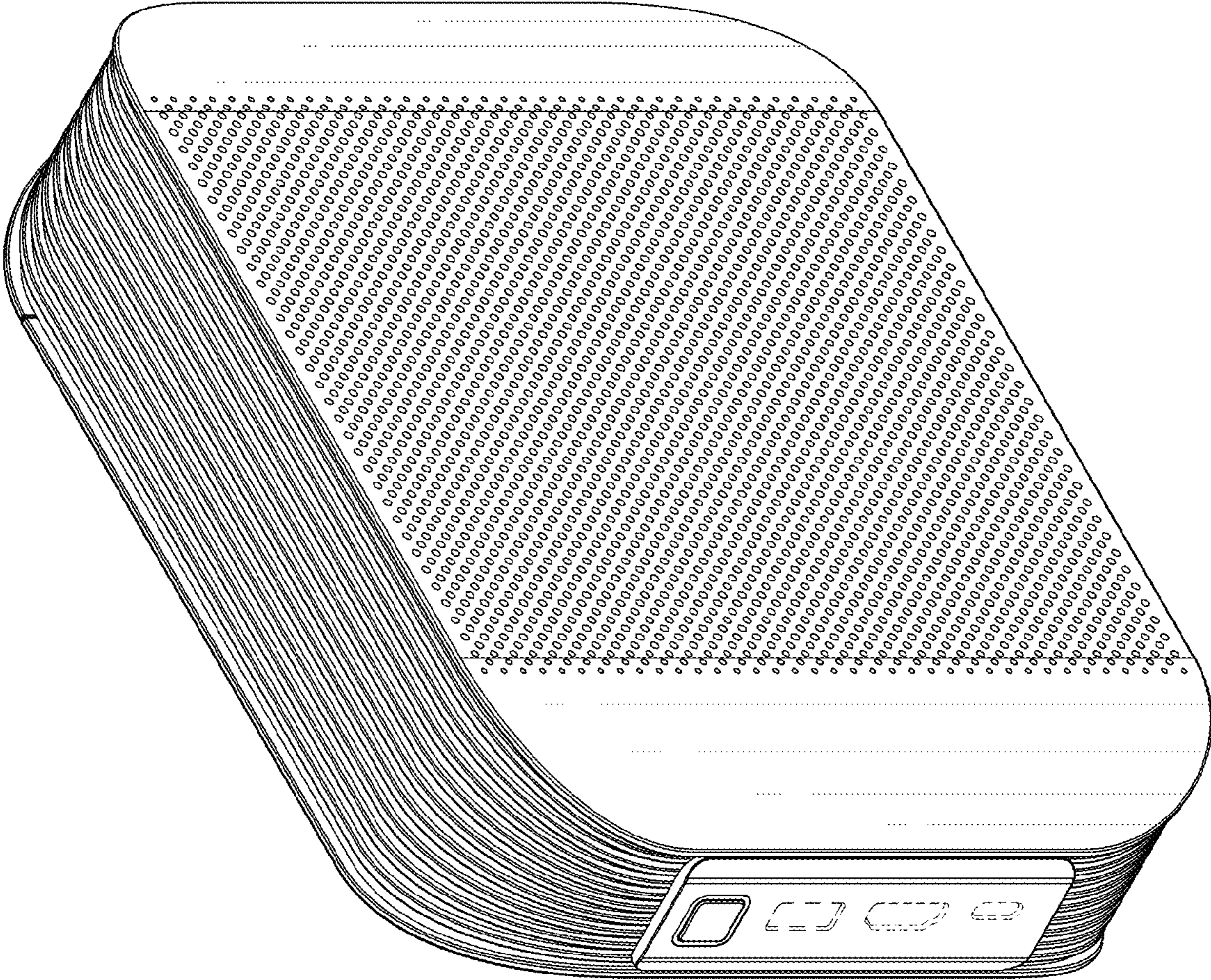

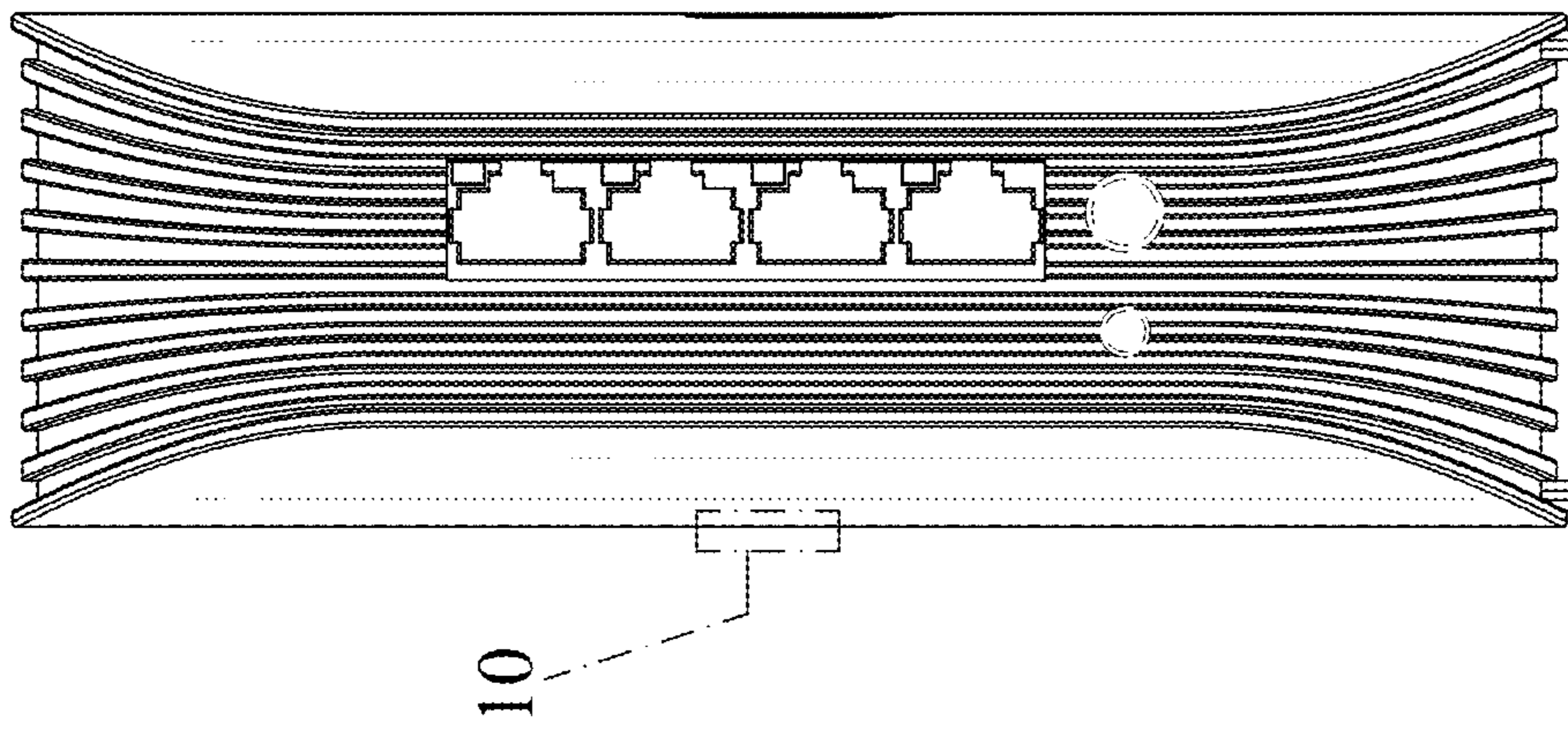

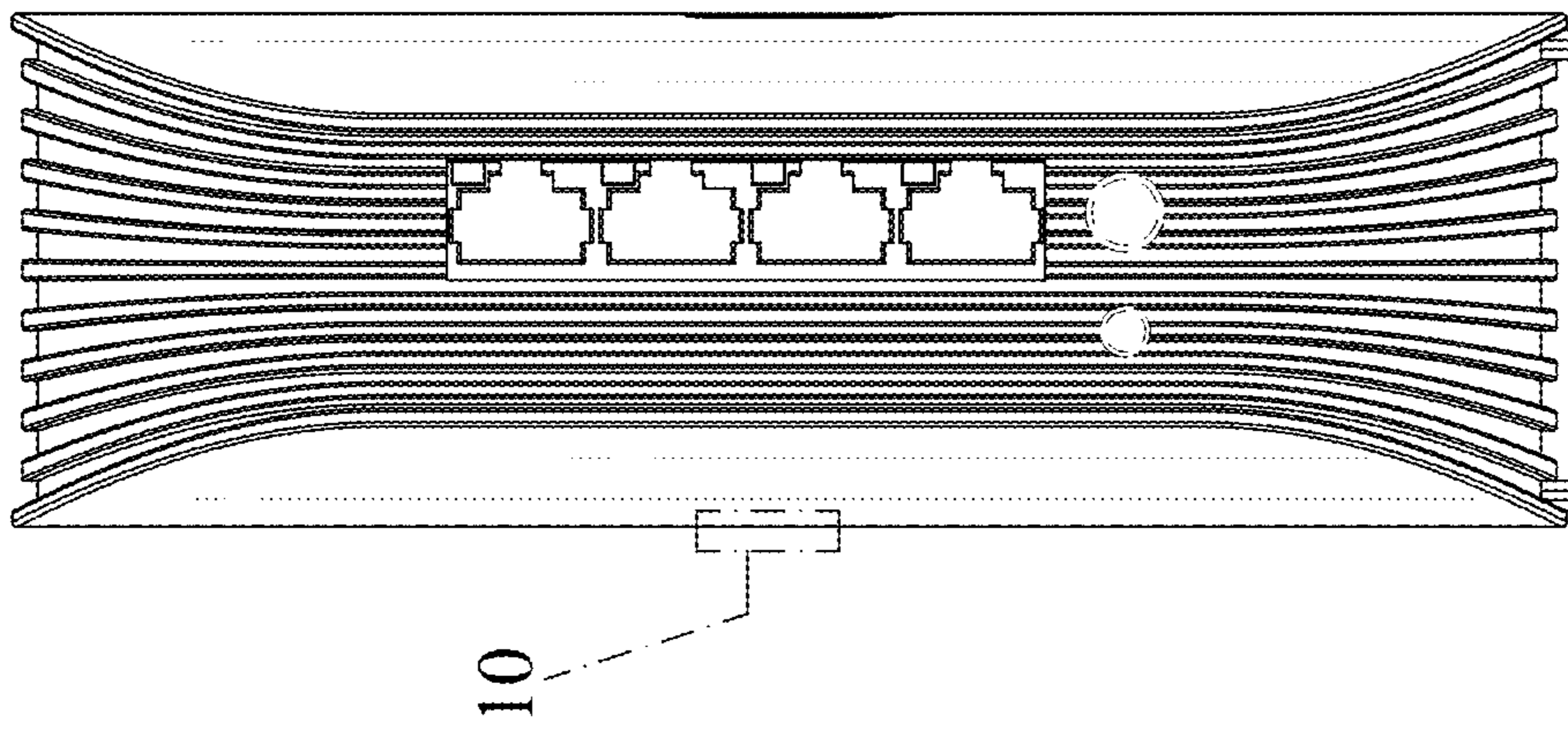

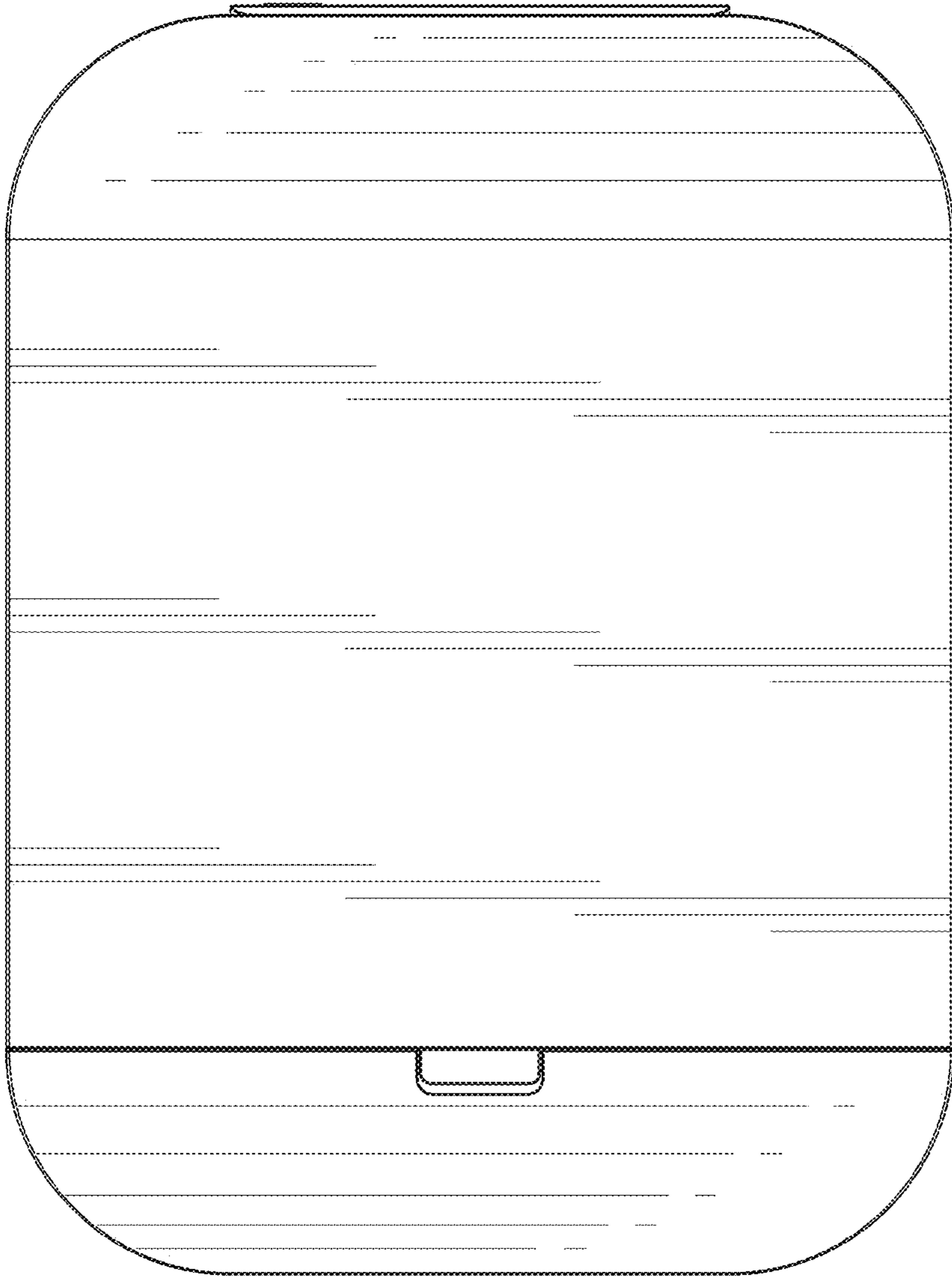

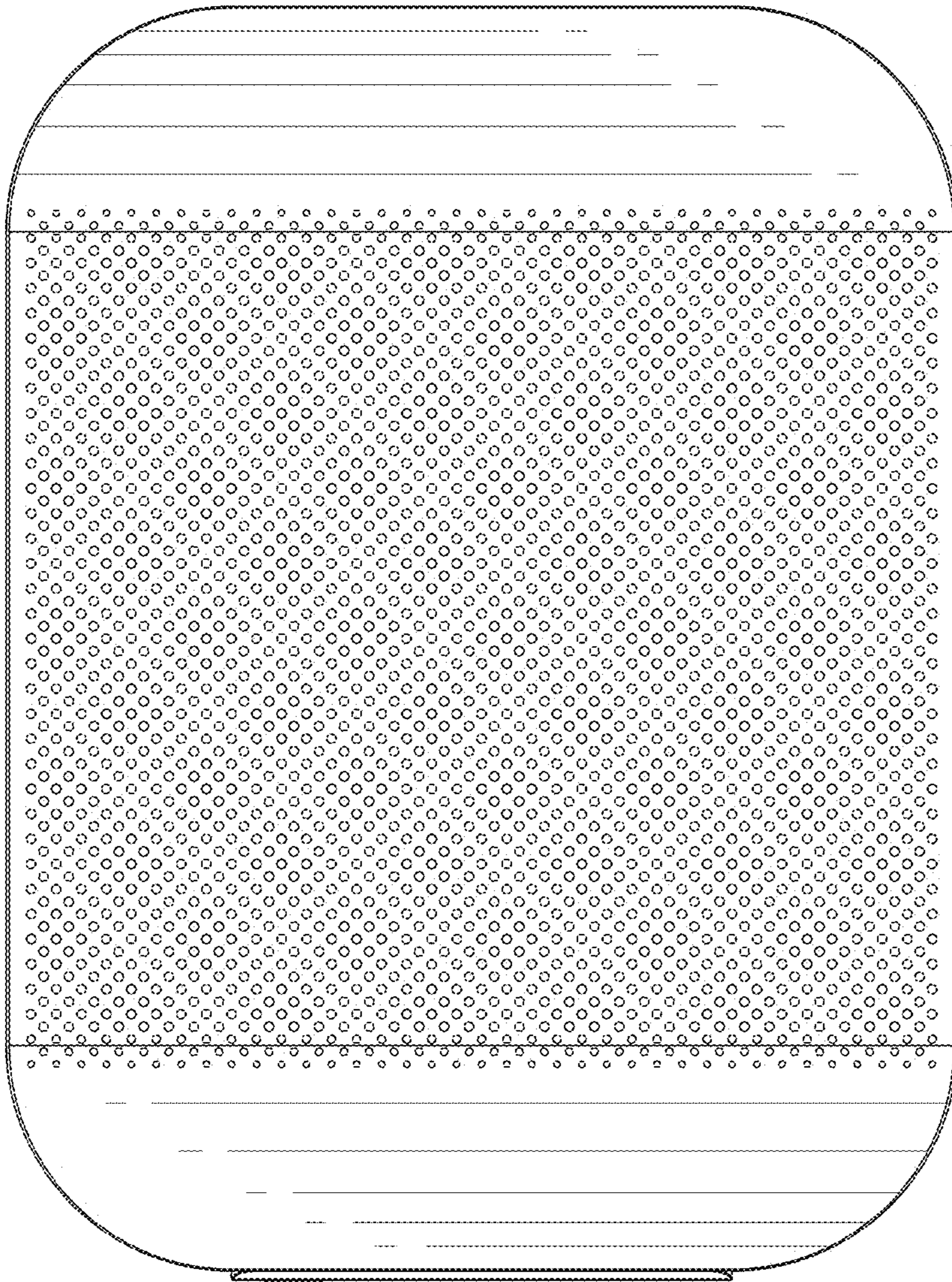

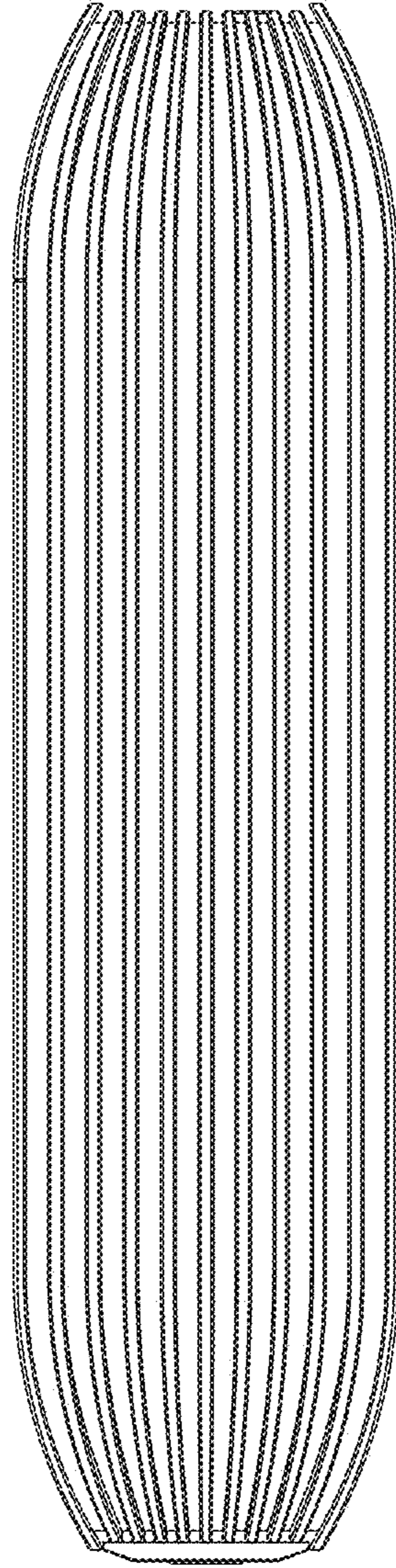

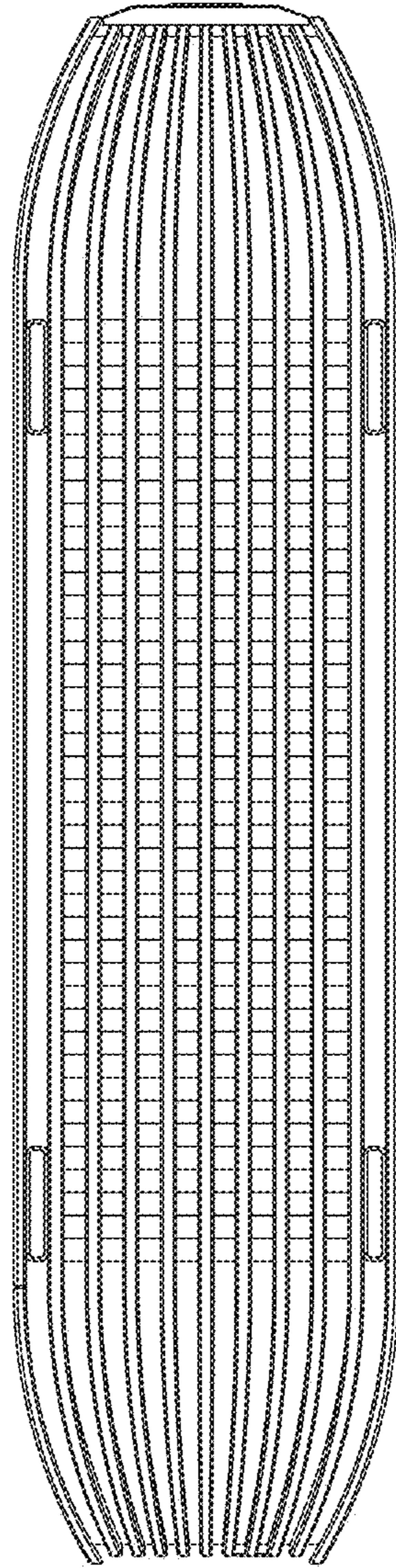

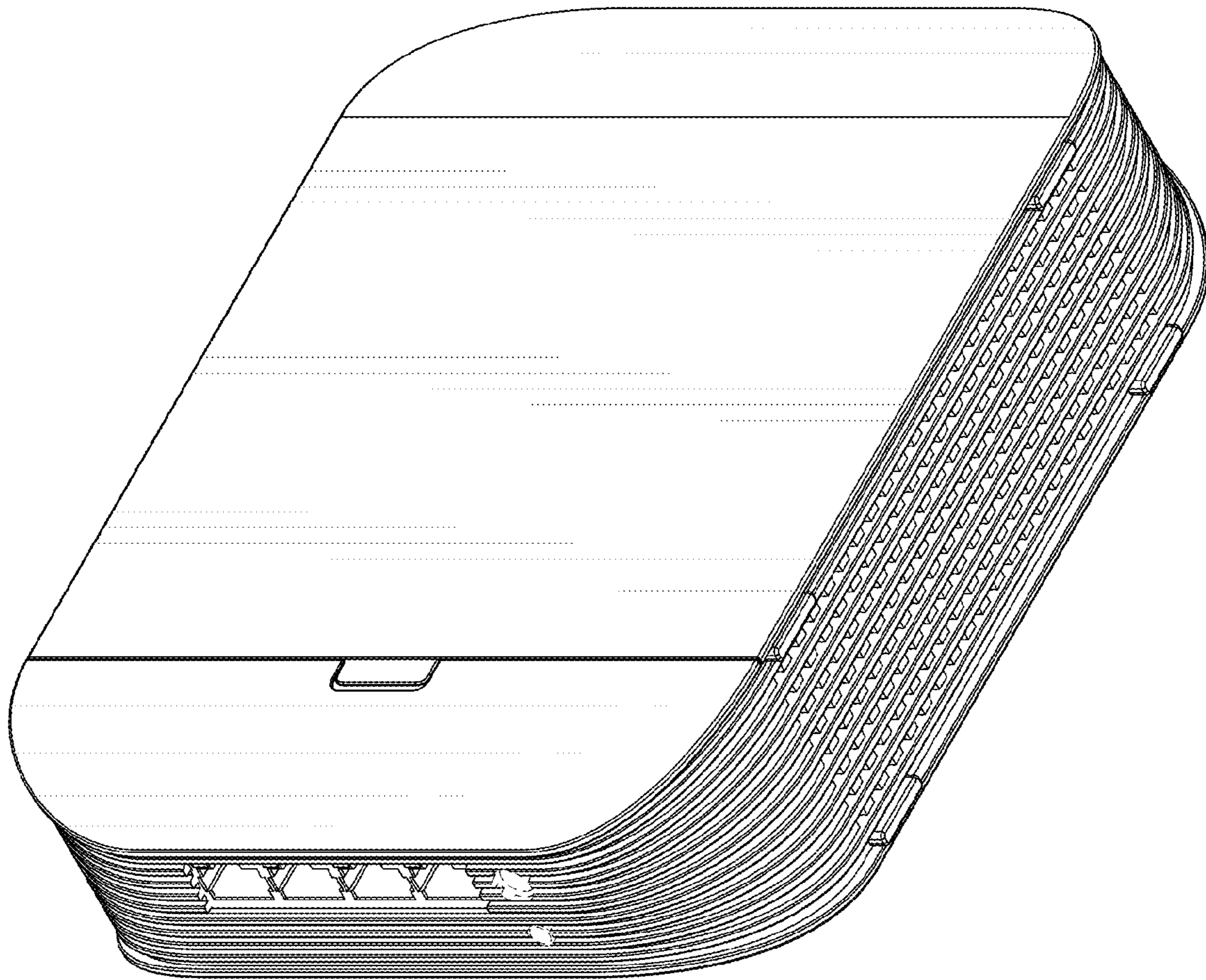

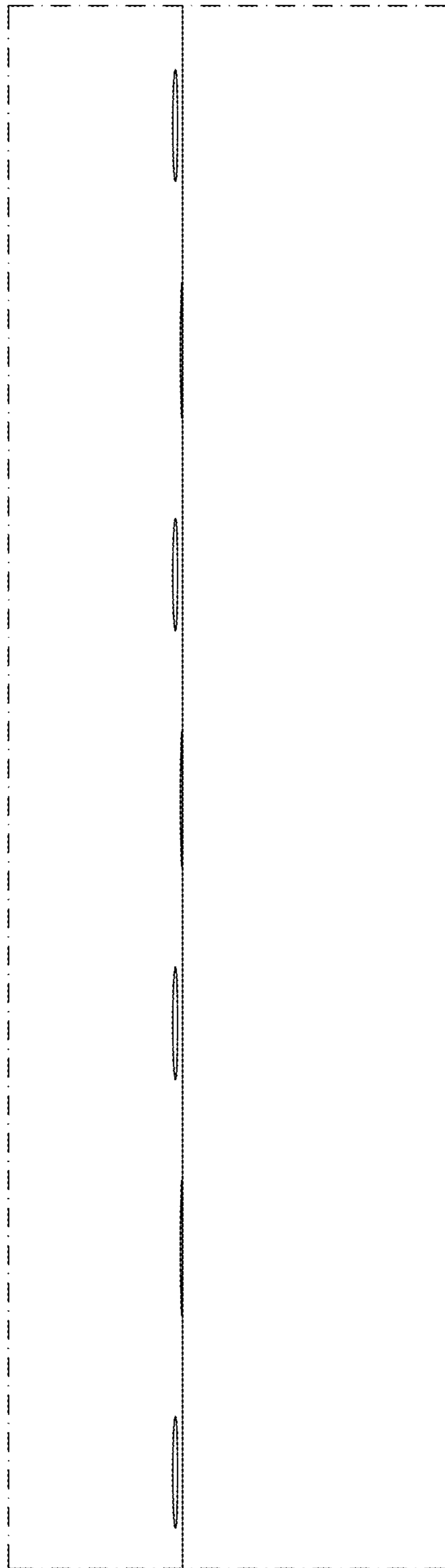

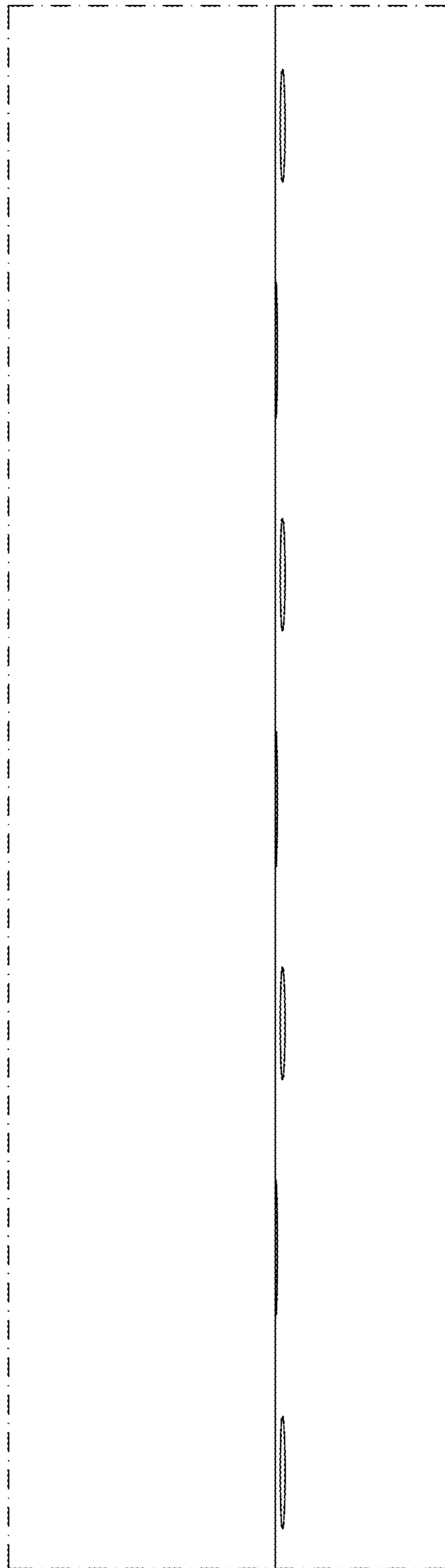
