The ornamental design for a display screen or portions thereof with graphical user interface, as shown and described.

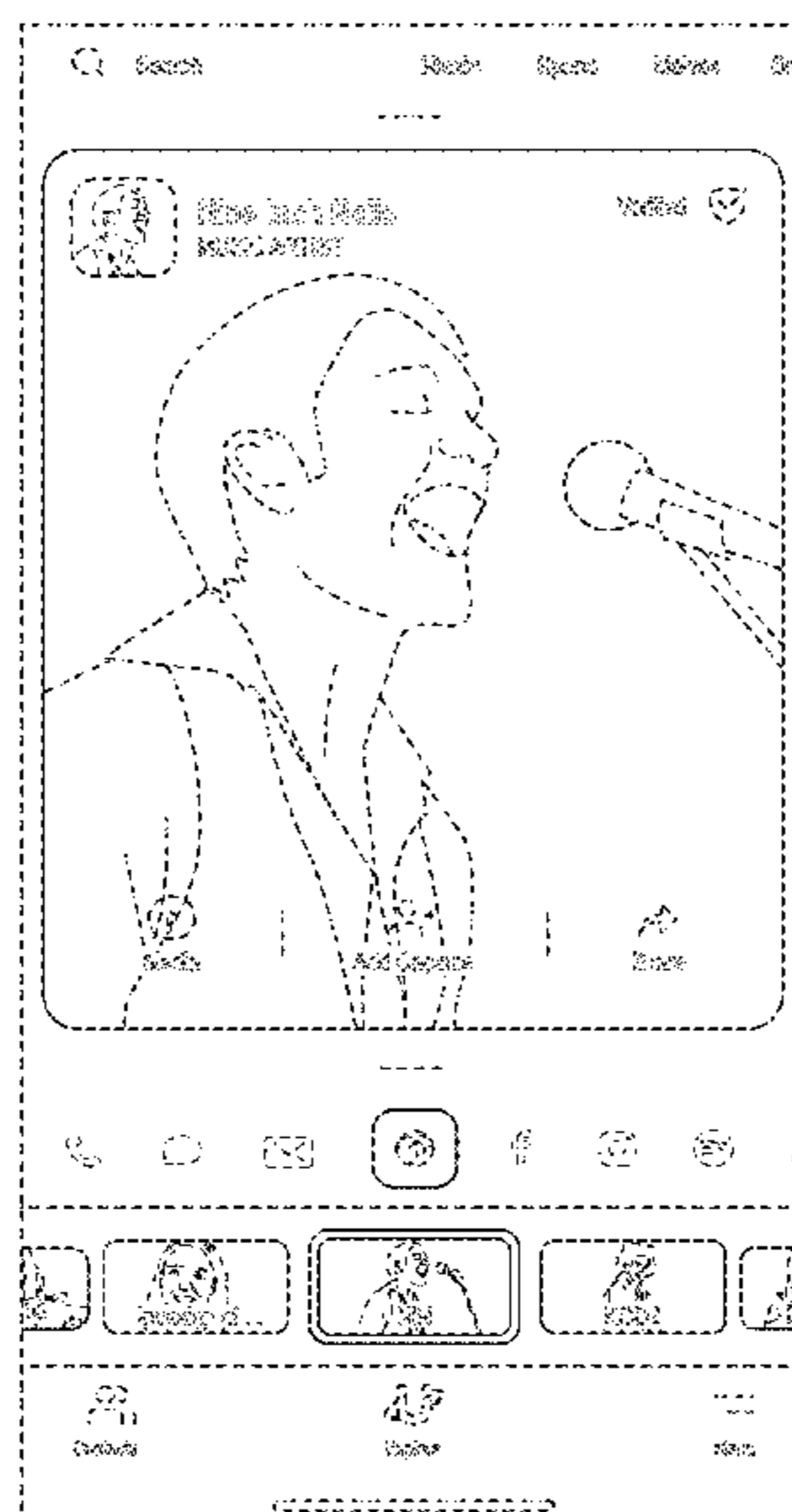
DESCRIPTION

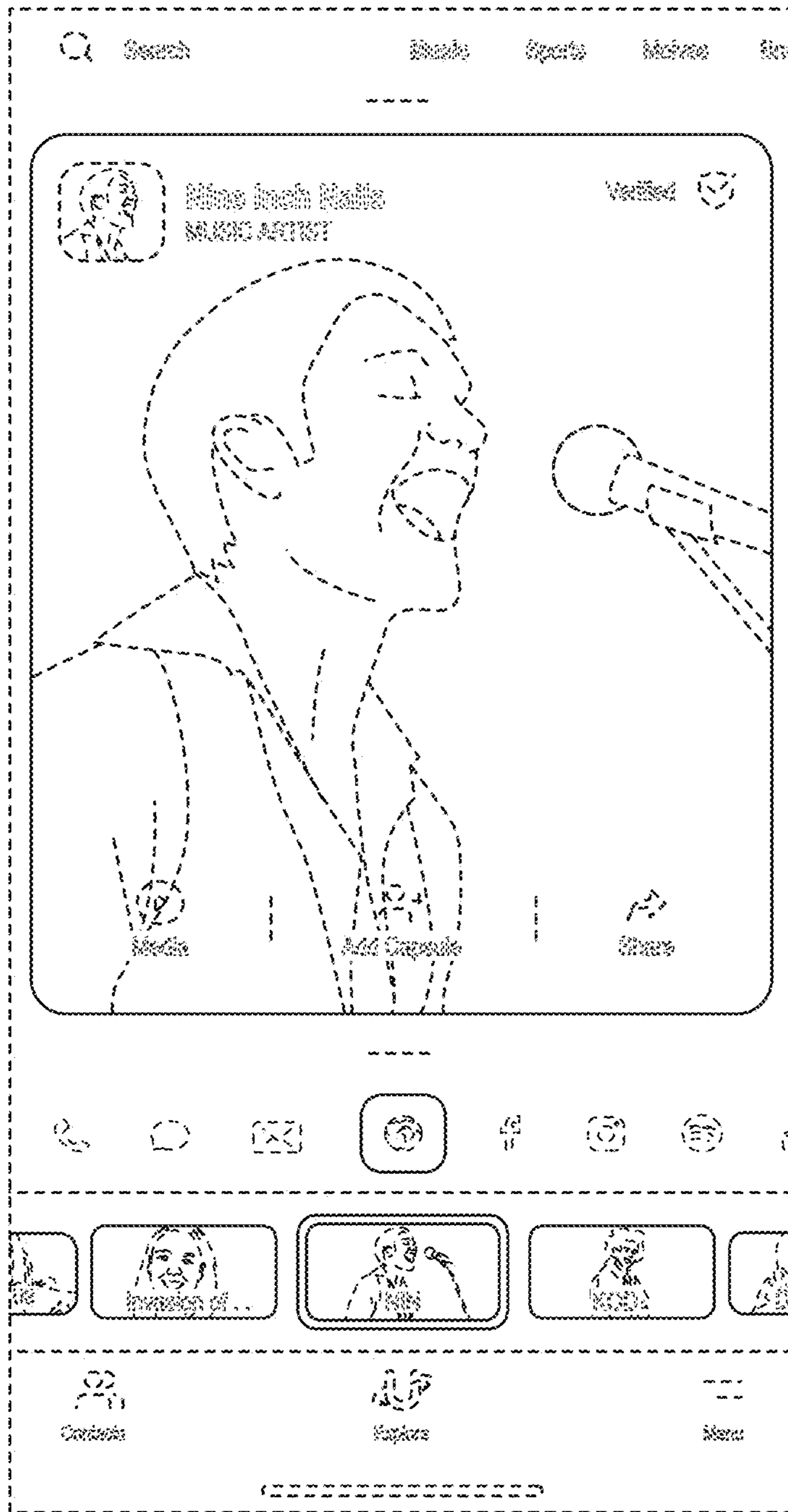

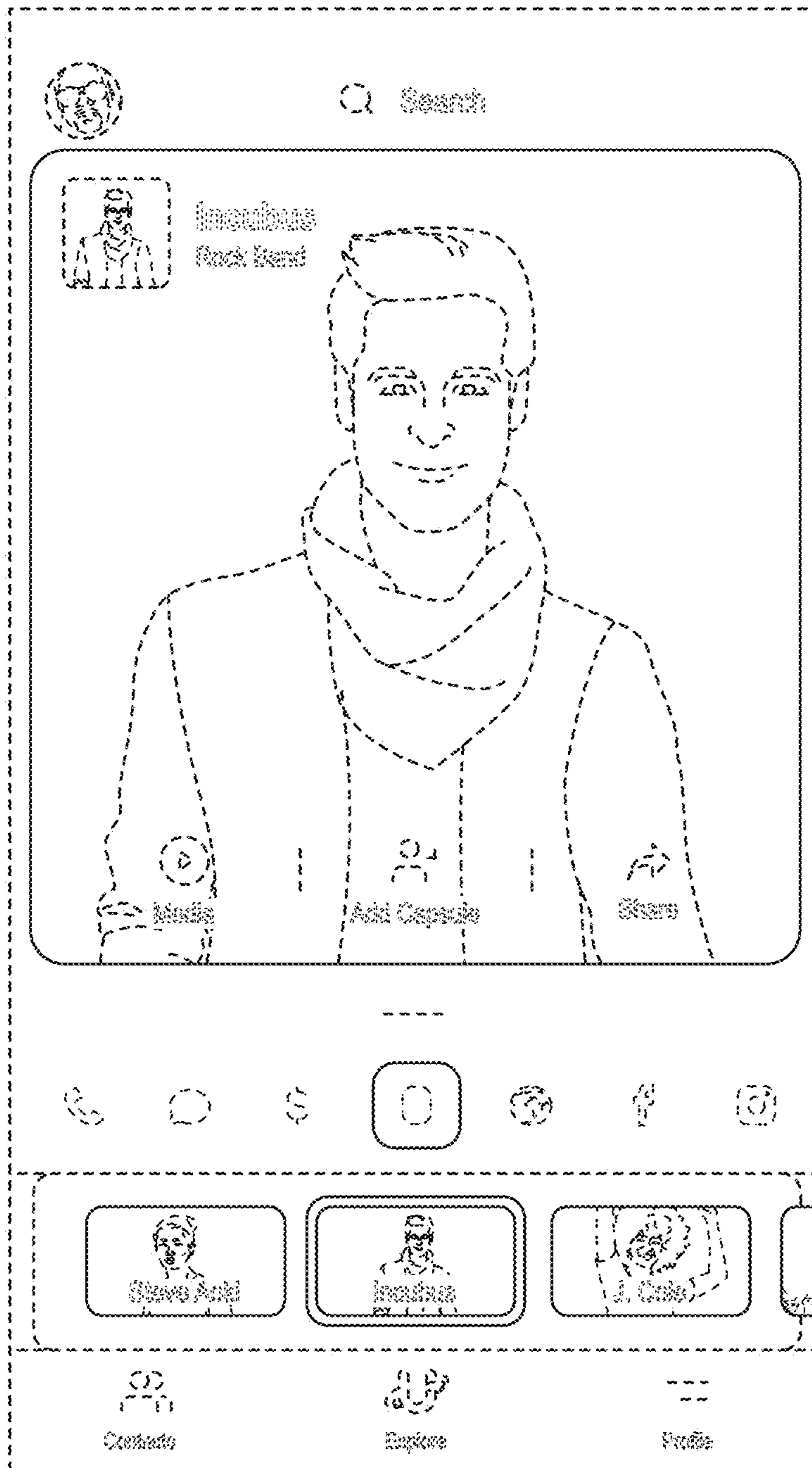
