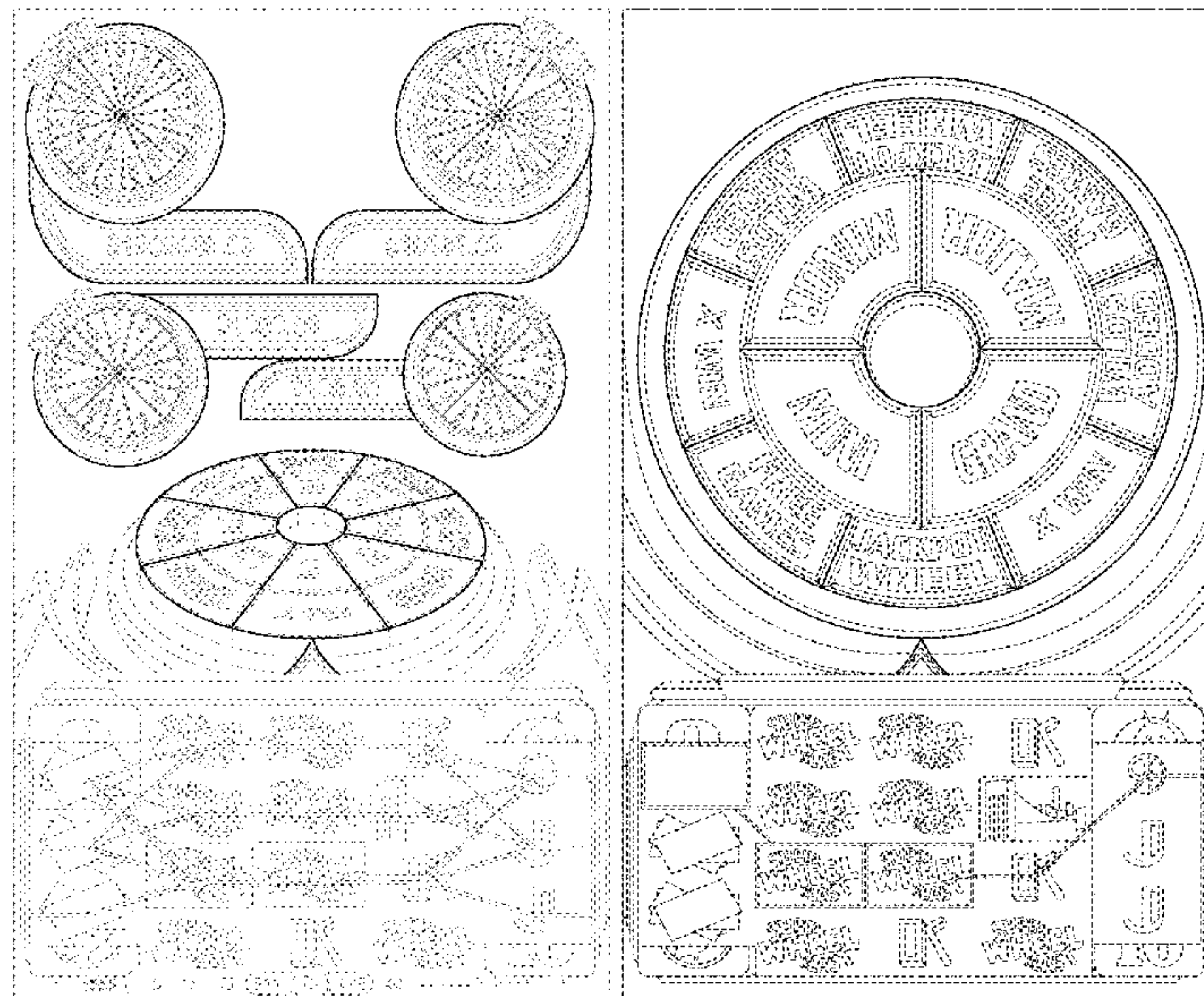
(57) **CLAIM**

I claim the ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the first image for a display screen with graphical user interface showing our new design; FIG. 2 is a front view of the second image for the display screen with graphical user interface; and FIG. 3 is a front view of the third image for the display screen with graphical user interface; FIG. 4 is another view of FIG. 1, but shown without the broken lines illustrating portions of the graphical user interface, for clarity illustrating the claimed design; and, FIG. 5 is another view of FIG. 2, but shown without the broken lines illustrating portions of the graphical user interface, for clarity illustrating the claimed design. The appearance of the first image and the second image sequentially transitions between the images shown in FIGS. 1 and 2. The process or period in which one image transitions to another image forms no part of the claimed design. The dash-dot broken line perimeter in the drawings illustrates a display screen or portion thereof and forms no part of the claimed design. The dash-dash broken lines in the drawings illustrate portions of the graphical user interface that form no part of the claimed design.

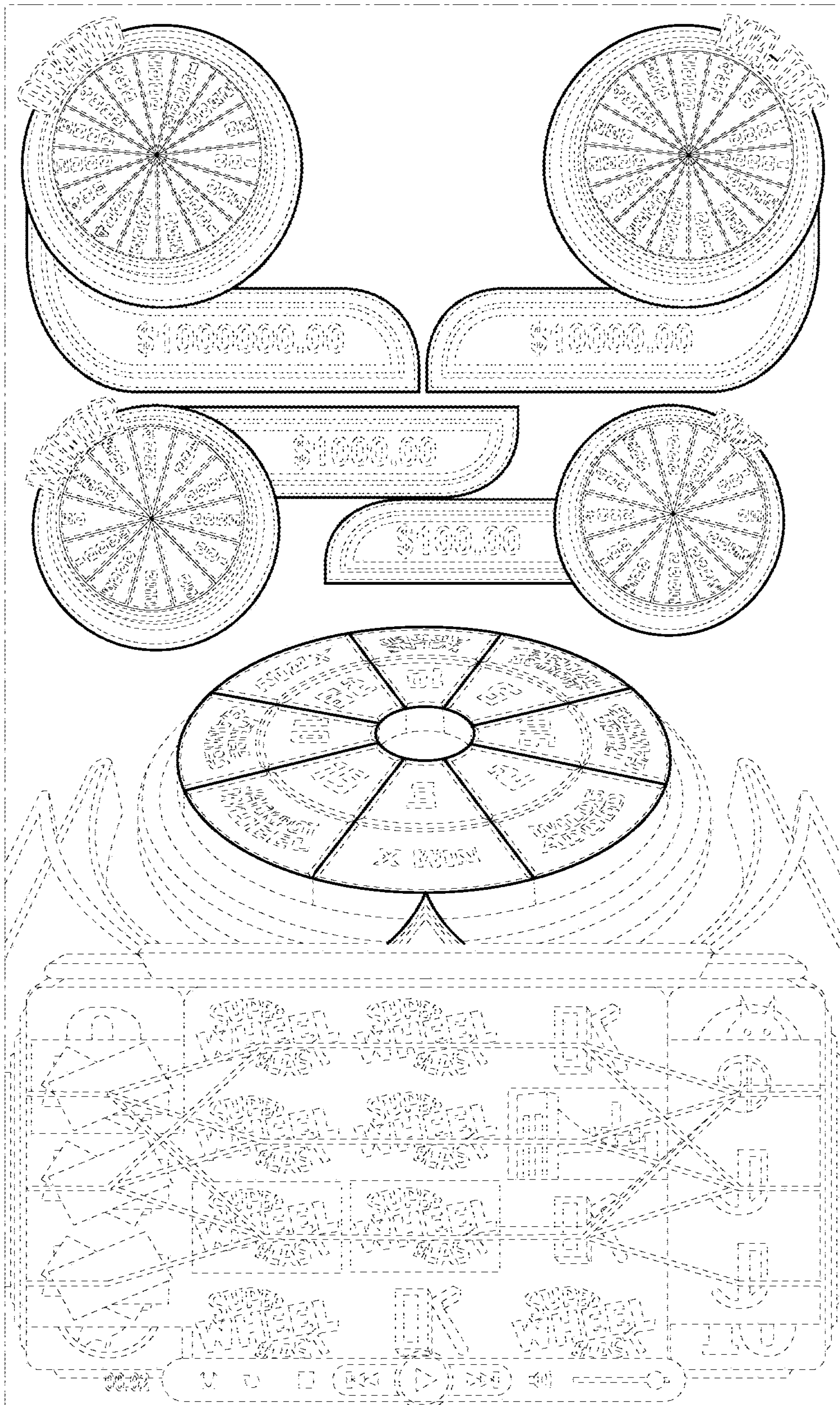

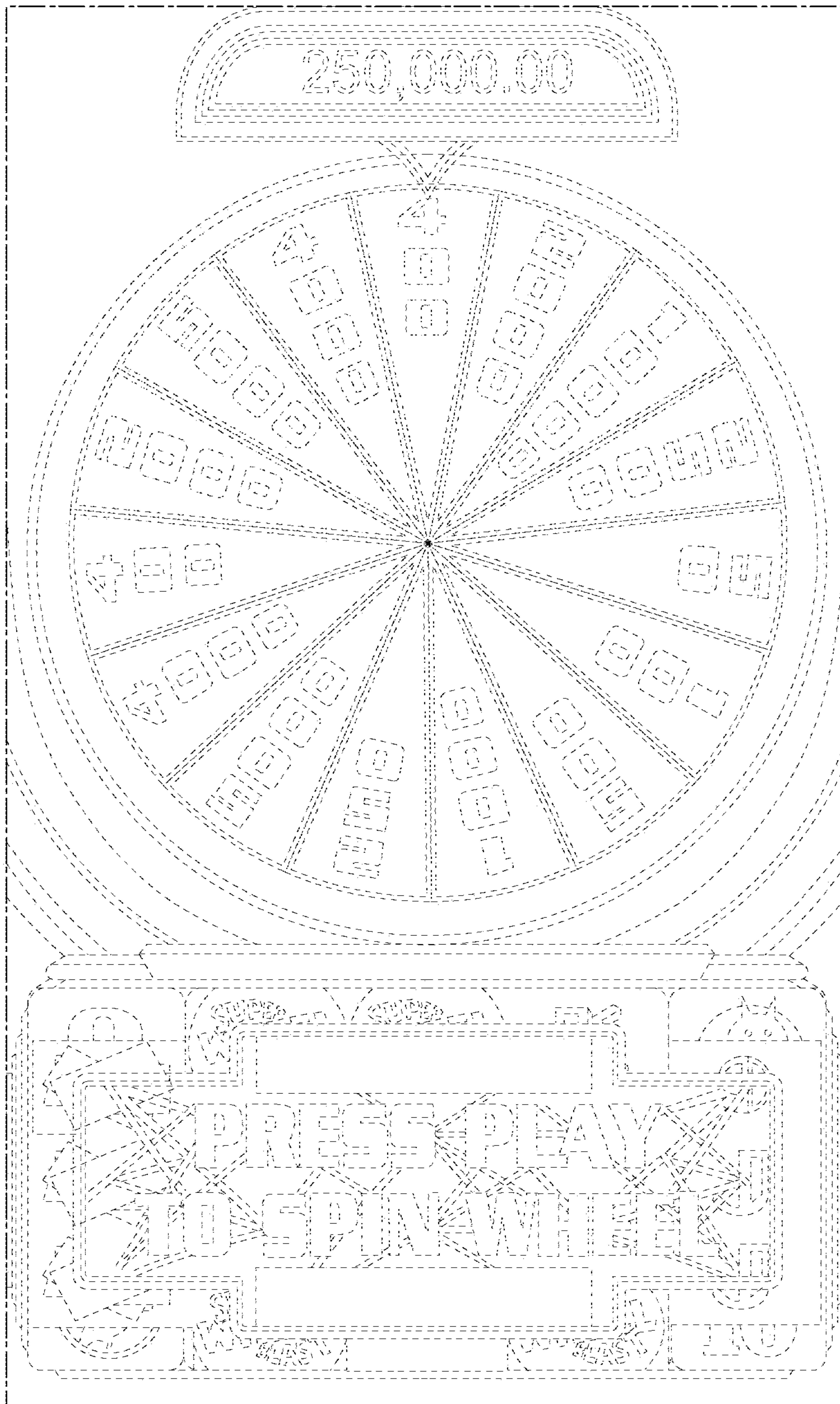

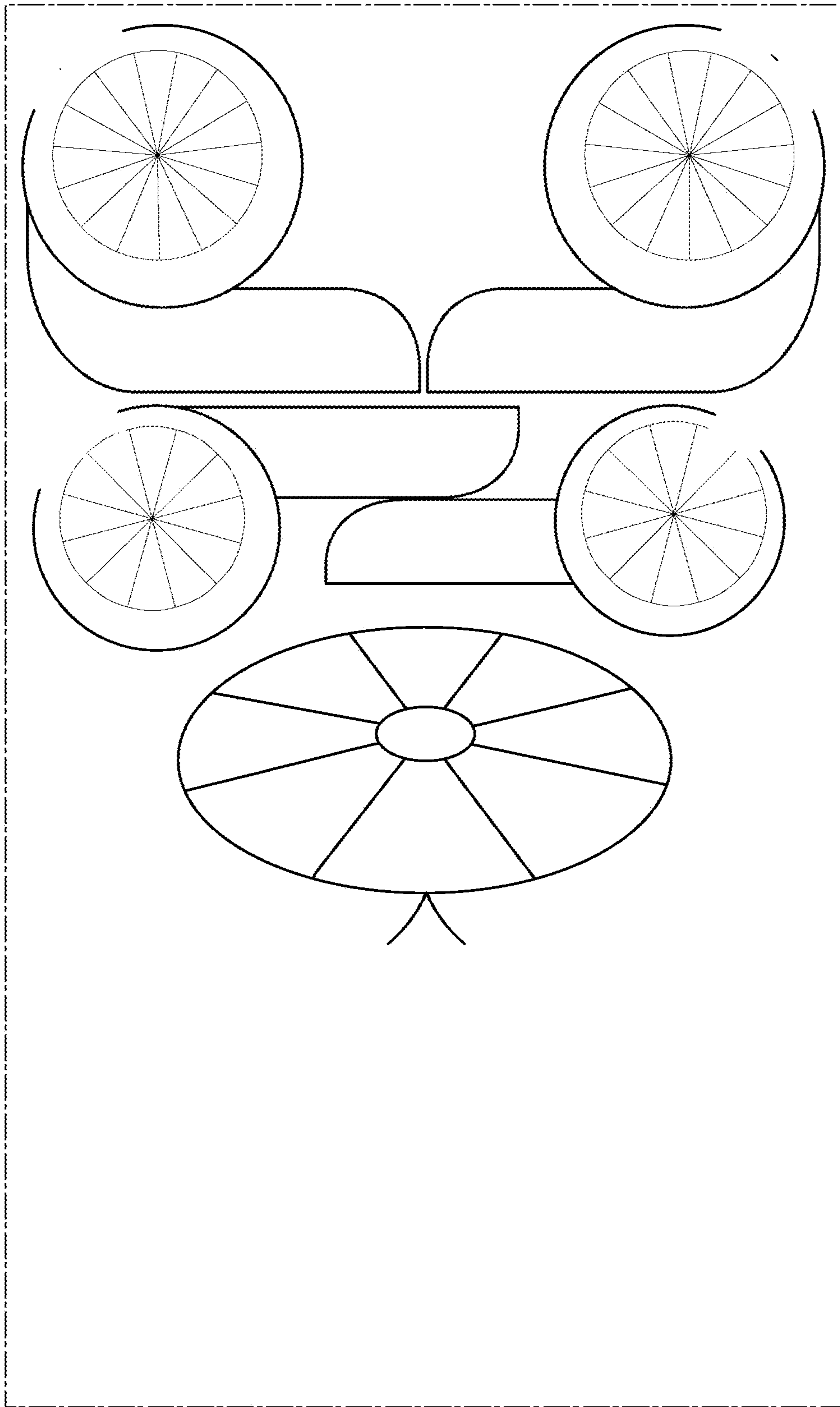

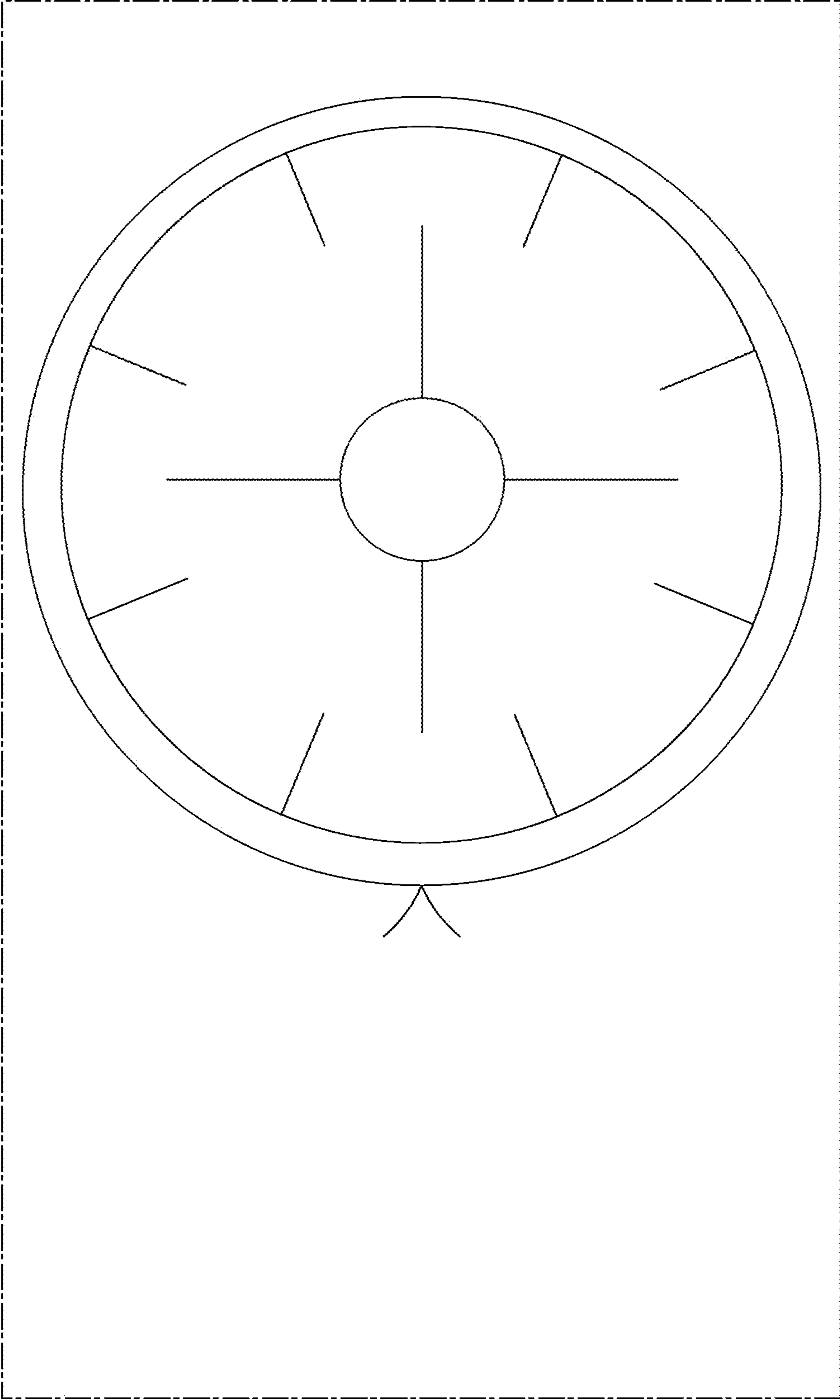
