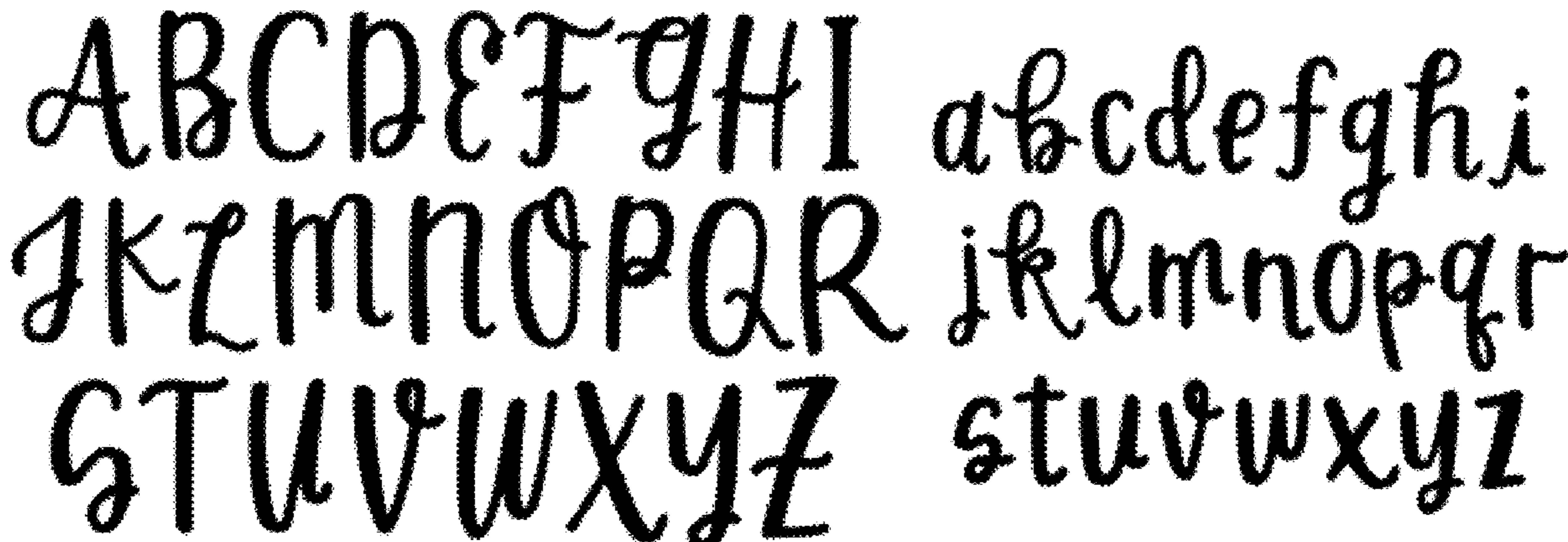
(57) **CLAIM**

I claim the ornamental design for a typeface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a typeface showing the upper-case letters of the claimed design;
FIG. 2 is a front view of a typeface showing the lower-case letters of the claimed design;
FIG. 3 is a front view of a typeface showing the numbers, punctuation marks and symbols of the claimed design; and,
FIG. 4 shows an exemplary arrangement of the letters, numbers, punctuation marks and symbols of the claimed design, as they could appear in use. The specific arrangement forms no part of the claimed design.
