(57) **CLAIM**

The ornamental design for a combination medical device receiver and display, as shown and described.

DESCRIPTION

FIG. 1 is an elevated perspective view of an embodiment of a combination medical device receiver and display; FIG. 2 is a front view of the combination medical device receiver and display shown in FIG. 1; FIG. 3 is a rear view of the combination medical device receiver and display shown in FIG. 1; FIG. 4 is a left side view of the combination medical device receiver and display shown in FIG. 1; FIG. 5 is a right side view of the combination medical device receiver and display shown in FIG. 1; FIG. 6 is a top view of the combination medical device receiver and display shown in FIG. 1; FIG. 7 is a bottom view of the combination medical device receiver and display shown in FIG. 1; FIG. 8 is a front view of a second embodiment of a combination medical device receiver and display, having rear, left side, right side, top, and bottom views as shown in FIGS. 3-7, respectively. 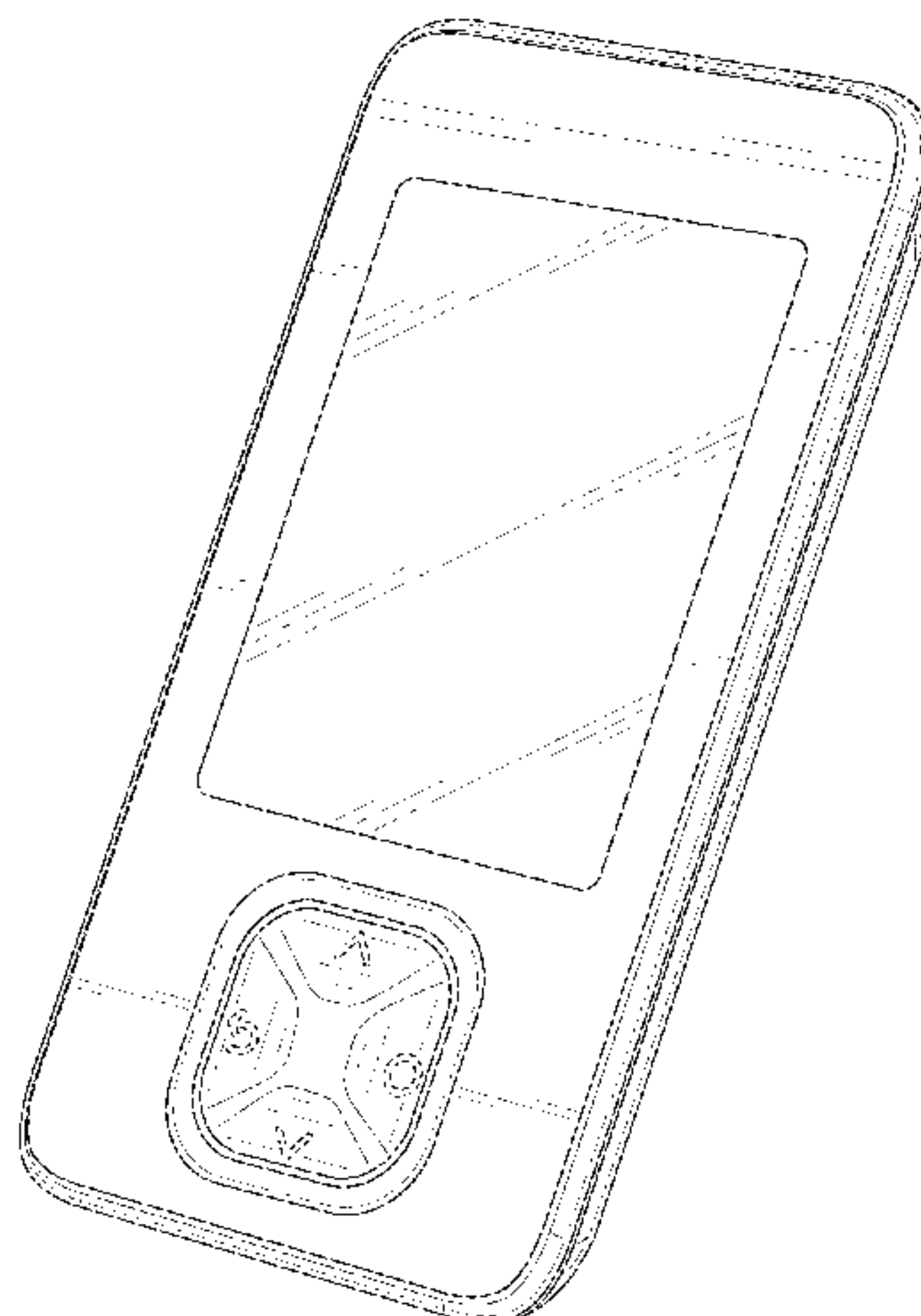

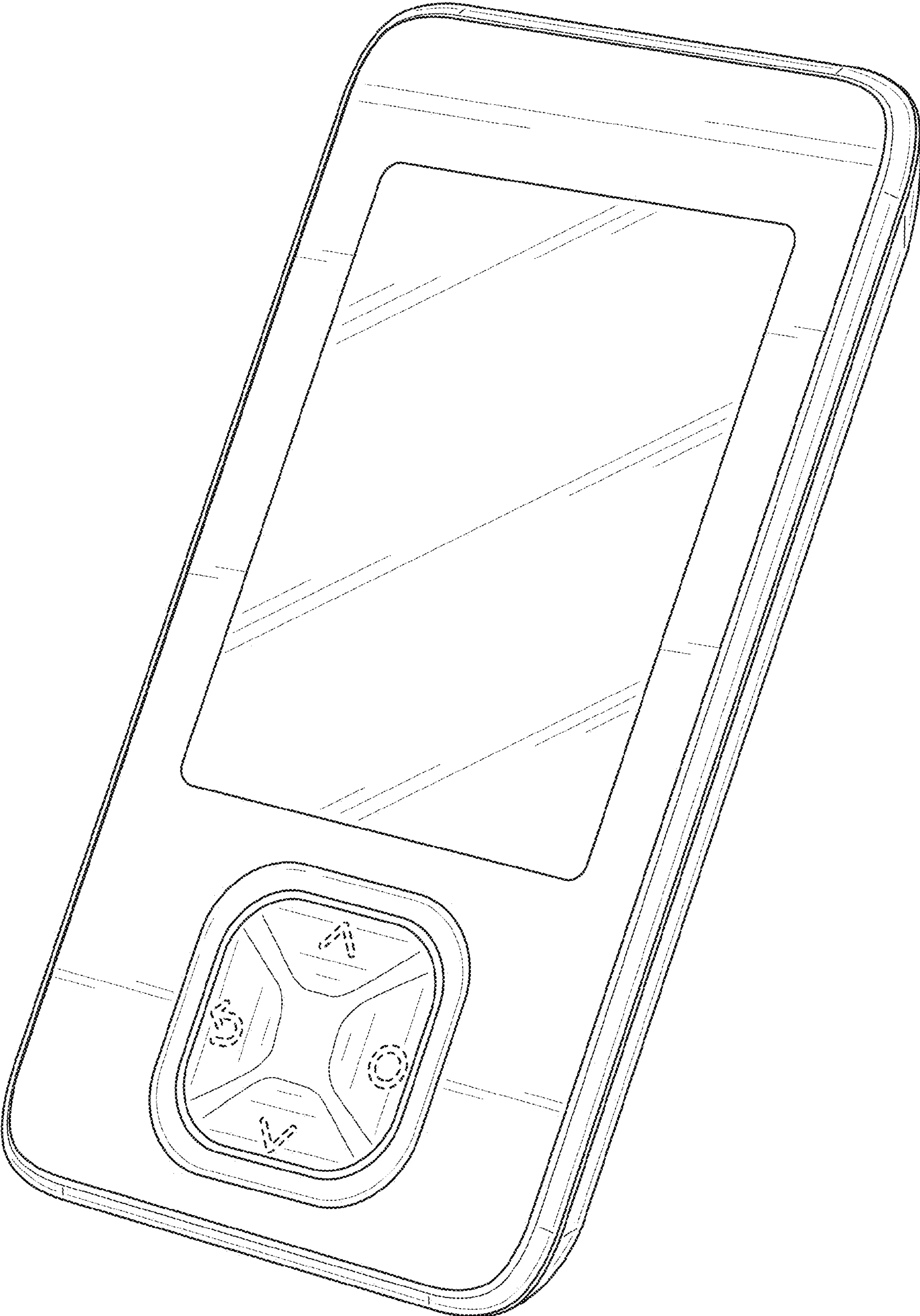

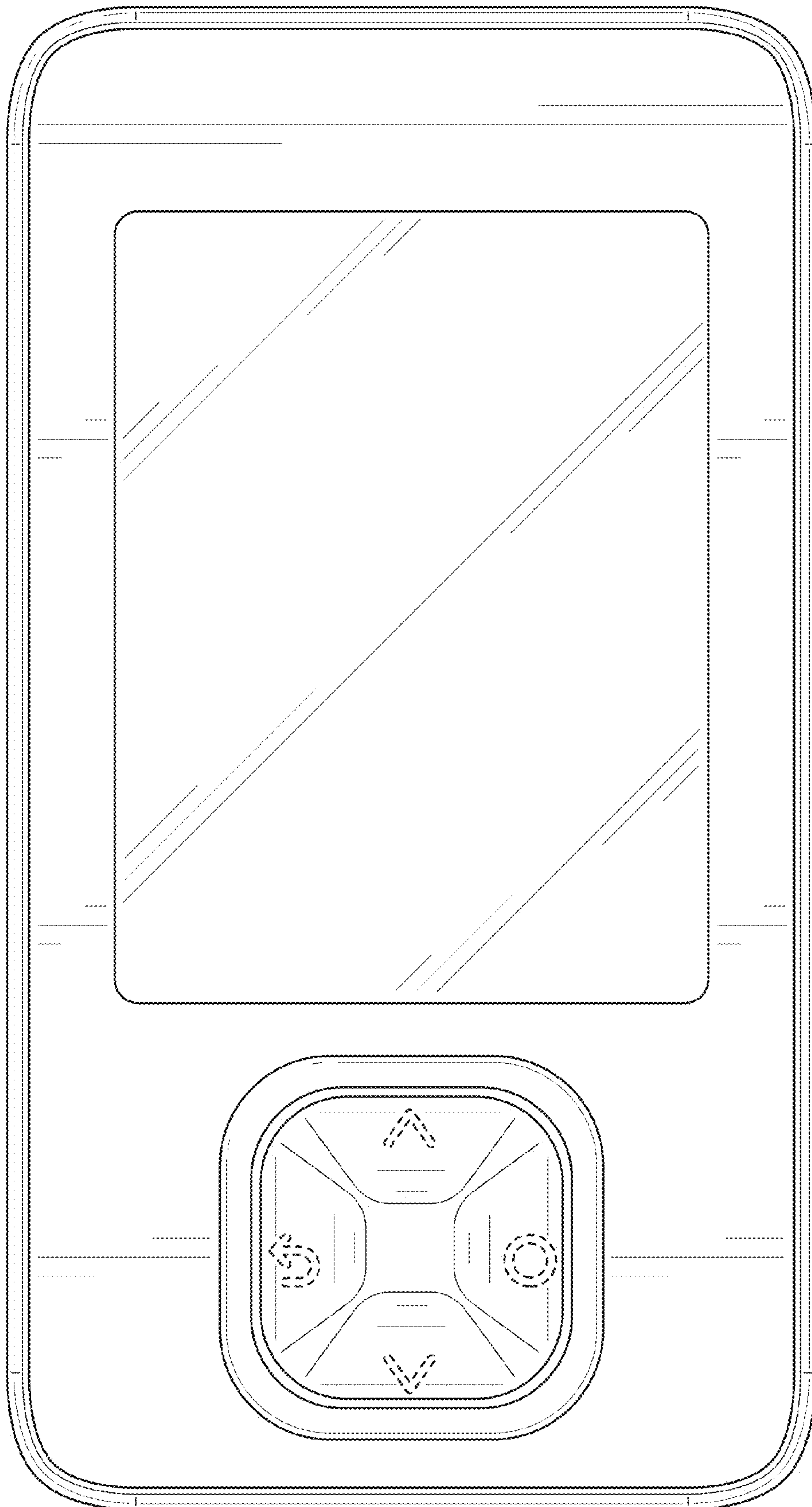

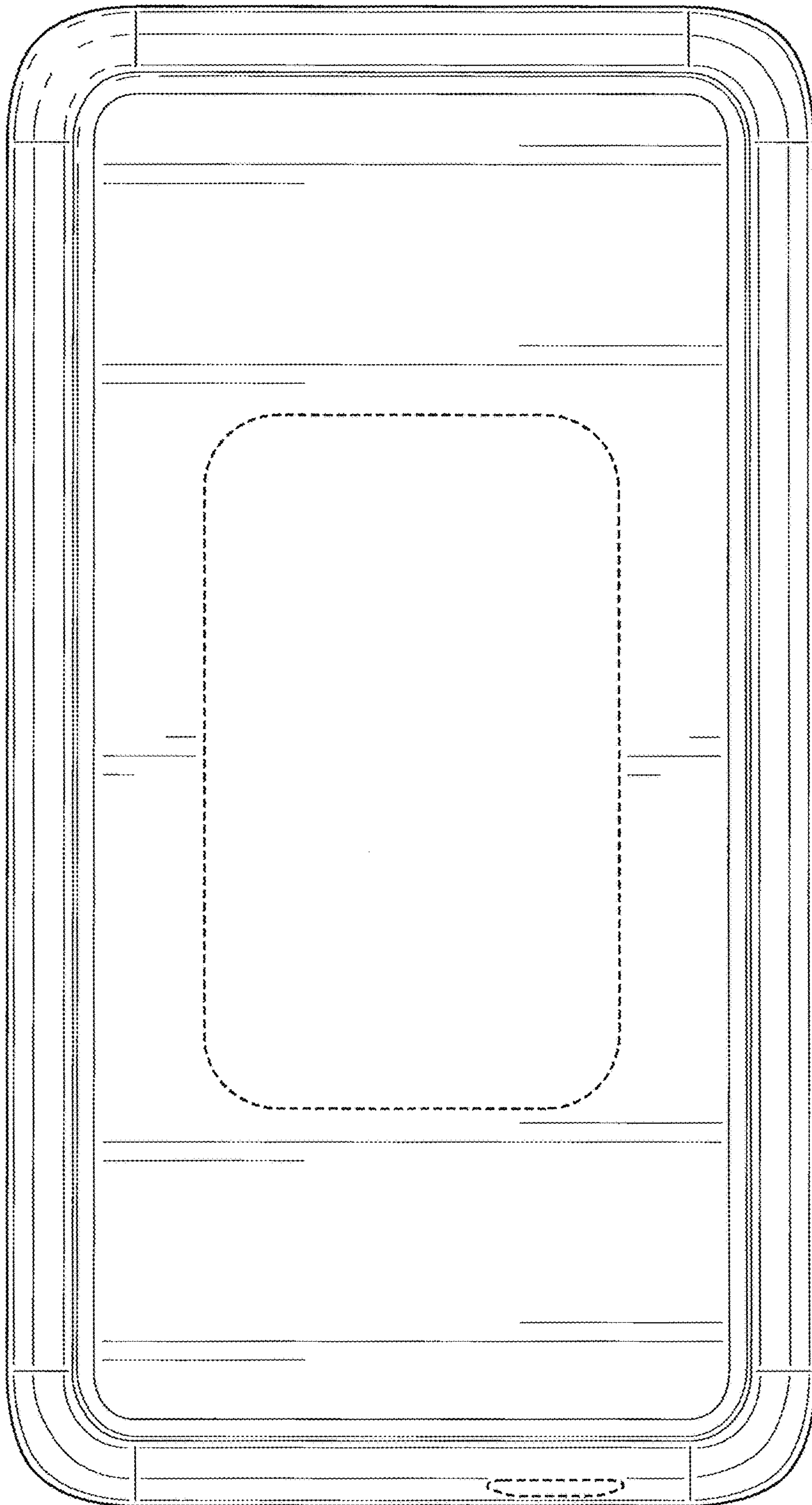

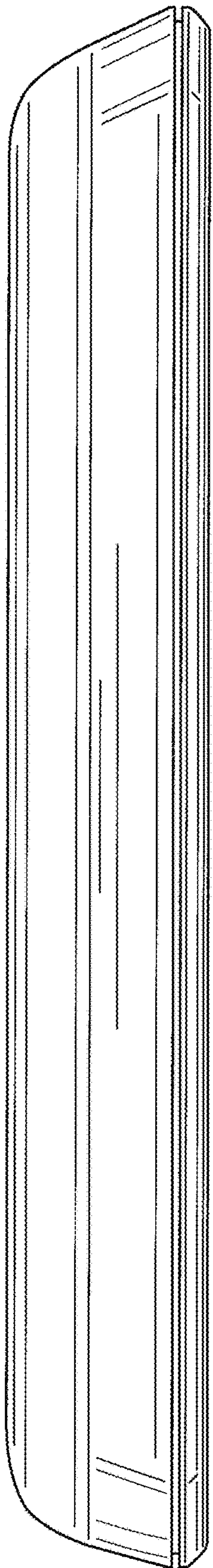

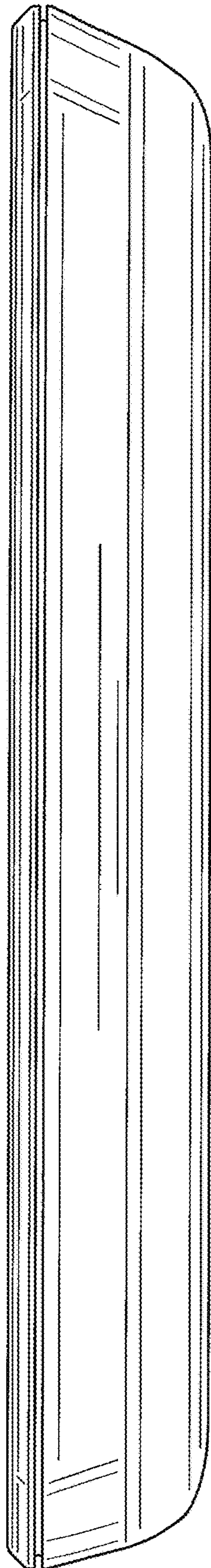

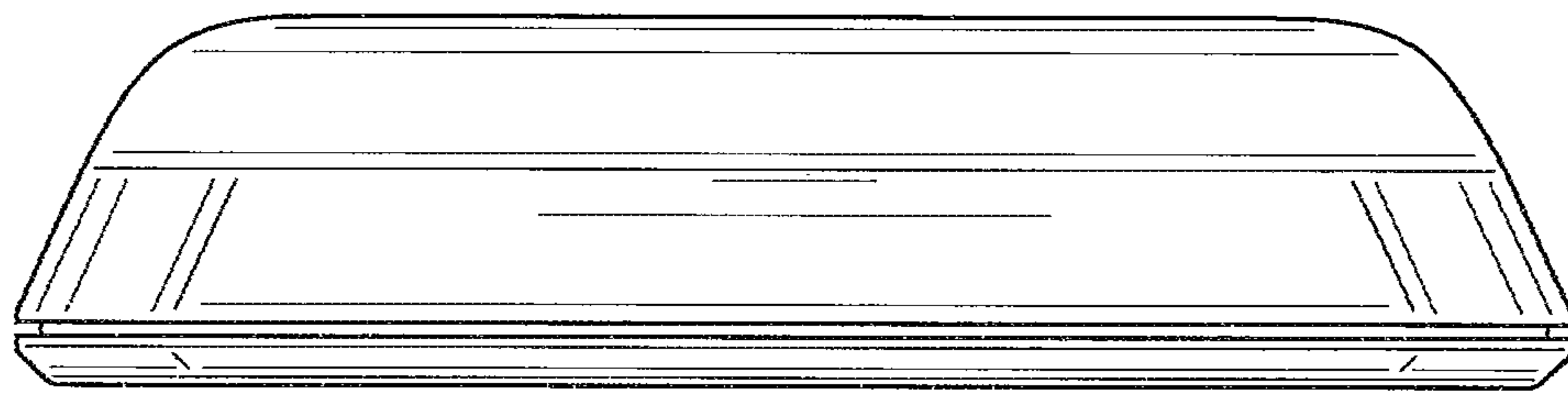

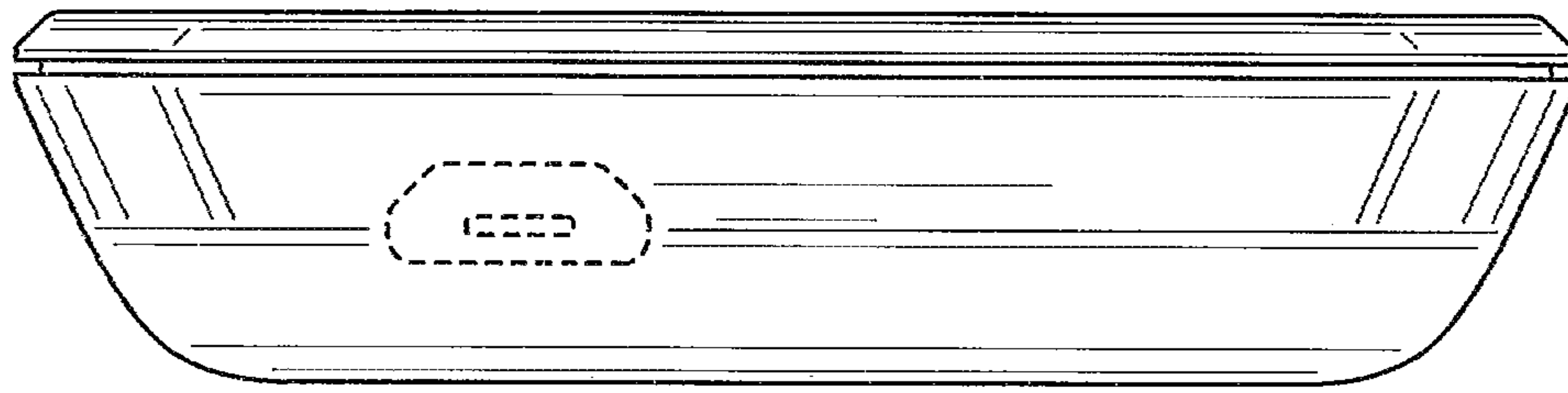

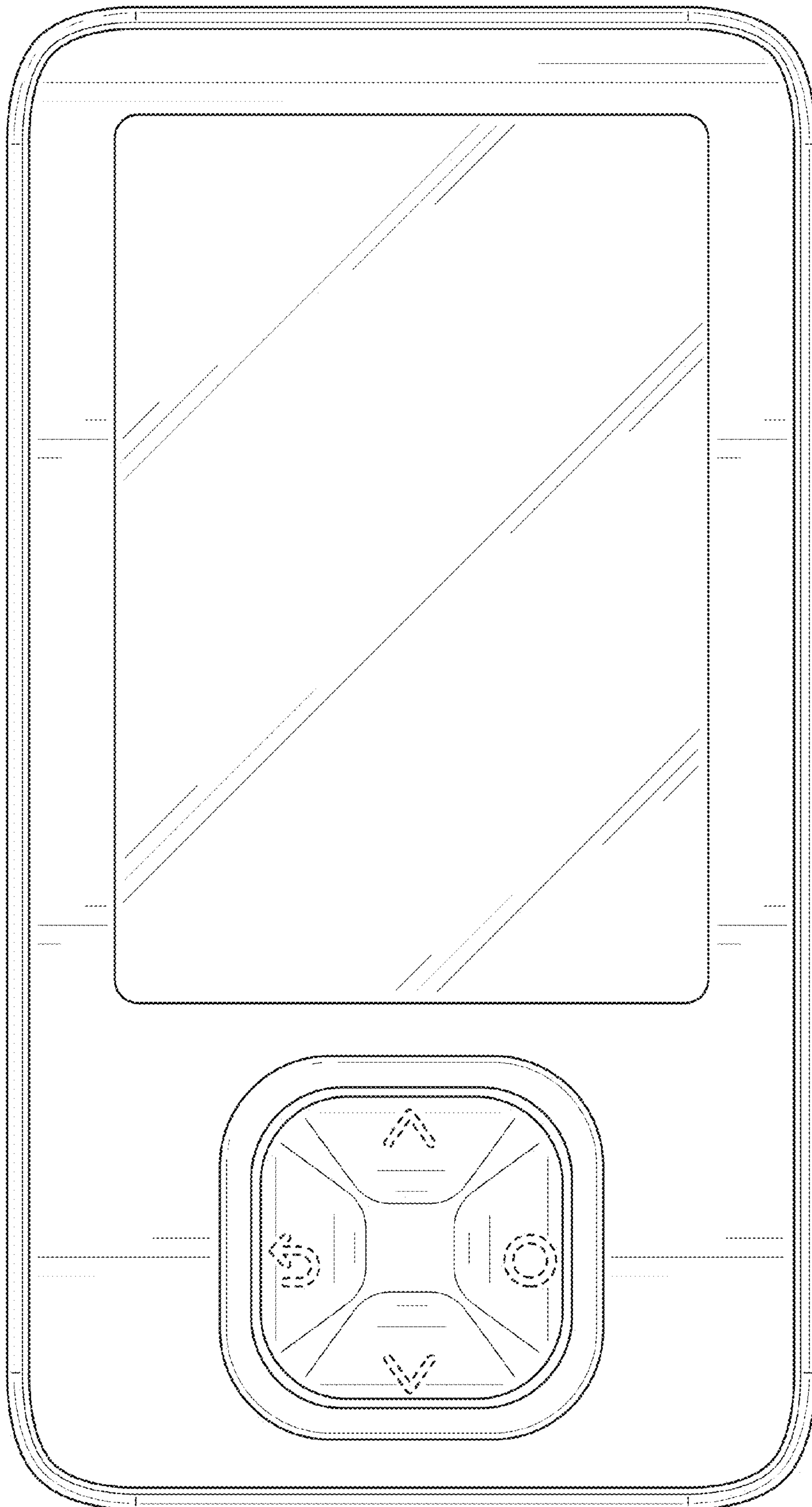

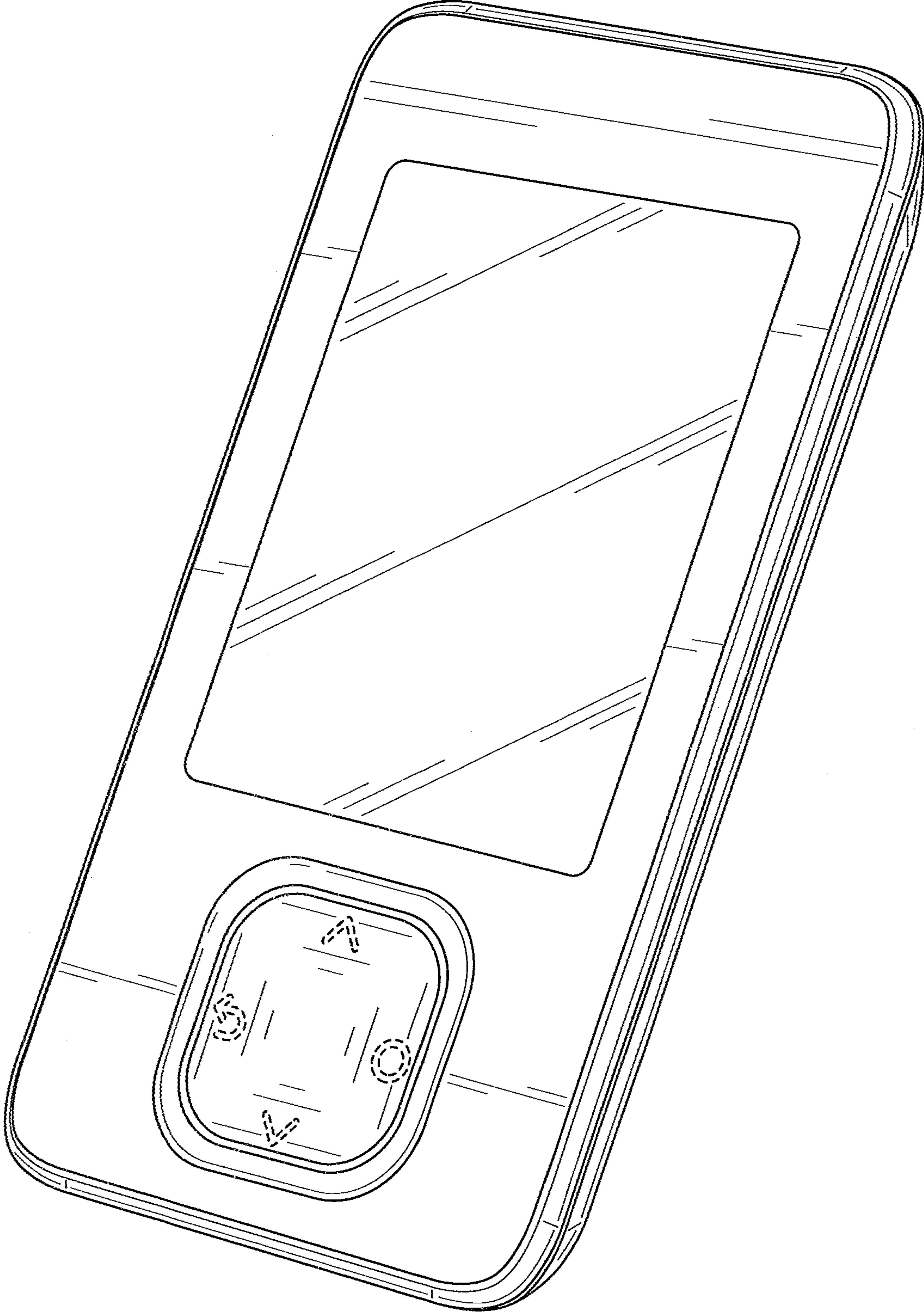

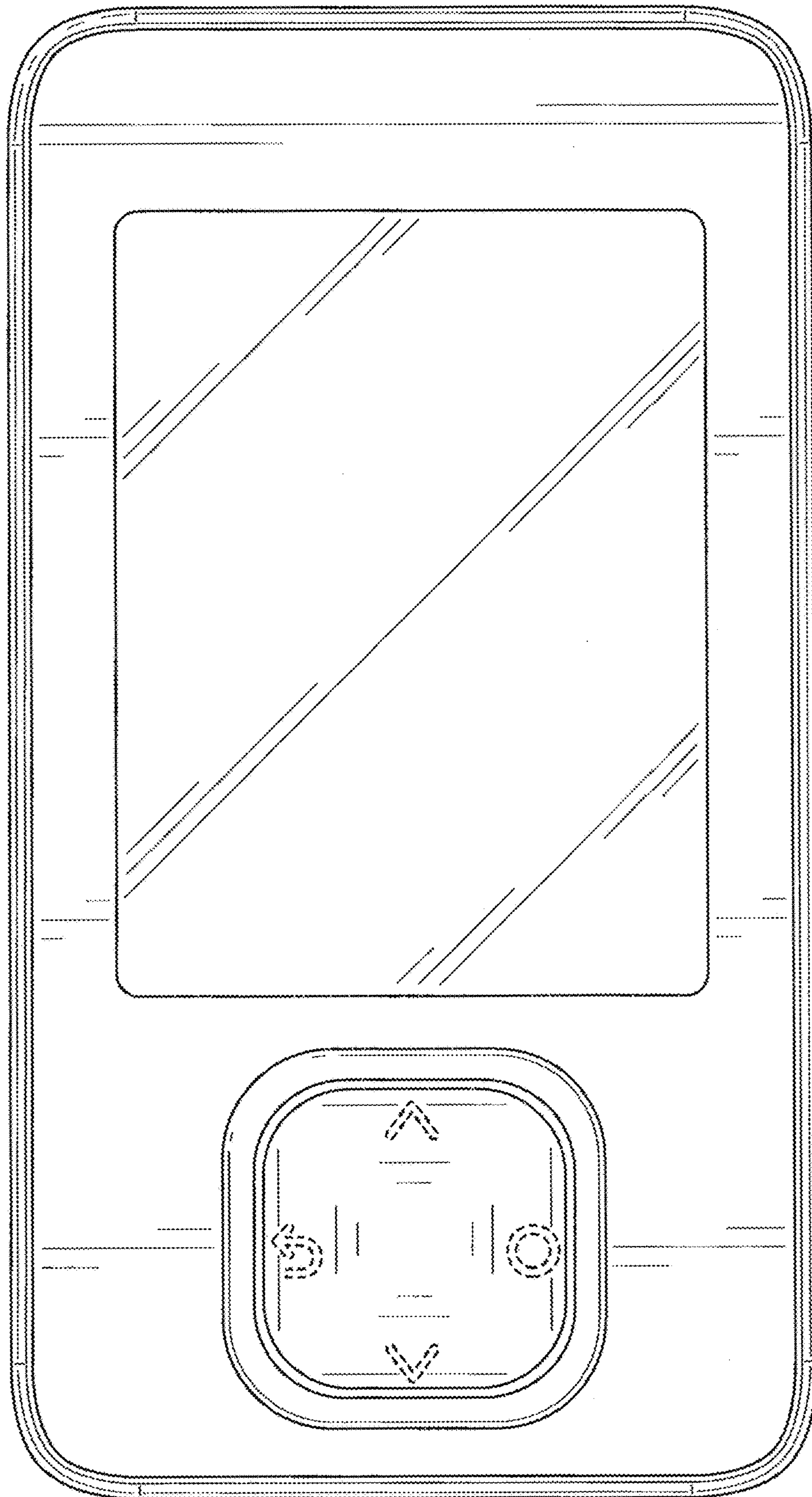

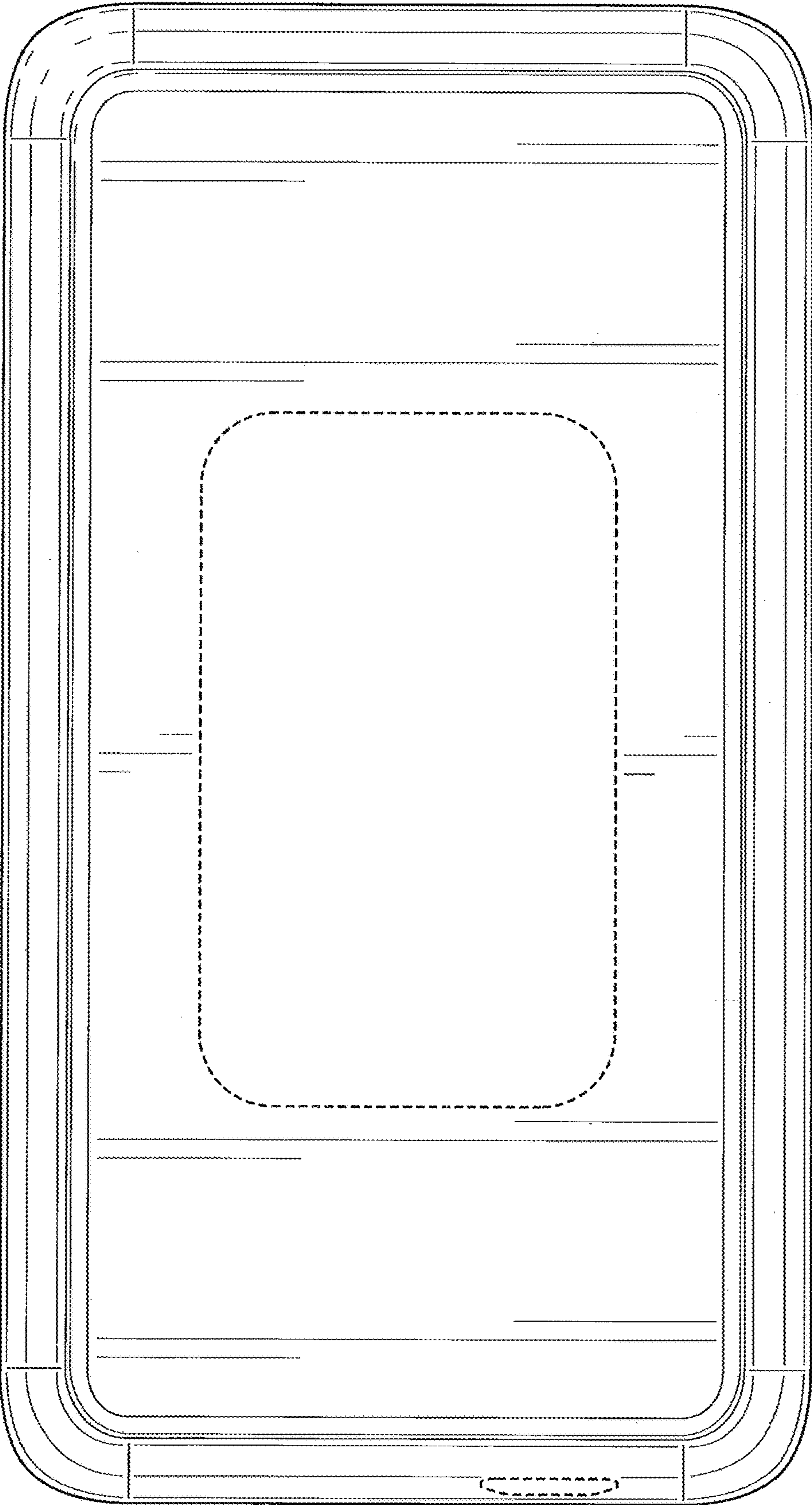

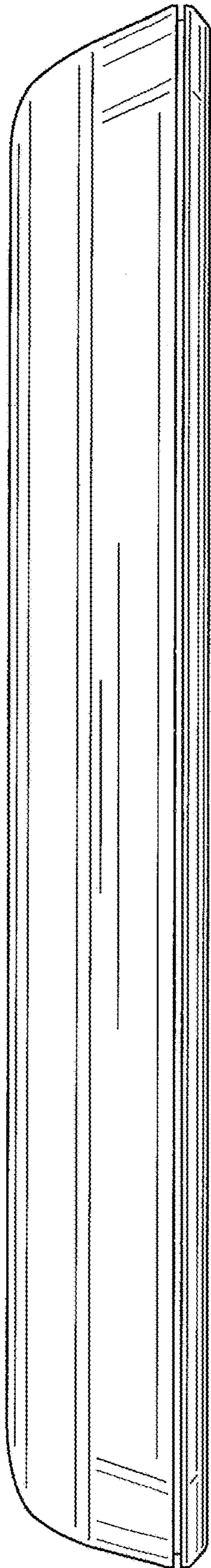

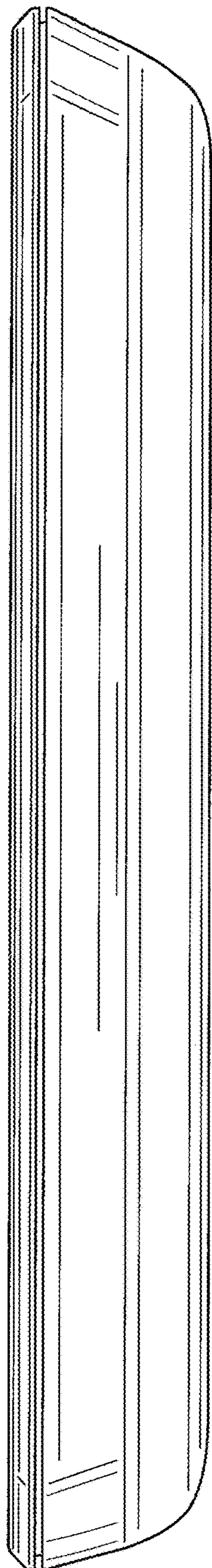

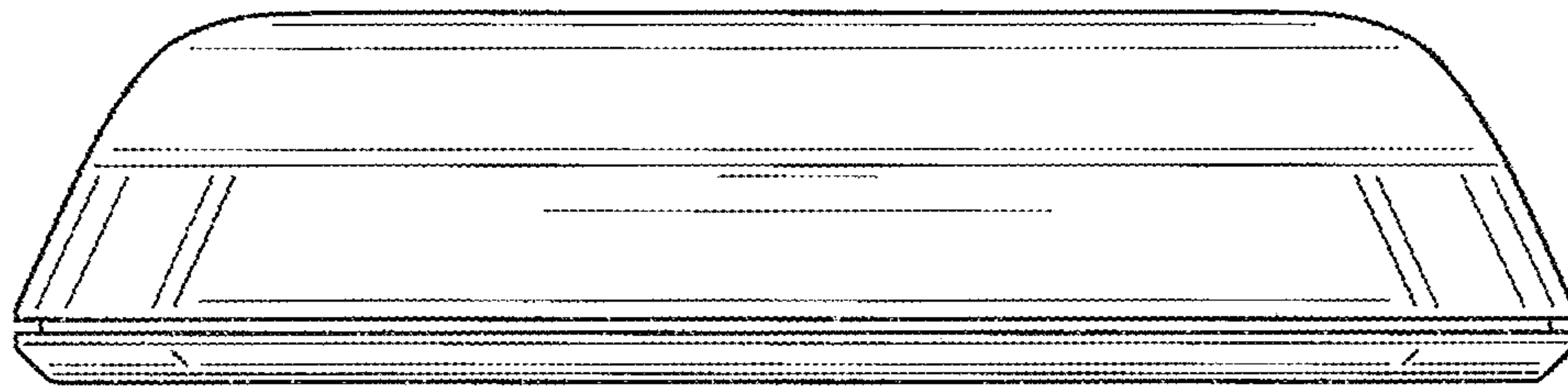

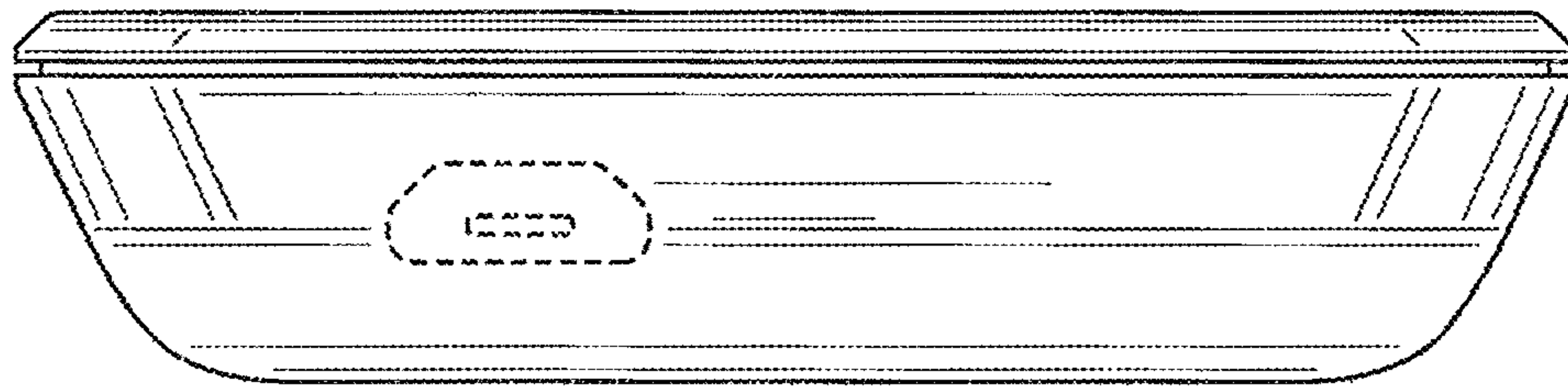

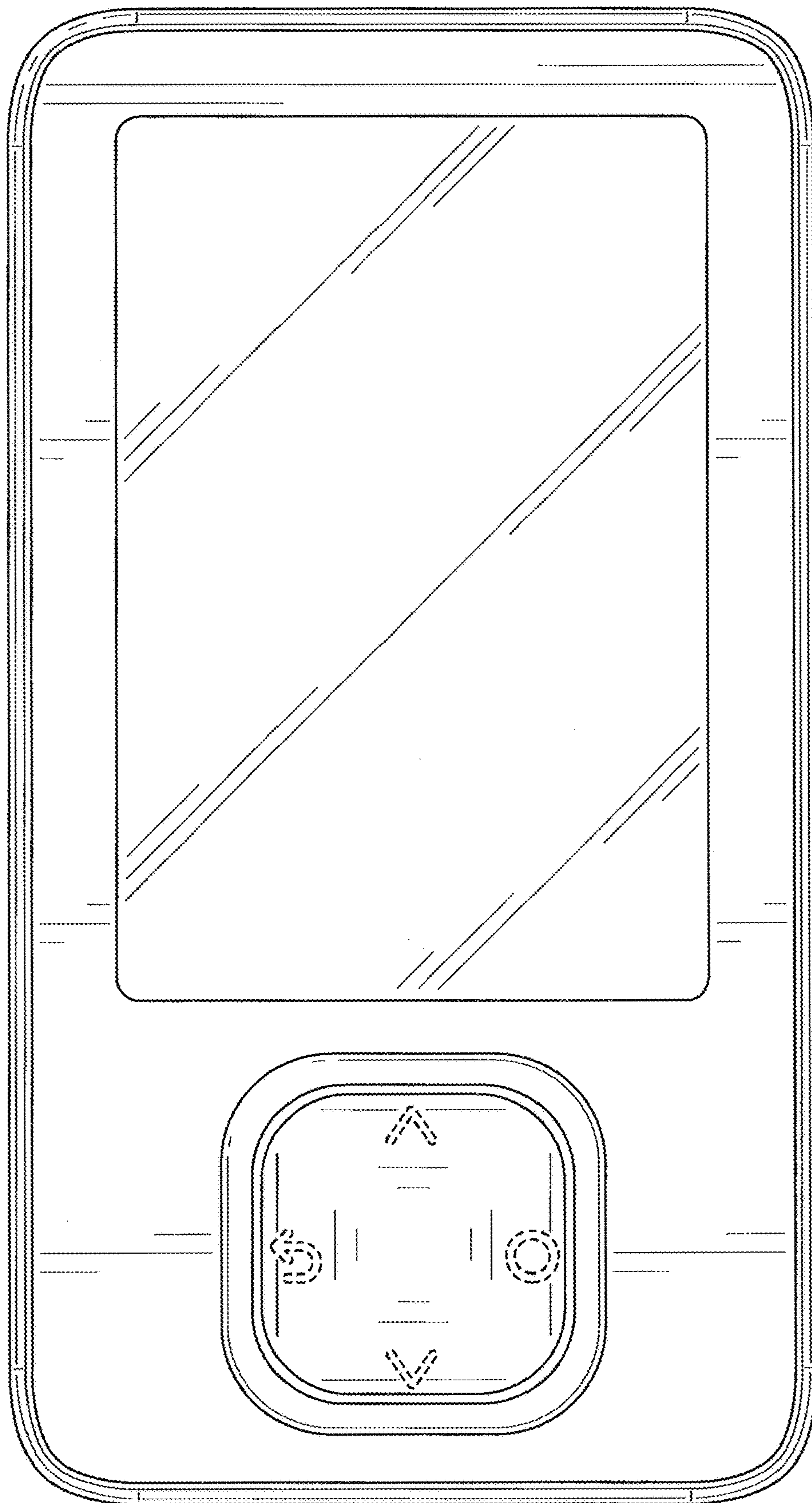

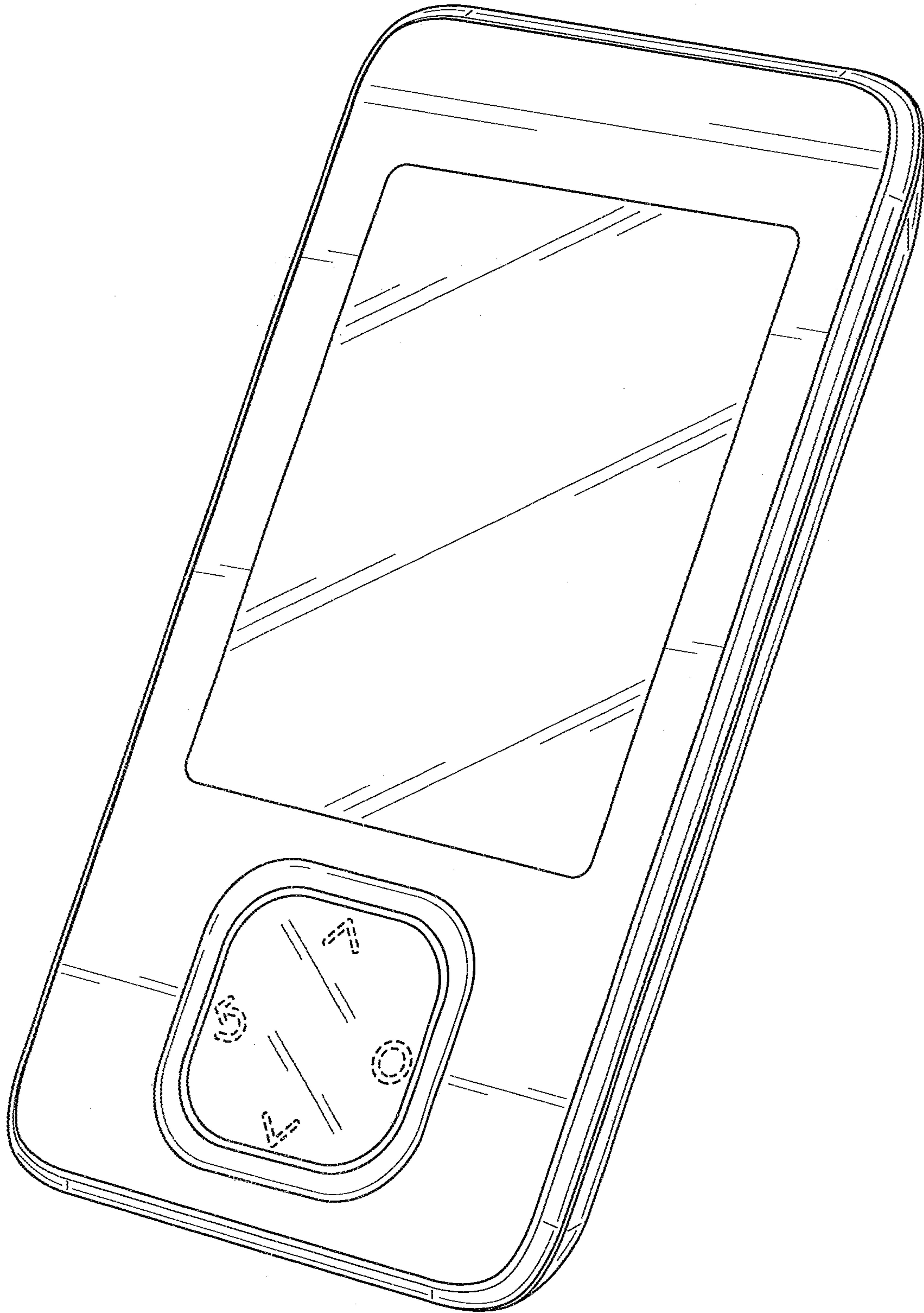

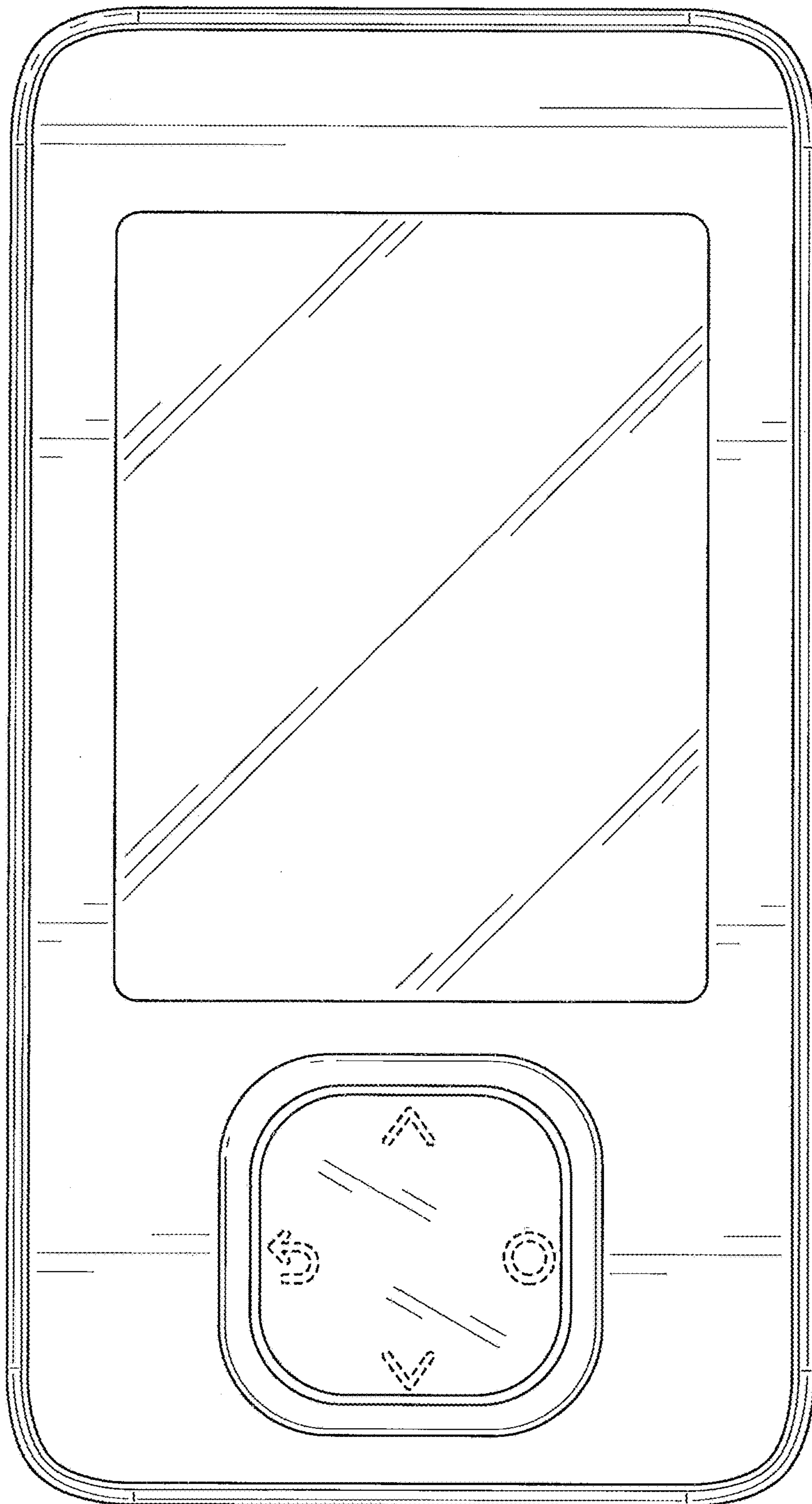

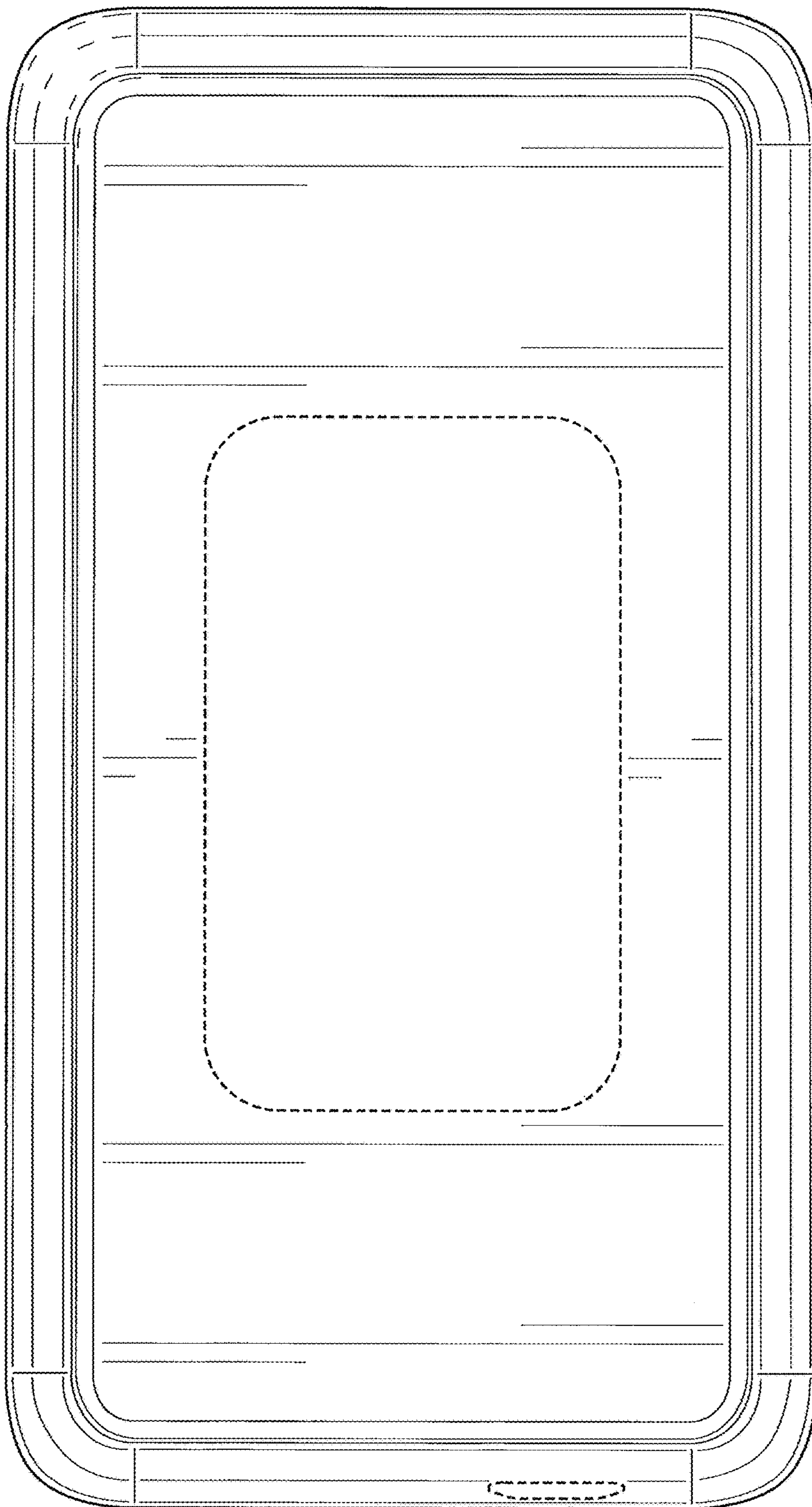

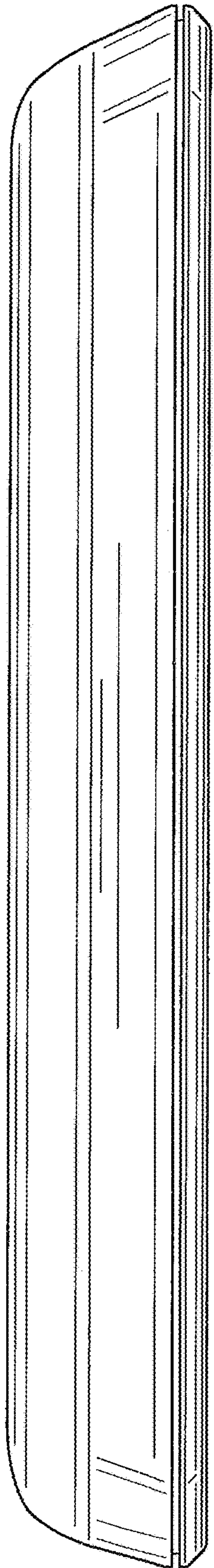

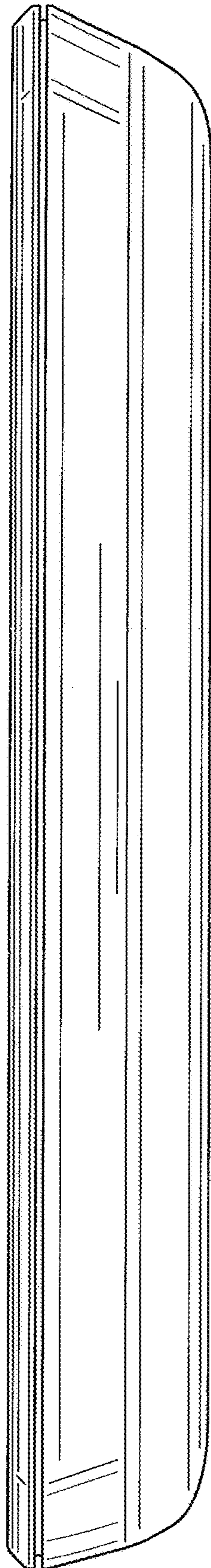

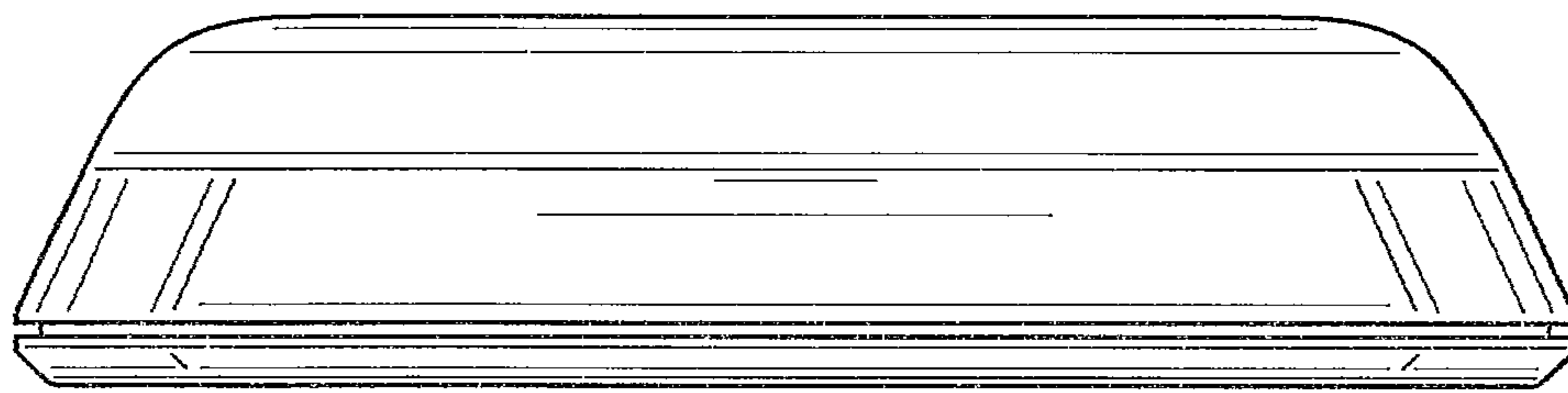

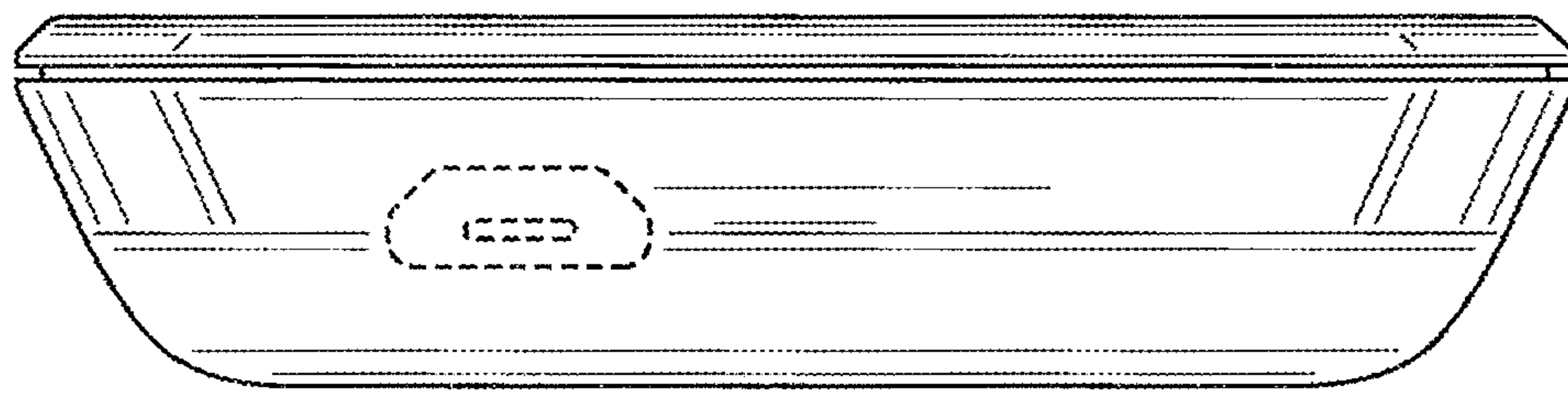

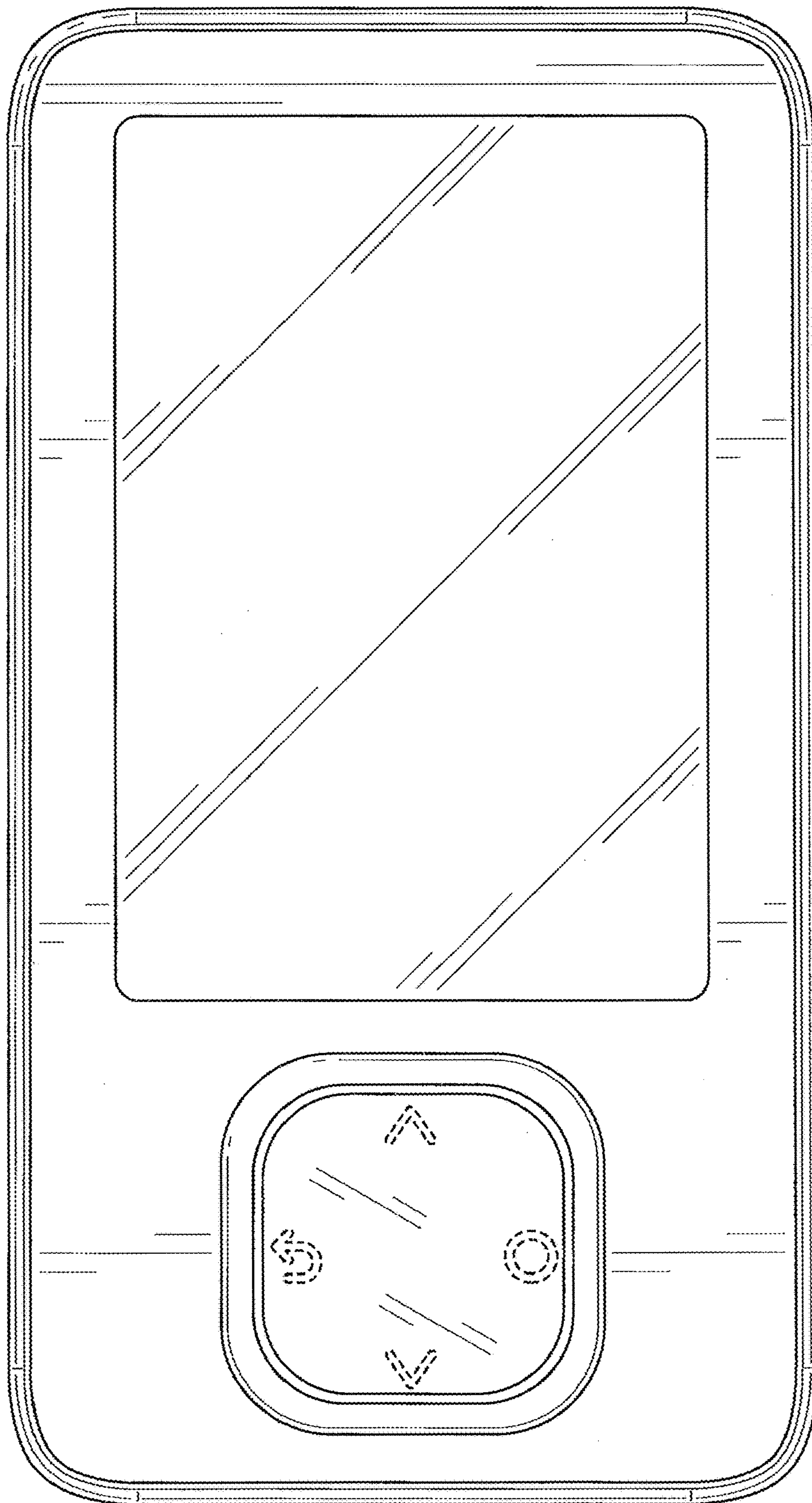
