The ornamental design for an adult novelty, substantially as shown and described.

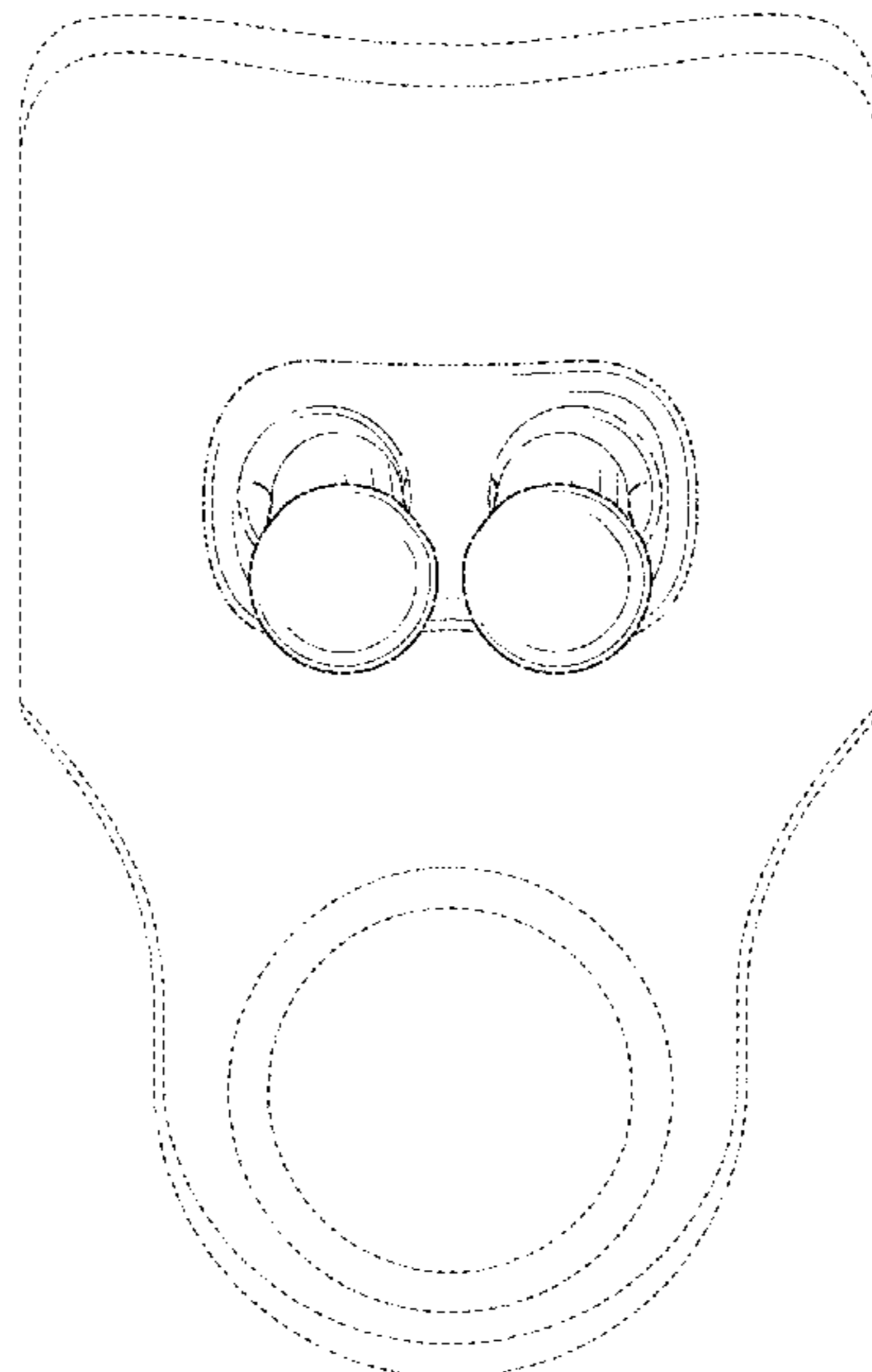
DESCRIPTION

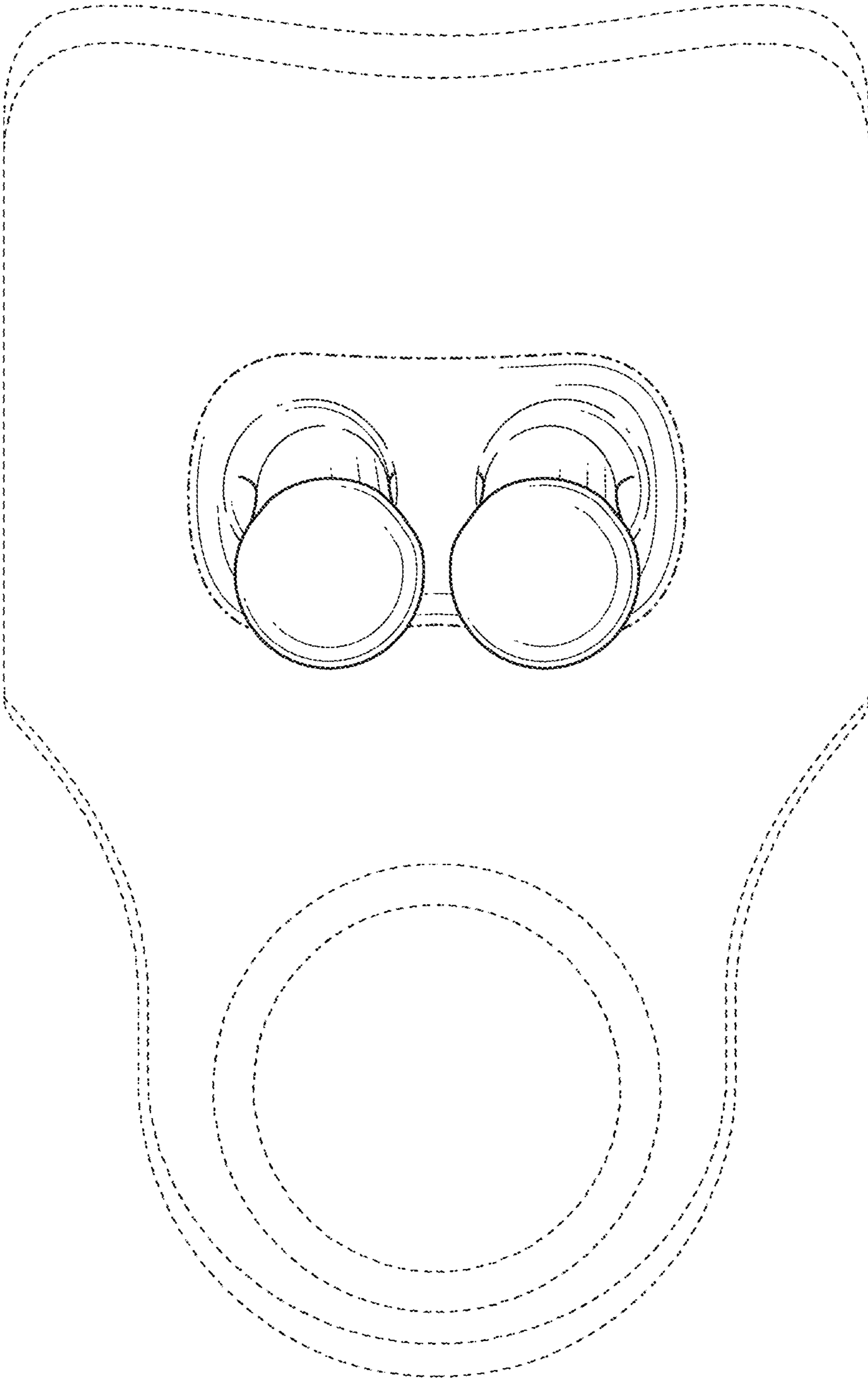

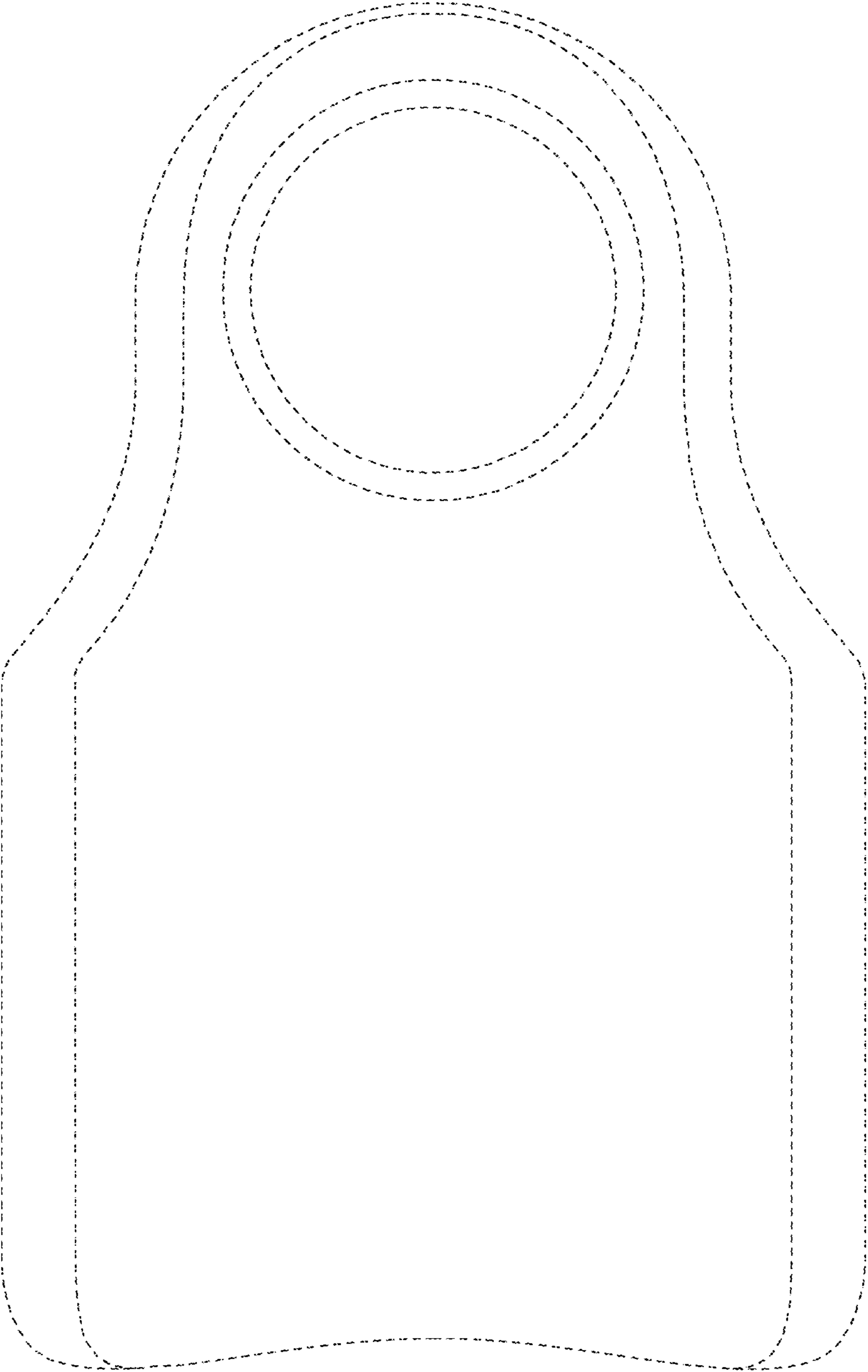

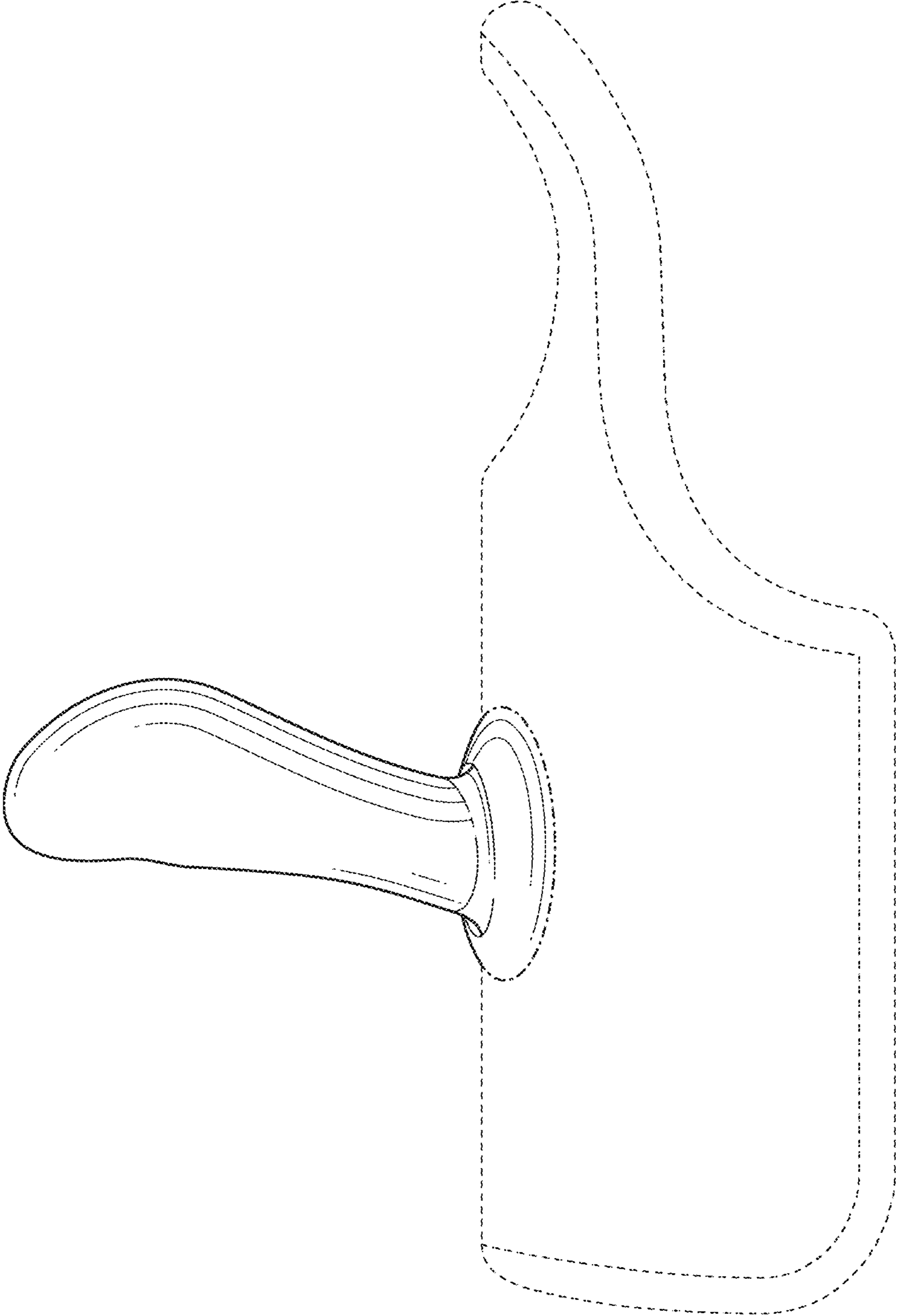

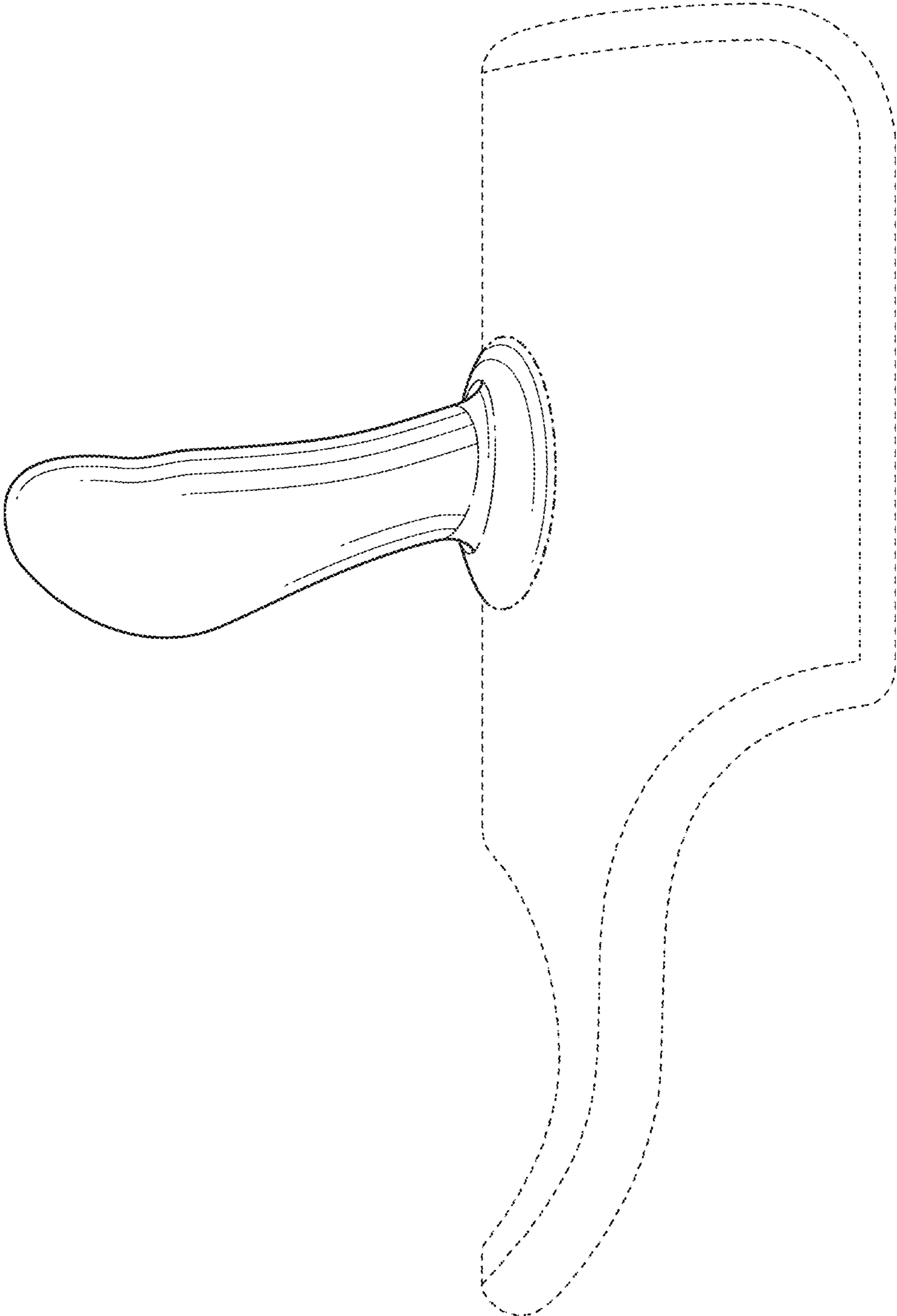

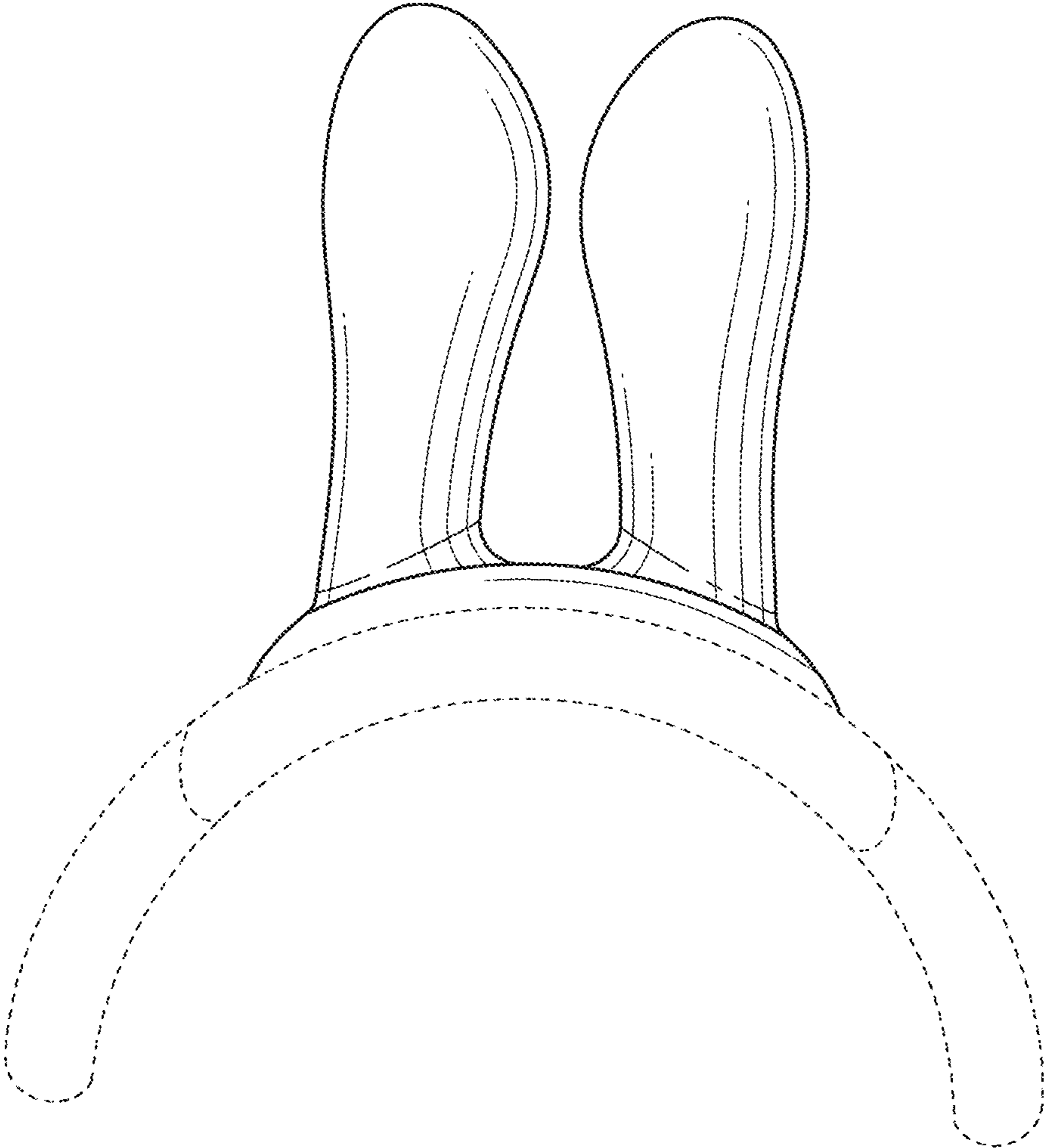

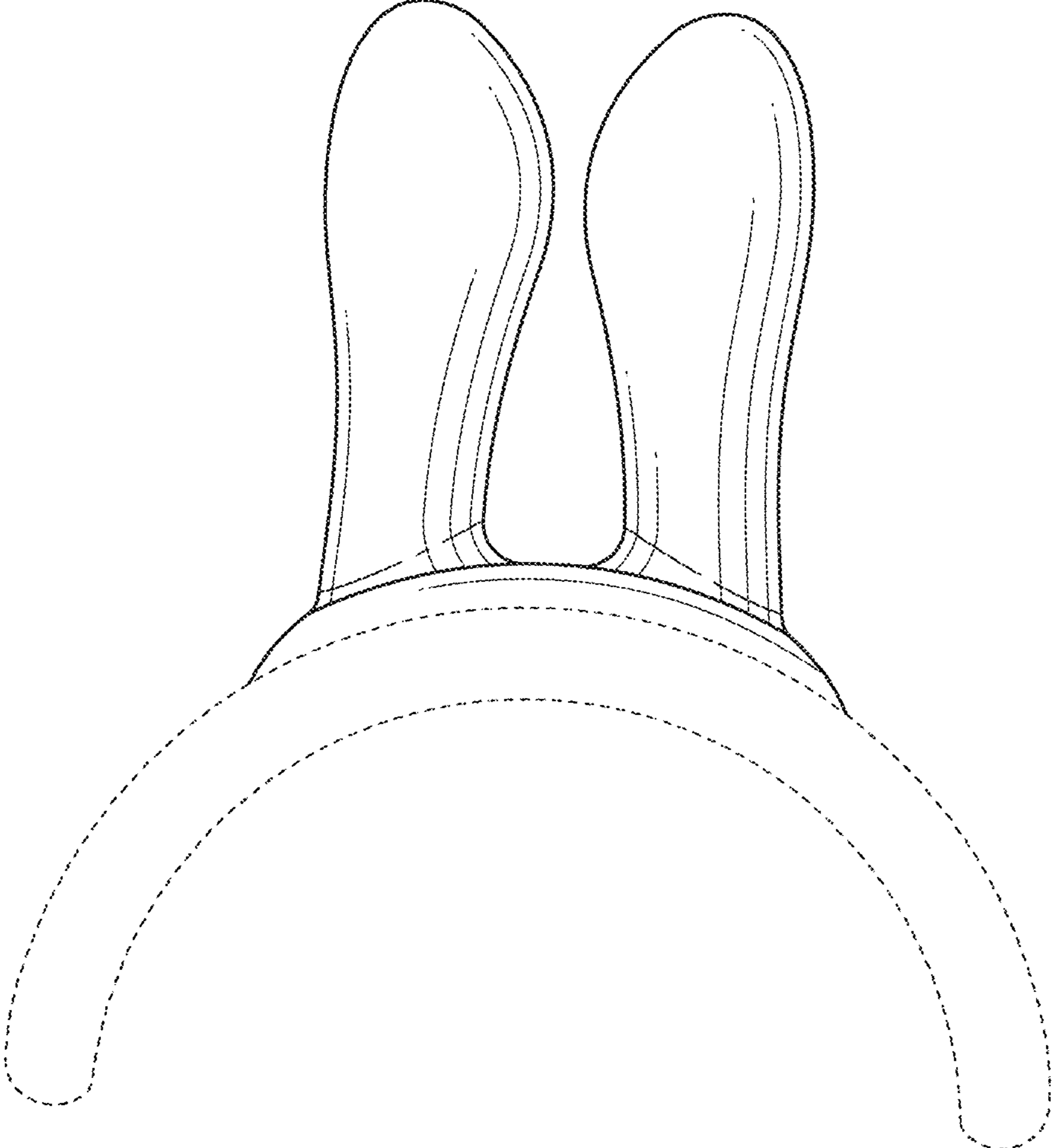

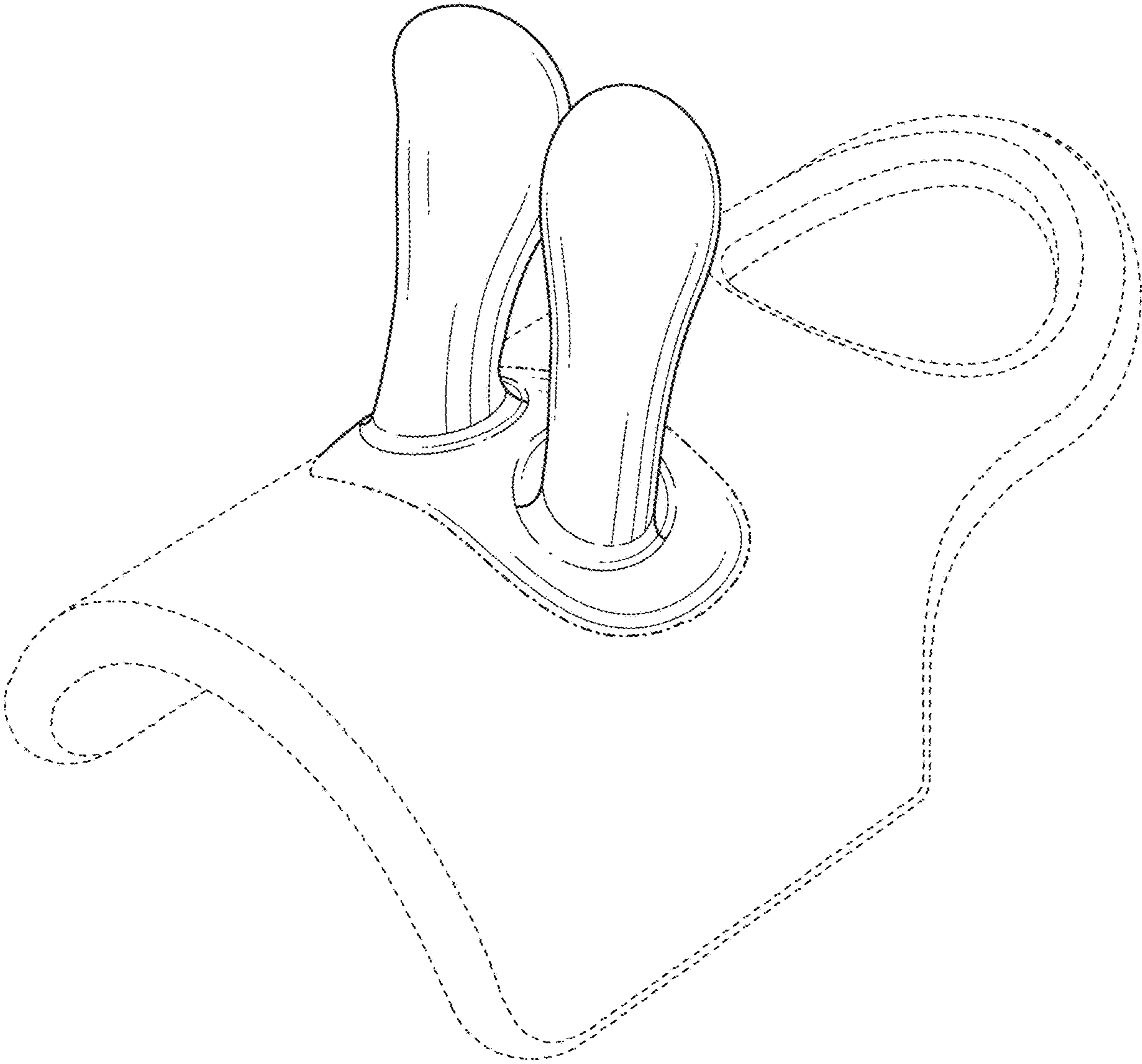
