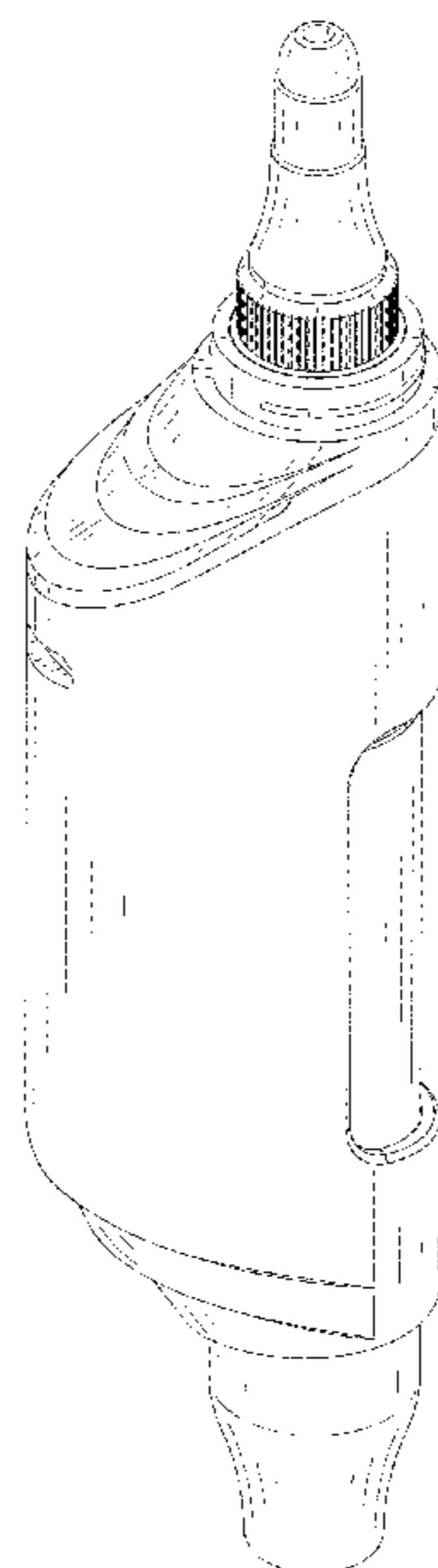
(57) **CLAIM**

The ornamental design for an electronic cigarette, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electronic cigarette, showing my new design;
FIG. 2 is another perspective view thereof;

FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;

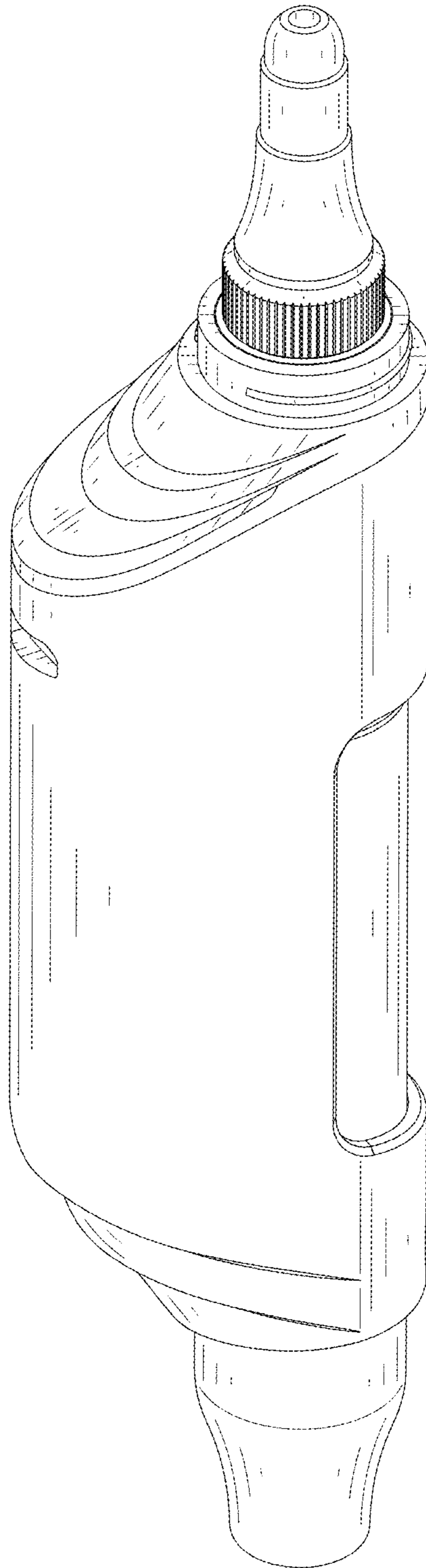

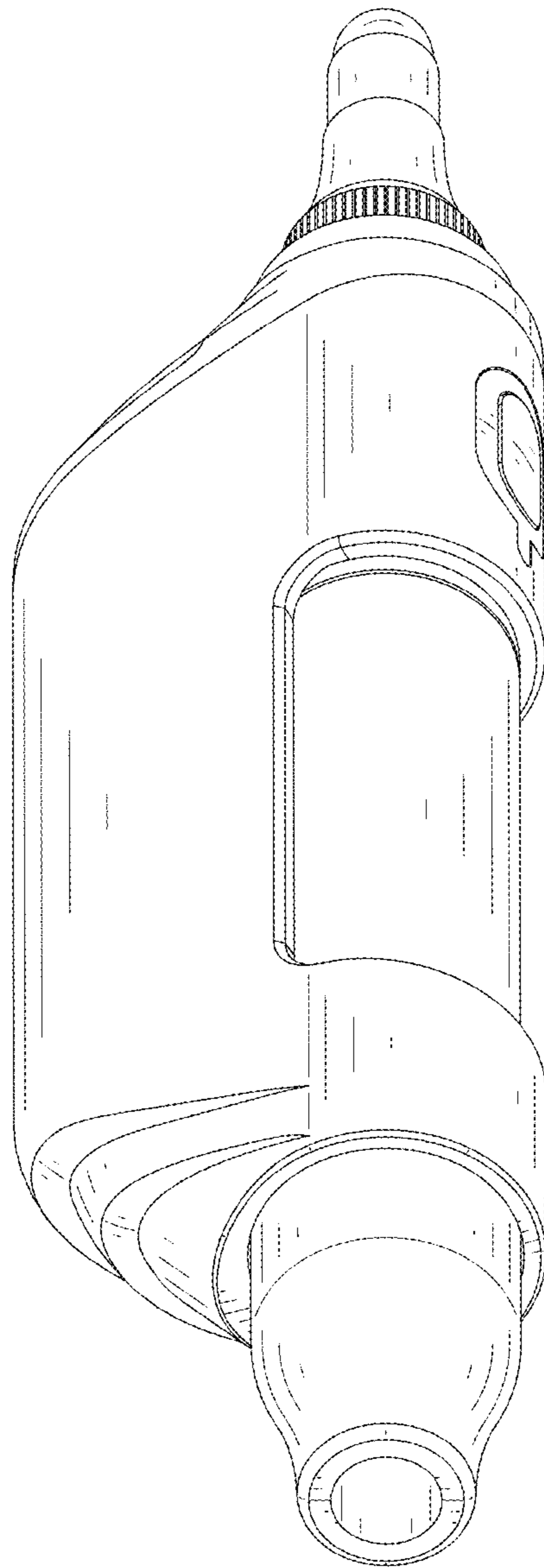

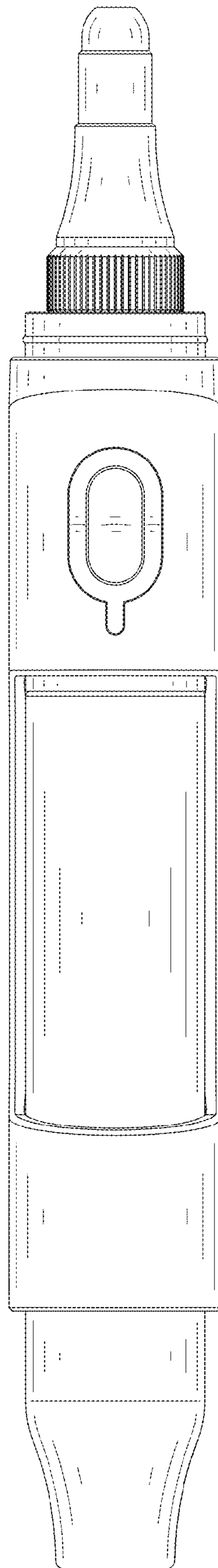

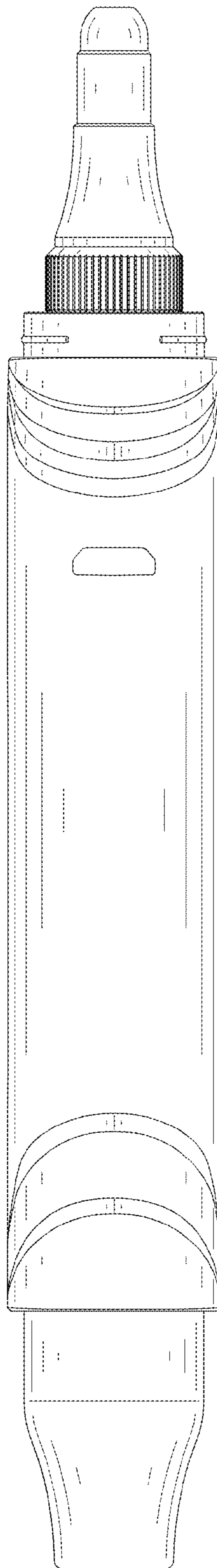

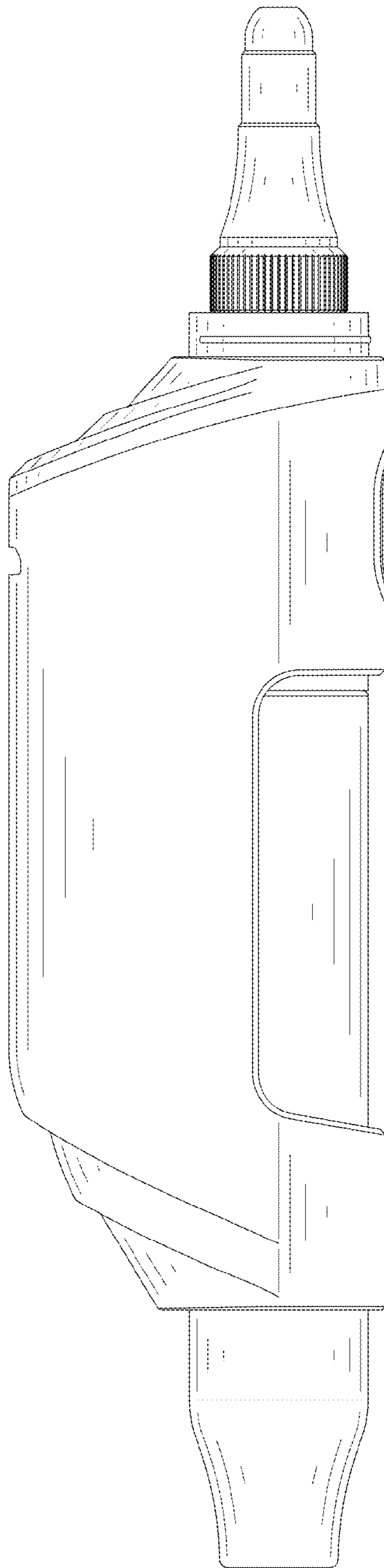

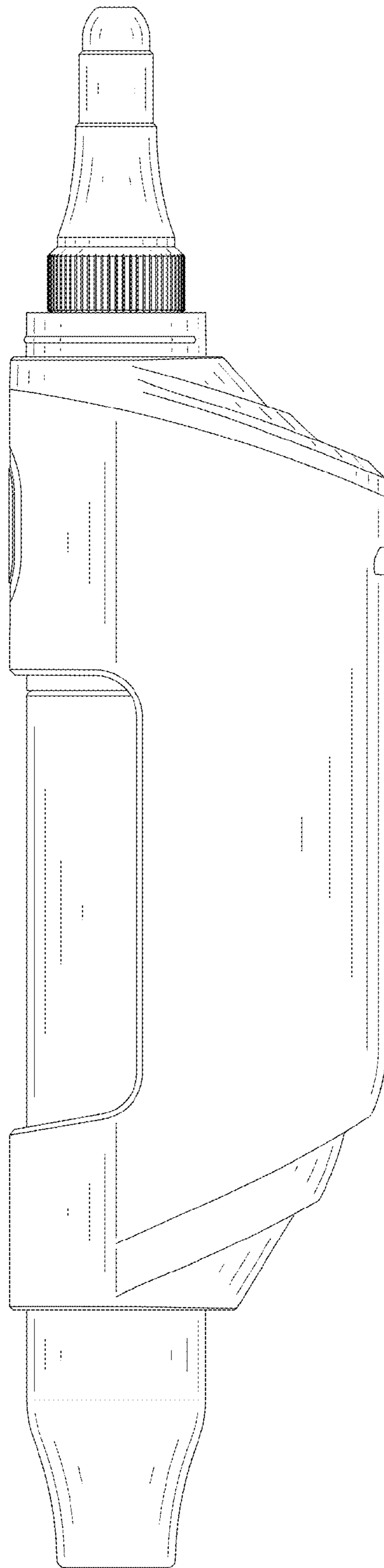

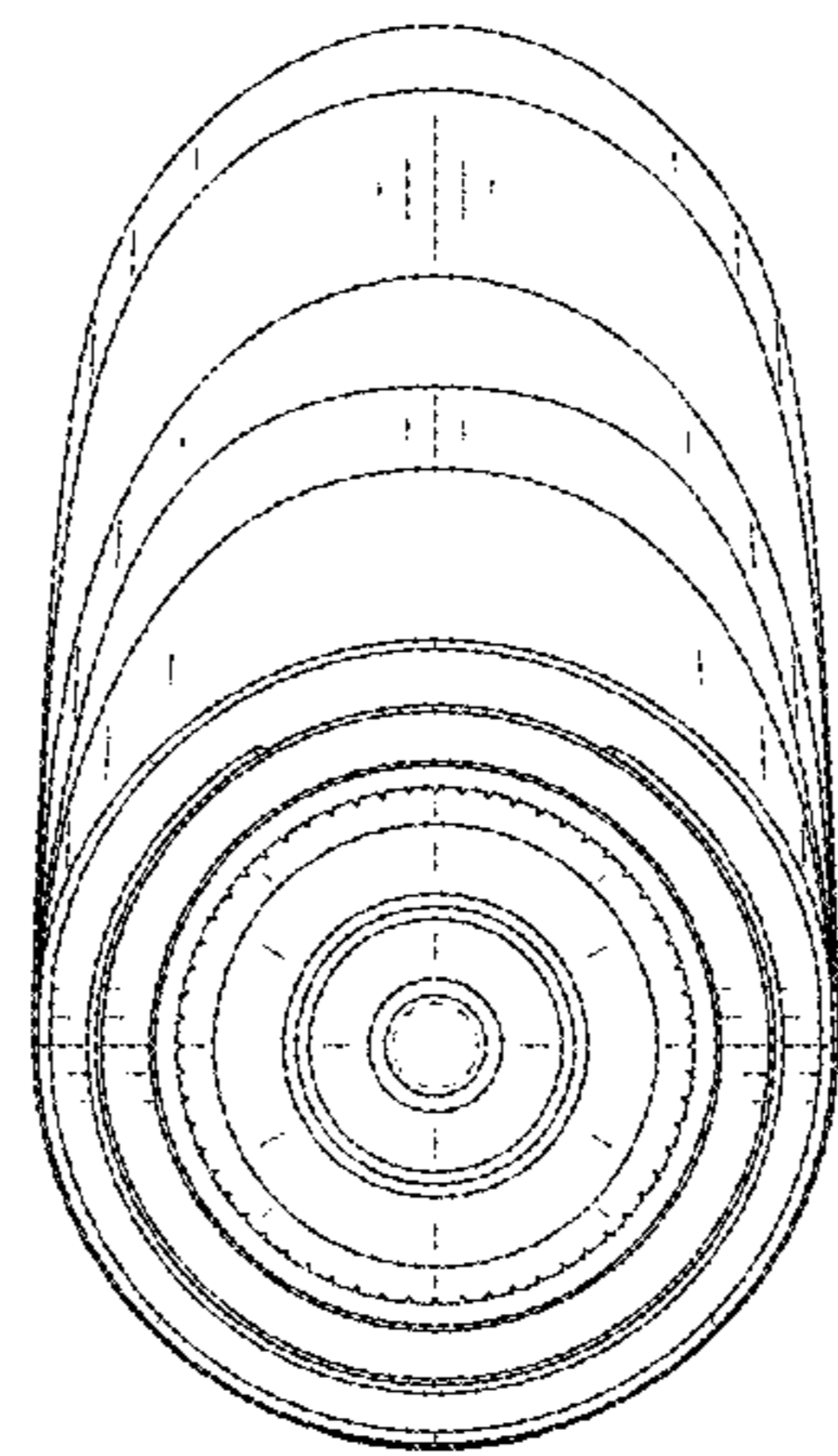

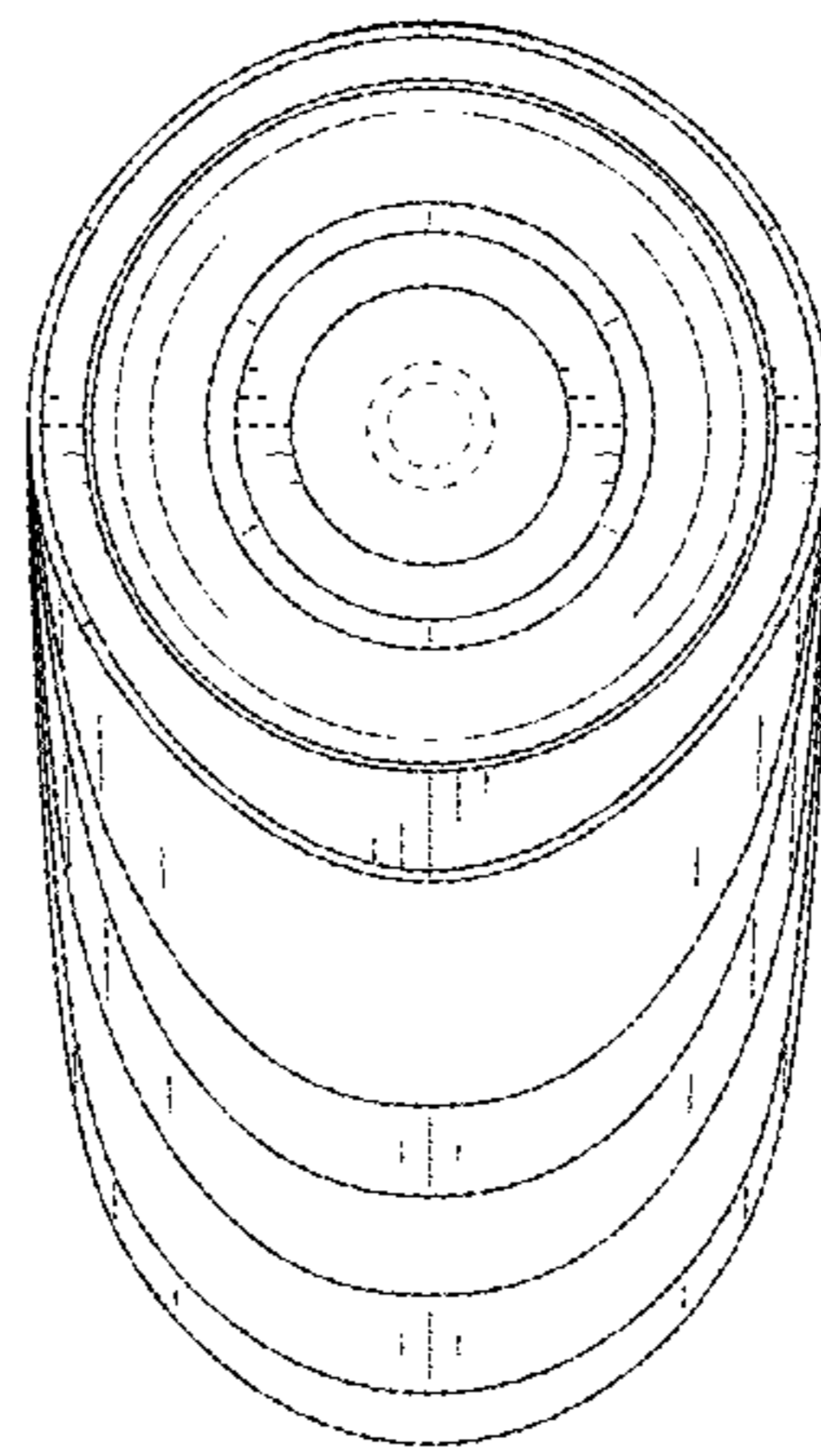

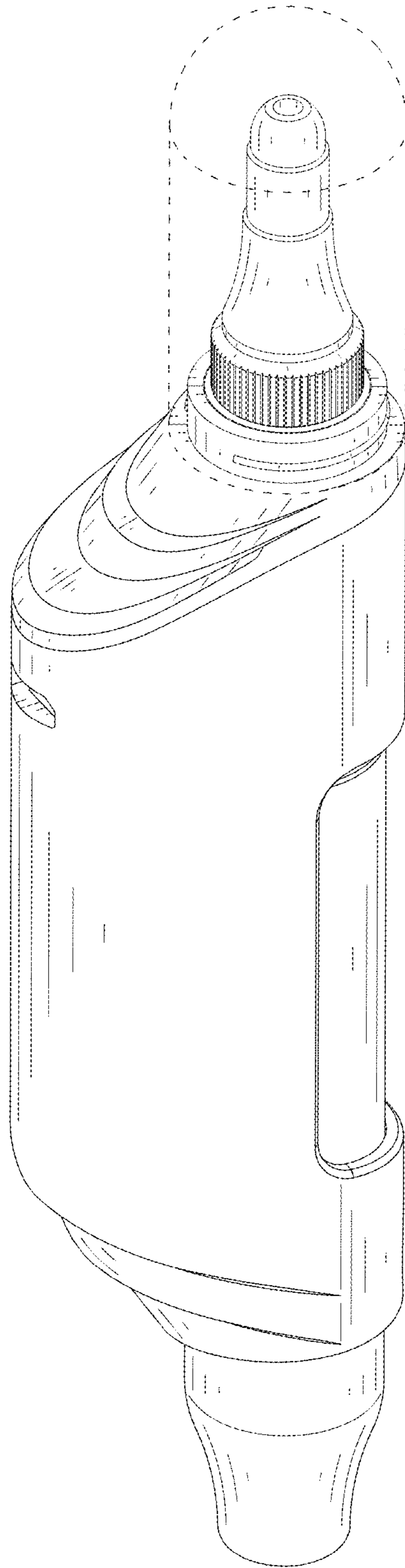
