(57) **CLAIM**

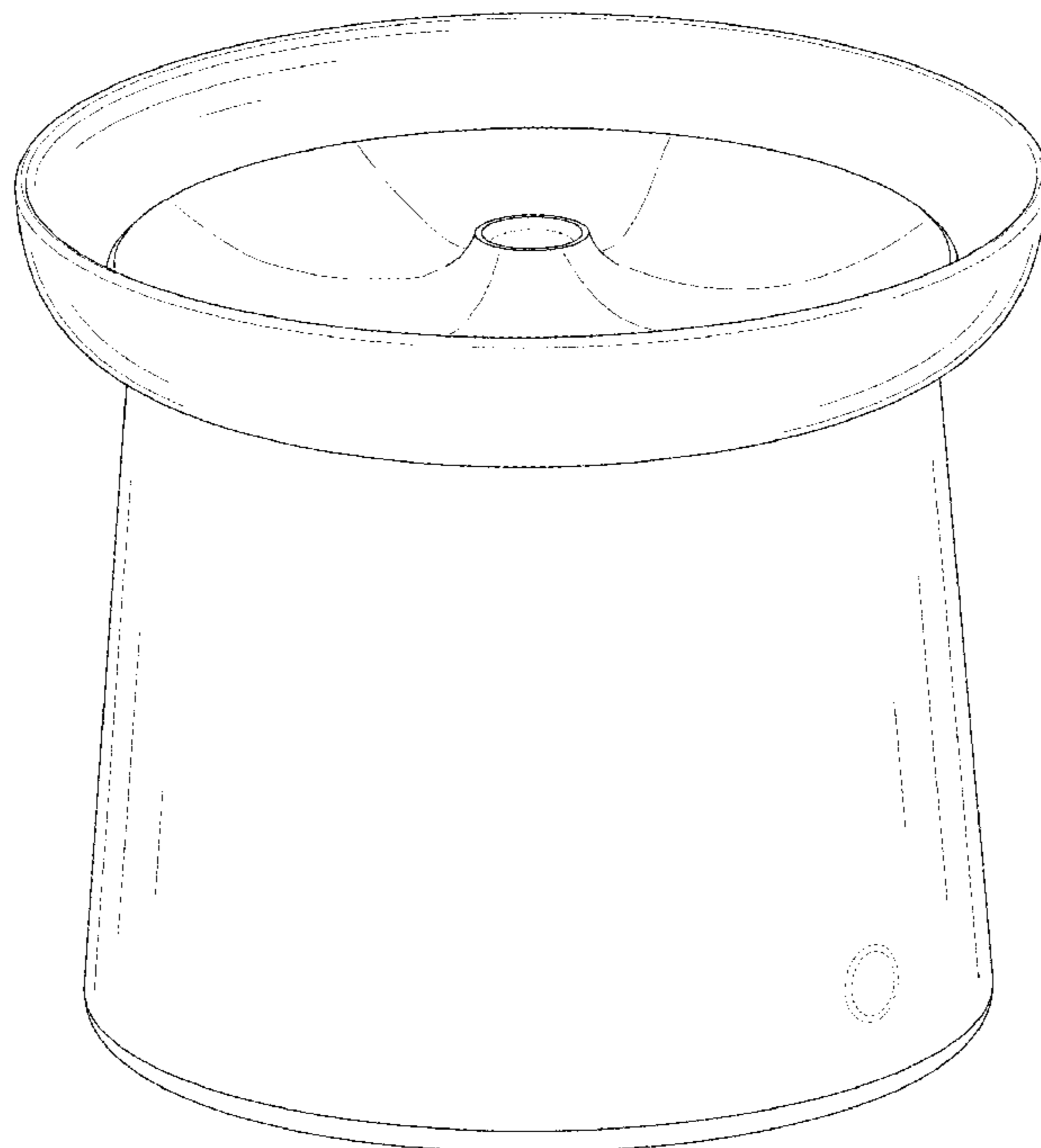
The ornamental design for an automatic water dispenser for pet, as shown and described.

DESCRIPTION

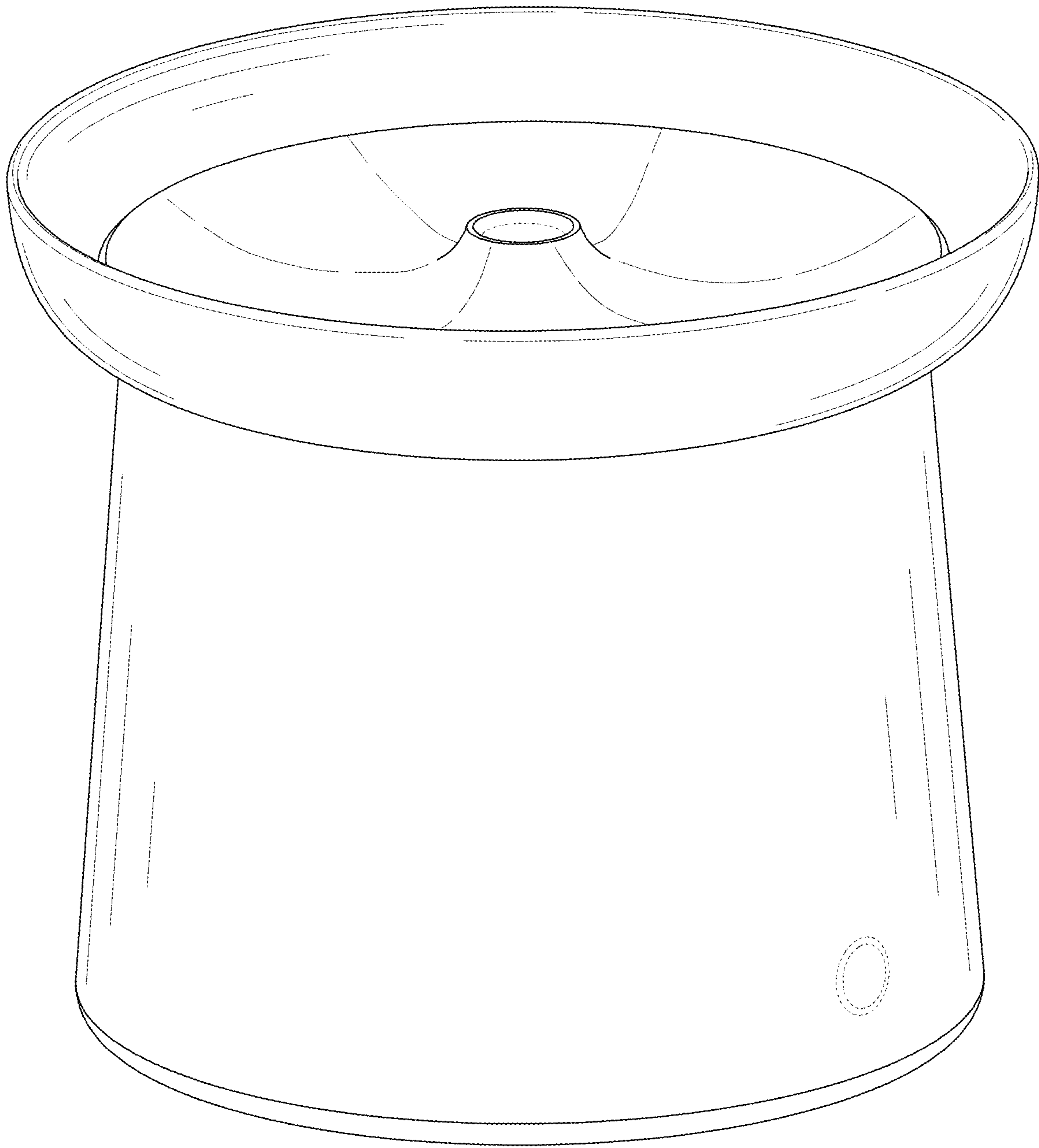

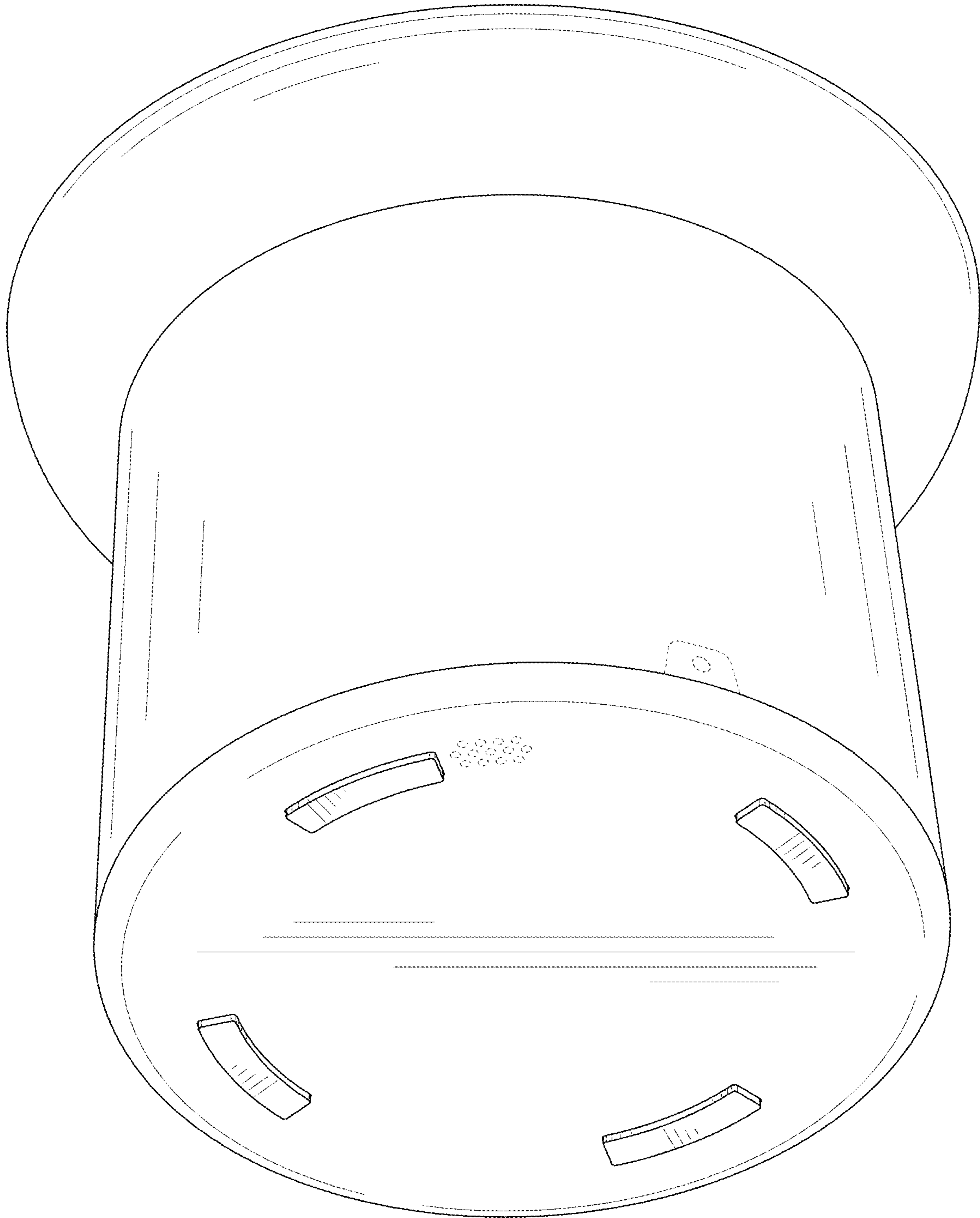

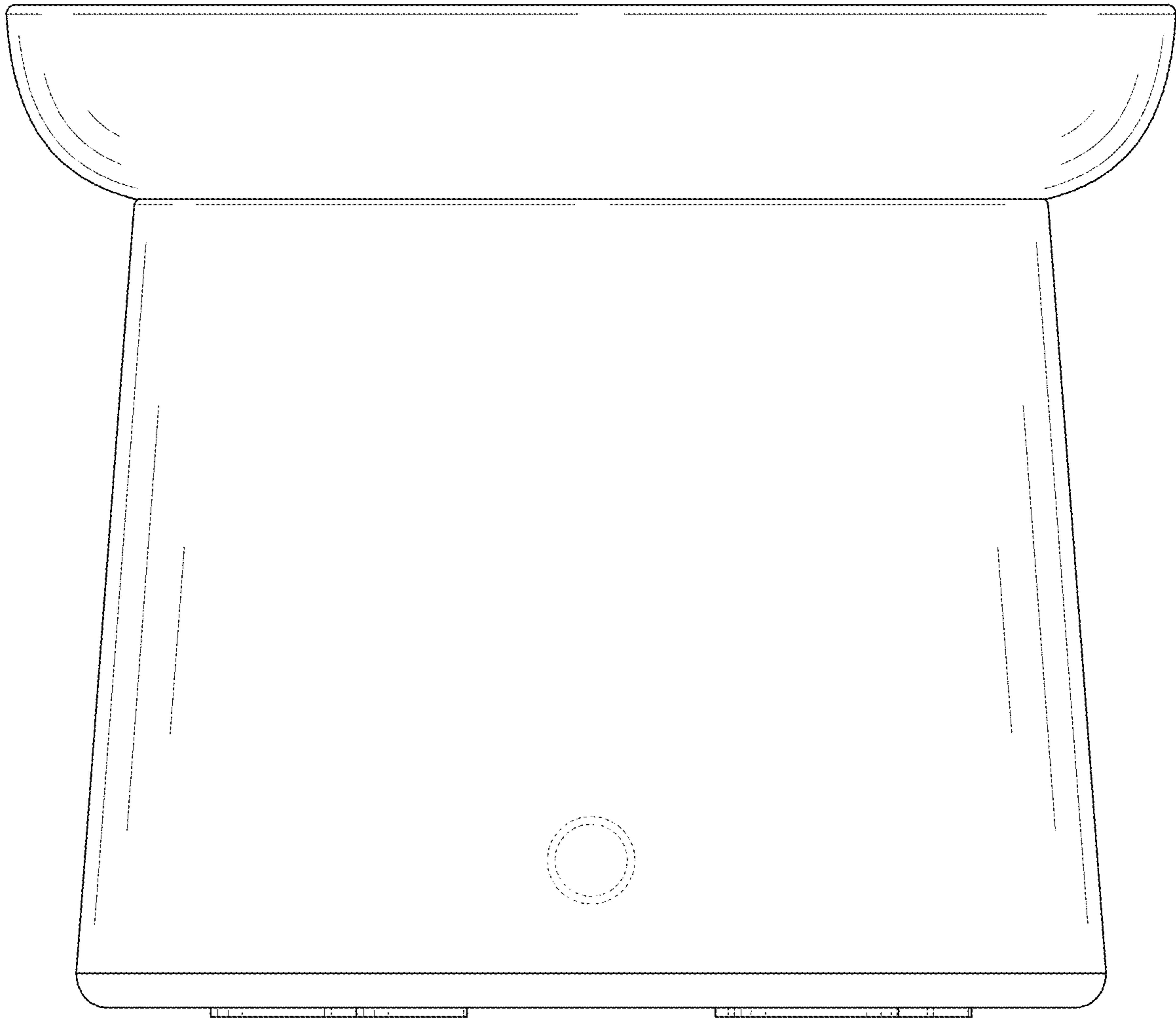

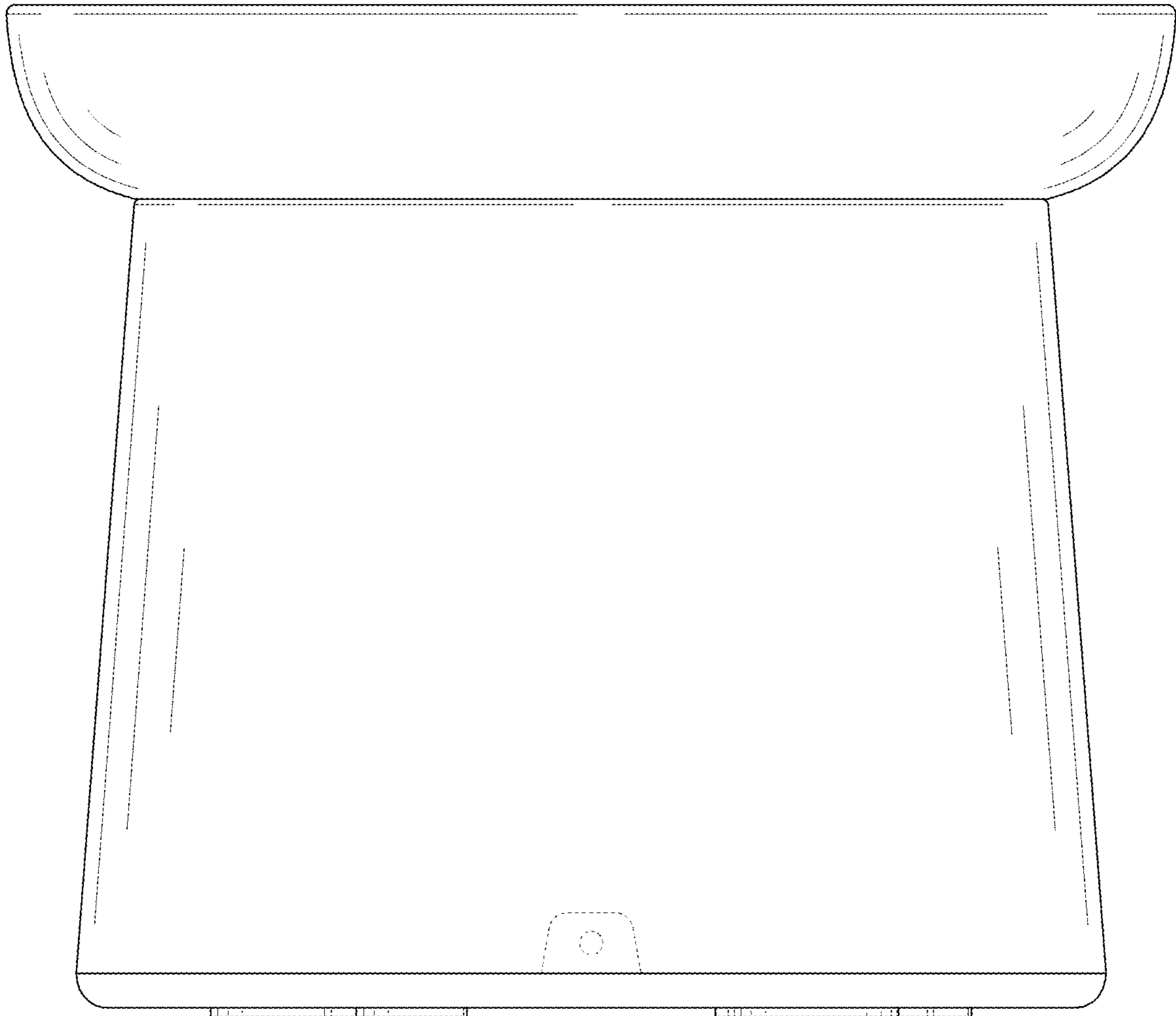

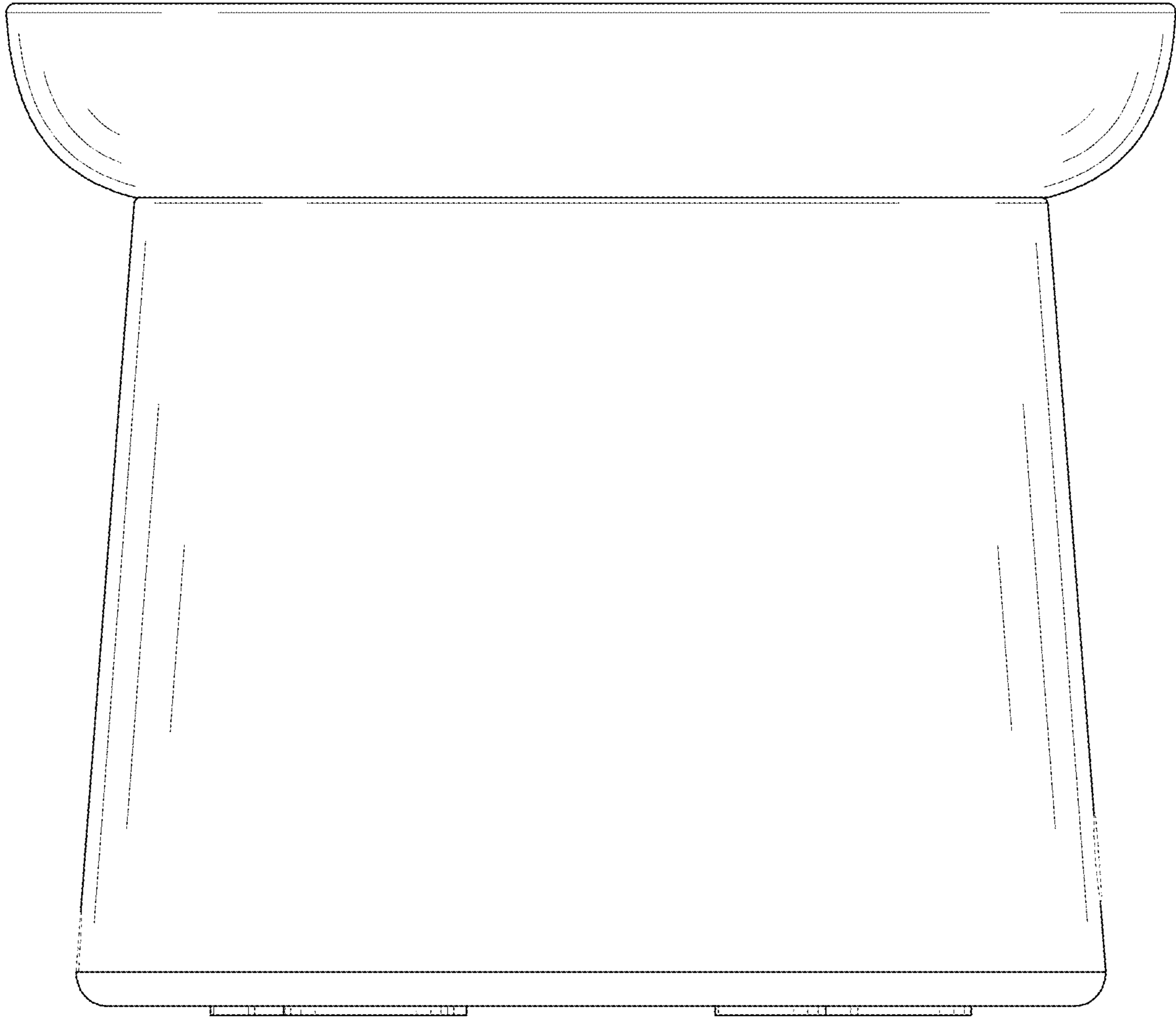

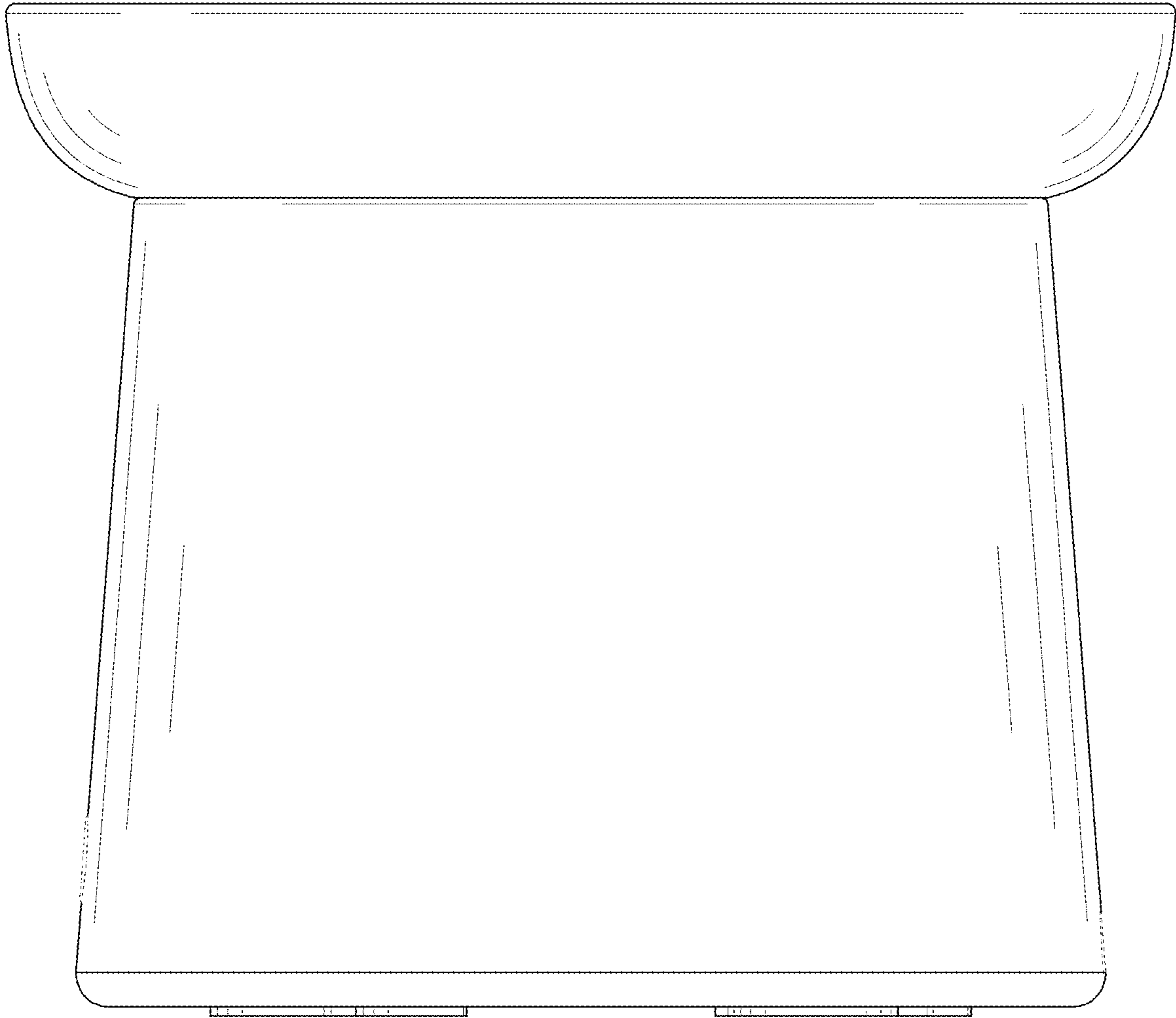

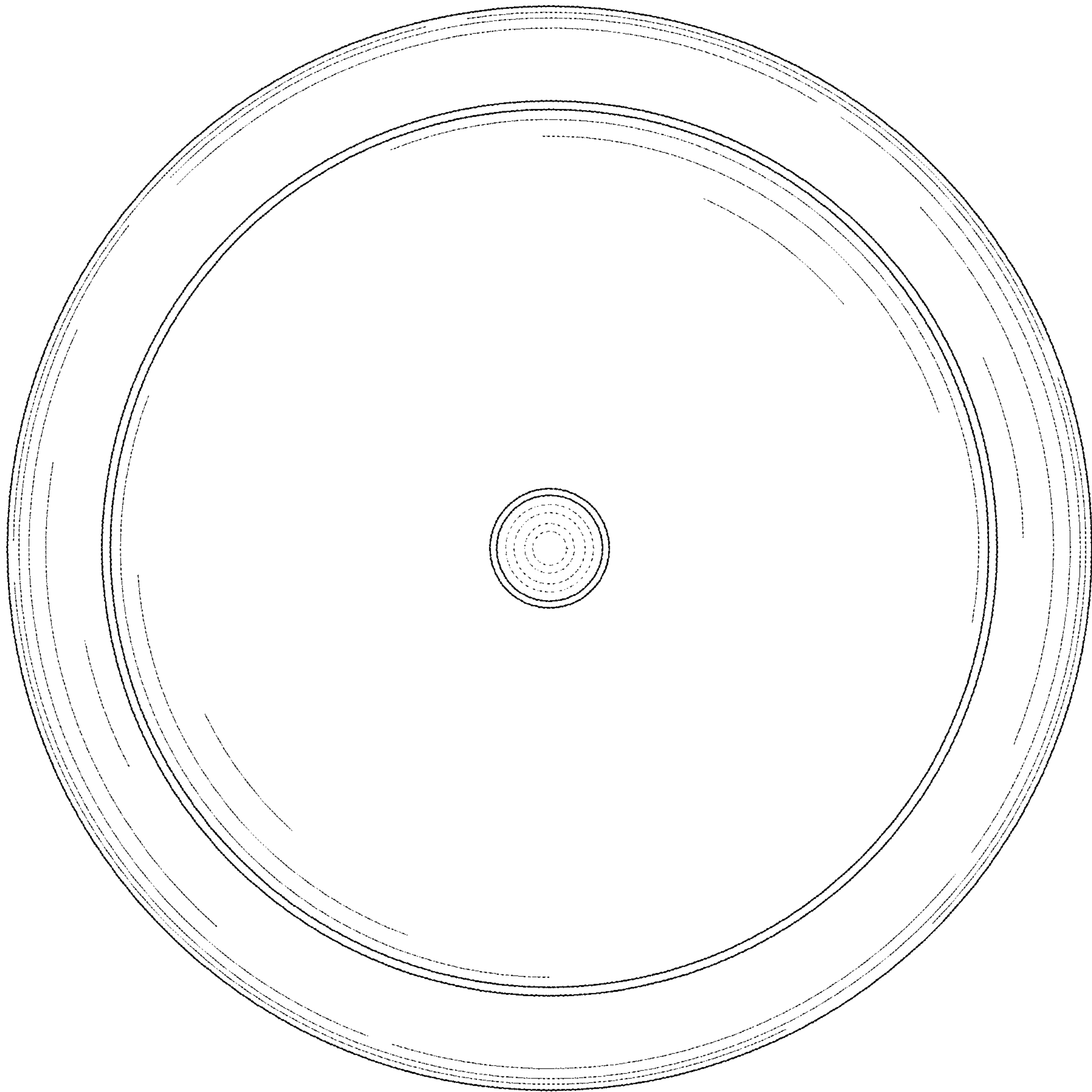

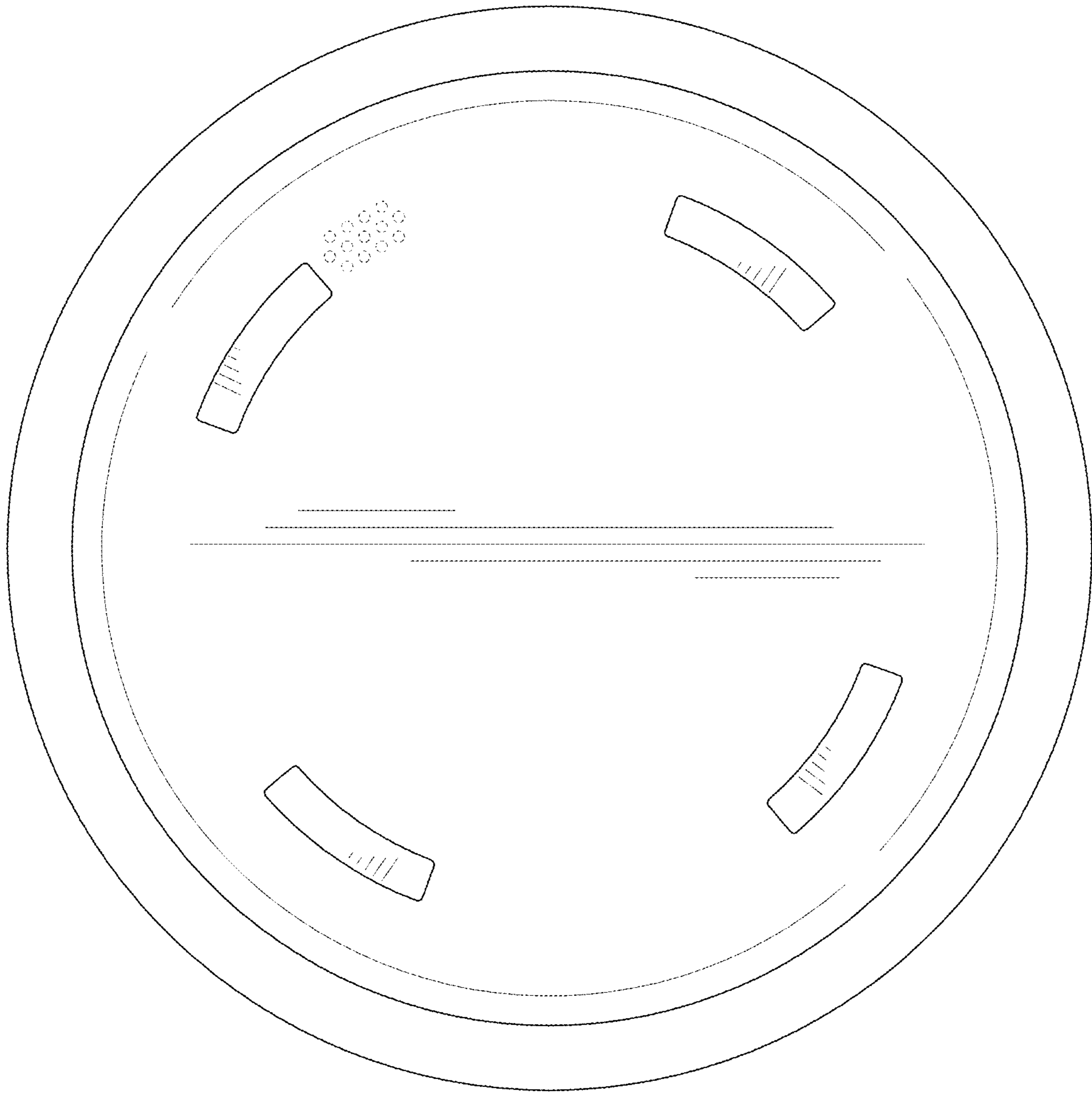
