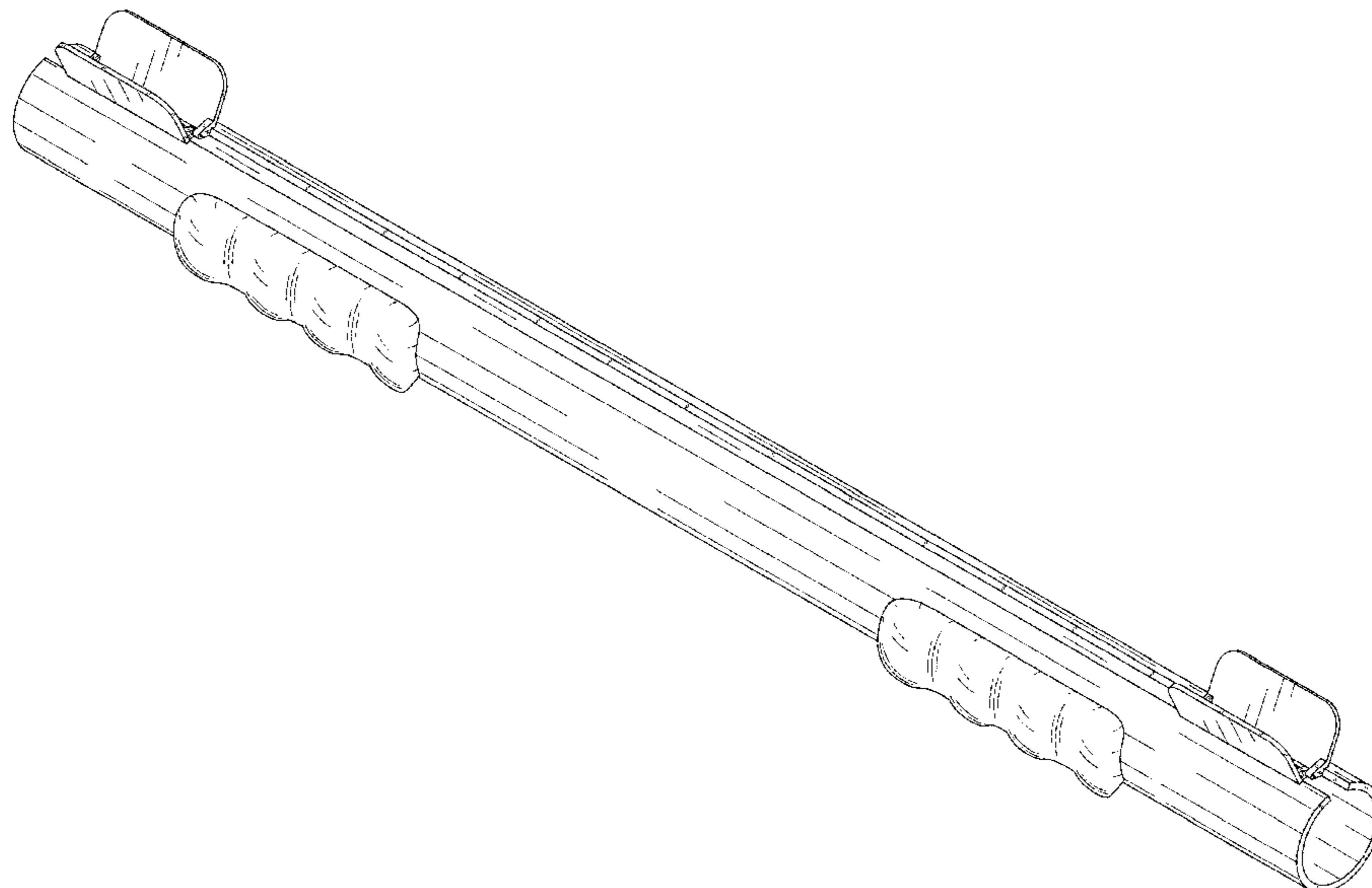
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective top front right view of a cart handle safety cover, showing my new design;

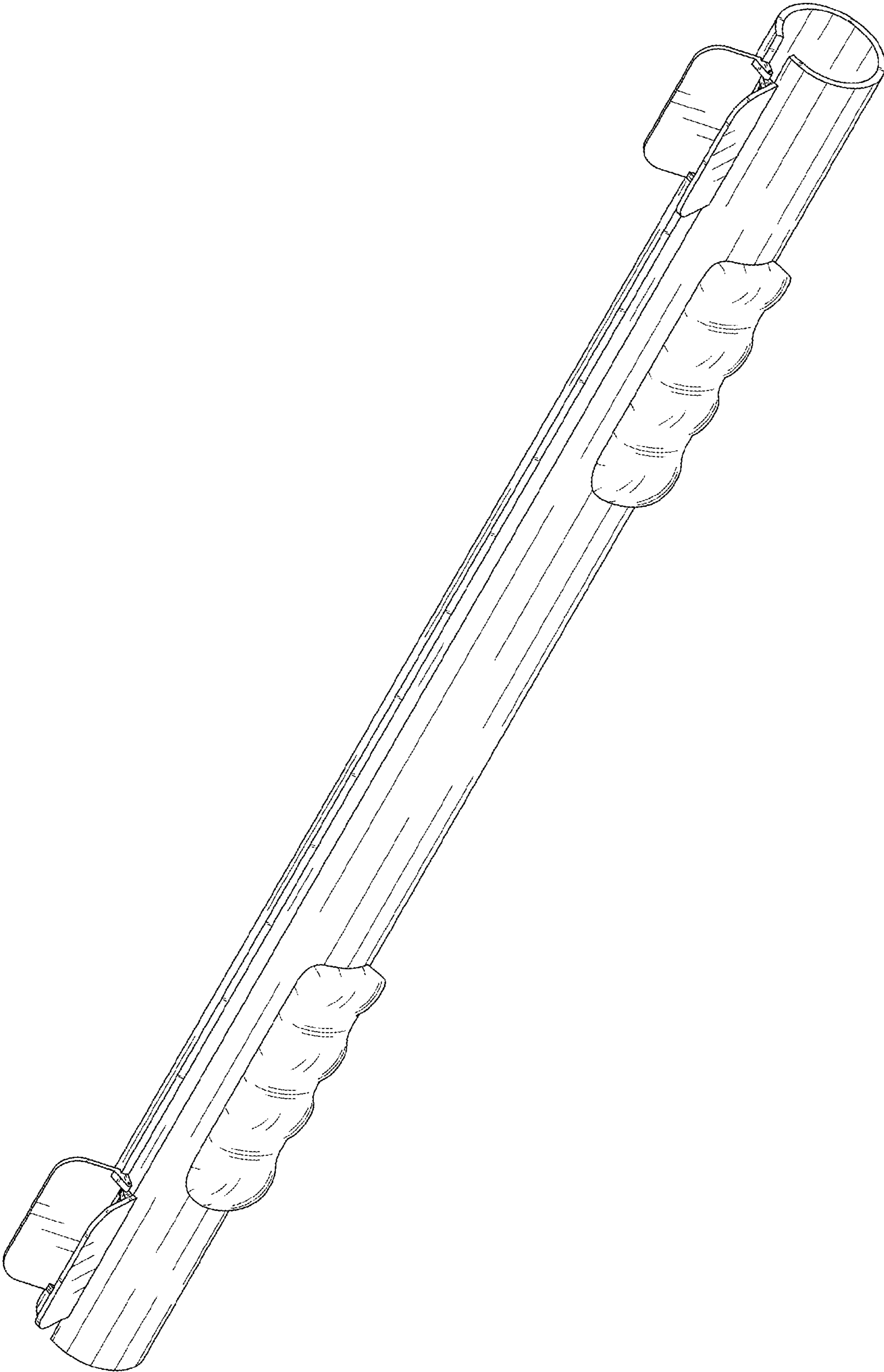

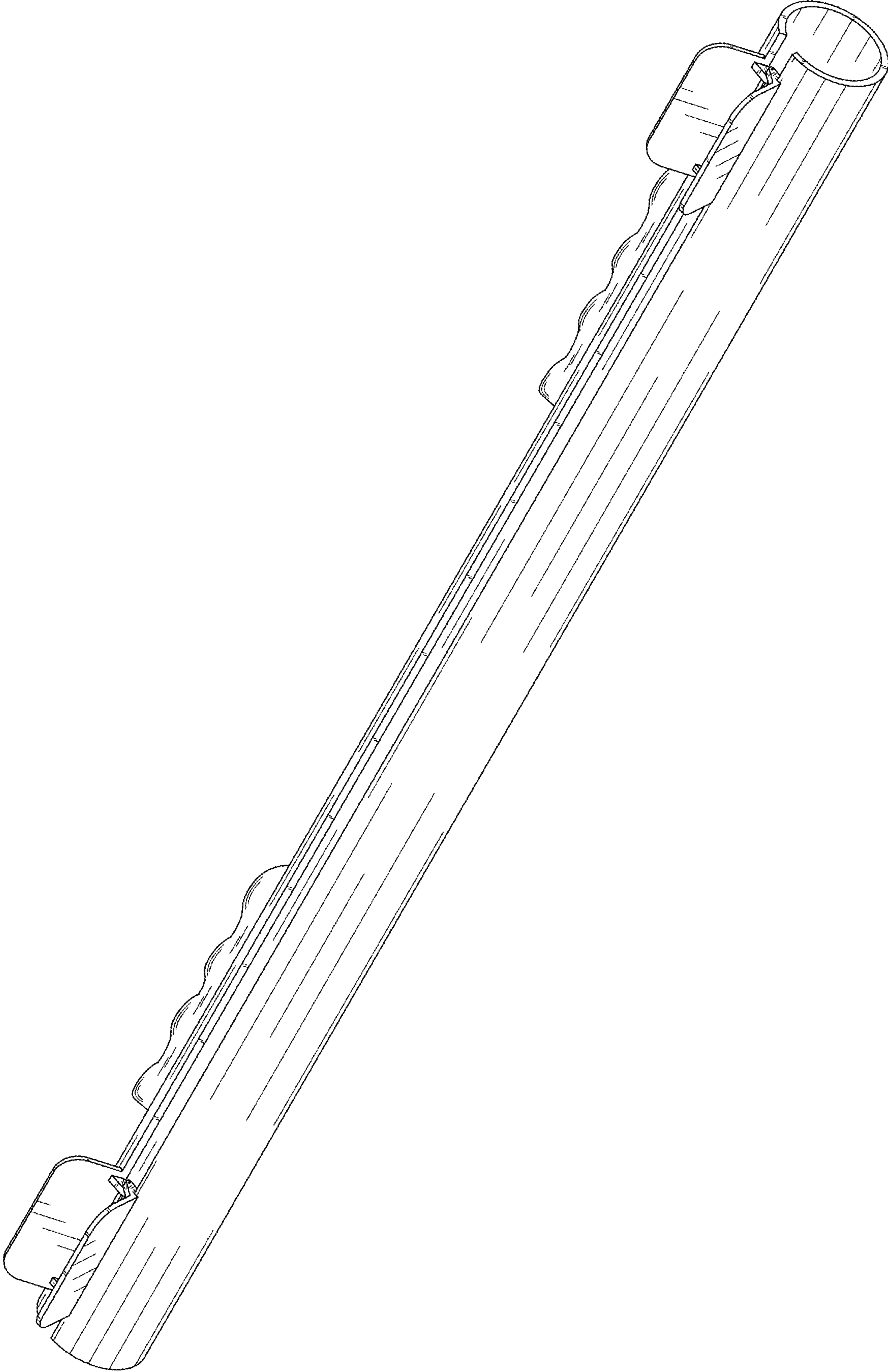

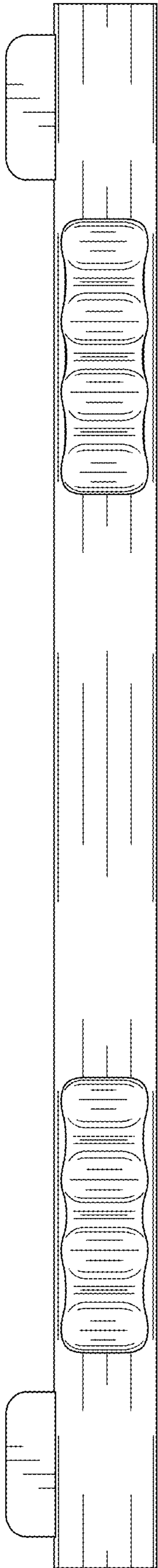

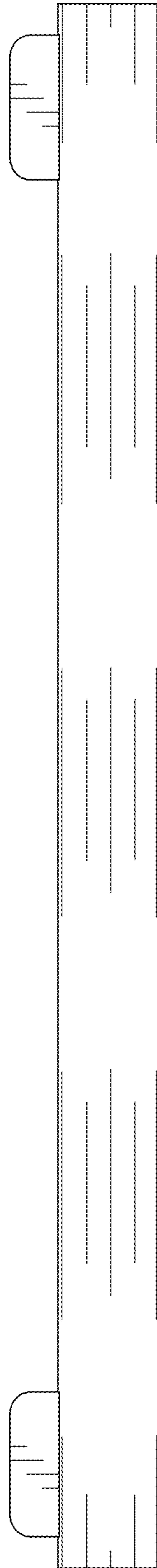

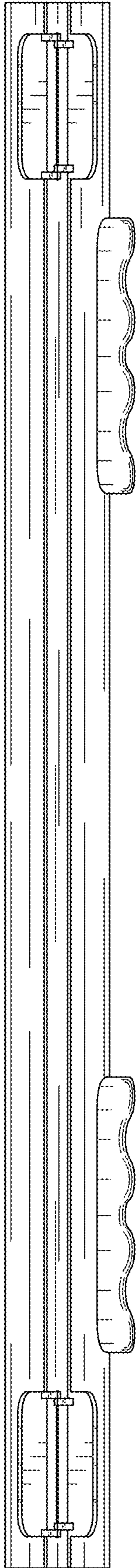

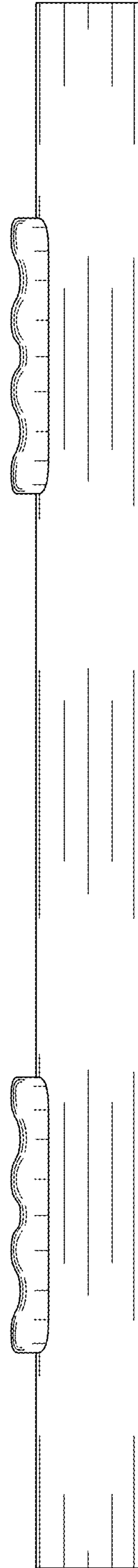

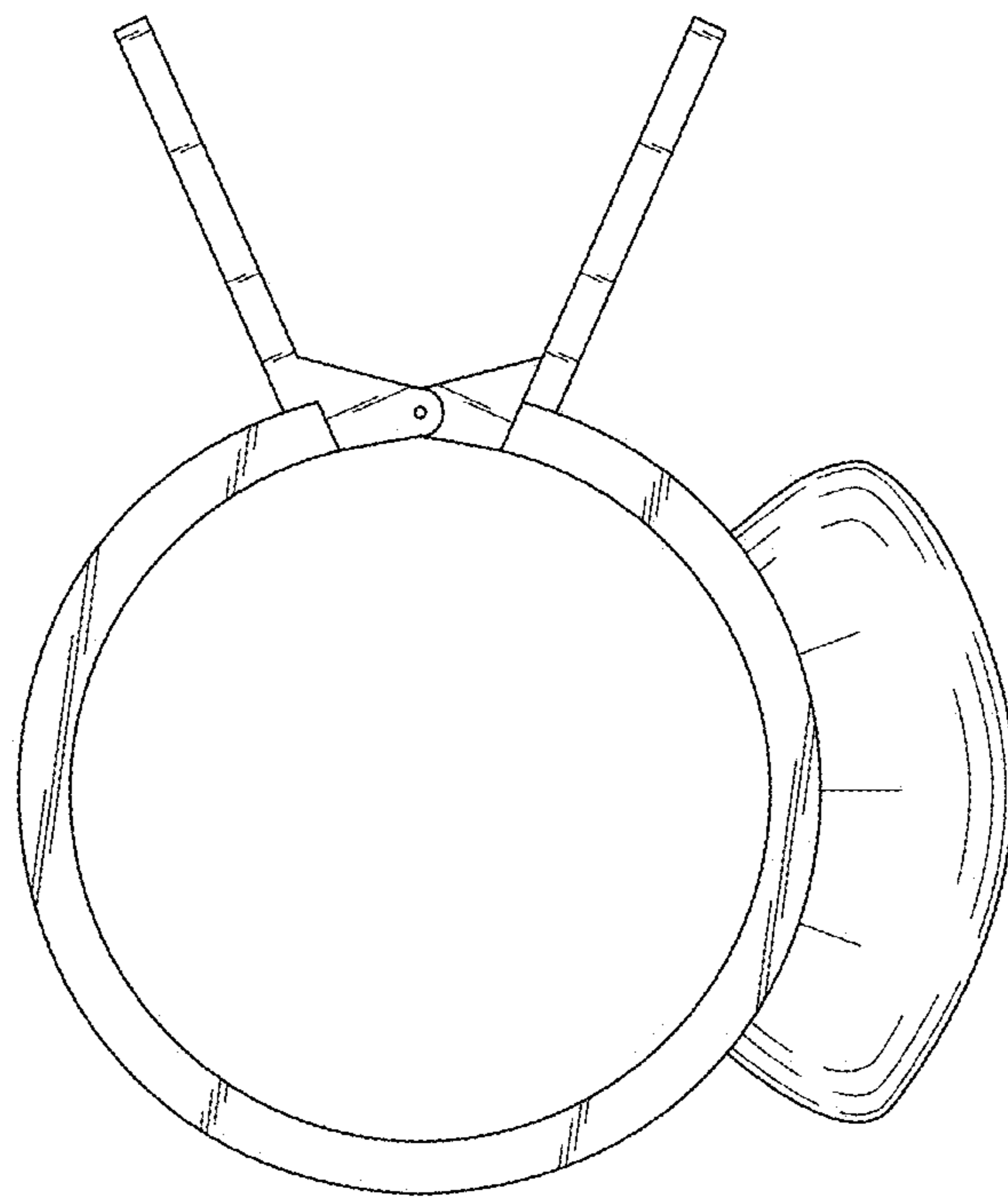

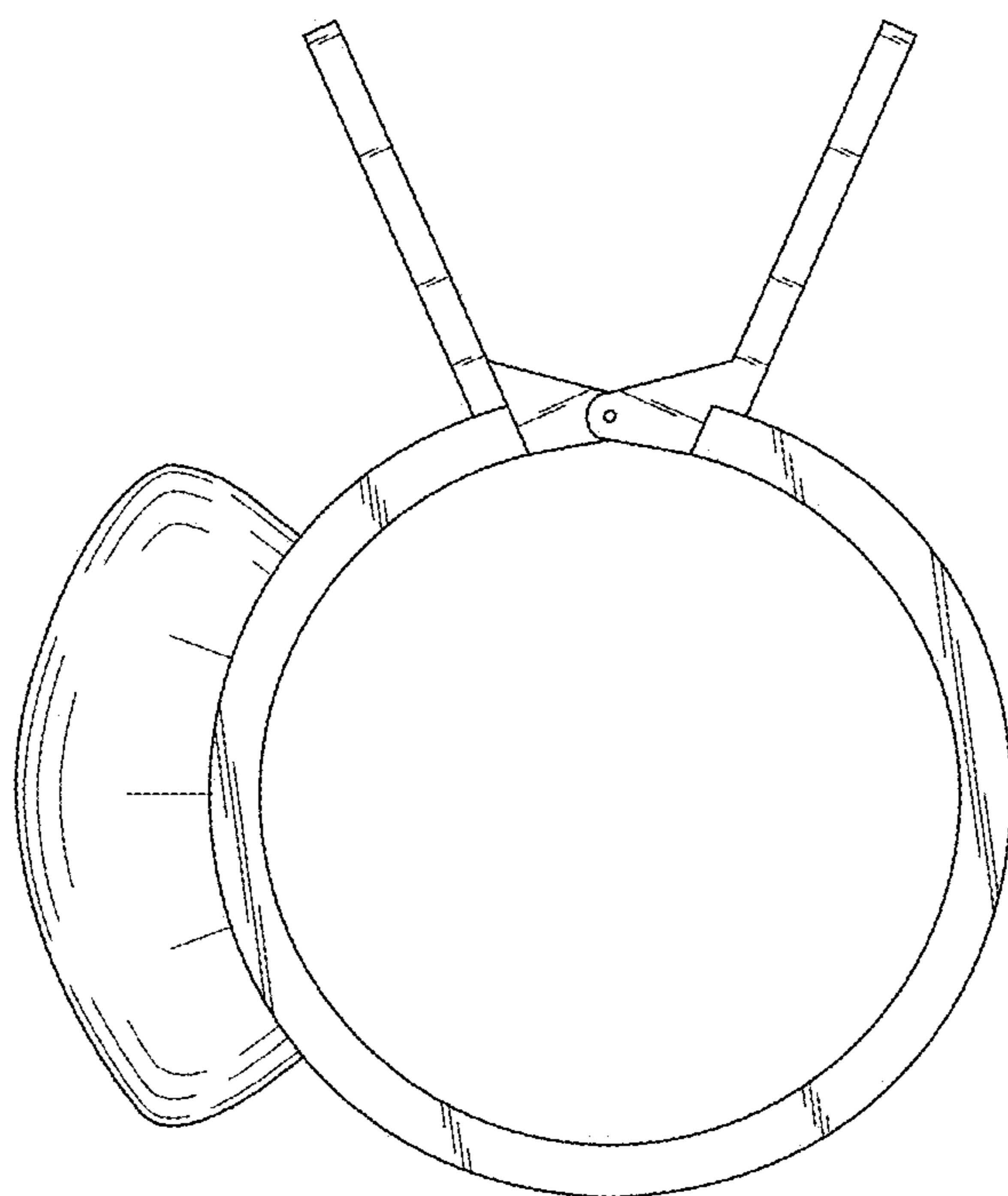
