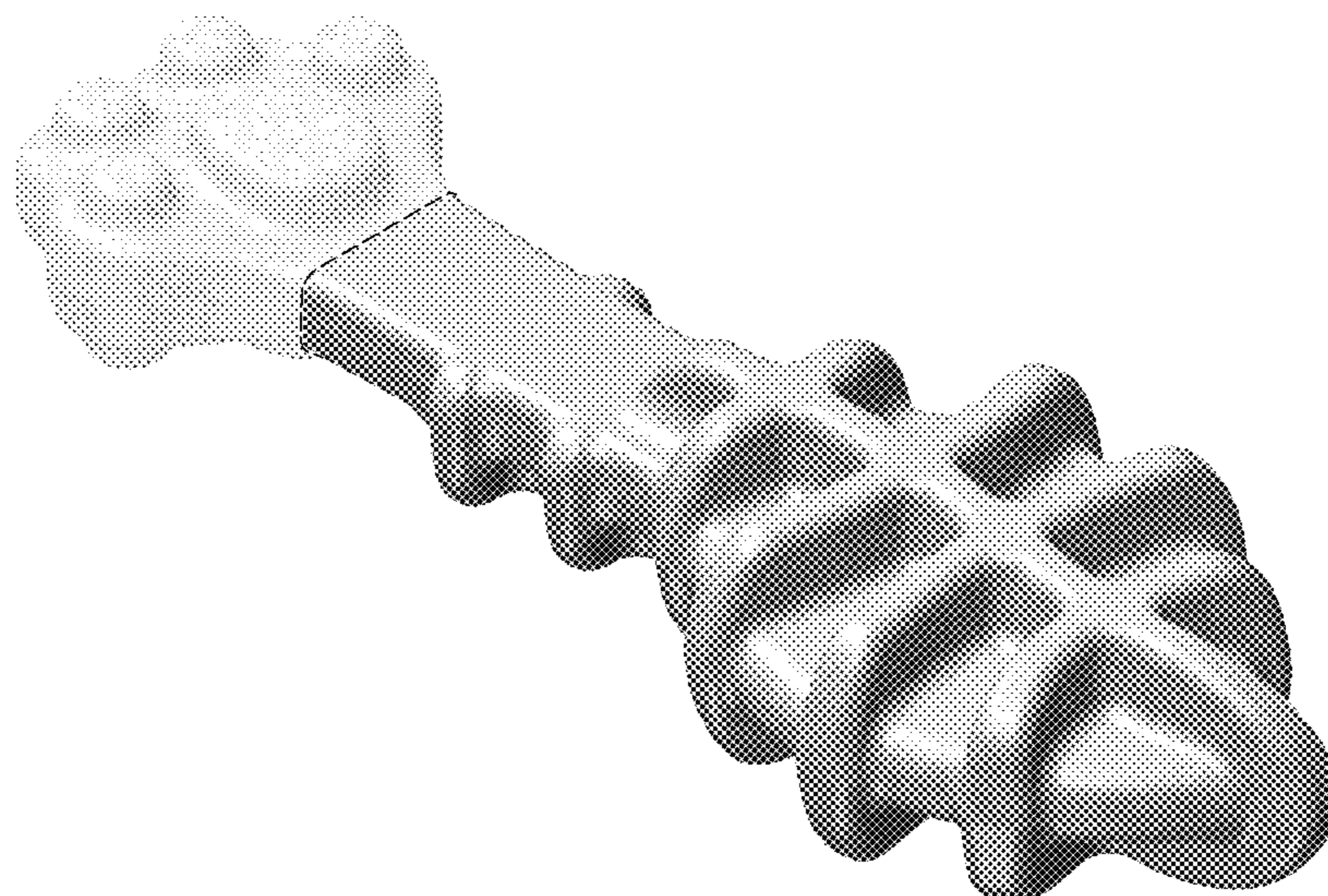
(57) **CLAIM**

The ornamental design for a pet treat, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, left side perspective view of a pet treat according to the invention;  
FIG. 2 is a rear, bottom, left side perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is a left side elevation view thereof; and,  
FIG. 7 is a right side elevation view thereof.  
The broken lines in FIGS. 1-4 and 6-7 illustrate the boundary of the claimed design which forms no part thereof. The de-emphasized and half-tone portions illustrate portions of the pet treat that form no part of the claimed design.

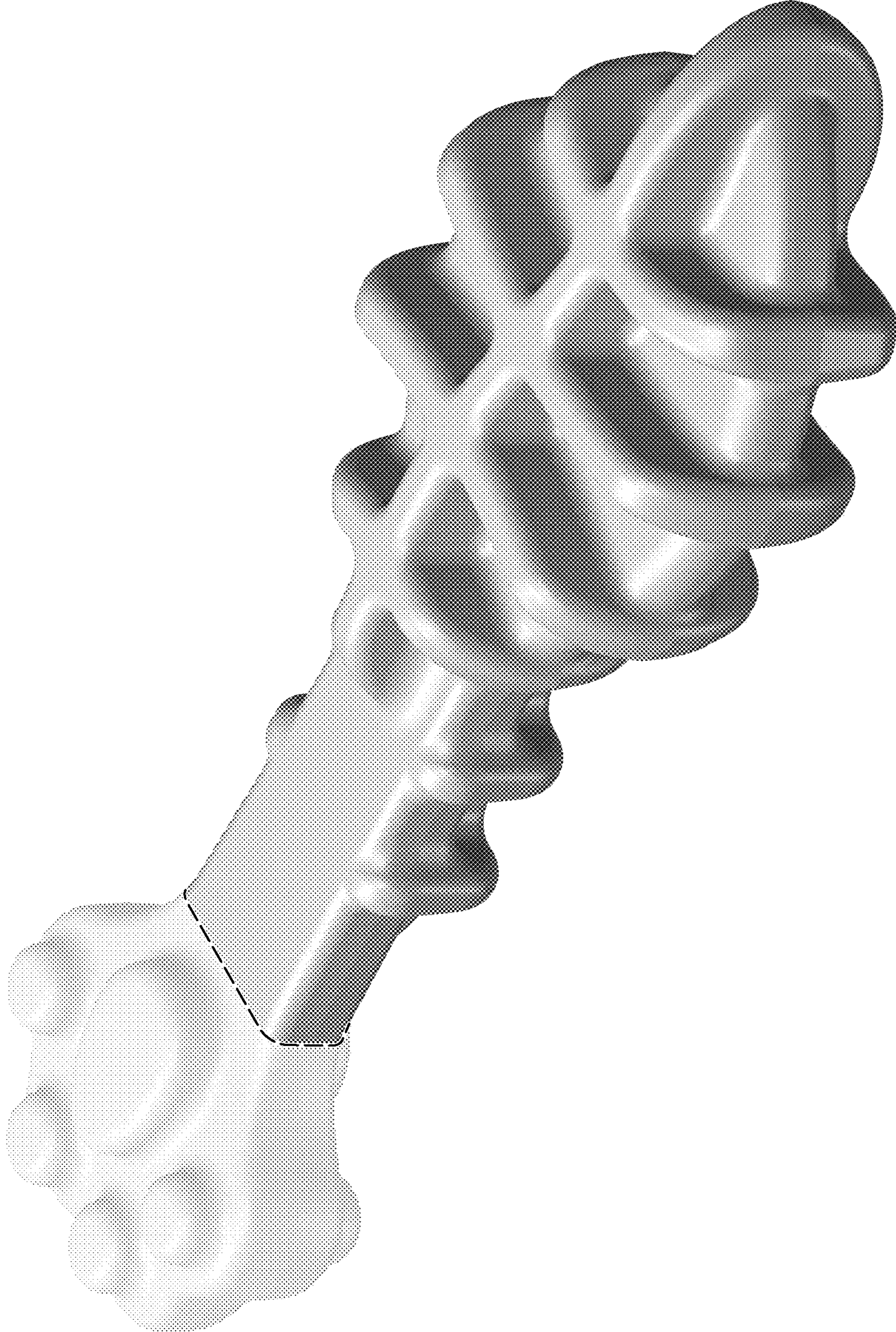

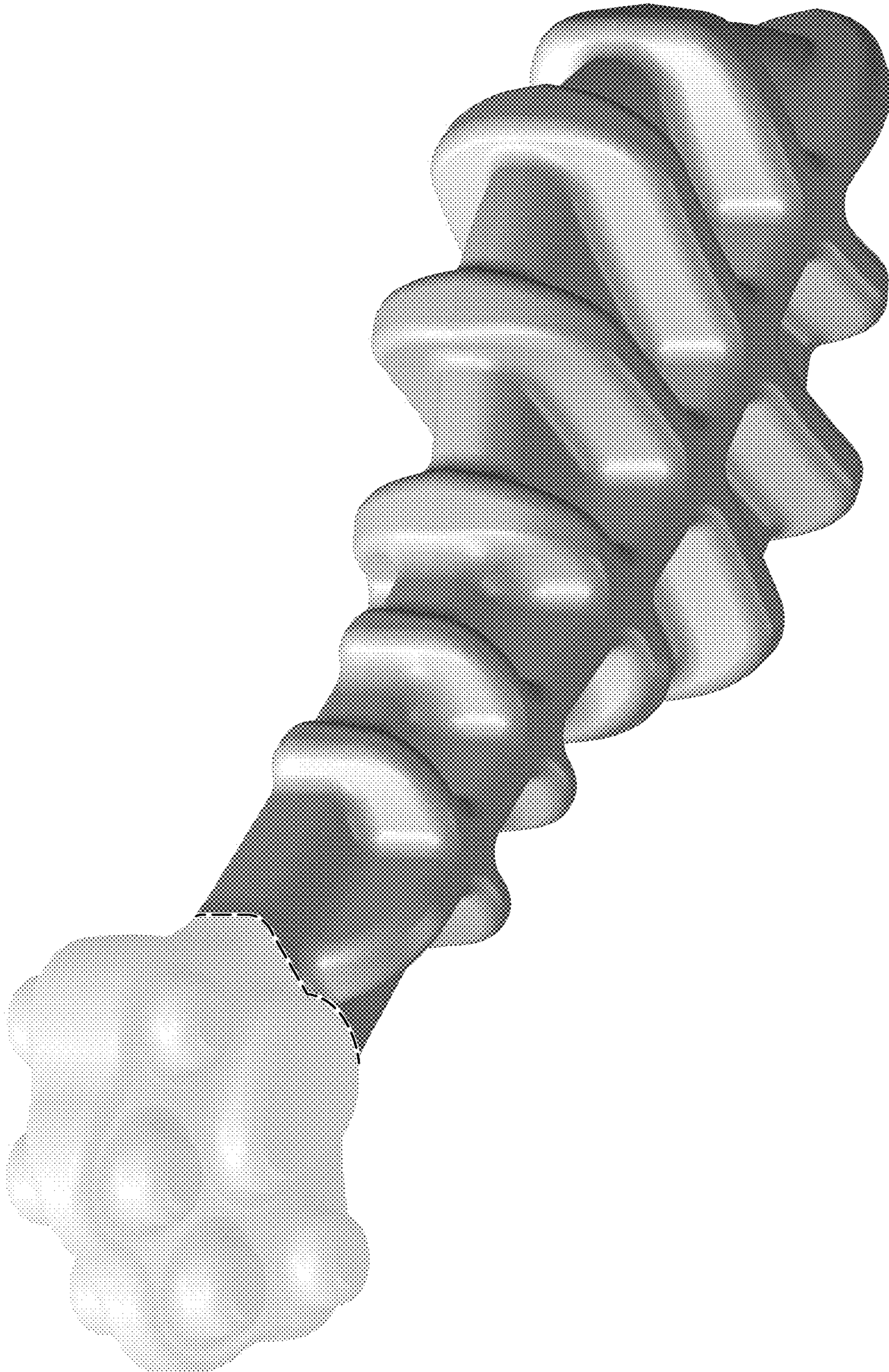

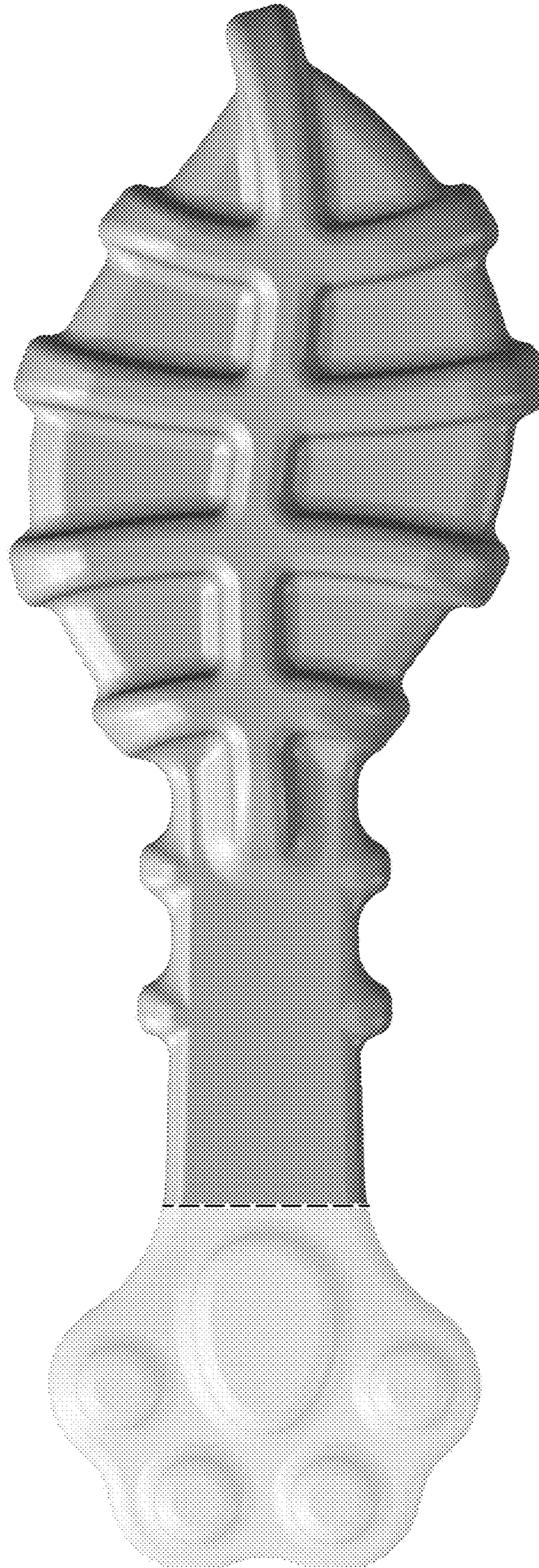

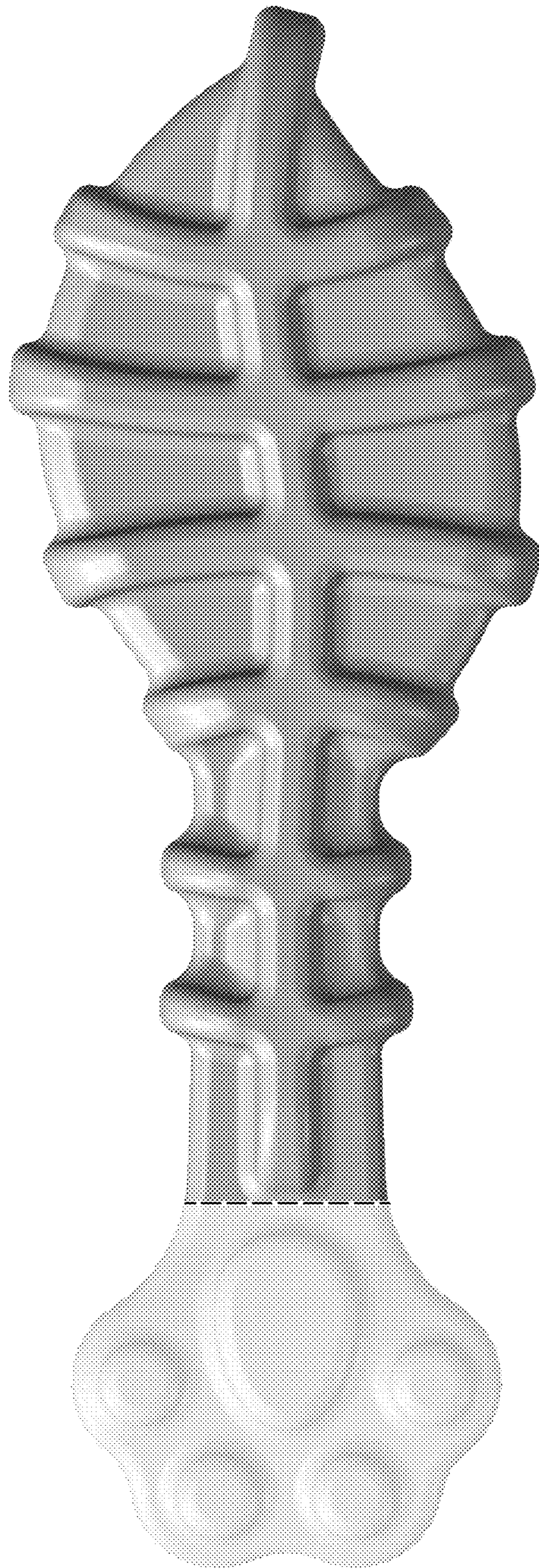

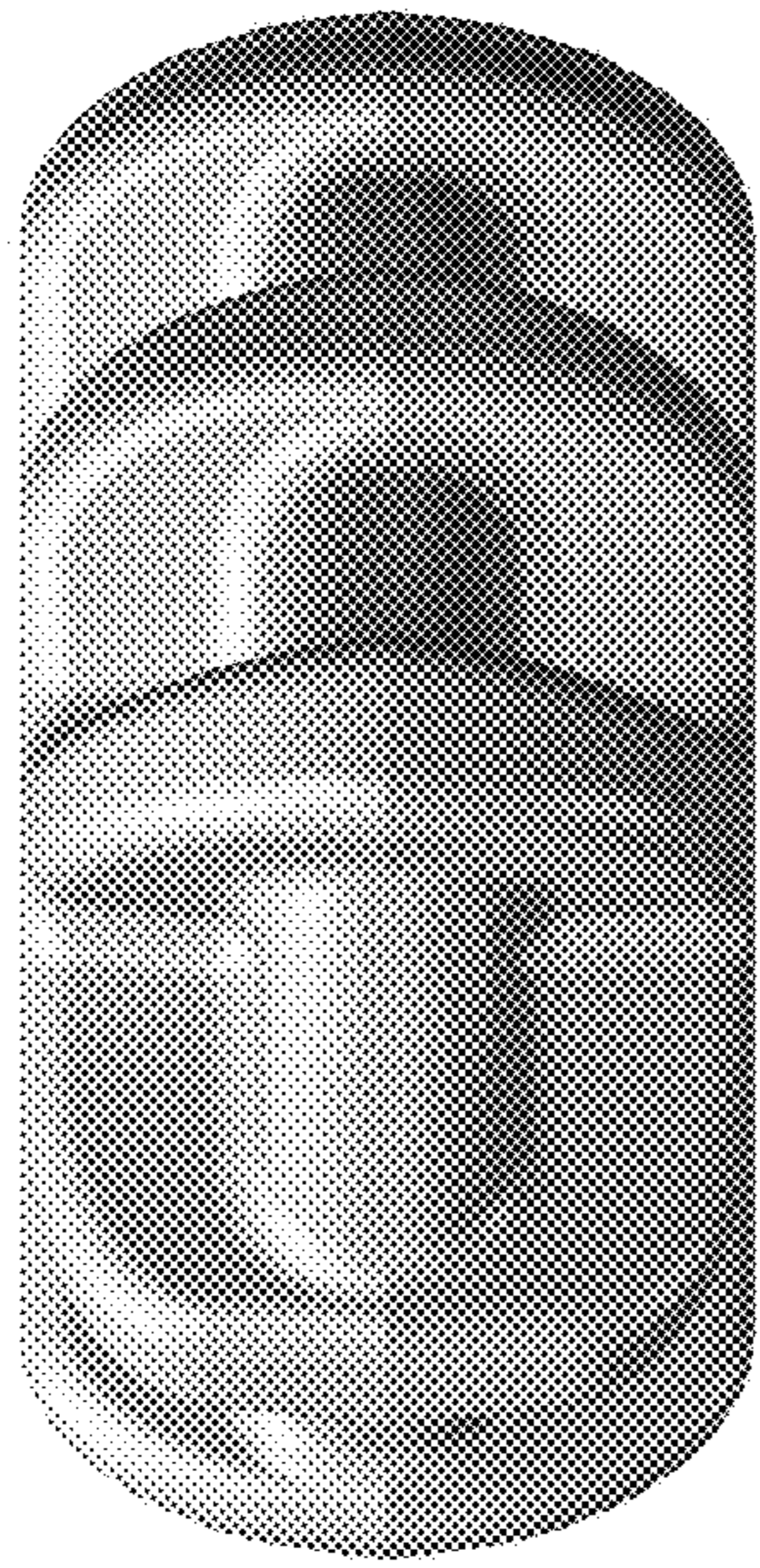

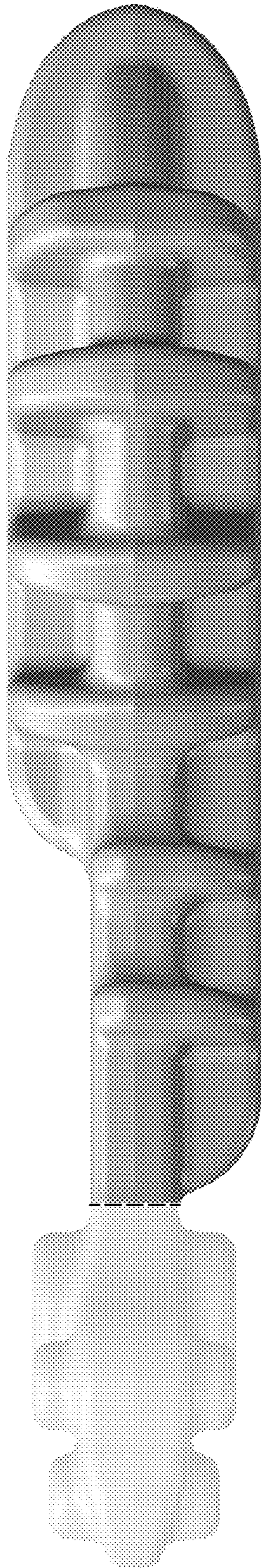

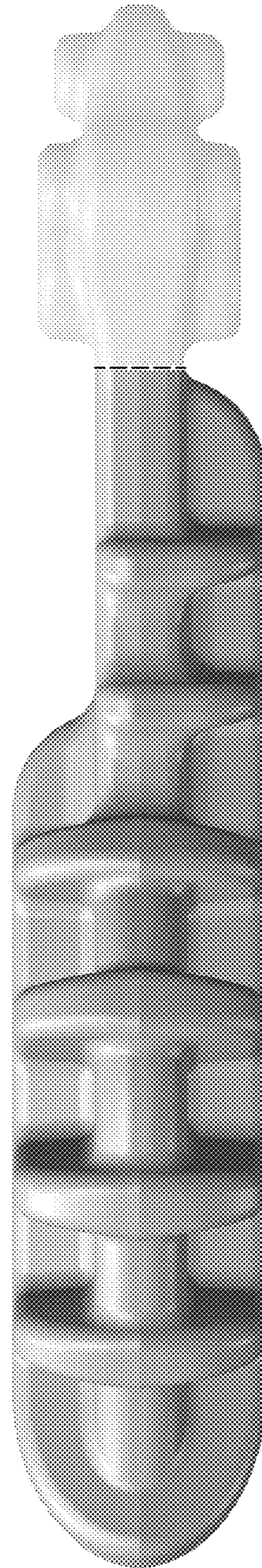
