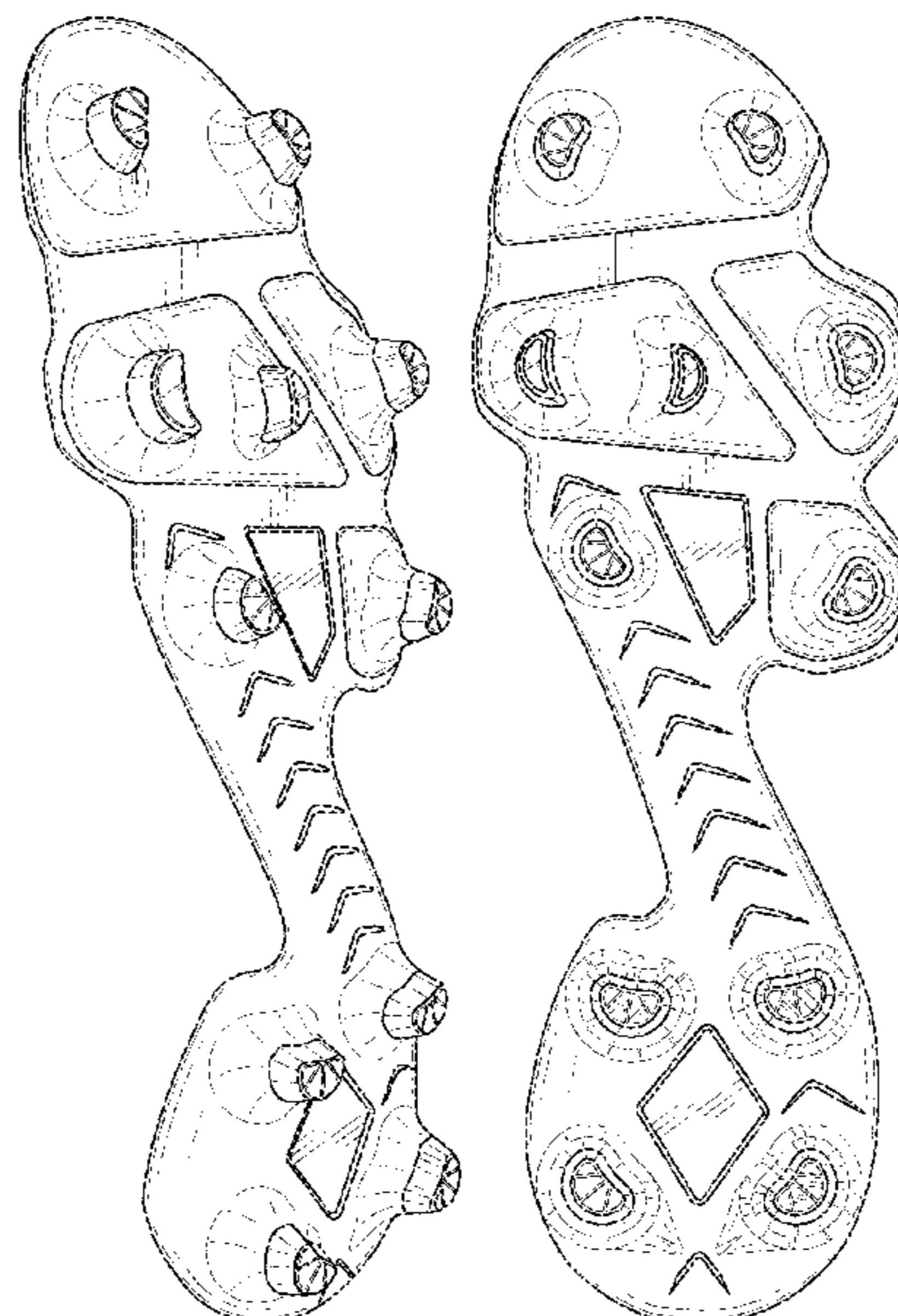
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom, right, front perspective view of an ornamental design for a shoe sole;  
FIG. 2 is a bottom plan view of the shoe sole of FIG. 1;  
FIG. 3 is a left side elevational view of the shoe sole of FIG. 1;  
FIG. 4 is a right side elevational view of the shoe sole of FIG. 1;  
FIG. 5 is a front elevational view of the shoe sole of FIG. 1; and,

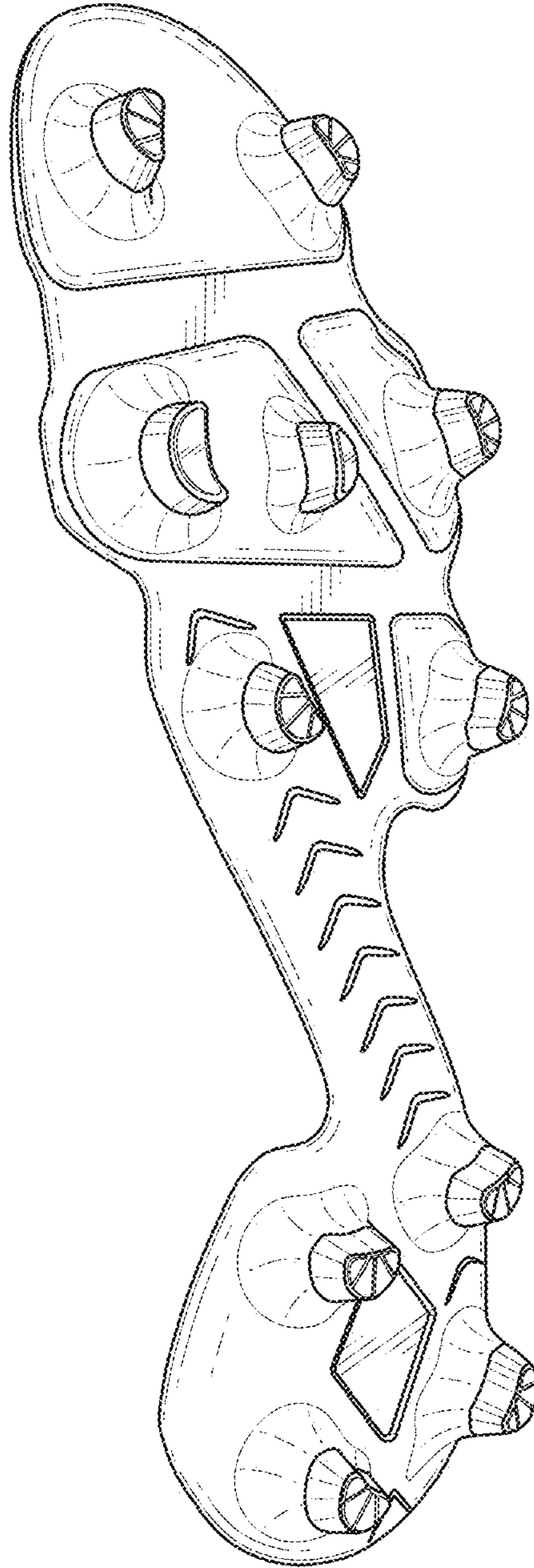

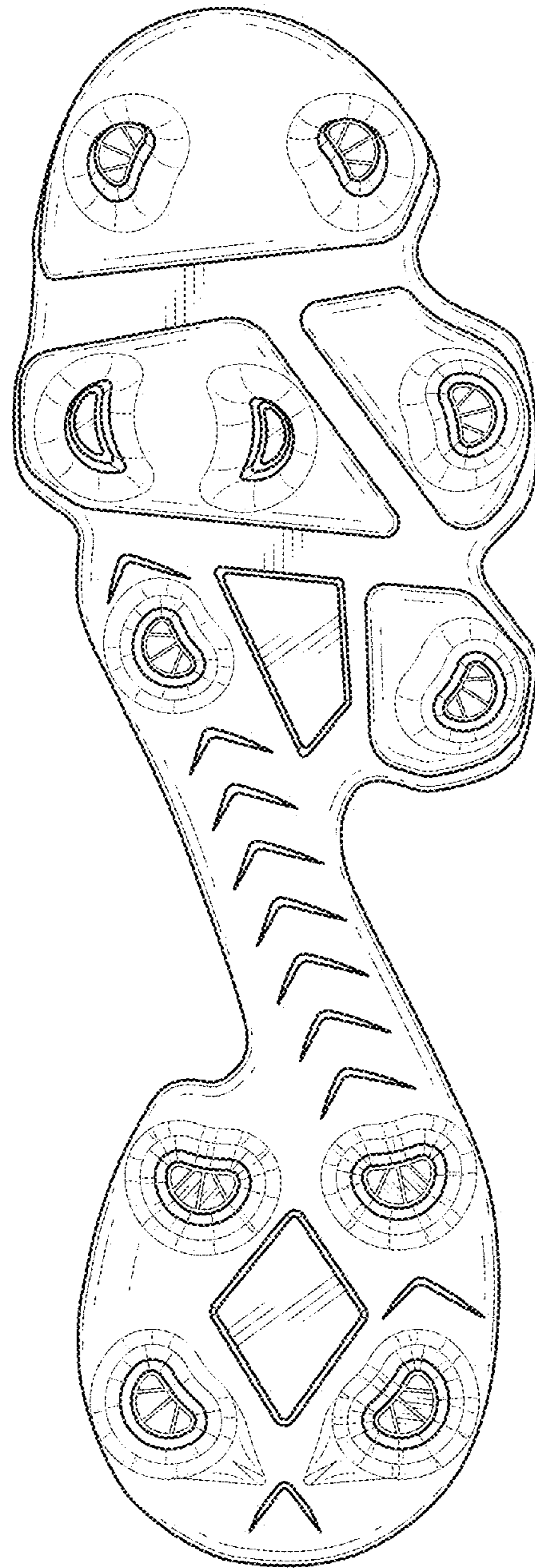

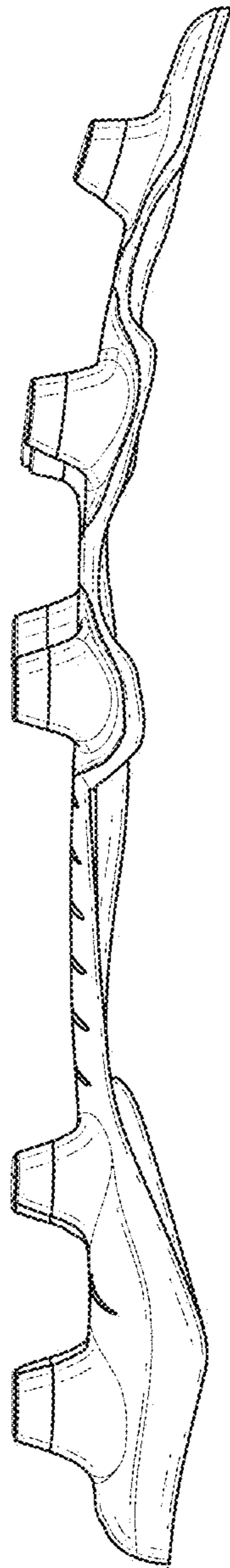

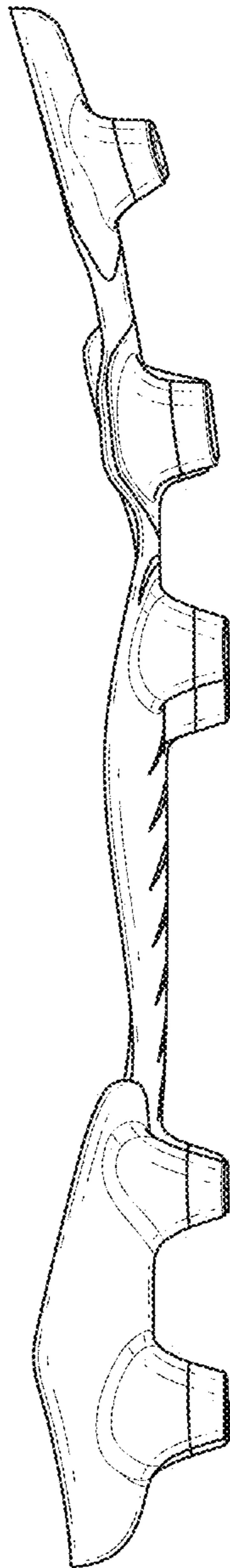

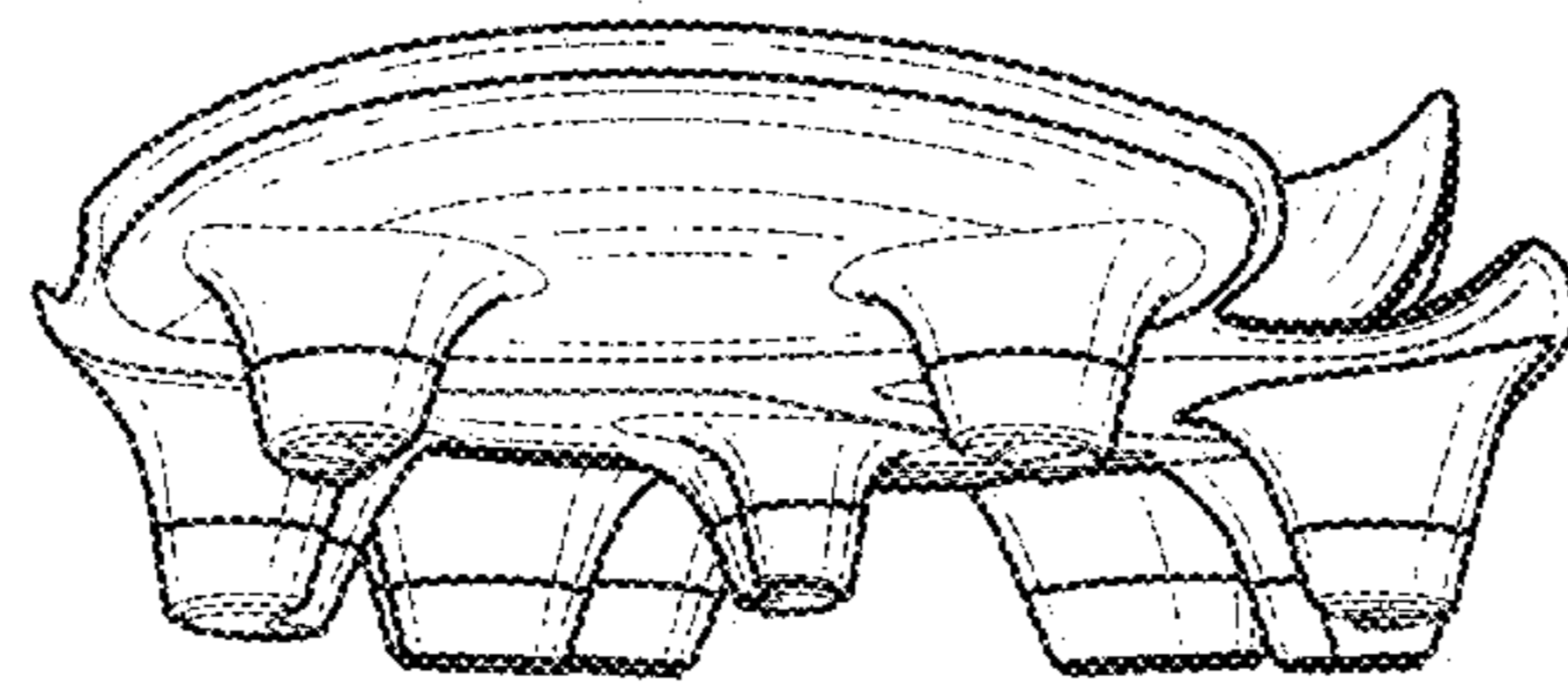

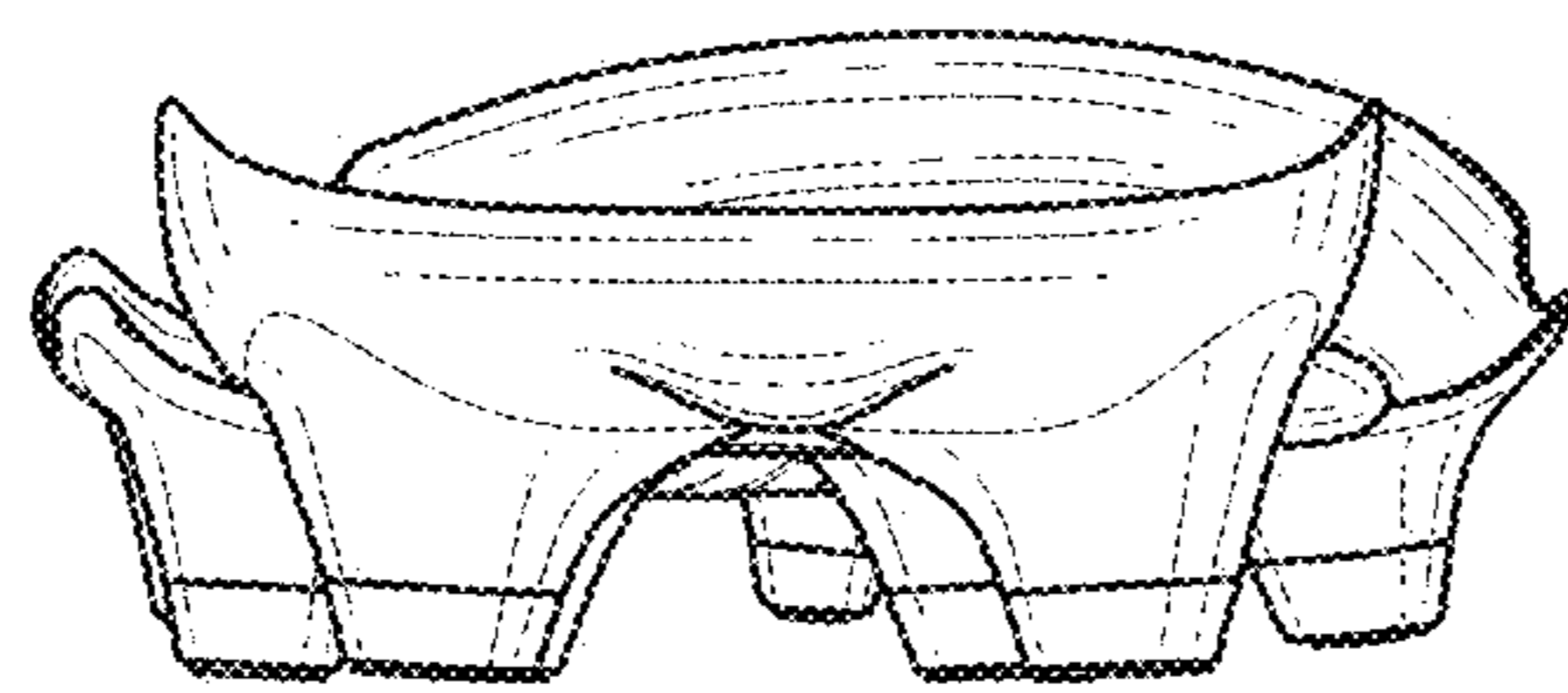
