DESCRIPTION

FIG. 1 is a perspective view of a bottle according to our new design;

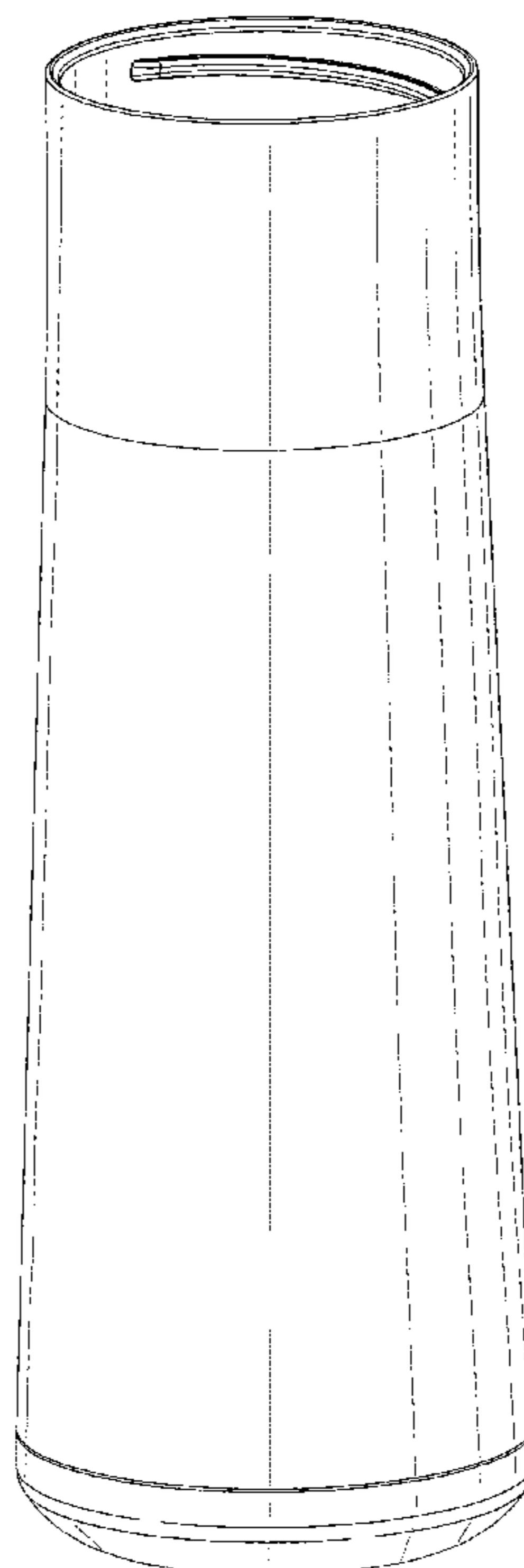

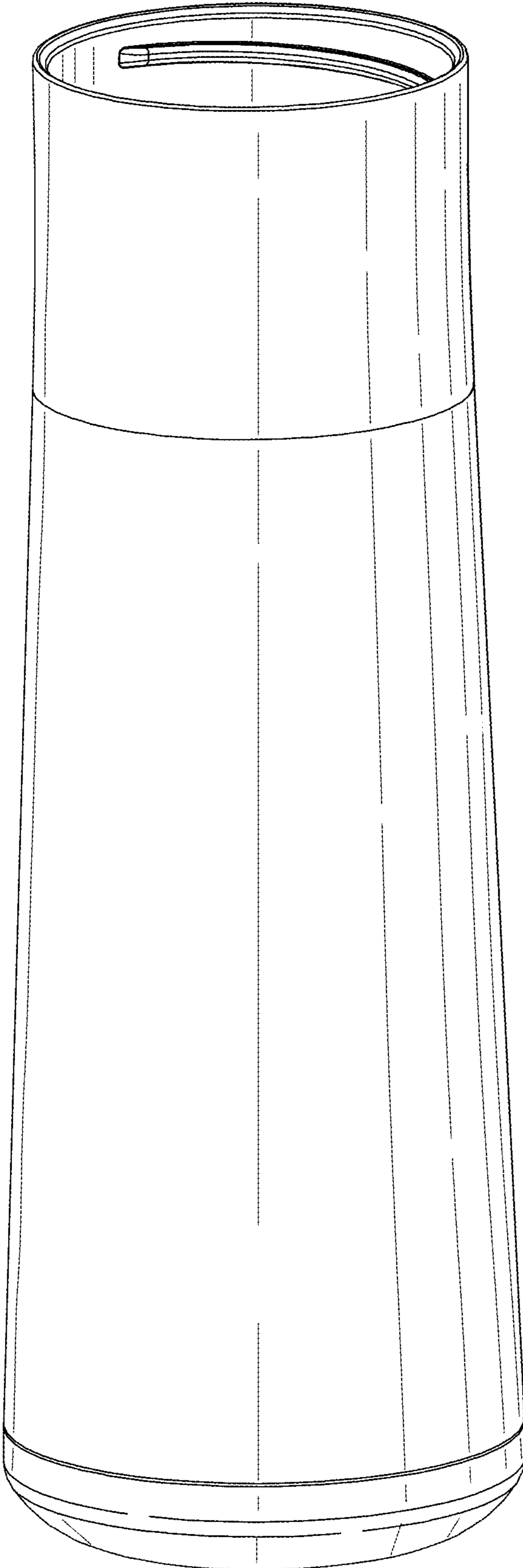

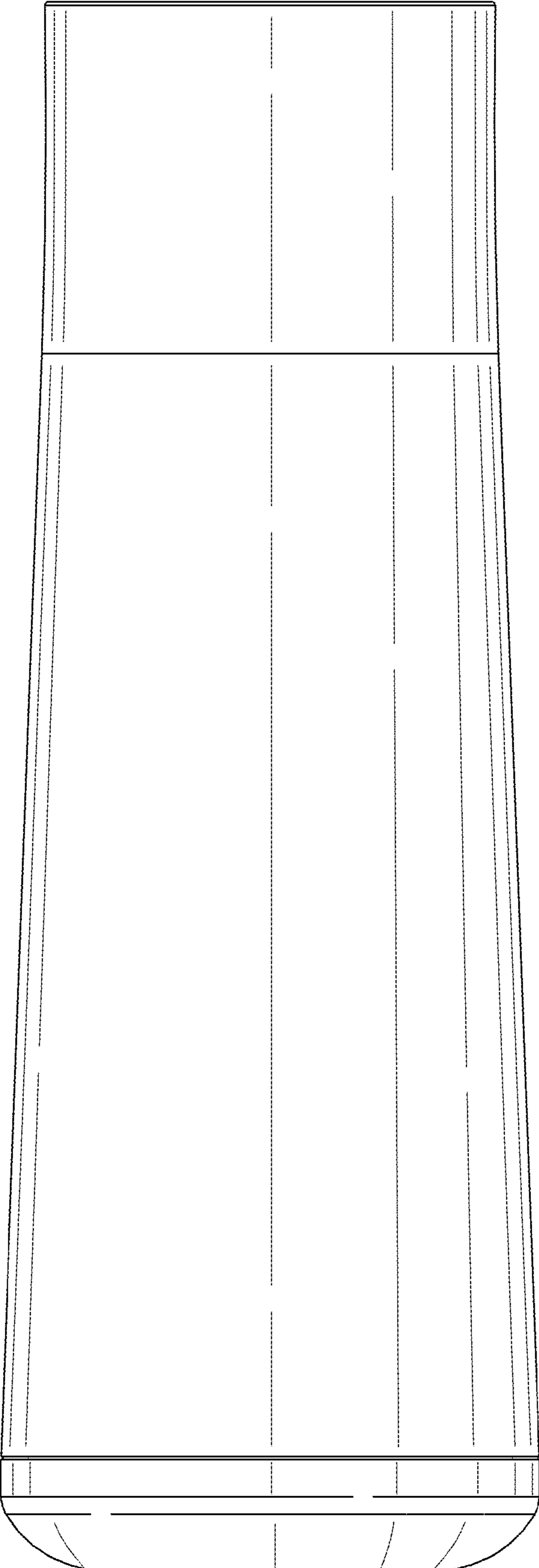

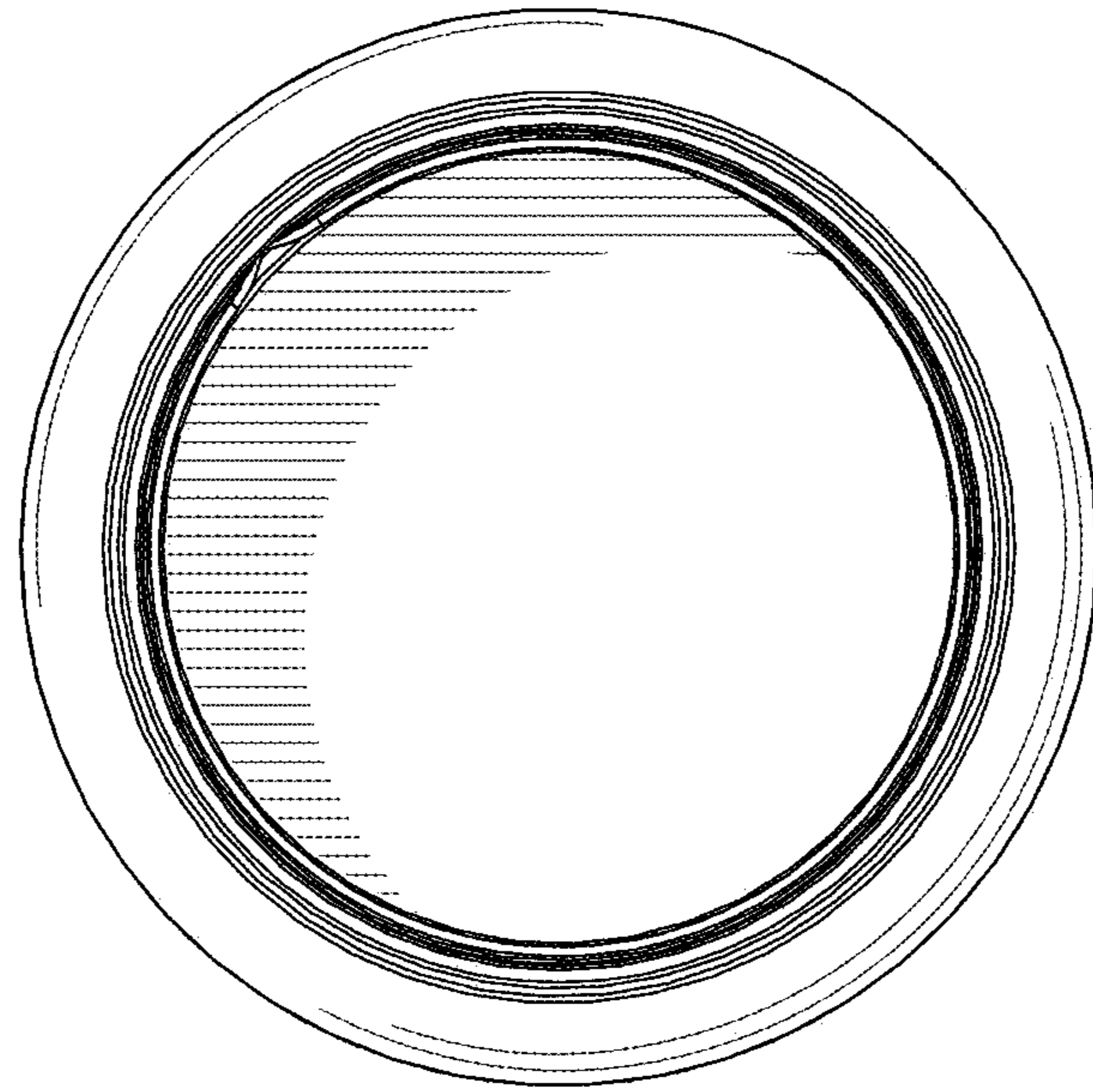

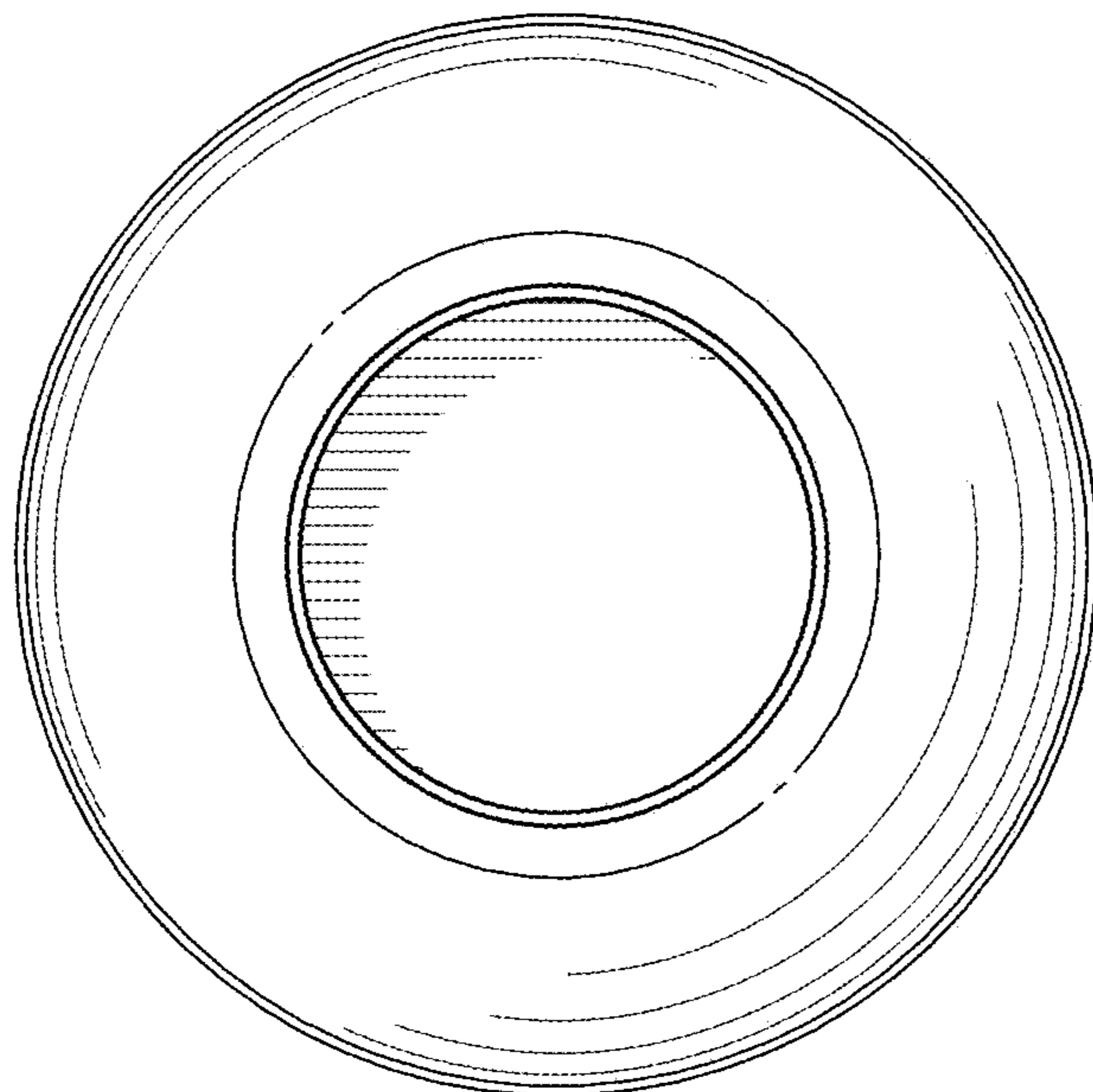

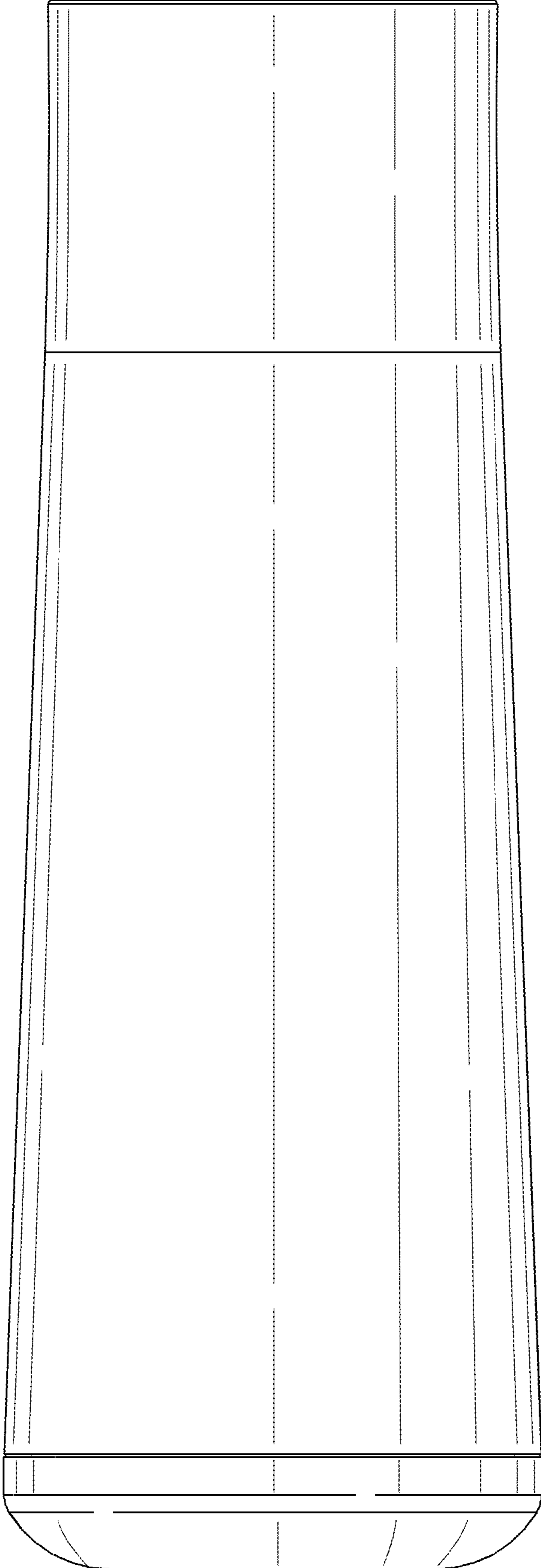

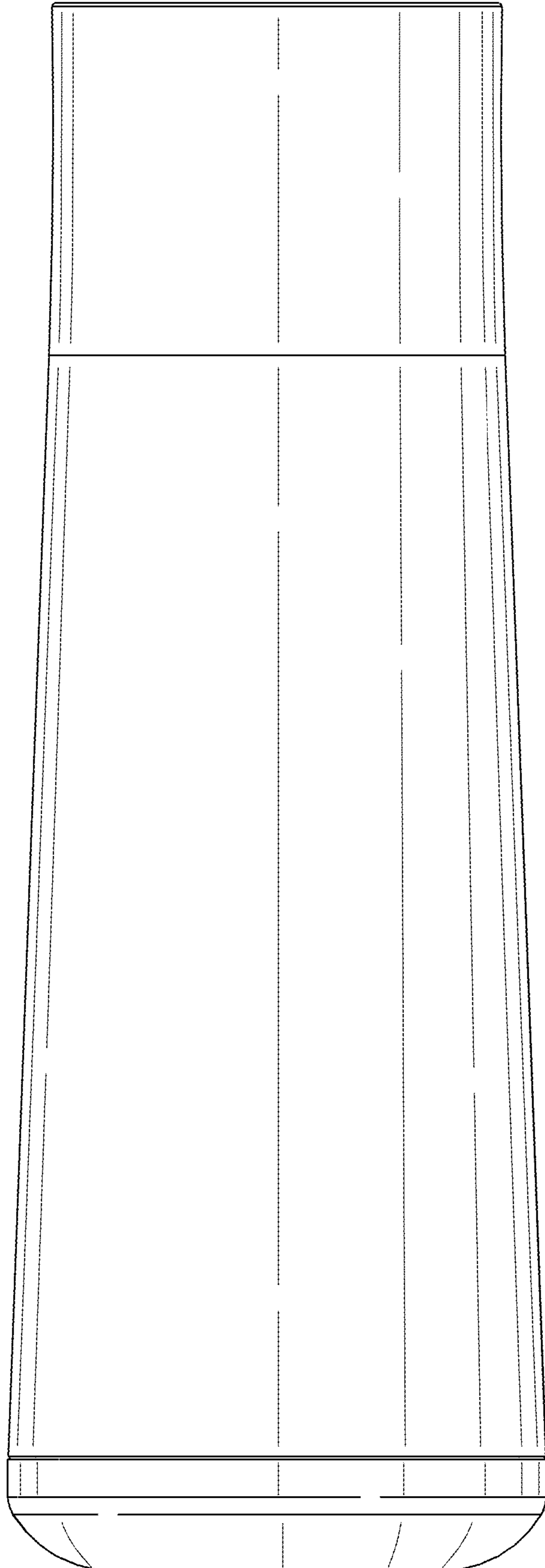
