(57) **CLAIM**

The ornamental design for a vehicle grille portion, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a vehicle grille portion according to the present invention, with the grille portion shown within the broken line. The de-emphasized and halftone structure located outside the broken line forms no part of the claimed design, but is instead included to show environmental aspects thereof.

FIG. 2 is an enlarged front view of the grille portion shown in FIG. 1.

FIG. 3 is a front left perspective of the vehicle grille portion shown in FIG. 1. The de-emphasized and halftone structure located outside the broken line forms no part of the claimed design, but is instead included to show environmental aspects thereof.

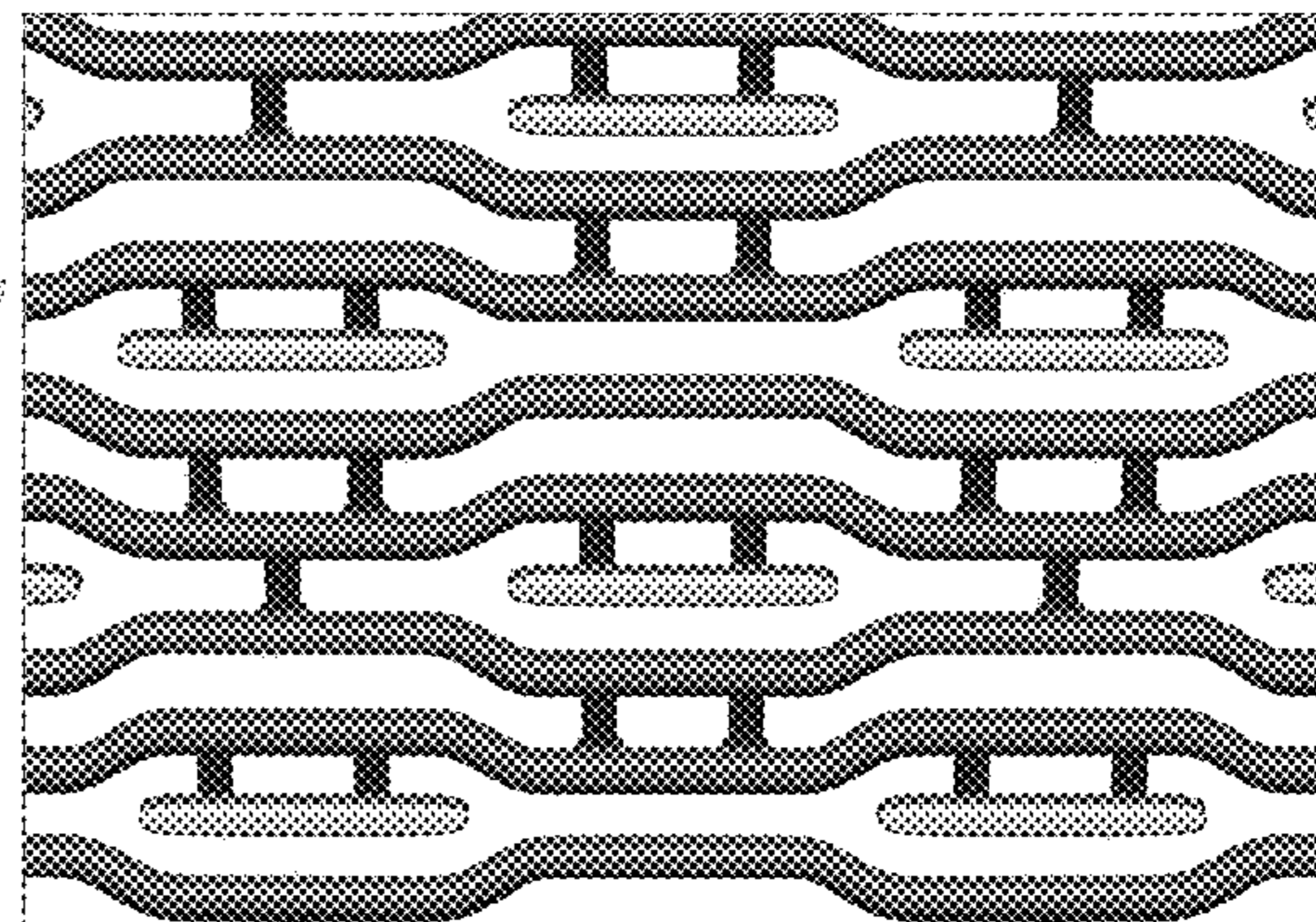
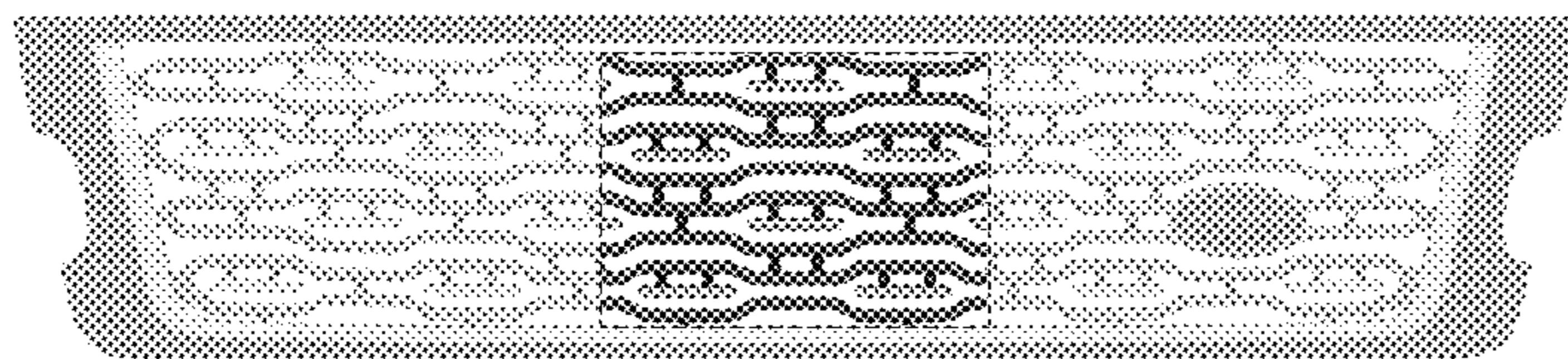
FIG. 4 is an enlarged front left perspective view of the grille shown in FIG. 3, with the portion translated slightly from the location of the portion as shown in FIG. 3.

FIG. 5 is an enlarged front view of a vehicle grille portion according to an alternative embodiment of the invention; and,

FIG. 6 is a front left perspective view of the grille portion shown in FIG. 5.

In FIGS. 1-6, any elements shown outside the broken line form no part of the claimed design, but are instead included to show environmental aspects thereof. The broken line forms an unclaimed boundary of the design.

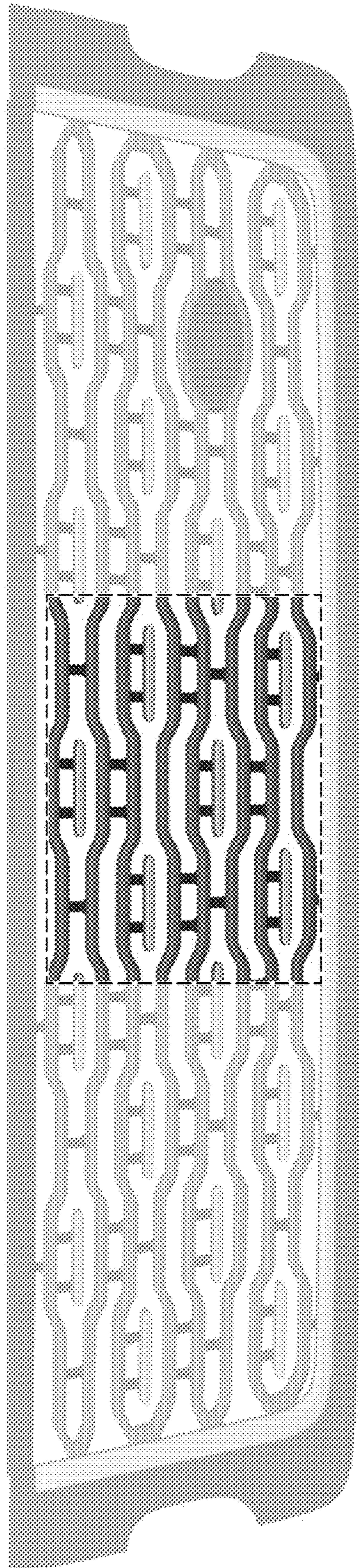

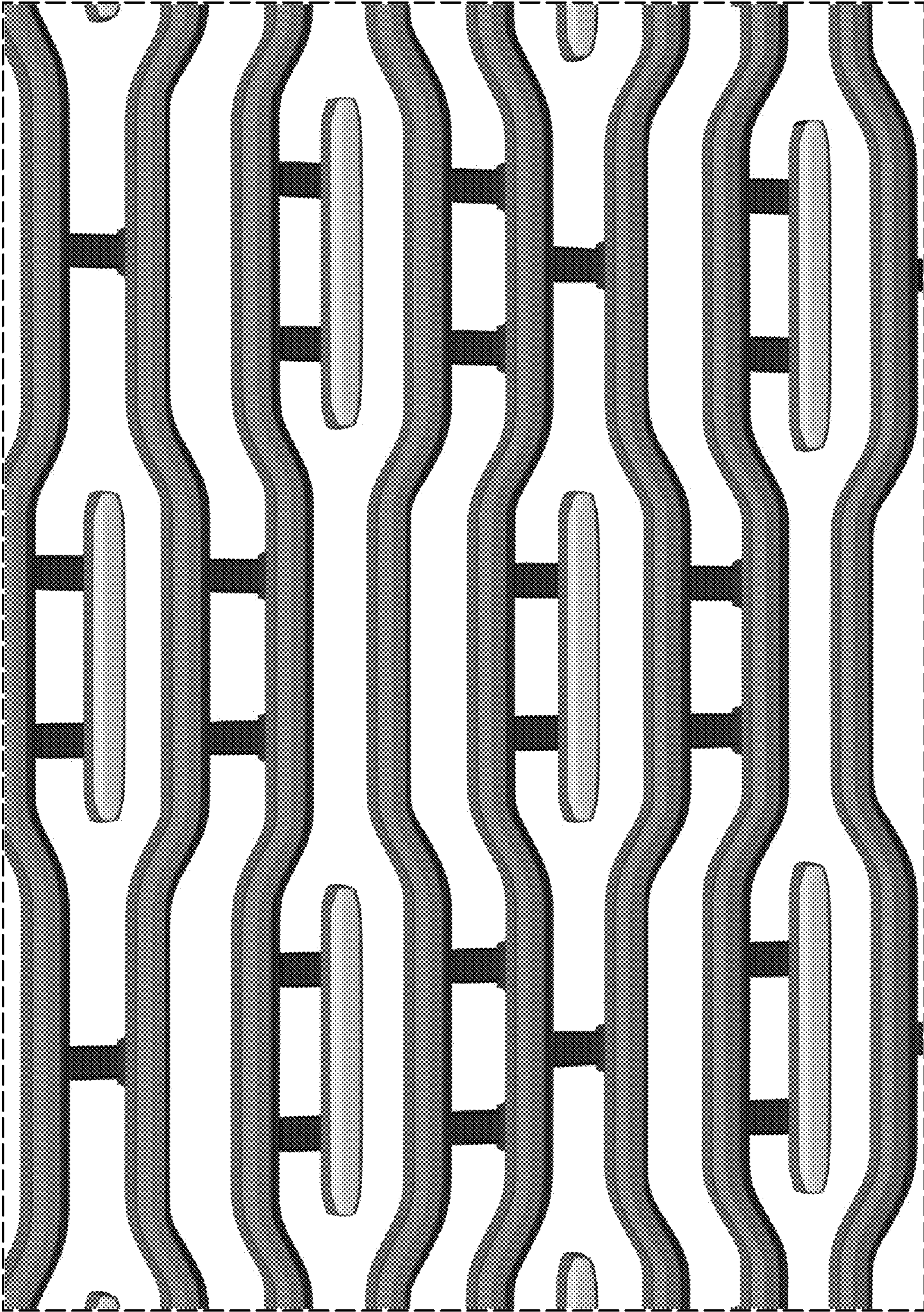

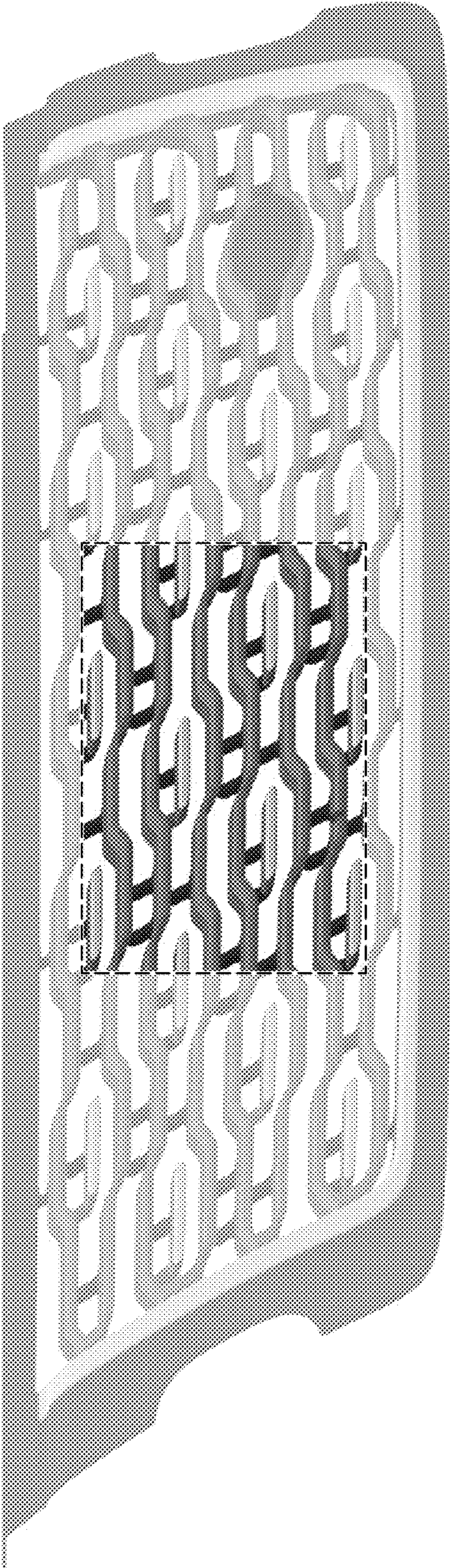

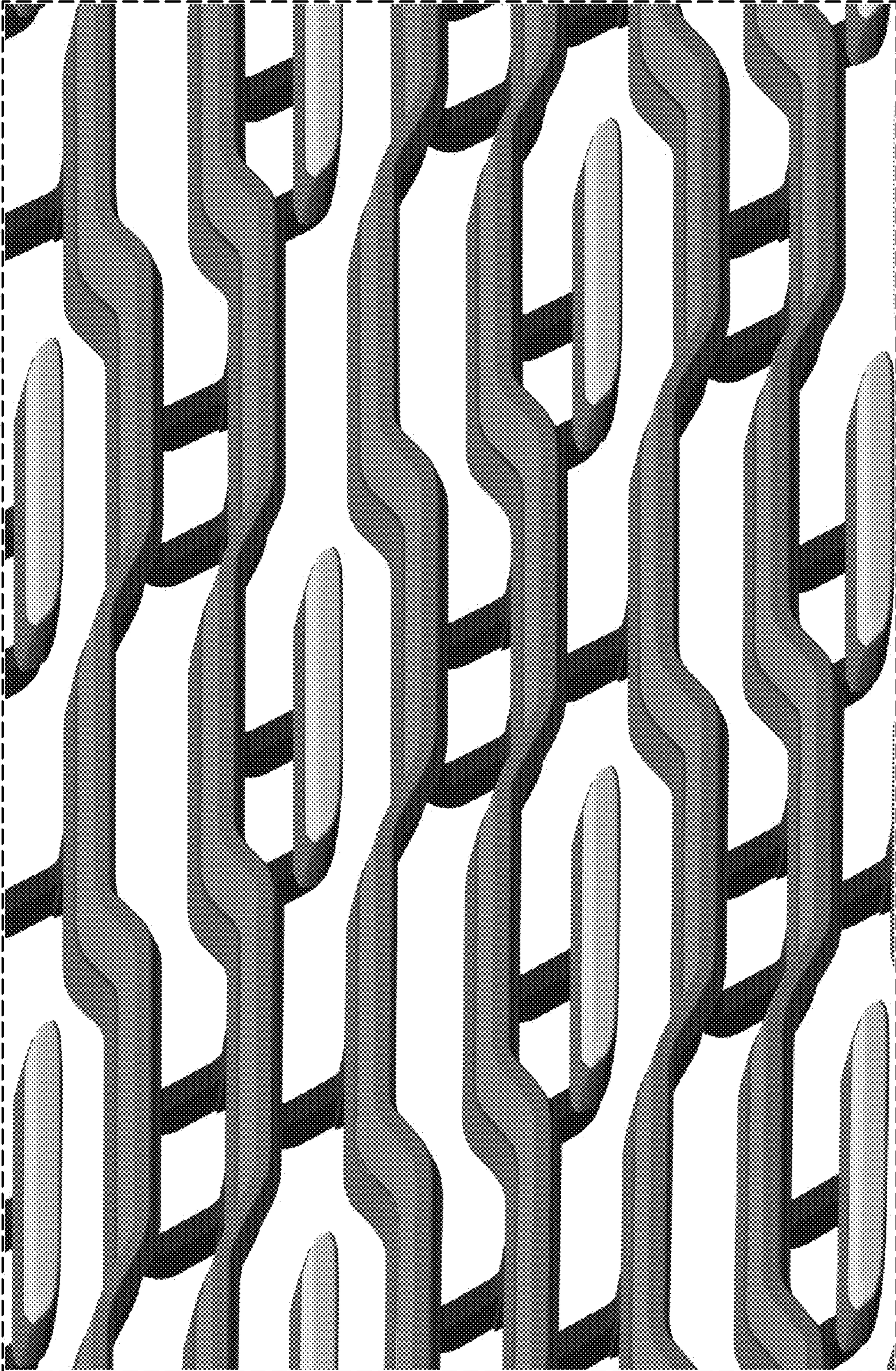

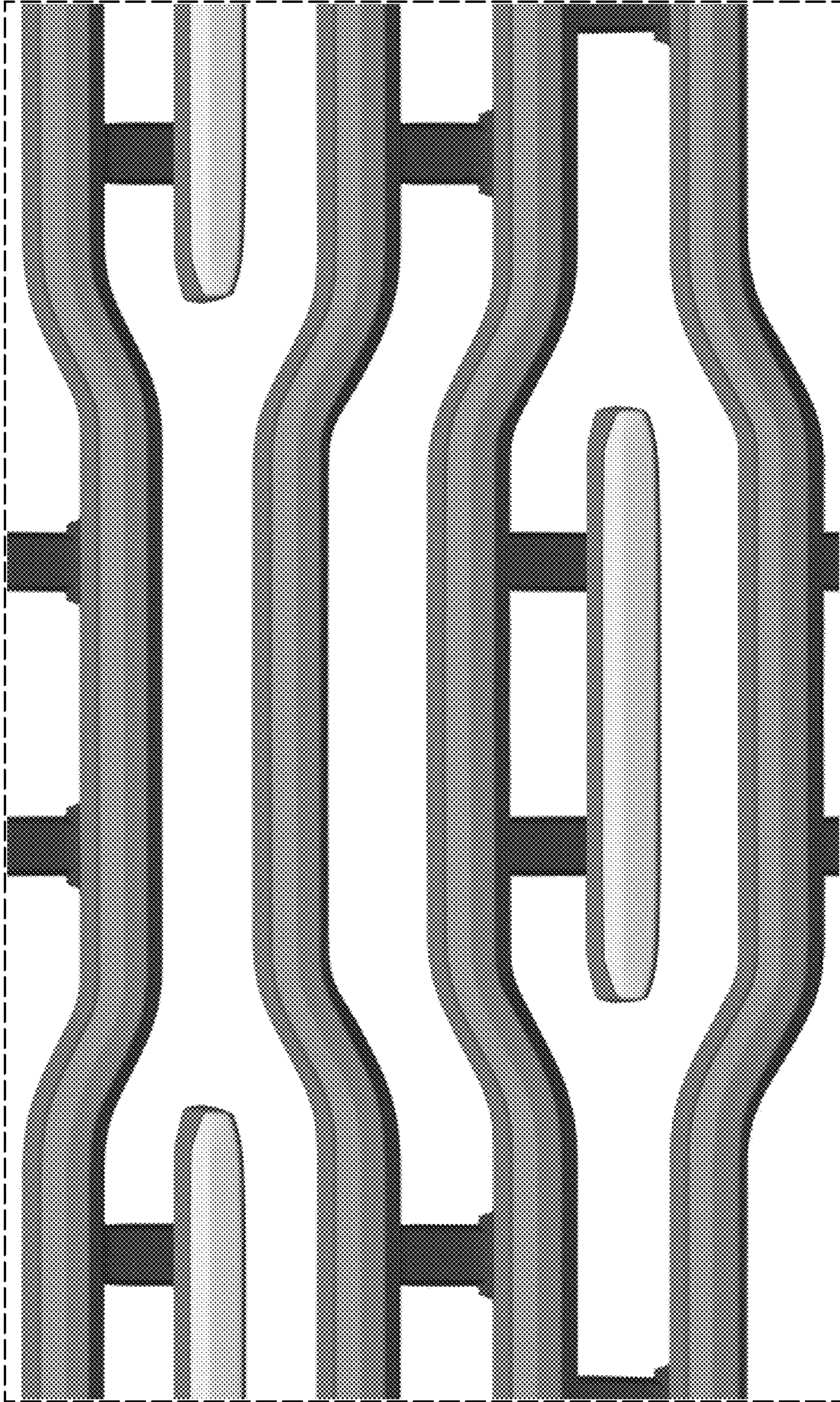

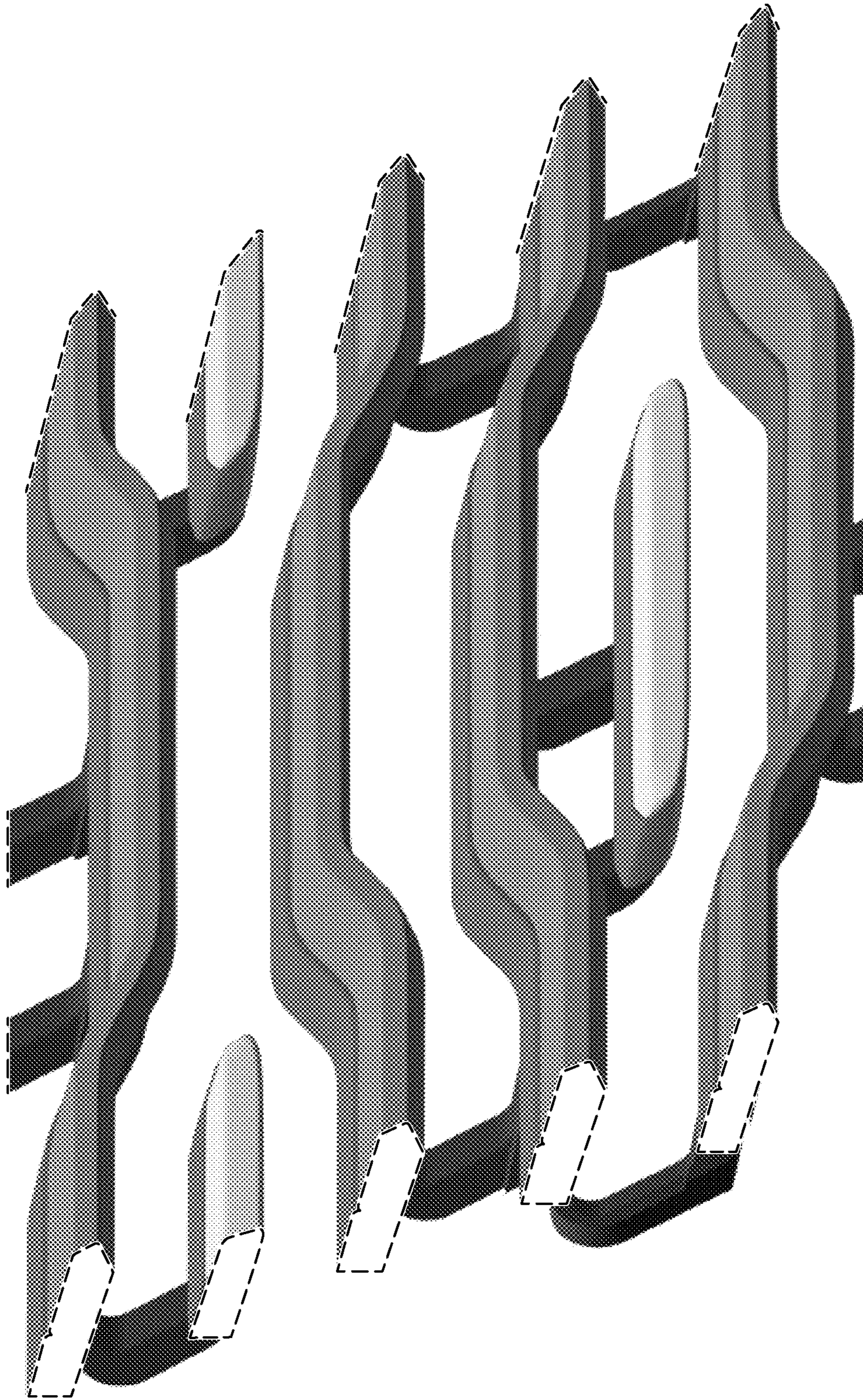
