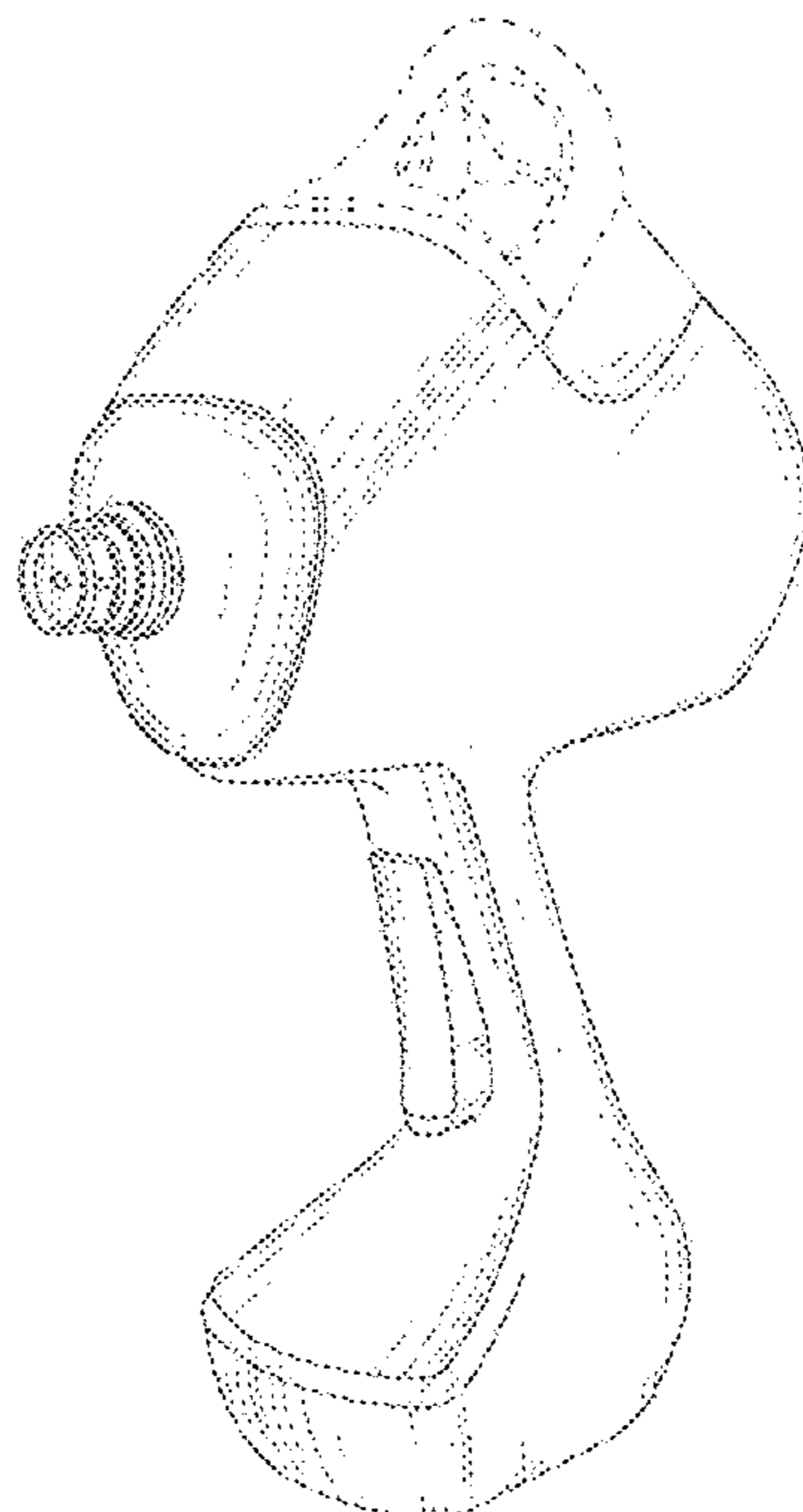

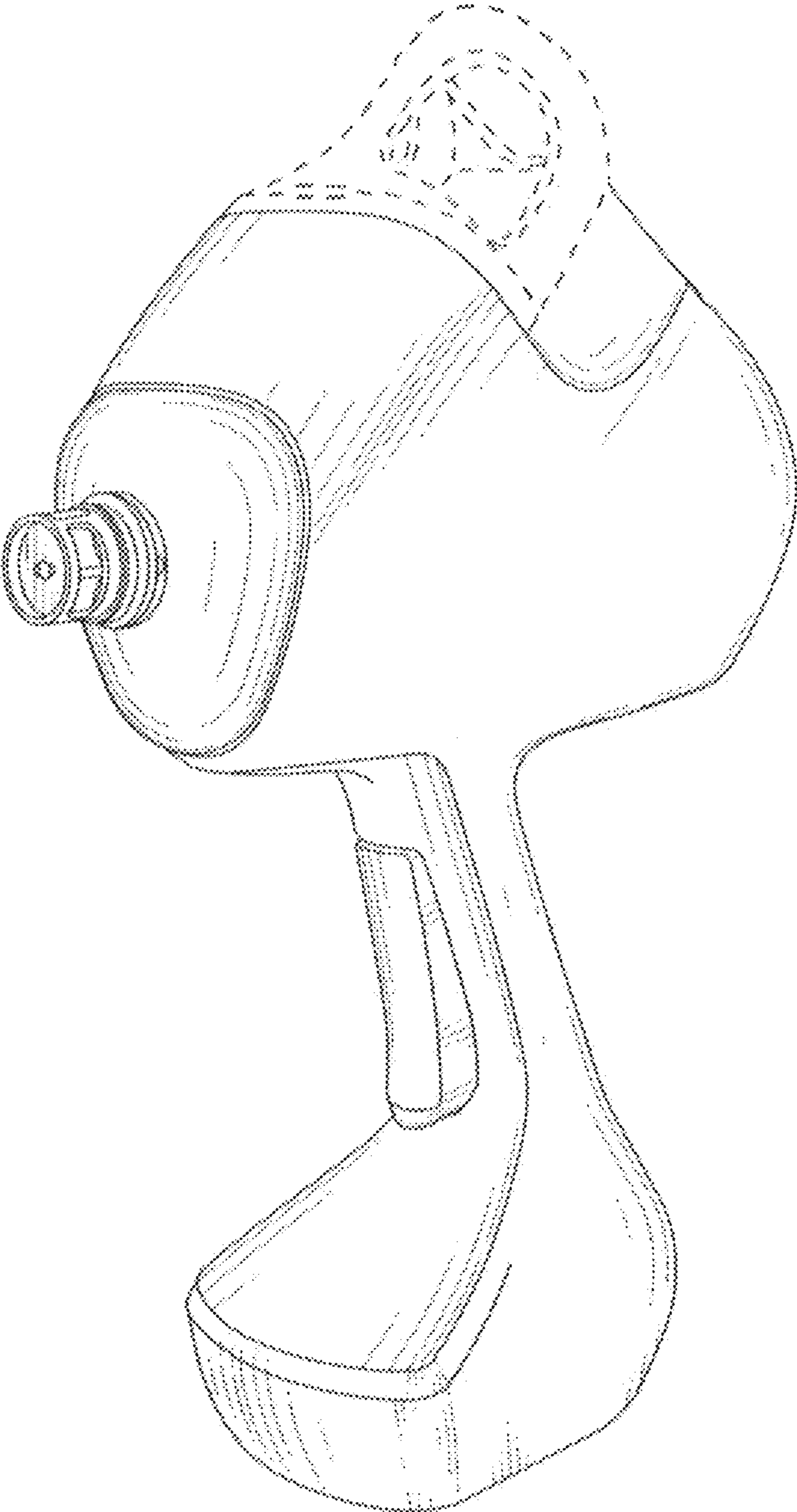
We claim the ornamental design for injector, as shown and described.

**DESCRIPTION**

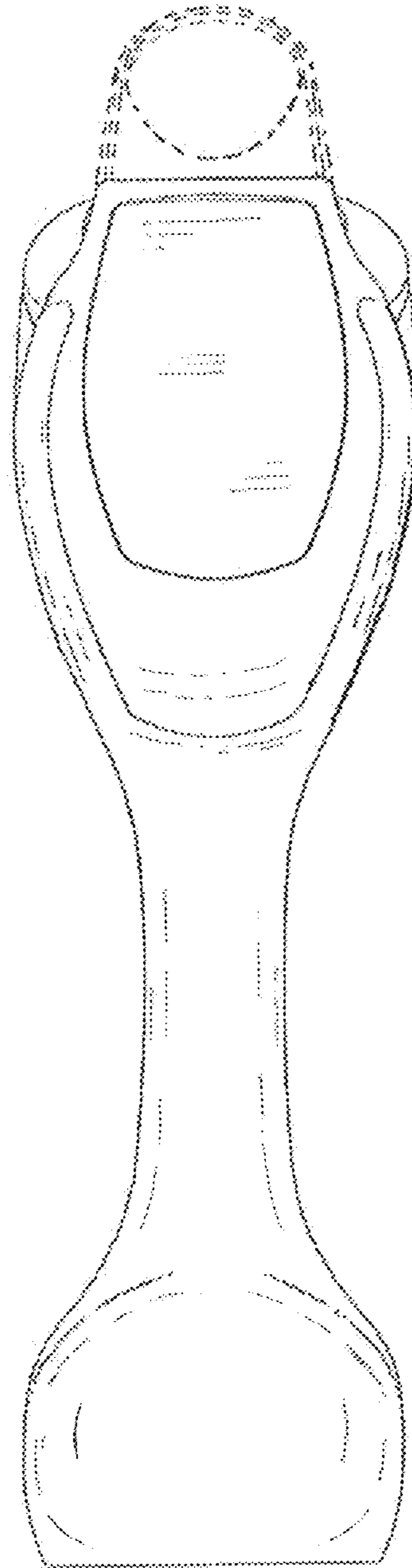
FIG. 1 is a front top perspective view of an injector according to the disclosure;

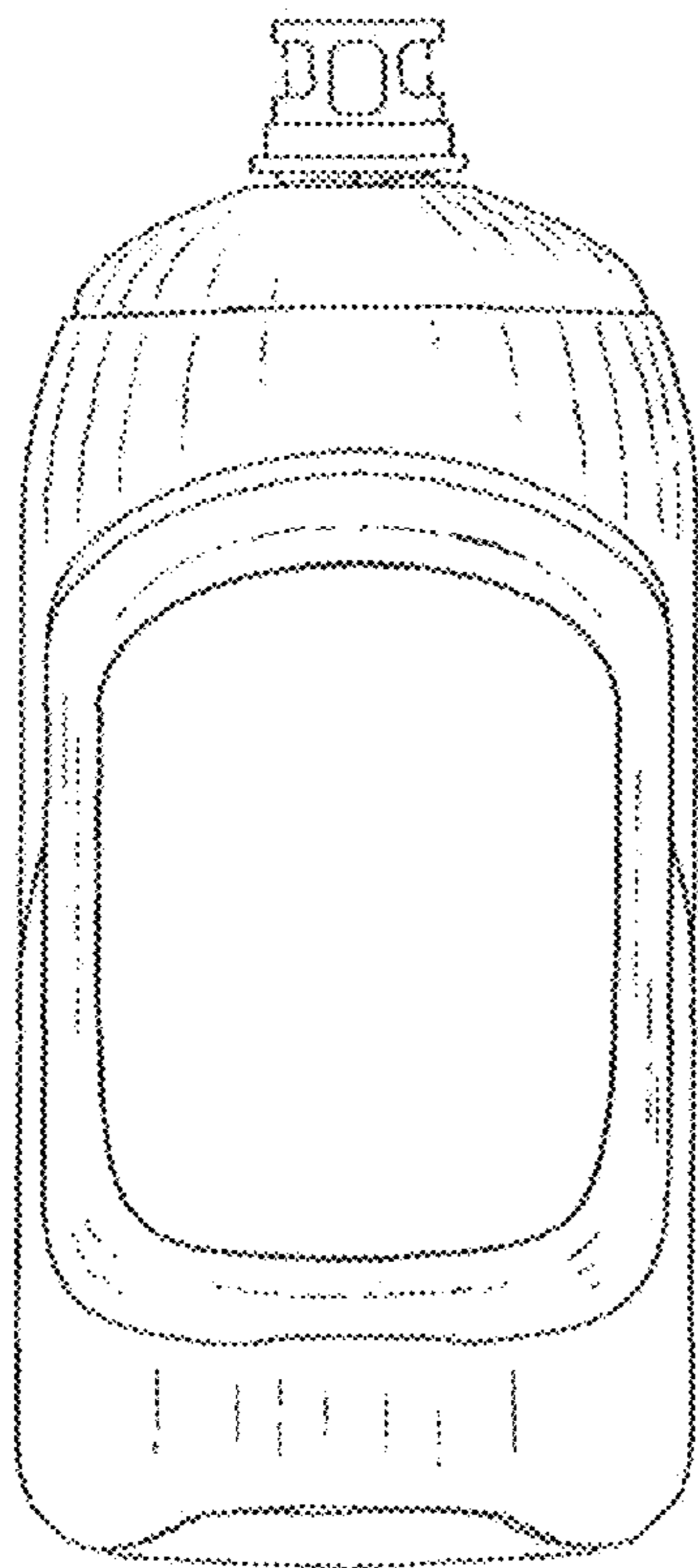




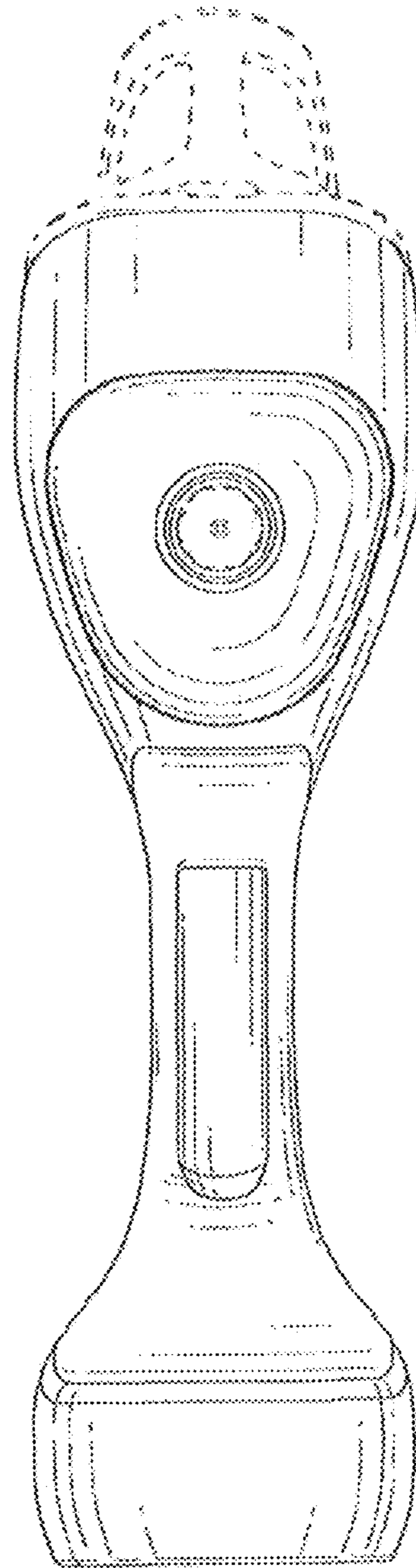

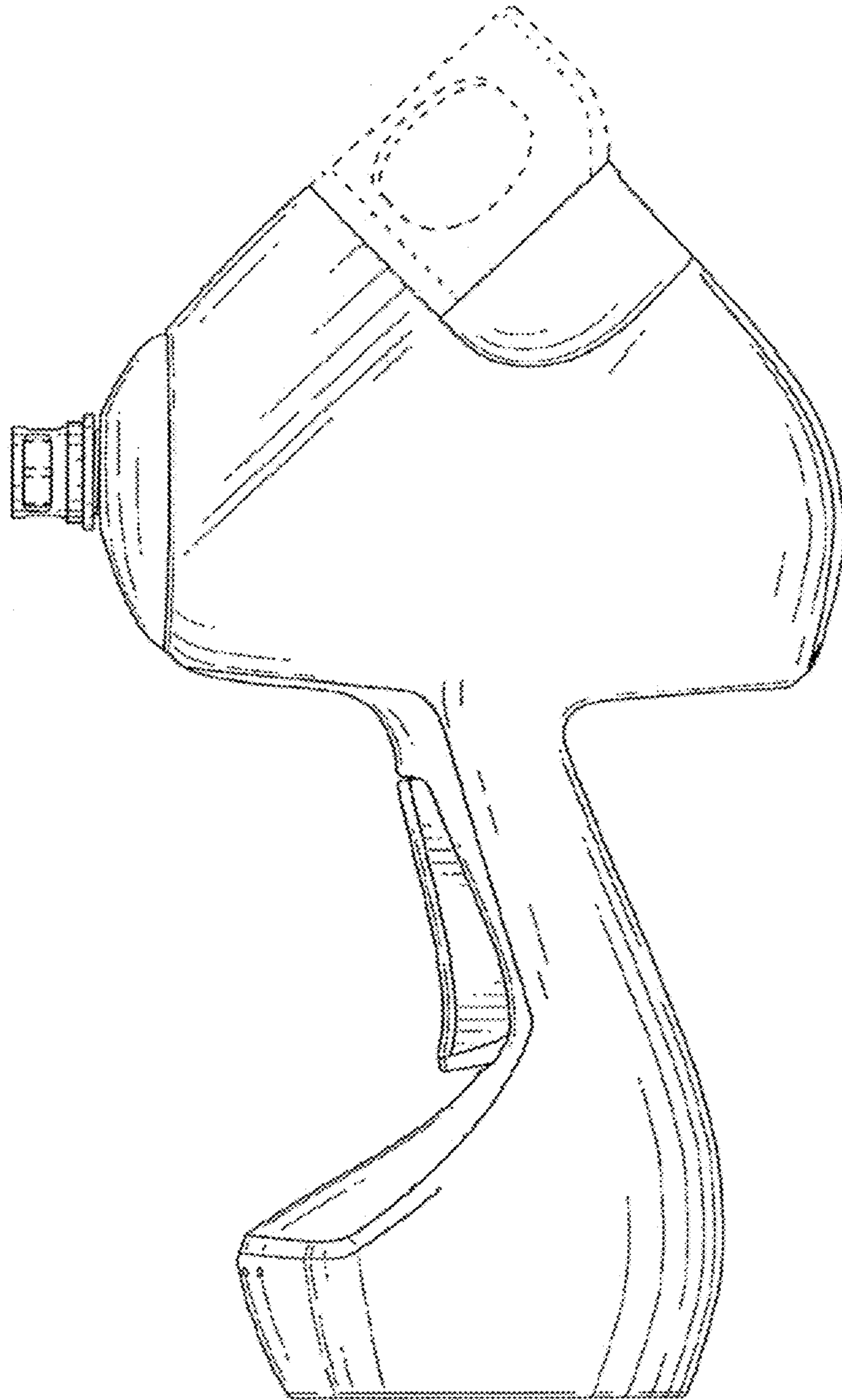

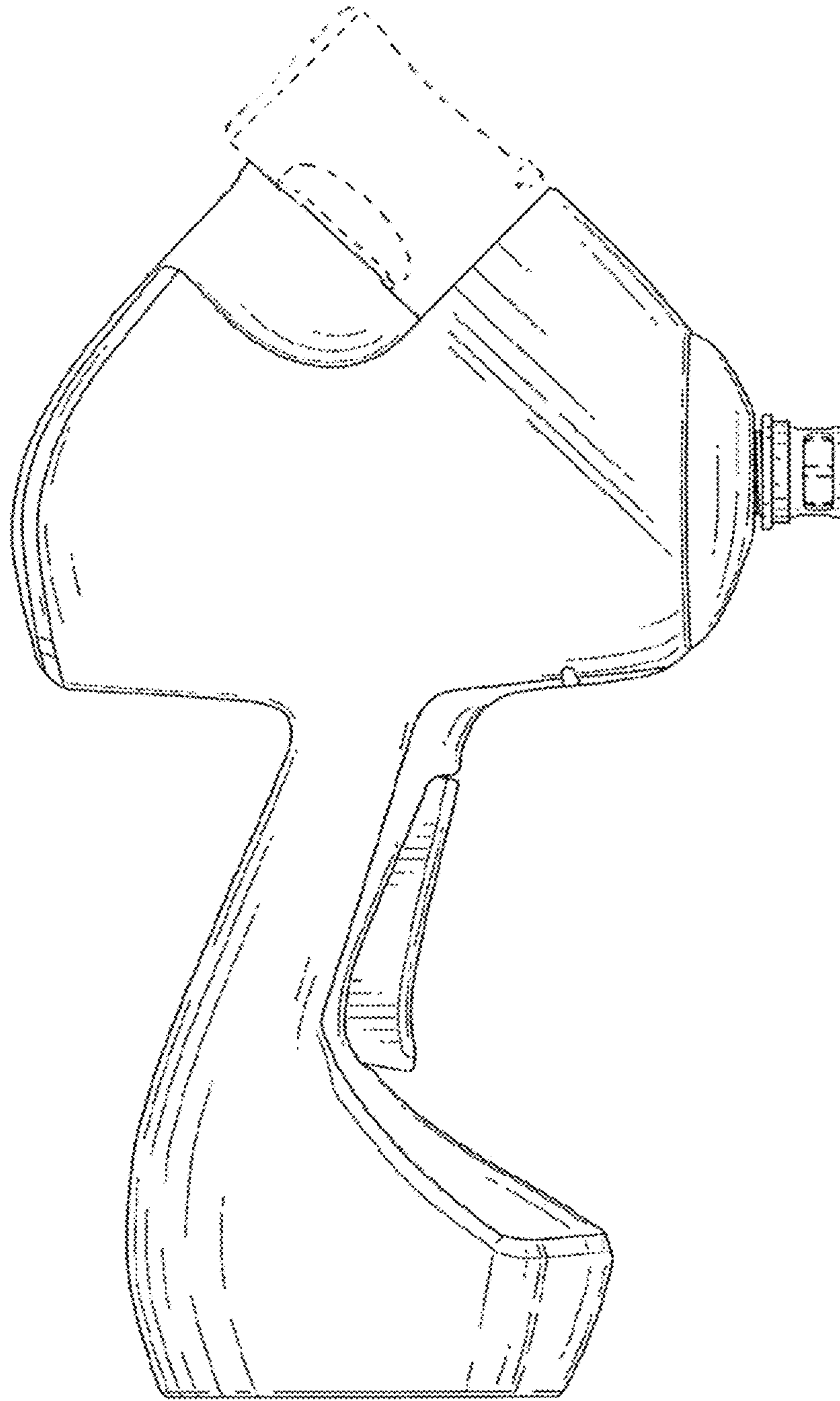

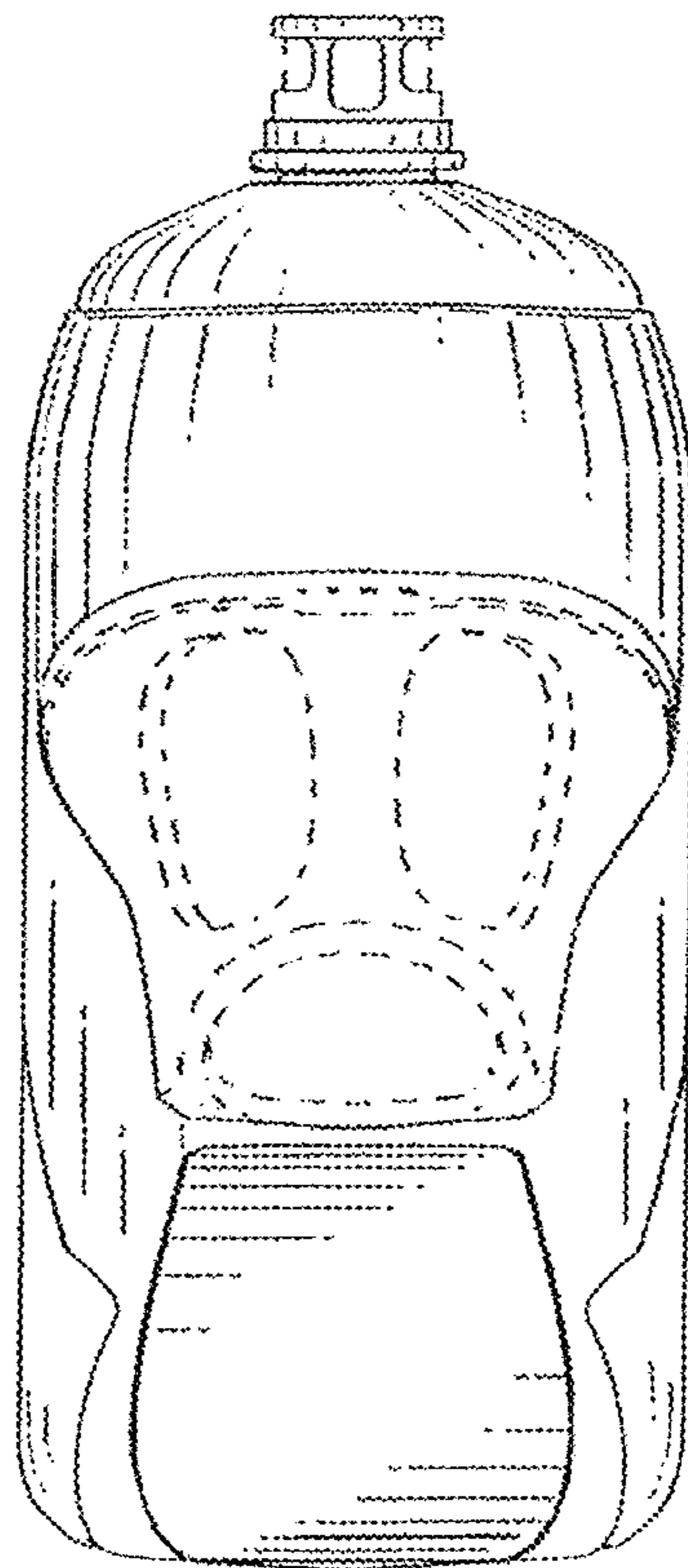
