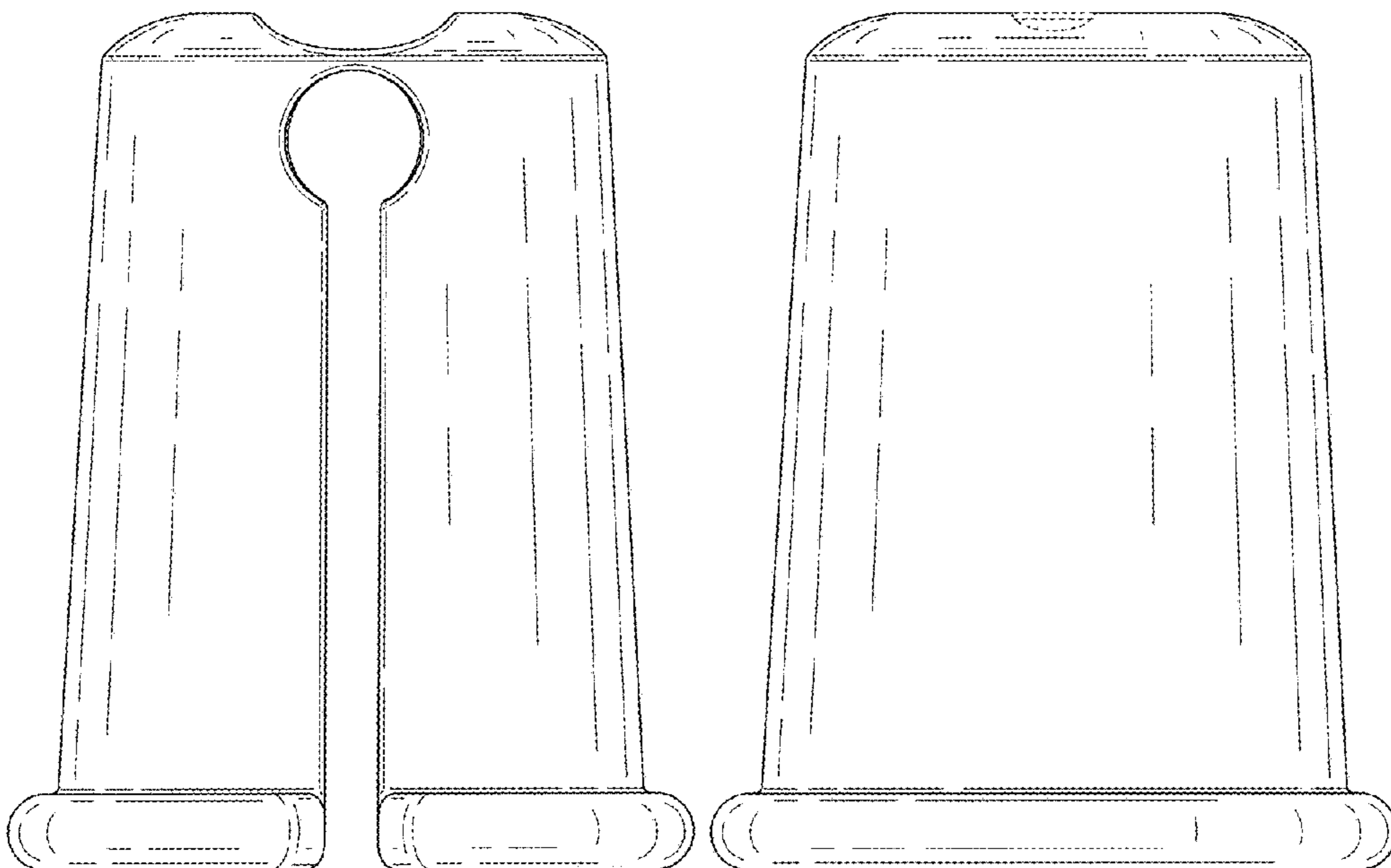
(57) **CLAIM**

The ornamental design for an eye surgical device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the eye surgical device; FIG. 2 is a right side elevational view of the eye surgical device; FIG. 3 is a left side elevational view of the eye surgical device; FIG. 4 is a front elevational view of the eye surgical device; FIG. 5 is a back elevational view of the eye surgical device; FIG. 6 is a top plan view of the eye surgical device; and, FIG. 7 is a bottom plan view of the eye surgical device. The broken line shows a tool receiving recess and forms no part of the claimed design.

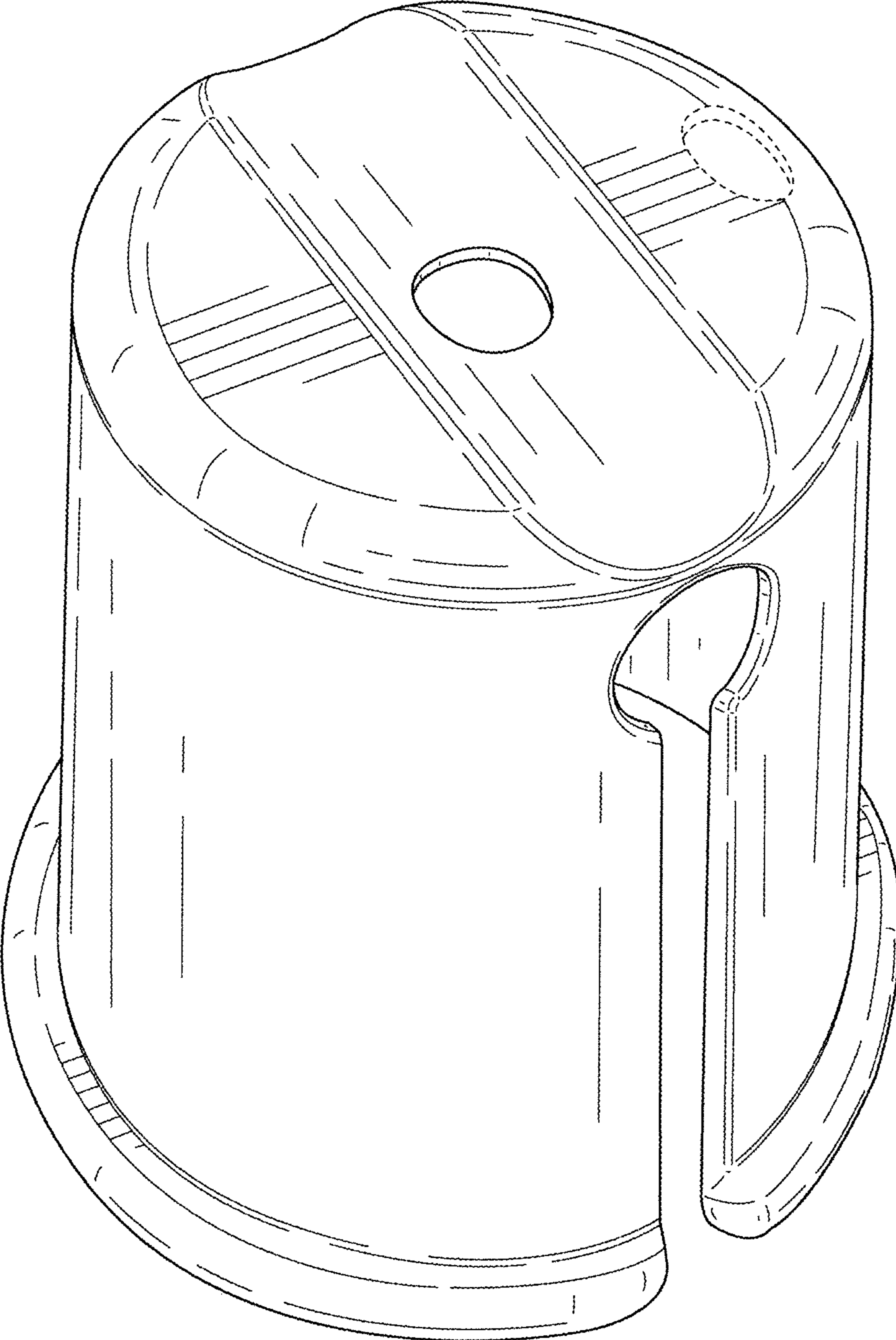

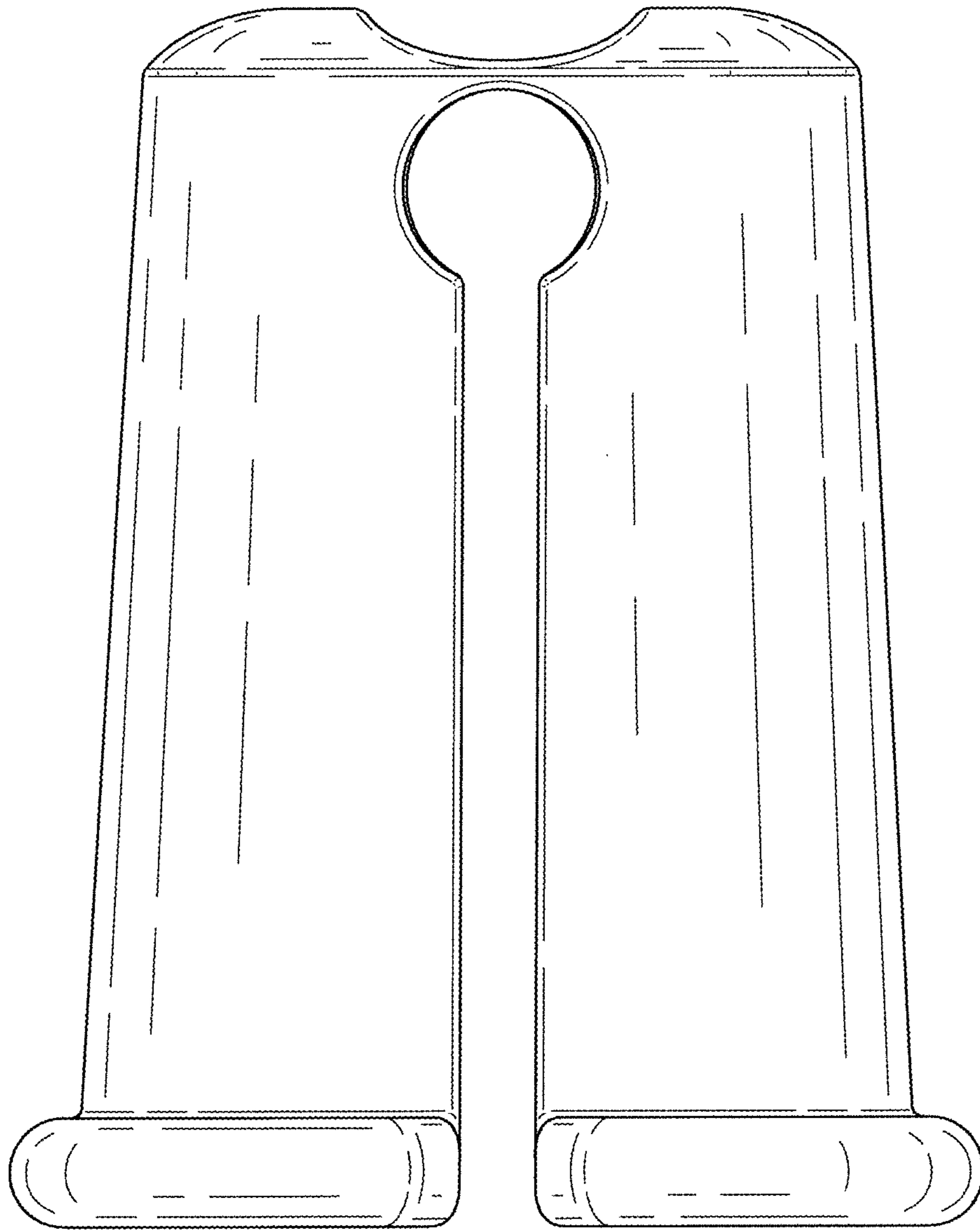

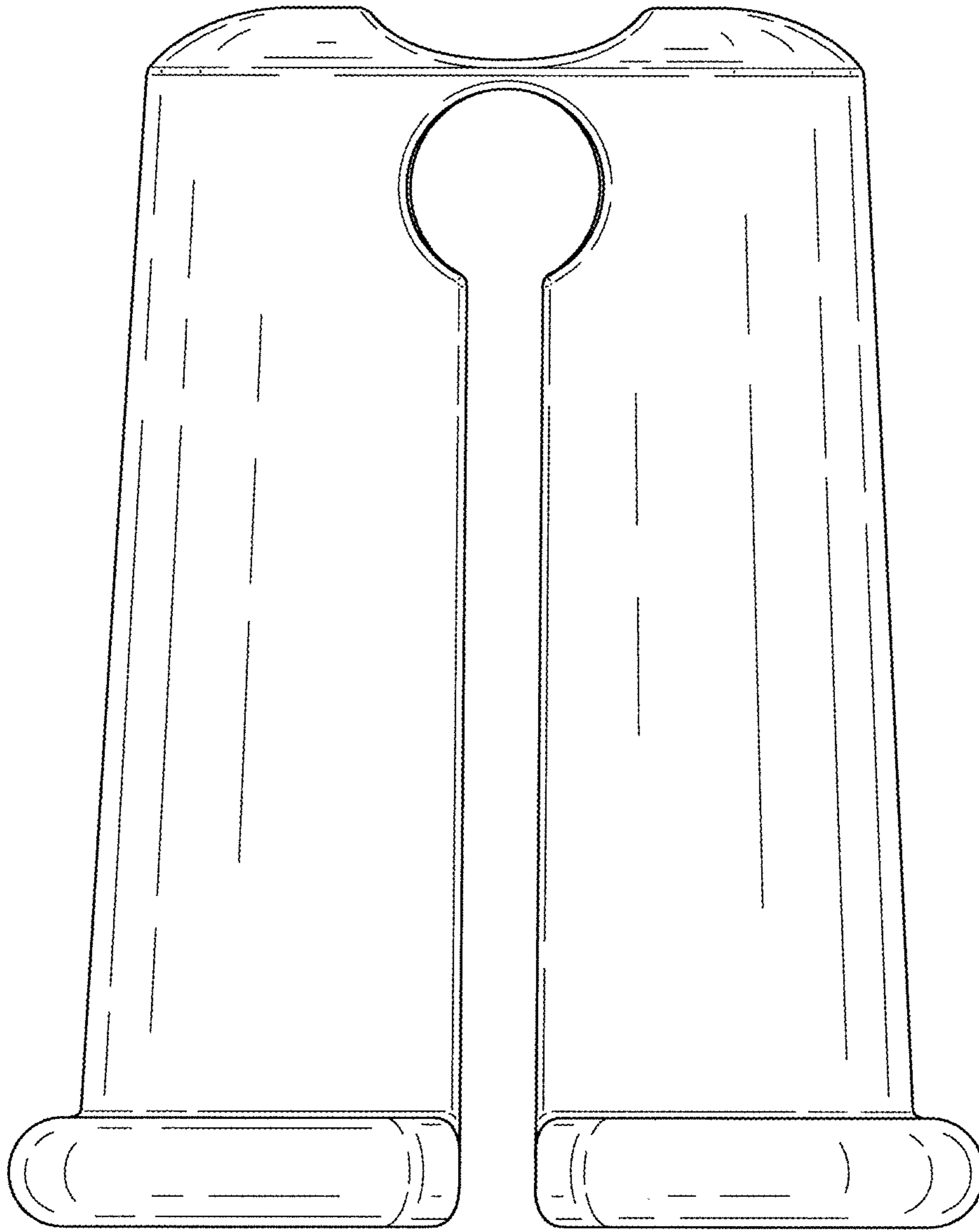

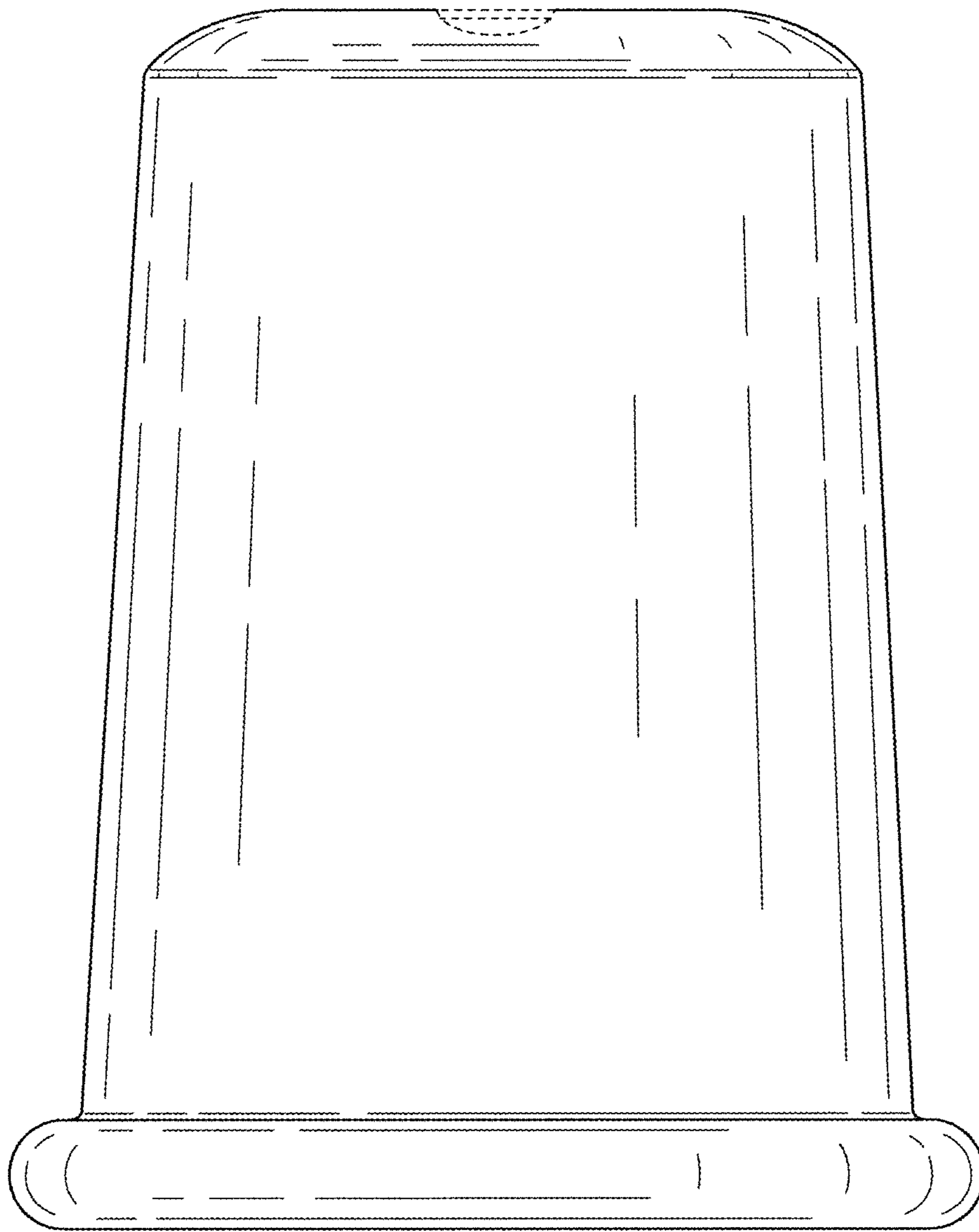

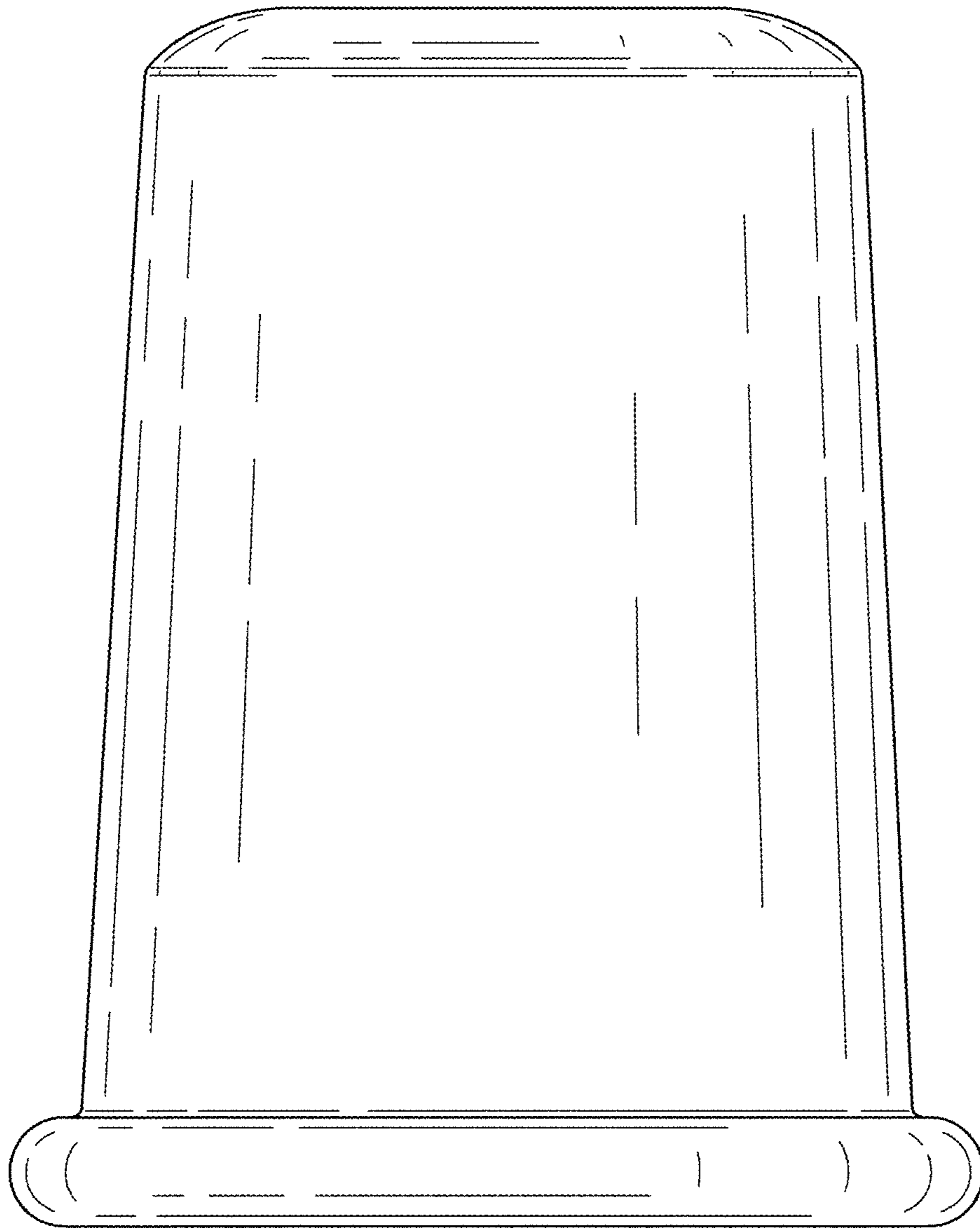

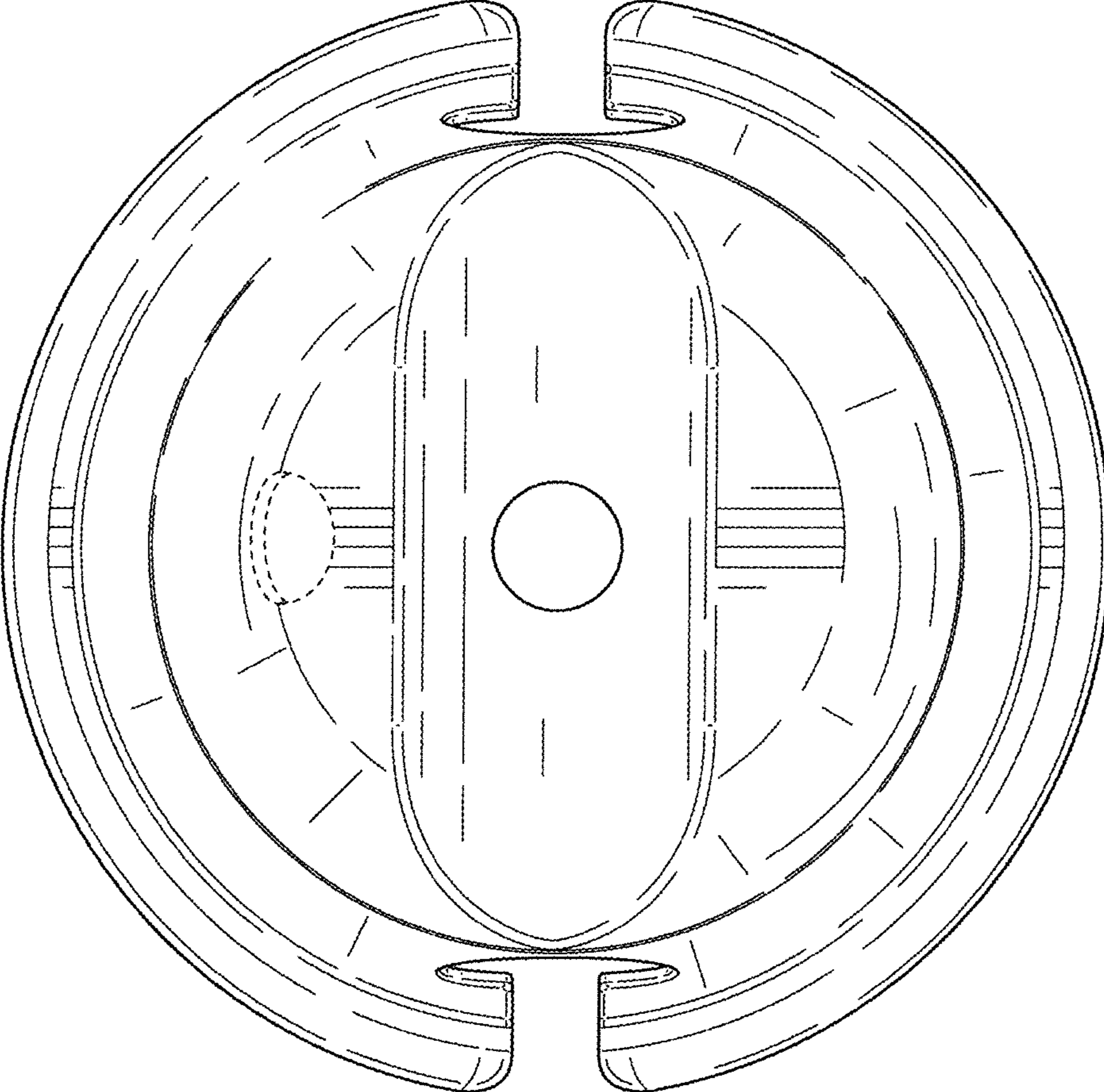

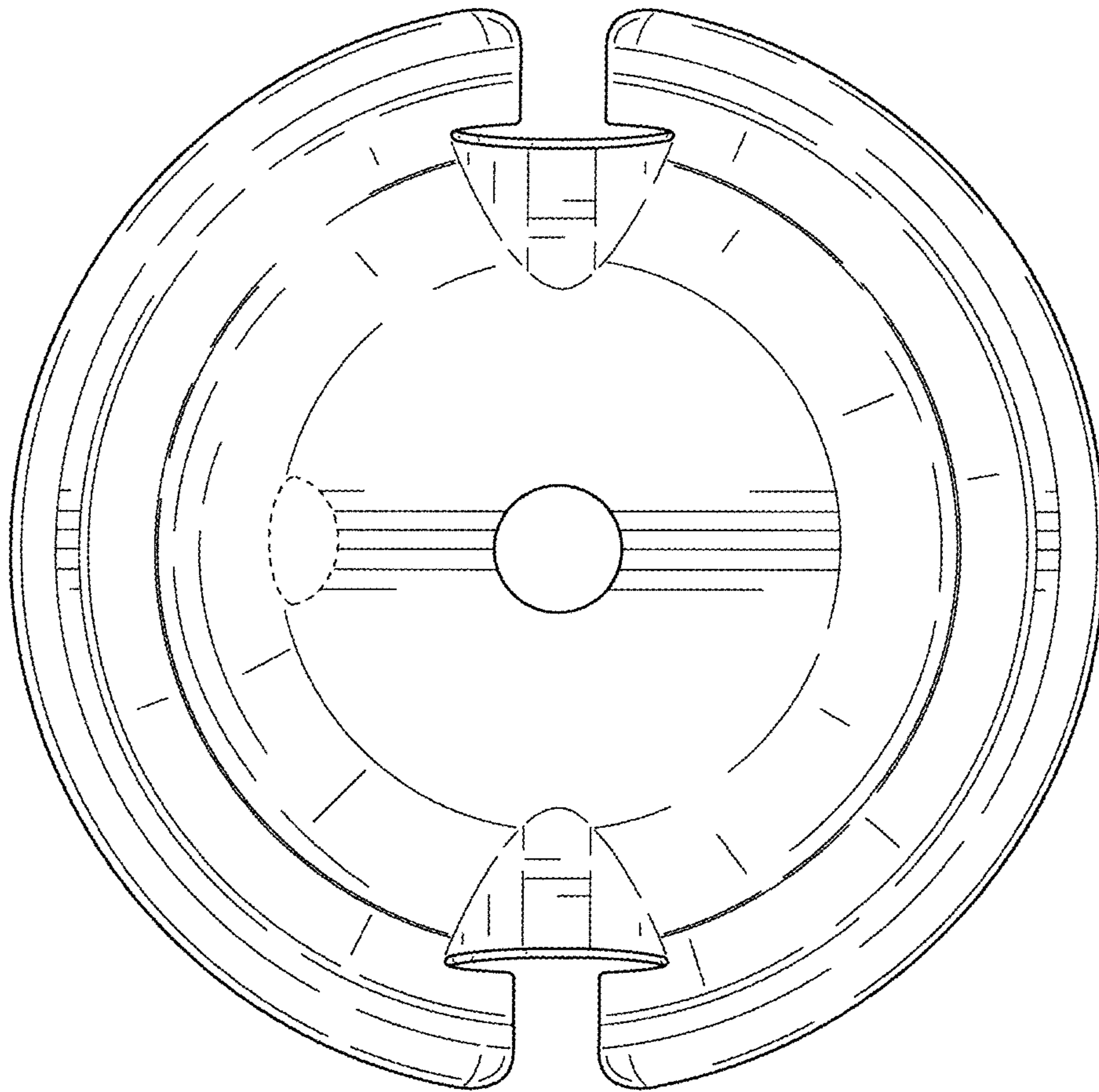
