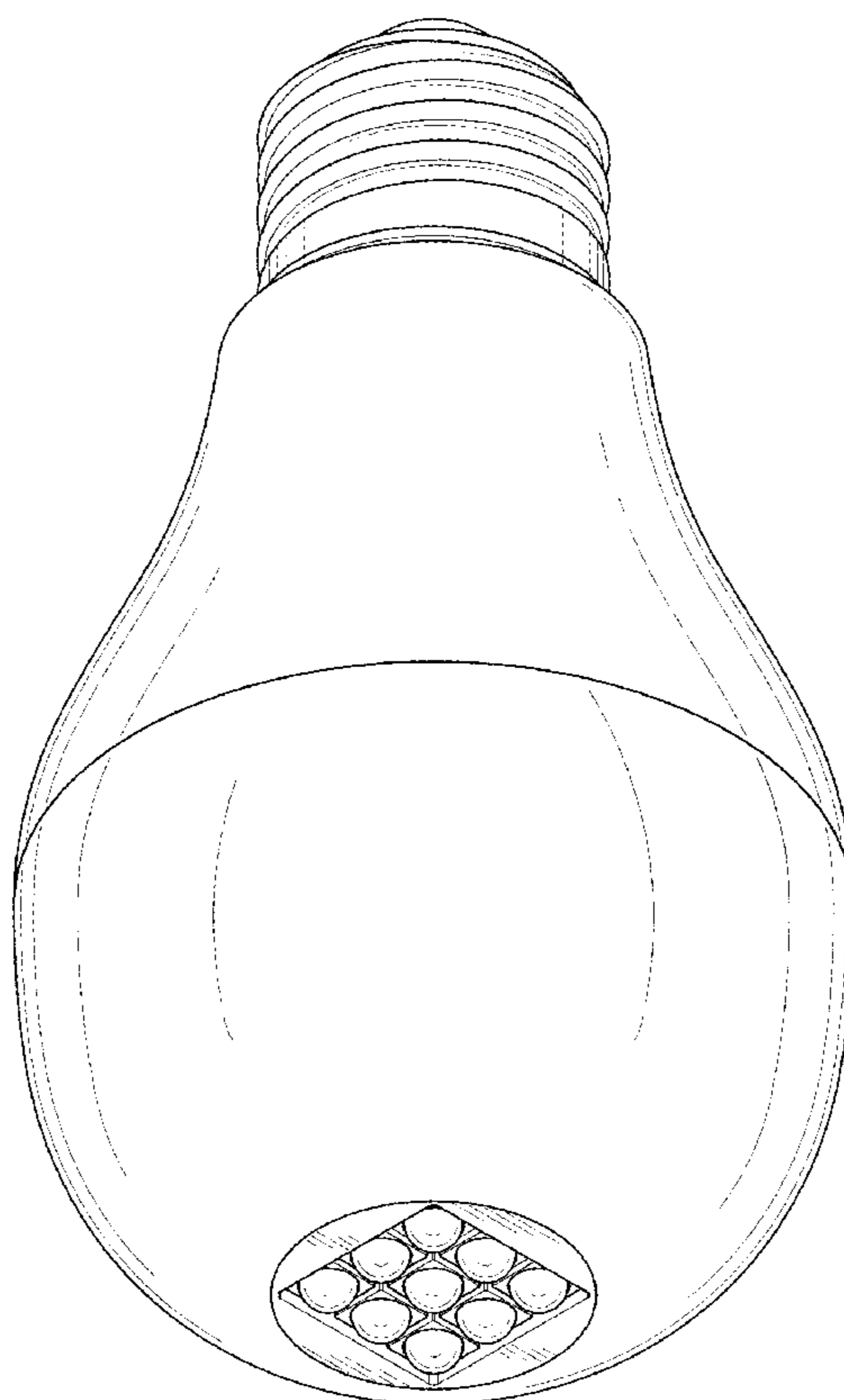
**CLAIM**

**DESCRIPTION**

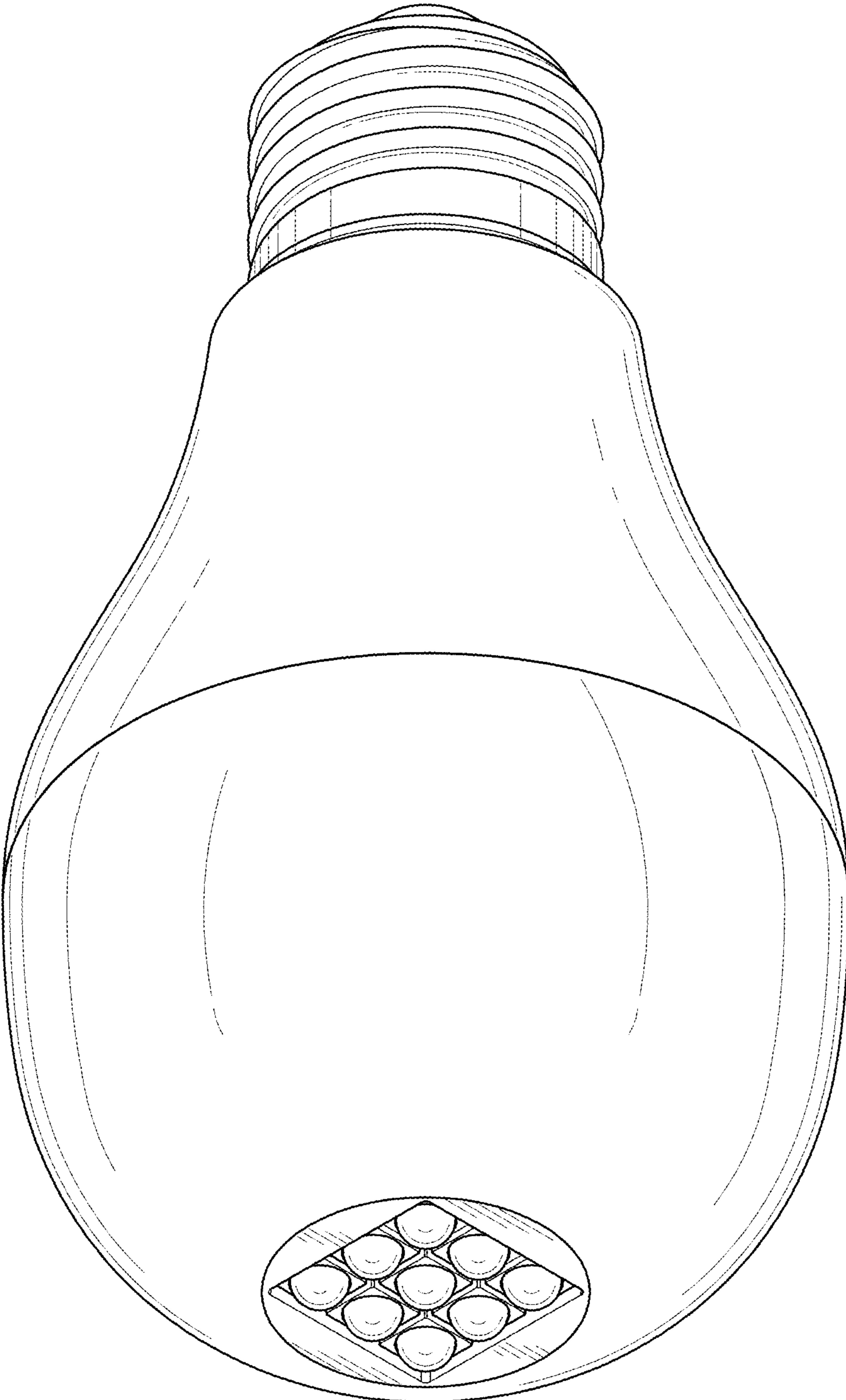

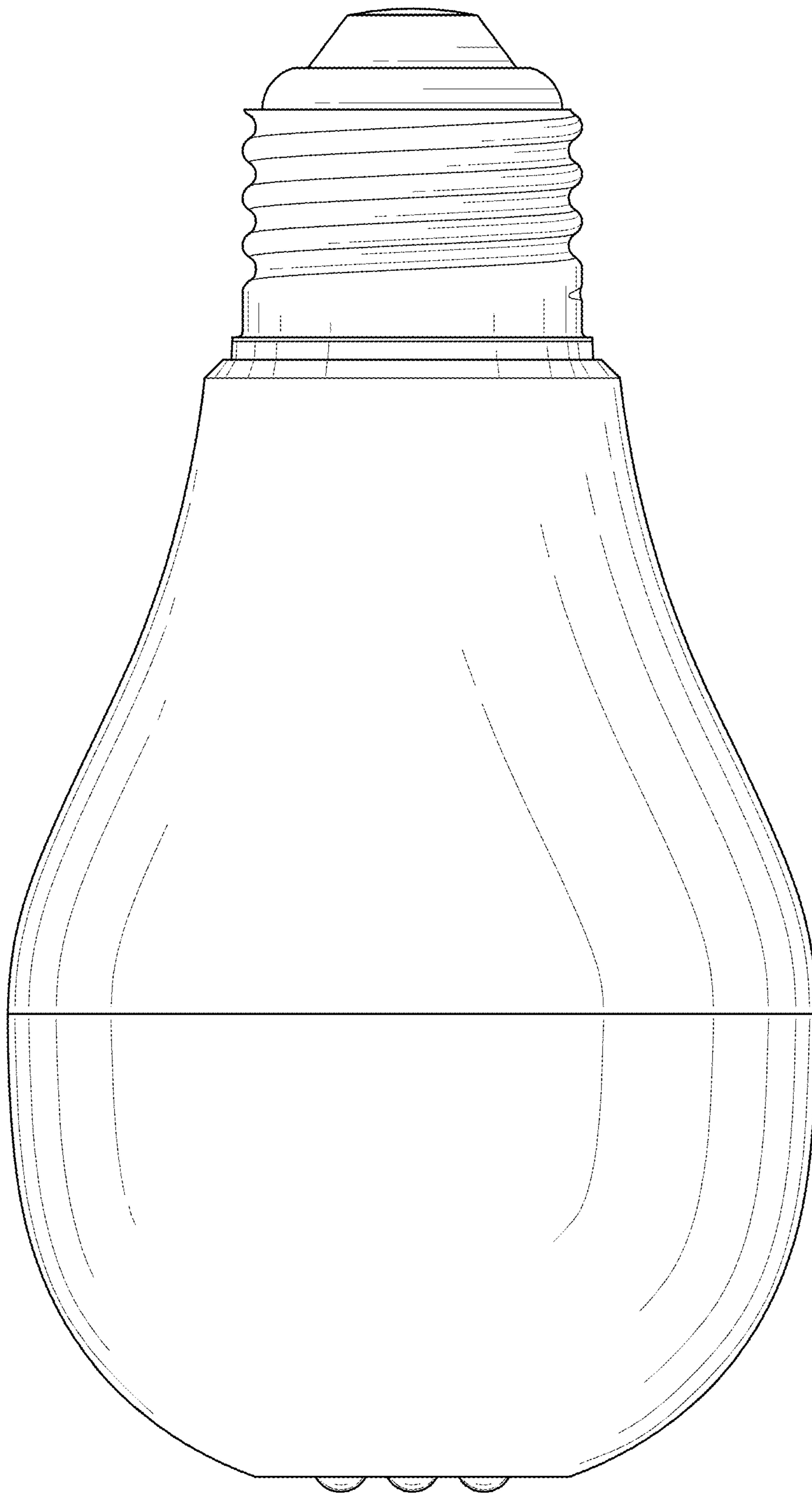

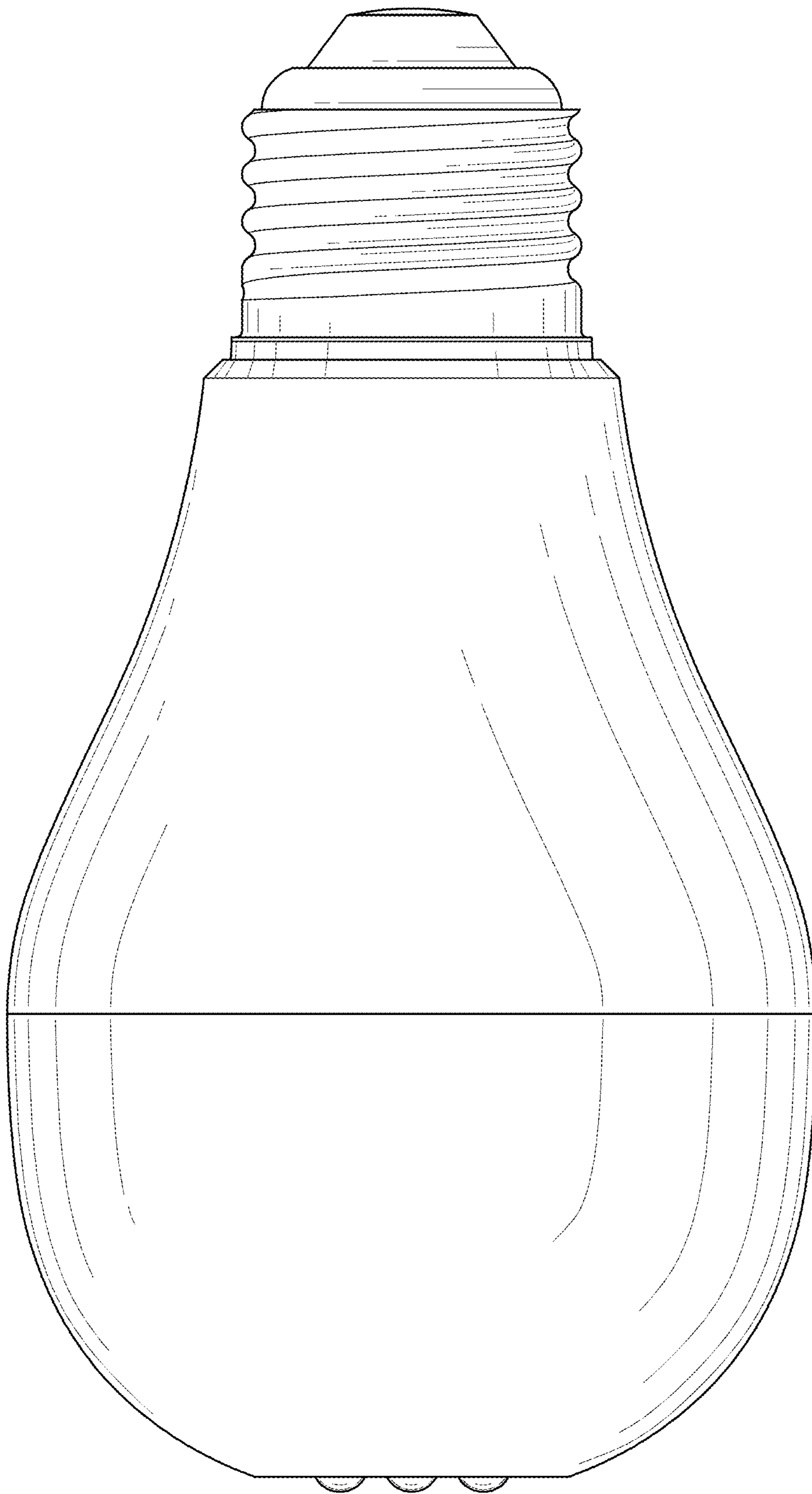

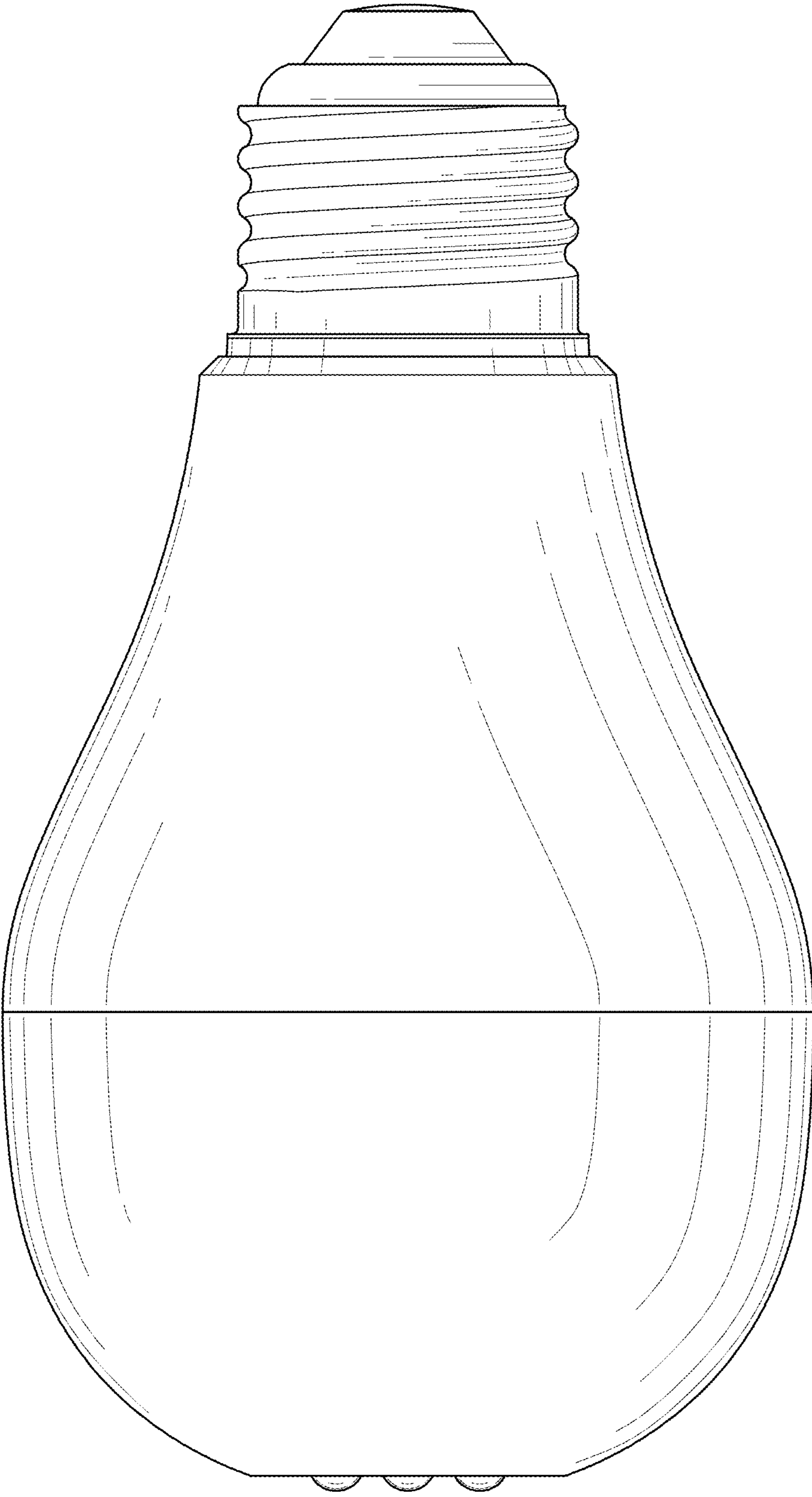

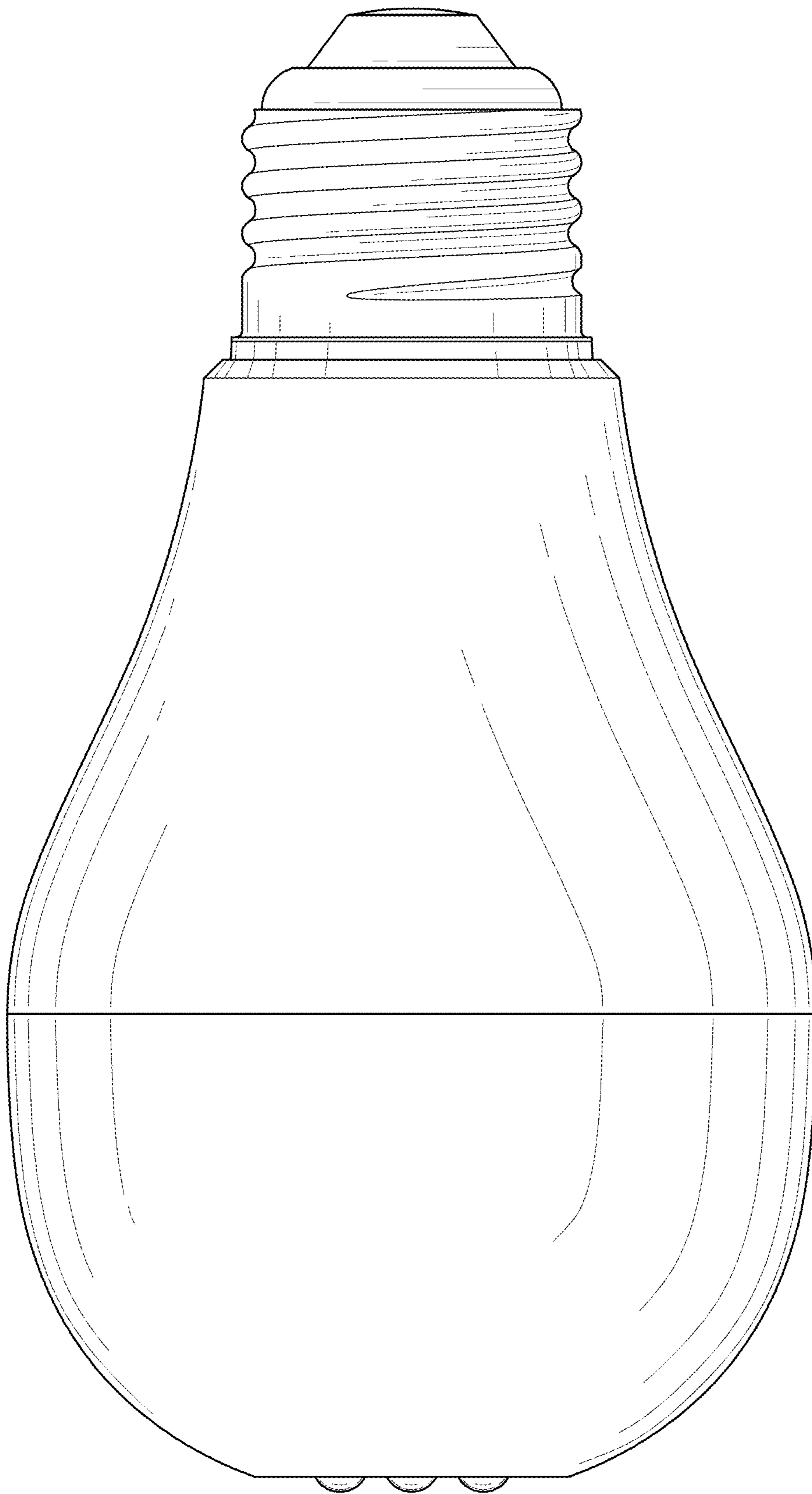

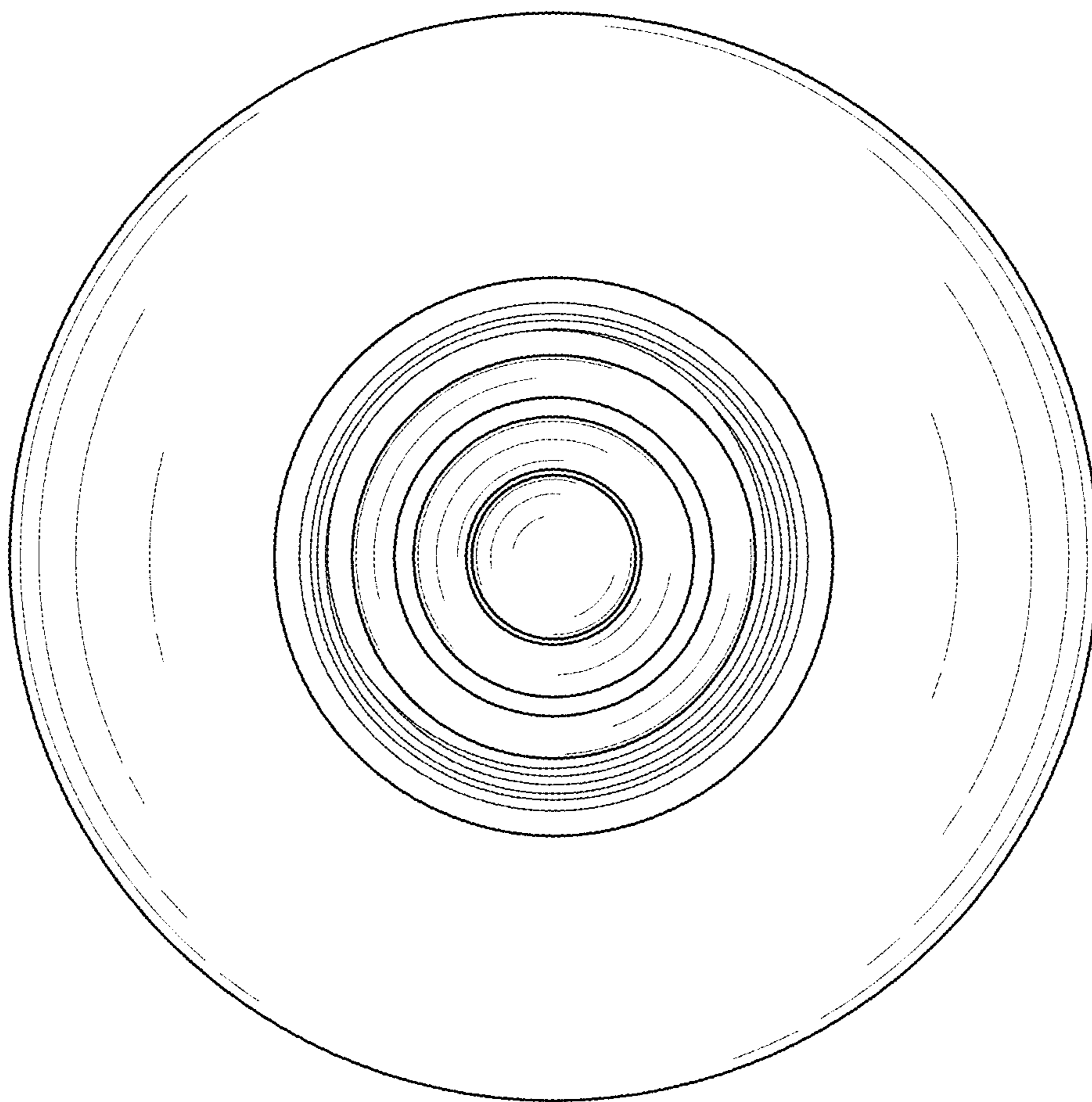

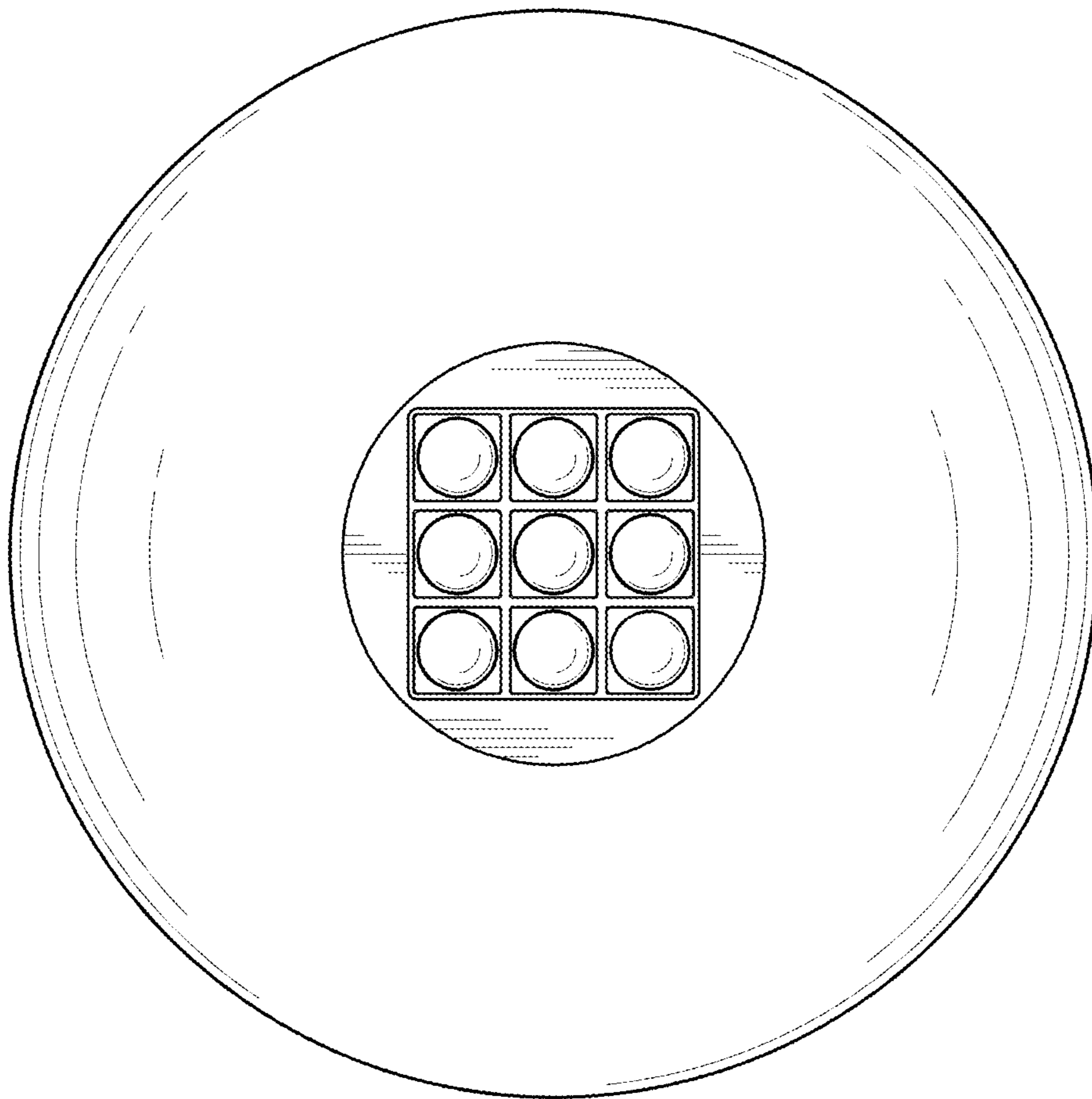
