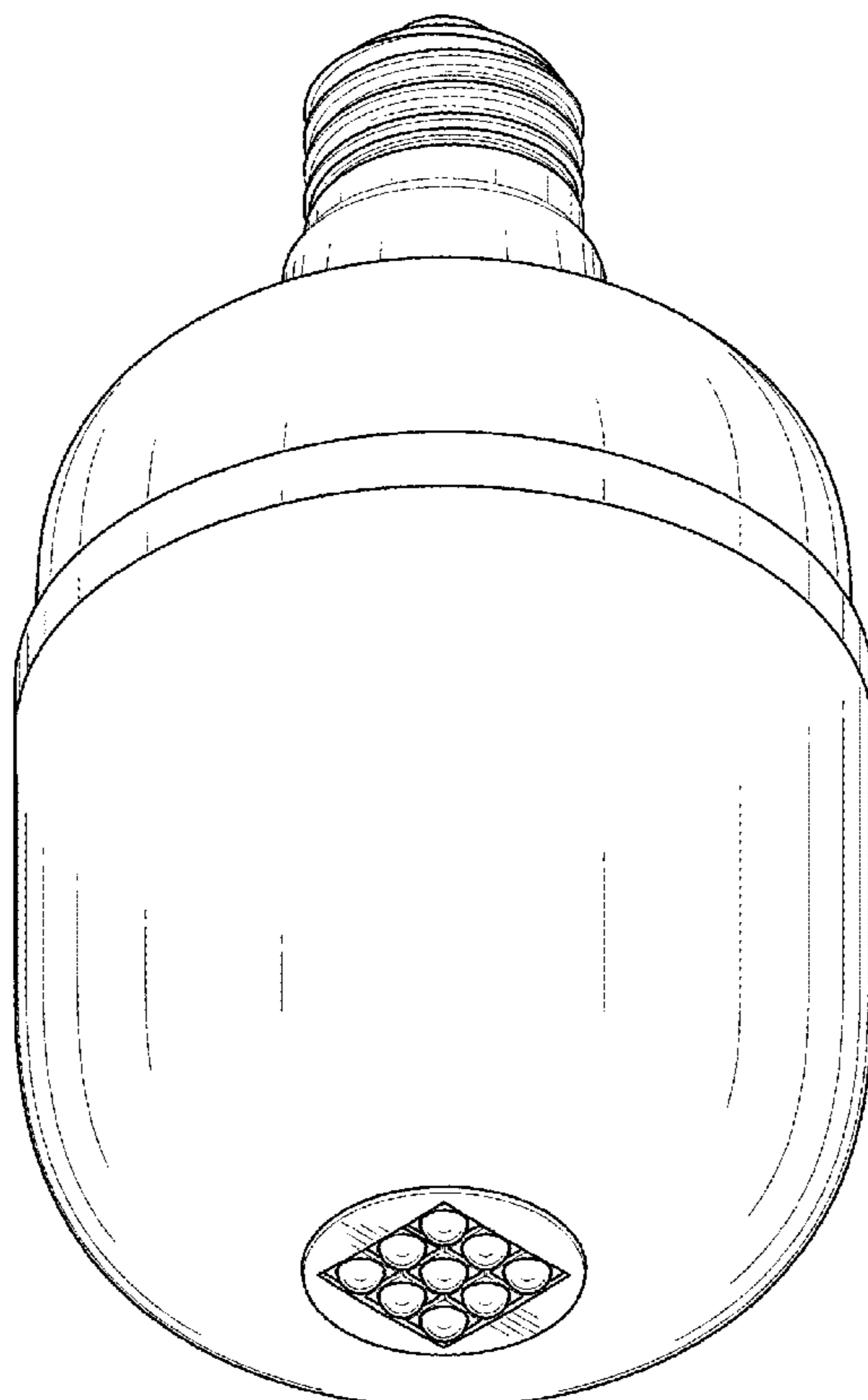
(57) **CLAIM**

The ornamental design for an ultraviolet sanitizing bulb, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side and bottom perspective view of an ultraviolet sanitizing bulb showing the claimed design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

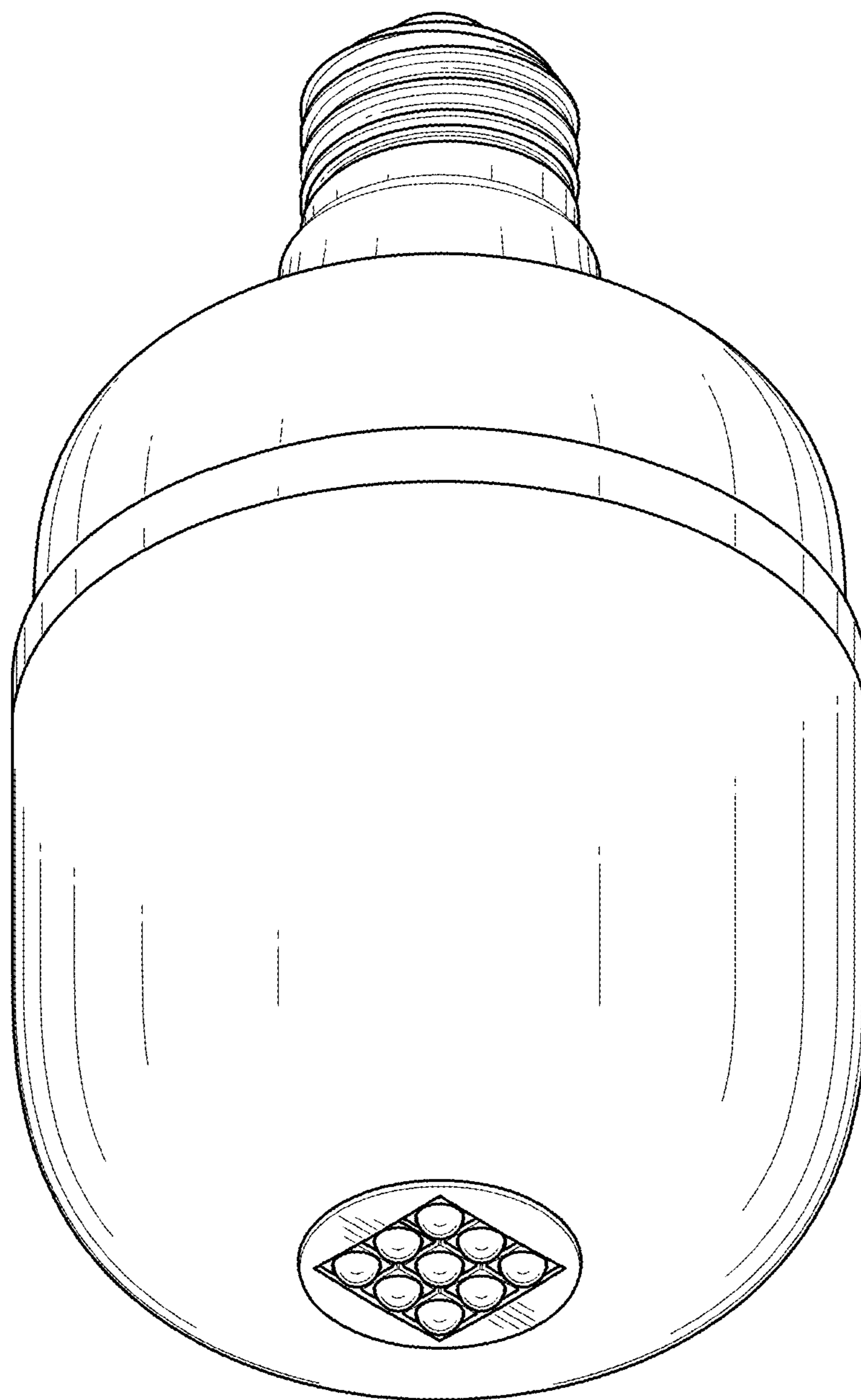

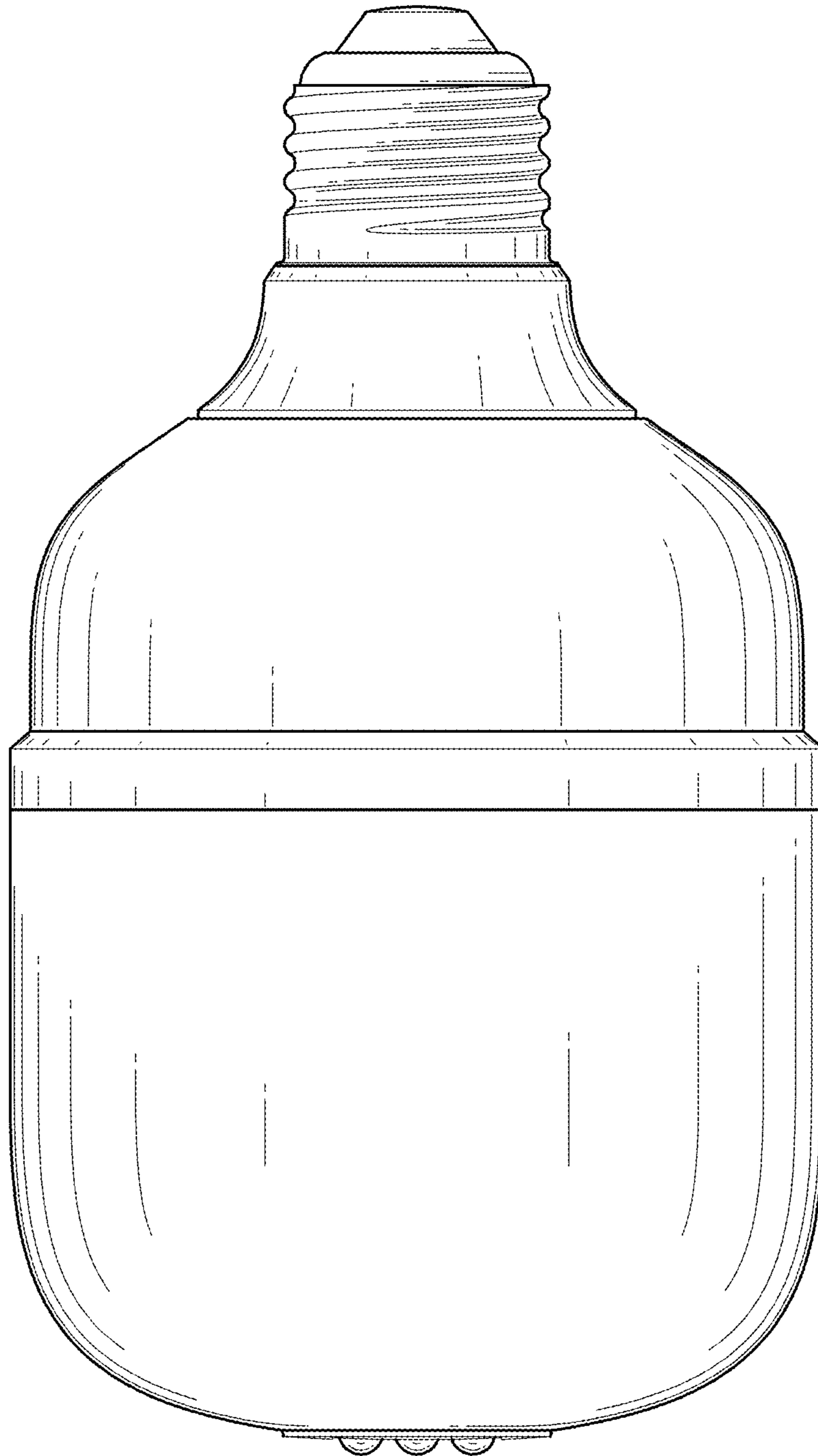

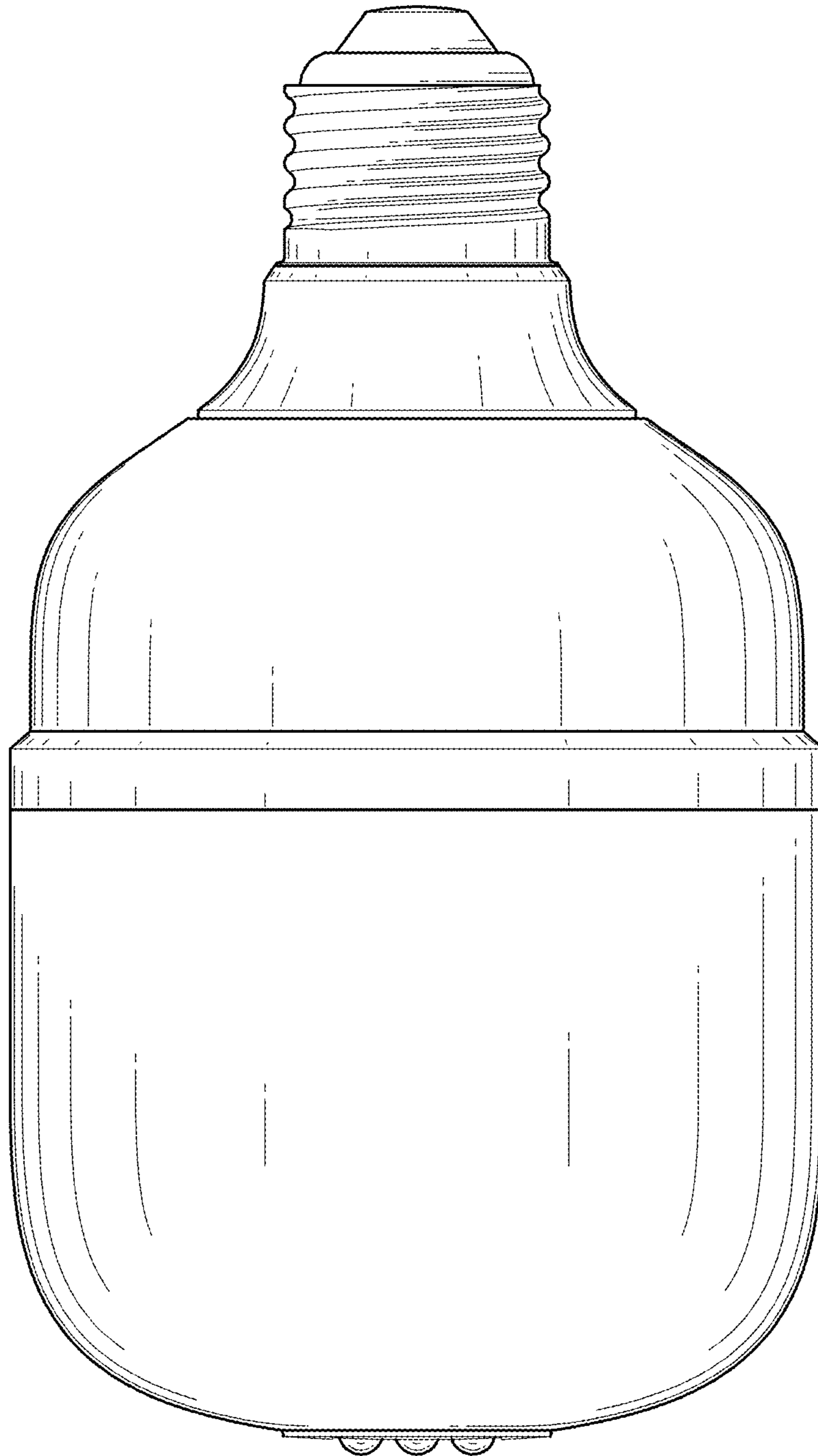

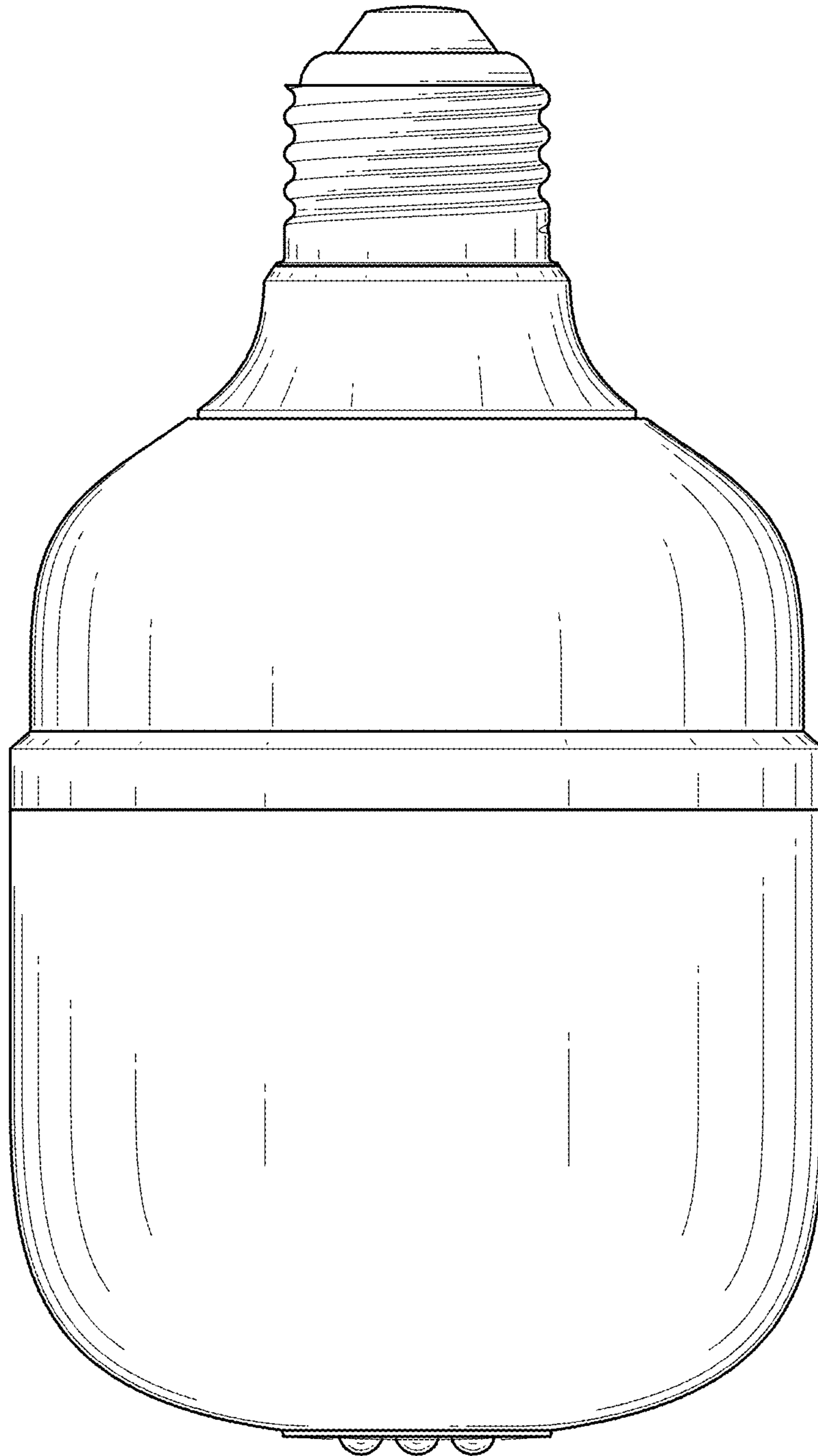

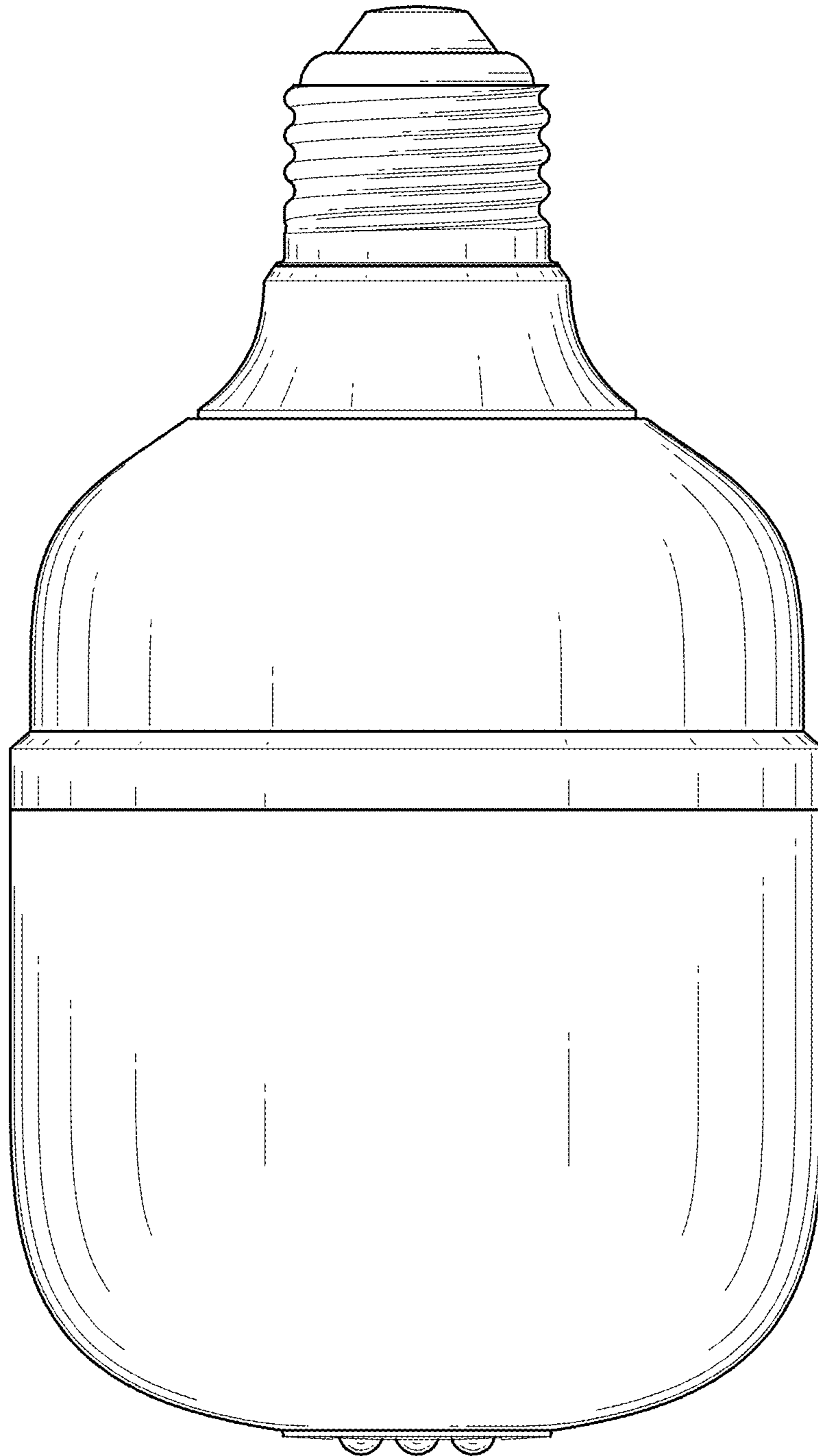

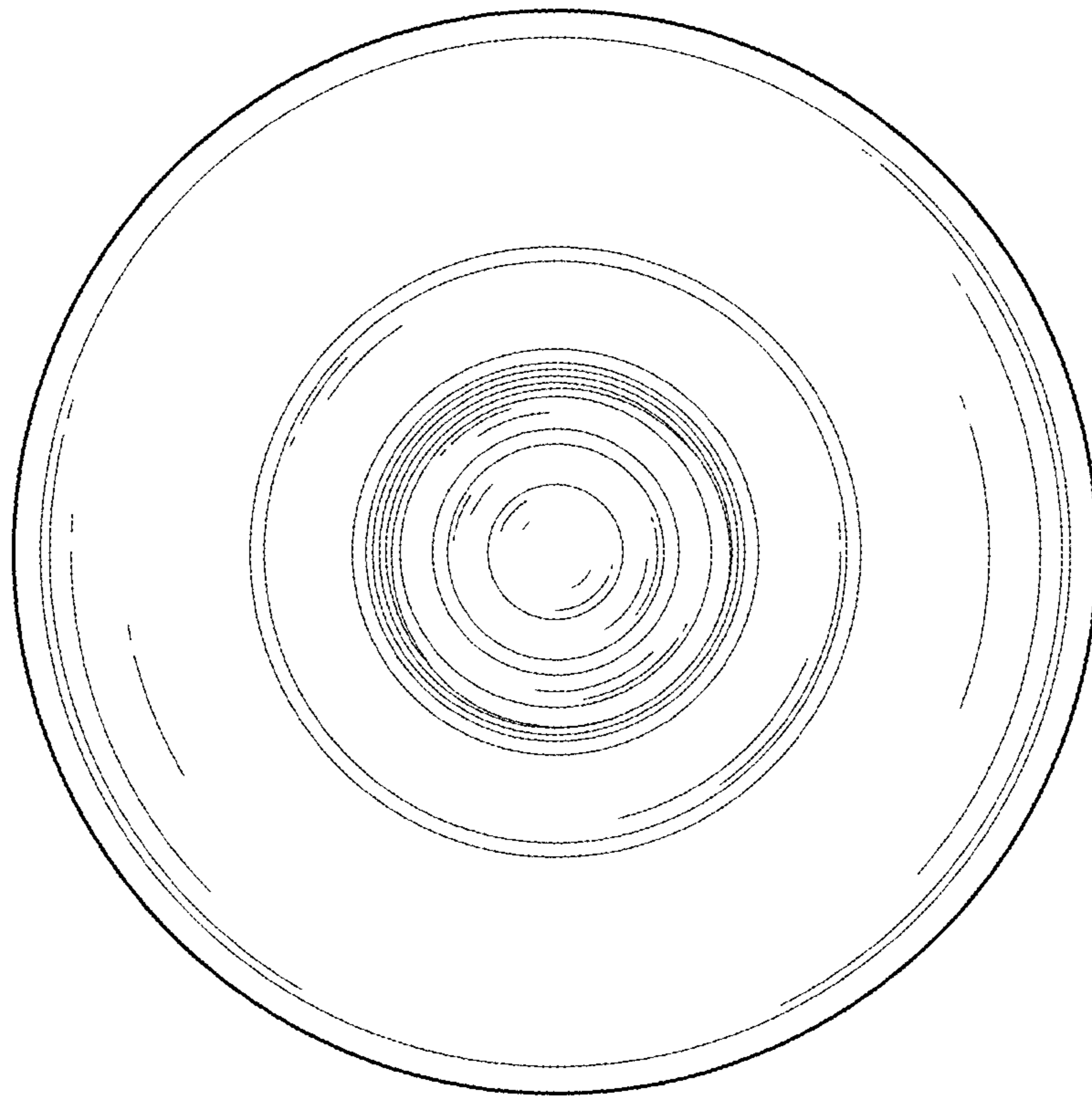

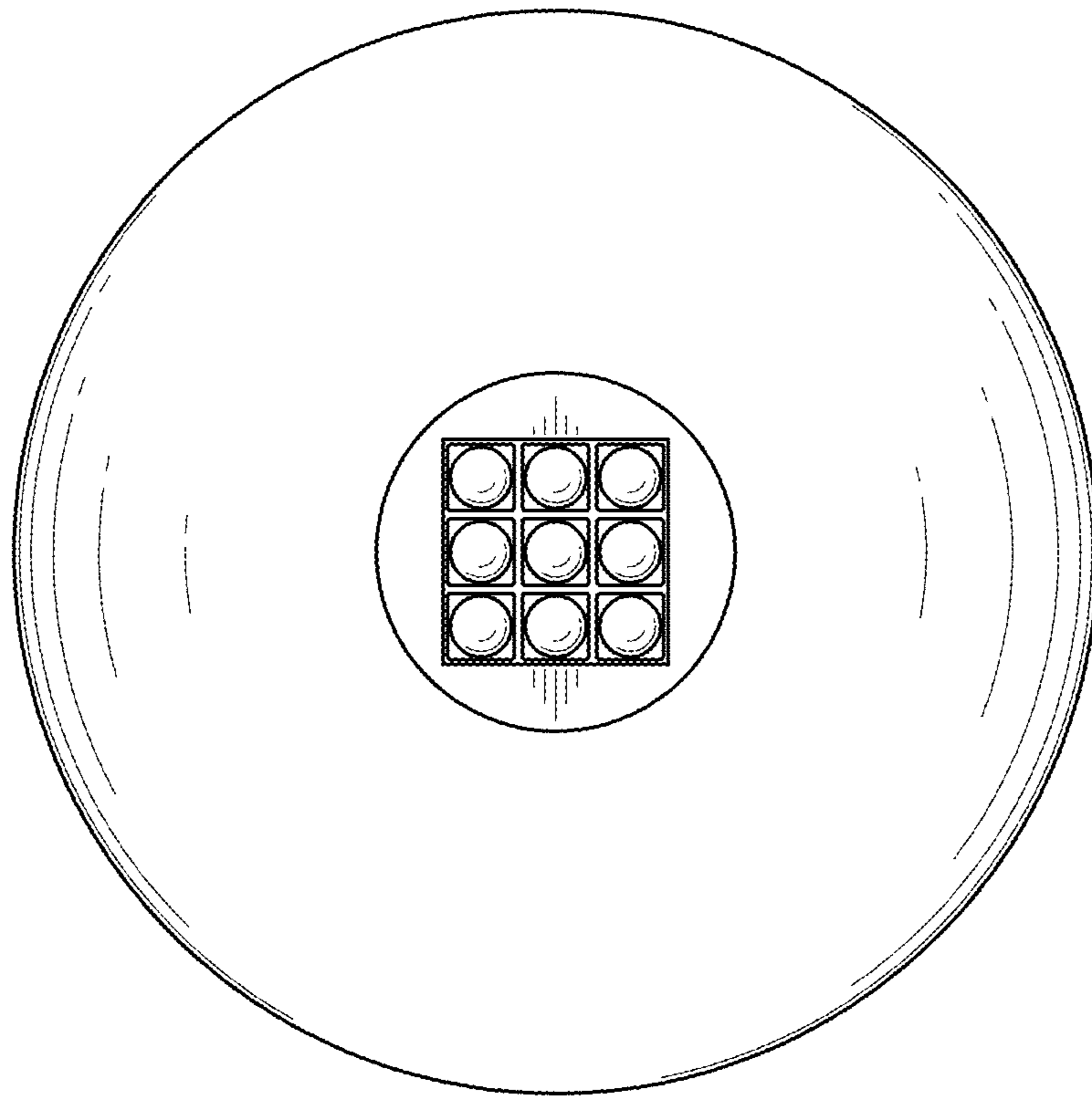
