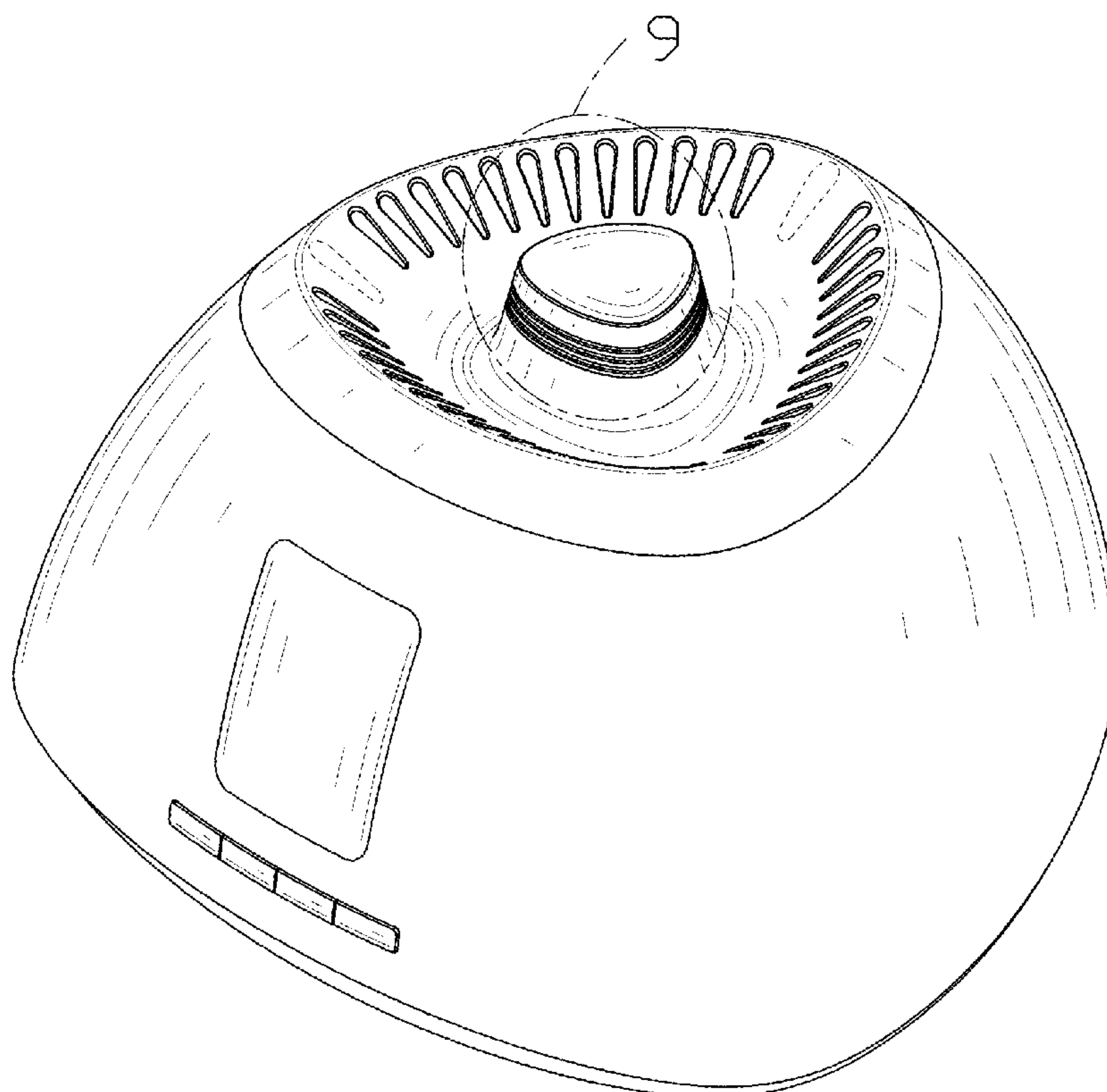
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a lamp, showing my design.
FIG. 2 is a bottom, rear, left side perspective view thereof.

FIG. 4 is a rear elevation view thereof.
FIG. 5 is a left side elevation view thereof.

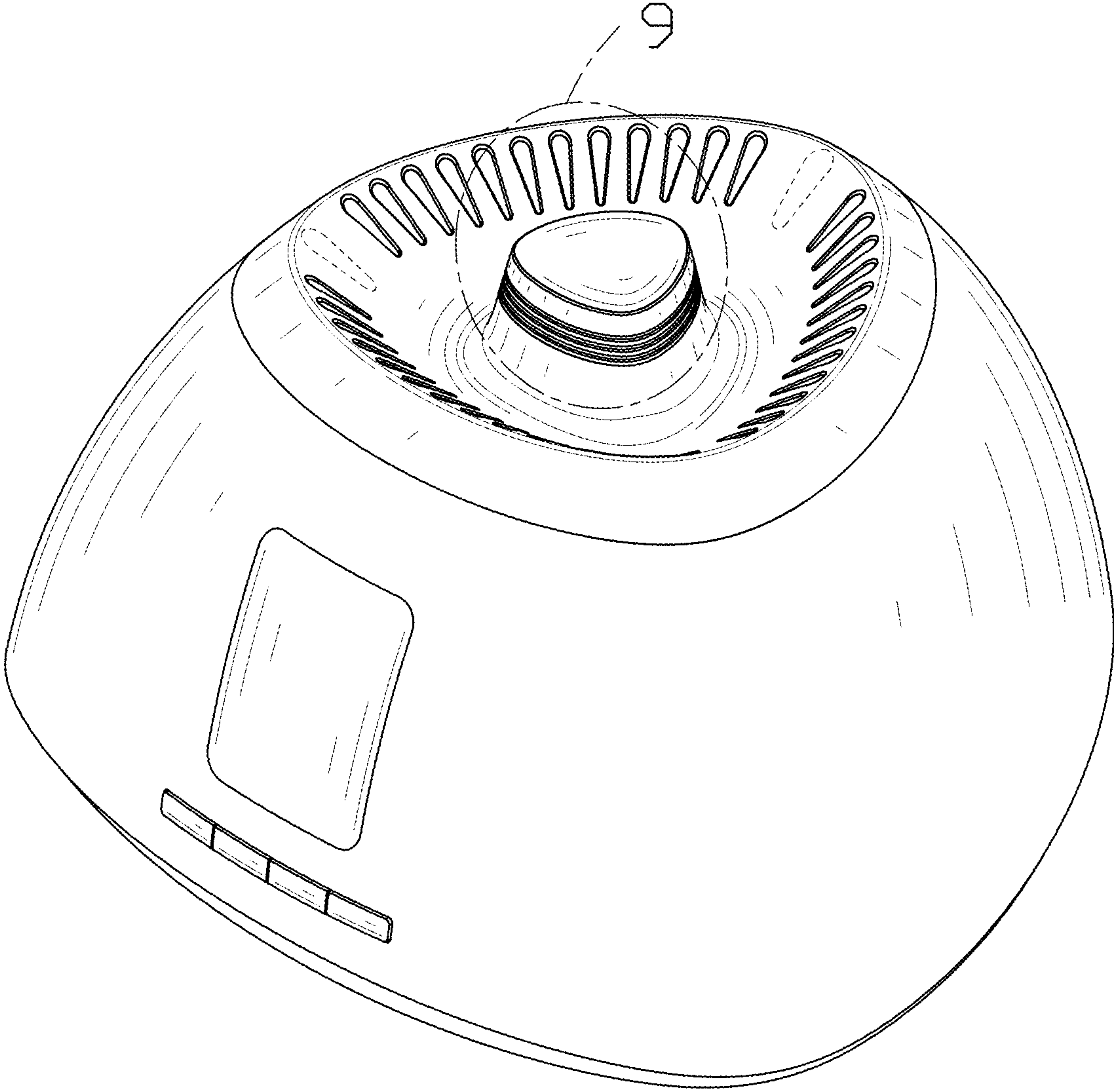

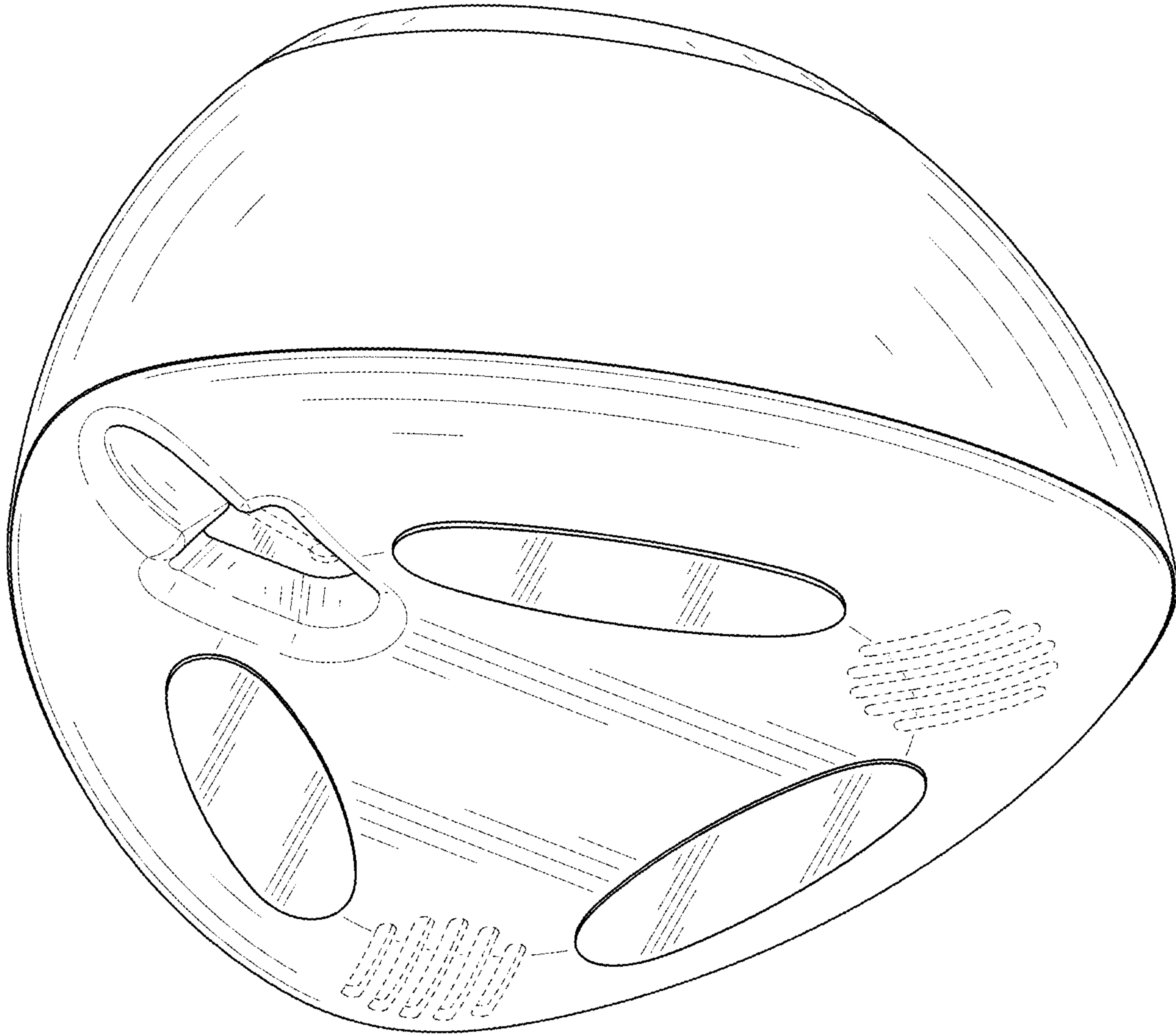

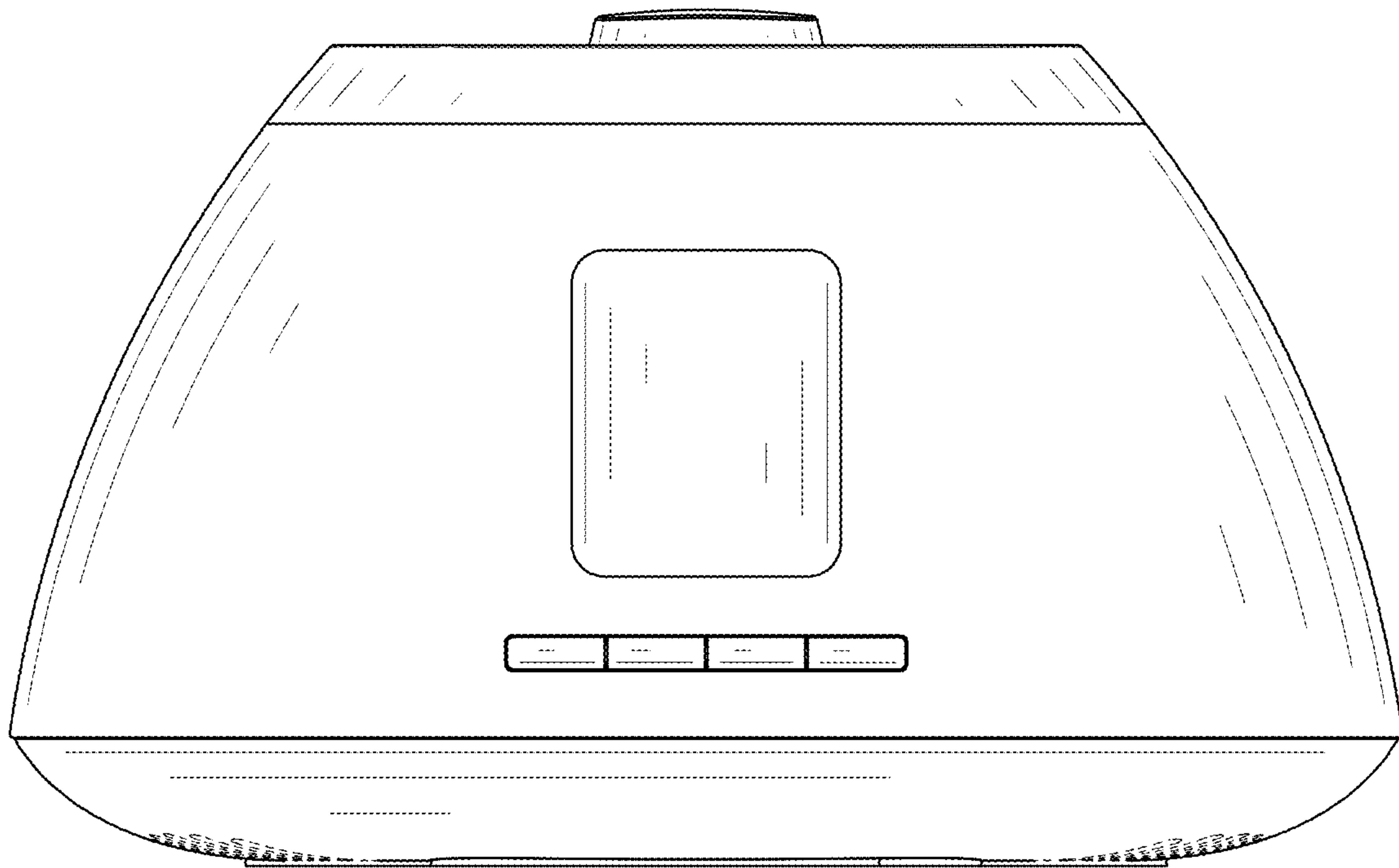

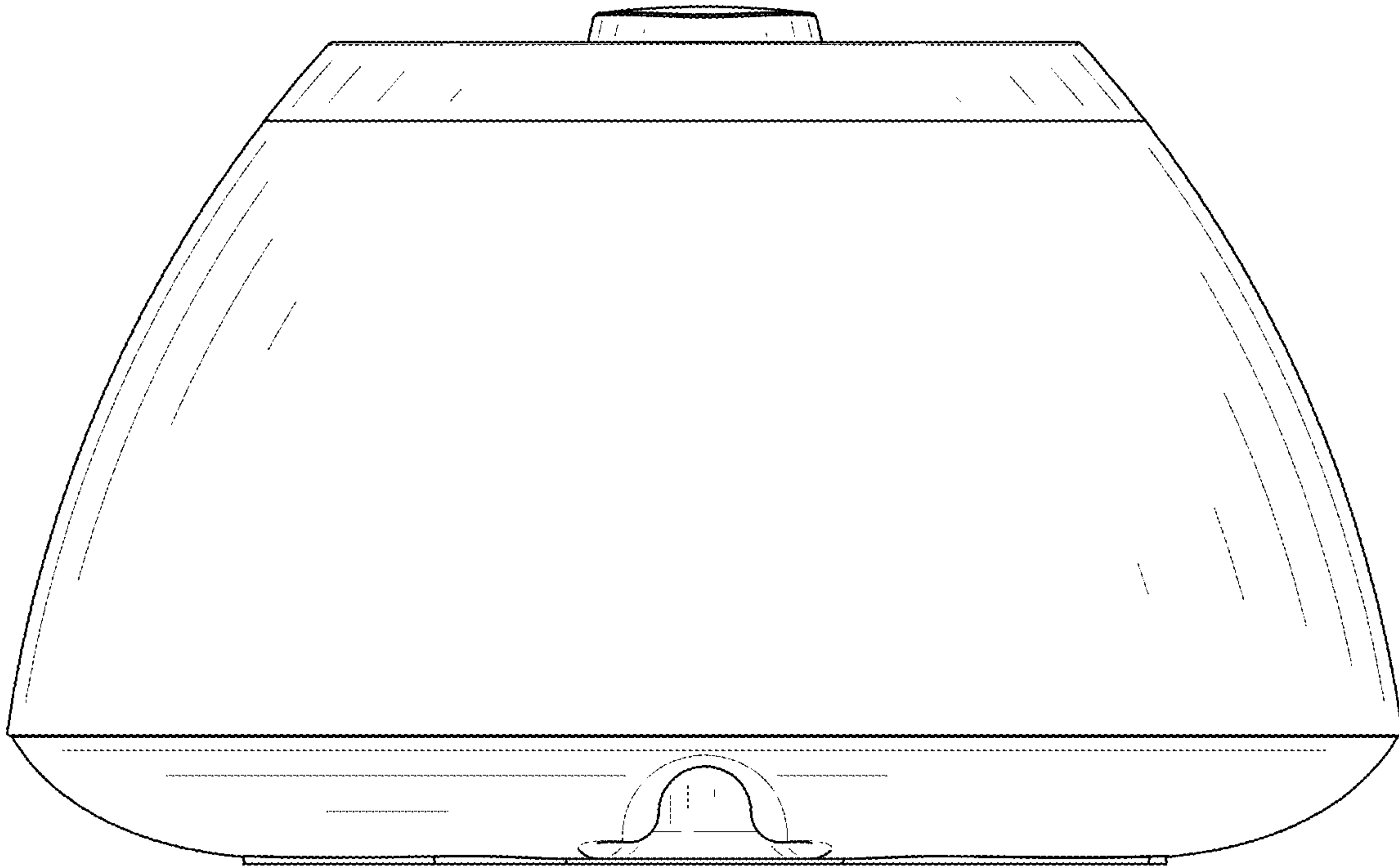

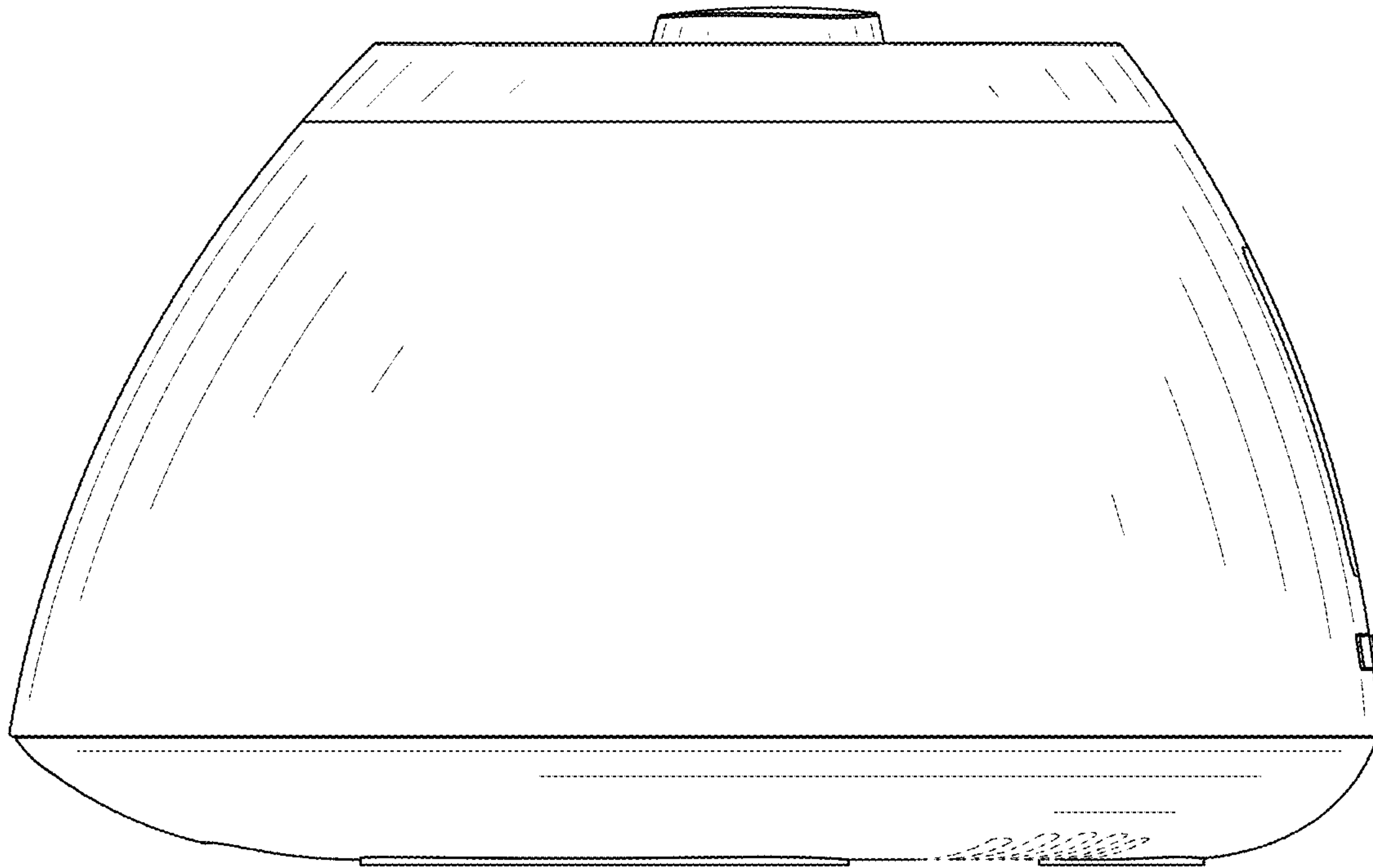

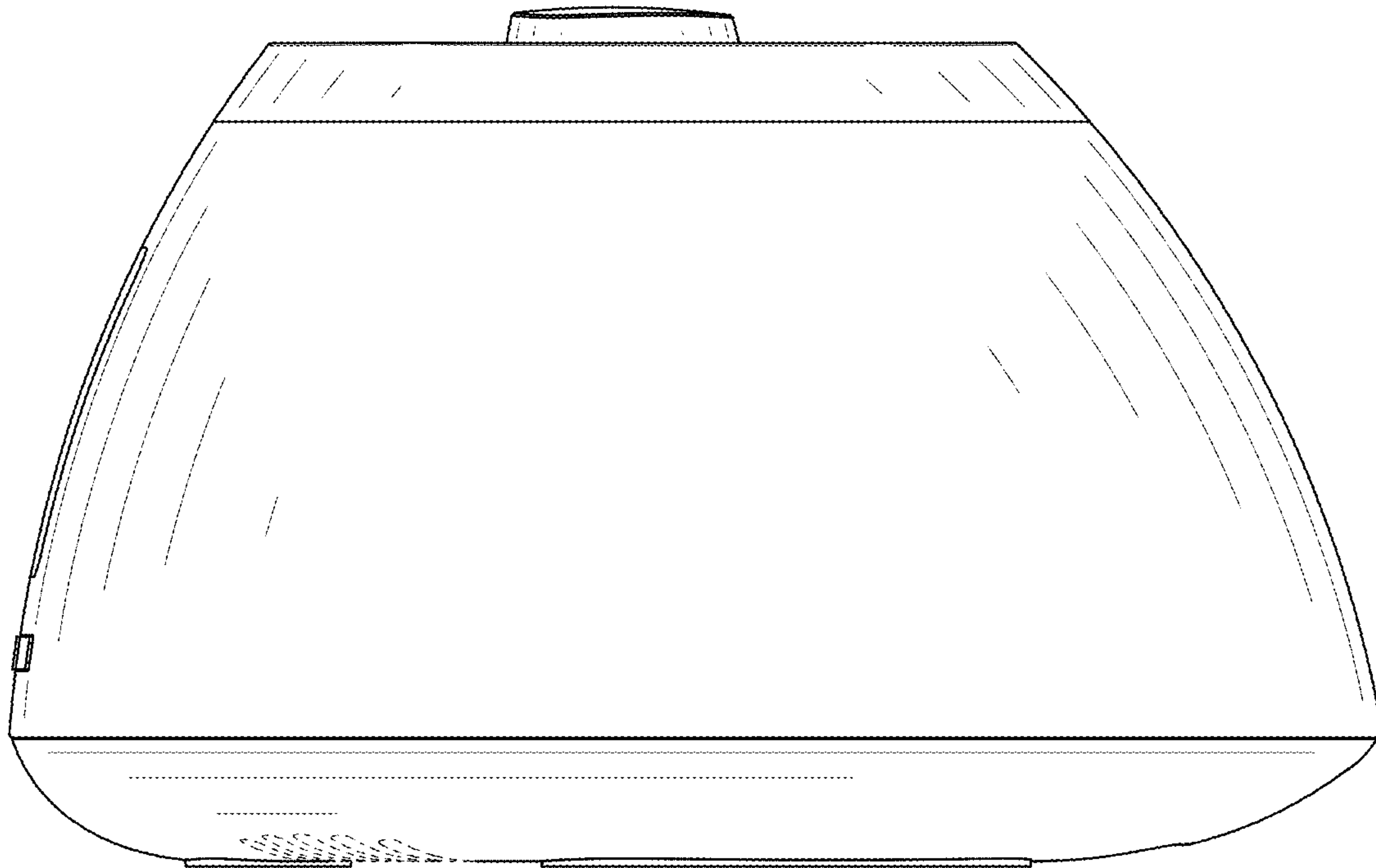

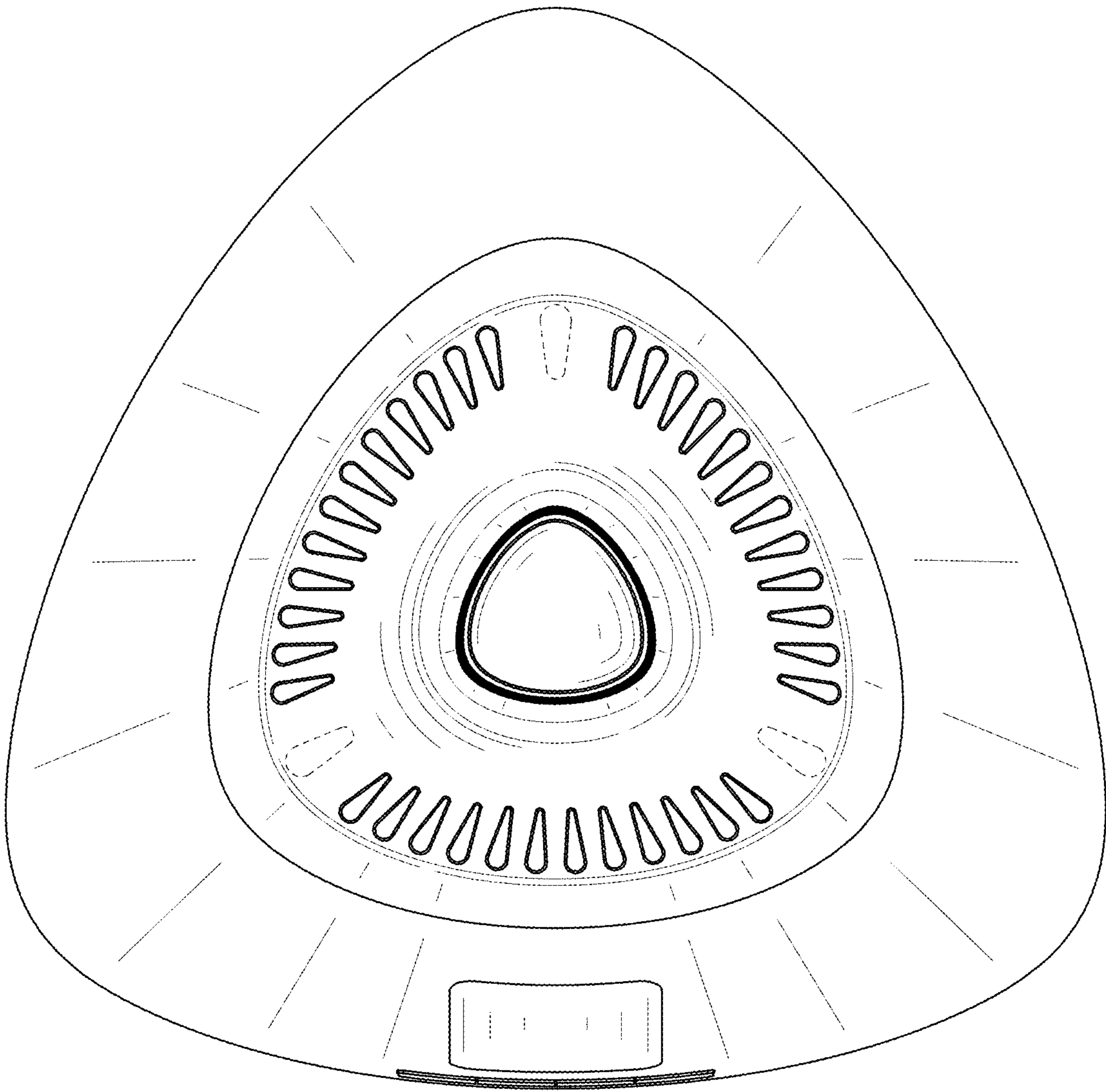

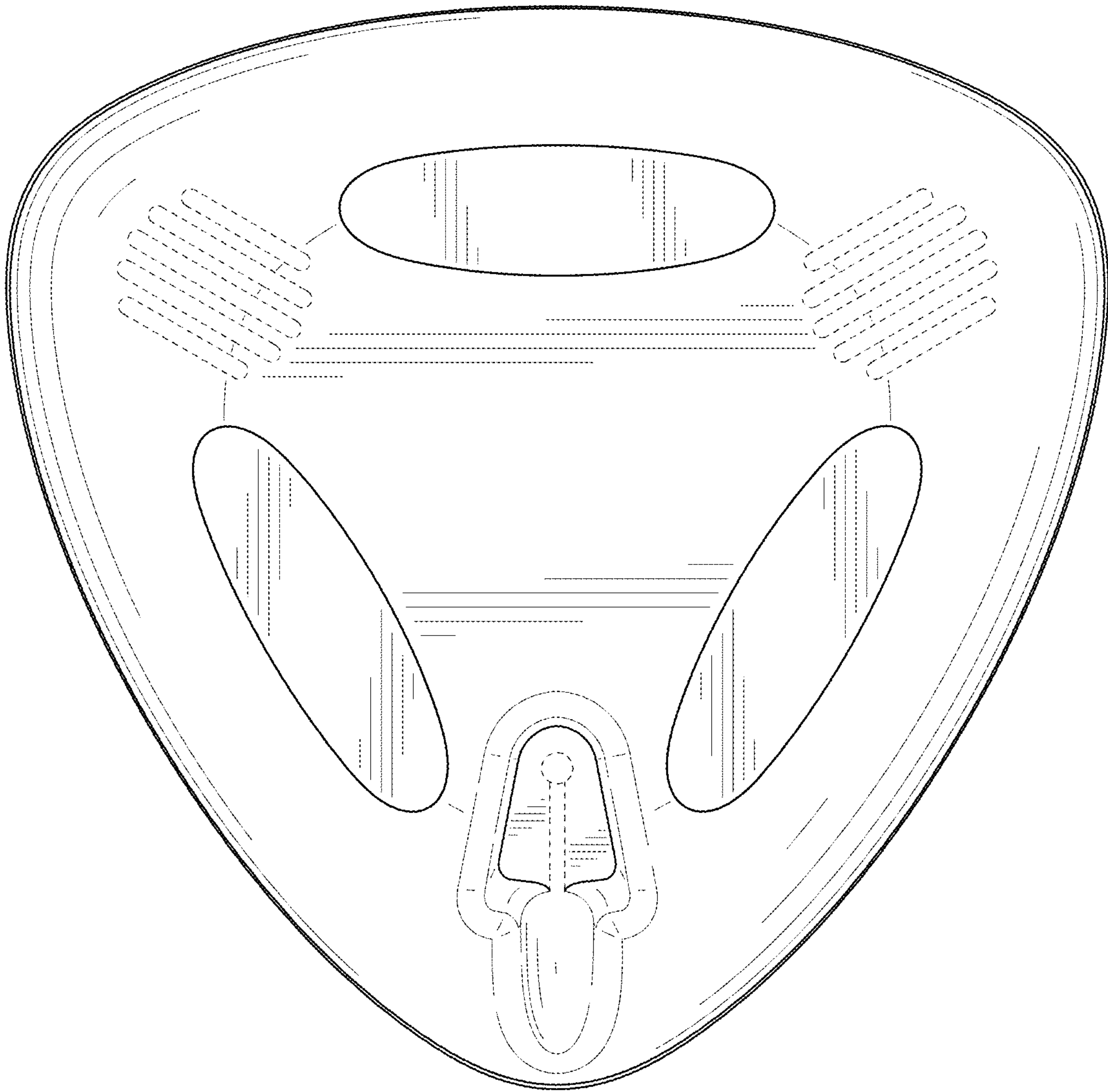

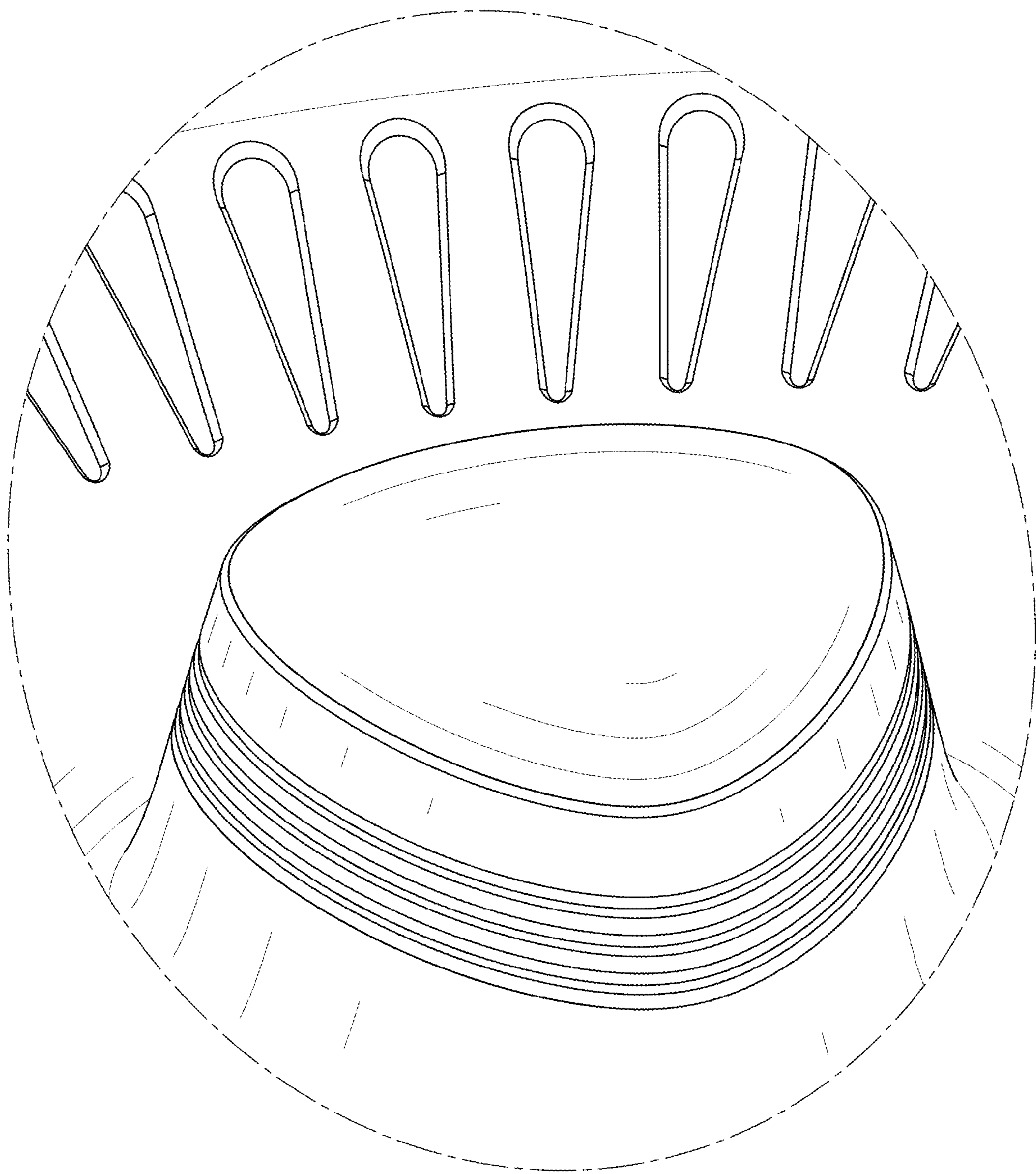
