FIG. 1 is a front view of a bra according to the design; FIG. 2 is a rear view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a rear perspective view thereof; FIG. 6 is a rear view thereof shown in an environment of use; FIG. 7 is a rear view thereof with back straps thereof shown in a partially opened position; and, FIG. 8 is a rear view thereof with the back straps thereof shown in a fully opened position.

The portions of the bra shown in broken lines in FIGS. 1-8 do not form part of the claimed design. The broken line showing of the arms, torso, neck, and head in FIG. 6 is for the purpose of illustrating portions of the environmental structure and forms no part of the claimed design.

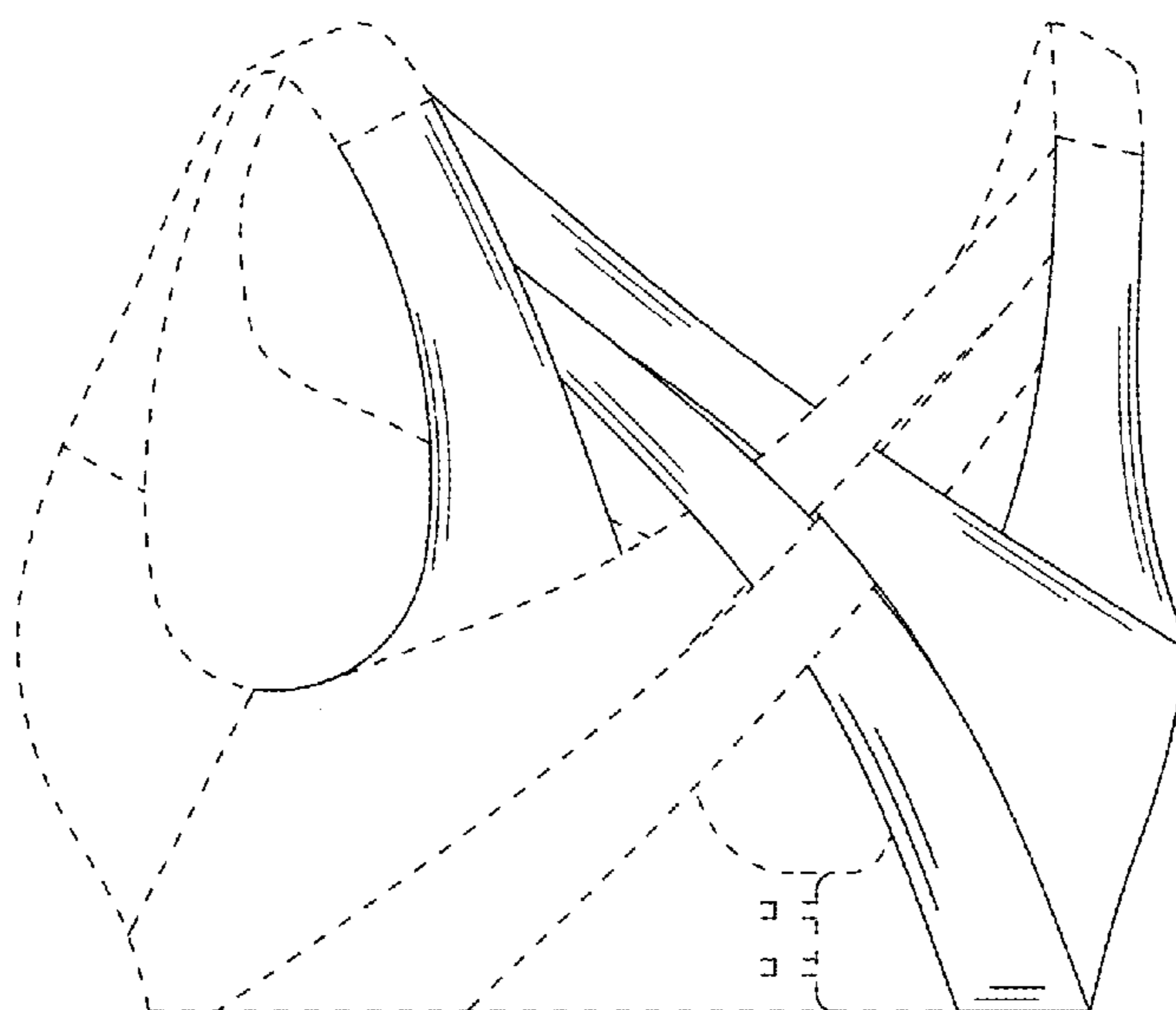

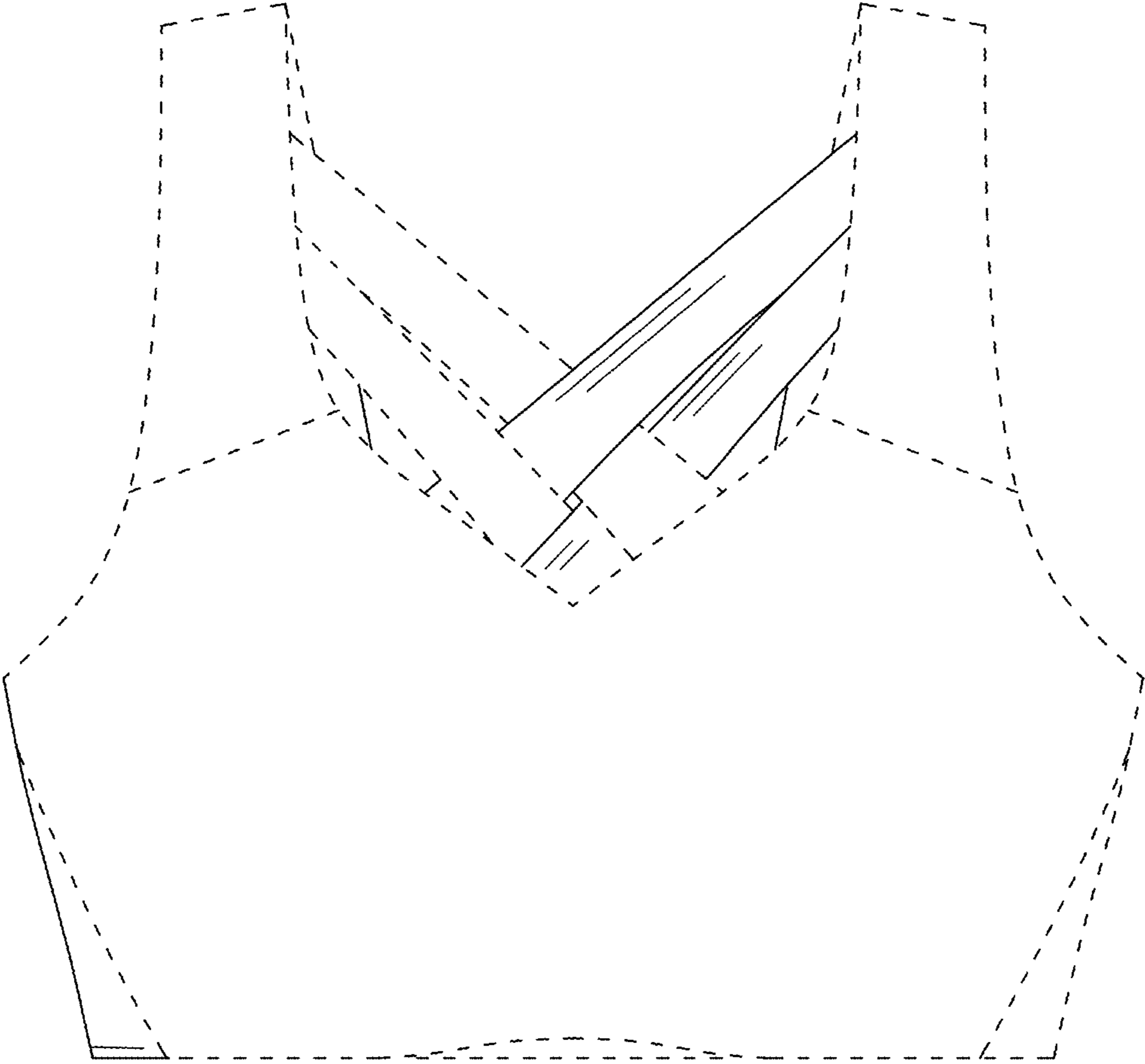

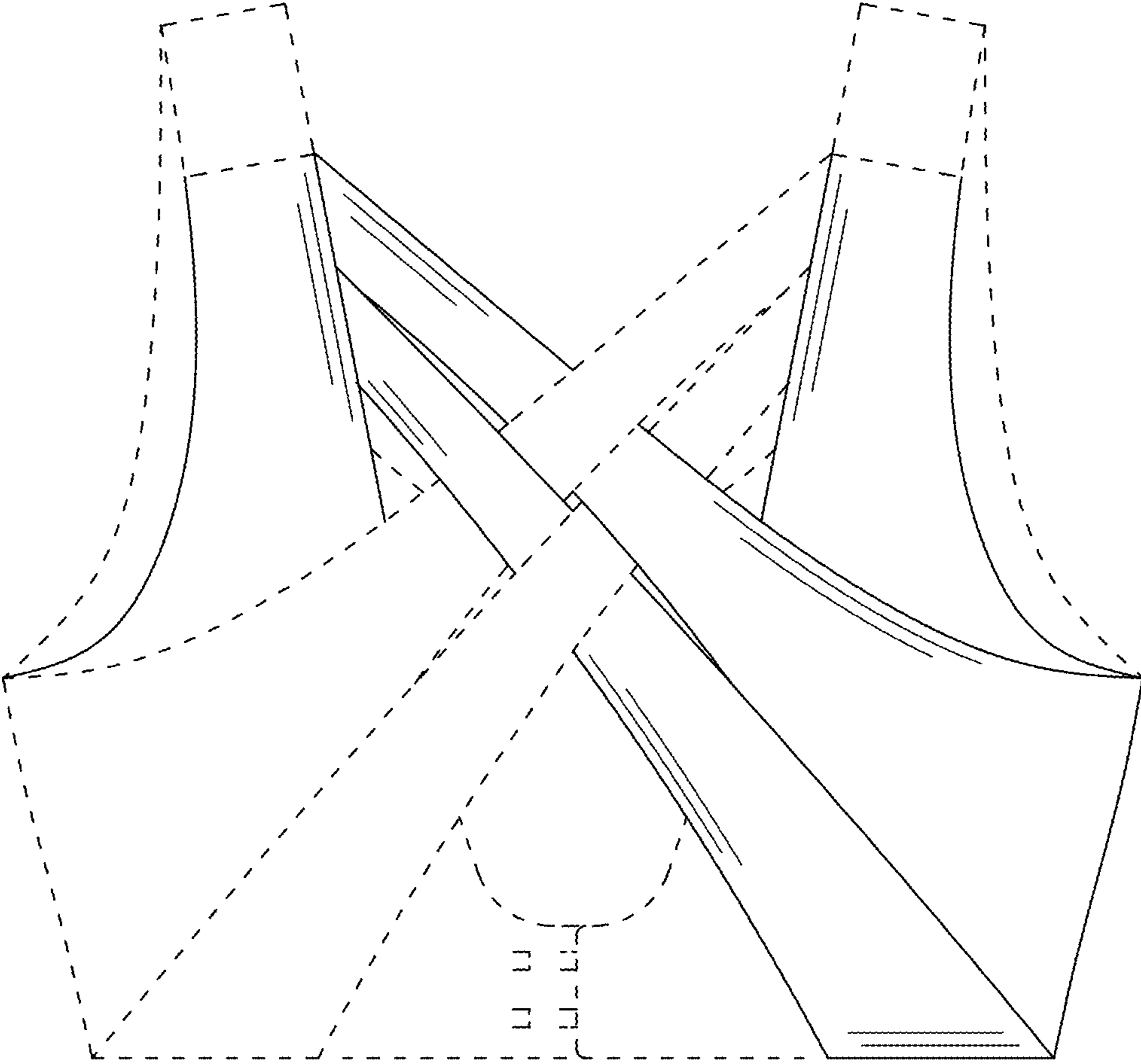

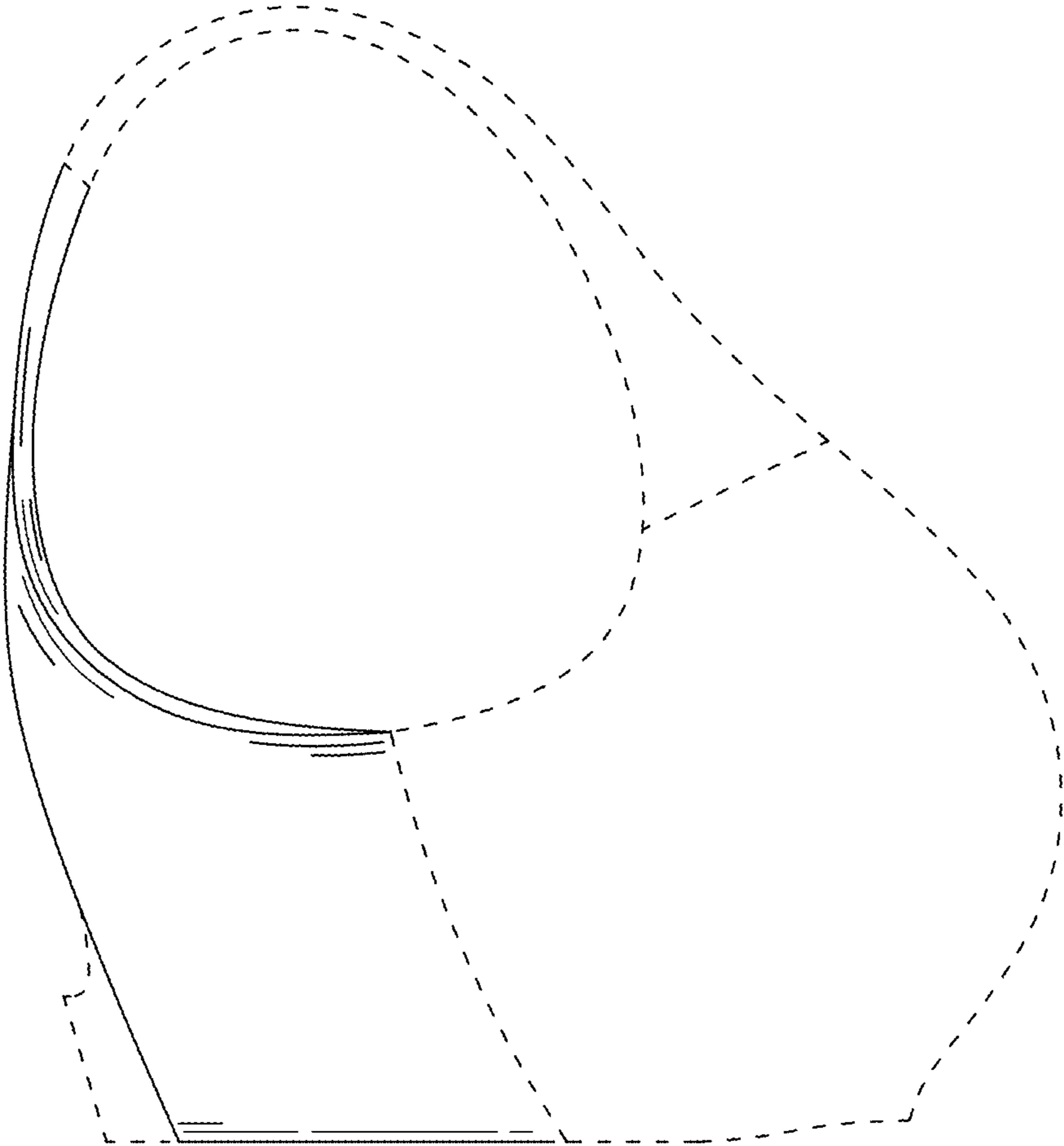

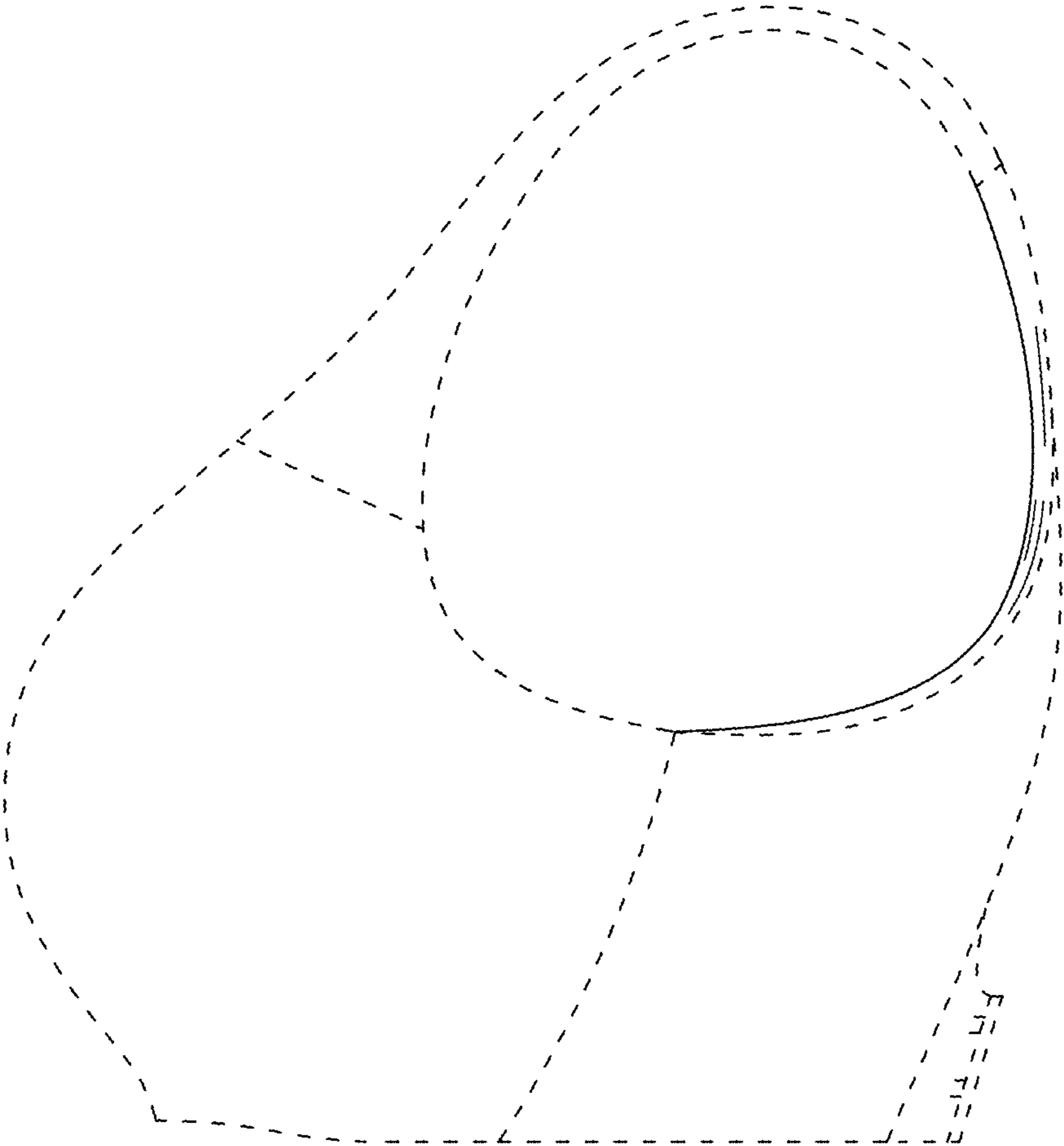

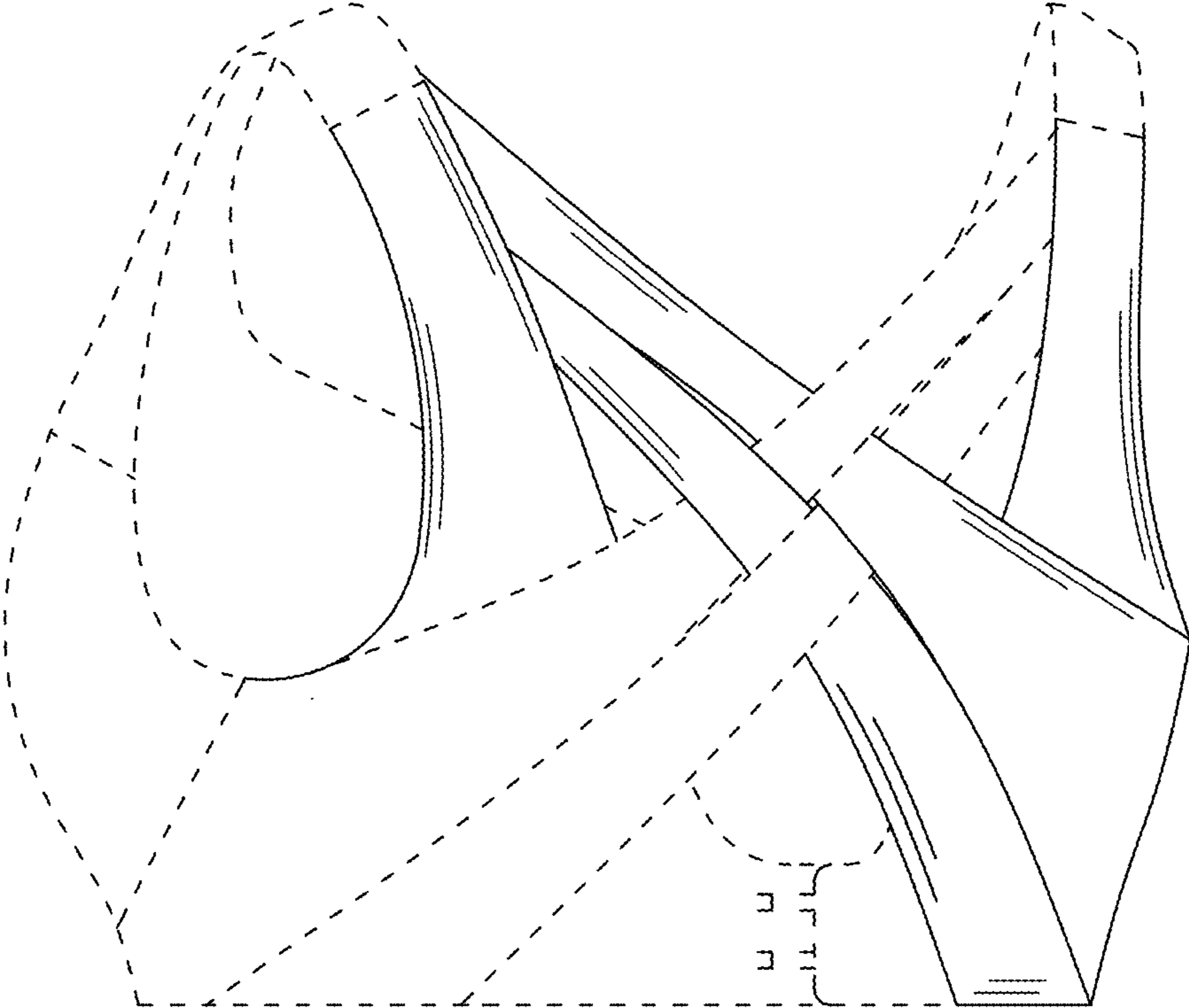

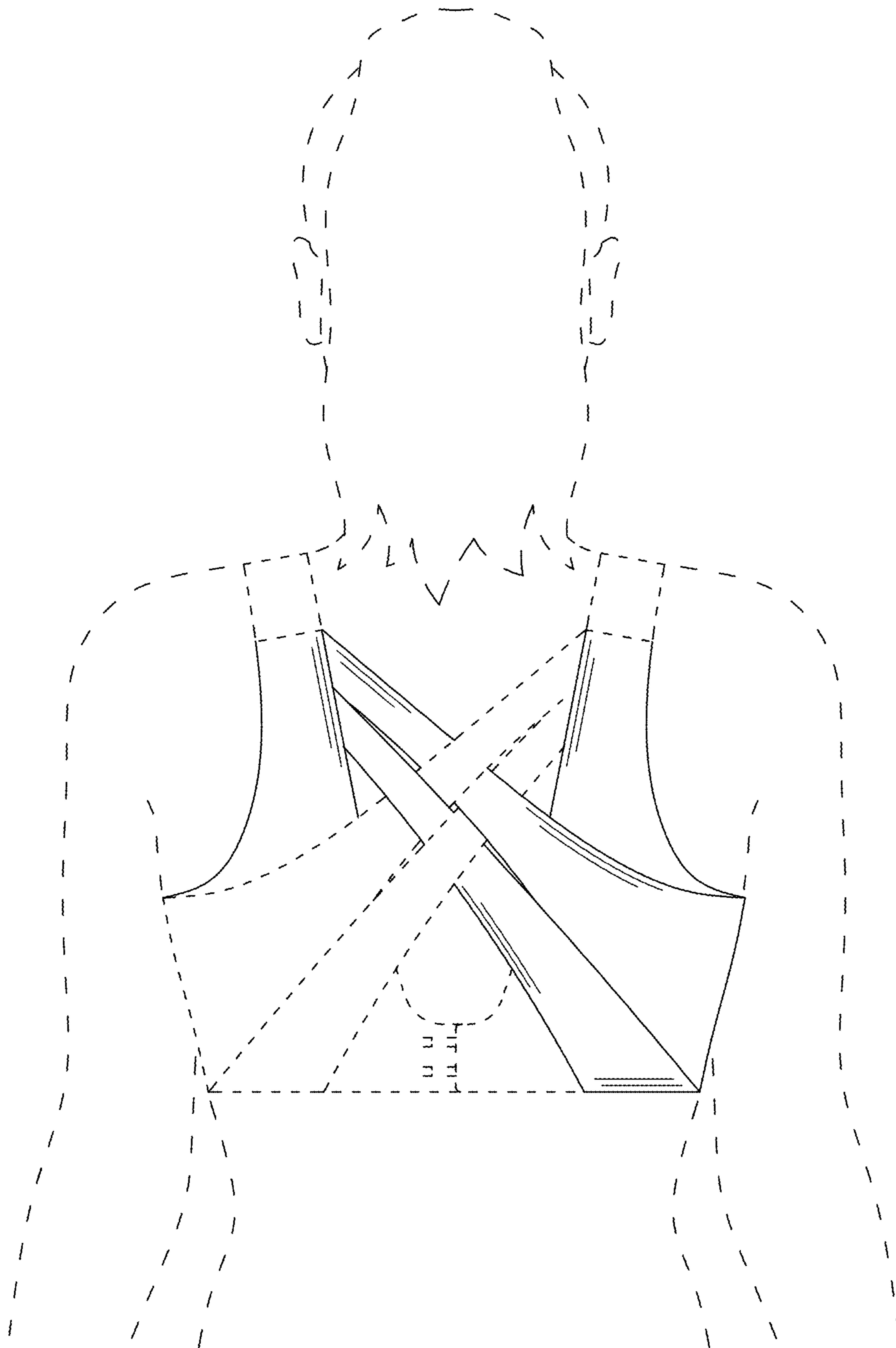

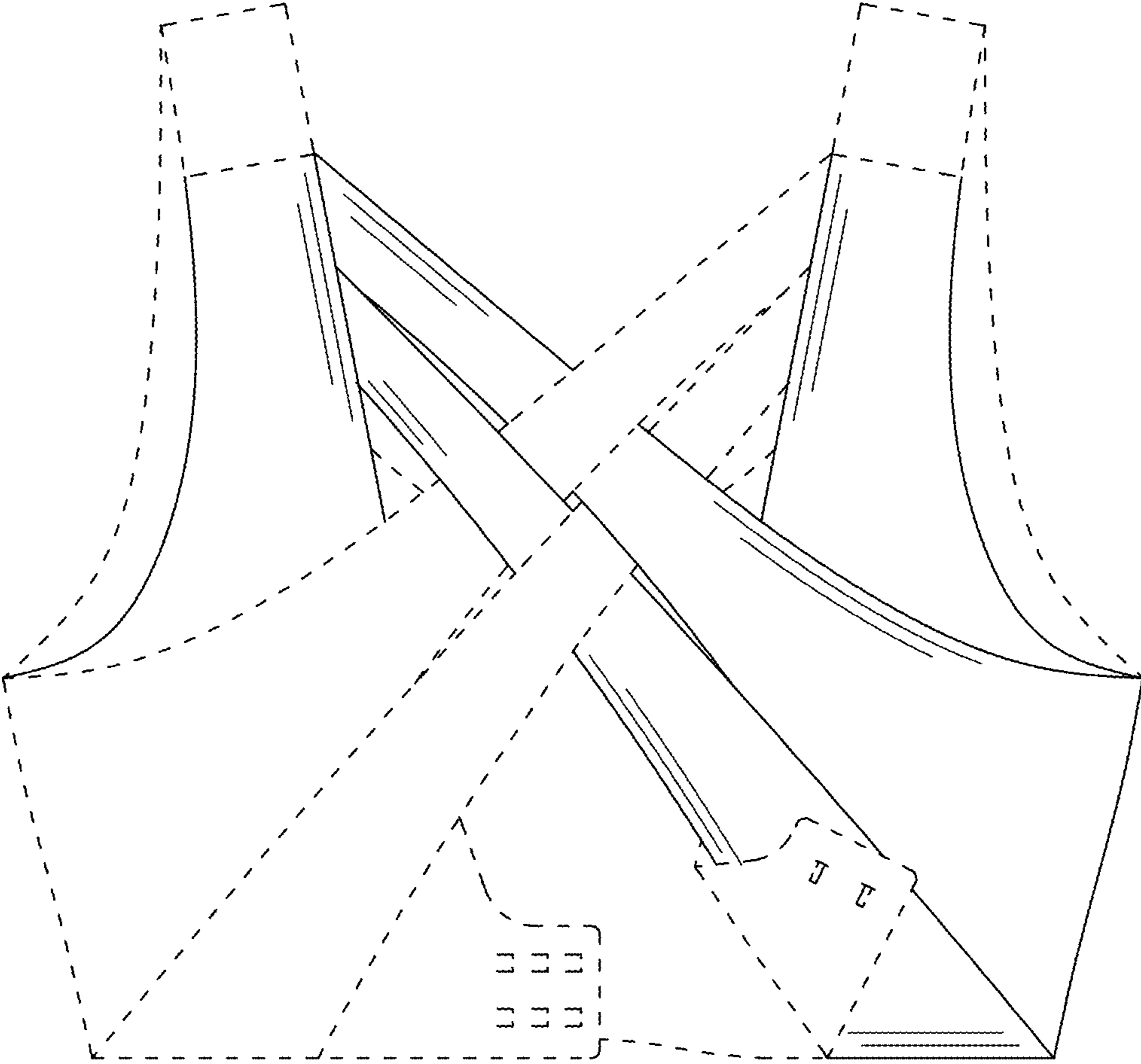

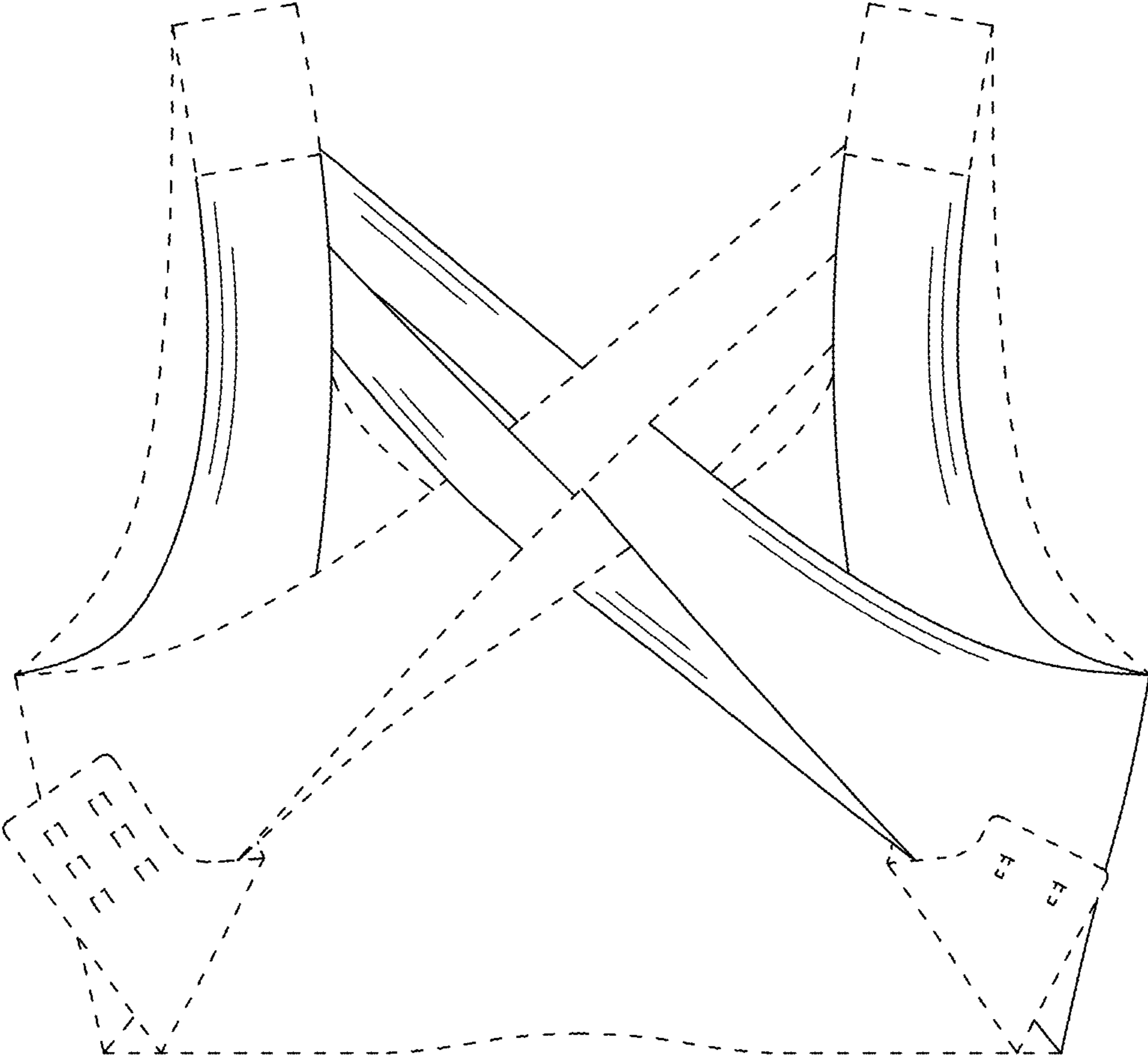
