The ornamental design for a hosiery garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hosiery garment, showing my new design.

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

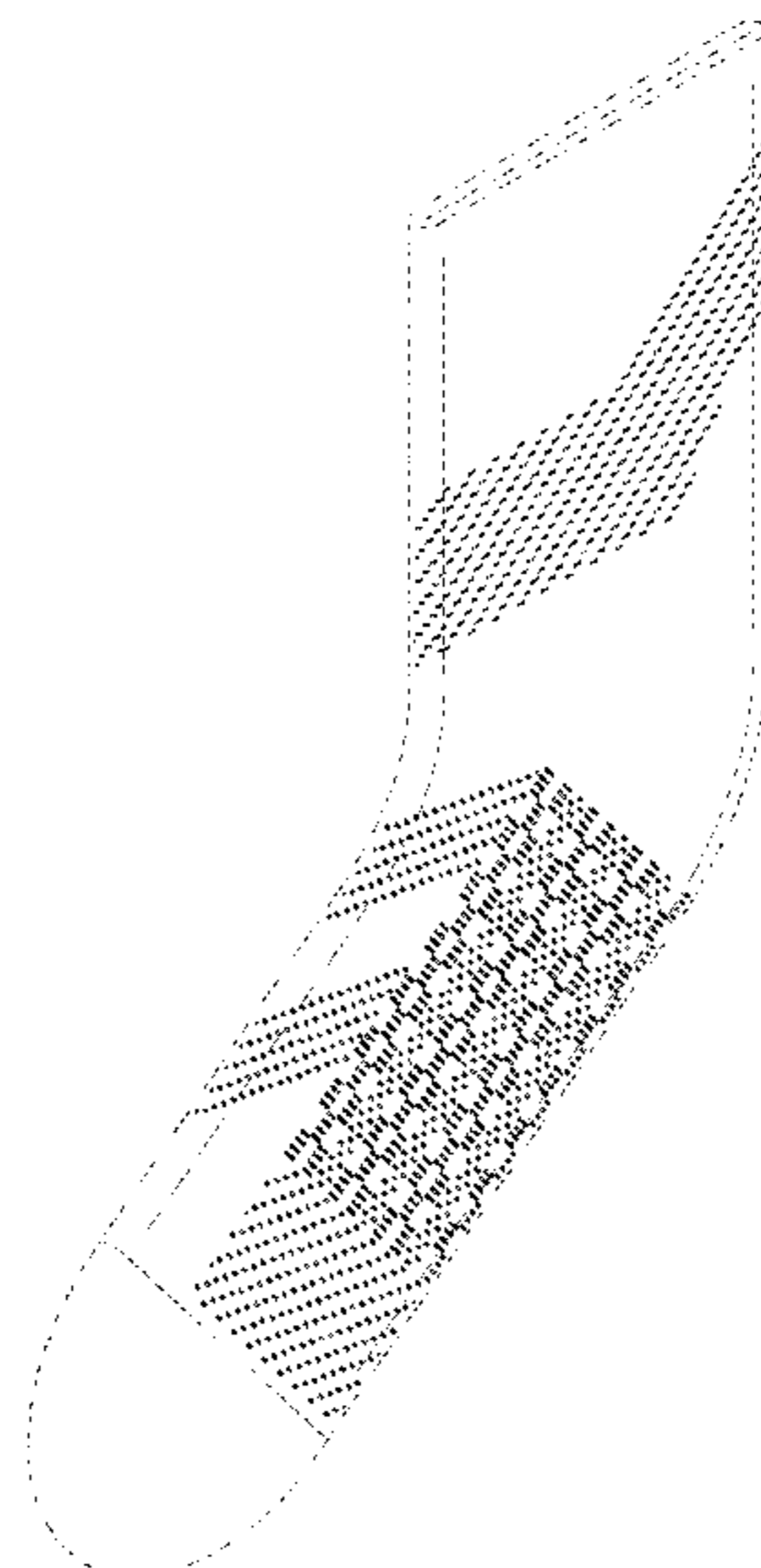
FIG. 5 is a right side elevational view thereof;

The dark dotted lines are a pattern on the surface of the sock. The dark dotted line pattern and the shaded surface area around the pattern form part of the claimed design. The lighter dotted lines at the perimeter and across the toe cap form no part of the claimed design.

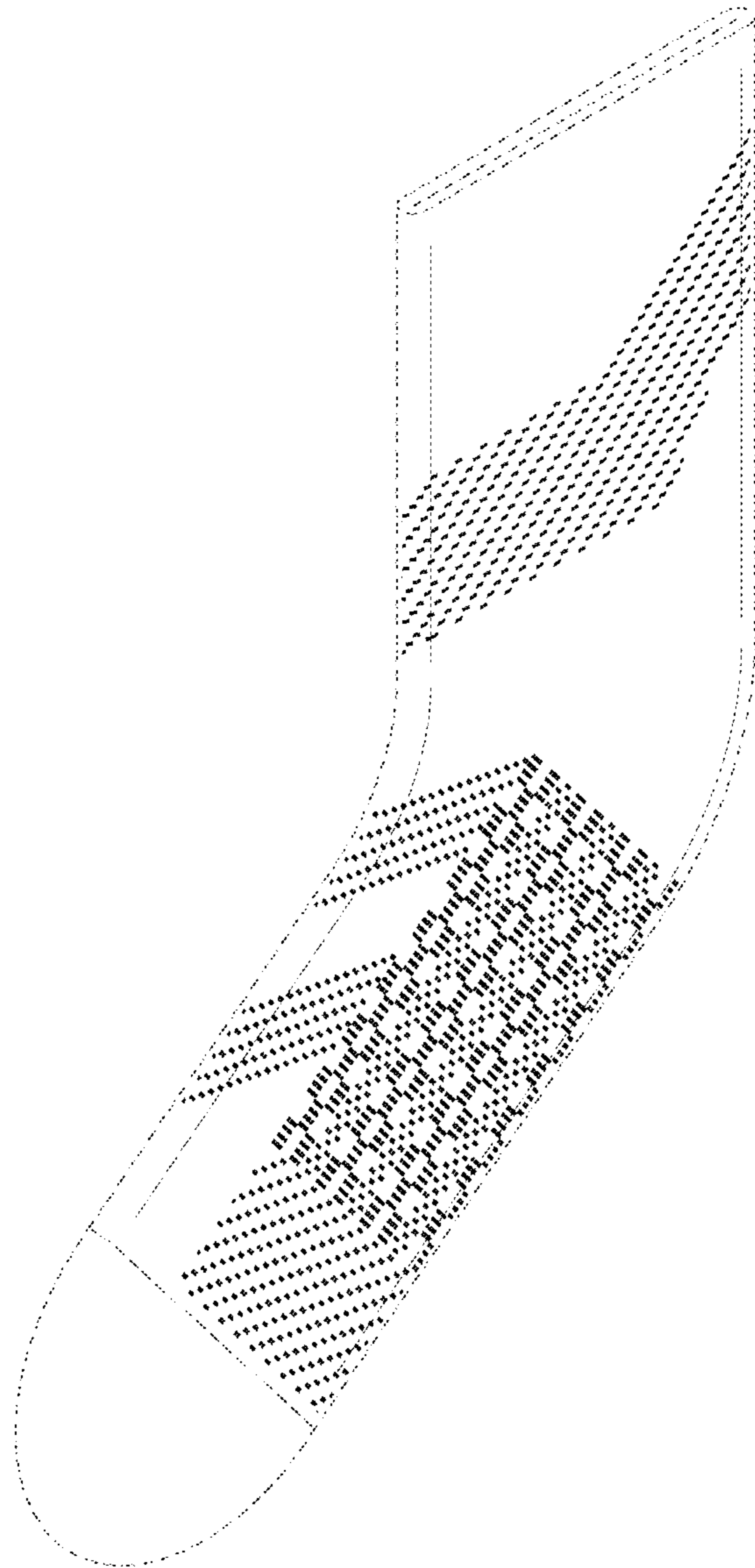

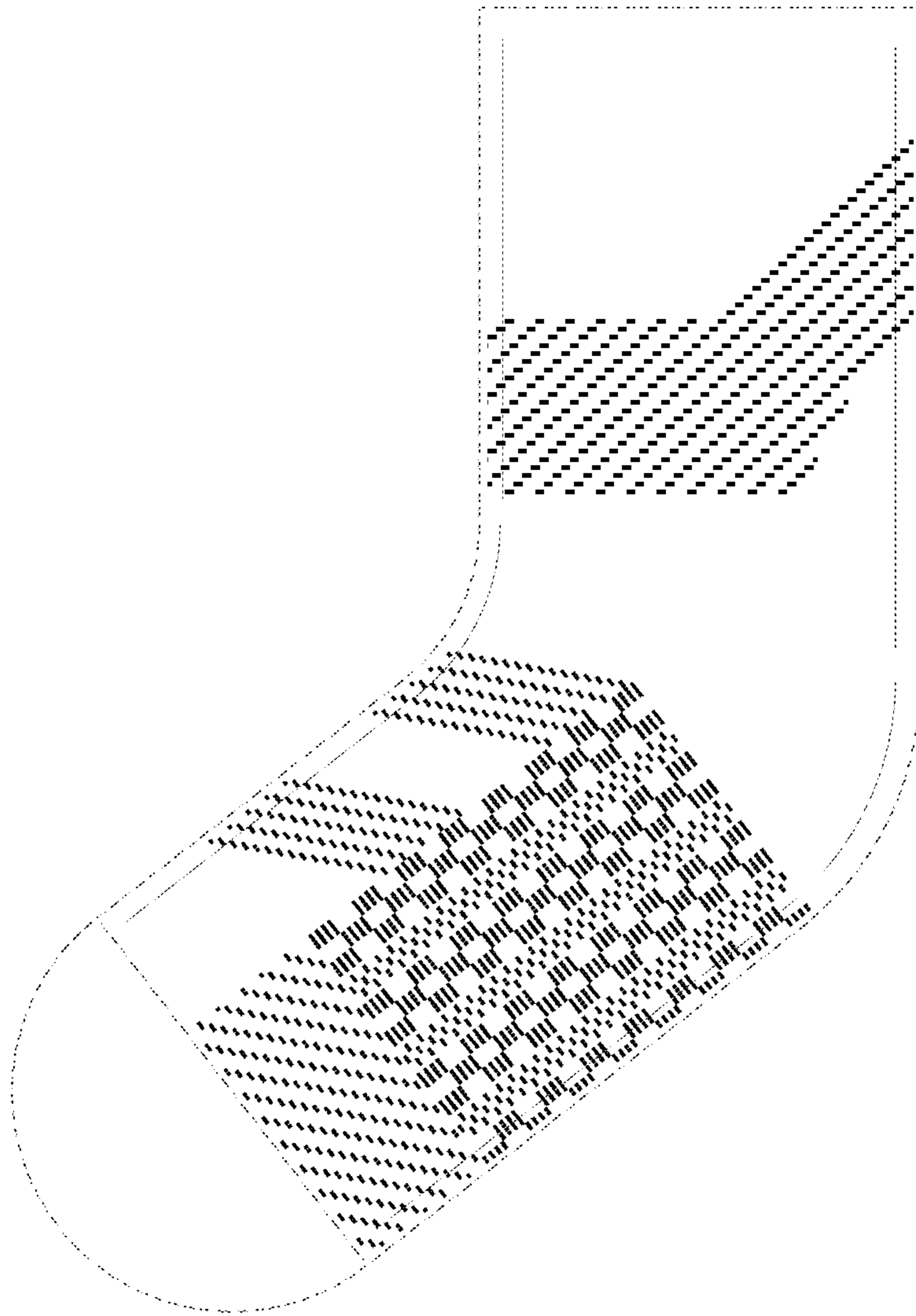

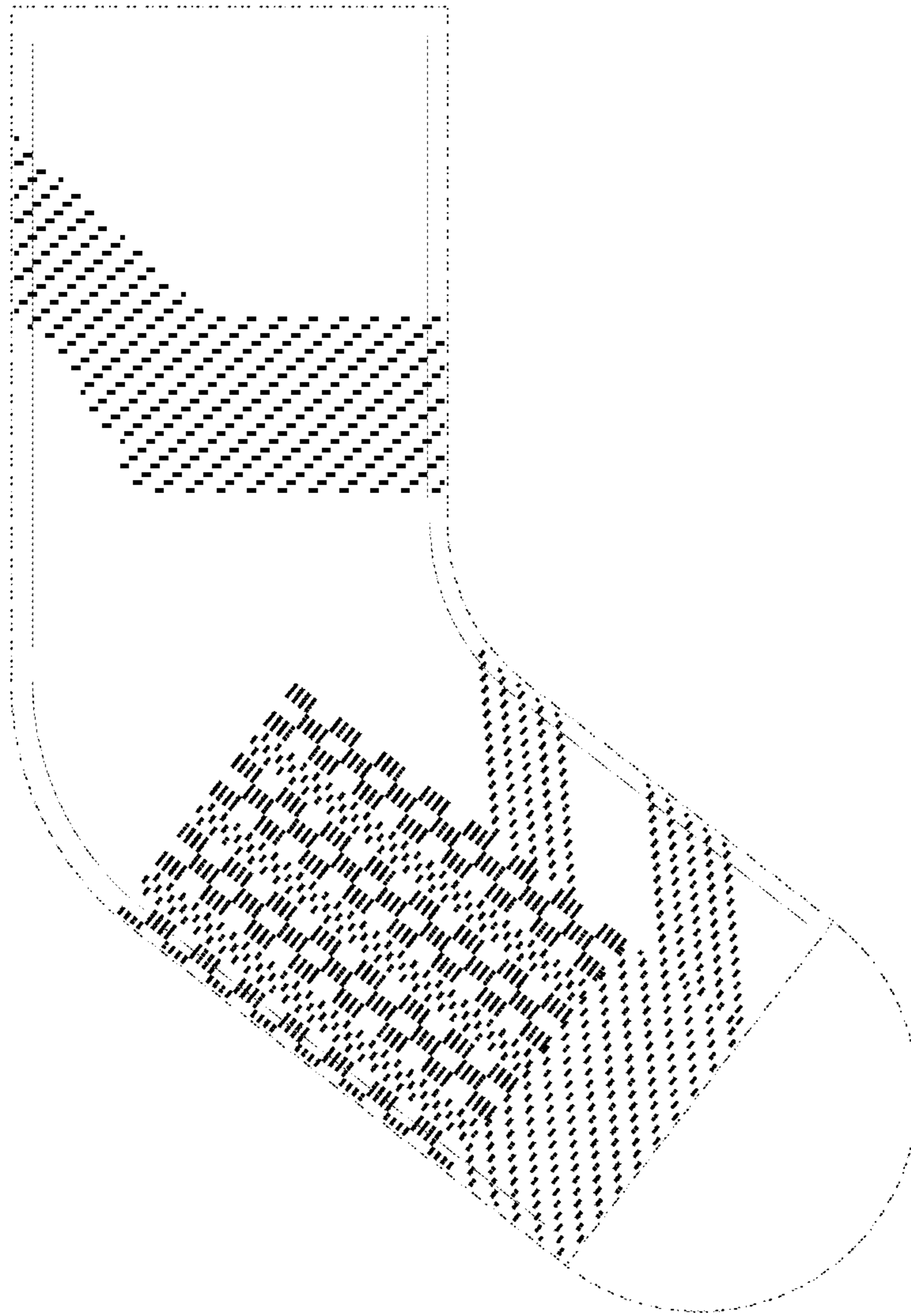

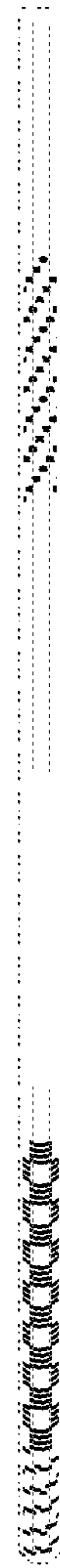
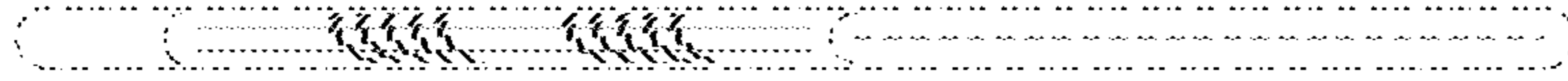
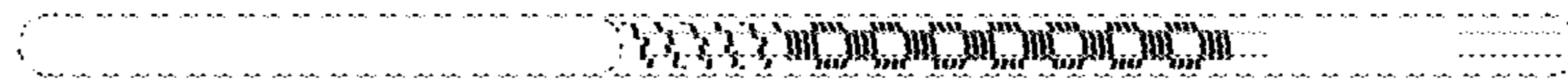
