(57) **CLAIM**

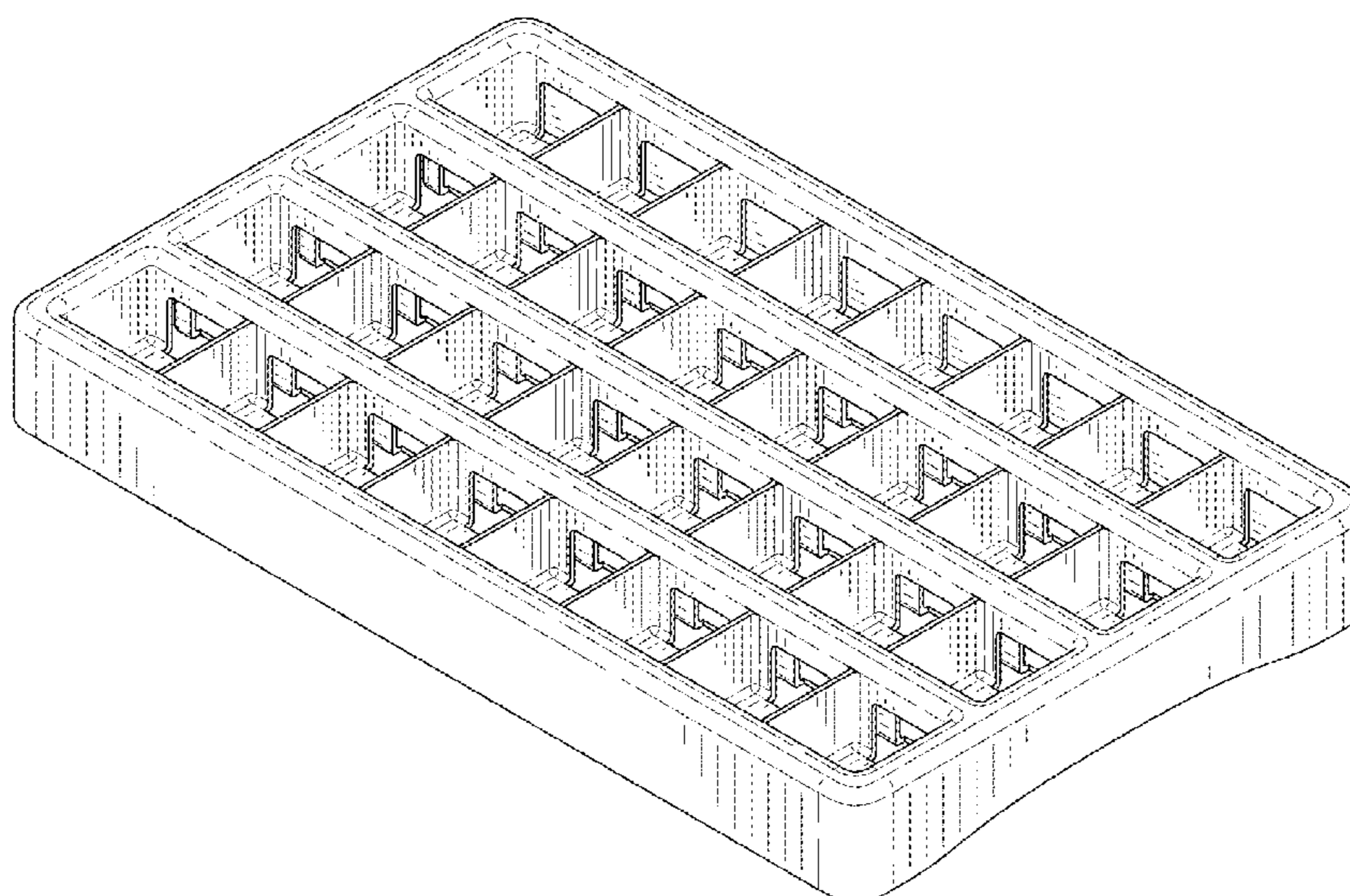
The ornamental design for a pill box organizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of an ornamental design for a pill box organizer showing my new design;  
FIG. 2 is a rear and right side perspective view of the pill box organizer;  
FIG. 3 is a front view of the pill box organizer;  
FIG. 4 is a rear view of the pill box organizer;  
FIG. 5 is a left side view of the pill box organizer;

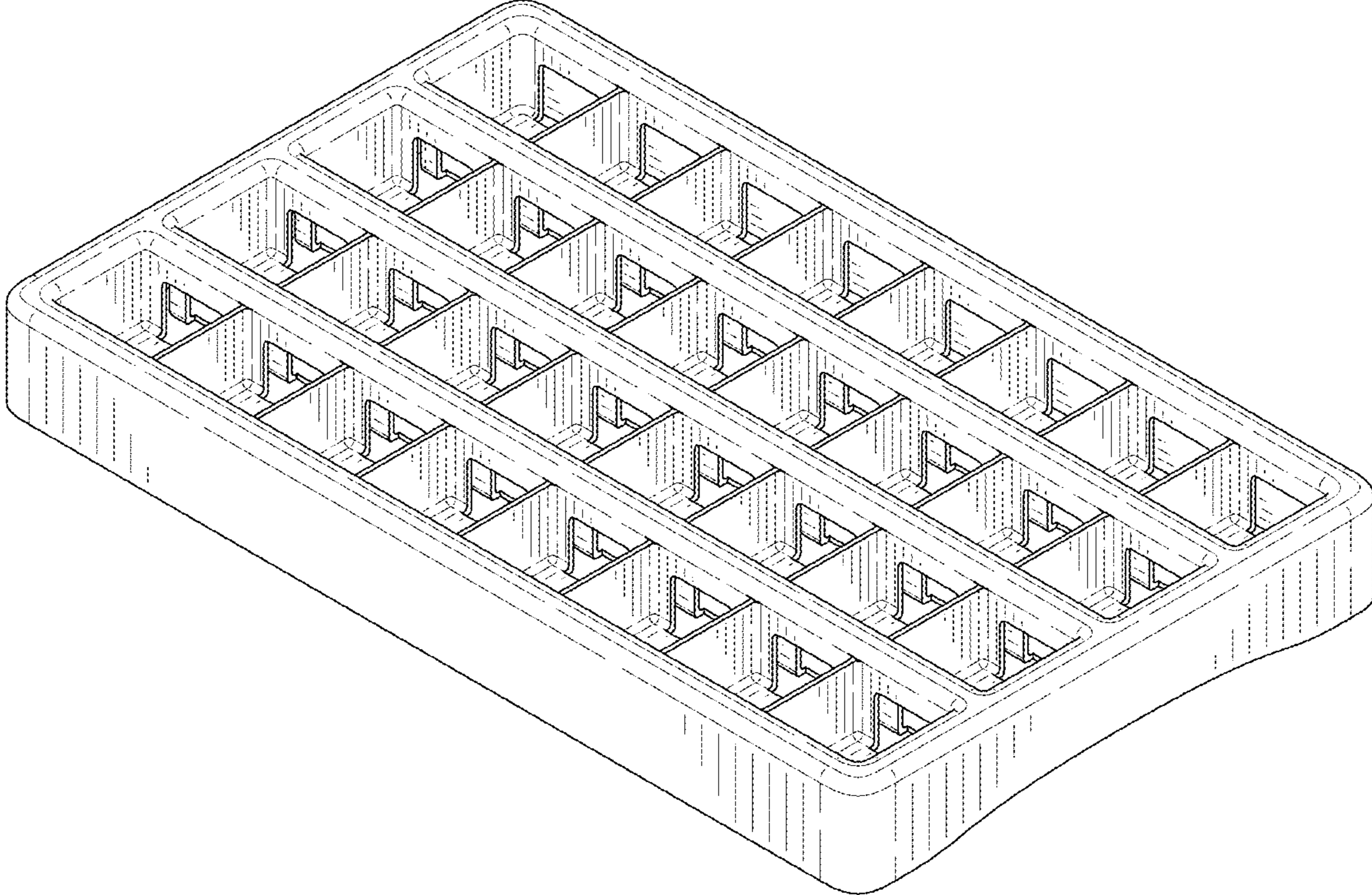

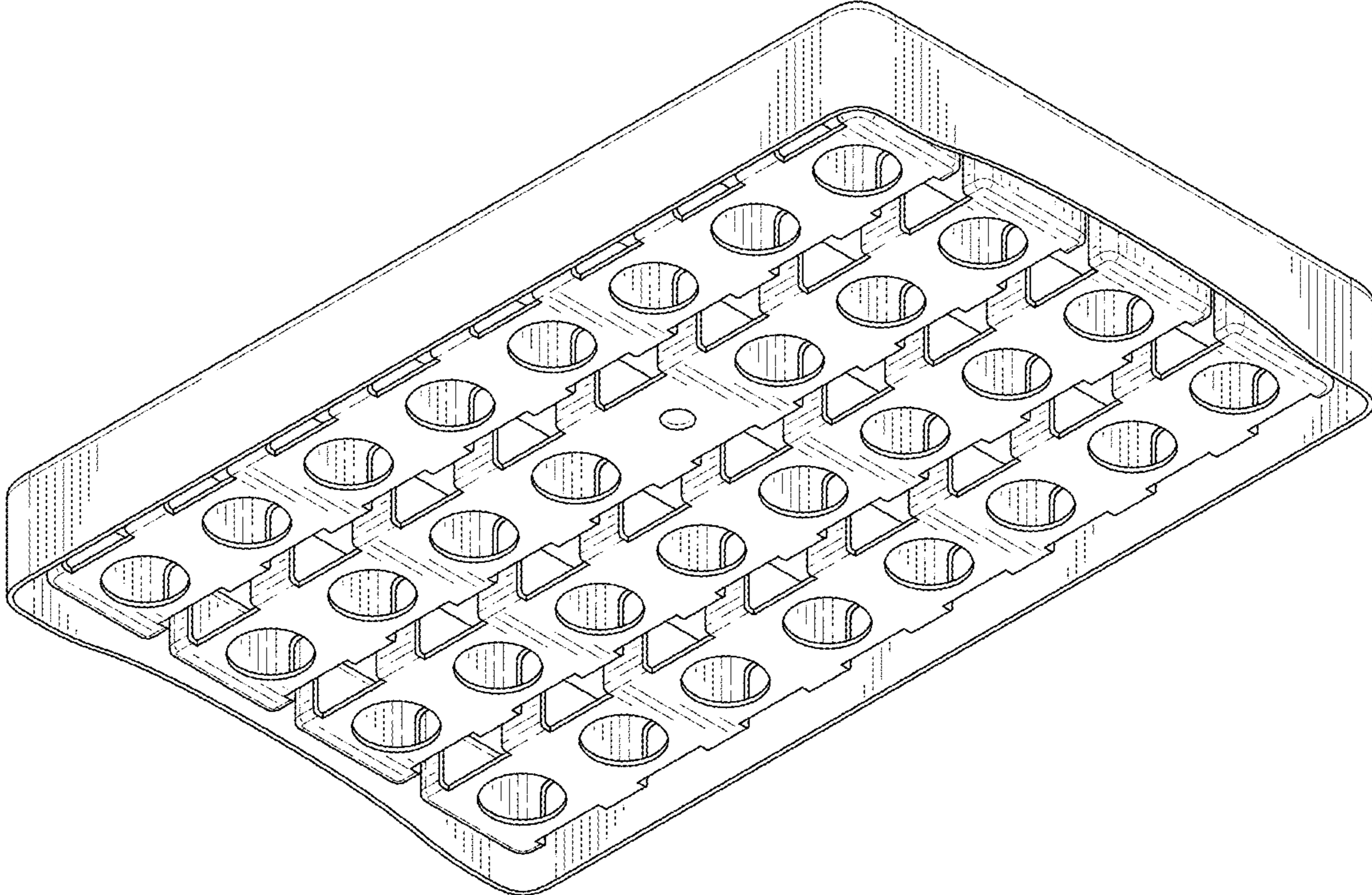

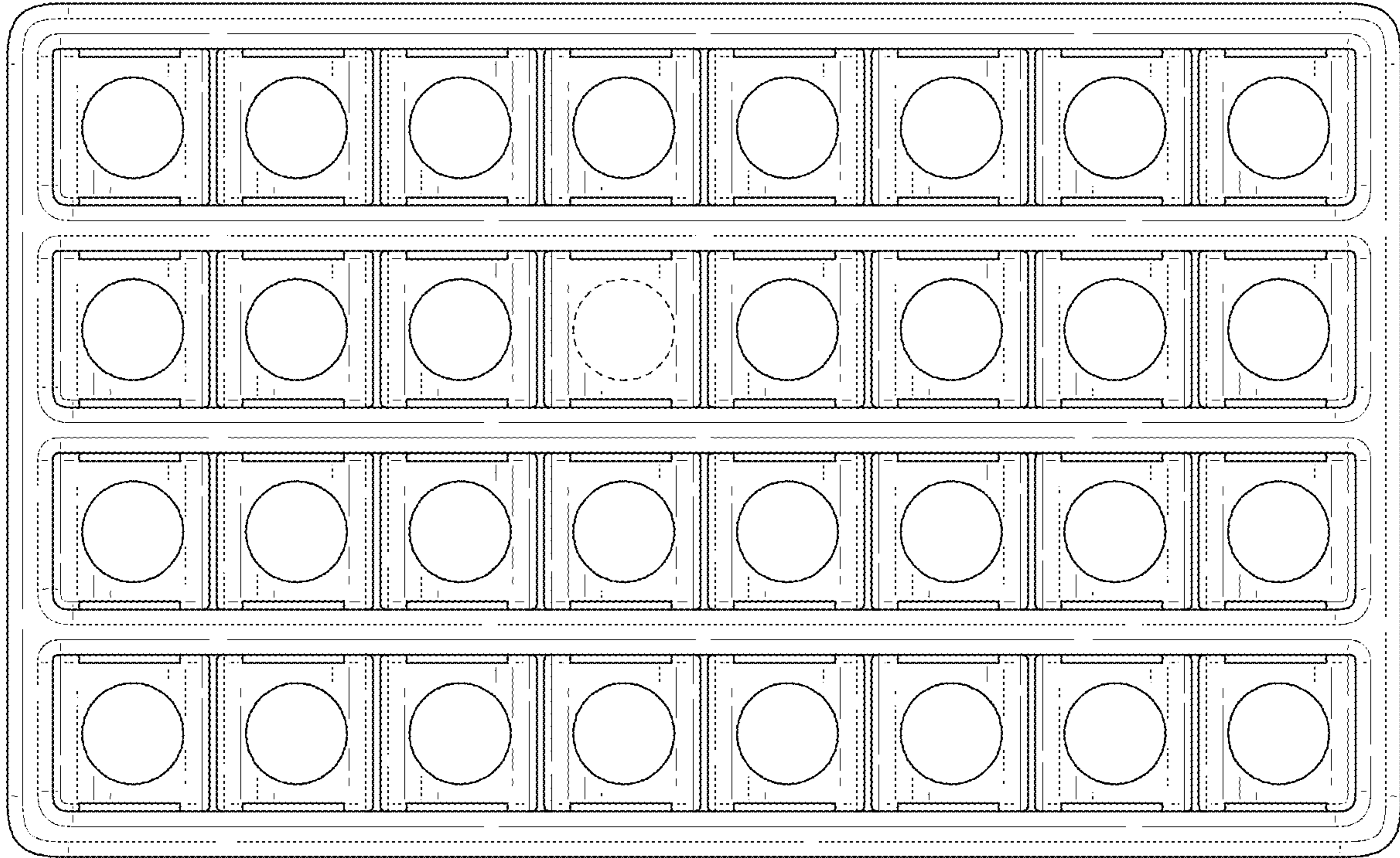

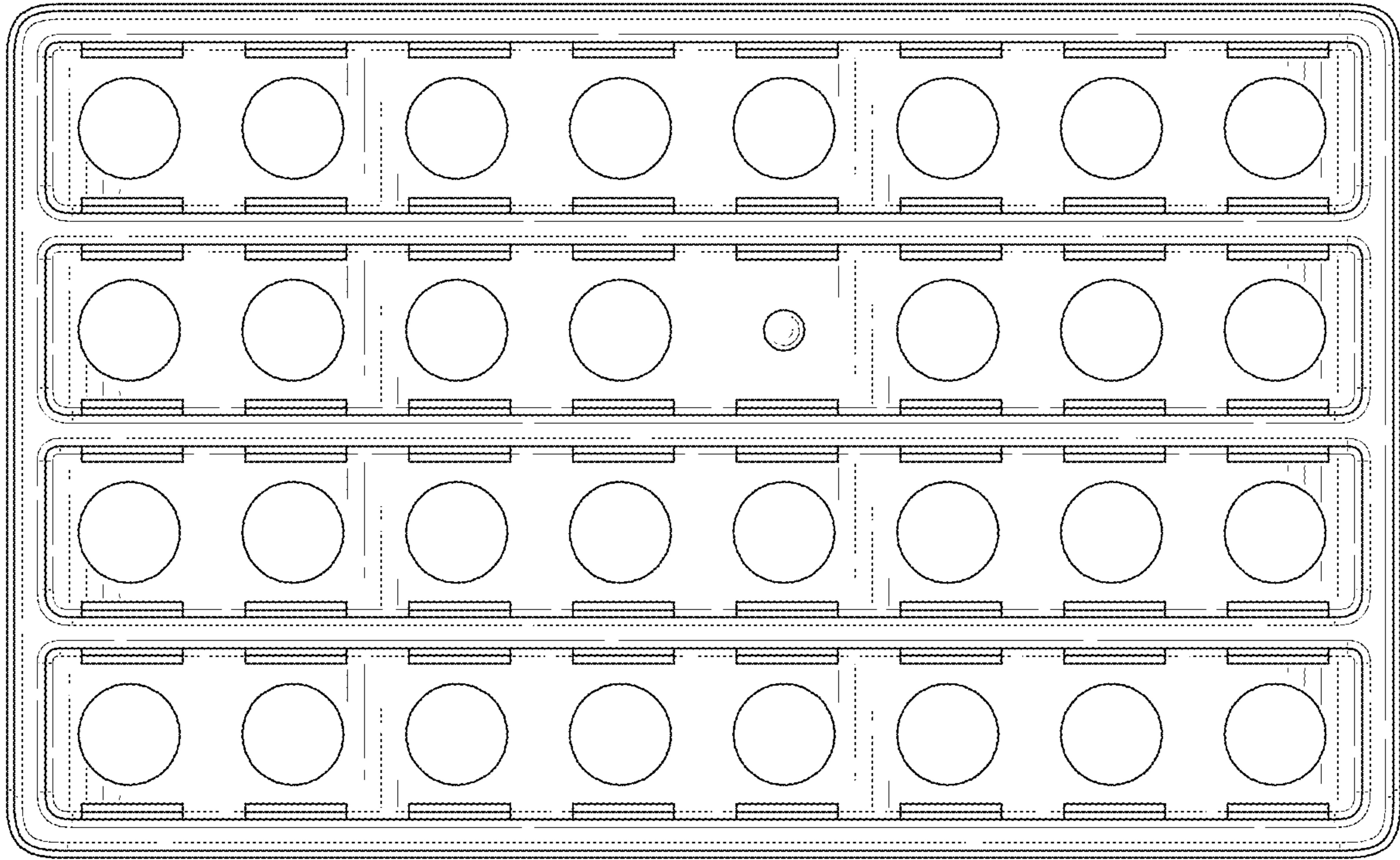

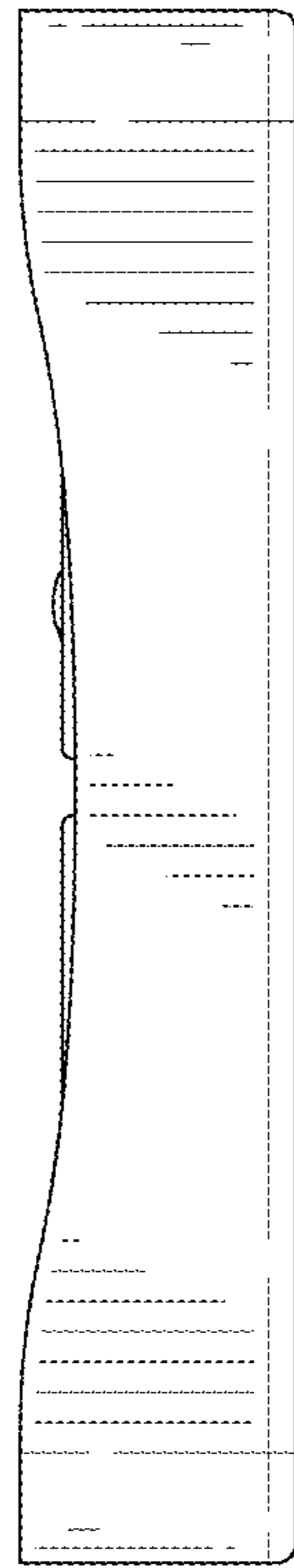

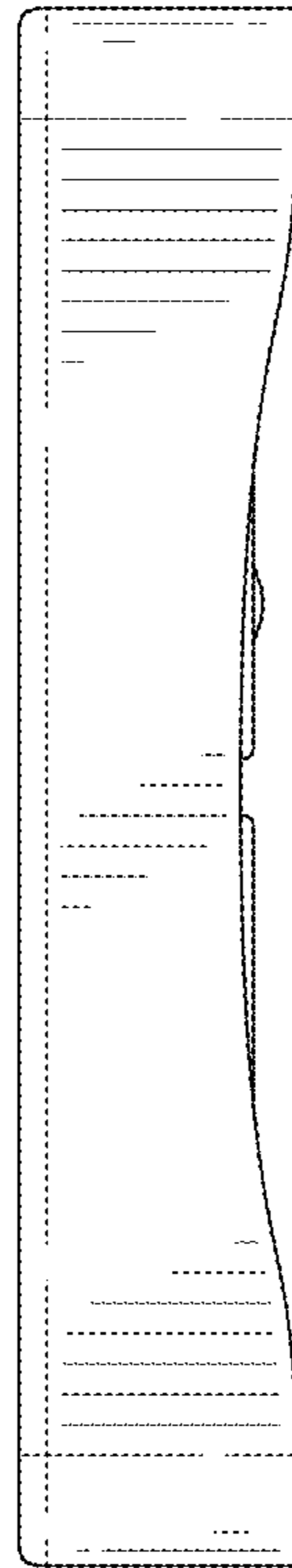

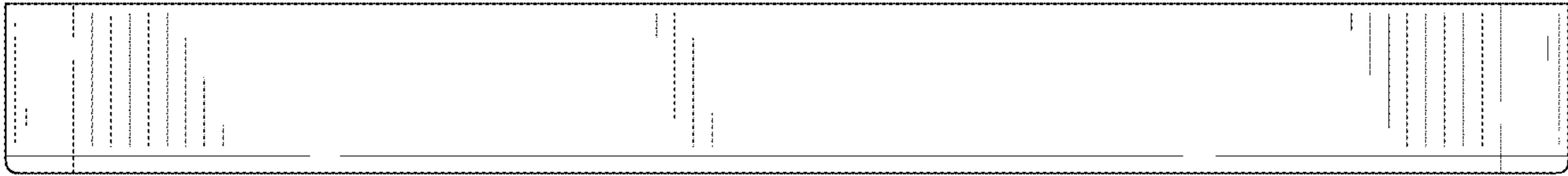

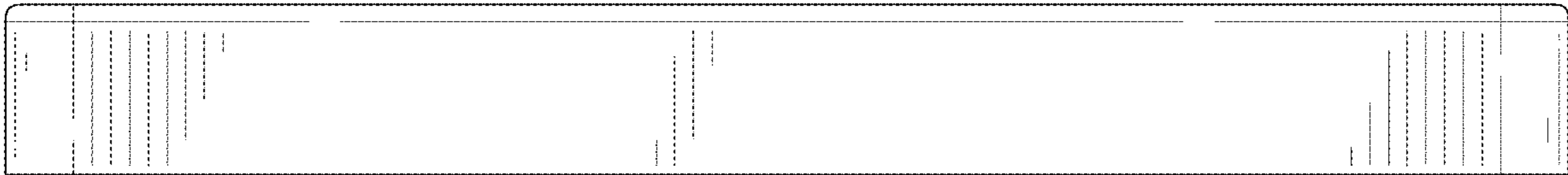
