FIG. 9 is a front perspective view of the carrying case or cover for a seat cushion of FIG. 1 shown in a second inverted folded configuration.

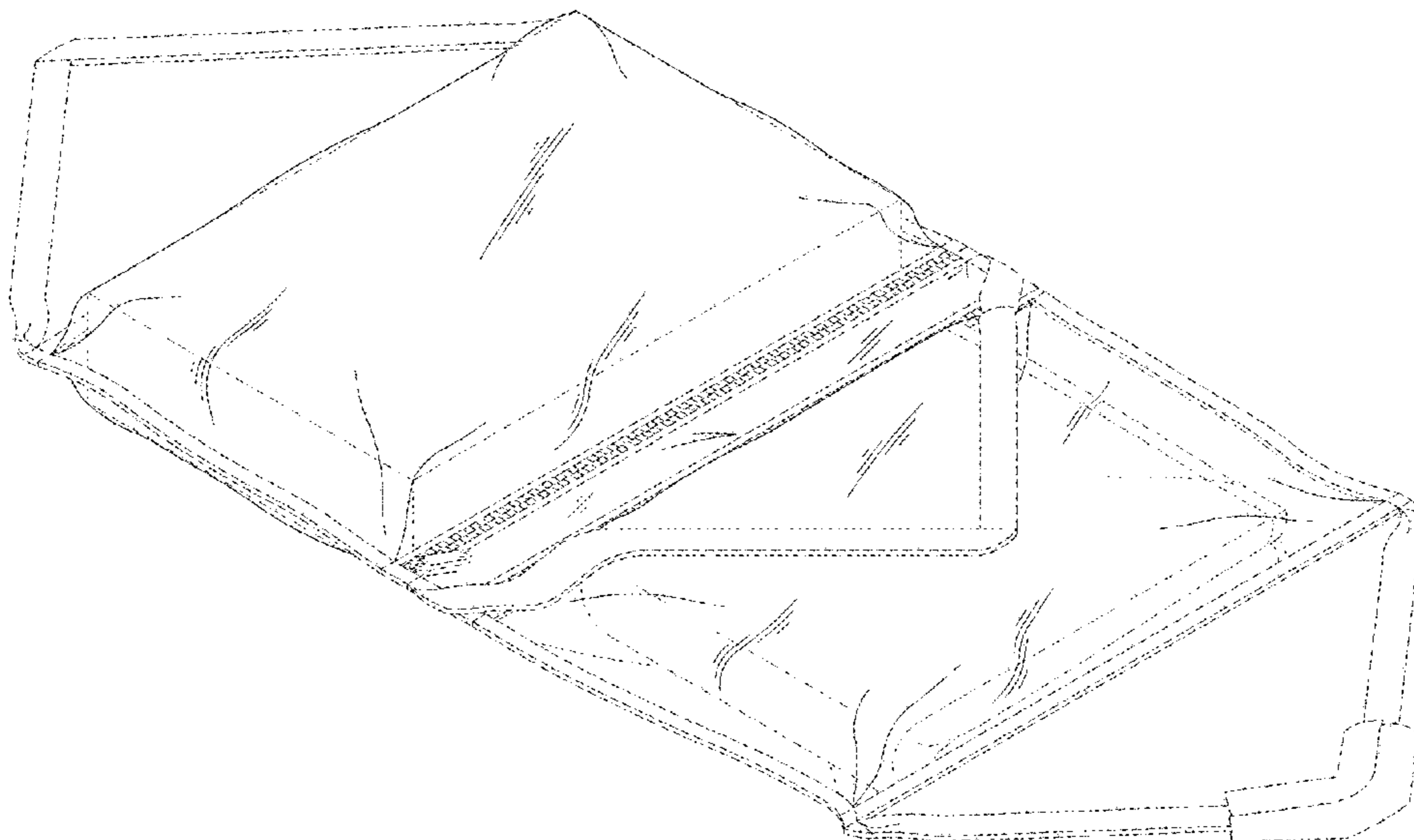

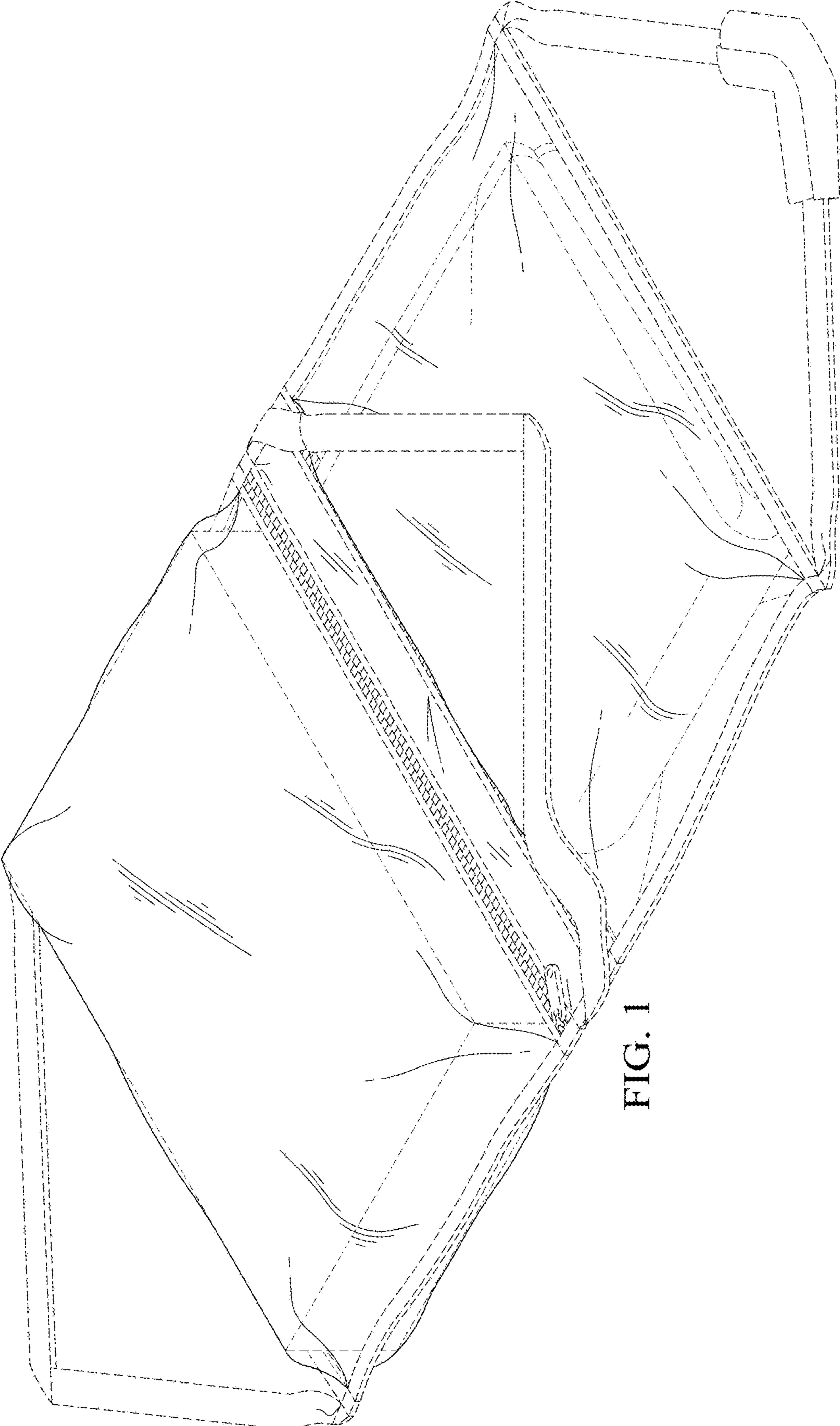

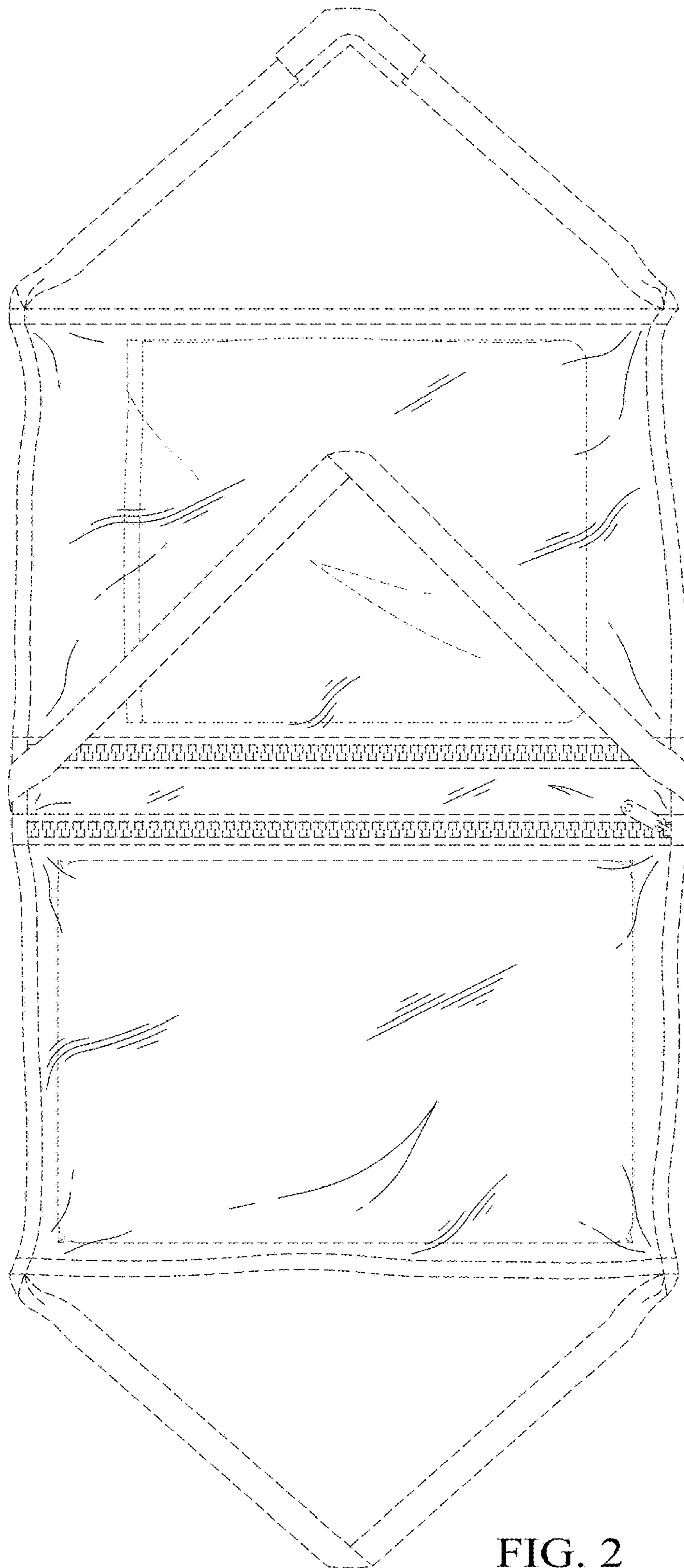

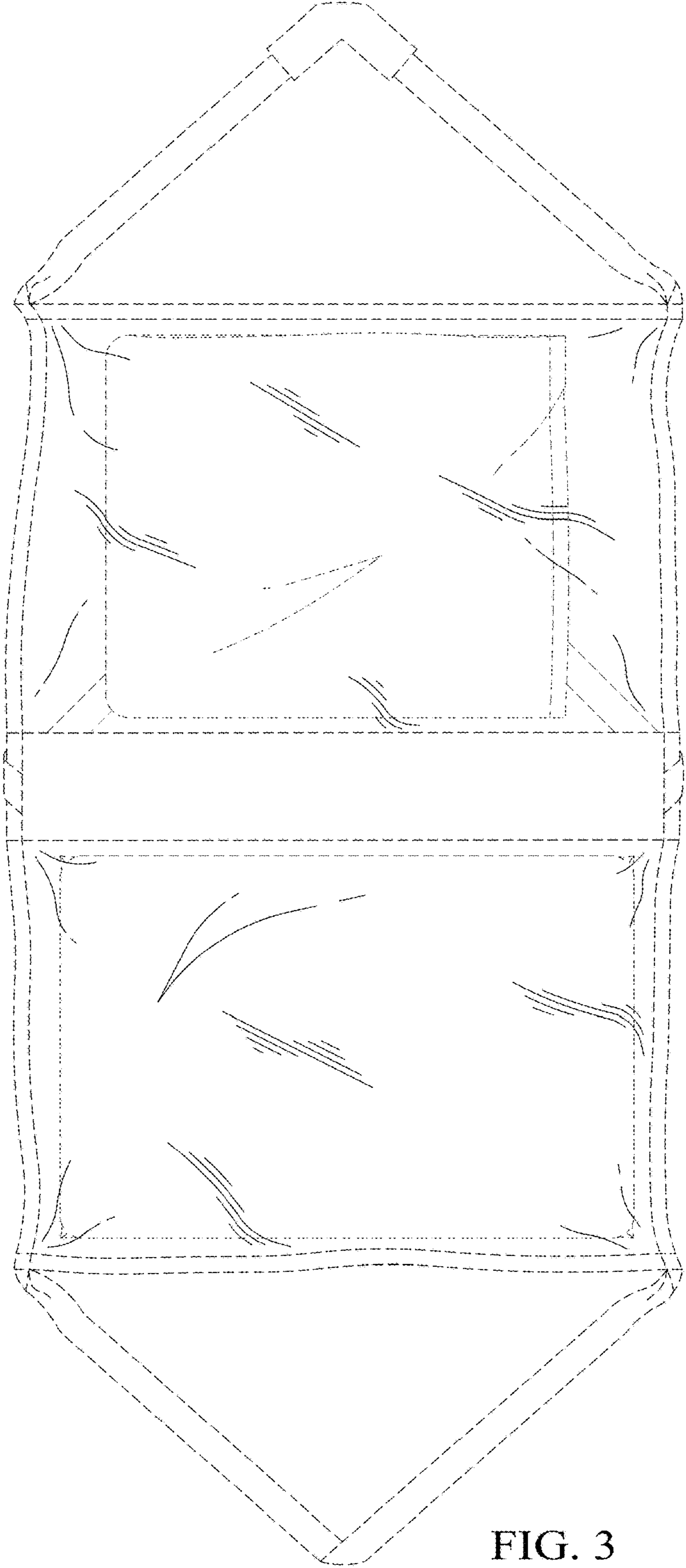

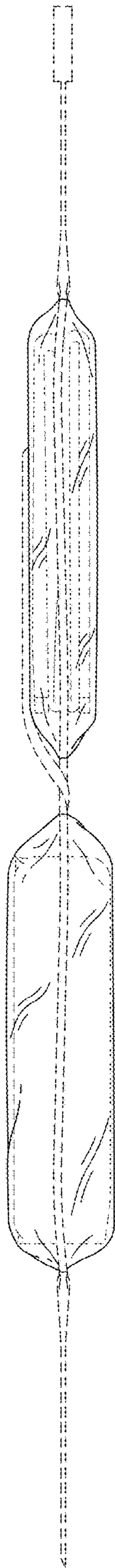

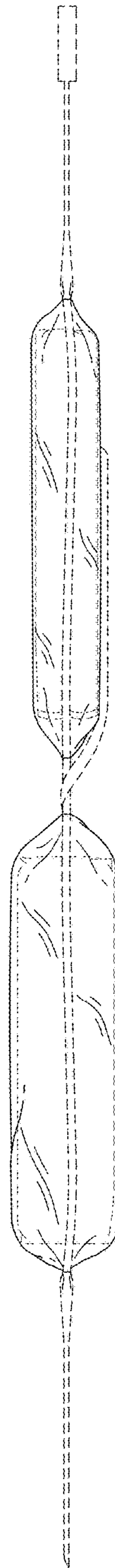

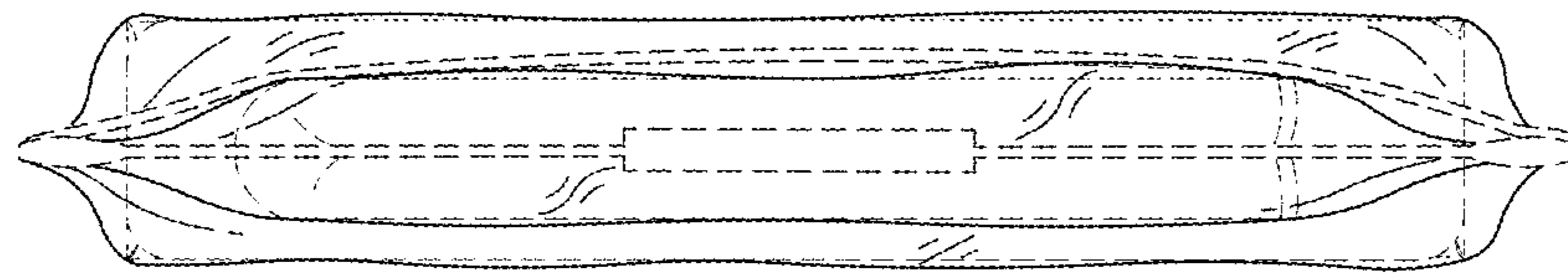

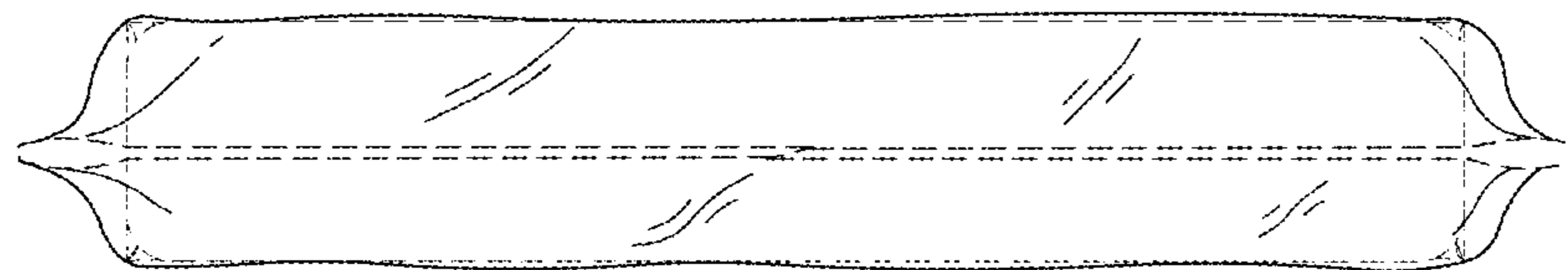

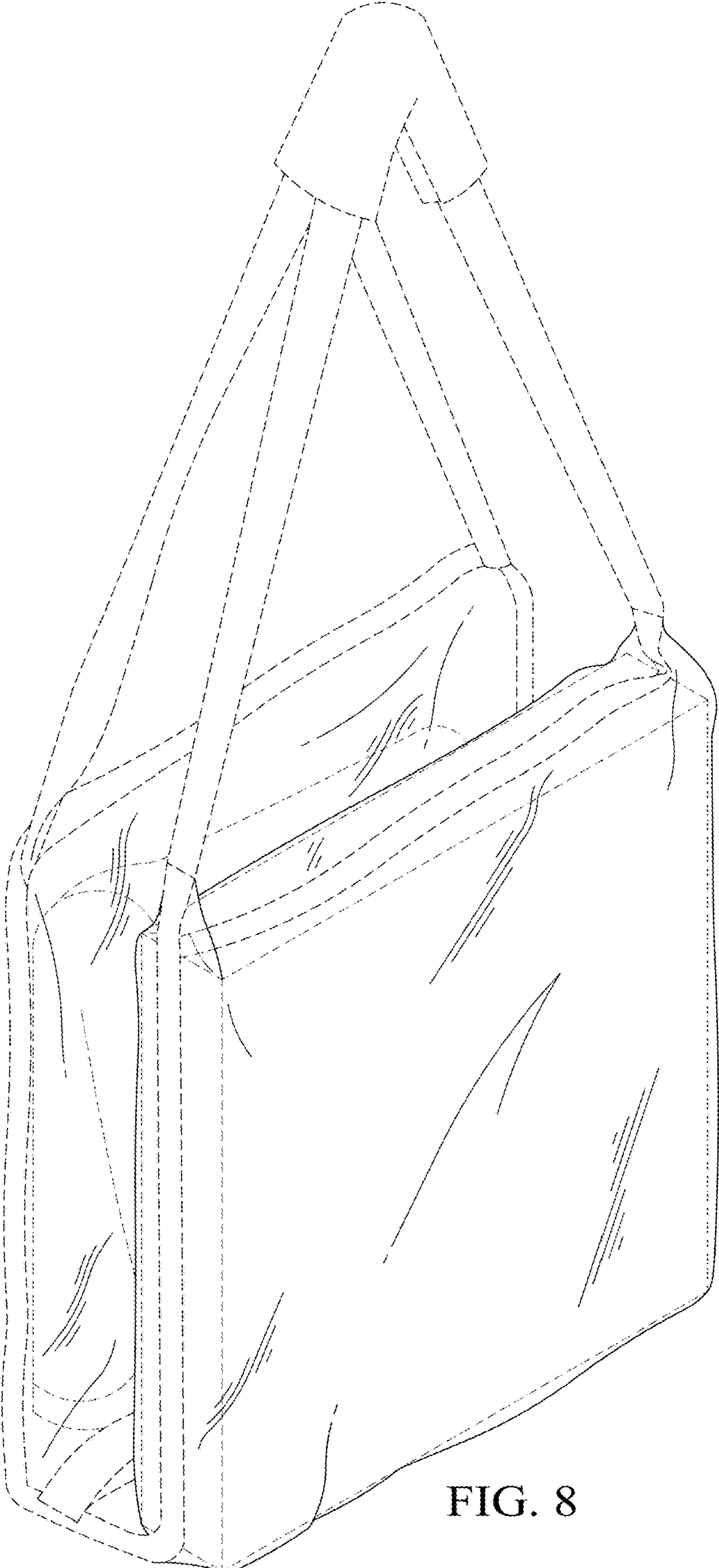

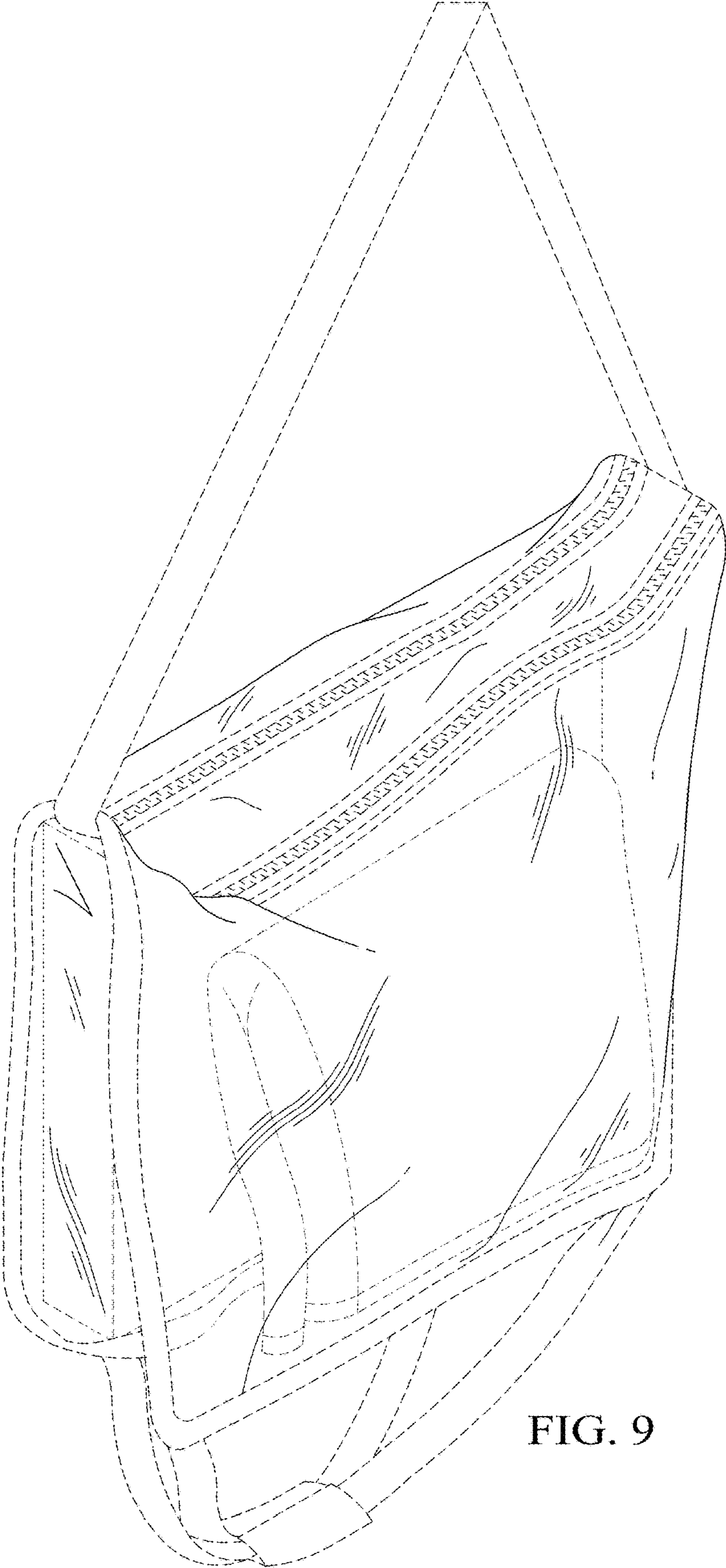
