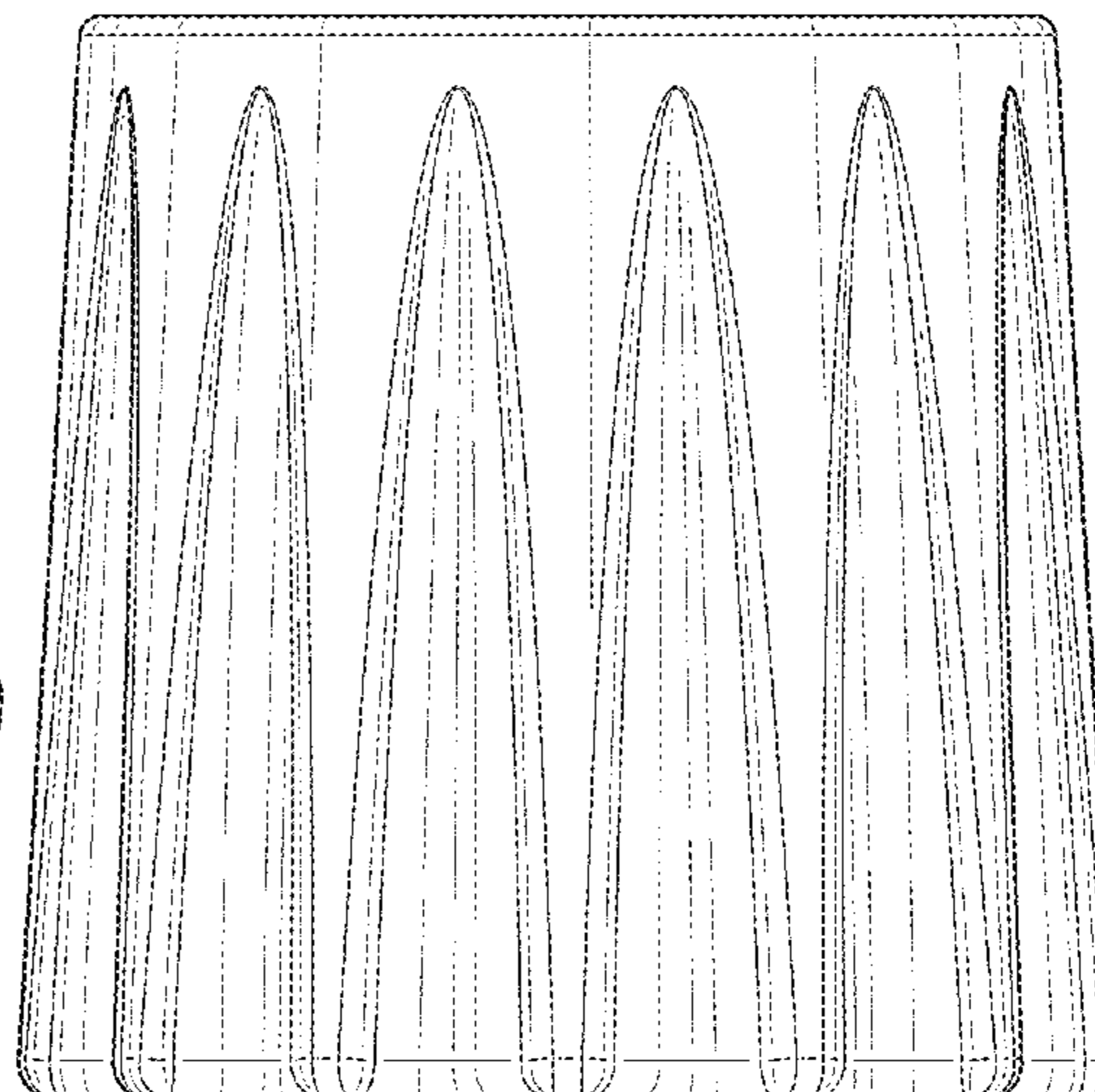
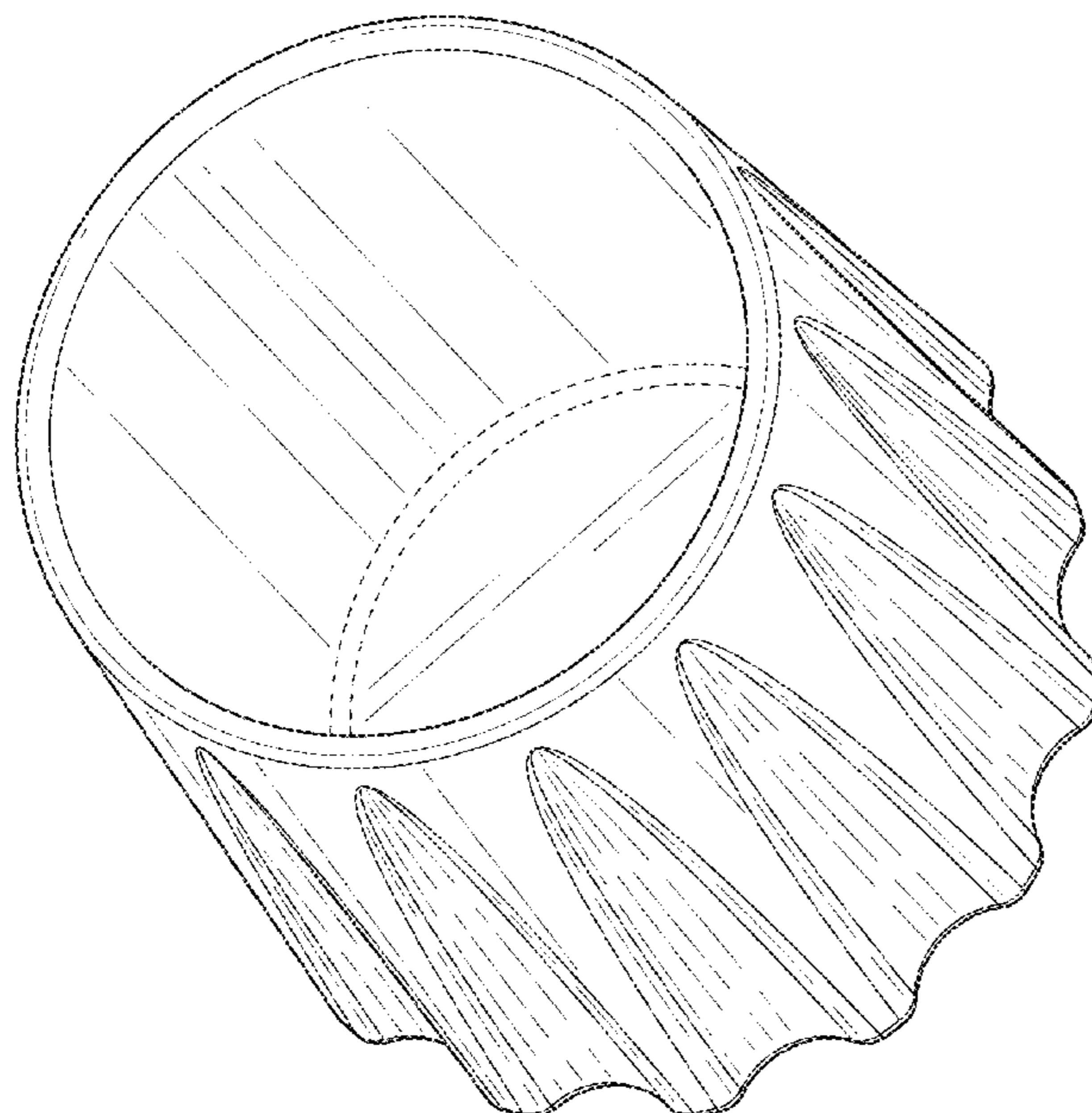
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a cup according to our new design;  
FIG. 2 is a front view of the cup of FIG. 1;  
FIG. 3 is a rear view of the cup of FIG. 1;  
FIG. 4 is a left side view of the cup of FIG. 1;  
FIG. 5 is a right side view of the cup of FIG. 1;  
FIG. 6 is a top view of the cup of FIG. 1; and,  
FIG. 7 is a bottom view of the cup of FIG. 1.  
The broken lines shown in FIGS. 1, 6, and 7 illustrate portions of the cup which form no part of the claimed design.

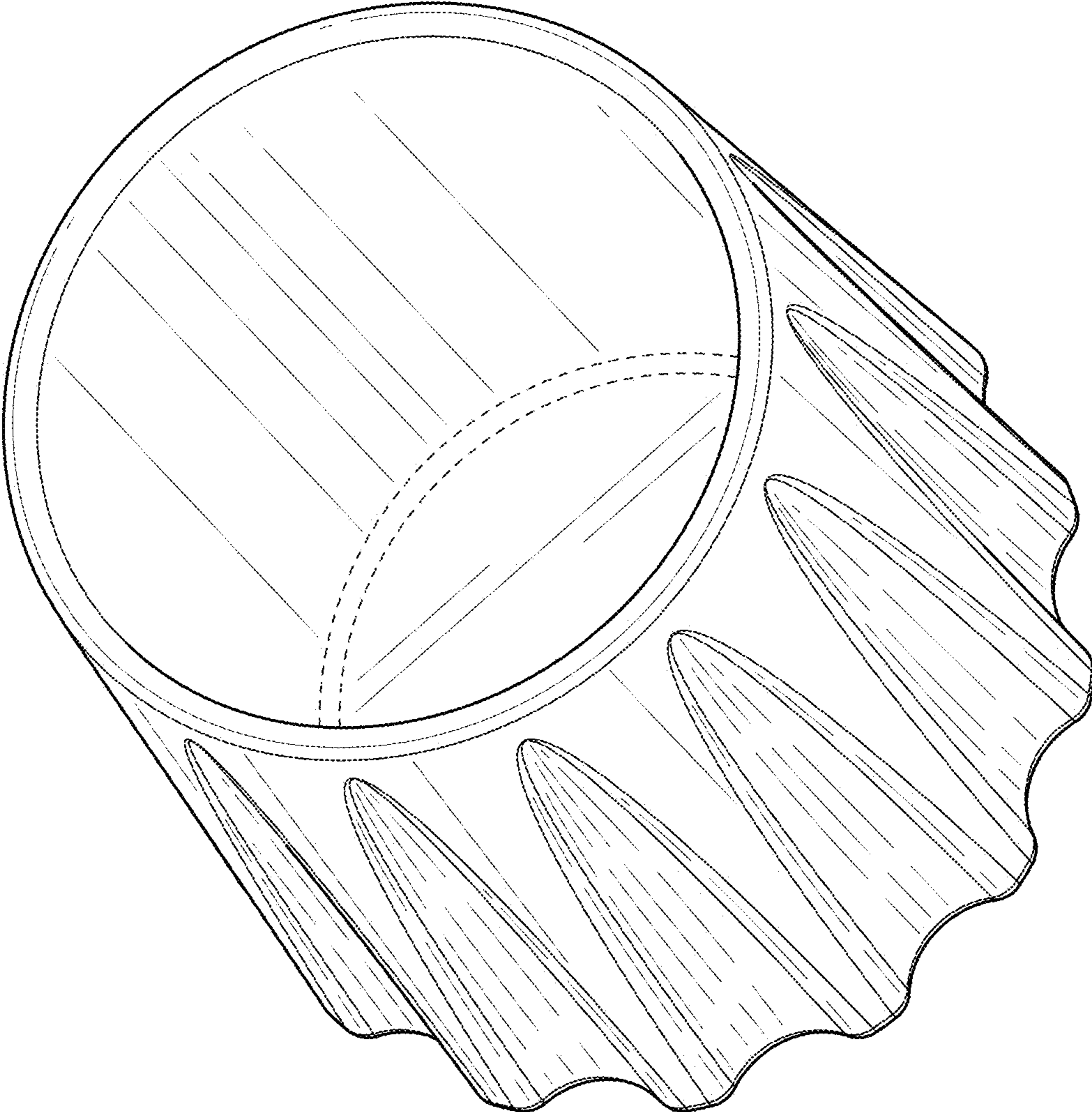

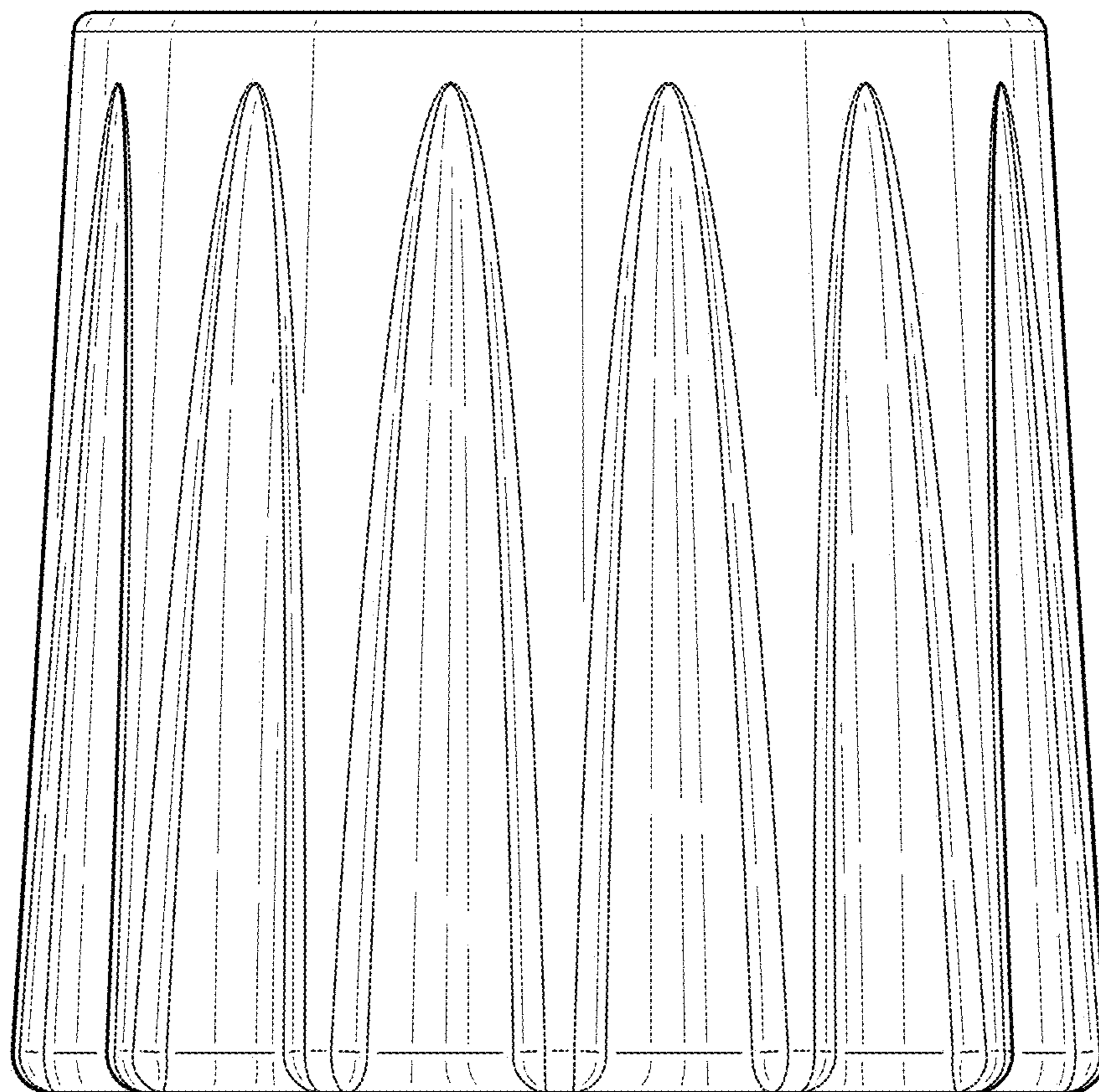

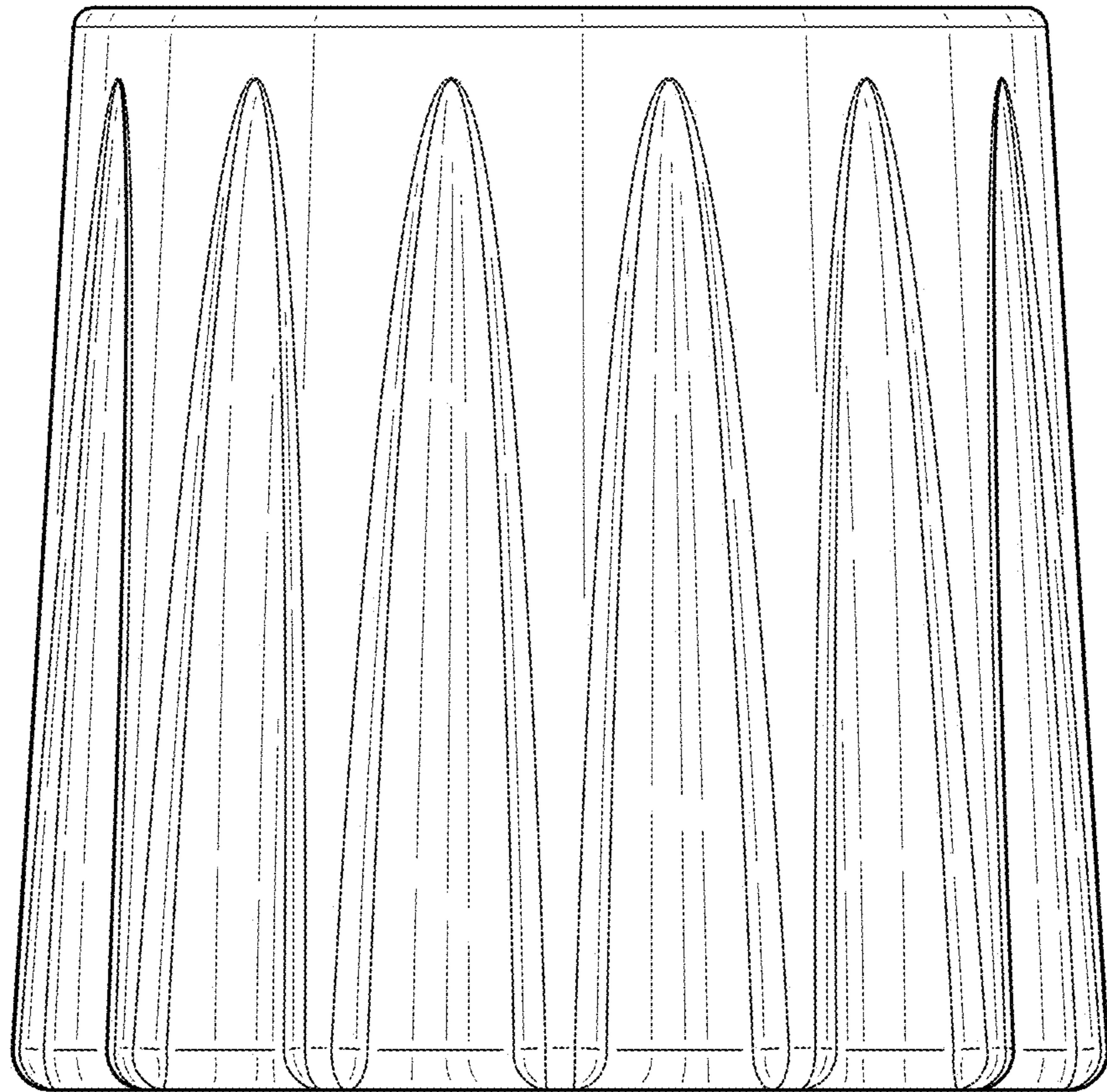

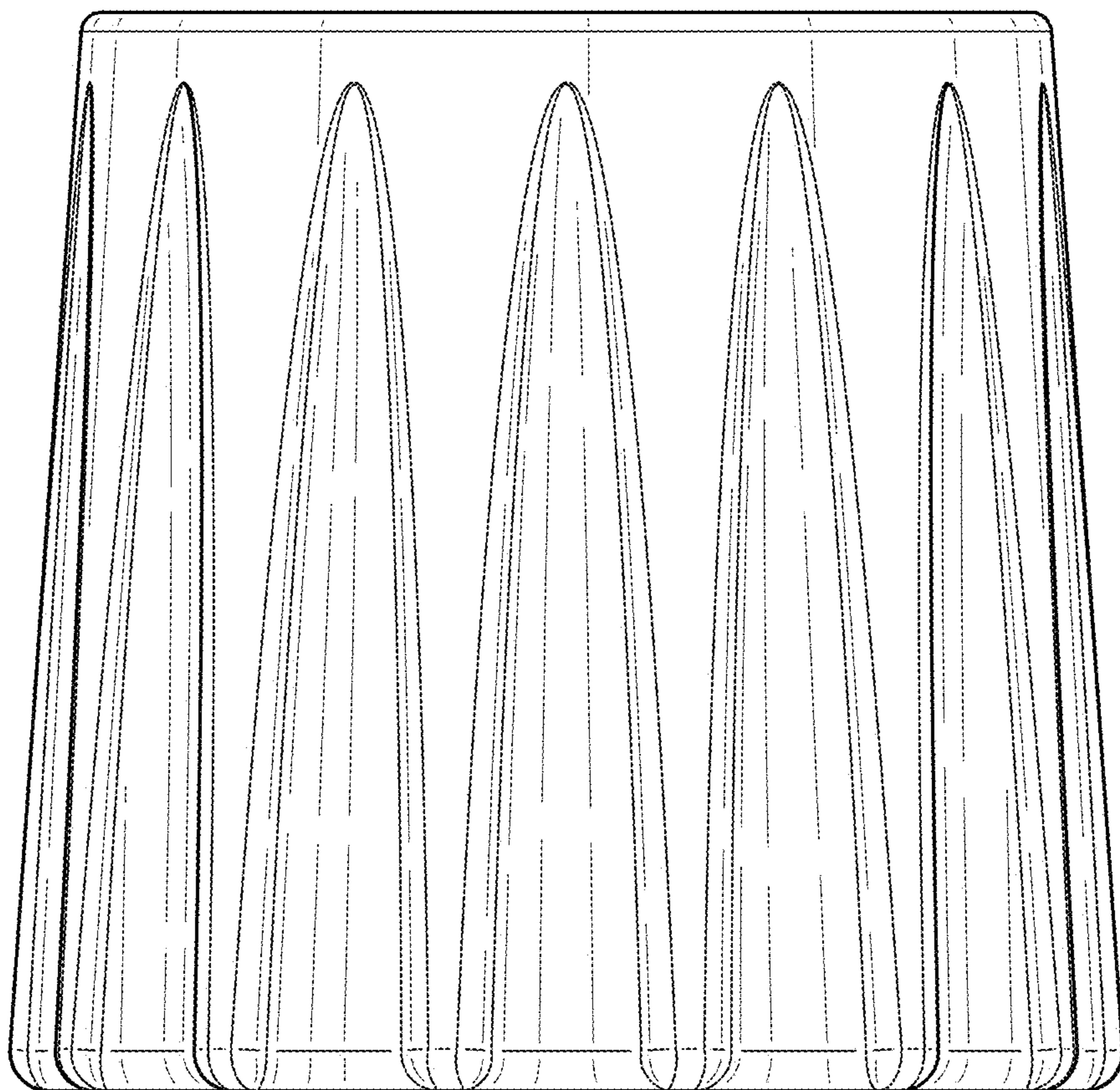

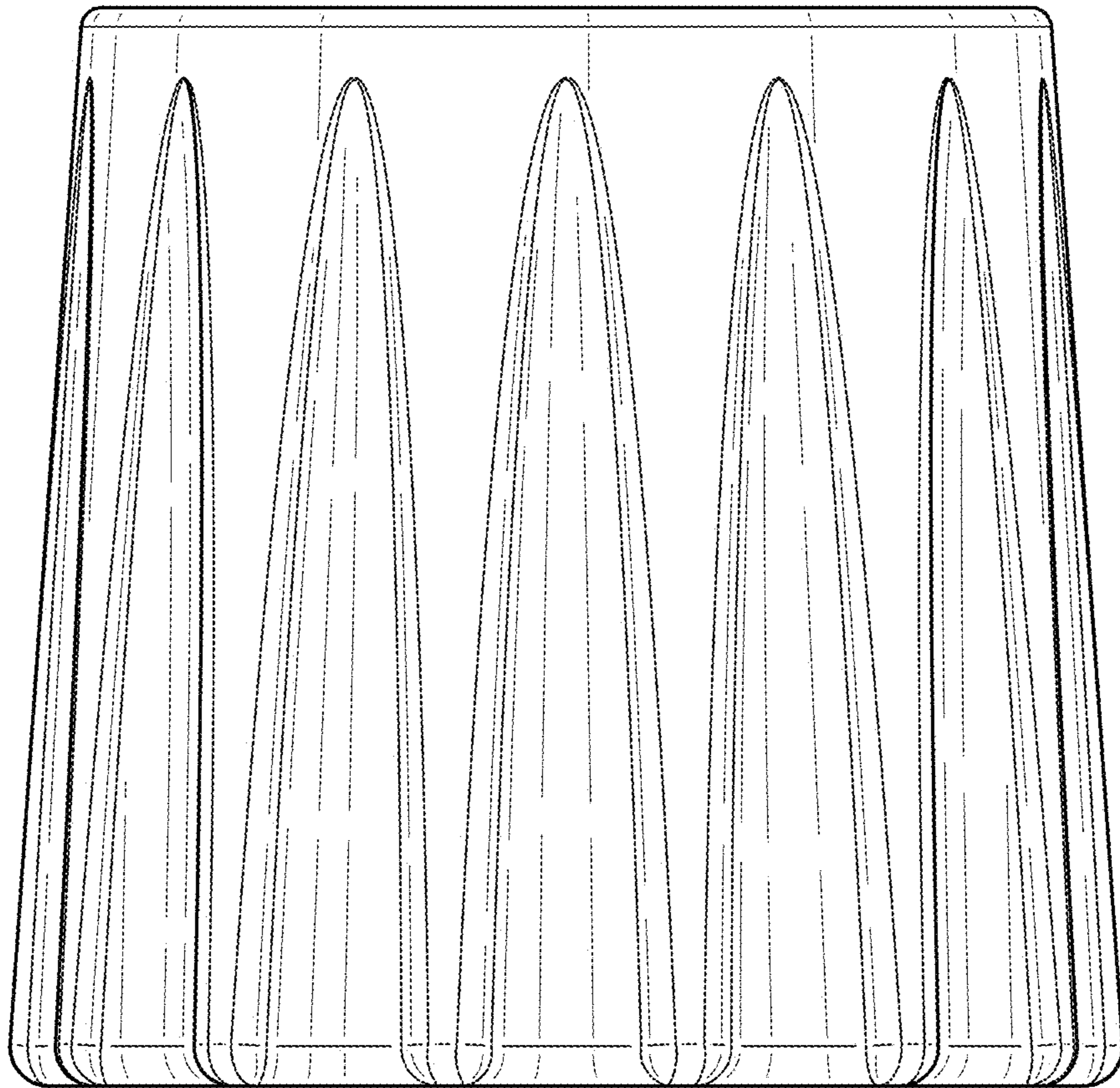

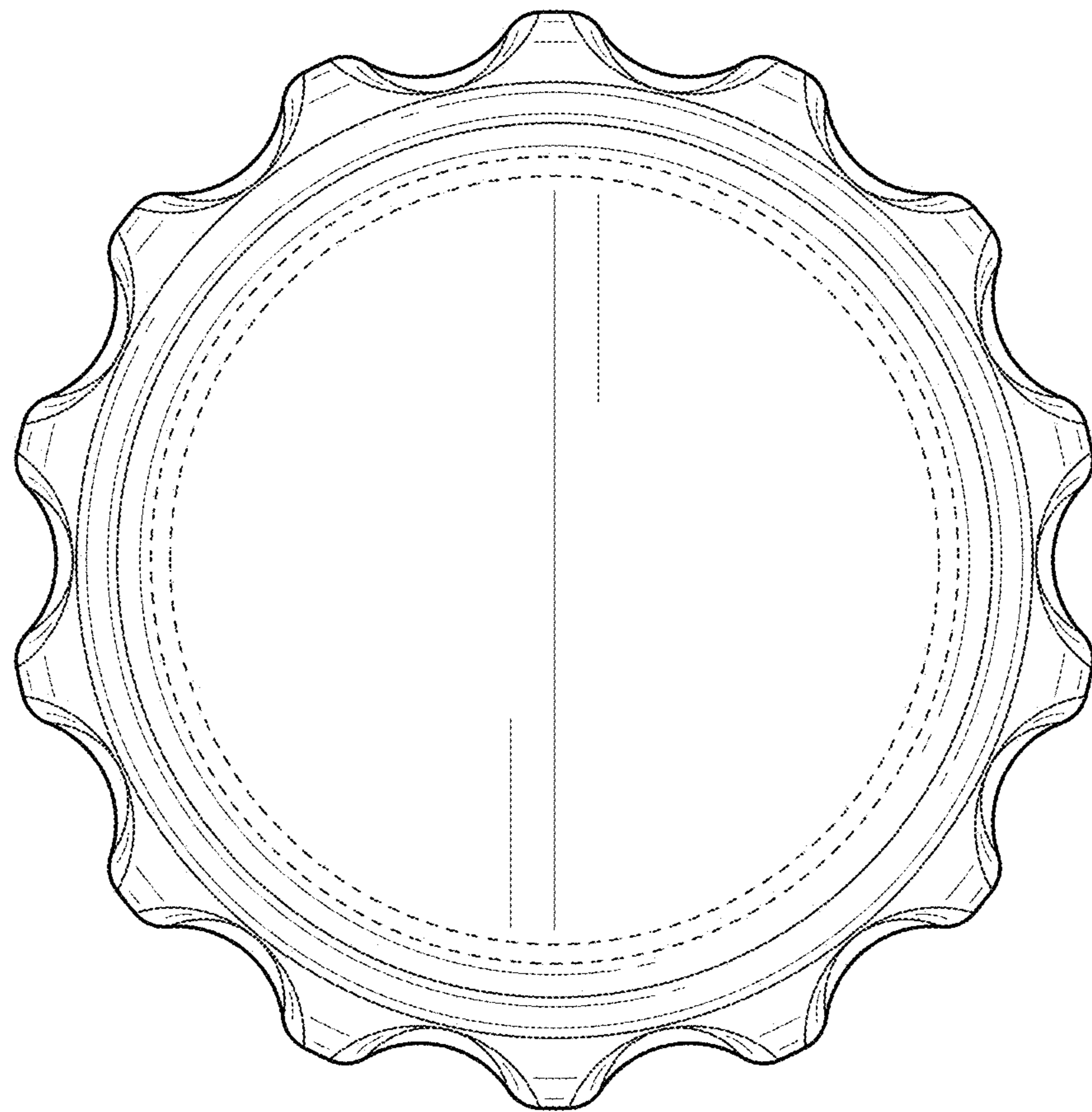

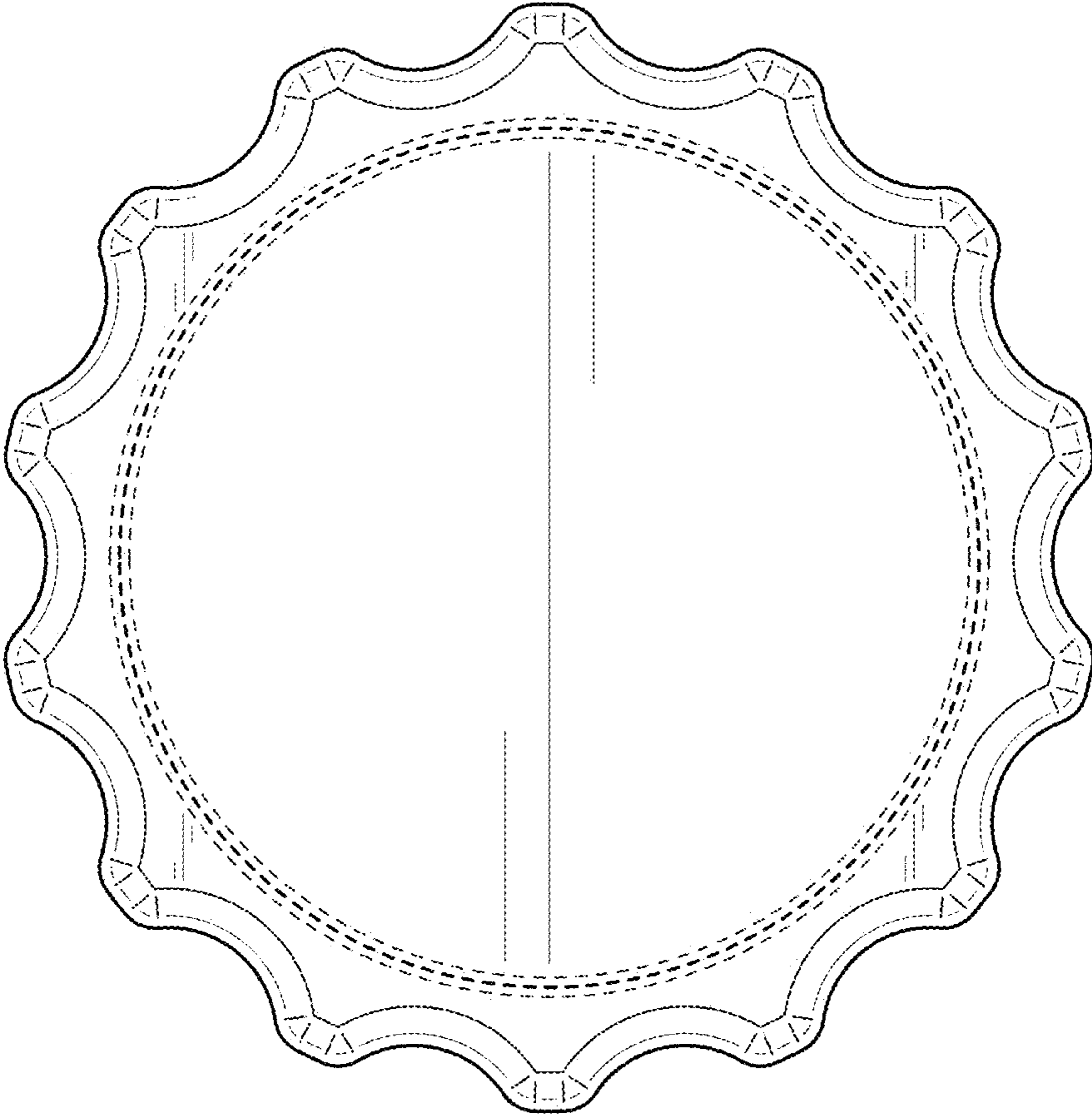
