The ornamental design for a caulk gun tip, as shown and described.

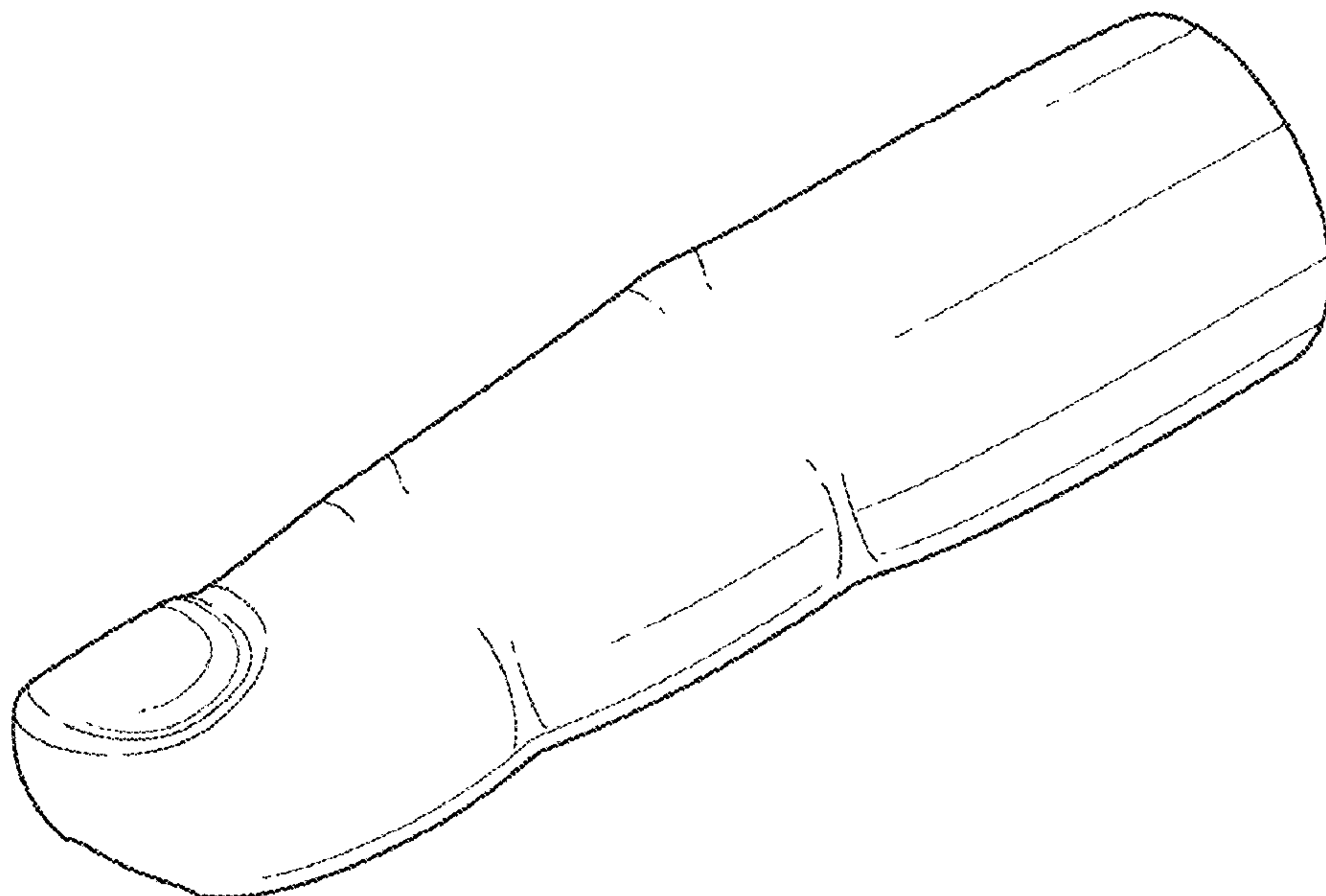
DESCRIPTION

FIG. 1 is a perspective view illustrating one embodiment of a caulk gun tip in accordance with the present design; FIG. 2 is a front view of the caulk gun tip of FIG. 1; FIG. 3 is a rear view of the caulk gun tip of FIG. 1; FIG. 4 is a first side view of the caulk gun tip of FIG. 1; FIG. 5 is a second side view of the caulk gun tip of FIG. 1; FIG. 6 is a top view of the caulk gun tip of FIG. 1; FIG. 7 is a bottom view of the caulk gun tip of FIG. 1; and, FIG. 8 is a perspective view illustrating a caulk gun tip in accordance with the present design attached to a caulk gun (shown in broken lines). The broken lines shown of the caulk gun and caulk tube in FIG. 8 are provided for purposes of environment and form no part of the claimed design.

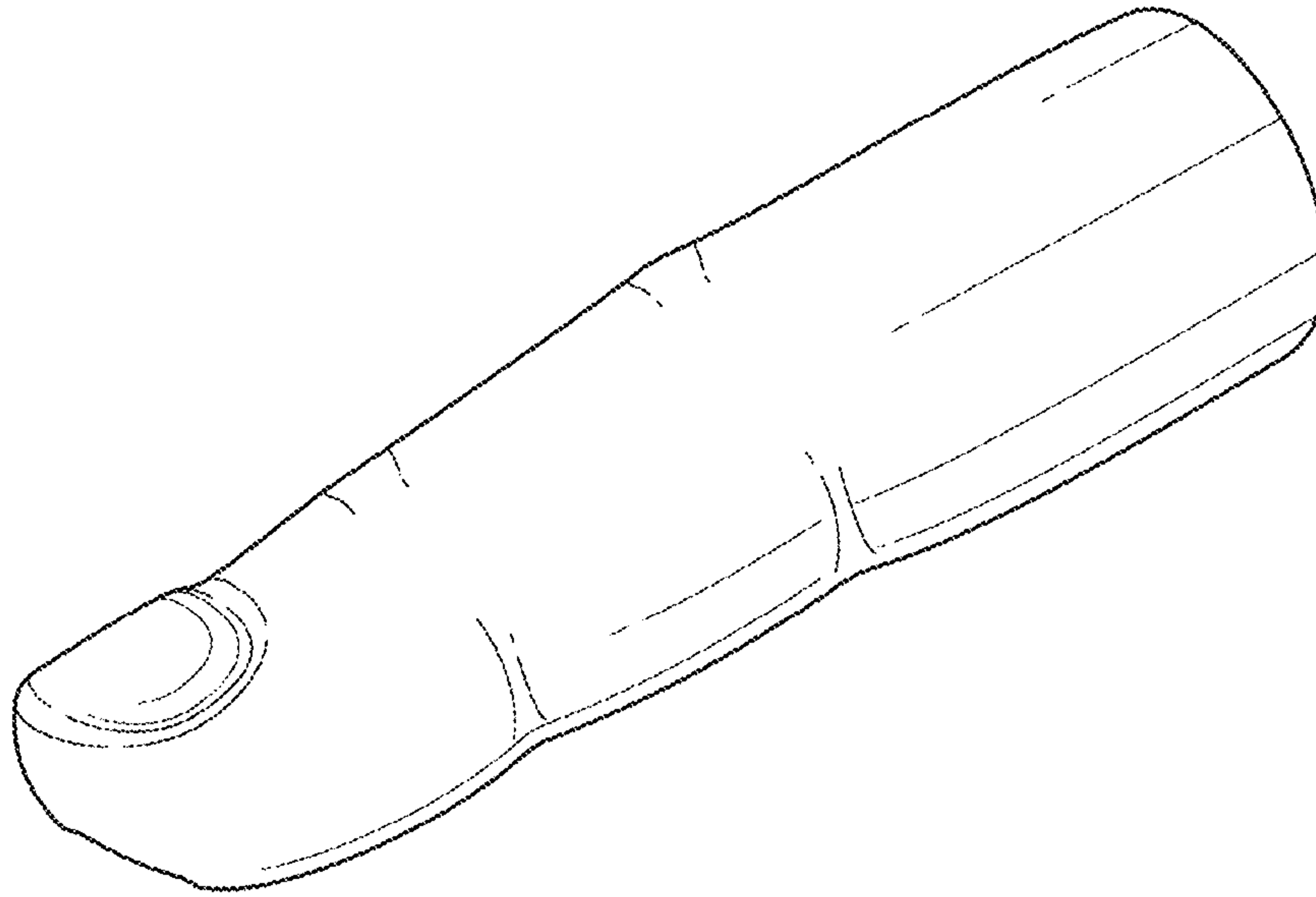

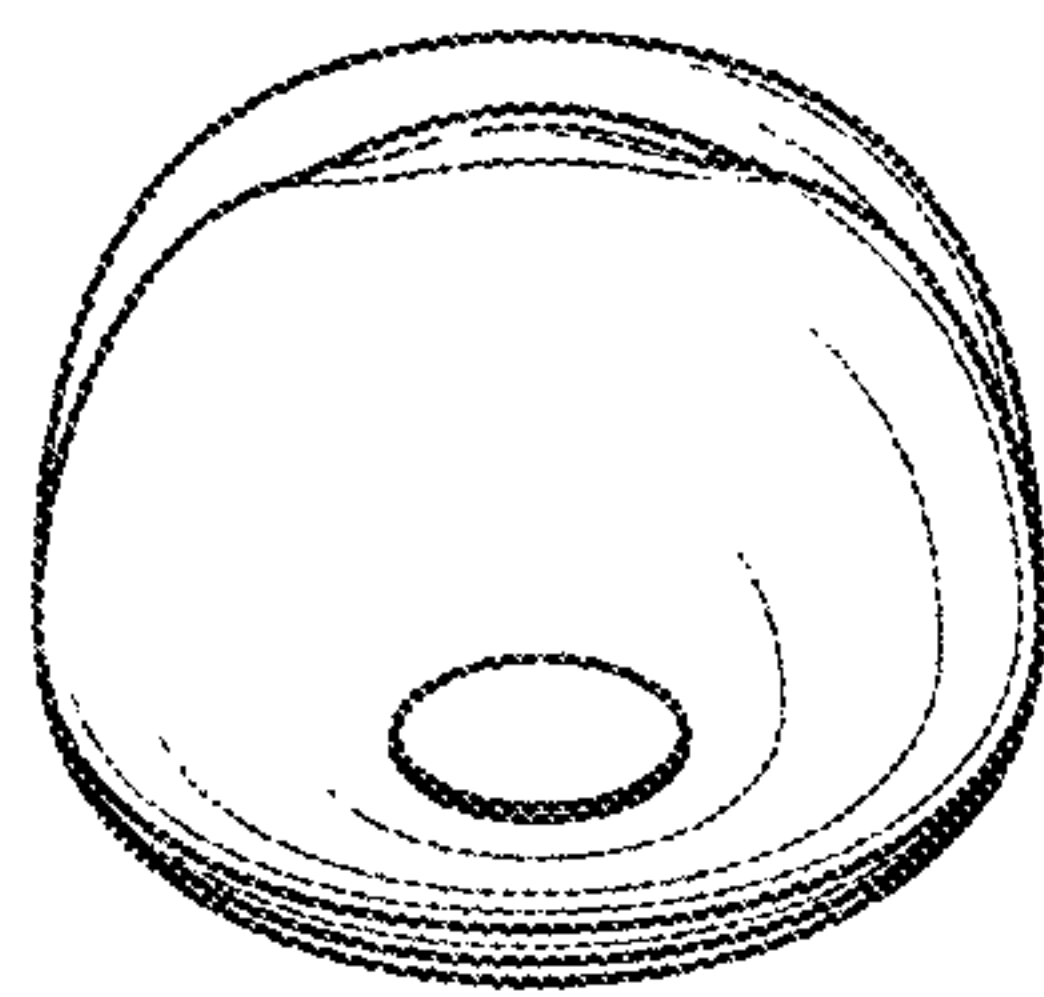

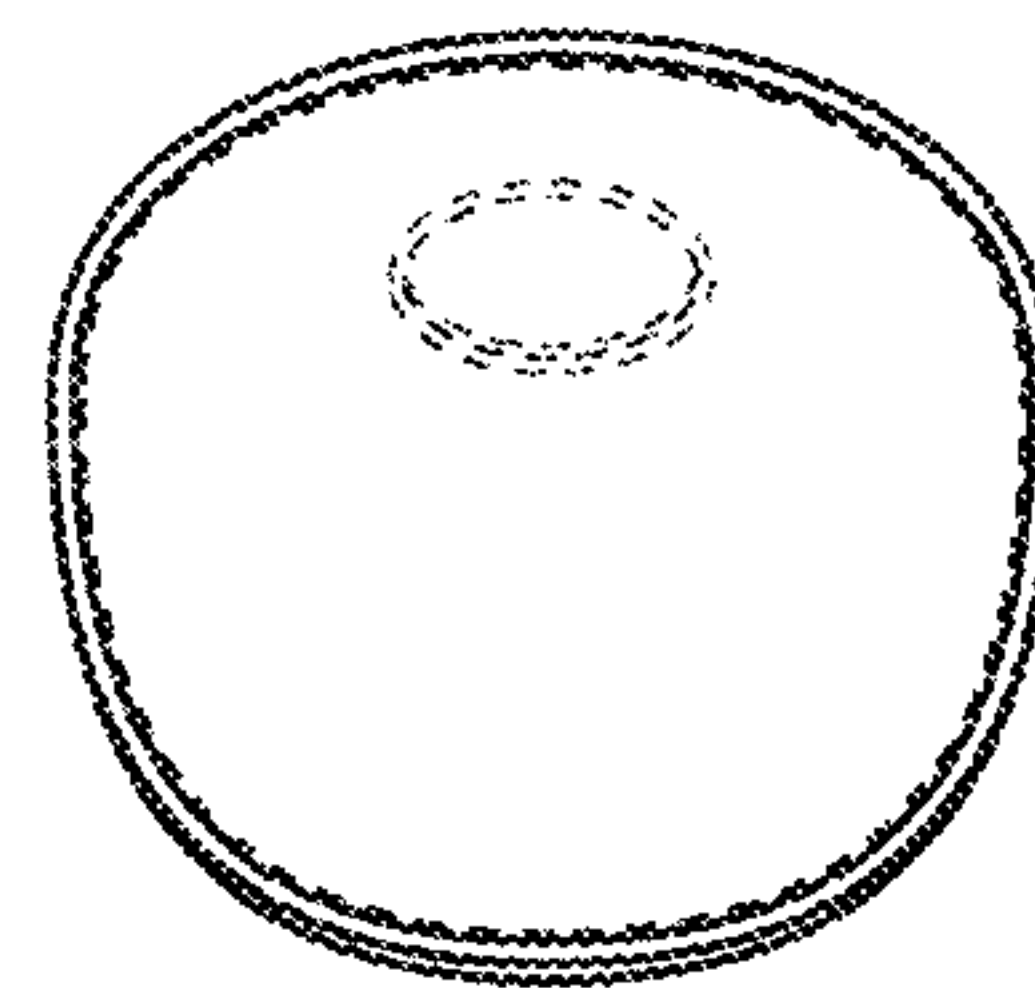

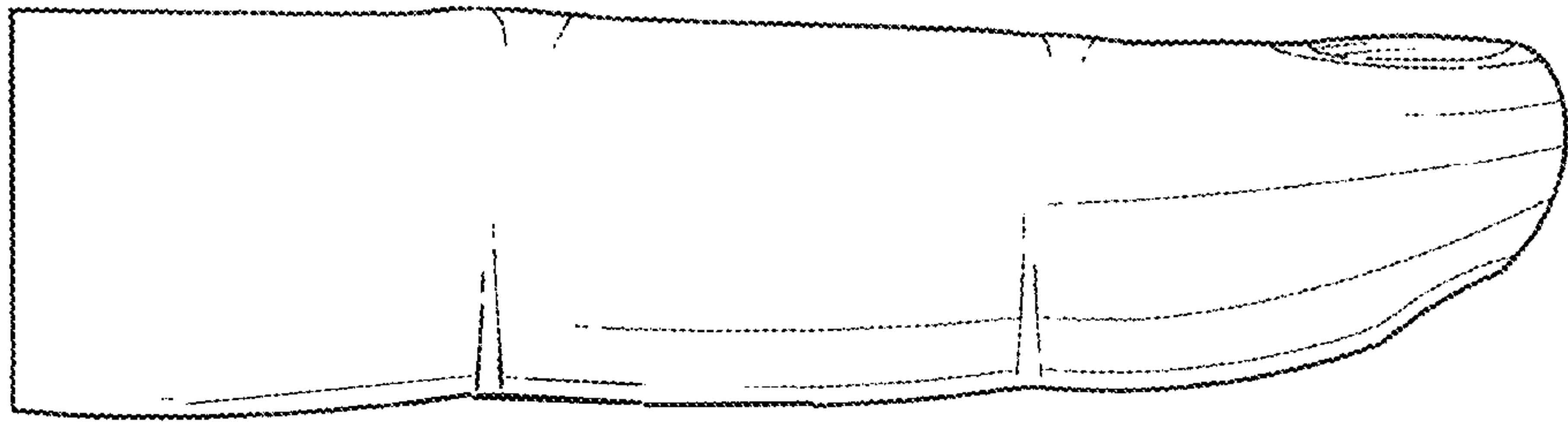

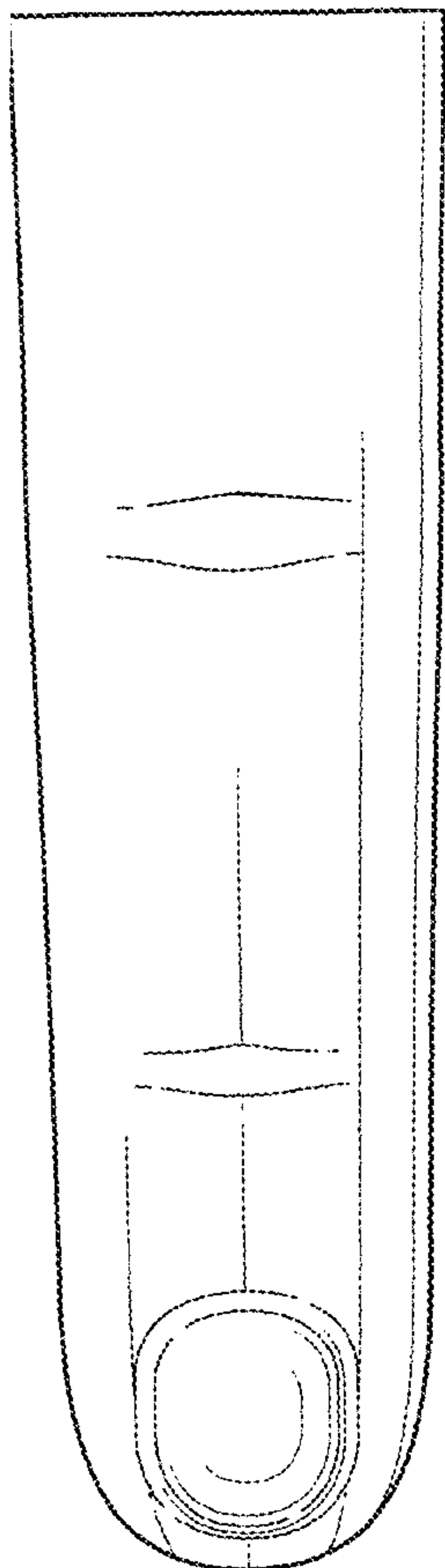

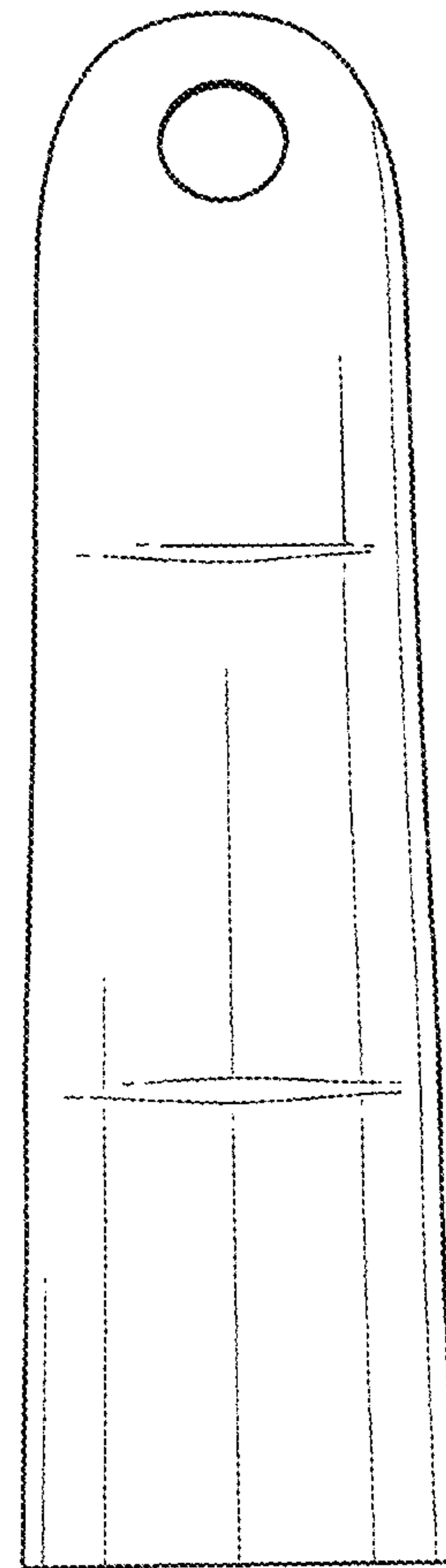

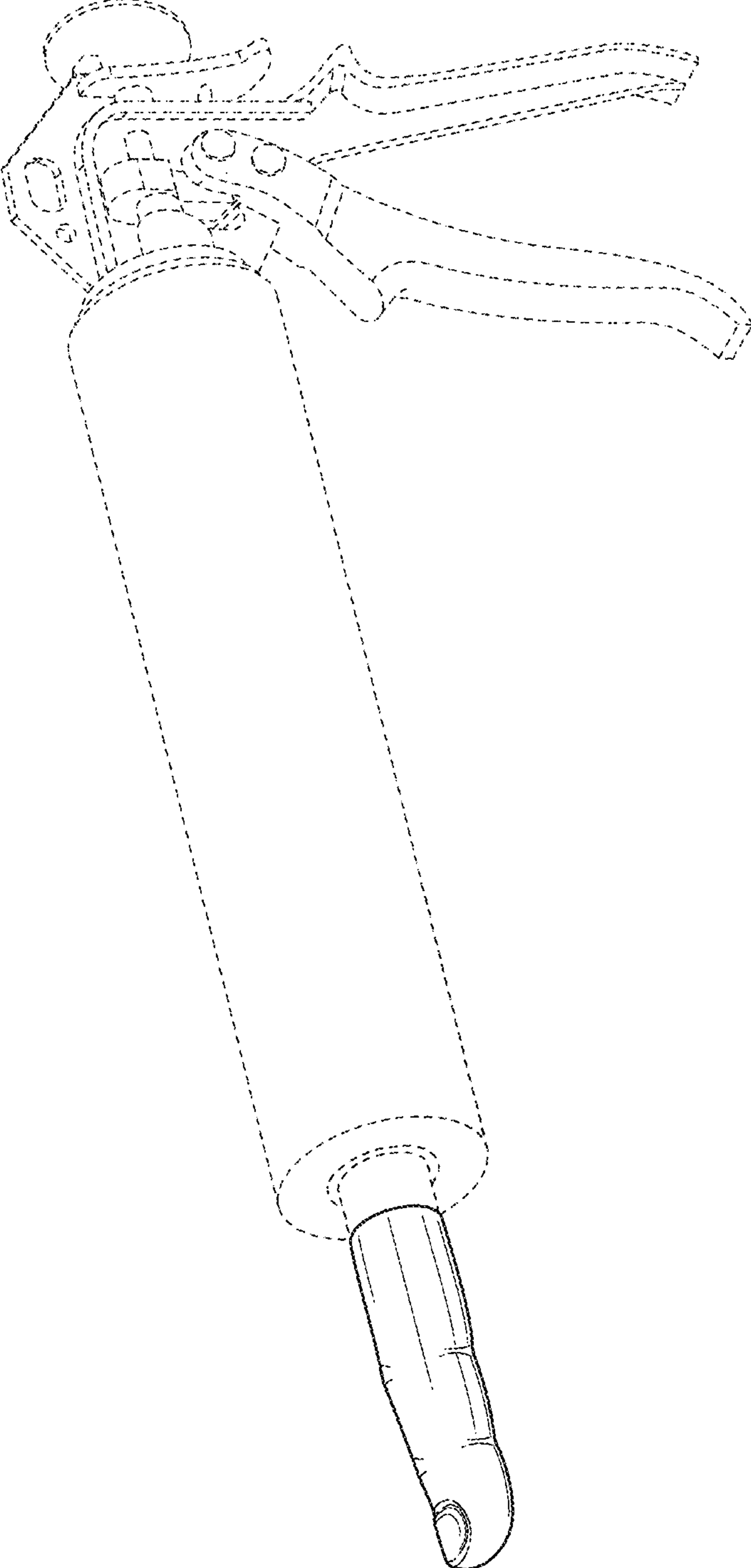
