I claim the ornamental design for a pole cup, as shown and described.

DESCRIPTION

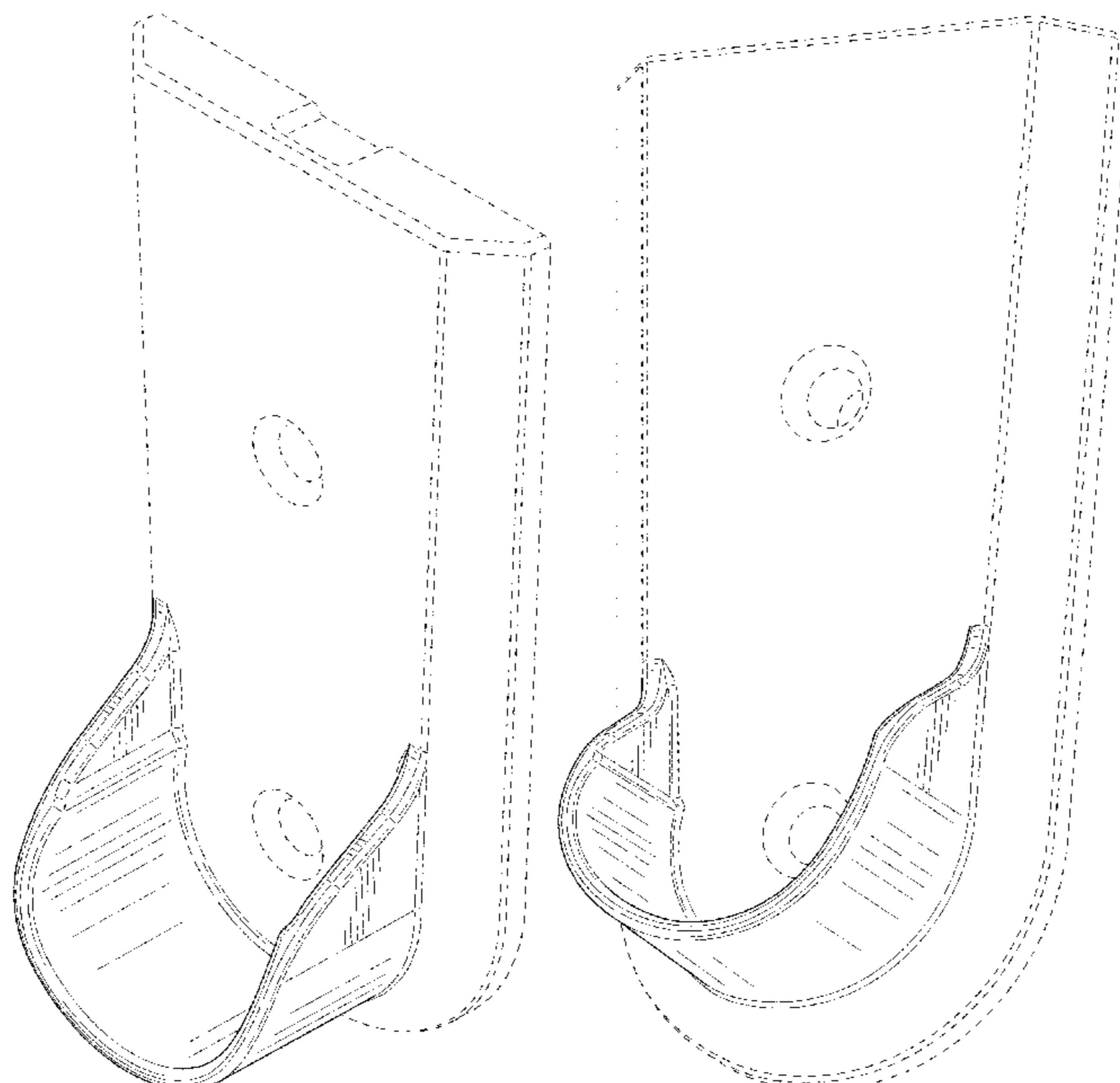
FIG. 1 is an upper front perspective view showing my new design for a pole cup;

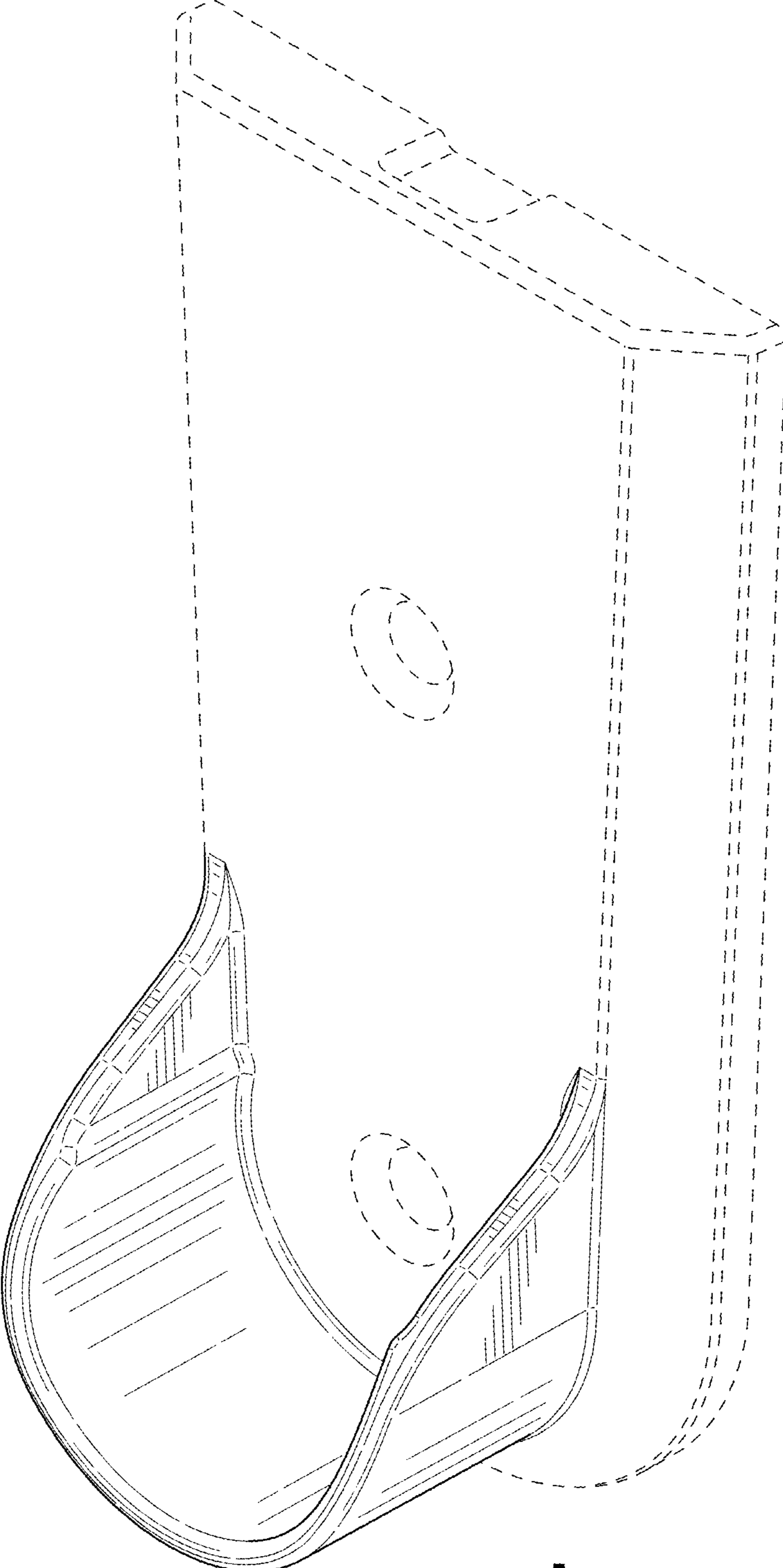

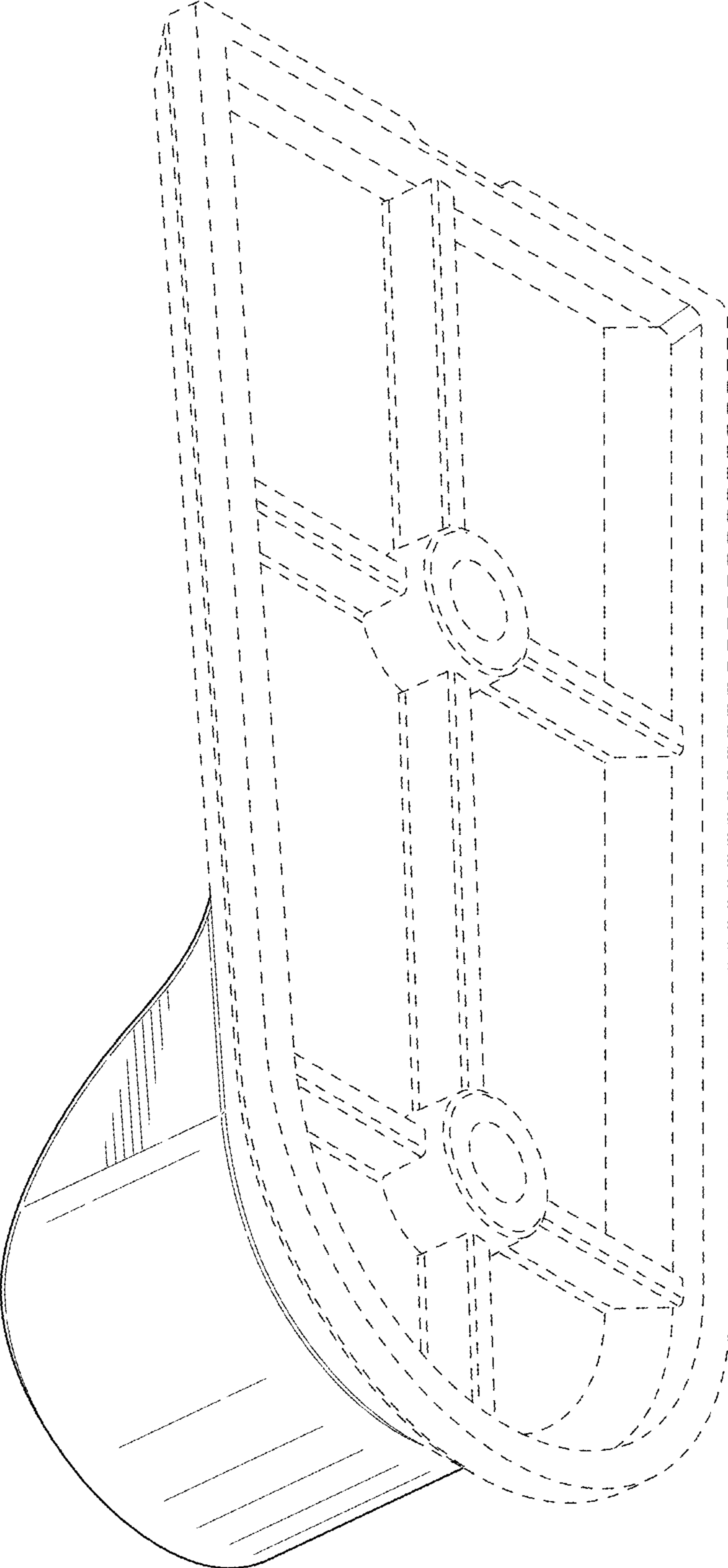

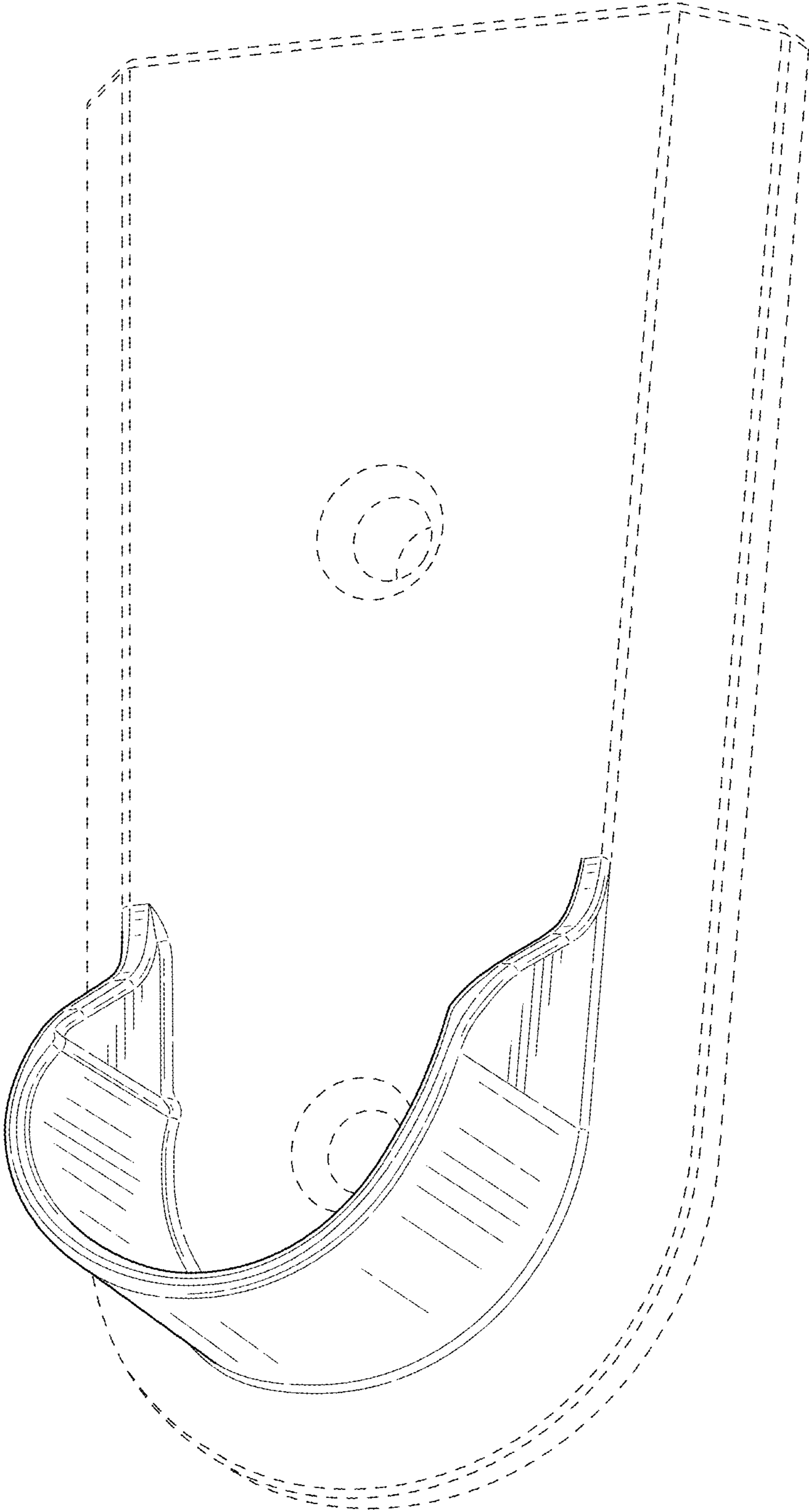

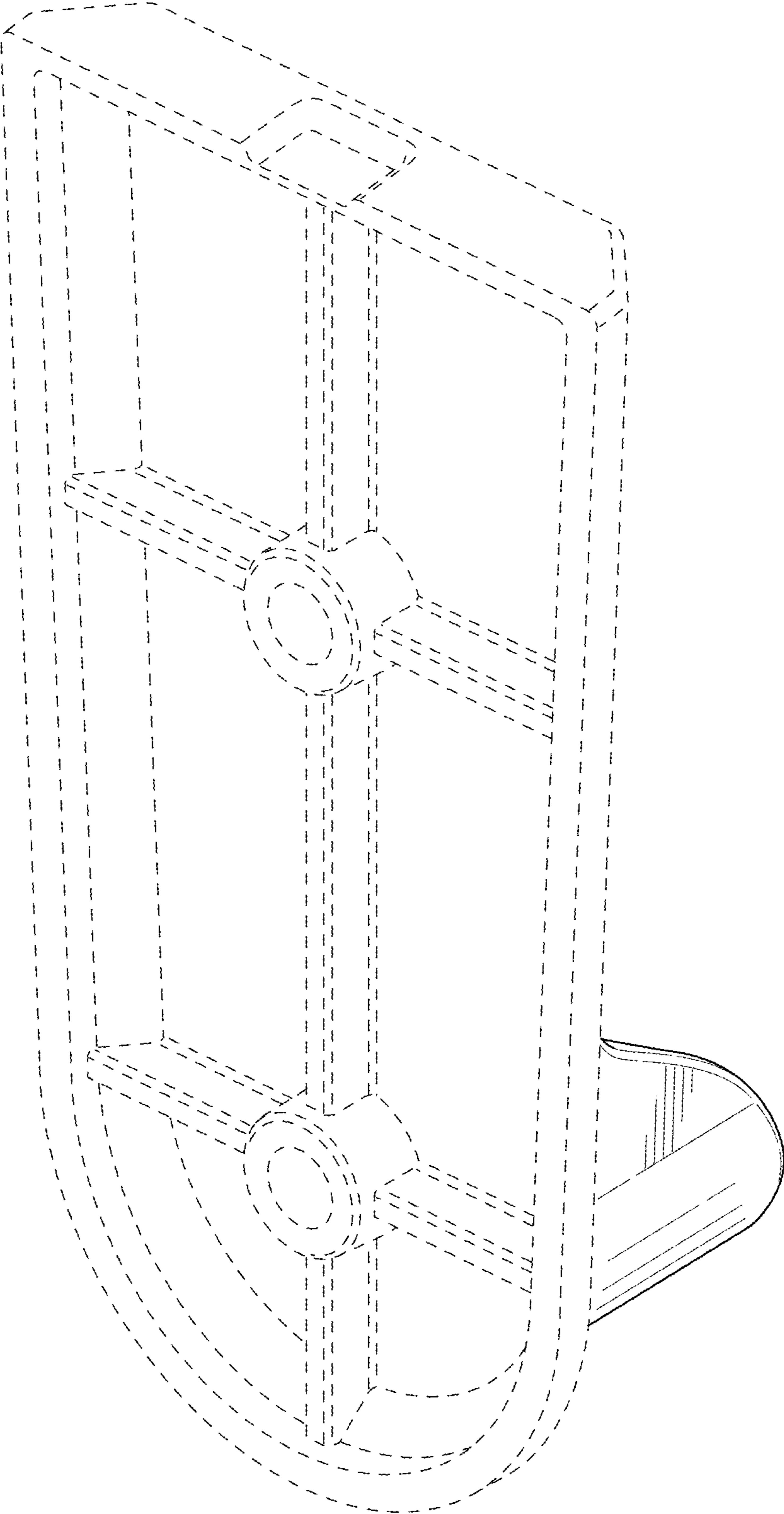

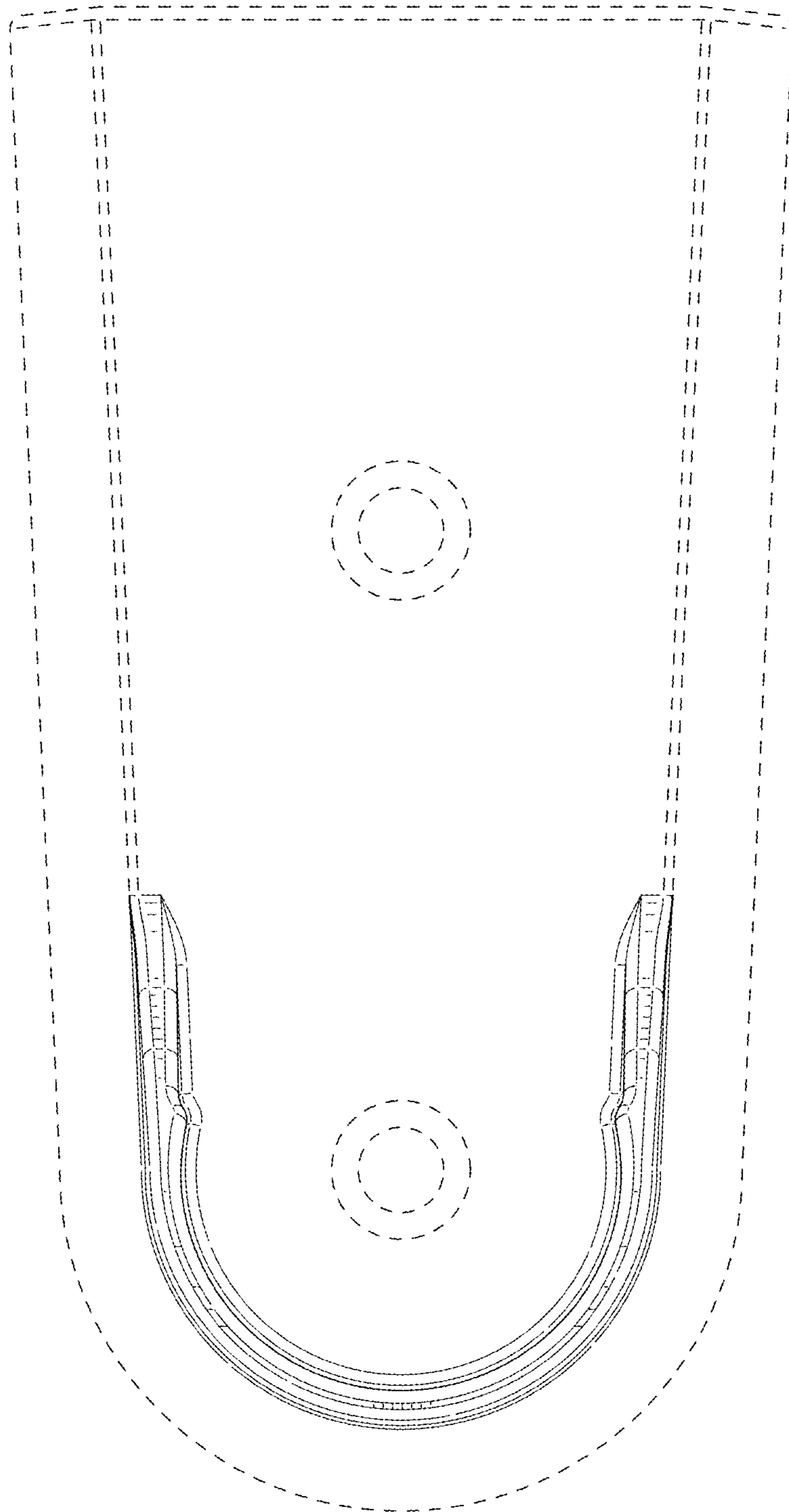

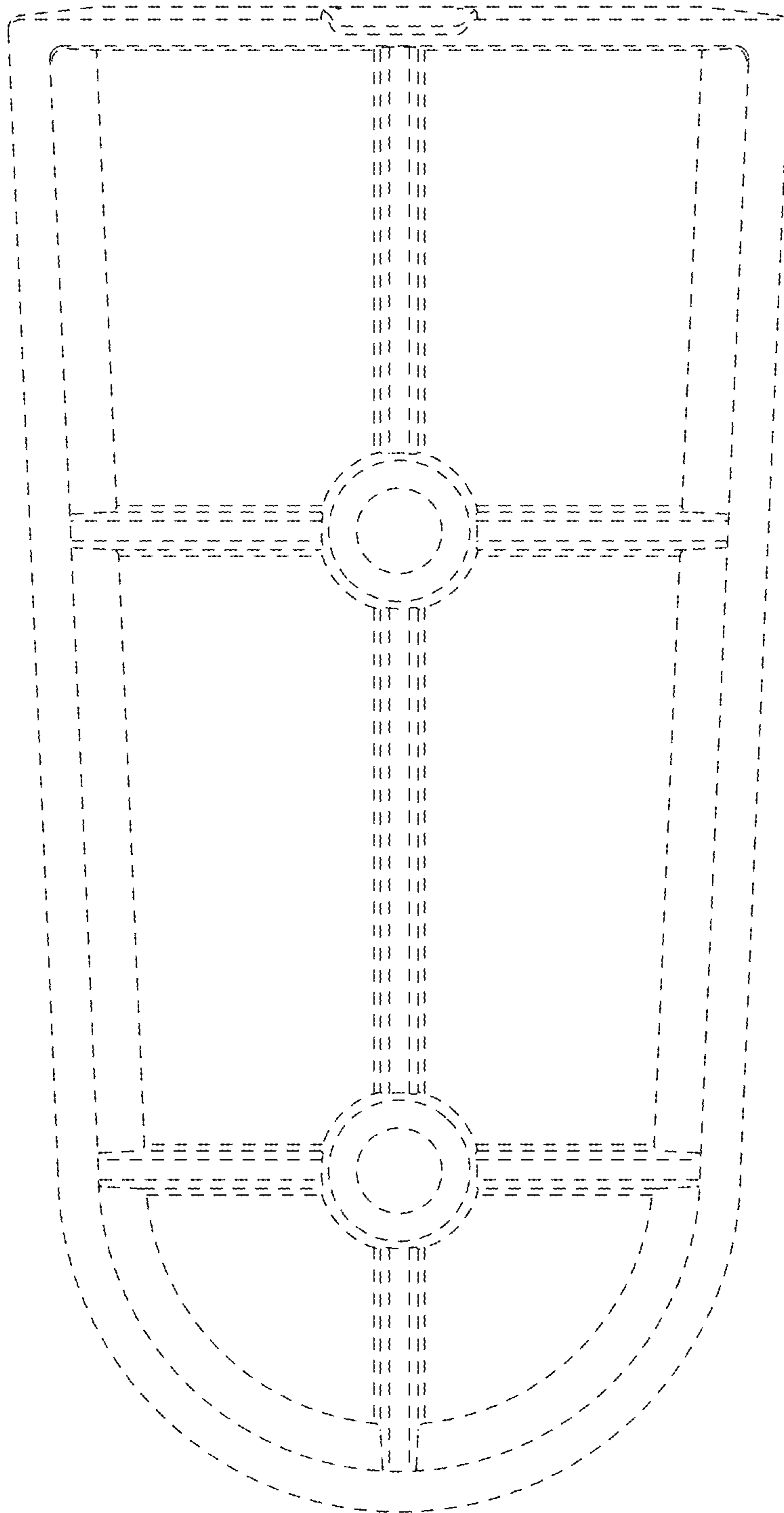

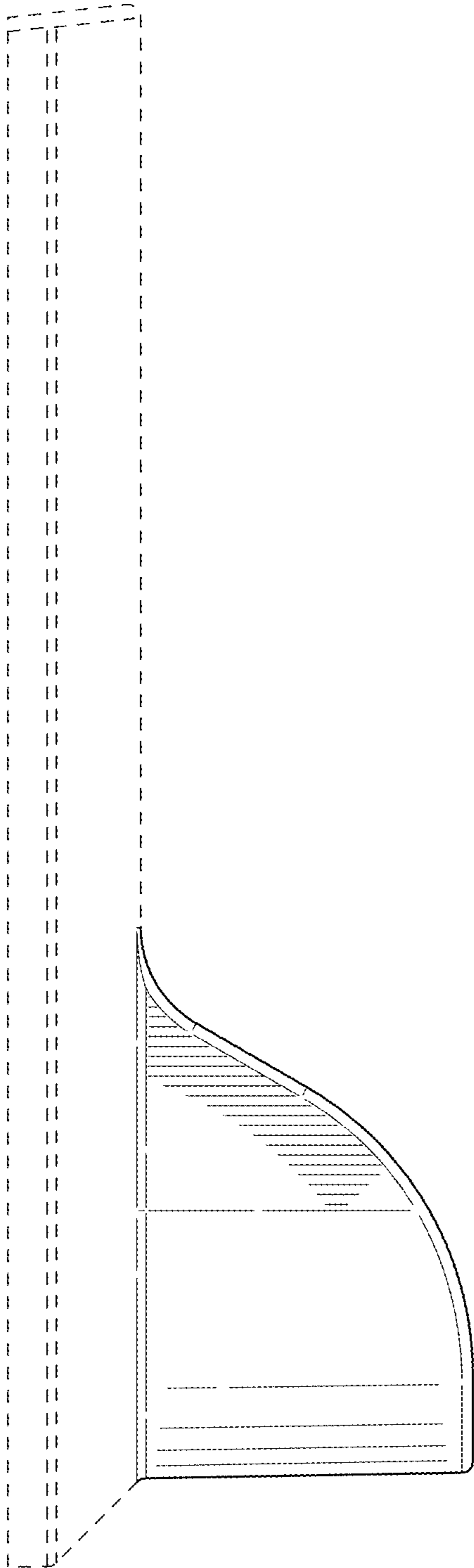

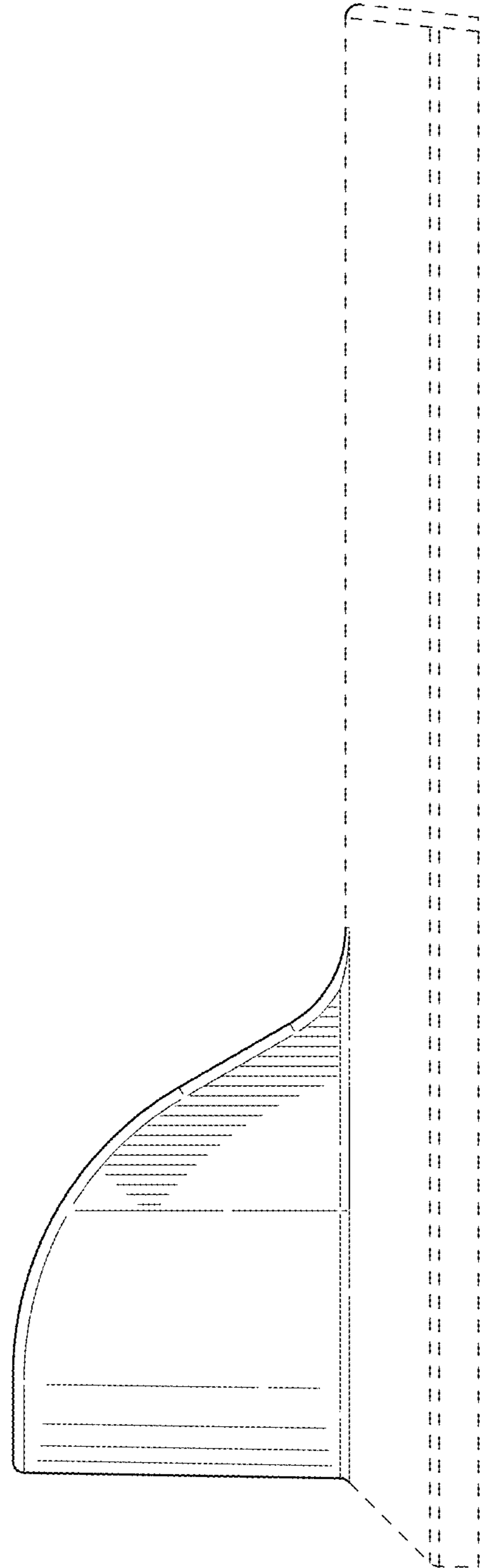

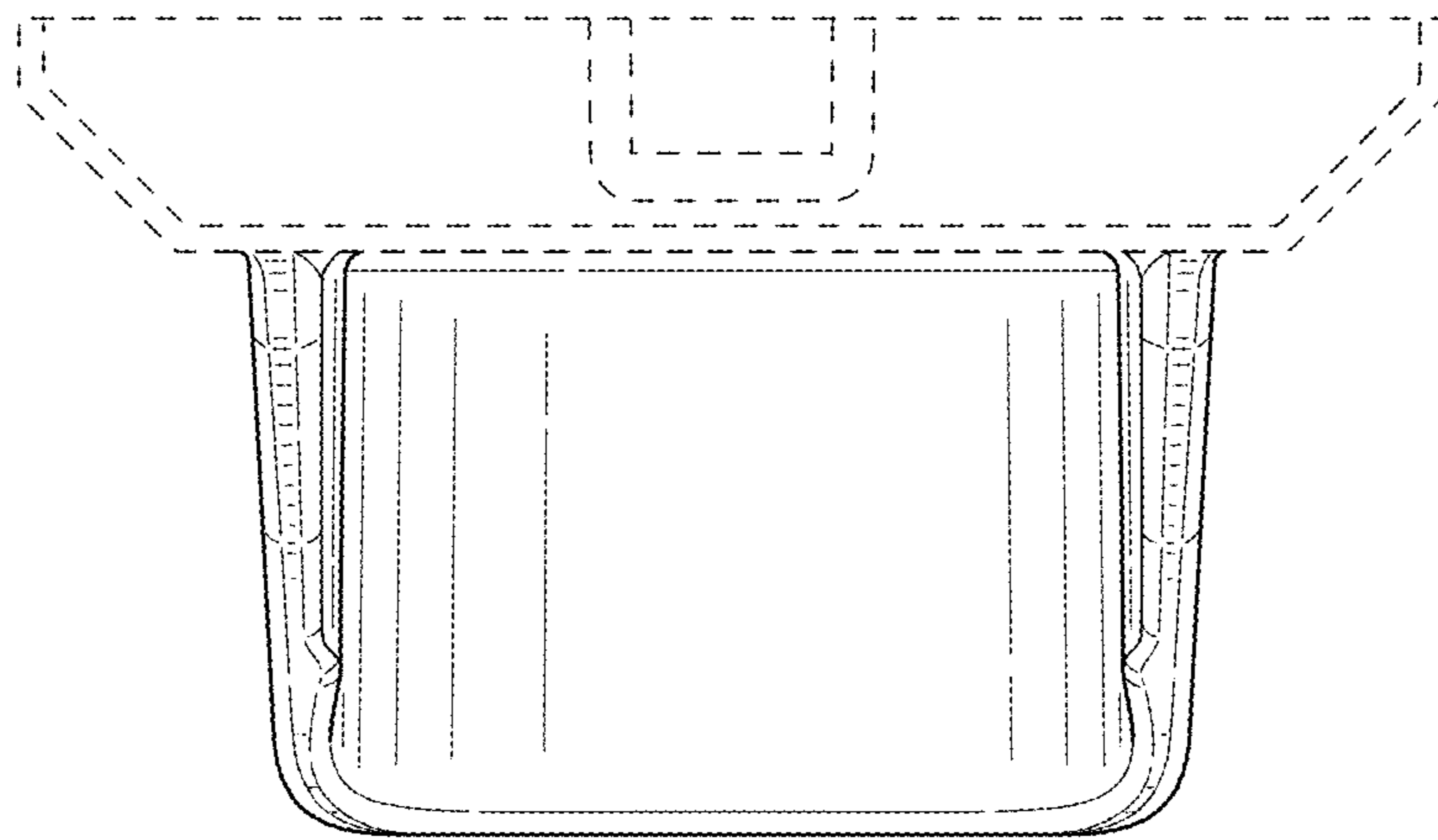

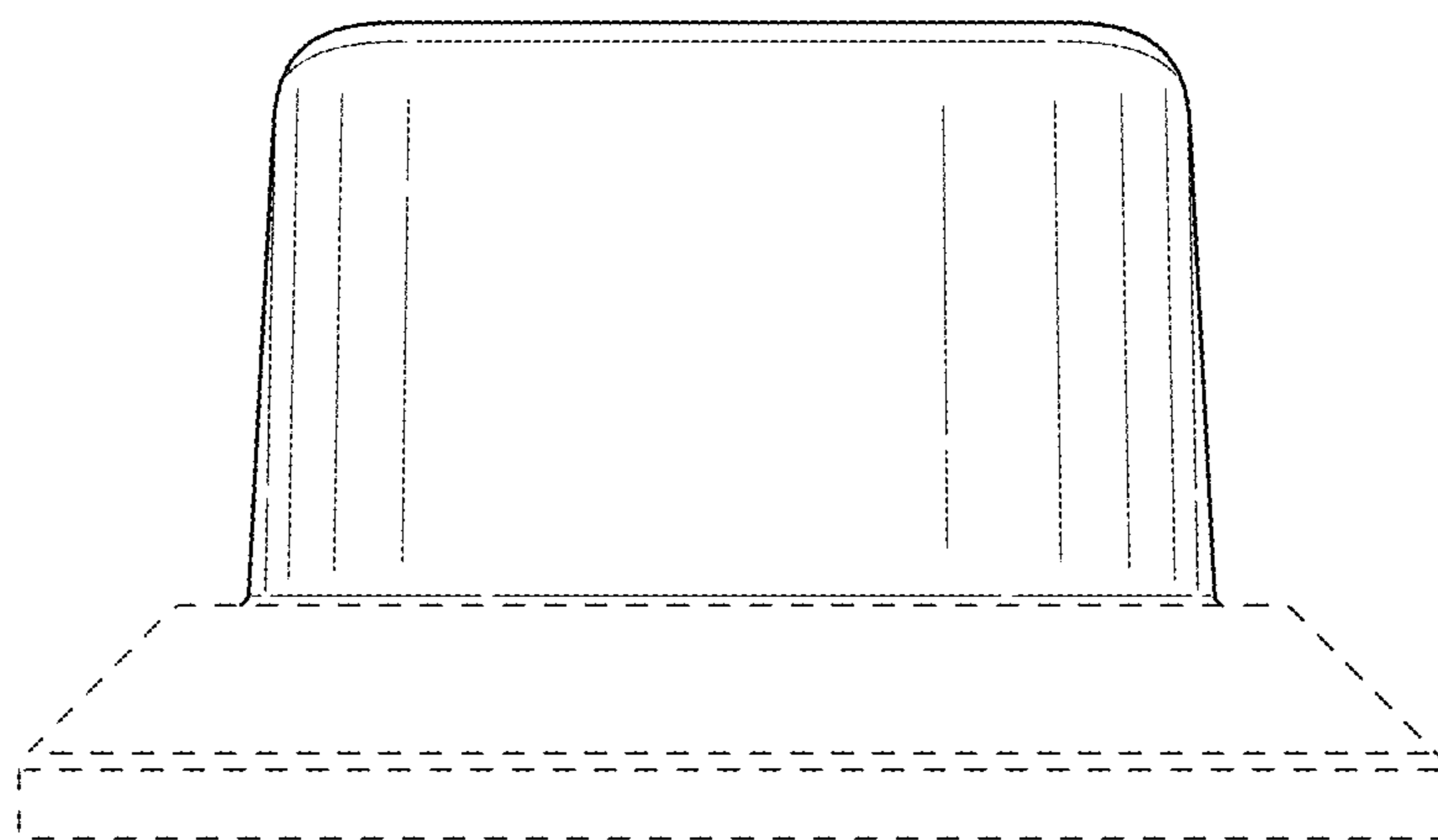
