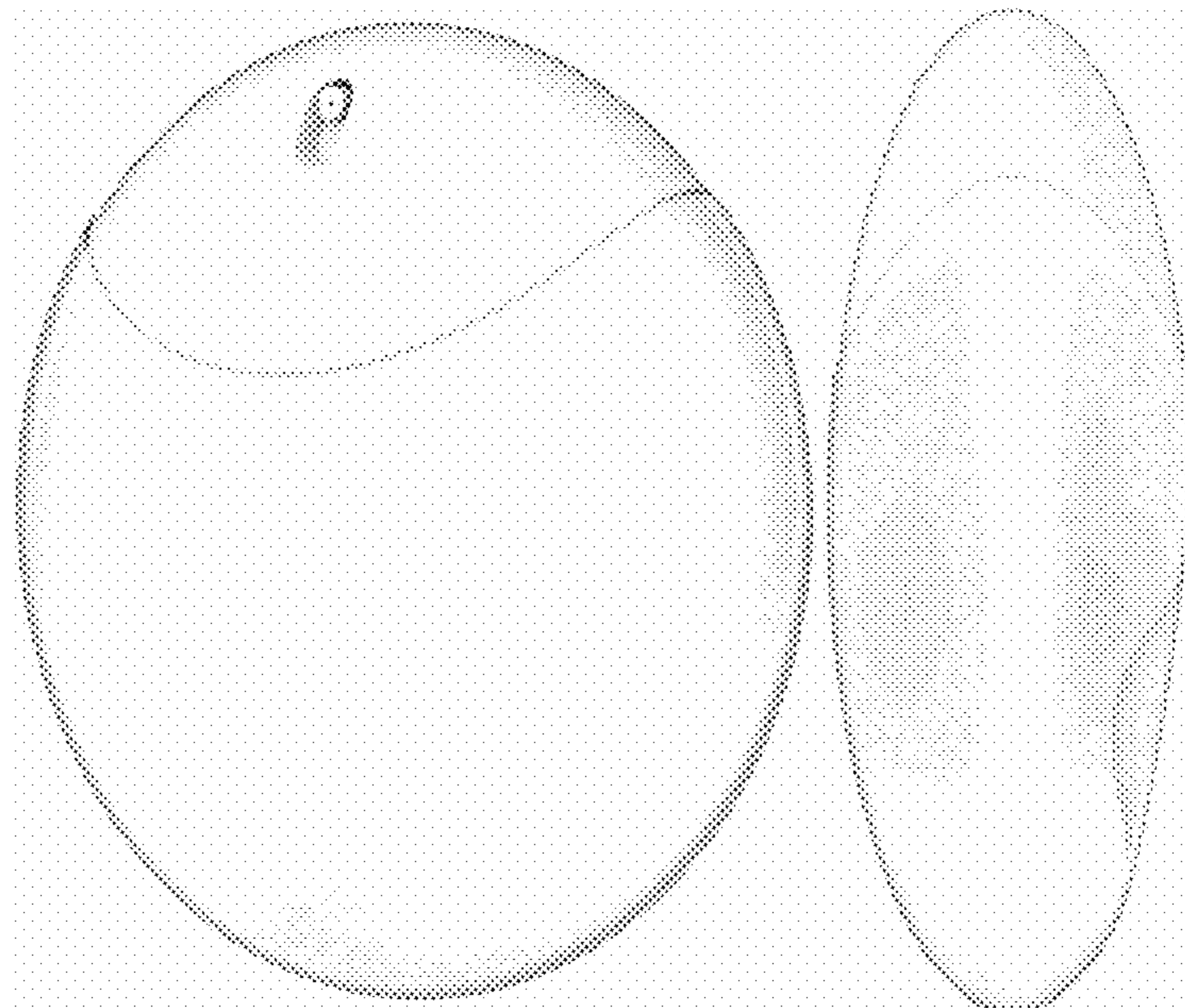
The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

- 1. Bottle
- 1.1 : Three-quarter
- 1.2 : Front
- 1.3 : Back
- 1.4 : Right
- 1.5 : Left
- 1.6 : Top
- 1.7 : Bottom

Reproduction 1.1 is a three-quarter view of the bottle, reproduction 1.2 is a front view of the bottle, reproduction 1.3 is a back view of the bottle, reproduction 1.4 is a right profile view of the bottle, reproduction 1.5 is a left profile view of the bottle, reproduction 1.6 is a top view of the bottle and reproduction 1.7 is a bottom view of the bottle.

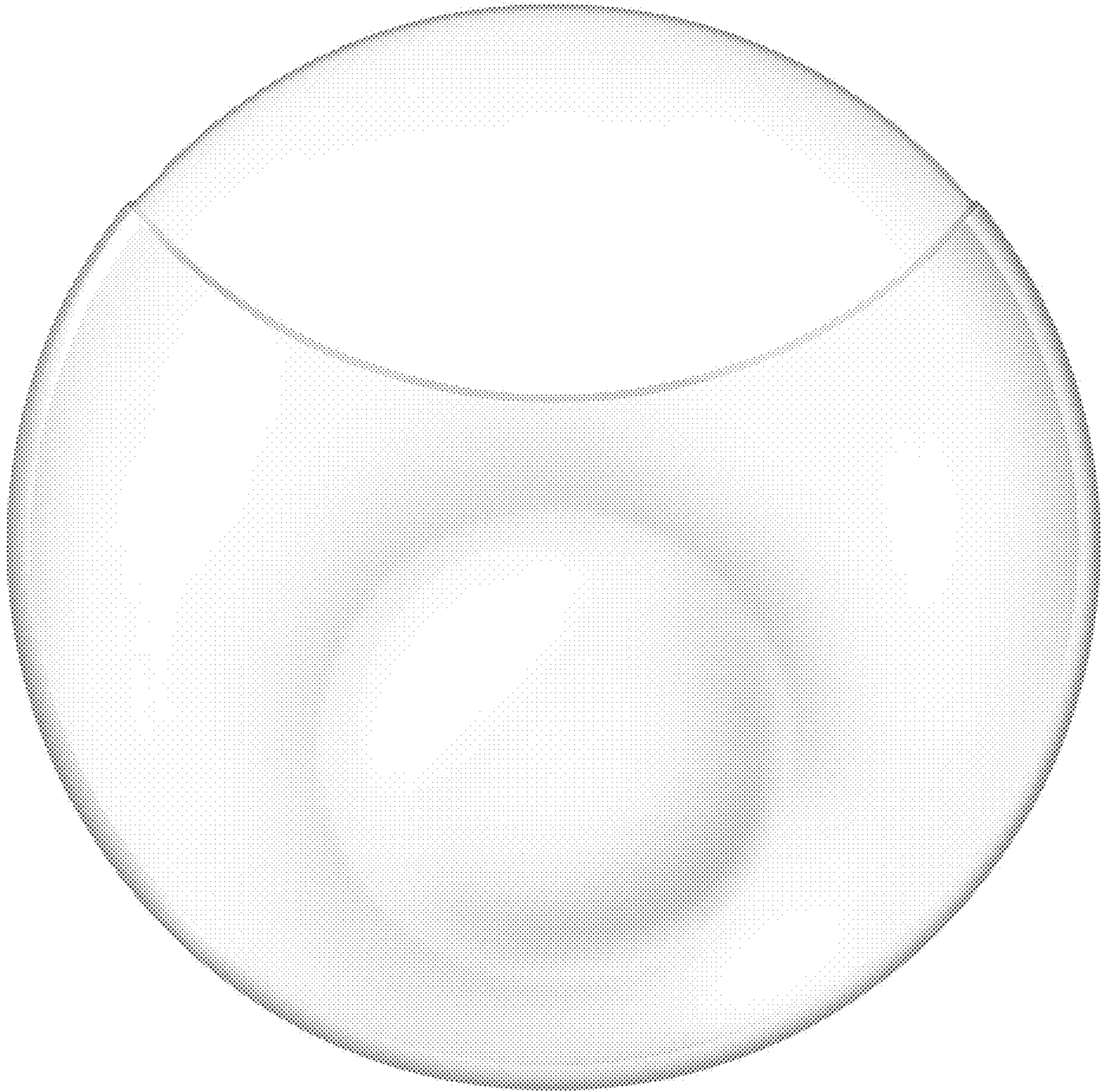

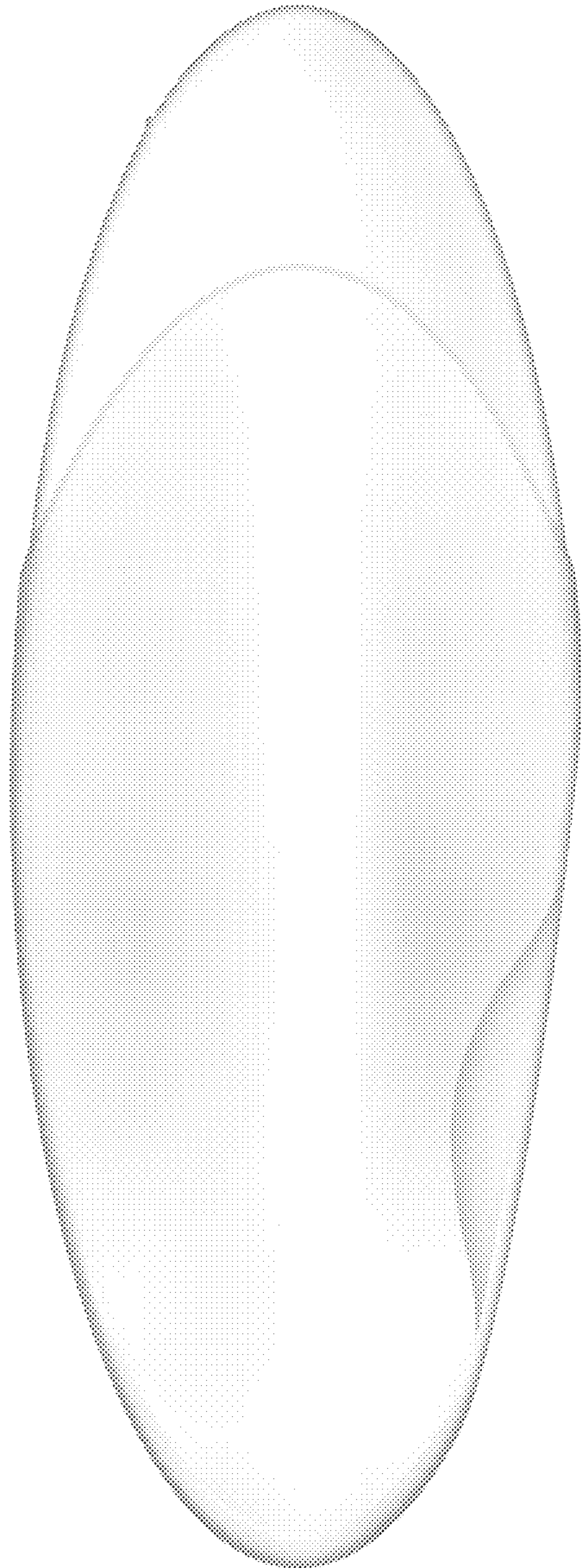




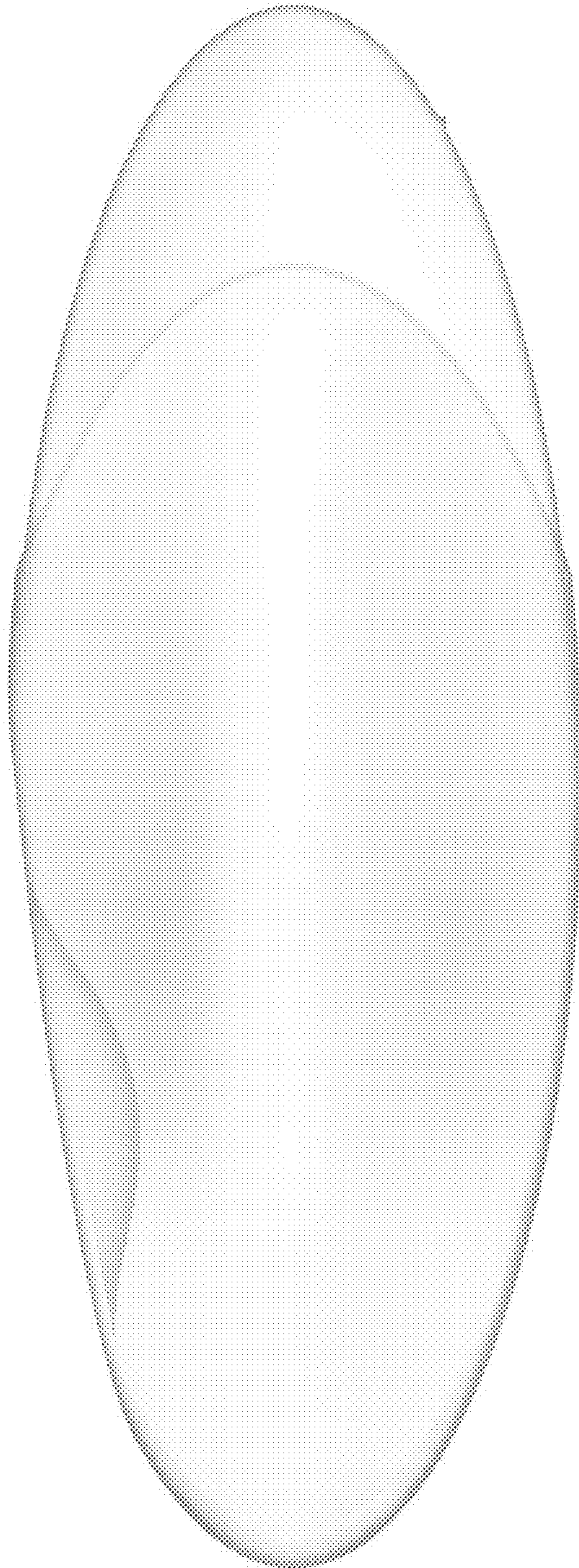

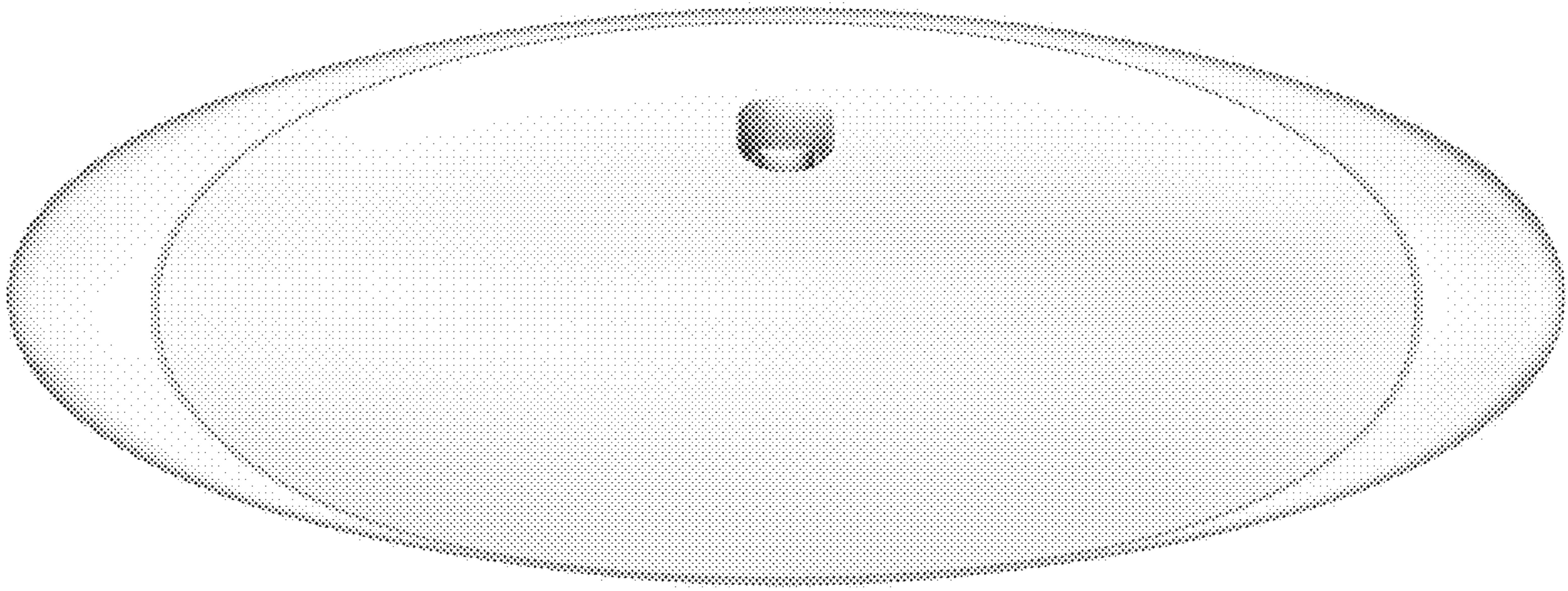
