The ornamental design for an electric car, as shown and described.

**DESCRIPTION**

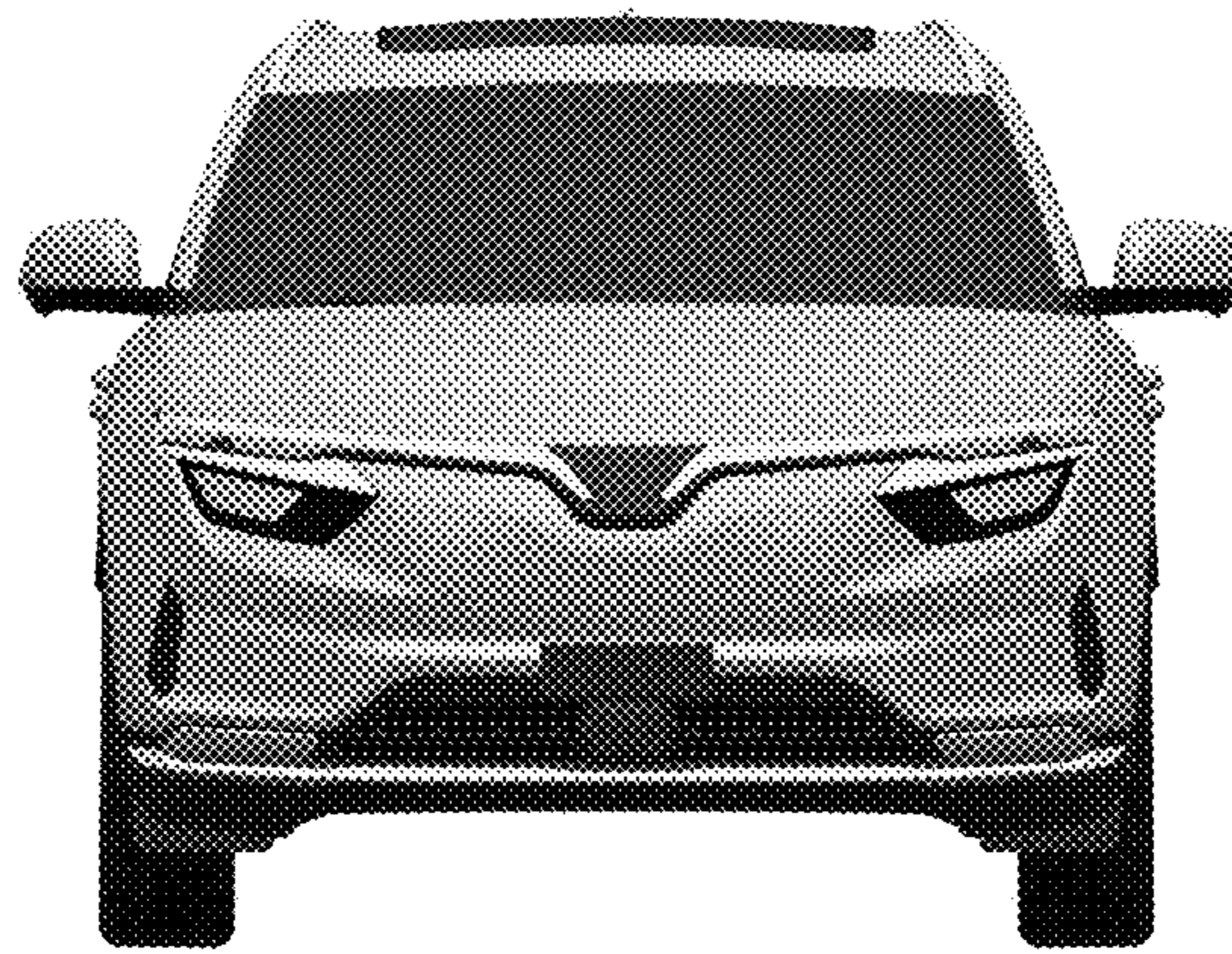

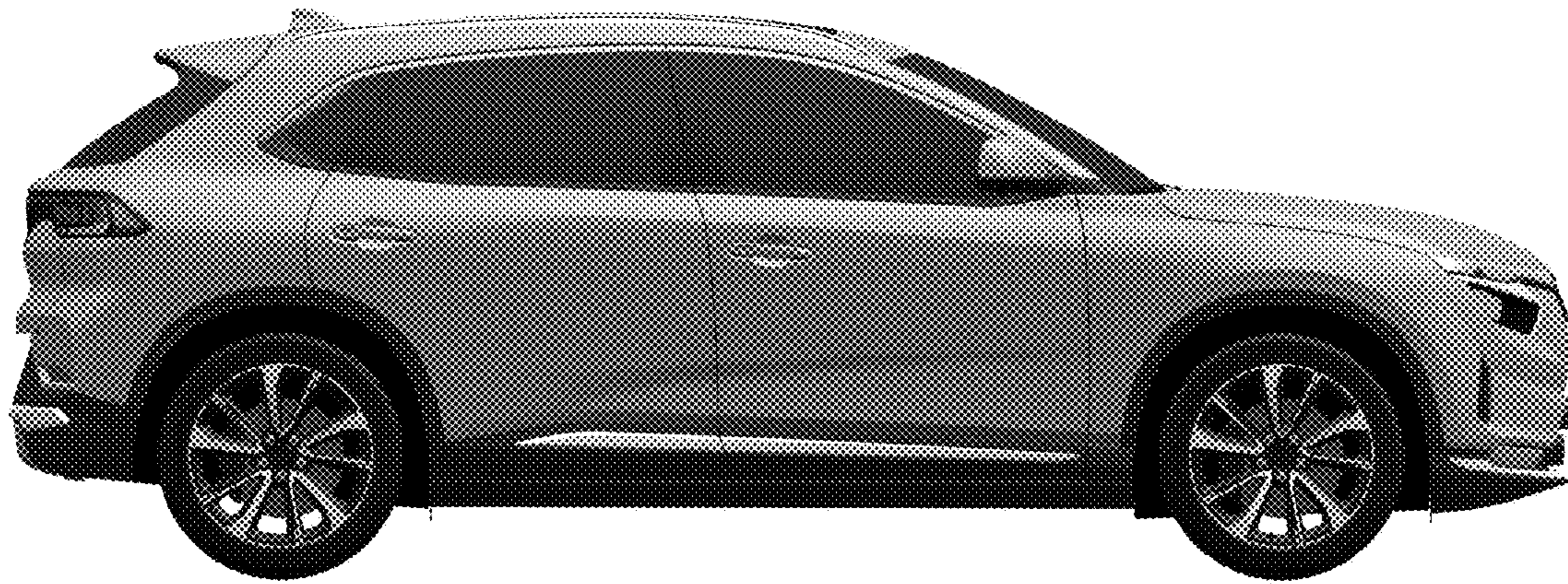

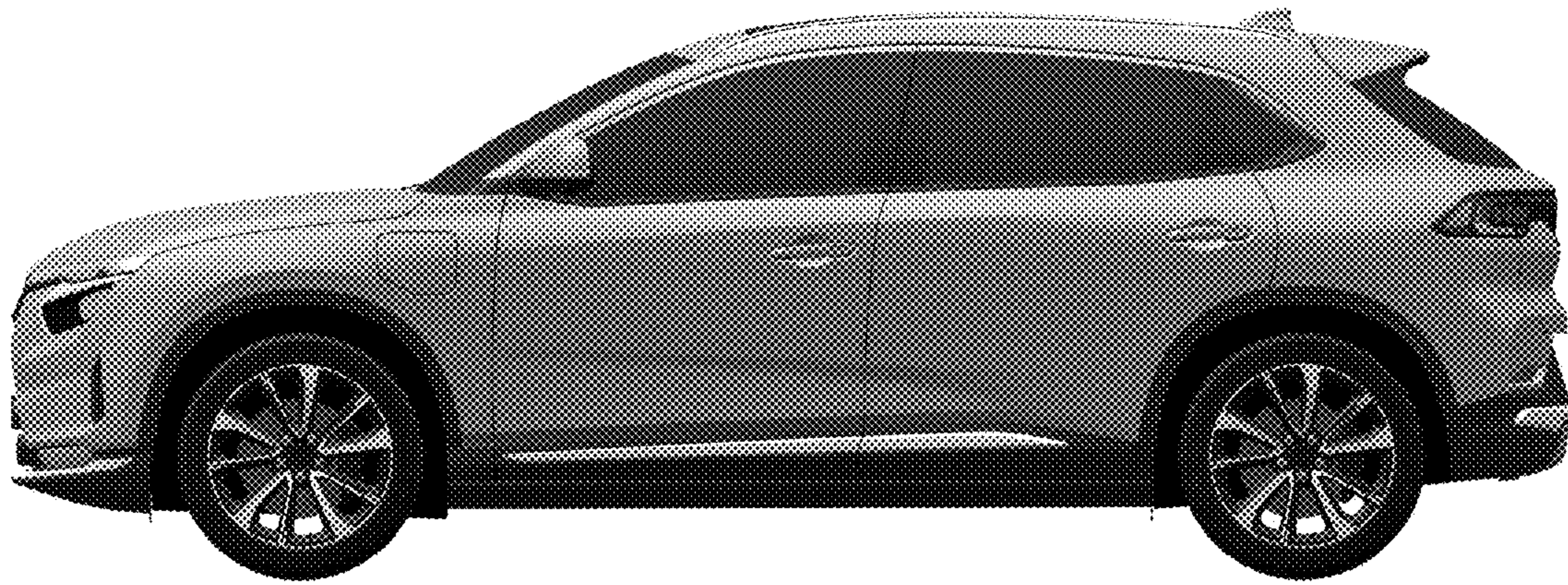
