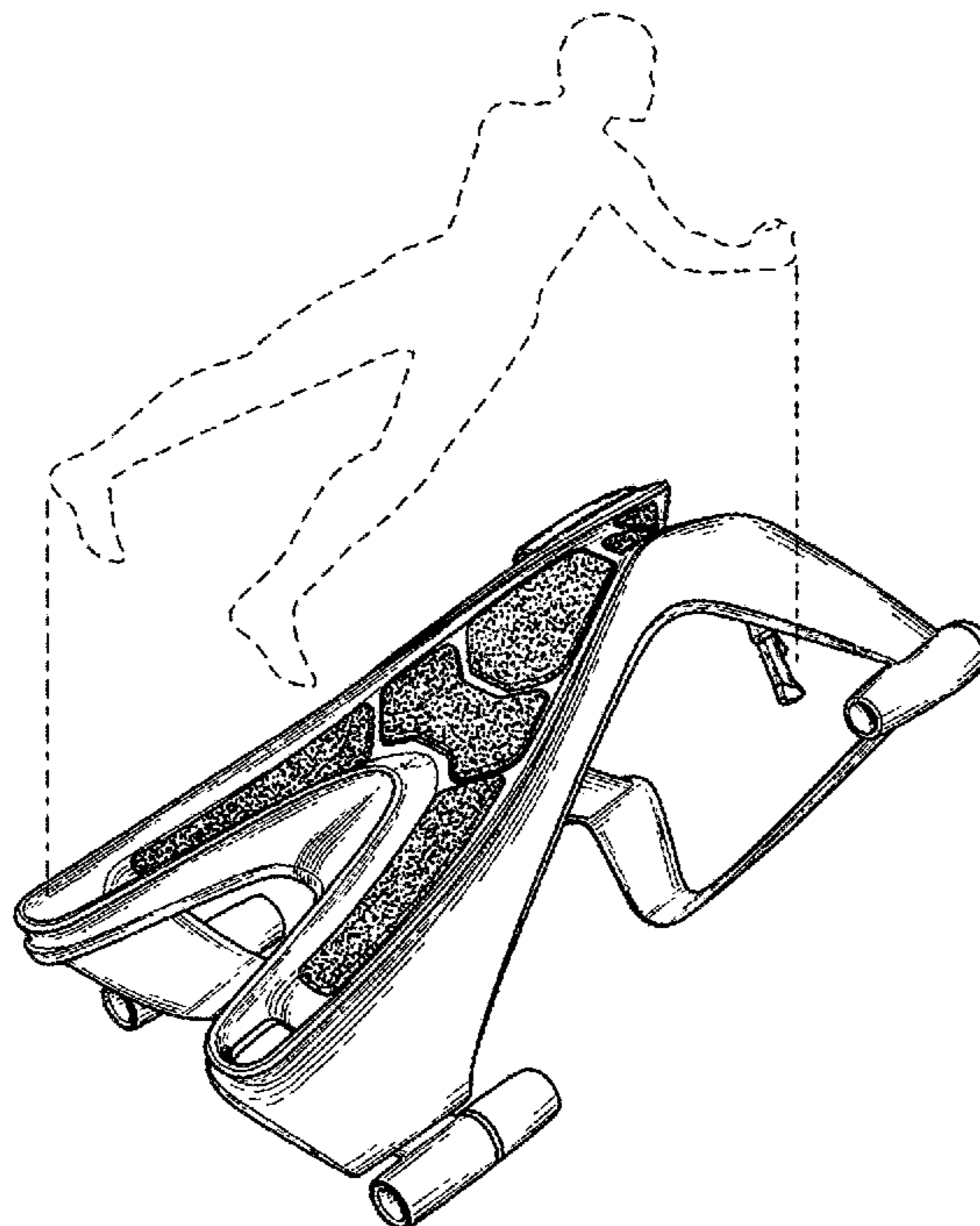
(57) **CLAIM**

The ornamental design for a water vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a water vehicle showing my new design;
FIG. 2 is a top, rear, and right side perspective view thereof;
FIG. 3 is a bottom, front, and left side perspective view thereof;
FIG. 4 is a bottom, rear, and right side perspective view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a front elevation view thereof;
FIG. 7 is a rear elevation view thereof;
FIG. 8 is a top plan view thereof;
FIG. 9 is a bottom plan view thereof; and,
FIG. 10 is the same view of the water vehicle as FIG. 2, showing environmental material in broken lines which is not part of the claimed design spaced away from the water vehicle.

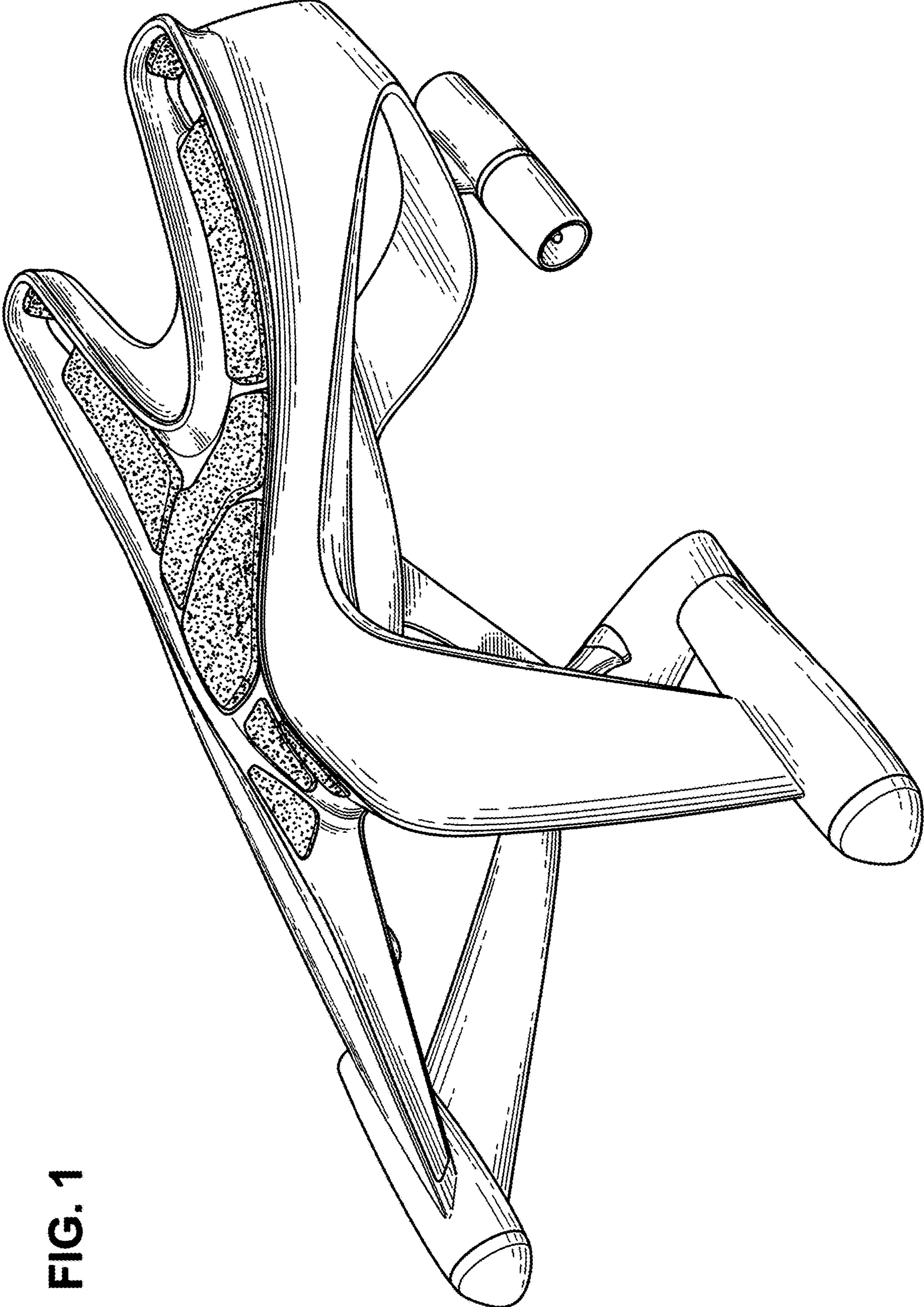

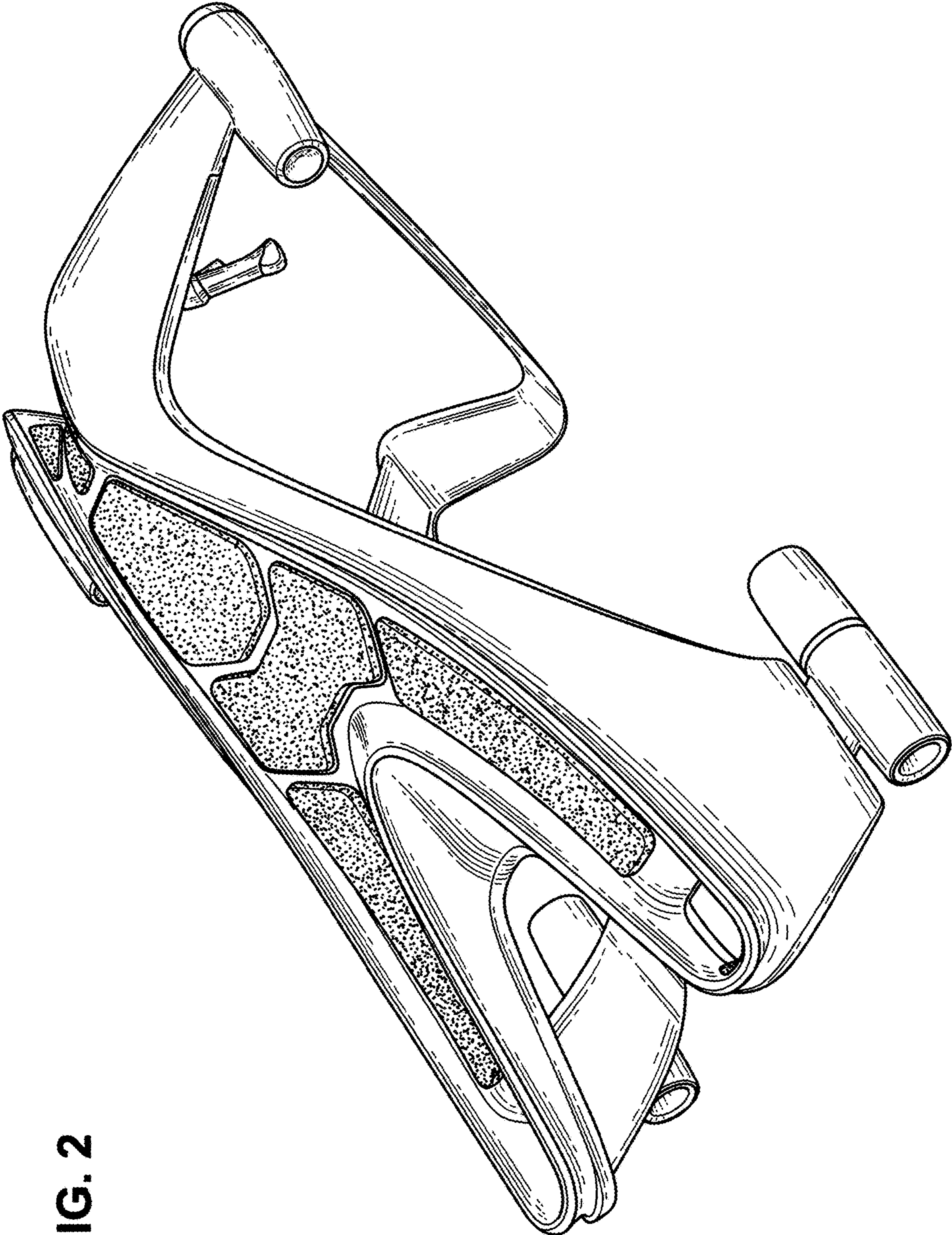

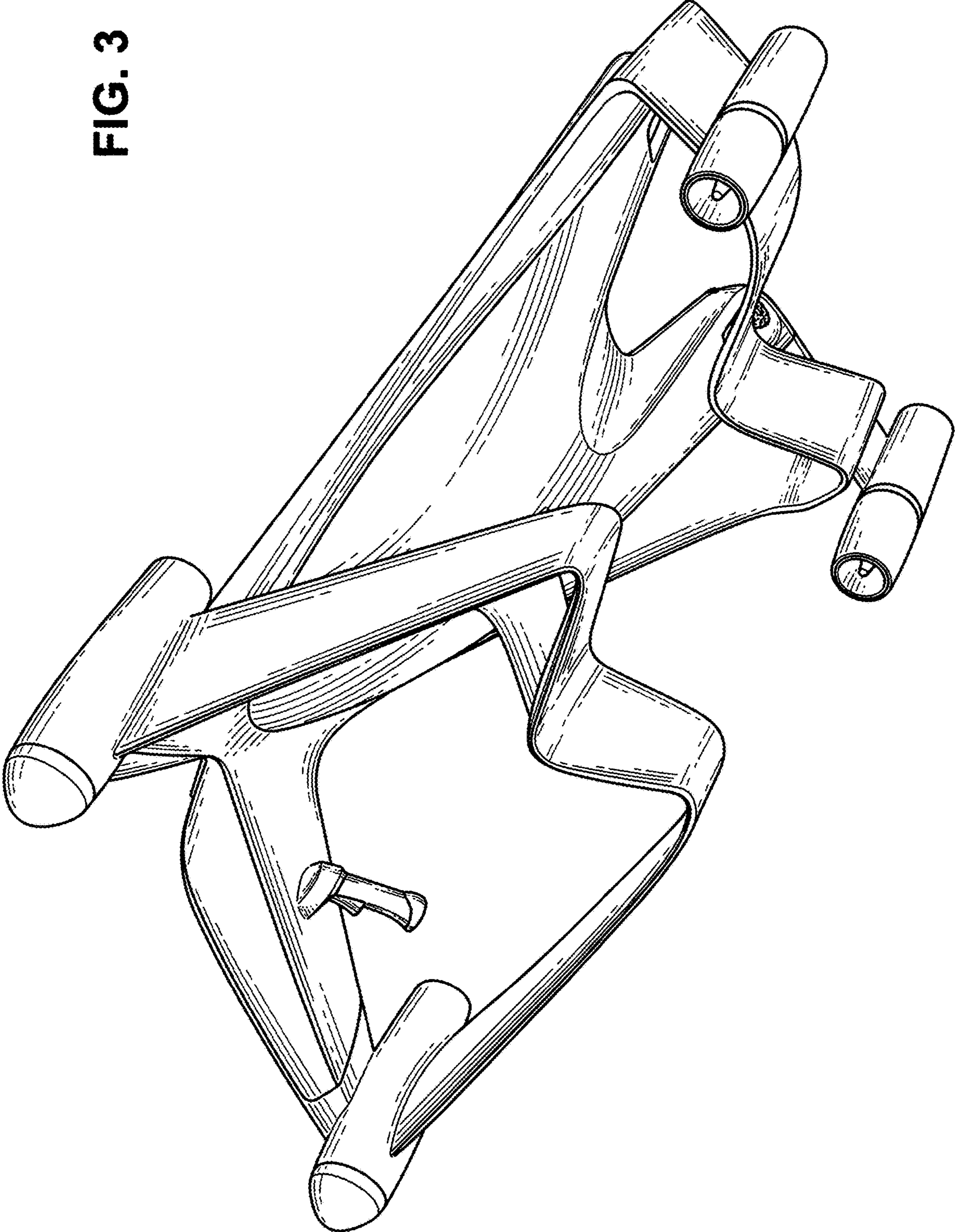

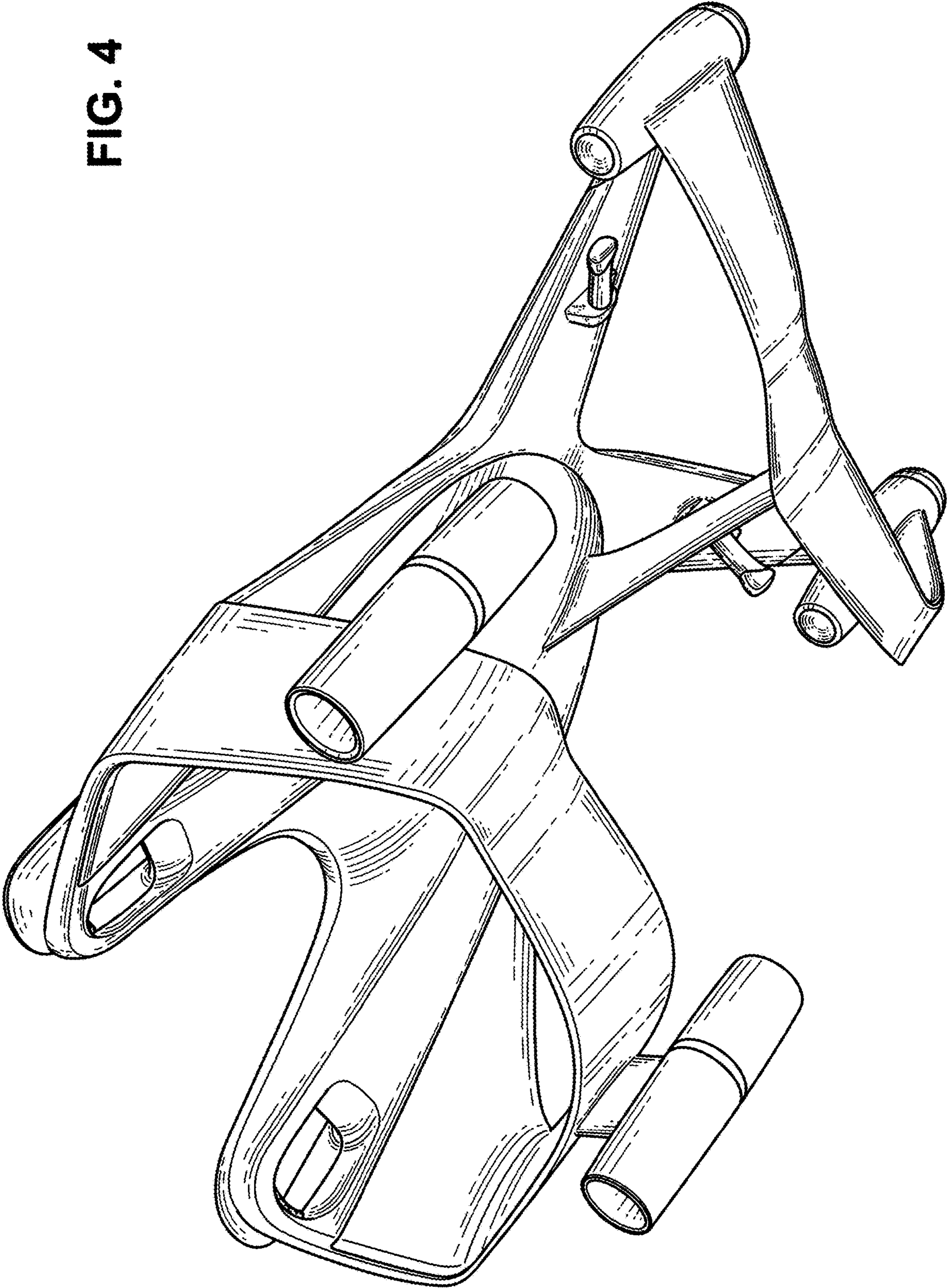

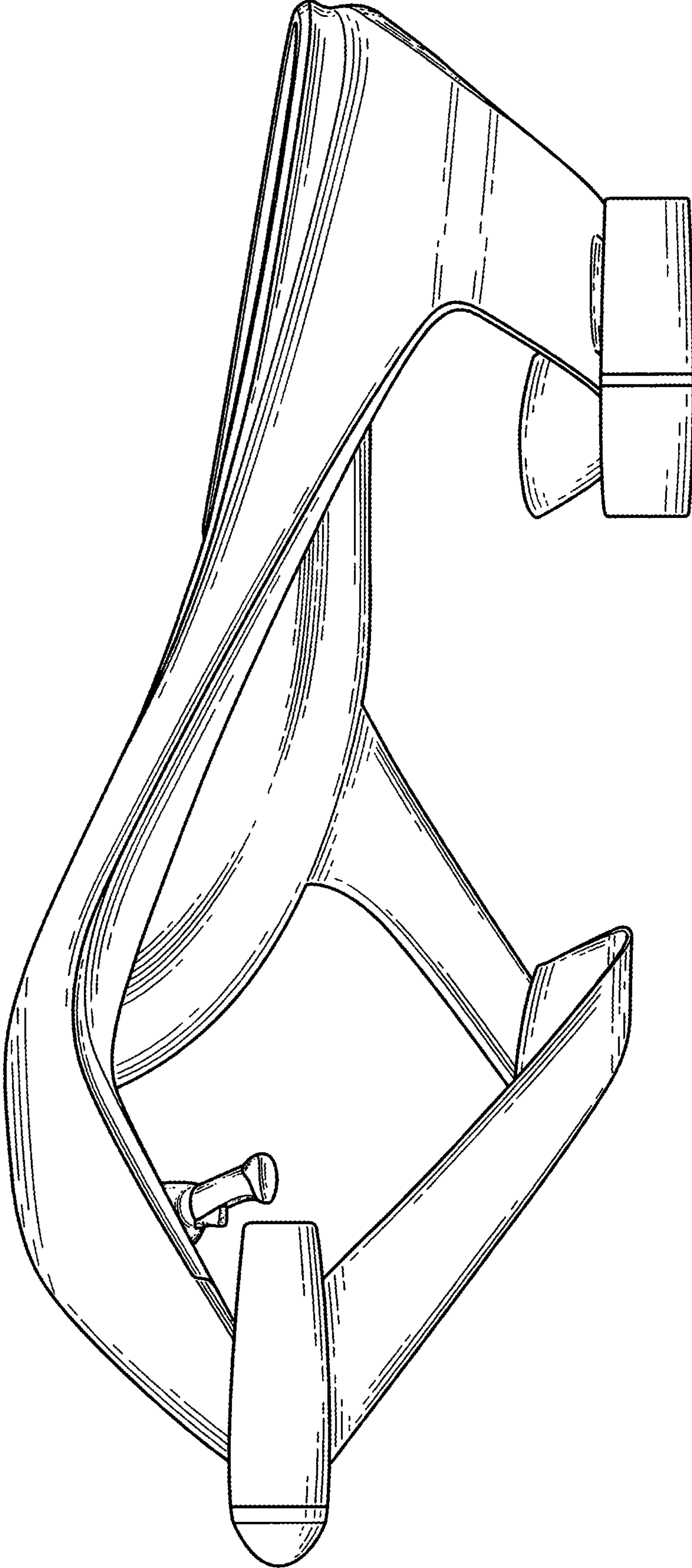

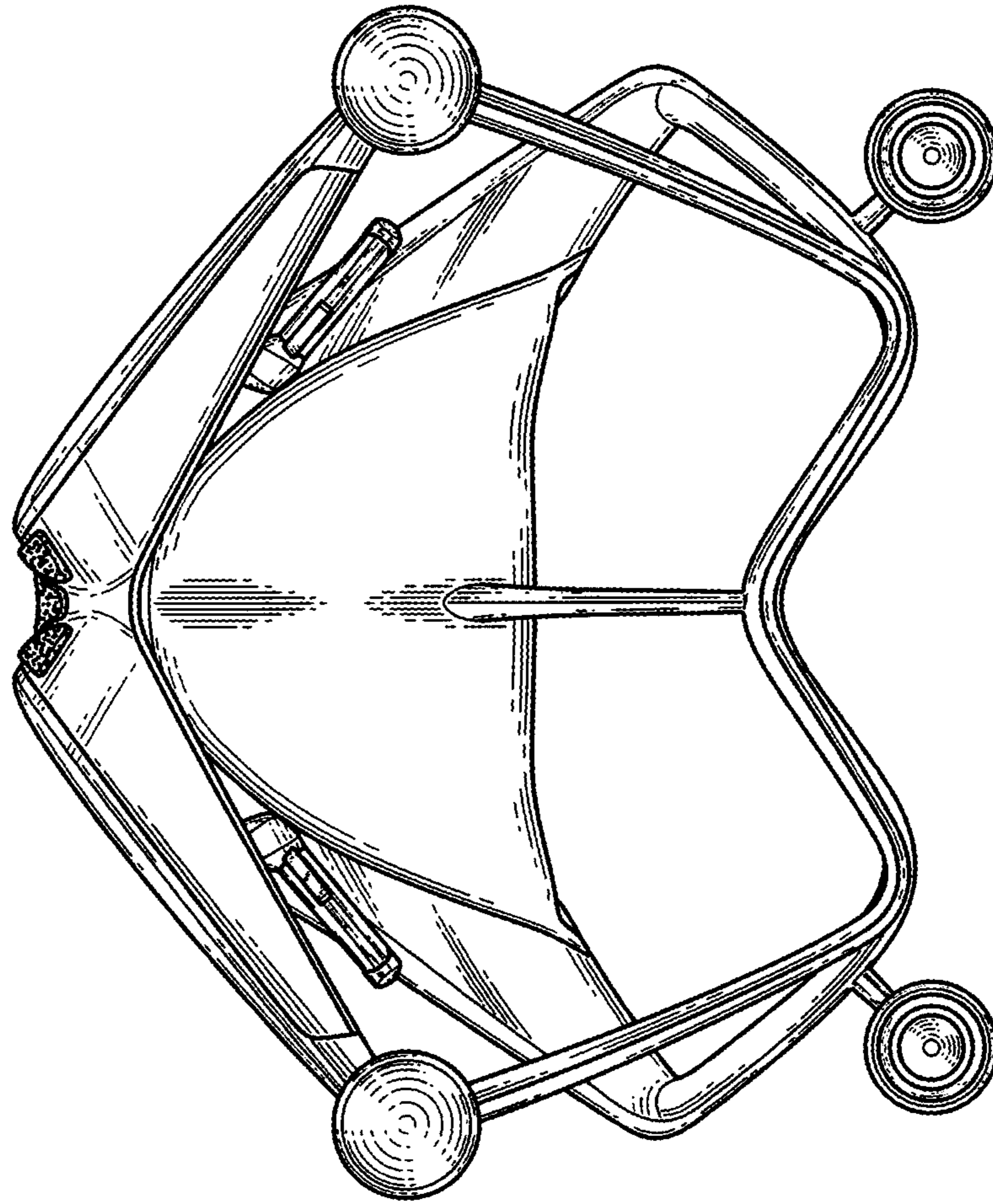
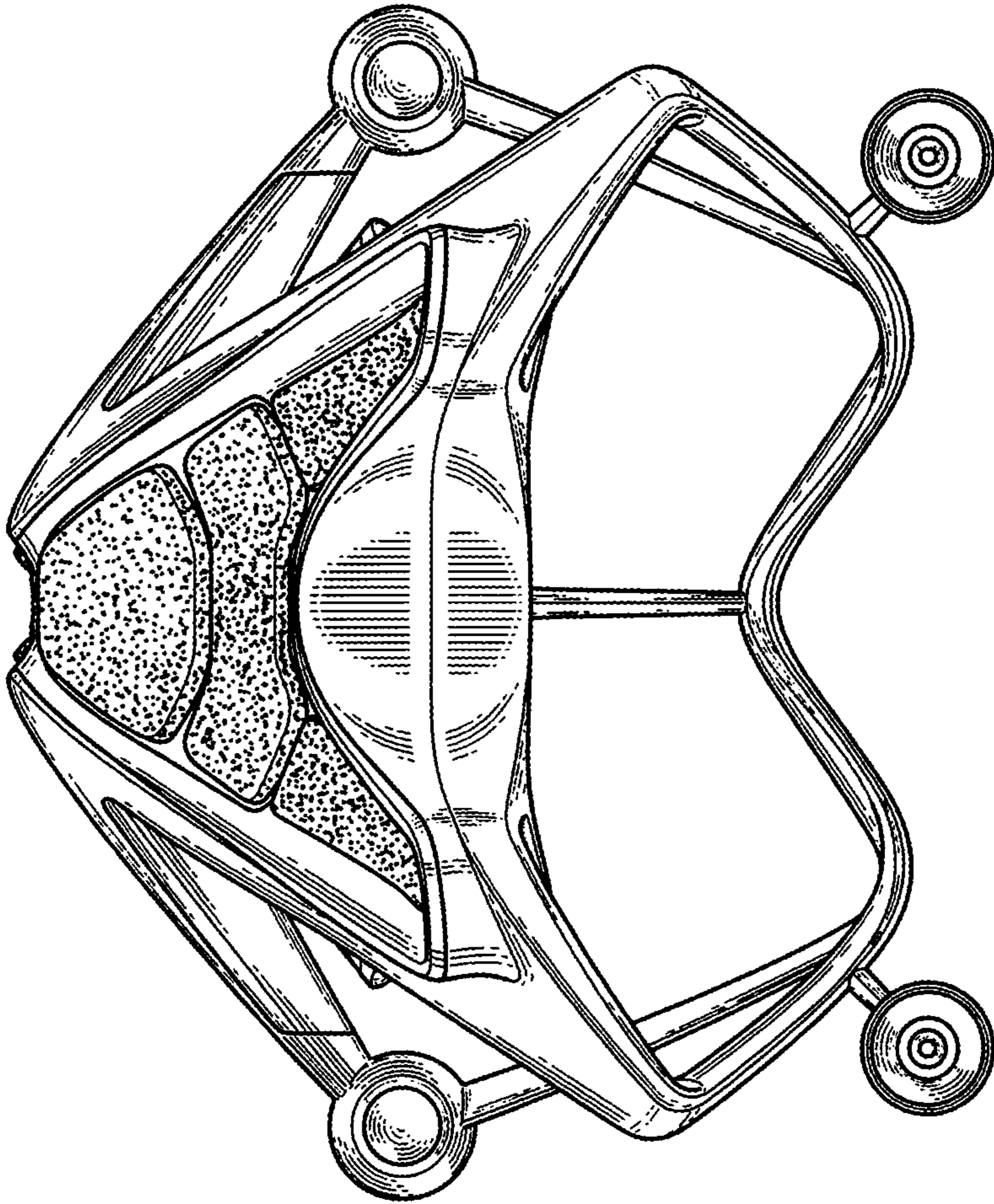

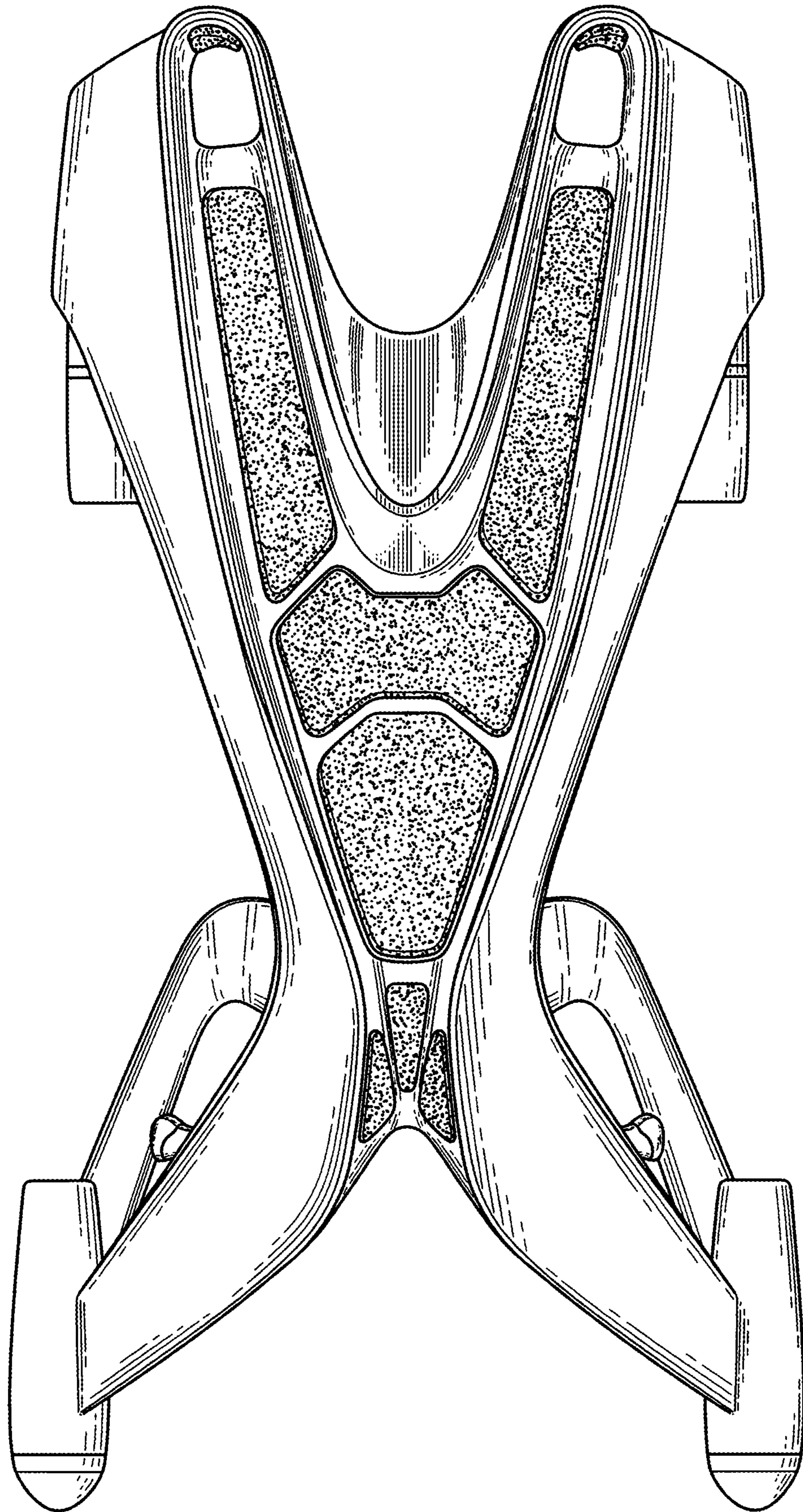

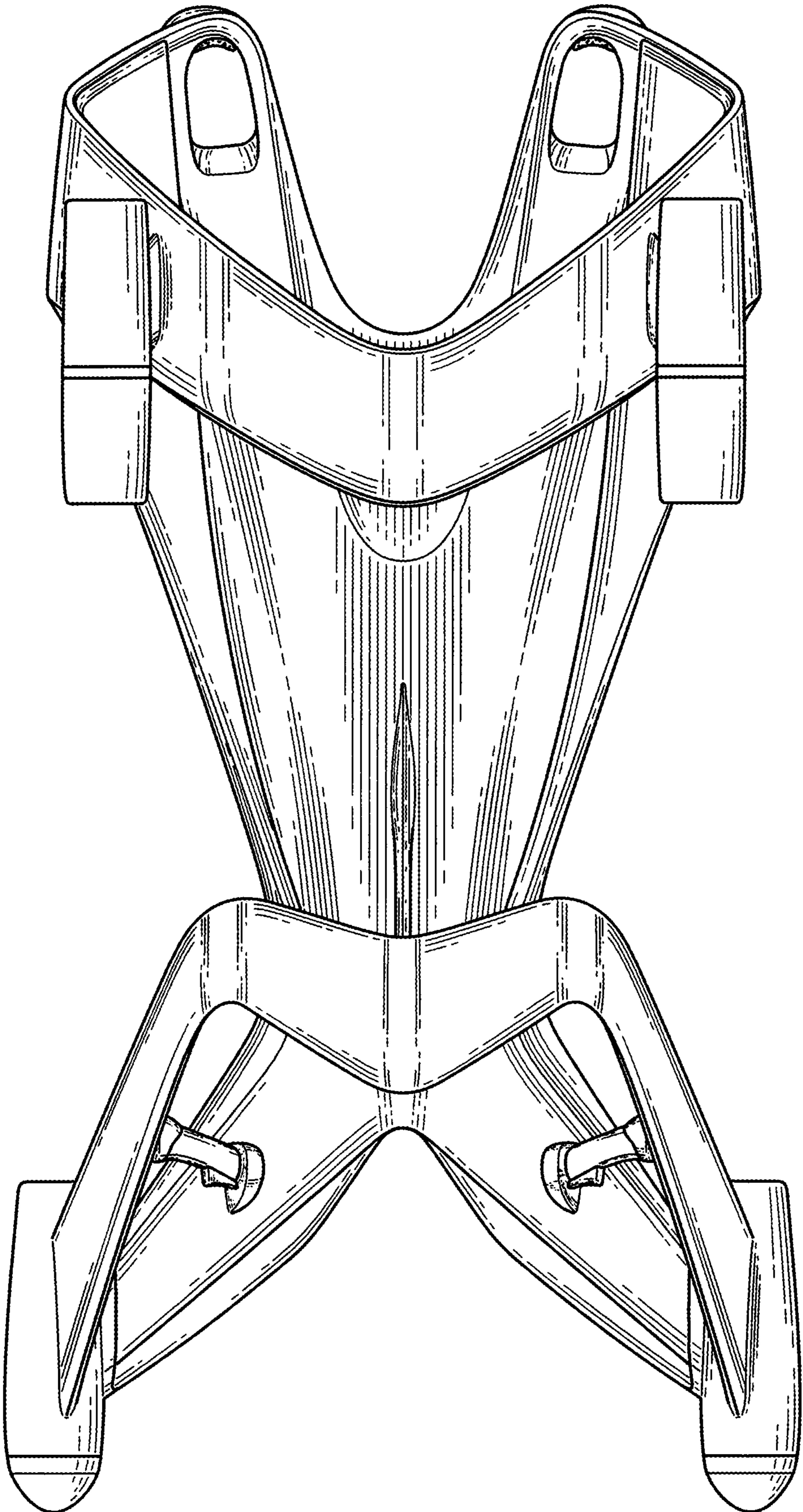

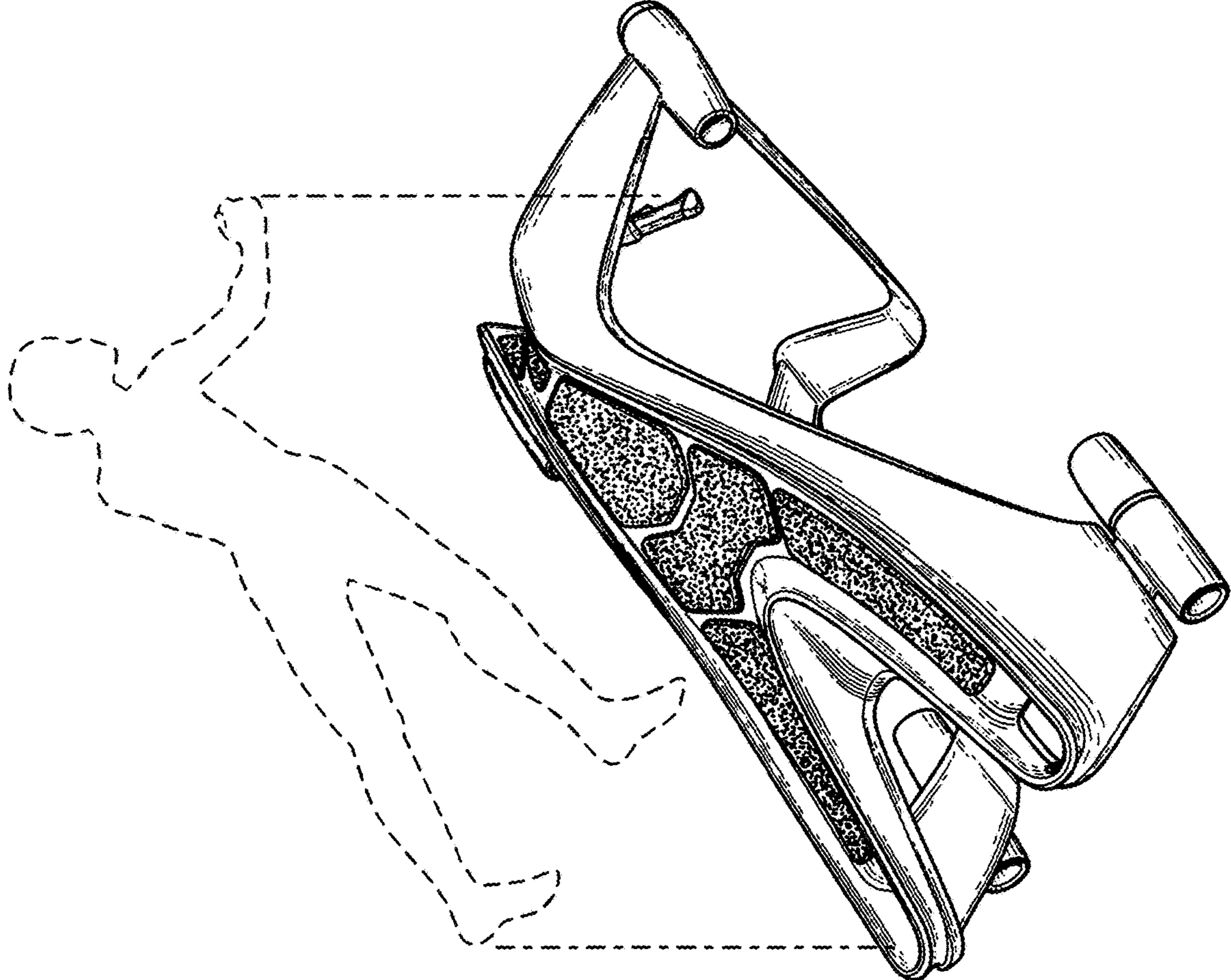
