FIG. 1 is a front perspective view of the indoor wall with built-in home appliances showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left view thereof; FIG. 5 is a right view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a reference view showing the state of use that the front center cover has been pushed inside; FIG. 9 is a reference view showing the state of use that the front center cover has been pushed inside and the front upper and bottom cover is being pushed upward and downward respectively; FIG. 10 is a reference view showing the state of use that the front center cover has been pushed inside the front upper cover has been pushed upward and the widgets to provide the user with the various information on the TV which is installed at the front center of the upper part; FIG. 11 is a front perspective view in a condition that the front inner part has been exposed; FIG. 12 is a front view of FIG. 11; FIG. 13 is a rear view of FIG. 11; FIG. 14 is a left view of FIG. 11; FIG. 15 is a right view of FIG. 11; FIG. 16 is a top view of FIG. 11; FIG. 17 is a bottom view of FIG. 11; and, FIG. 18 is a reference view showing the state of use that the television which is installed at the front center of the claimed design can be used.

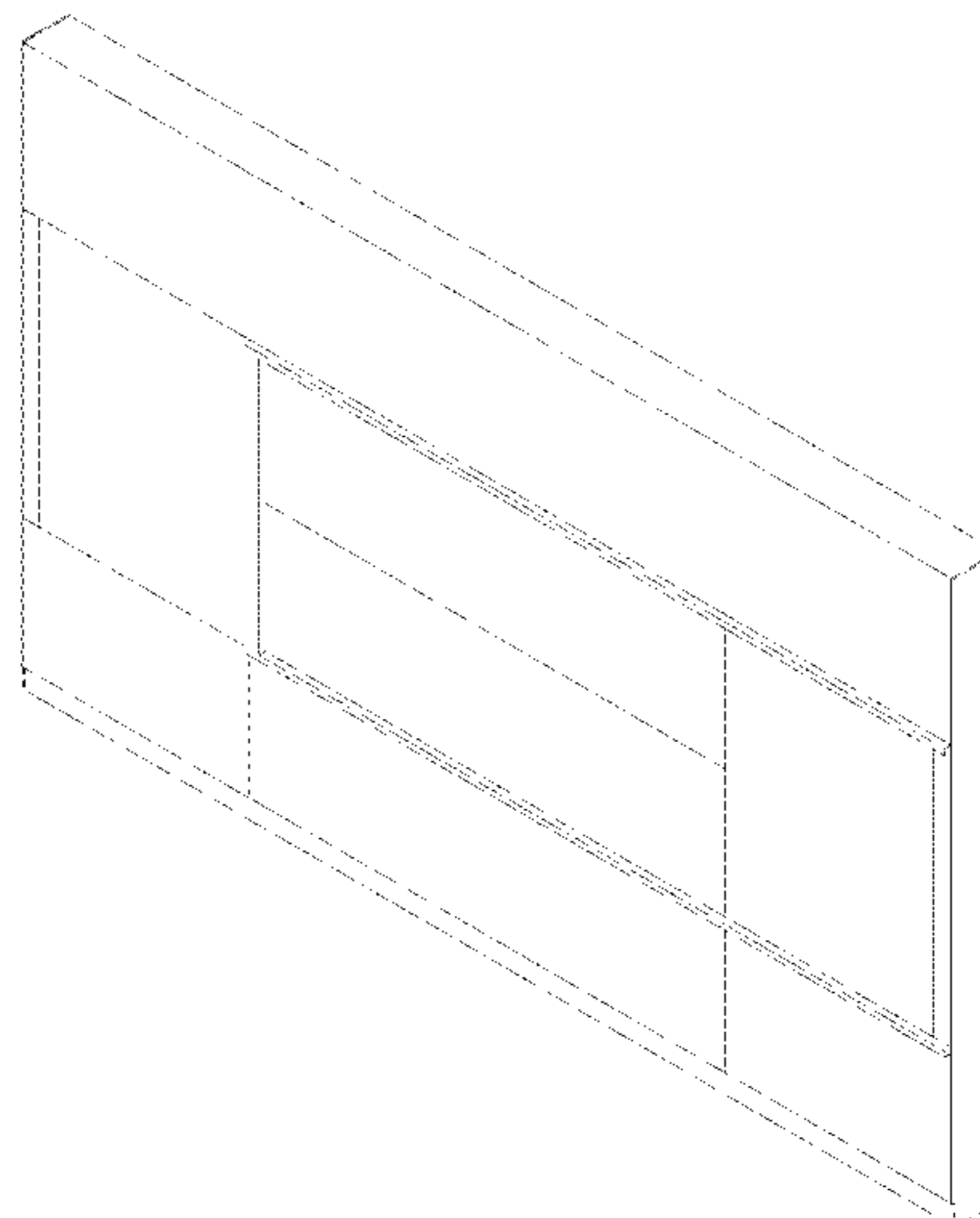

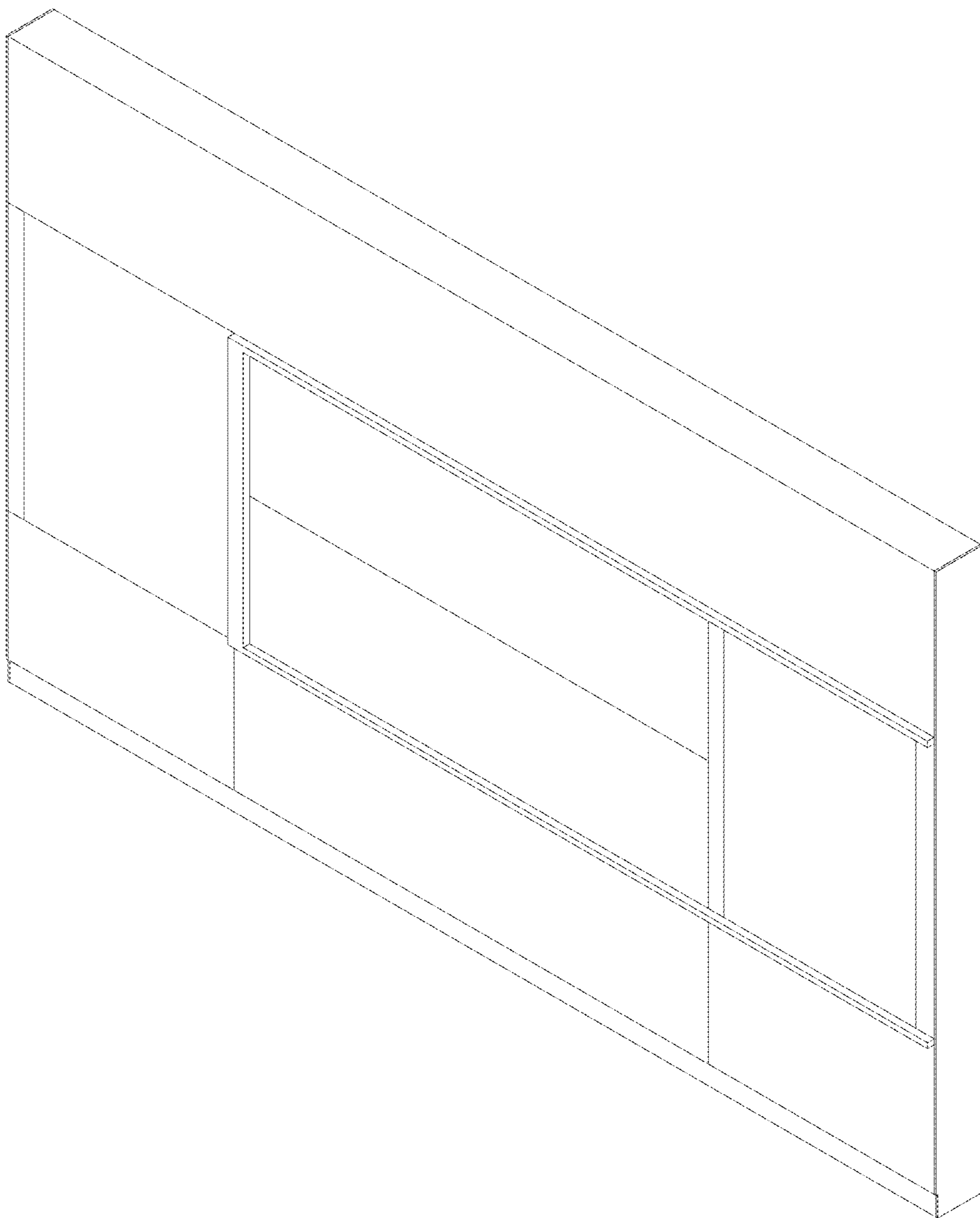

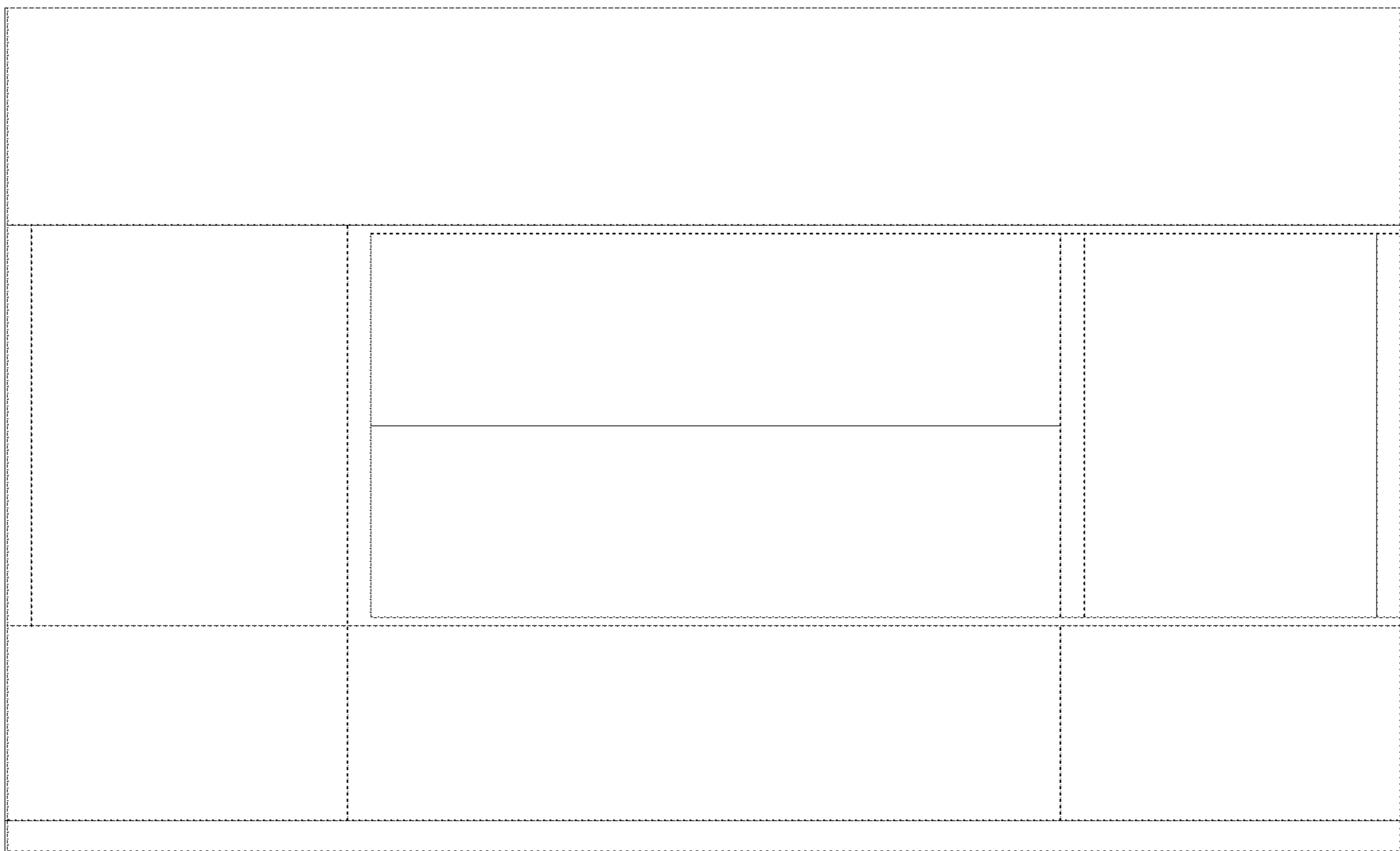

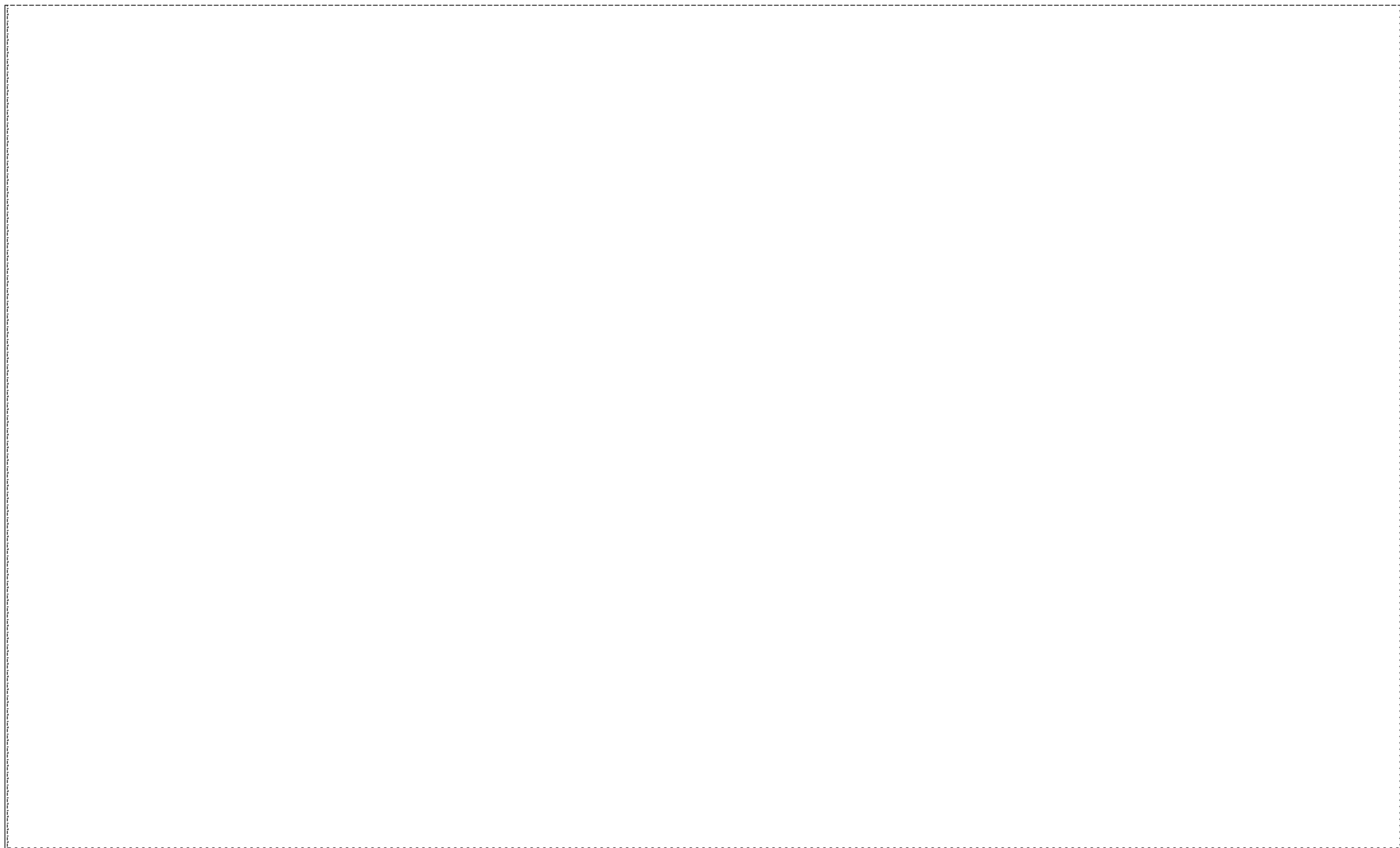

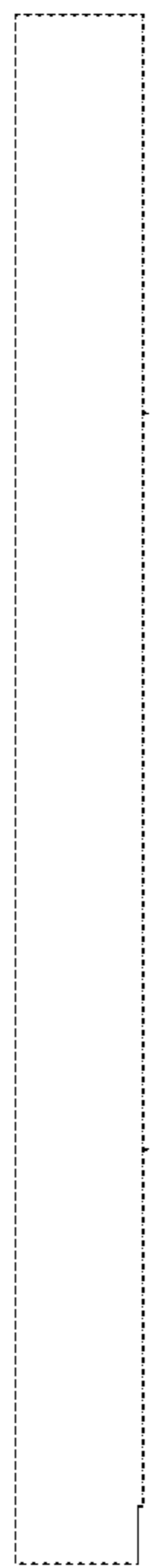

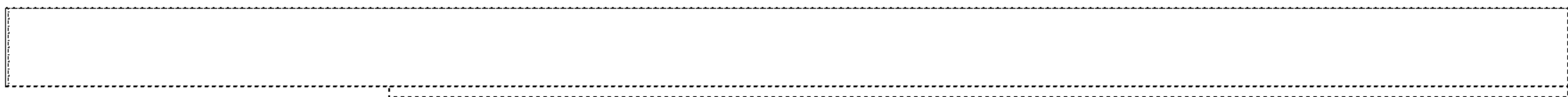

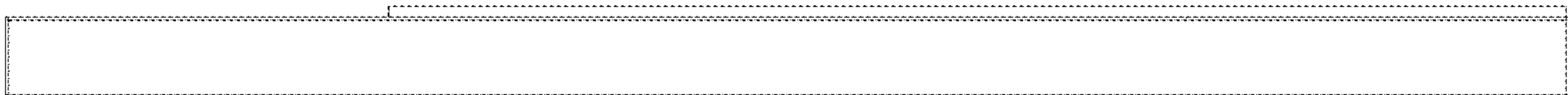

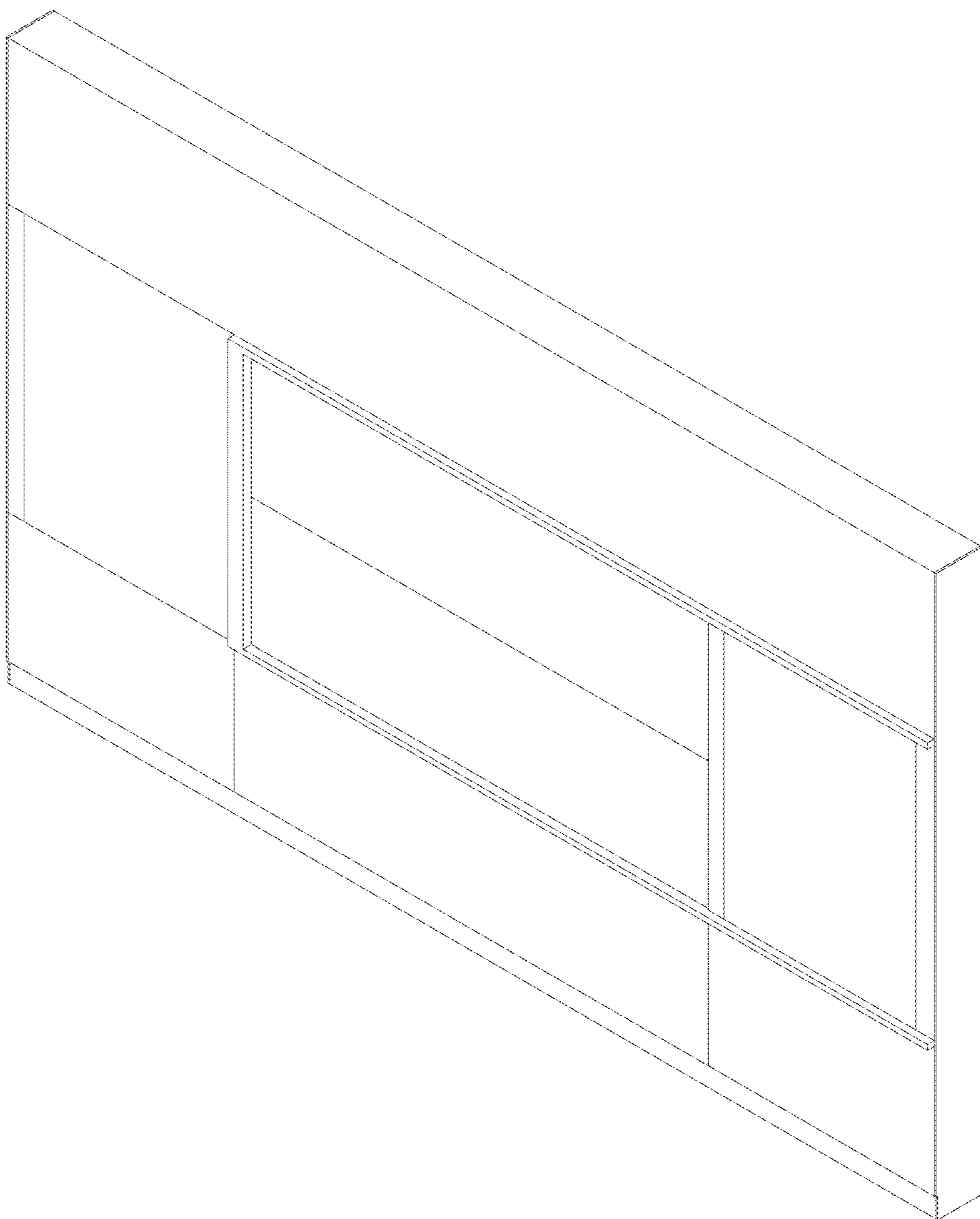

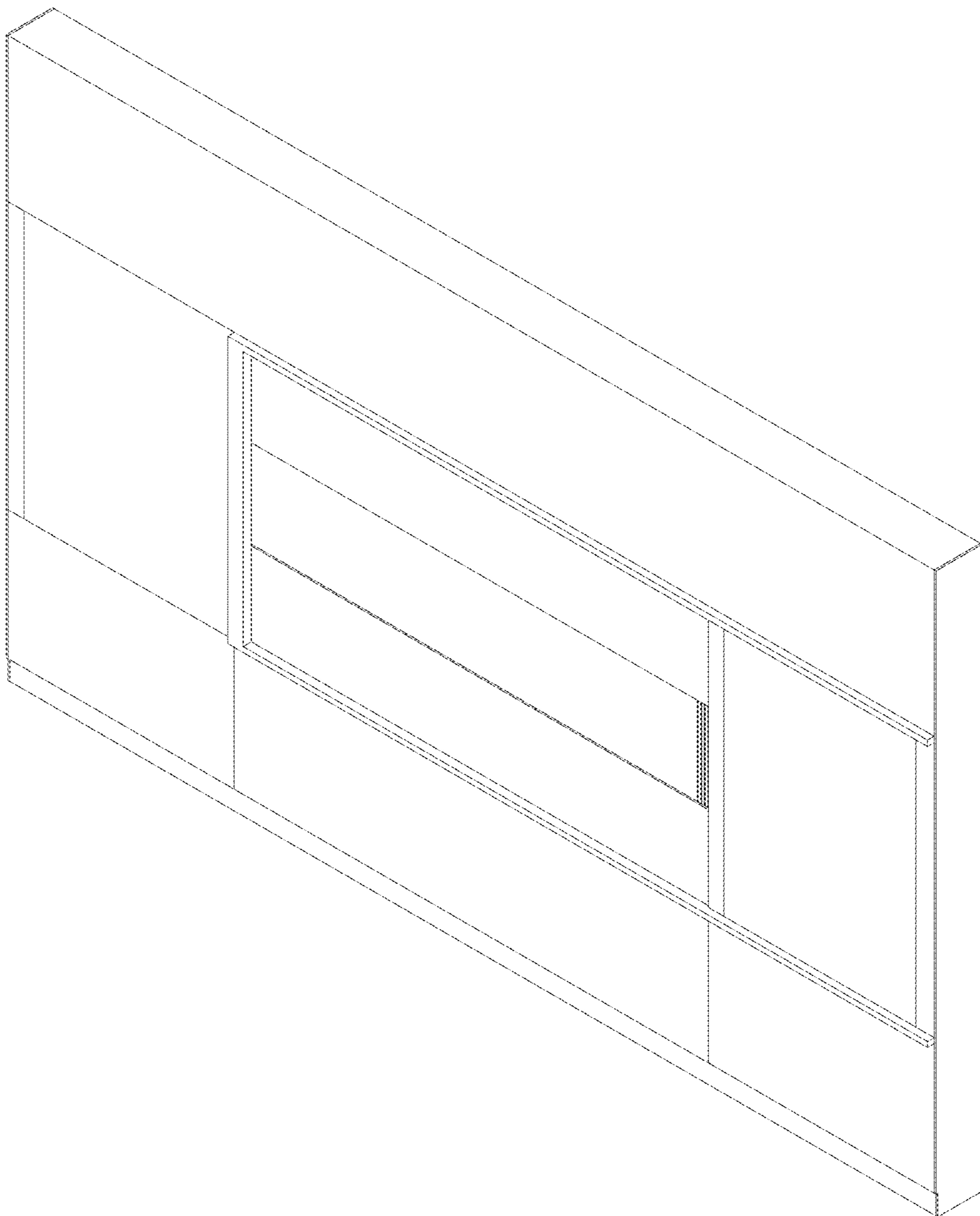

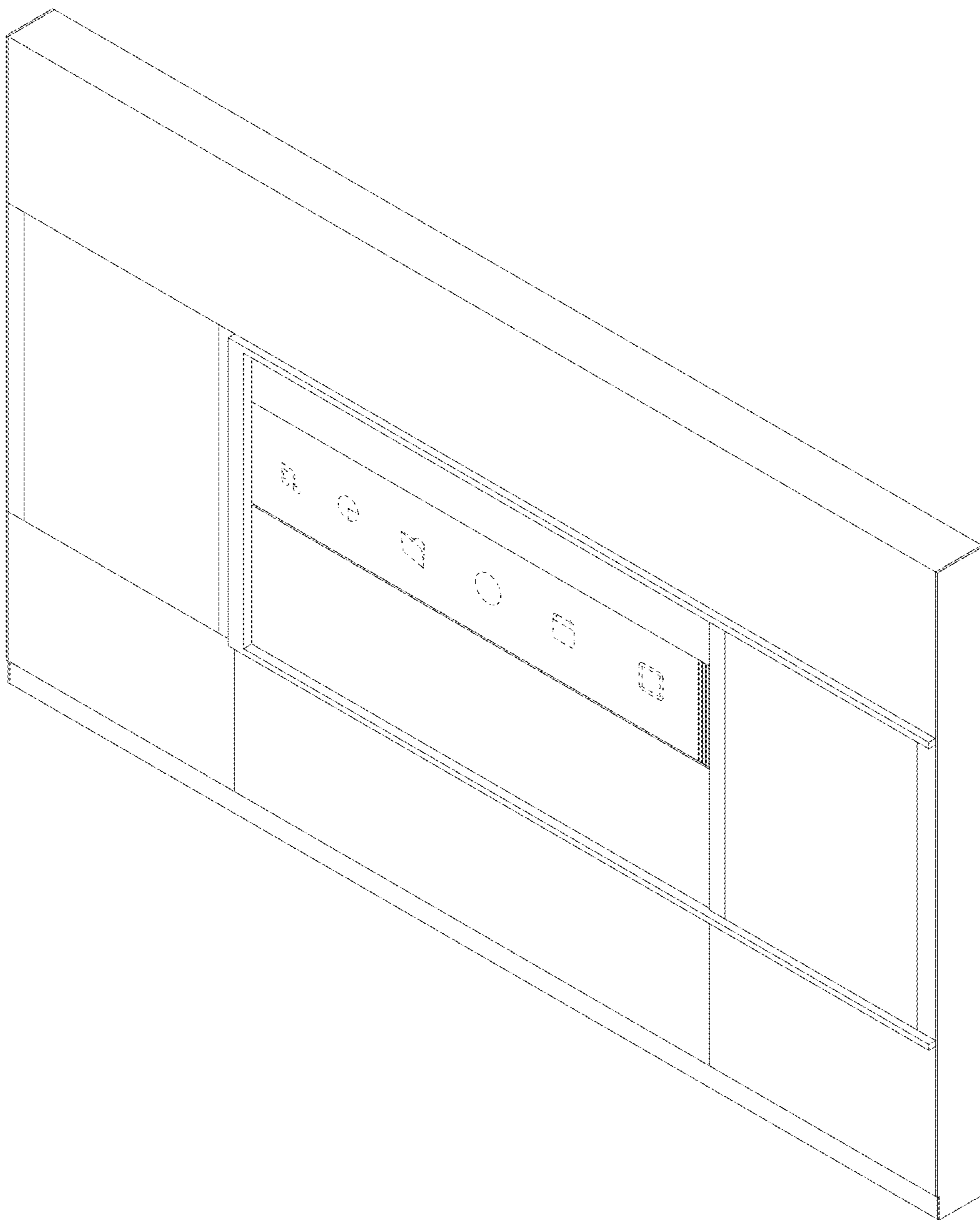

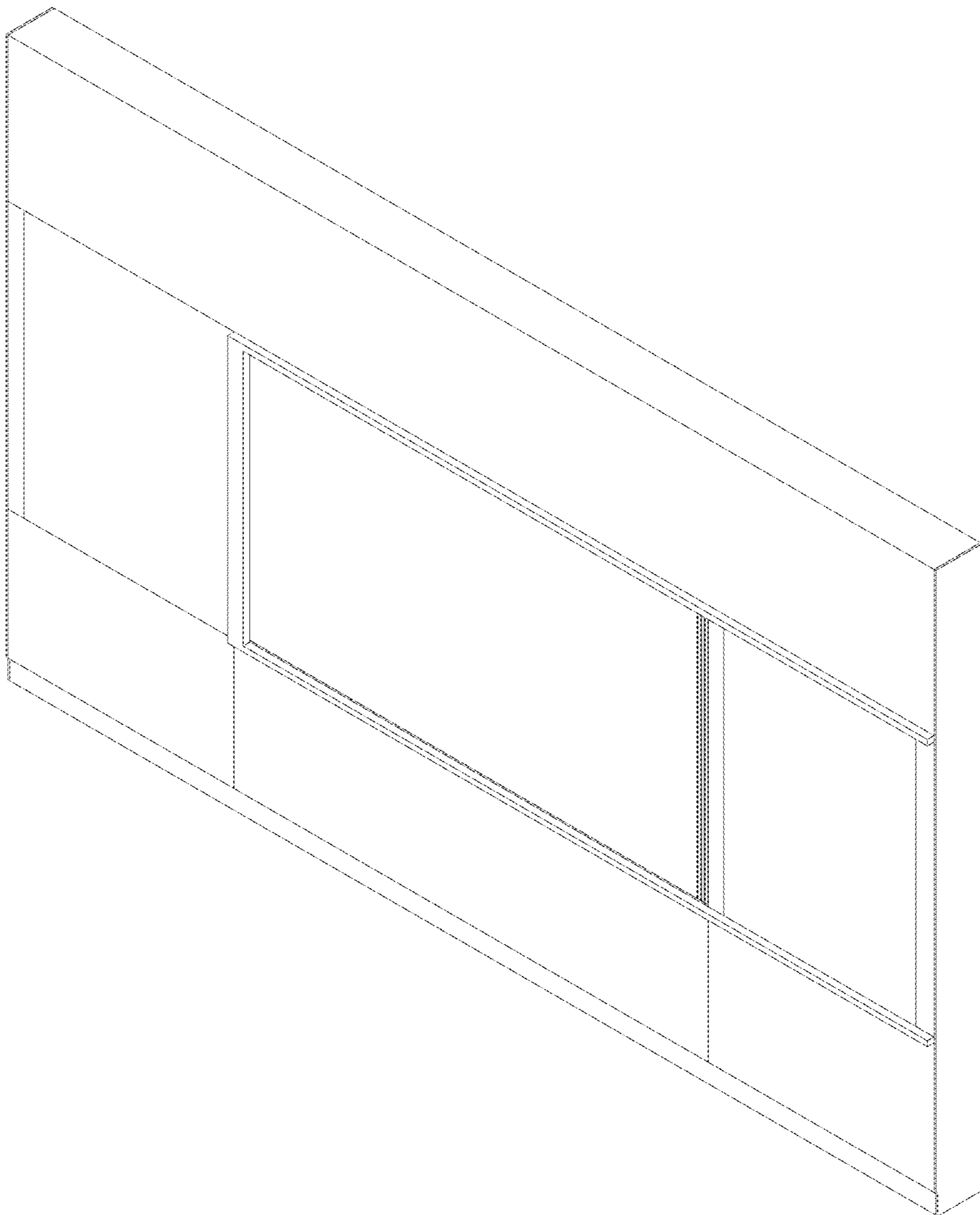

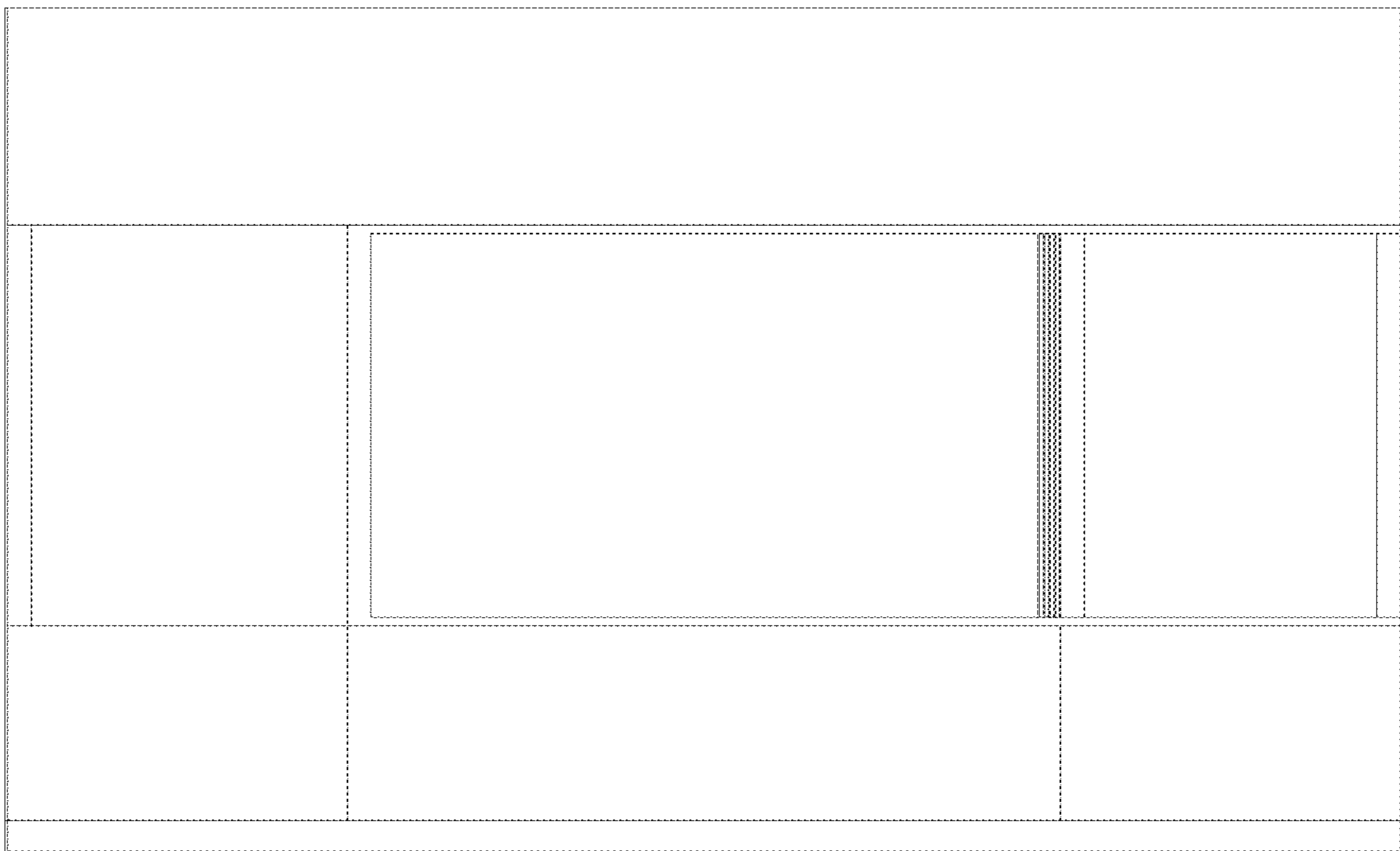

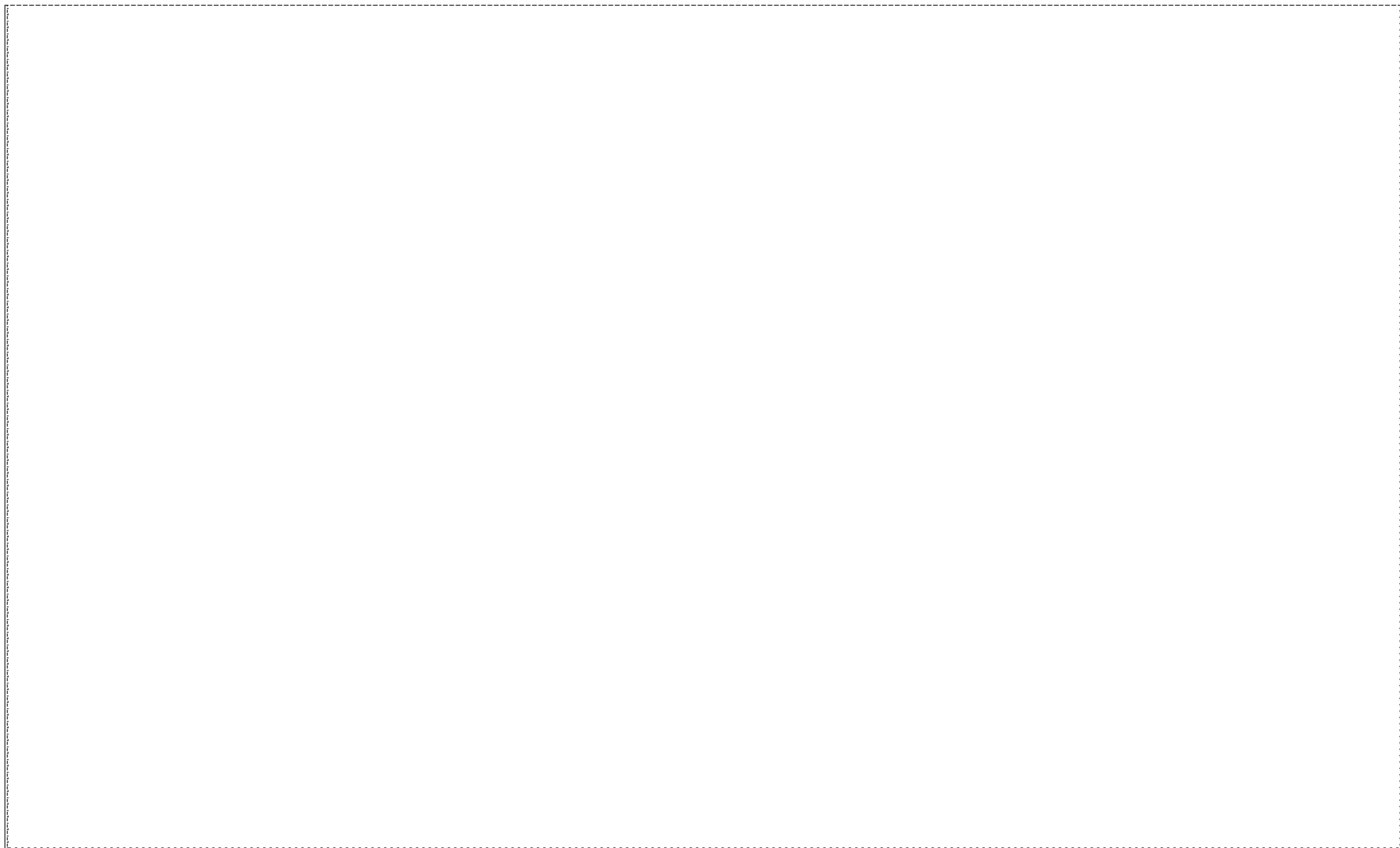

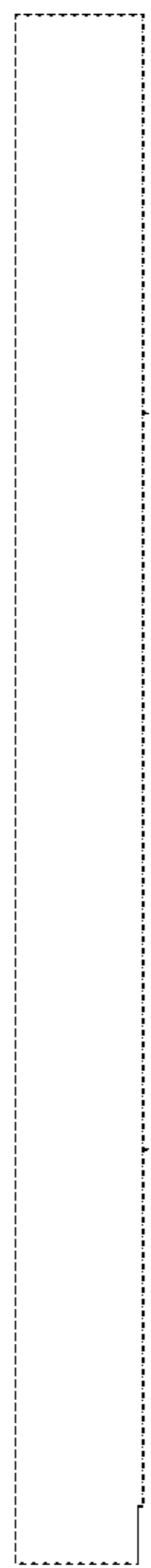

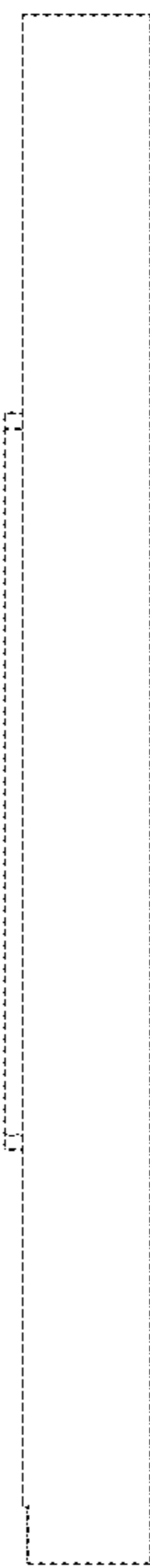

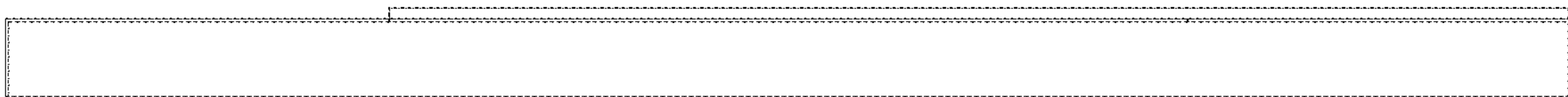
