(57) **CLAIM**

The ornamental design for an ear tip, substantially as shown  
and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an ear tip for the right ear of  
a user, as seen from the front, top, and left side, “left” being  
from the observer’s point of view;

FIG. 2 is front view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a back view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top end view thereof;

FIG. 7 is a bottom end view thereof;

FIG. 8 is a perspective view of a second implementation of  
an ear tip, for the left ear of a user, as seen from the front,  
top, and right side;

FIG. 9 is front view thereof;

FIG. 10 is a right side view thereof;

FIG. 11 is a back view thereof;

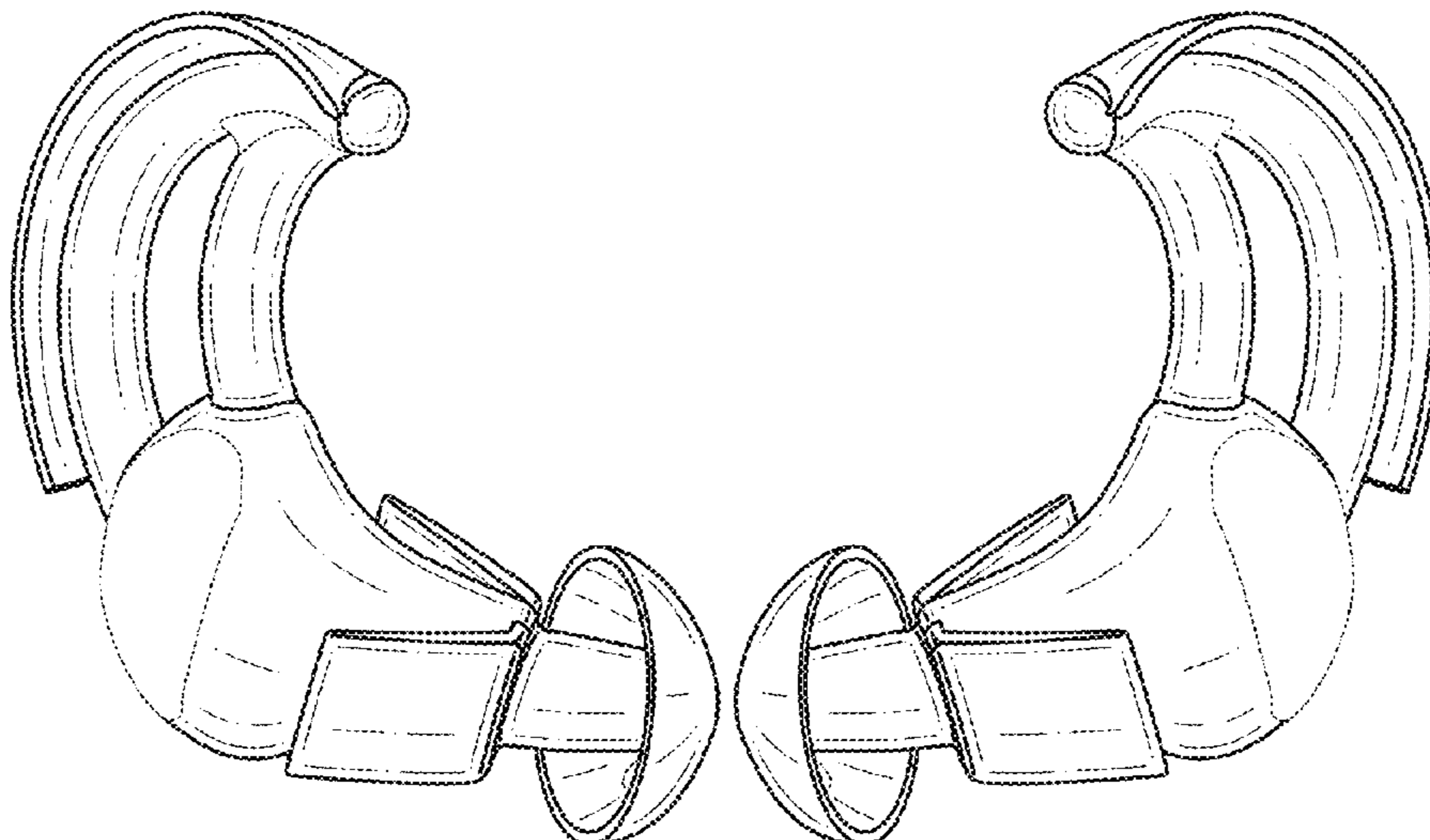
FIG. 12 is a left side view thereof;

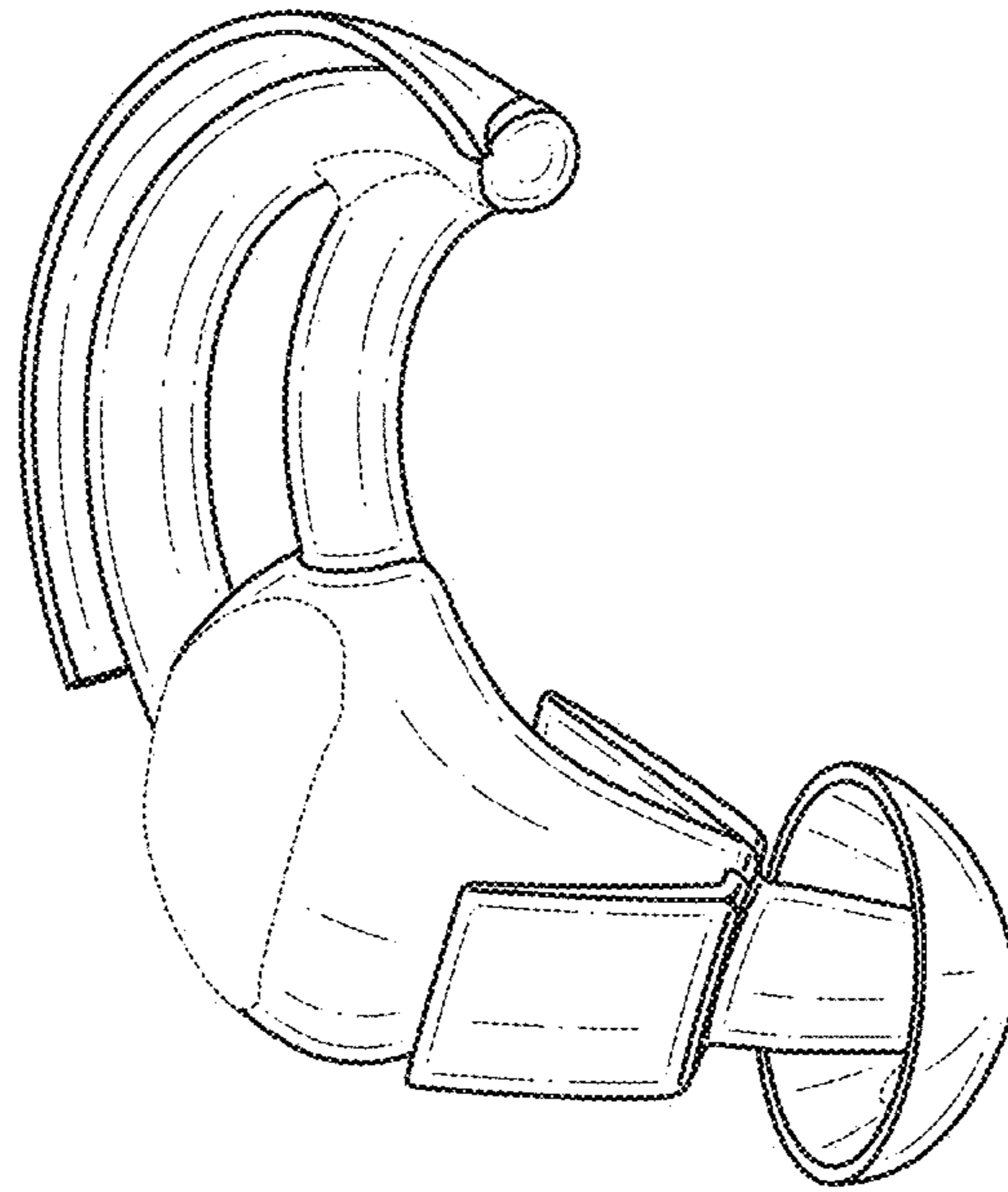

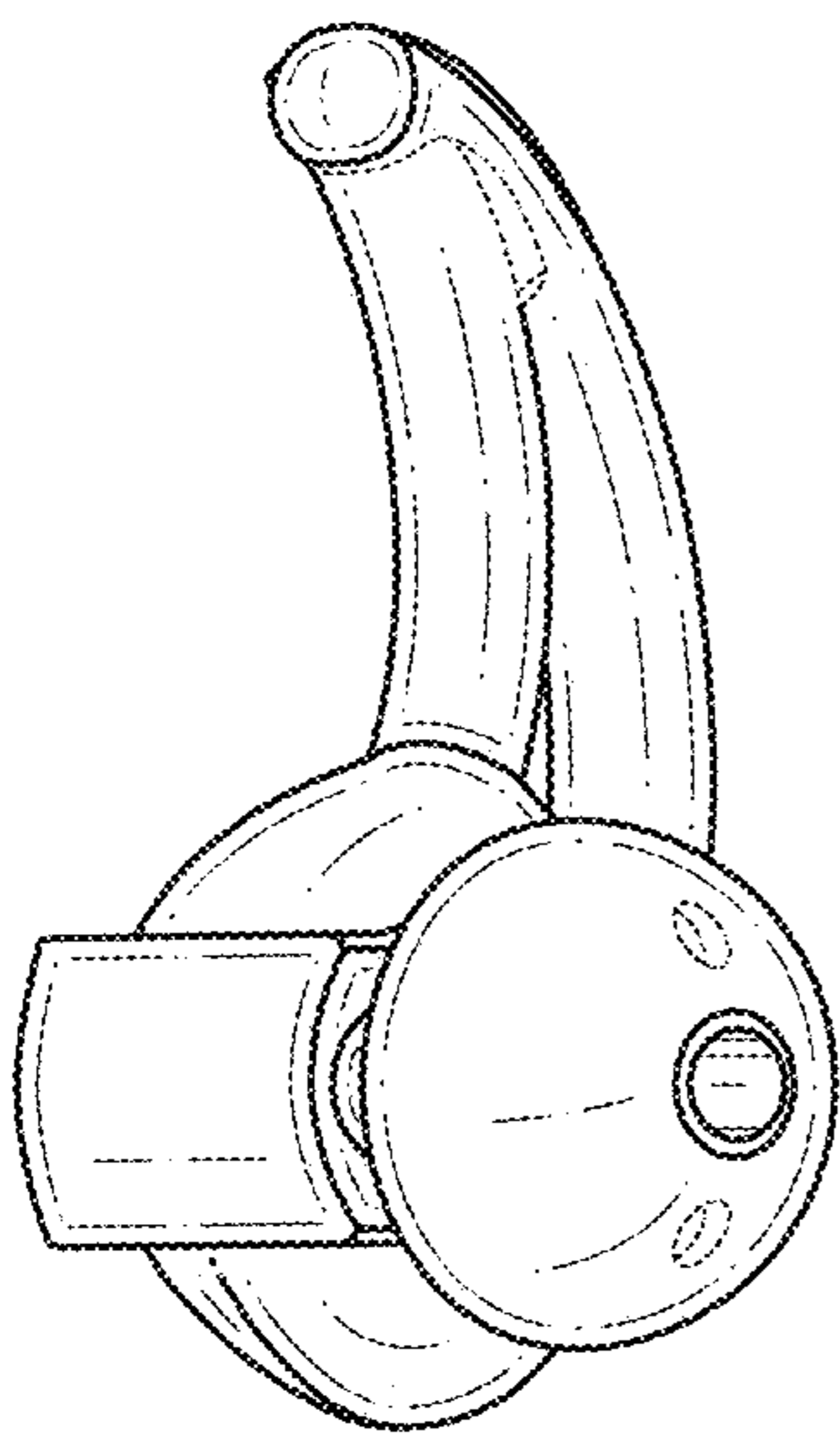

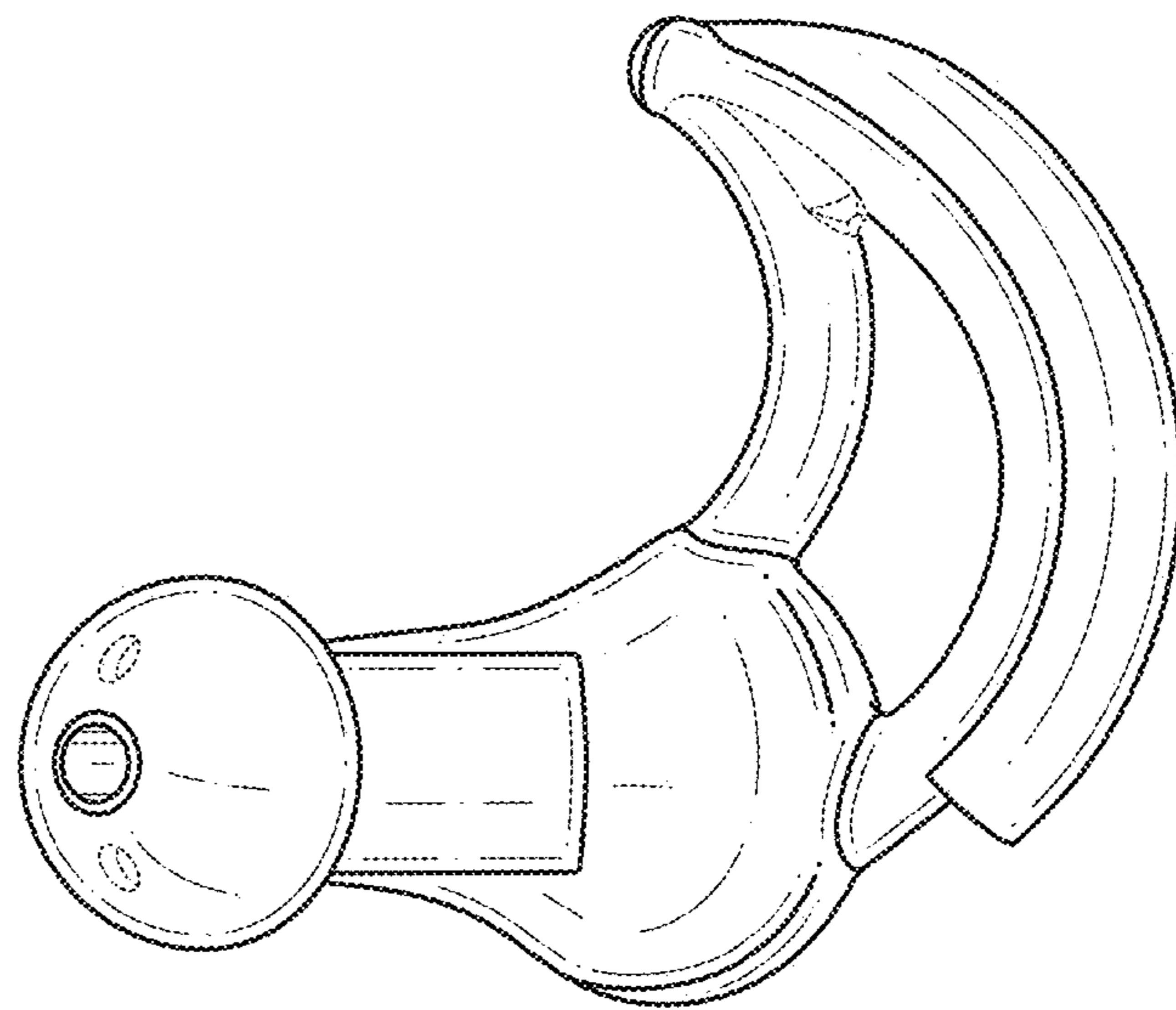




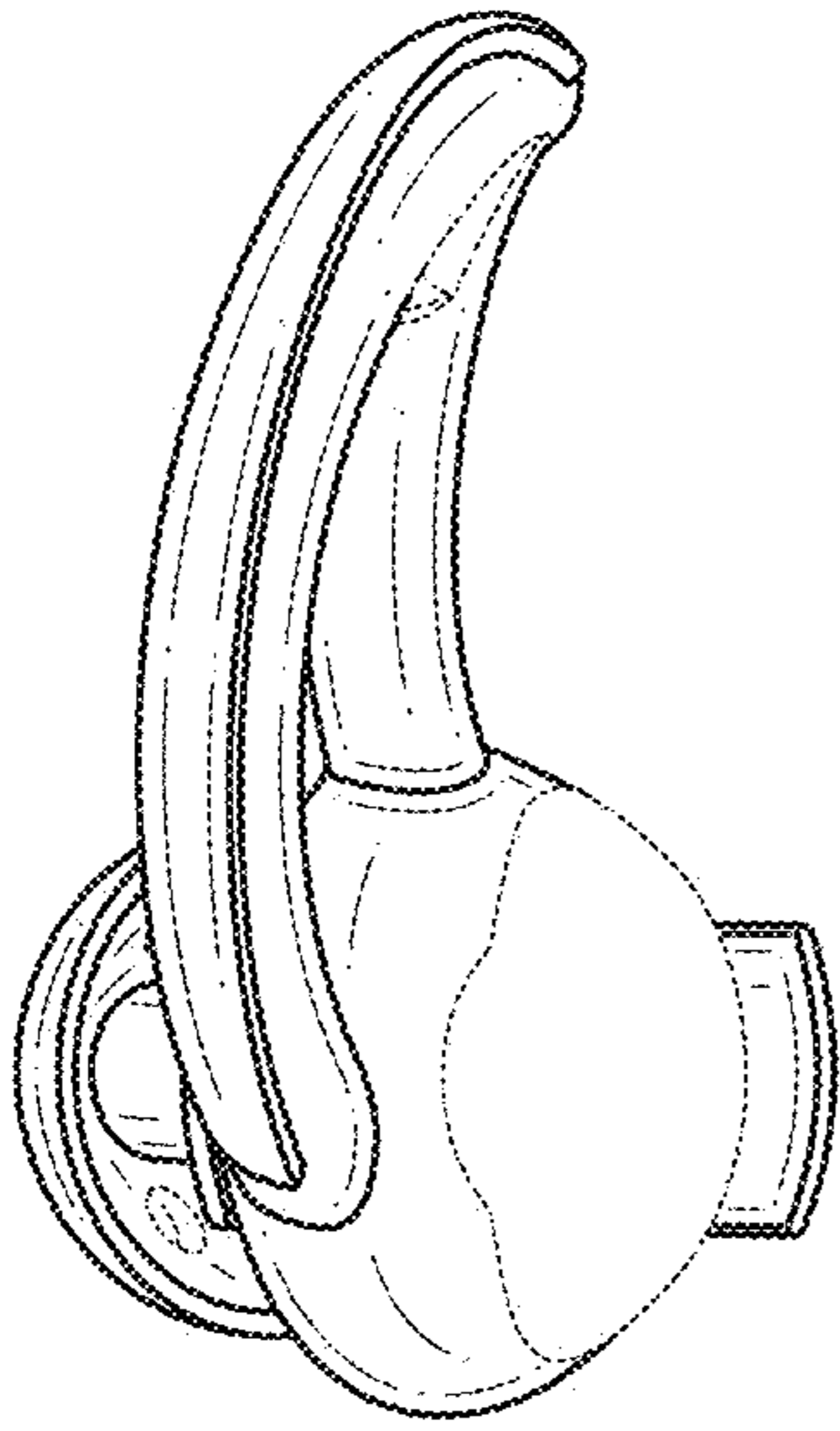

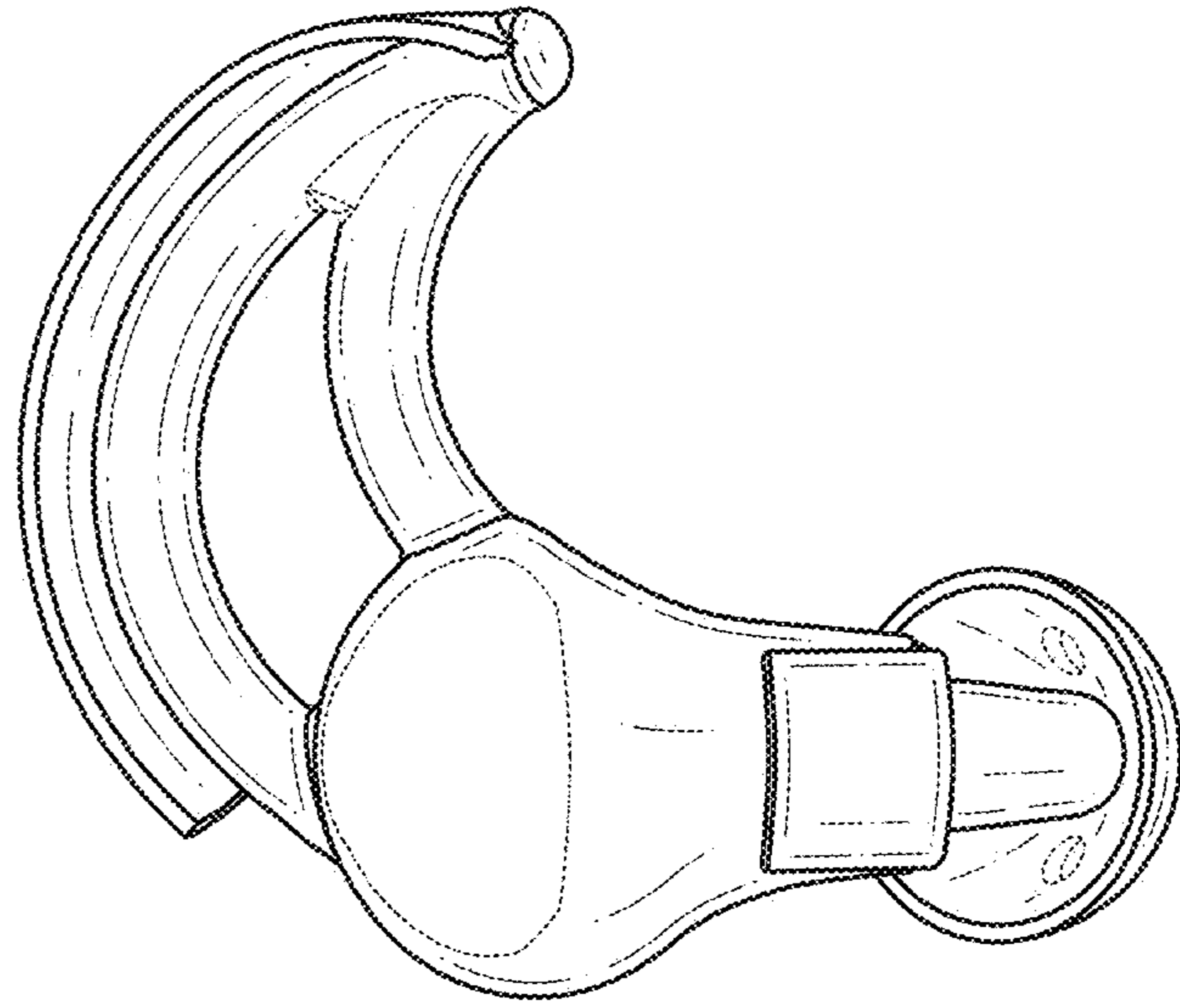

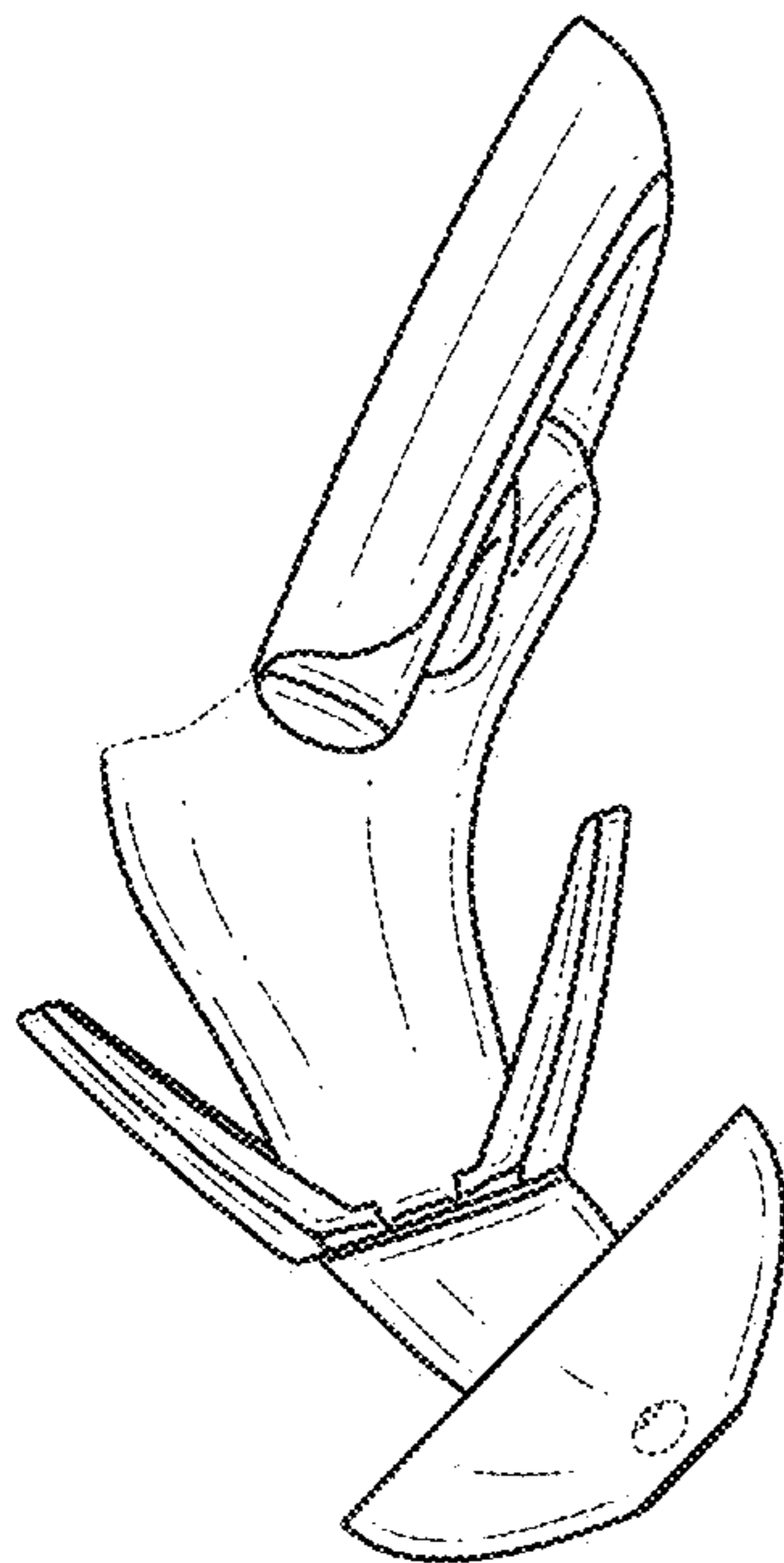

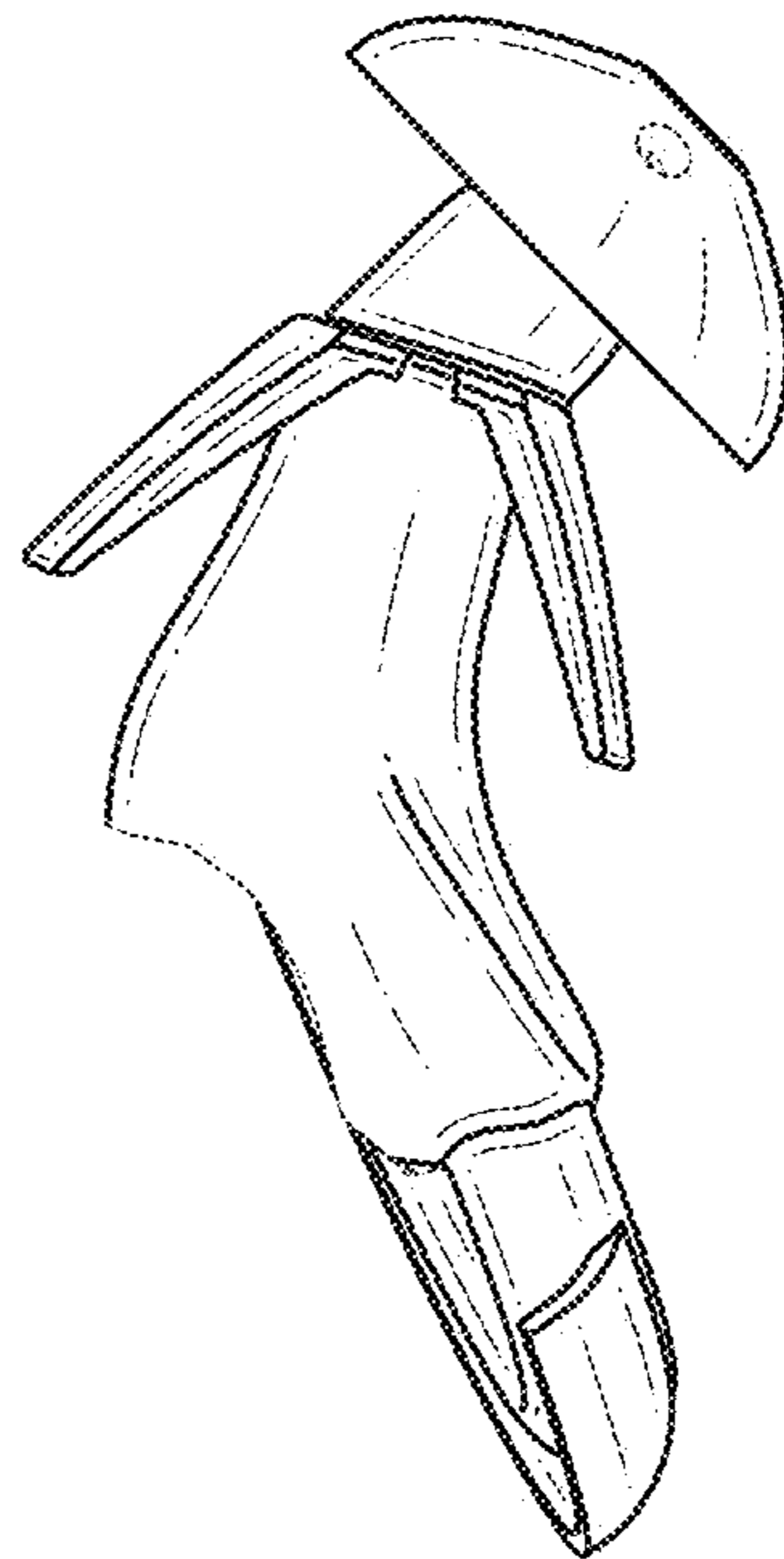

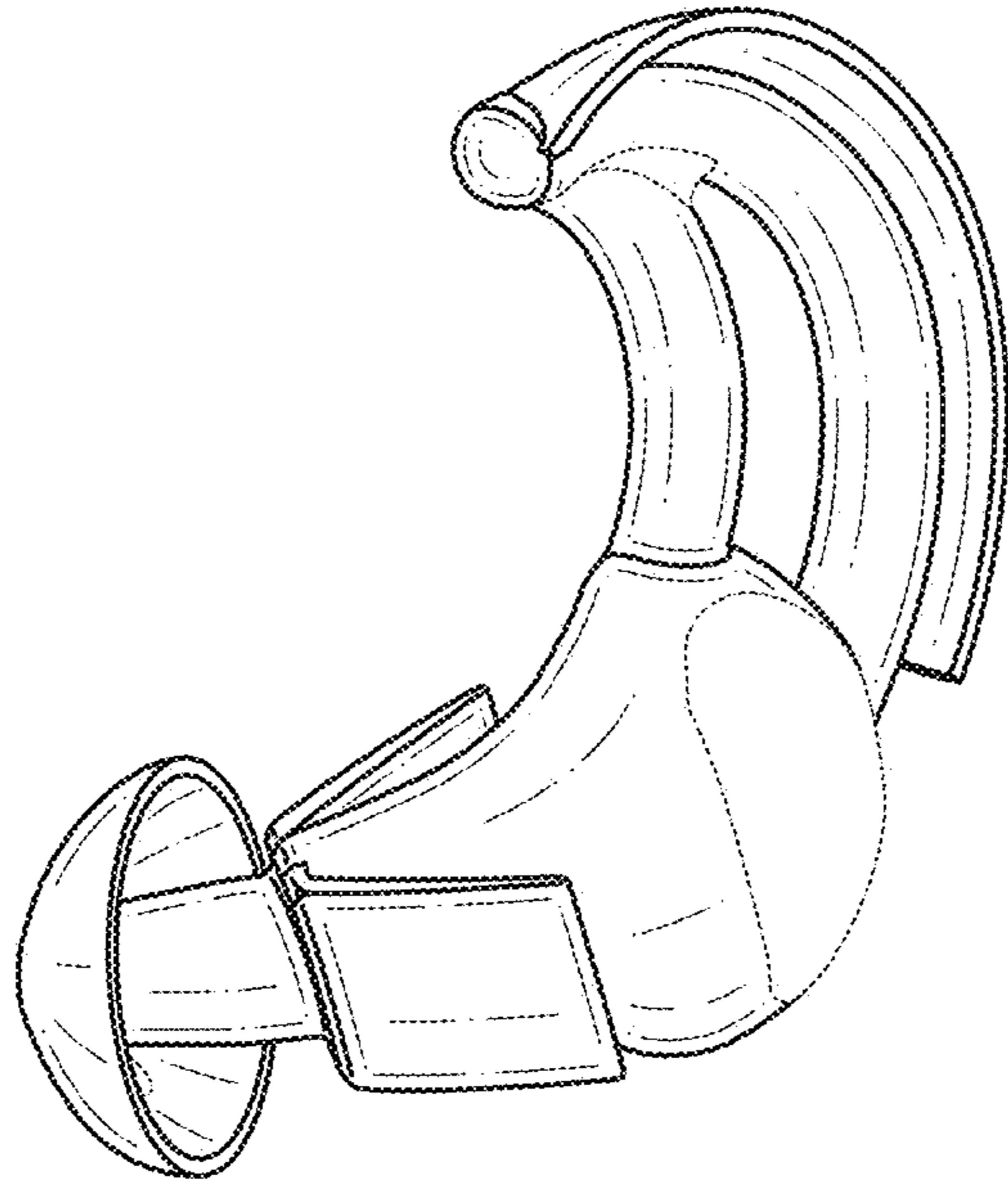

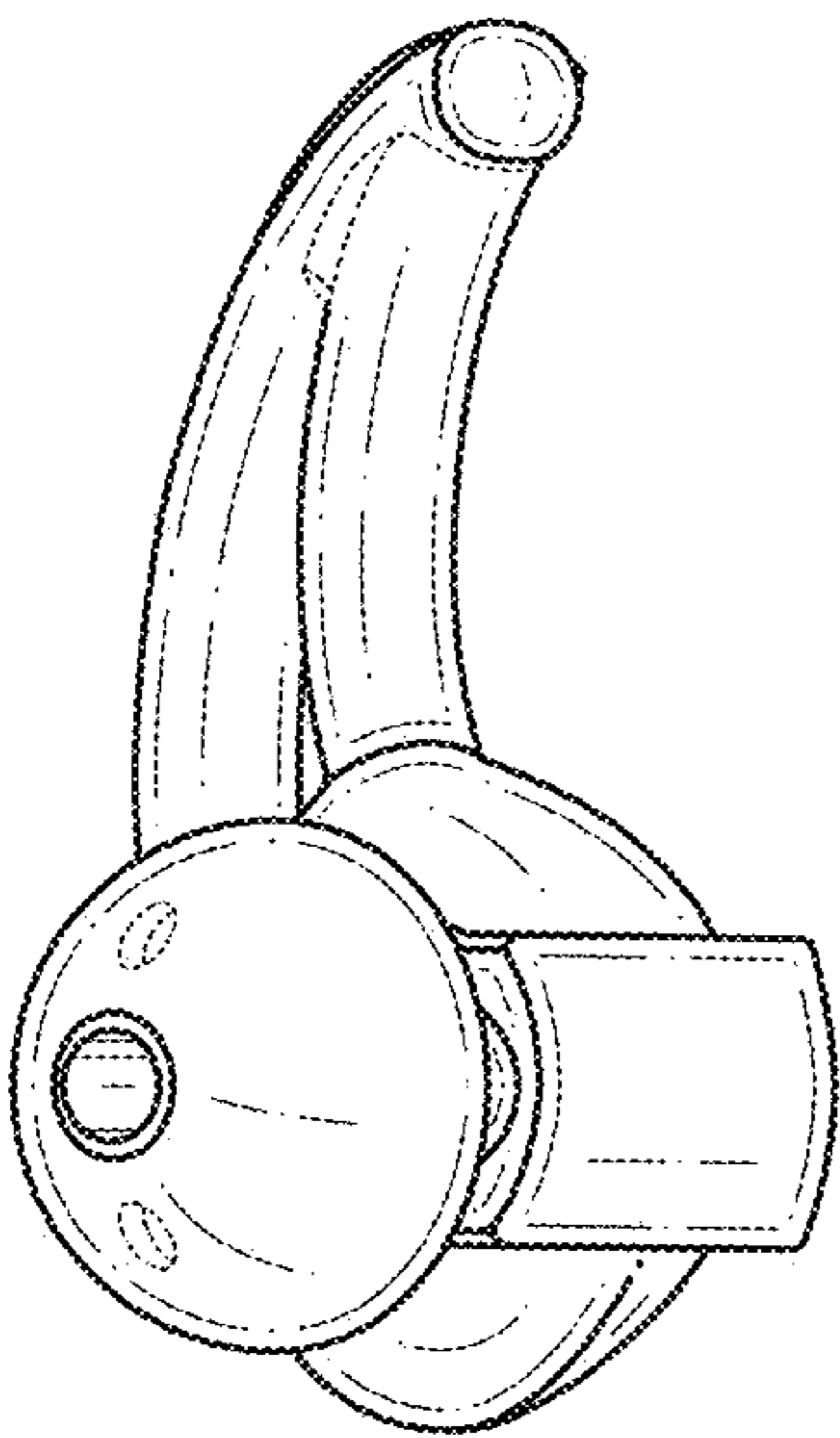

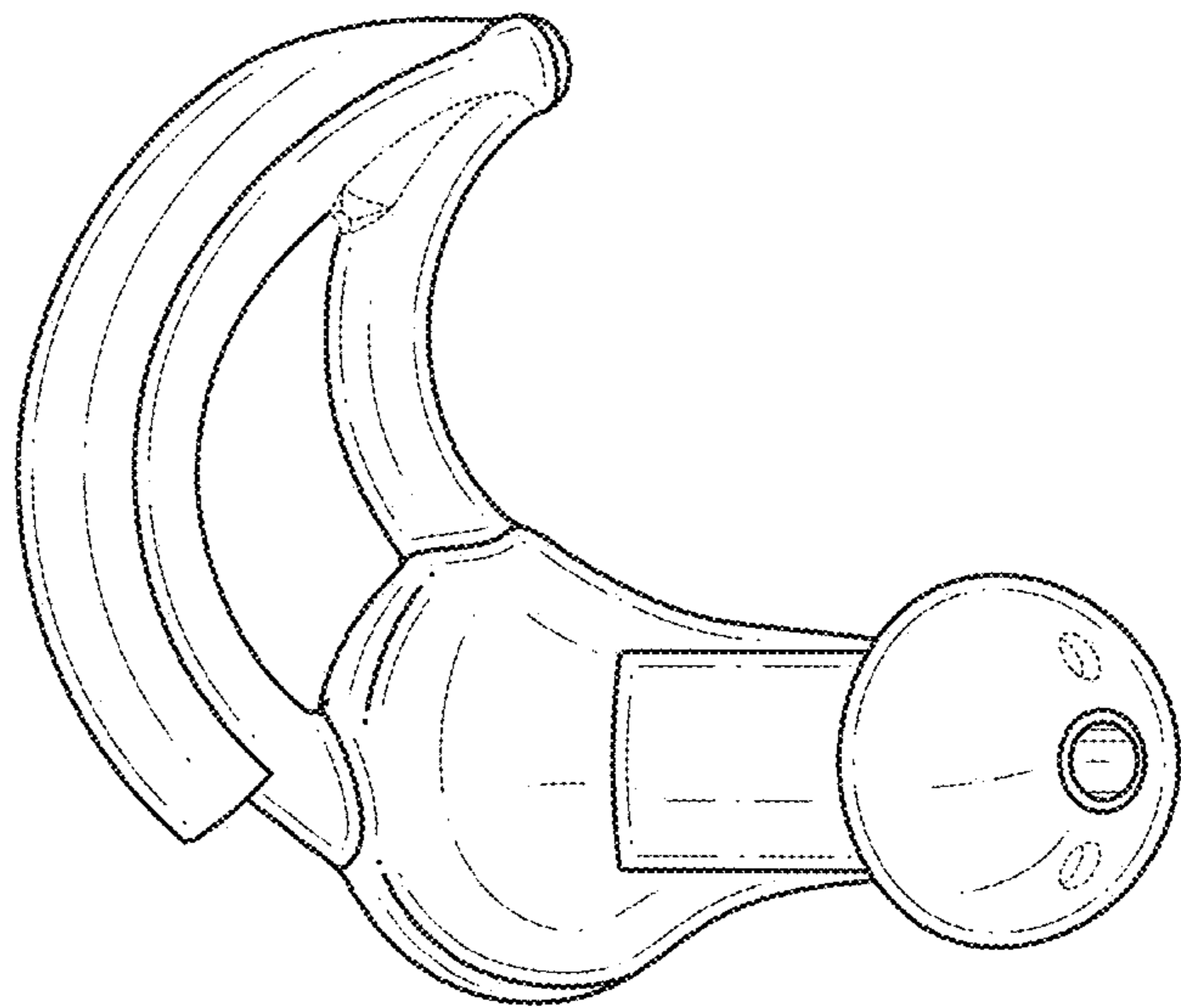

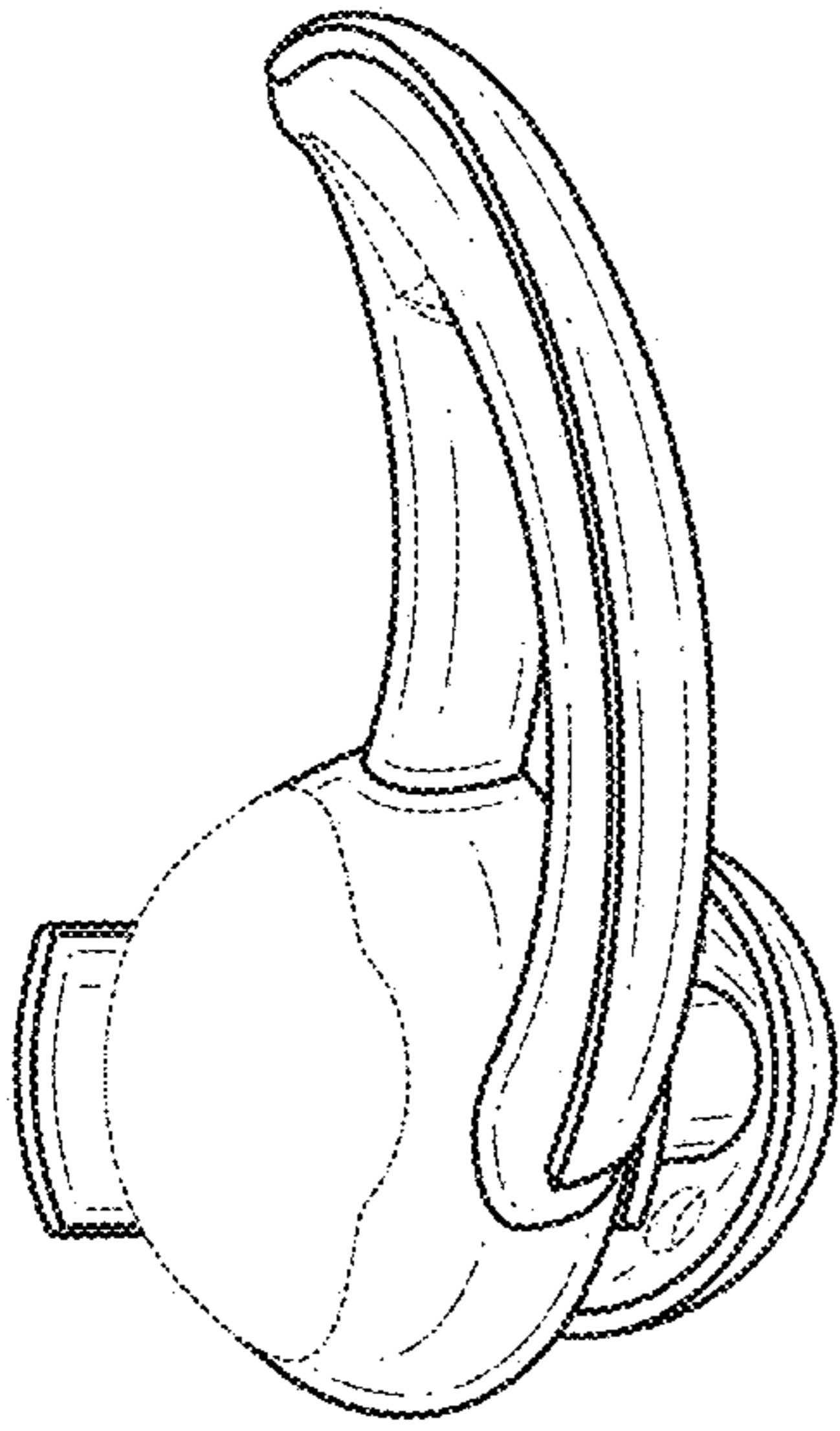

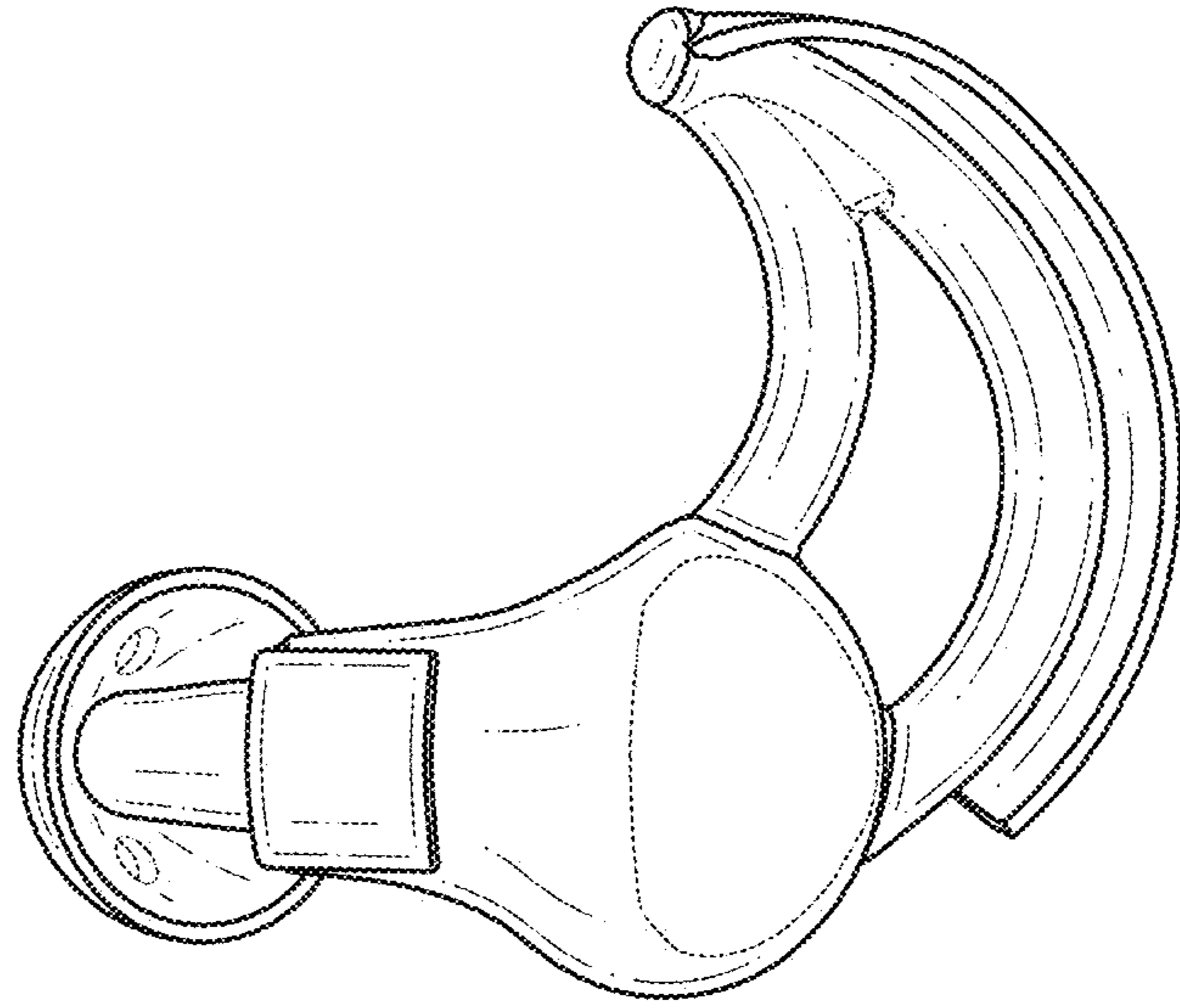

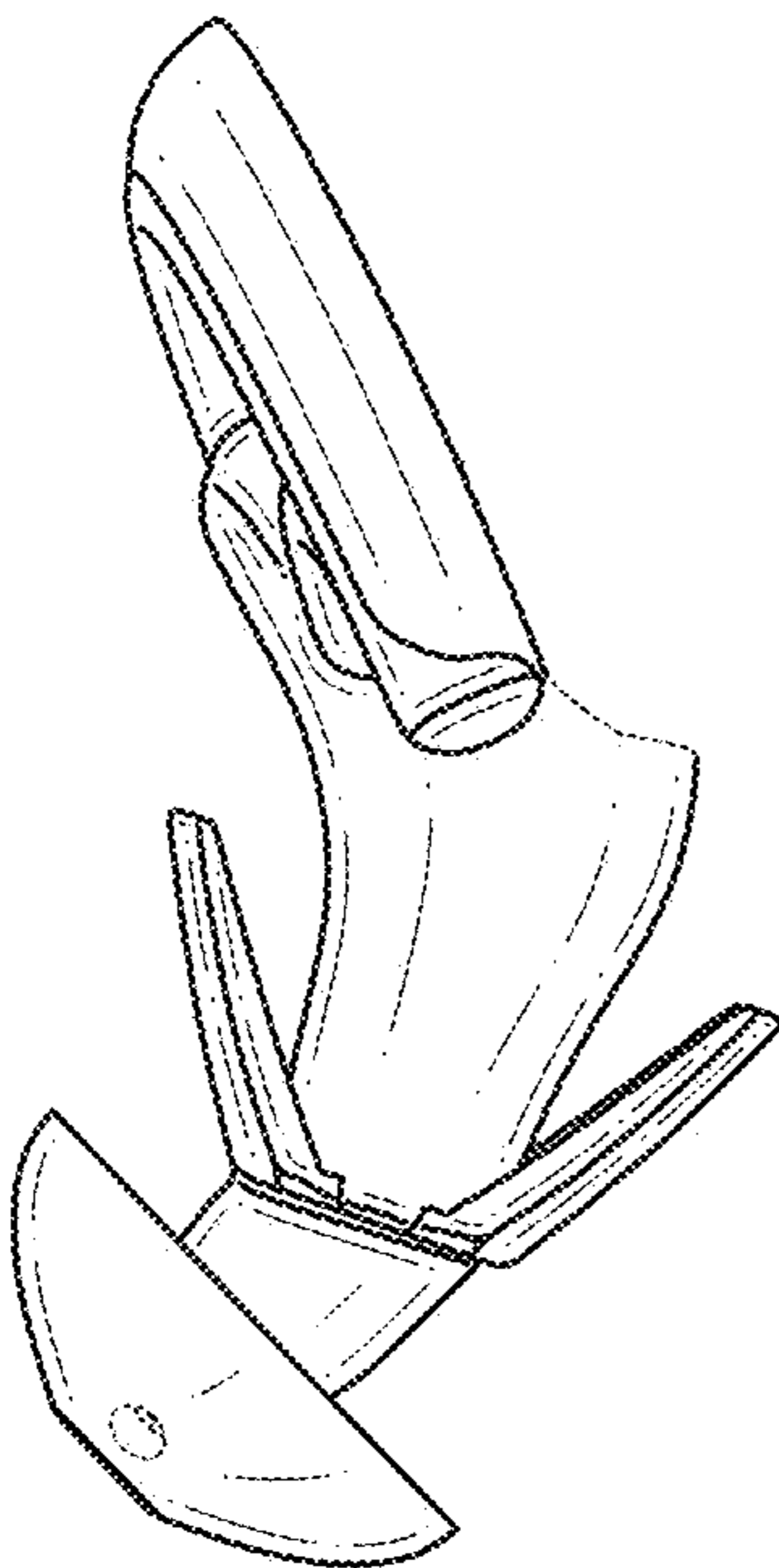

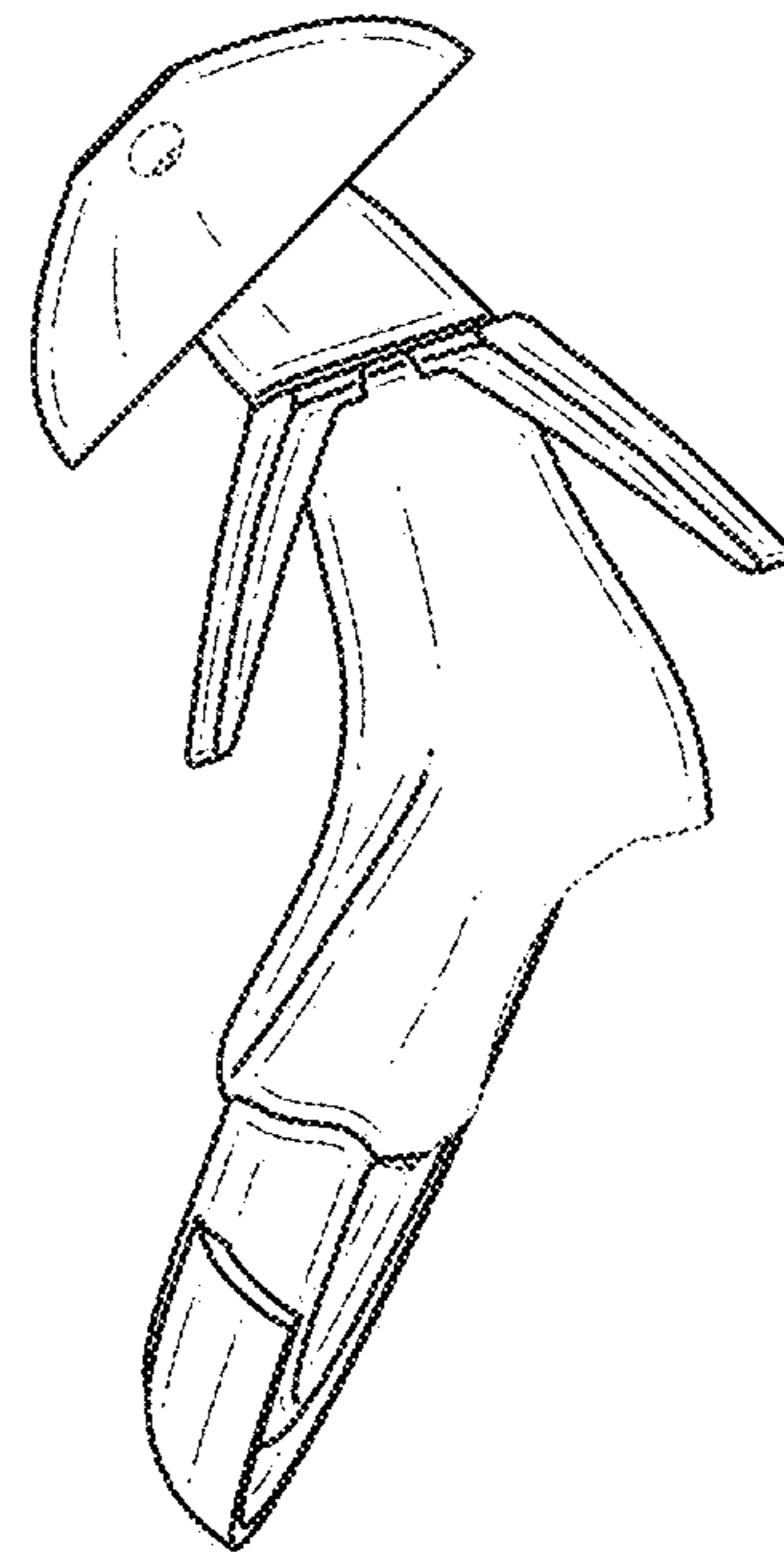
