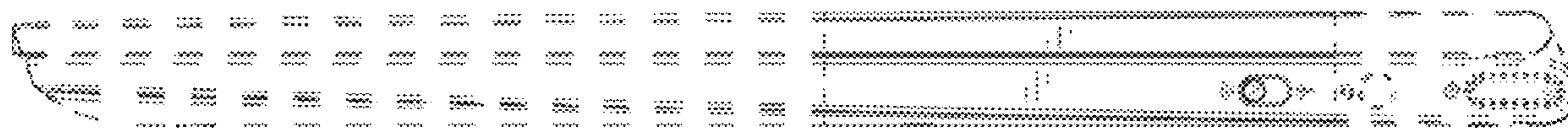
The ornamental design for a laptop computer, as shown and described.

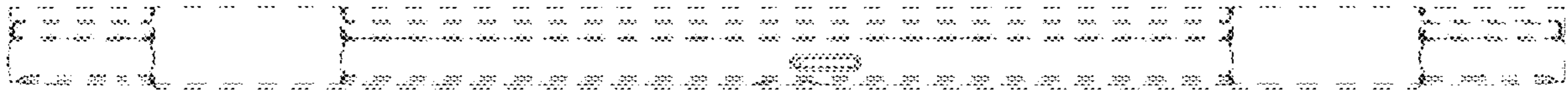

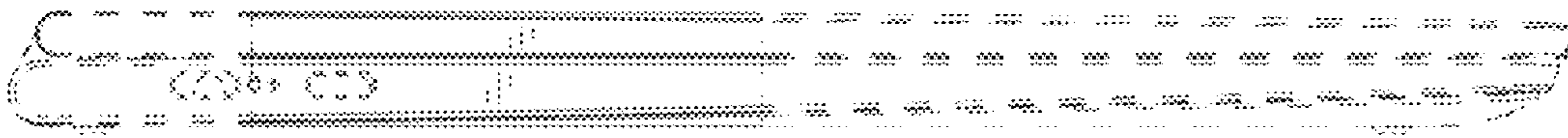

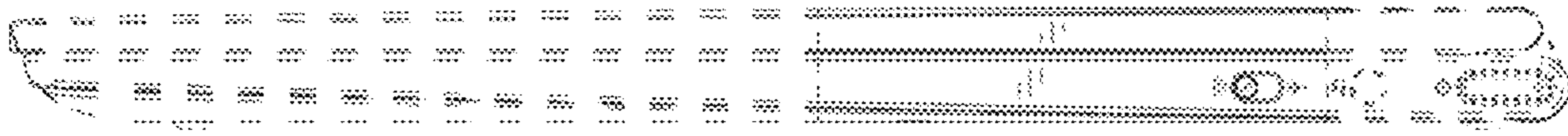

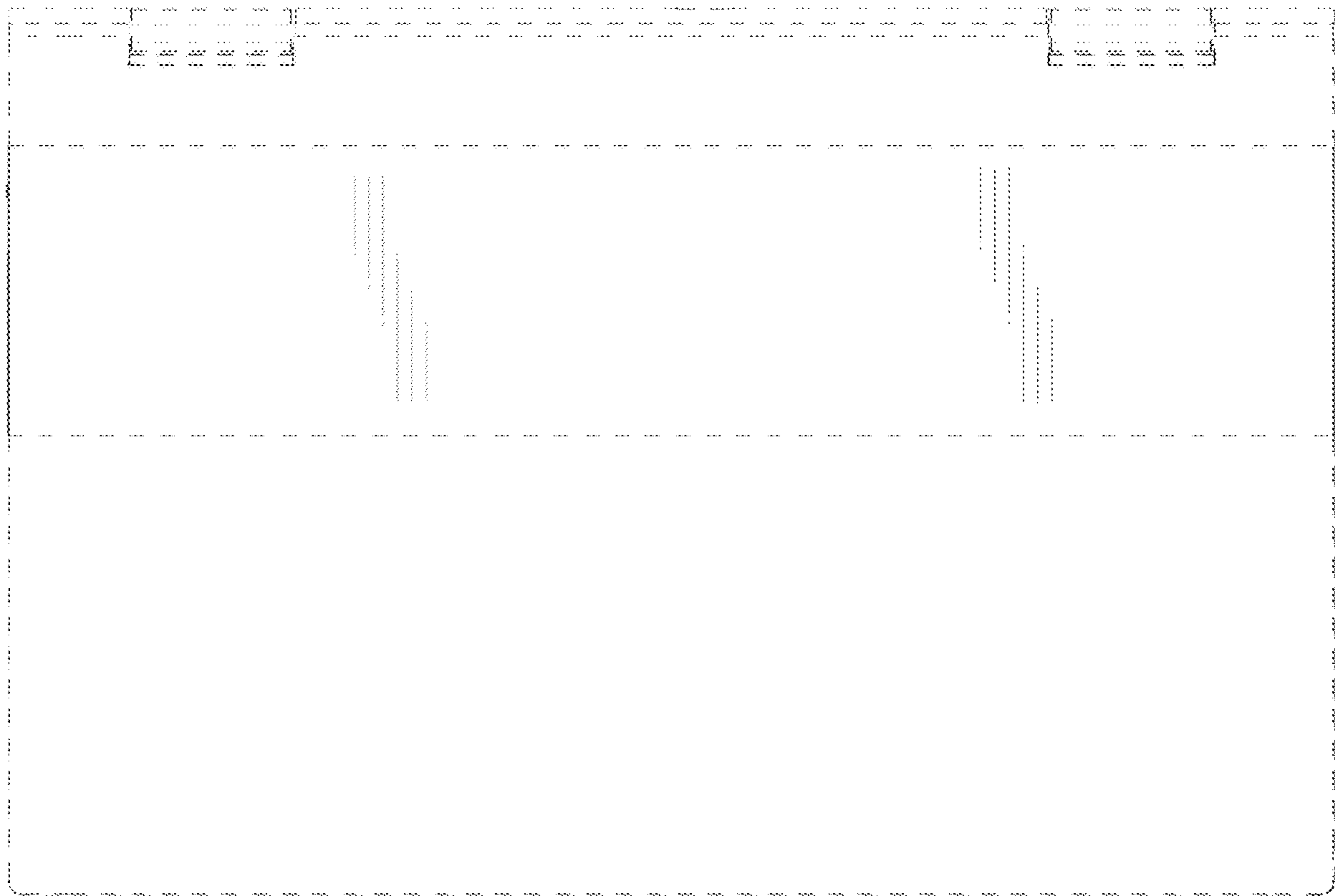
