(57) **CLAIM**

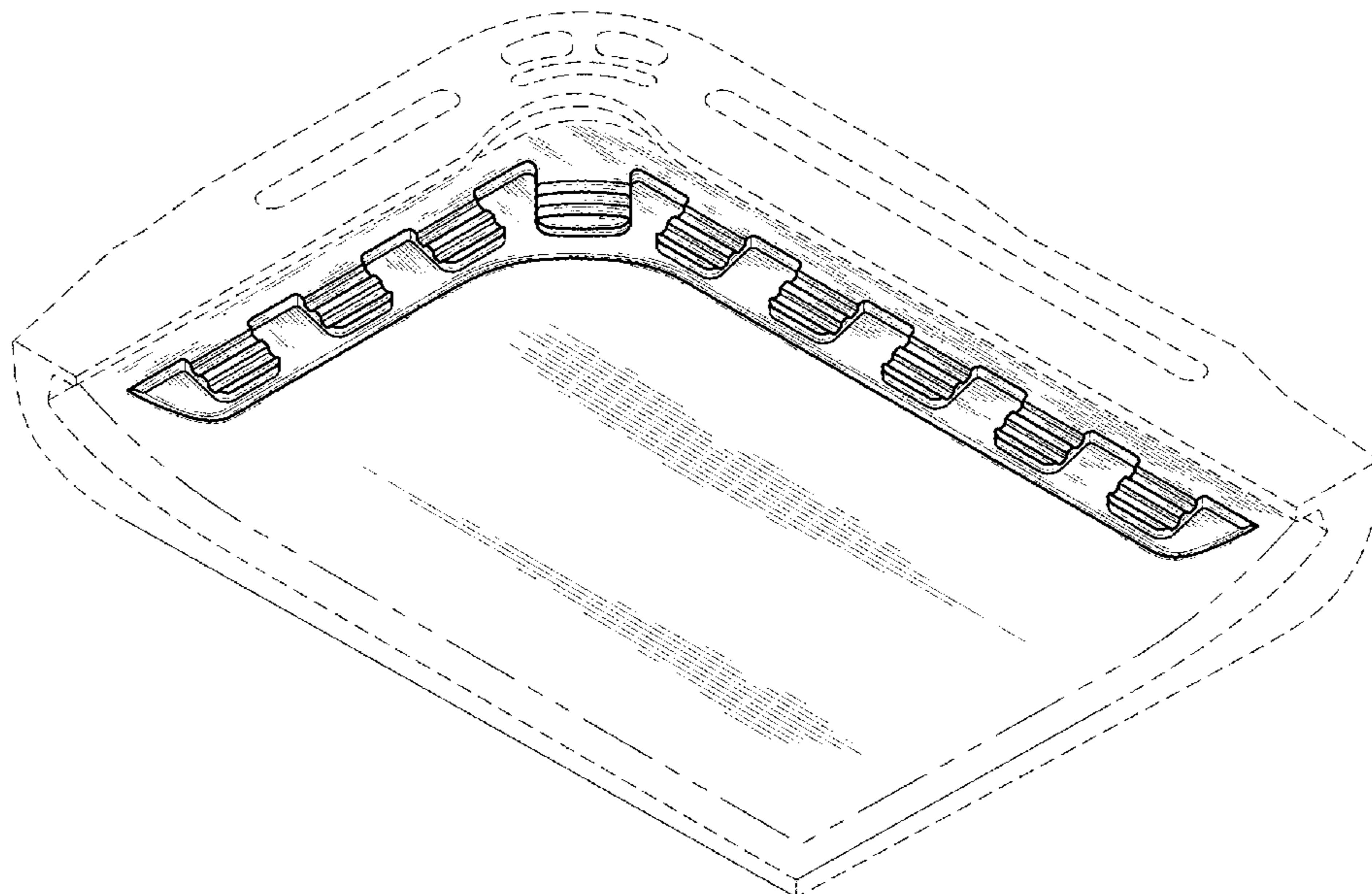
The ornamental design for a case for portable electronic computing device, as shown and described.

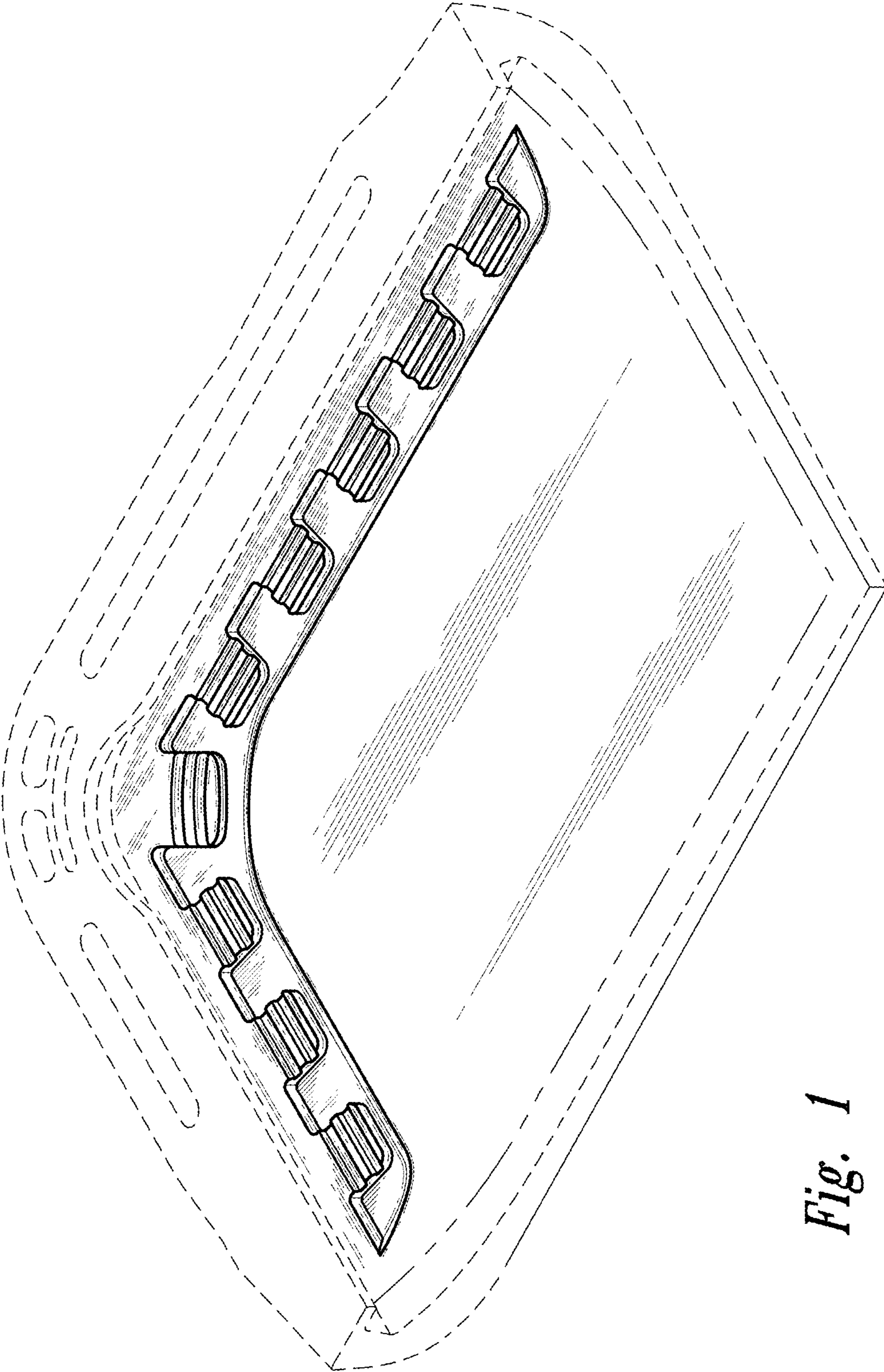

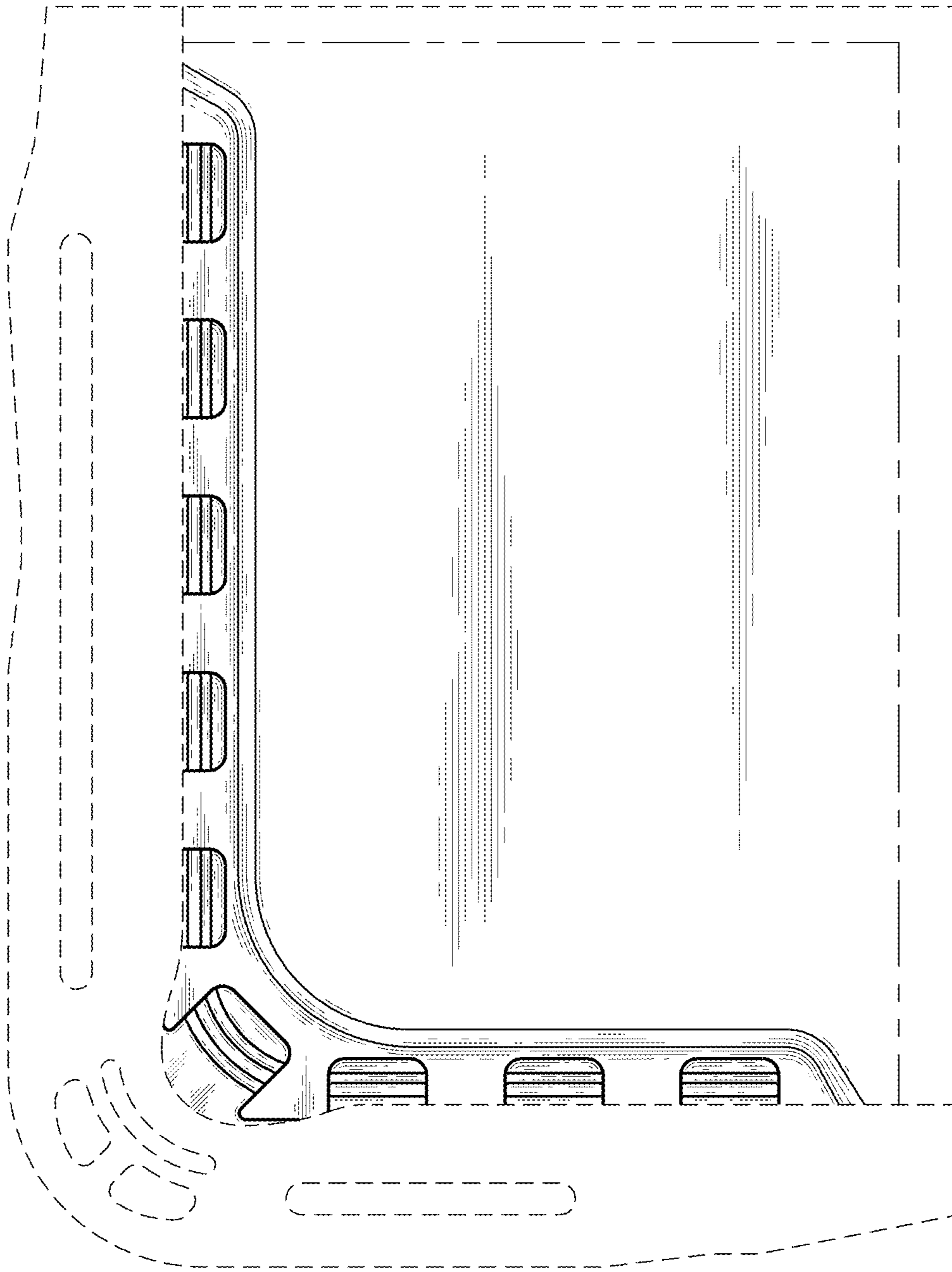

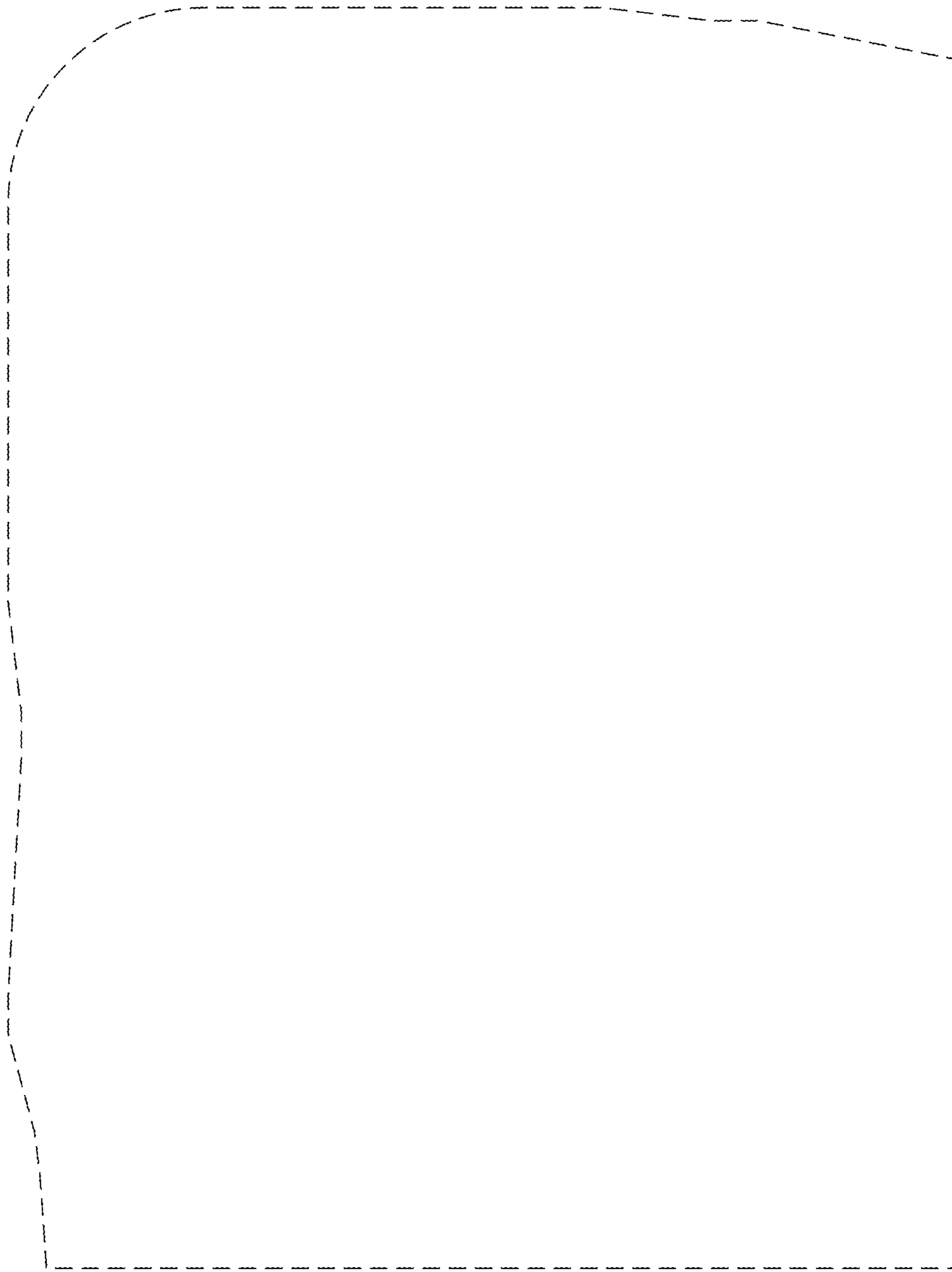

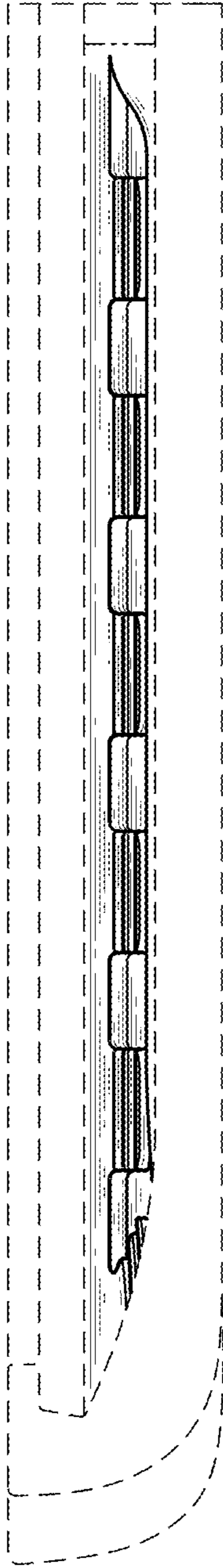

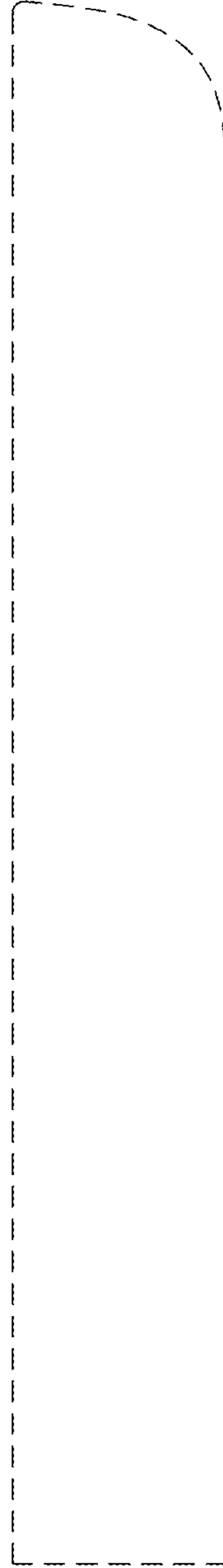

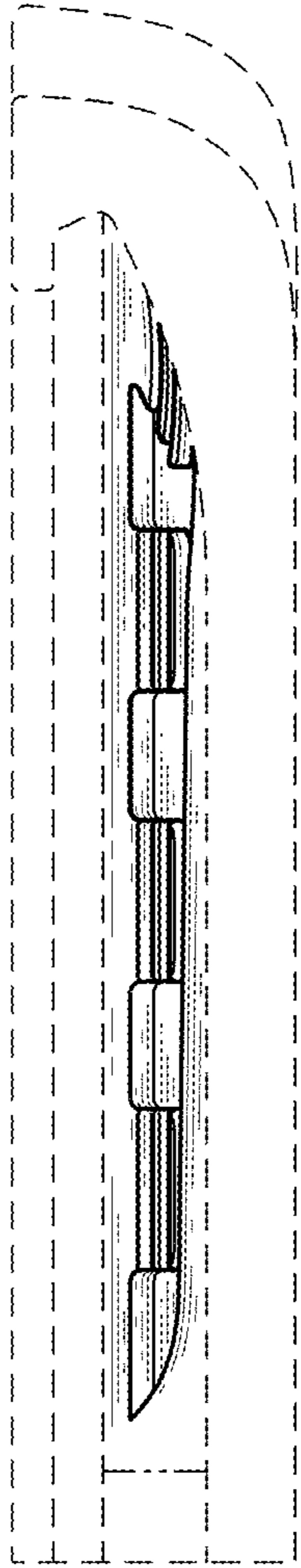




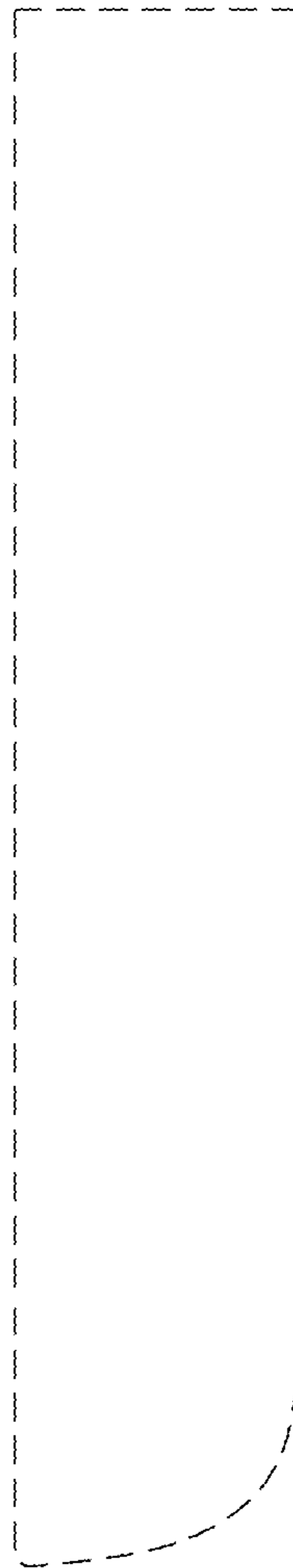
