(57) **CLAIM**

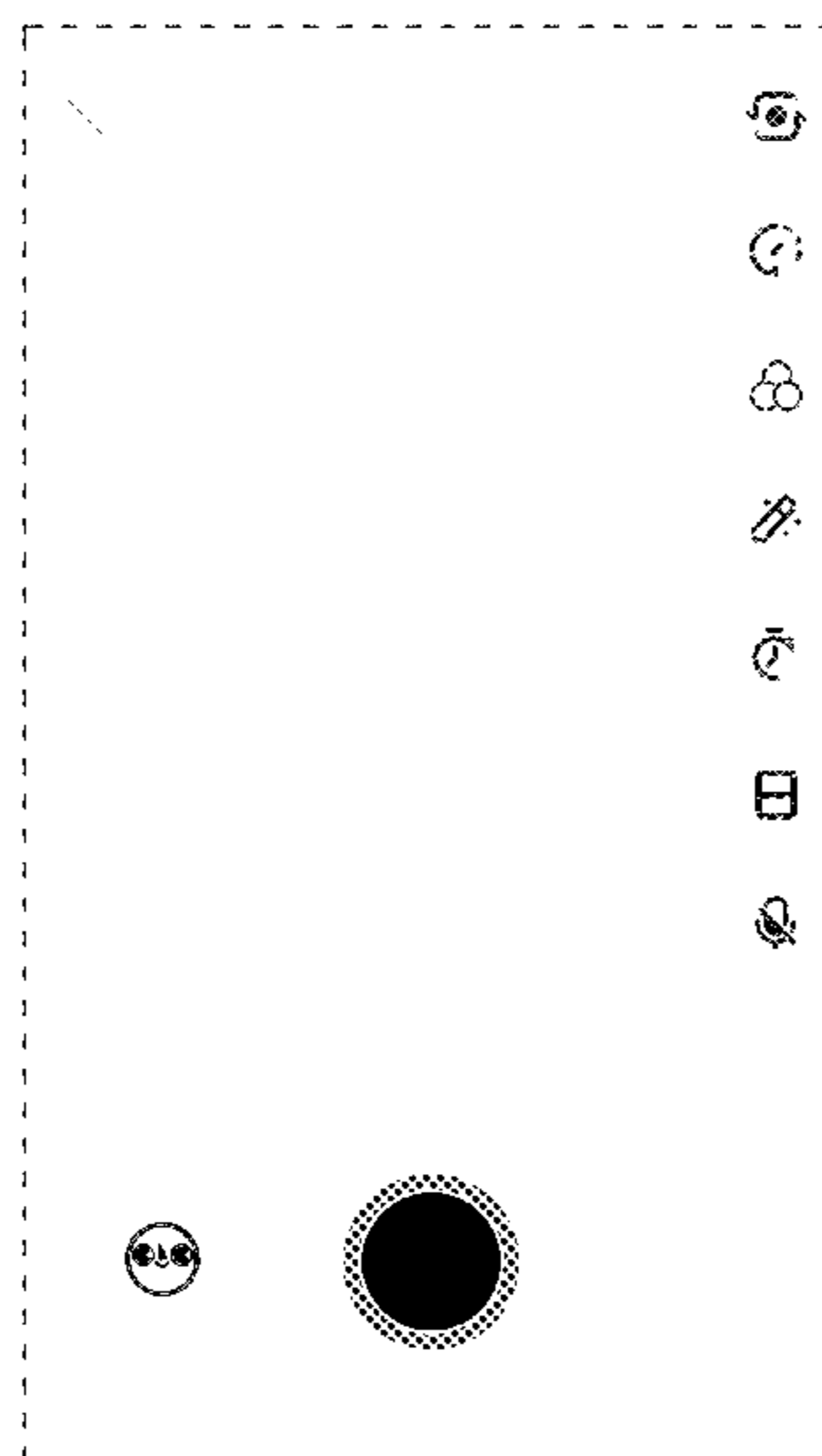
I claim the ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with a graphical user interface showing the new design; and,

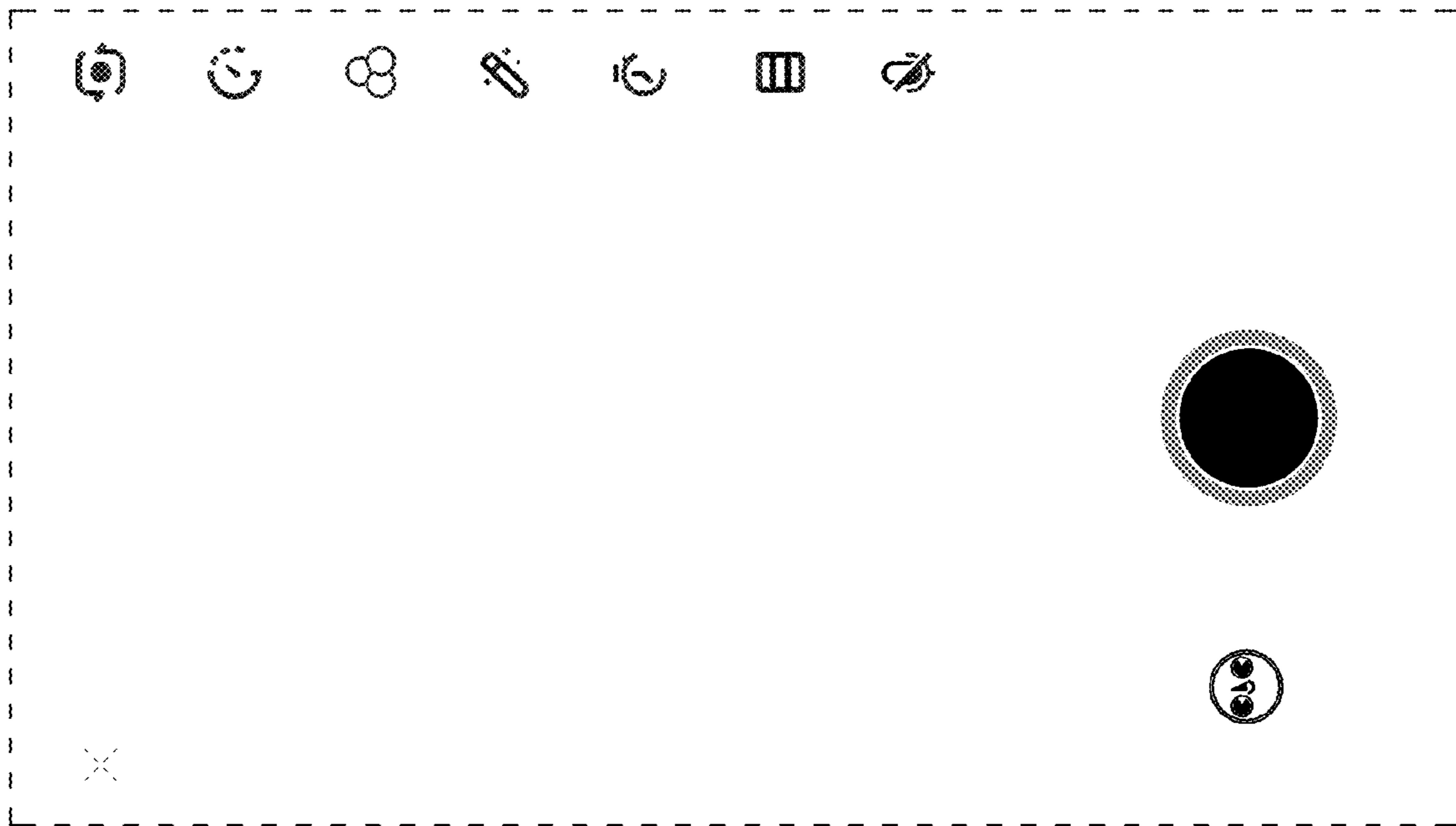
