FIG. 4 shows another embodiment thereof.

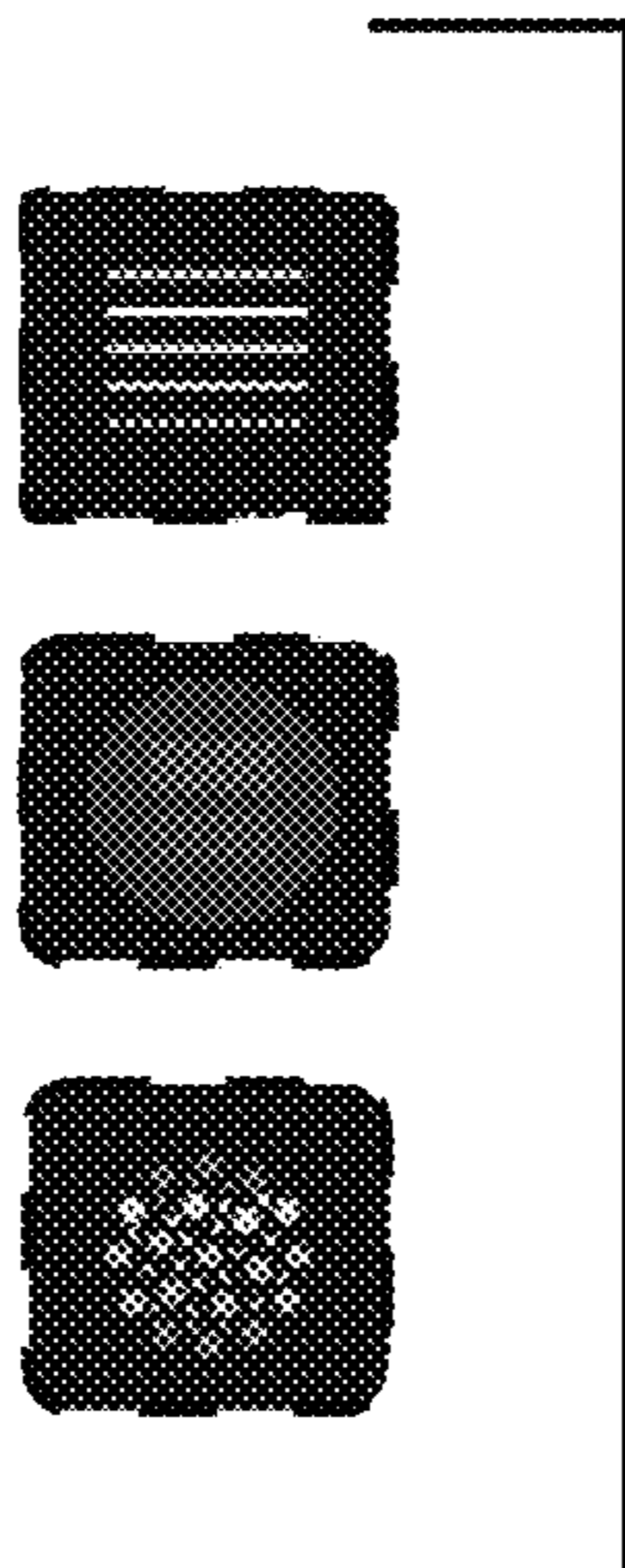
The peripheral dashed broken lines illustrate a display screen or portion thereof and form no part of the claimed design.

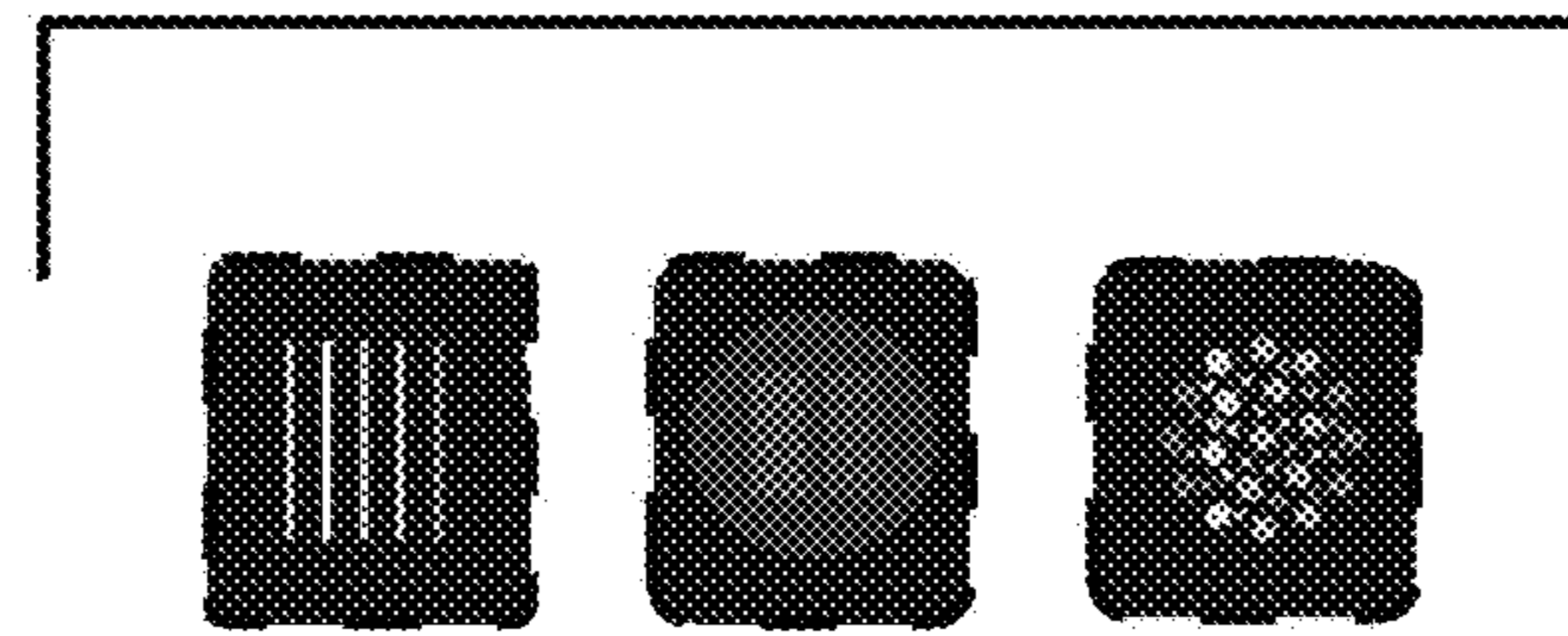

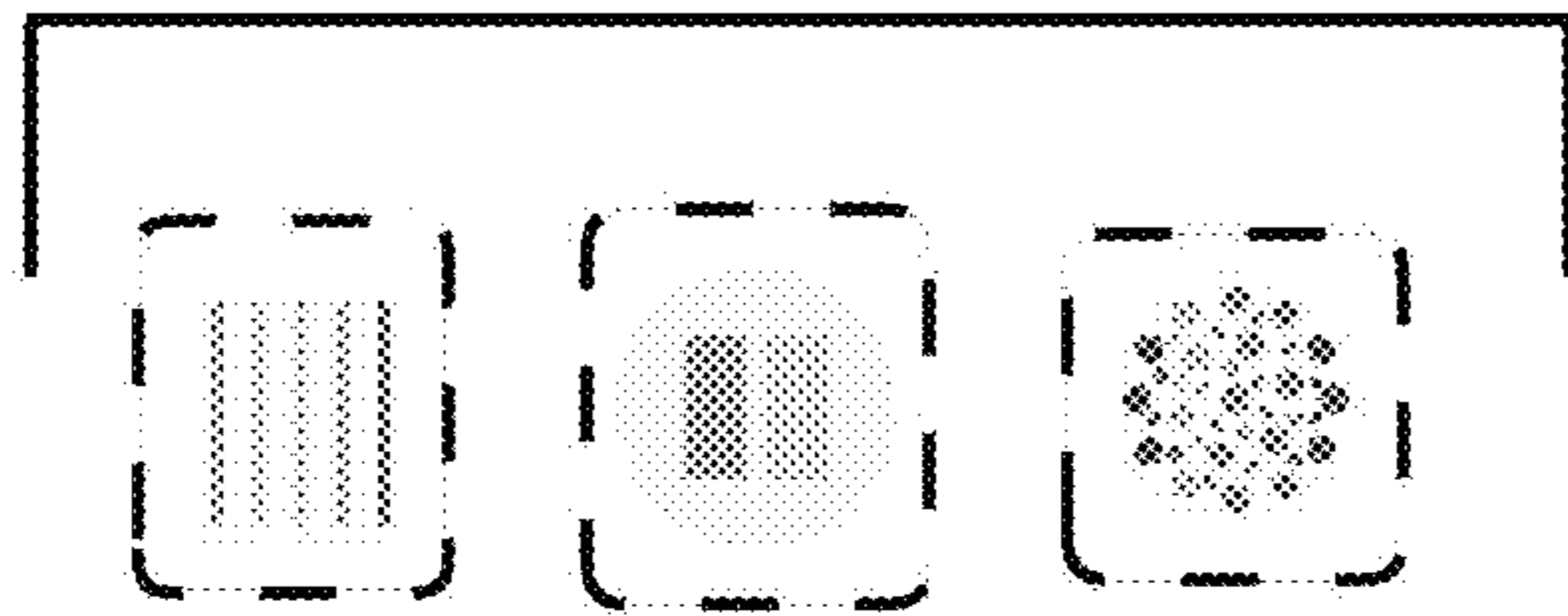

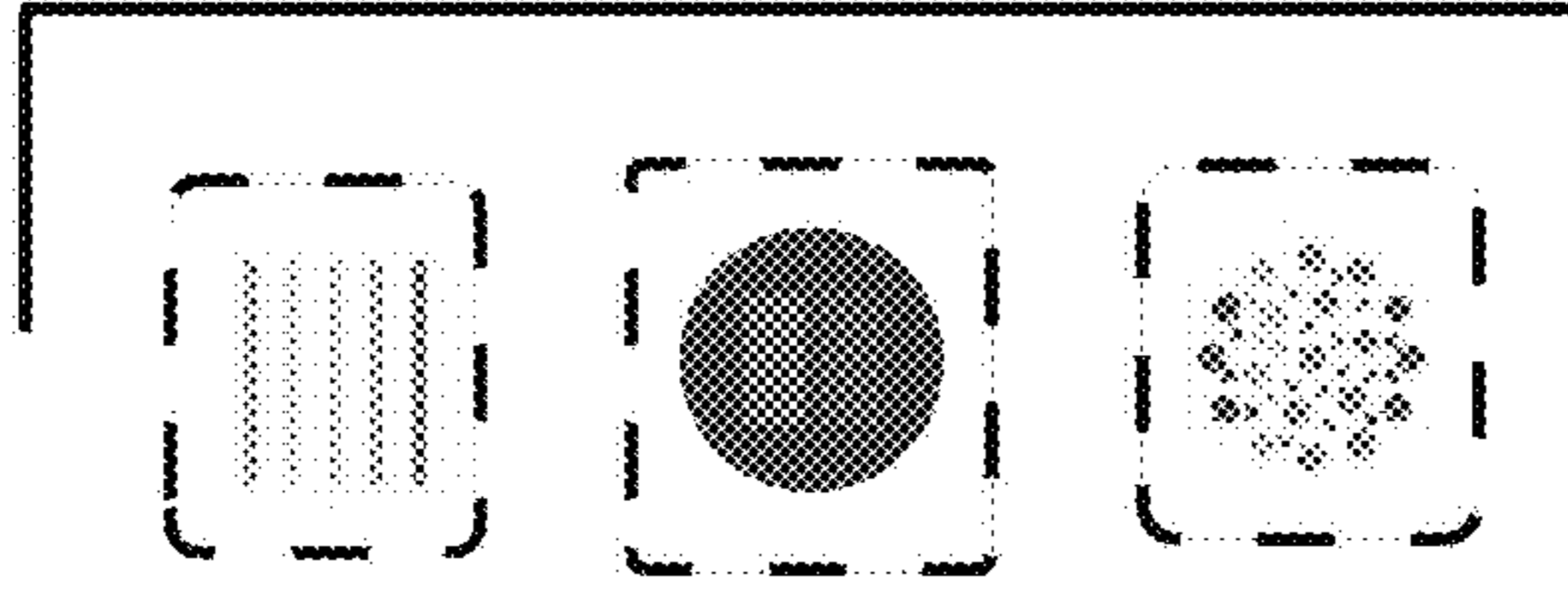
