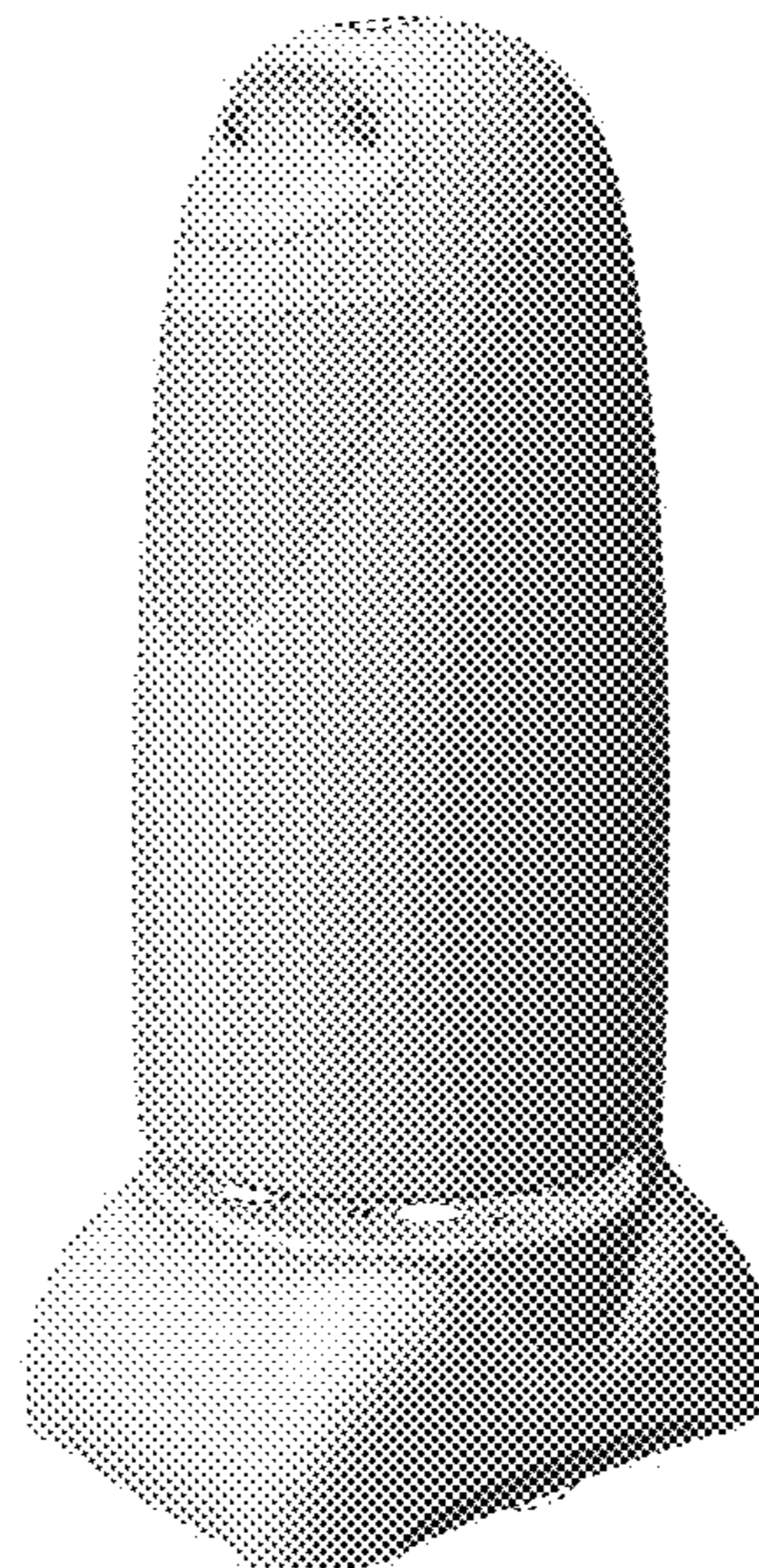
(57) **CLAIM**

The ornamental design for a self-traveling robot, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a self-traveling robot, showing my new design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right side elevational view thereof; and,
FIG. 8 is a left side elevational view thereof.
The broken lines shown in the drawings illustrate portions of the self-traveling robot that are environmental structures and form no part of the claimed design. Grayscale shading illustrates contour, not any particular color.

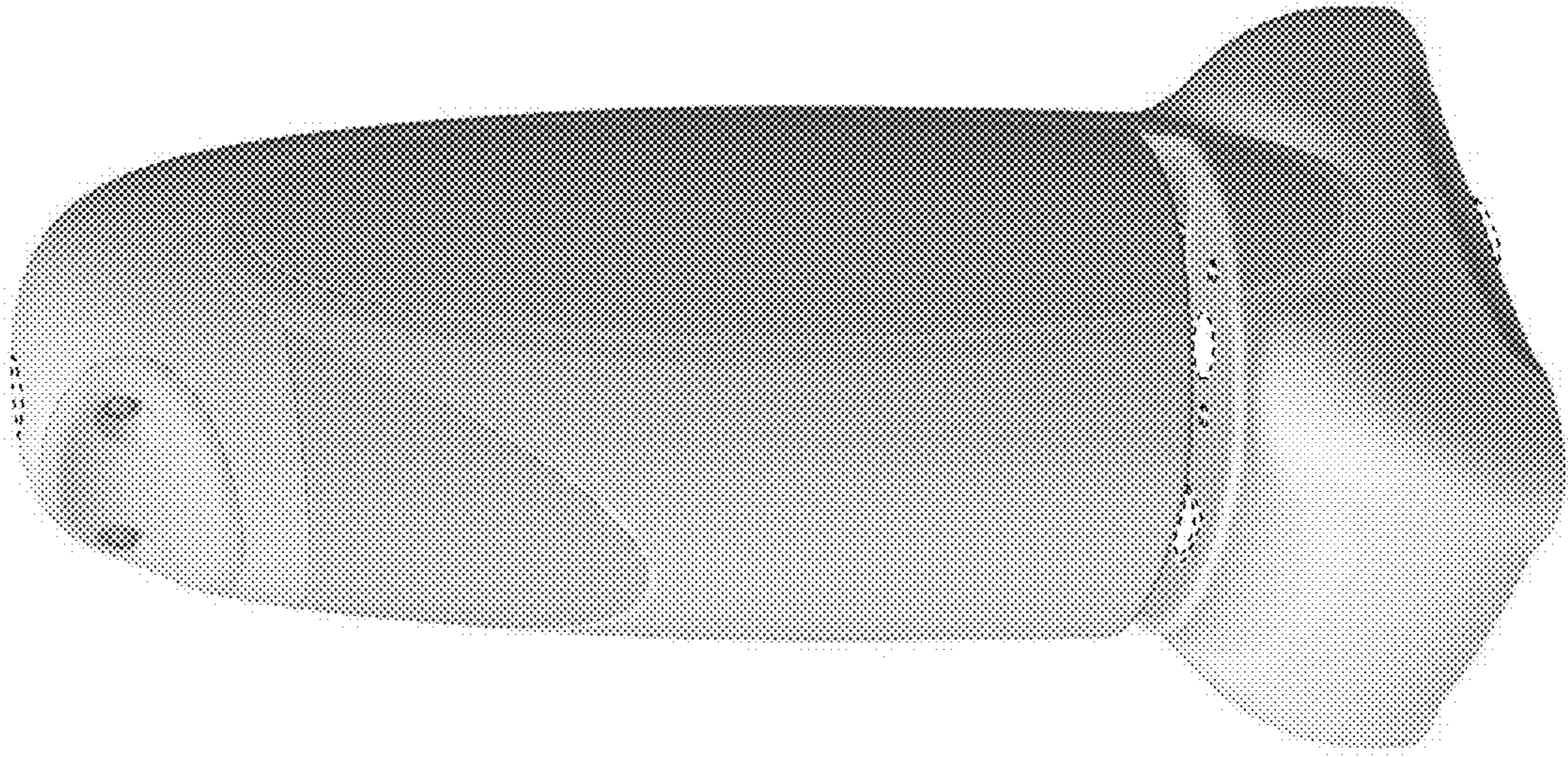

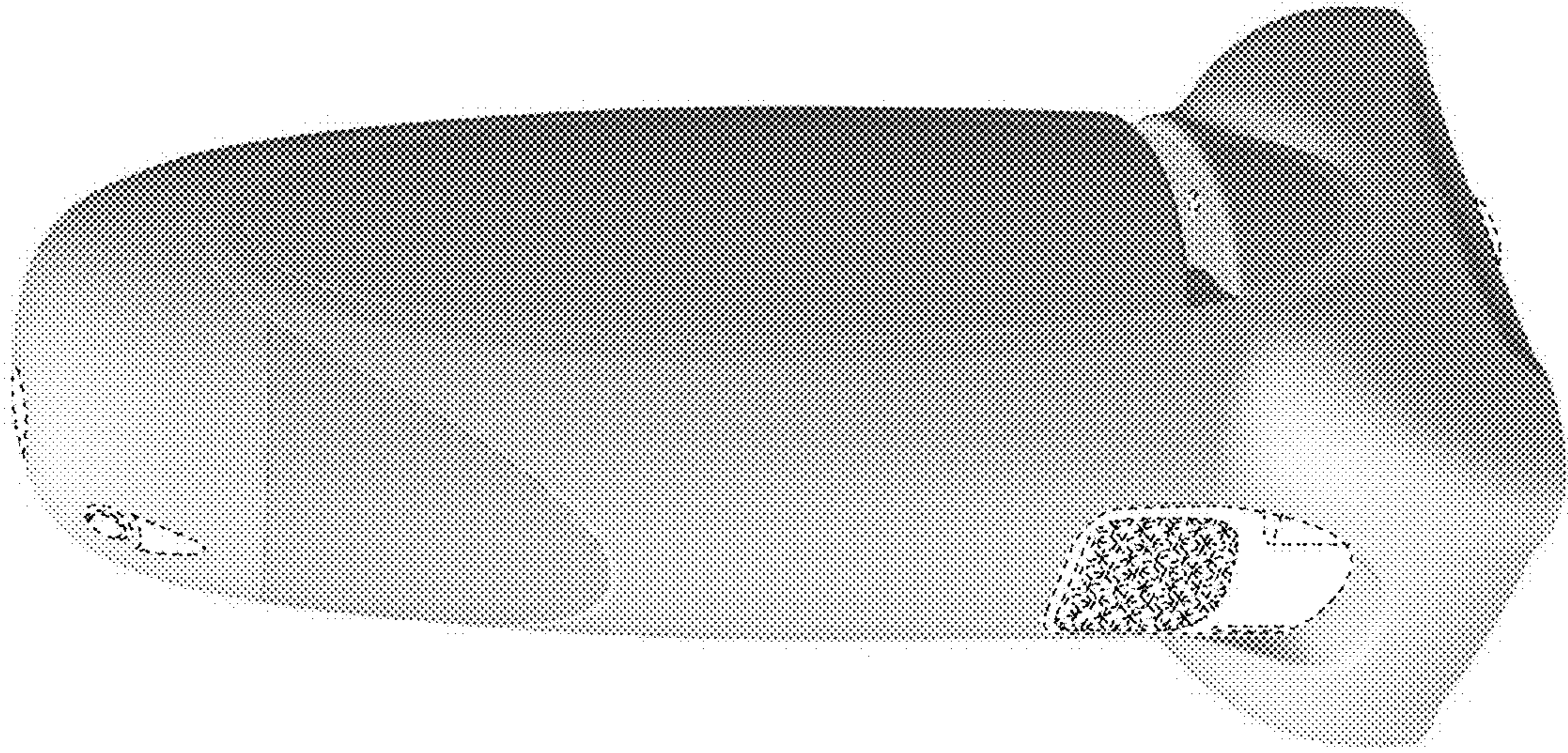

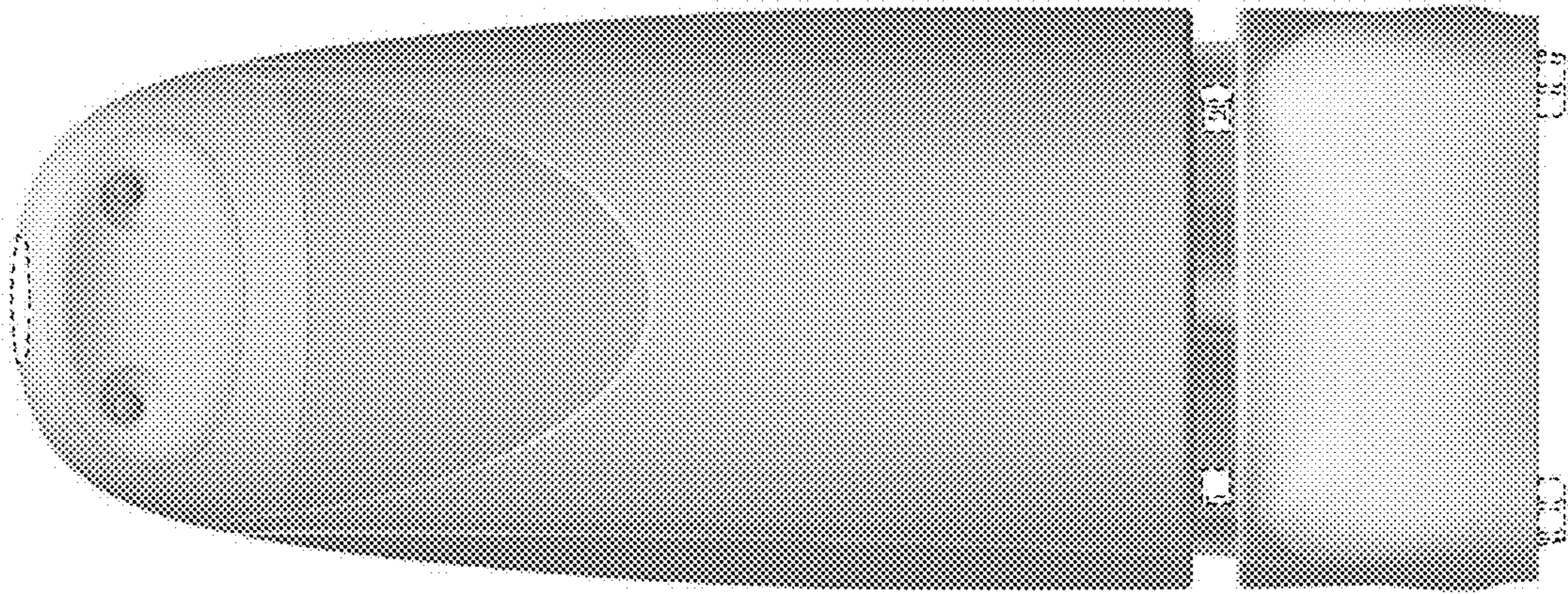

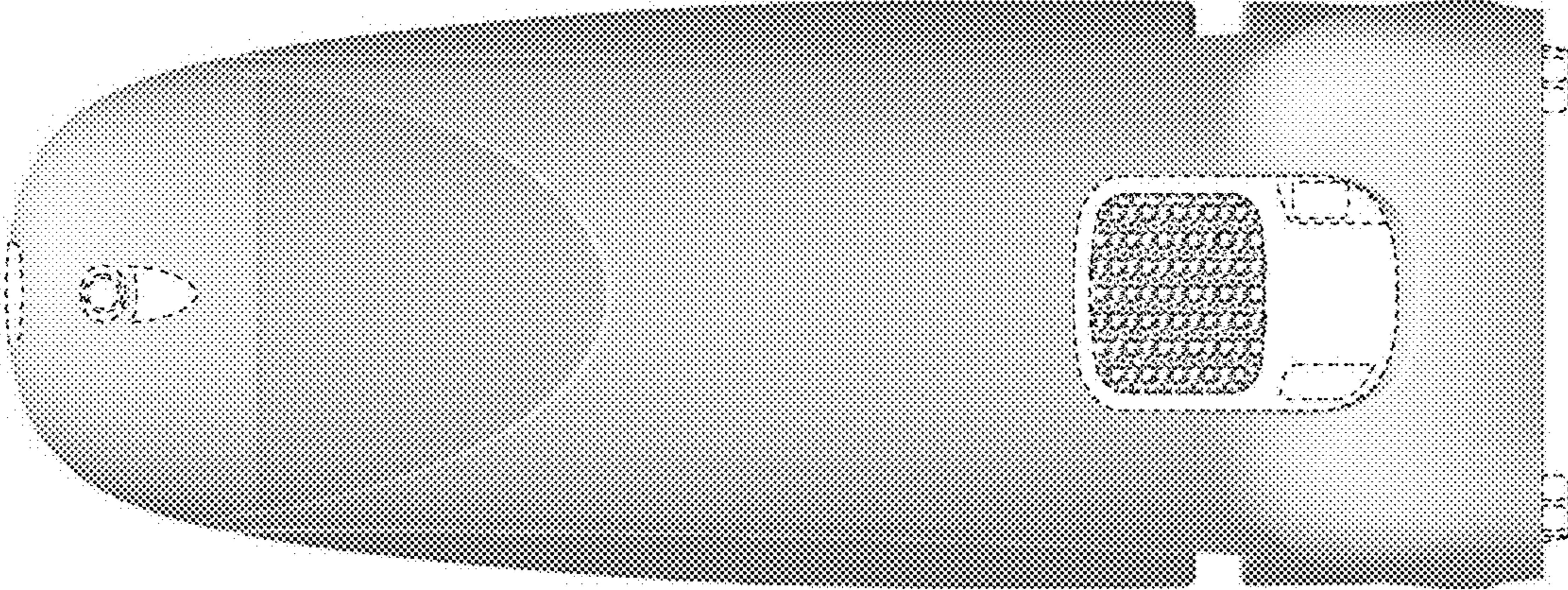

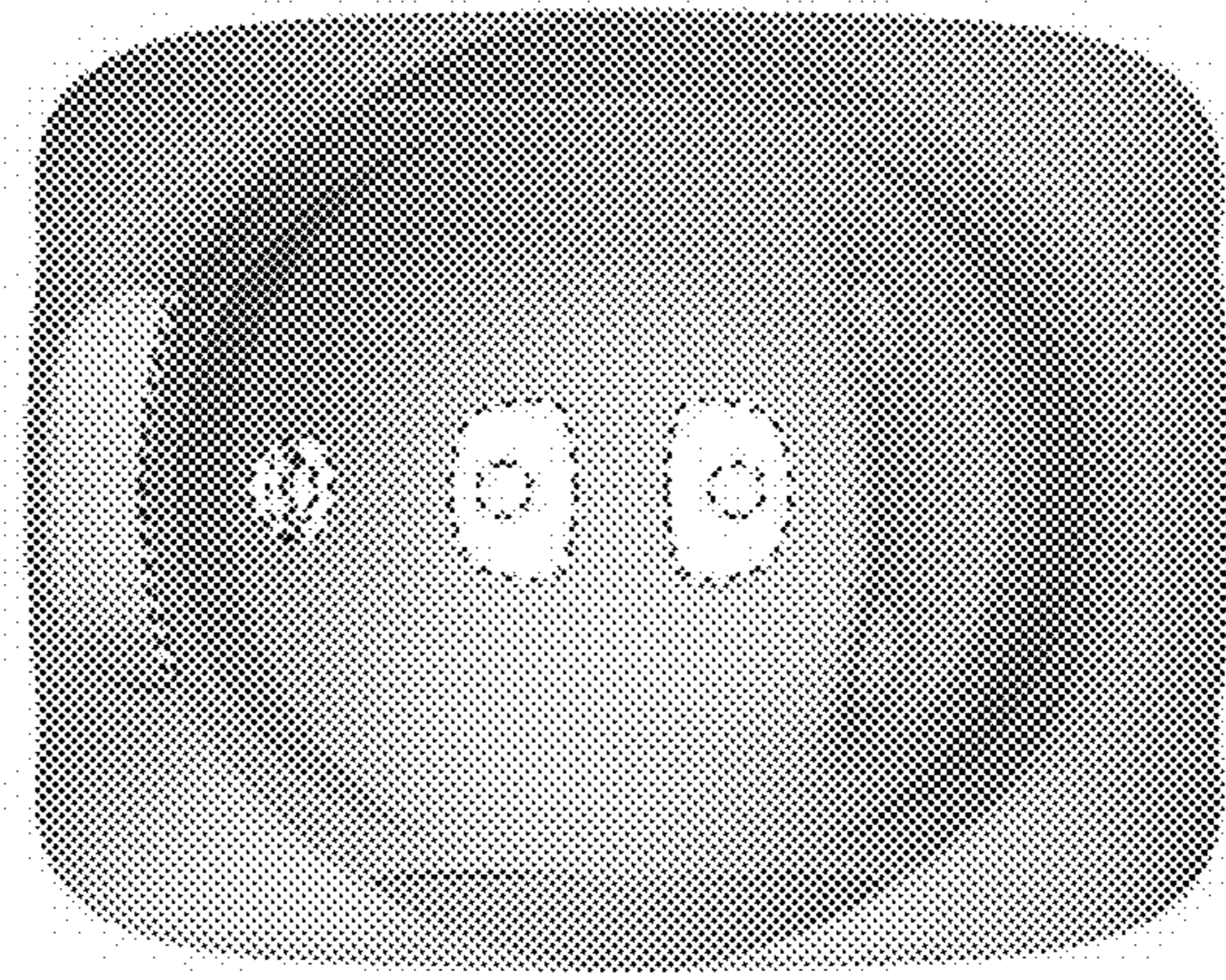

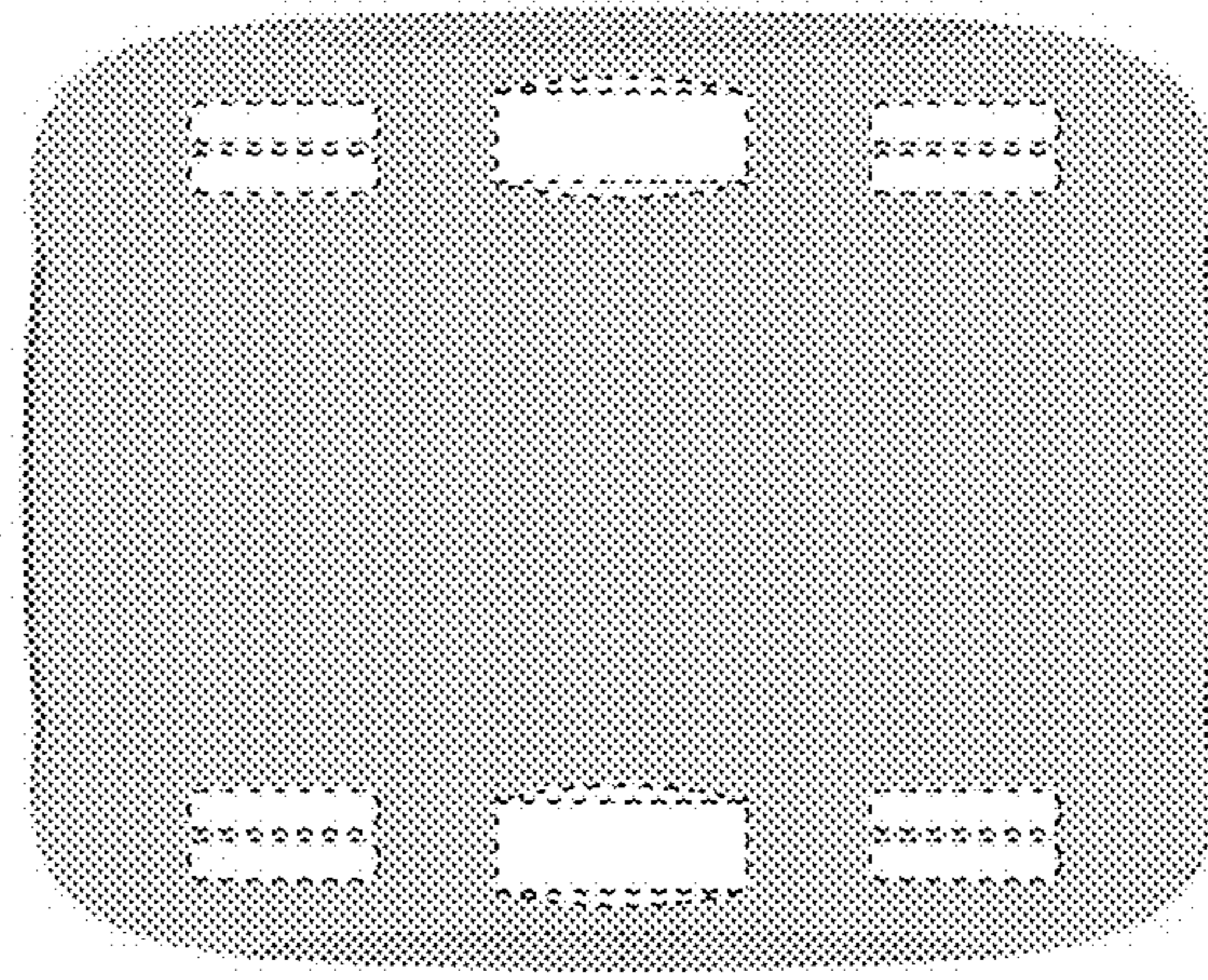

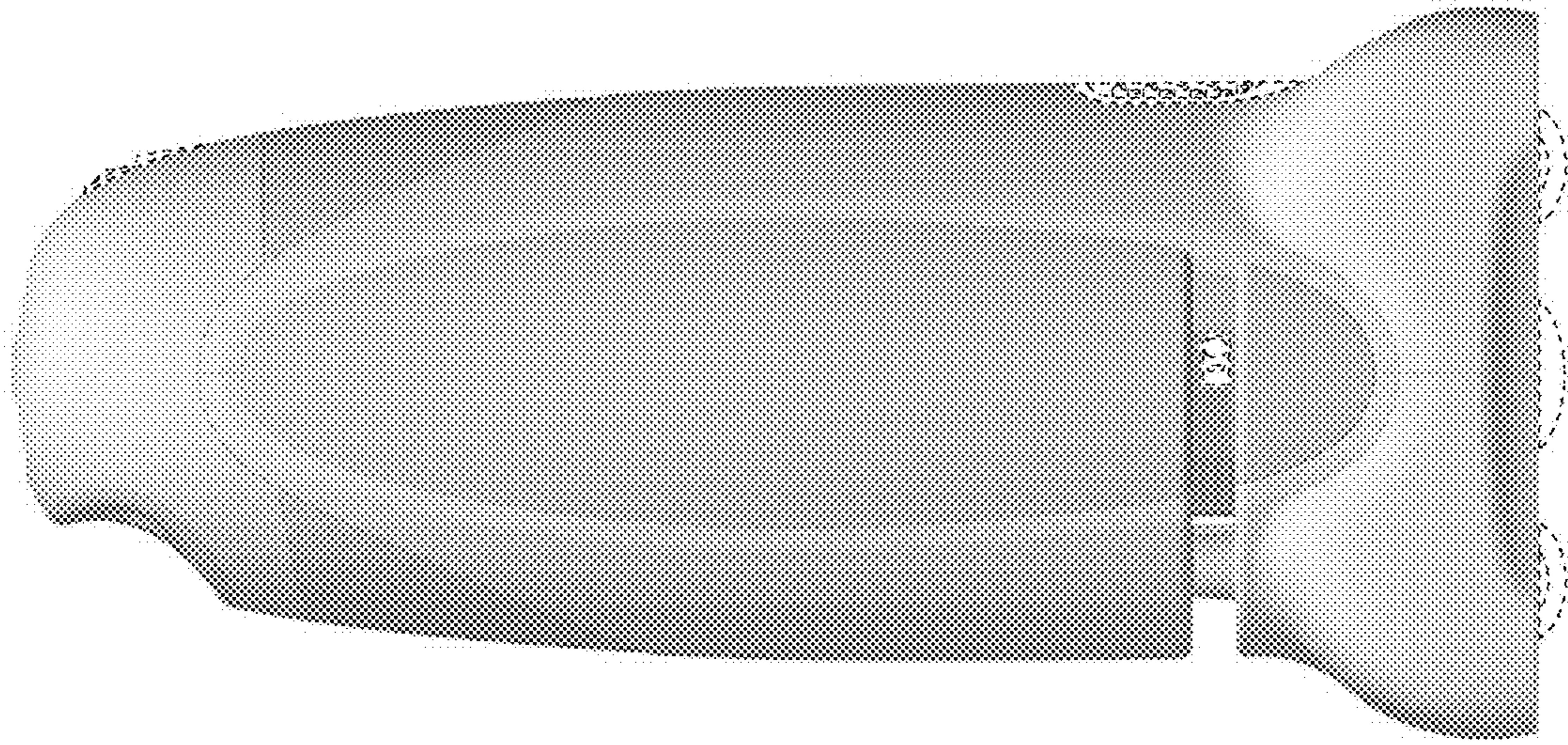

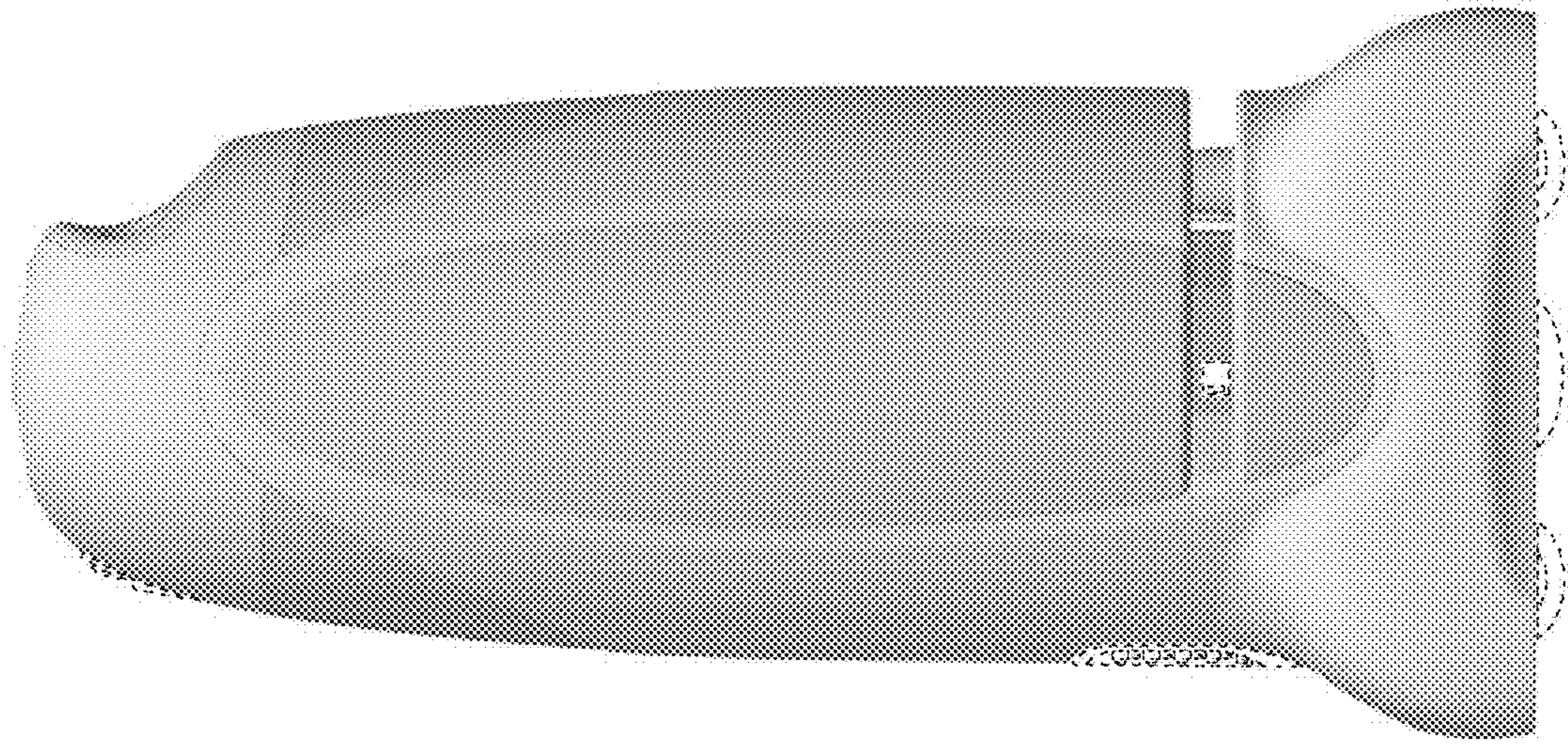
