FIG. 7 is a top view of the ink cartridge of FIG. 1.

FIG. 8 is a bottom view of the ink cartridge of FIG. 1.

FIG. 9 is a front view of the ink cartridge of FIG. 1; and,

FIG. 10 is a rear view of the ink cartridge of FIG. 1.

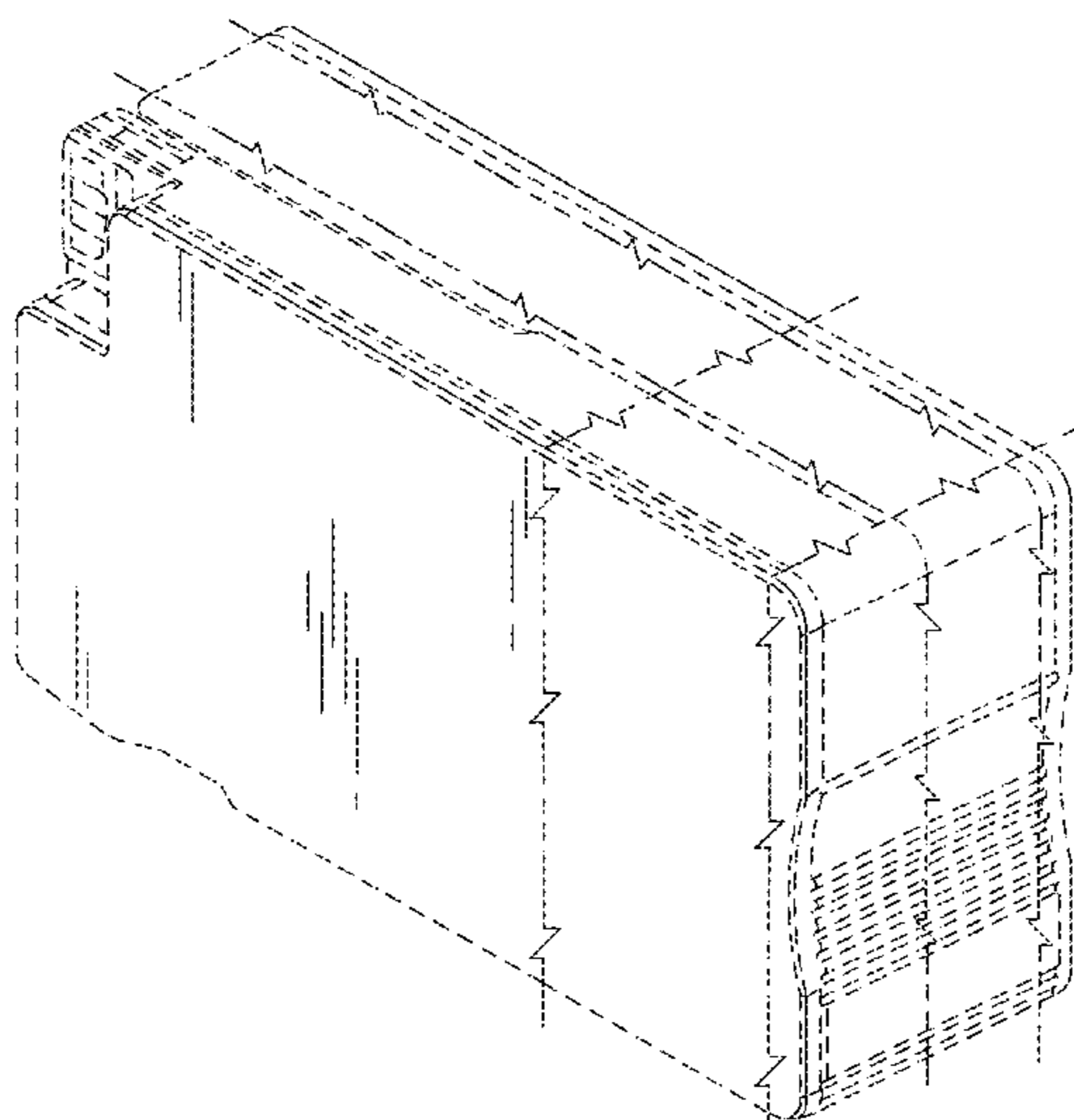

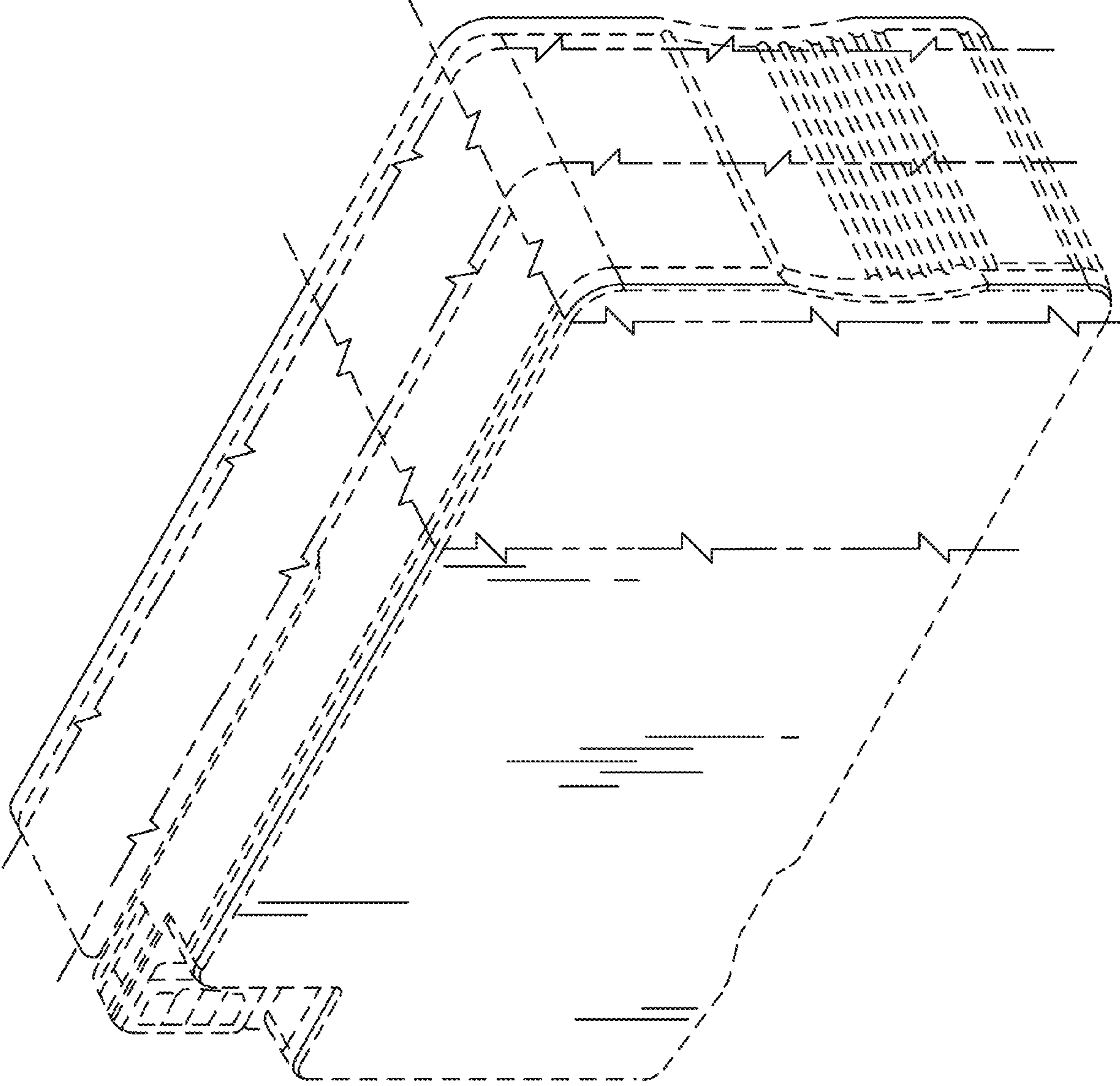
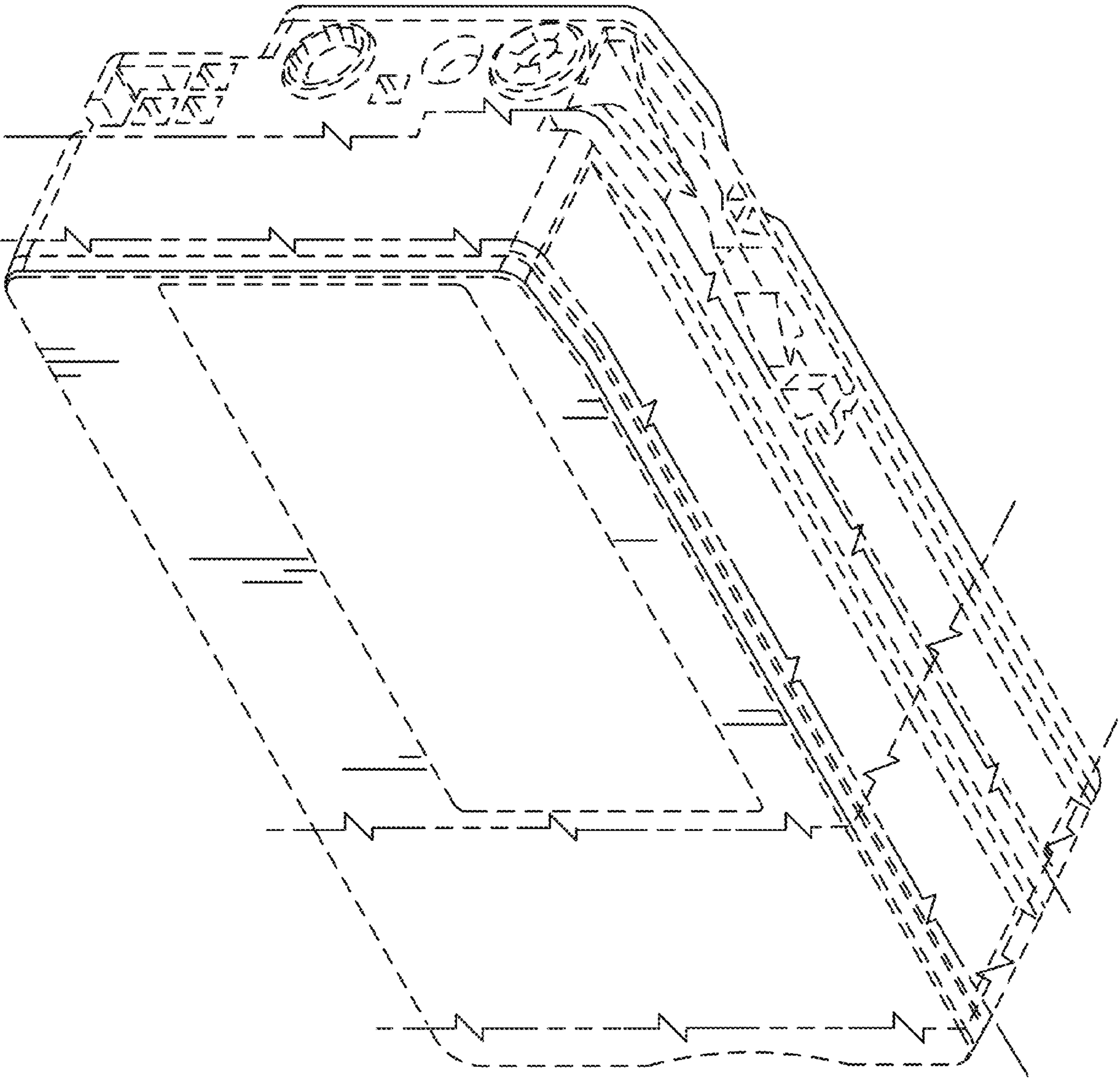

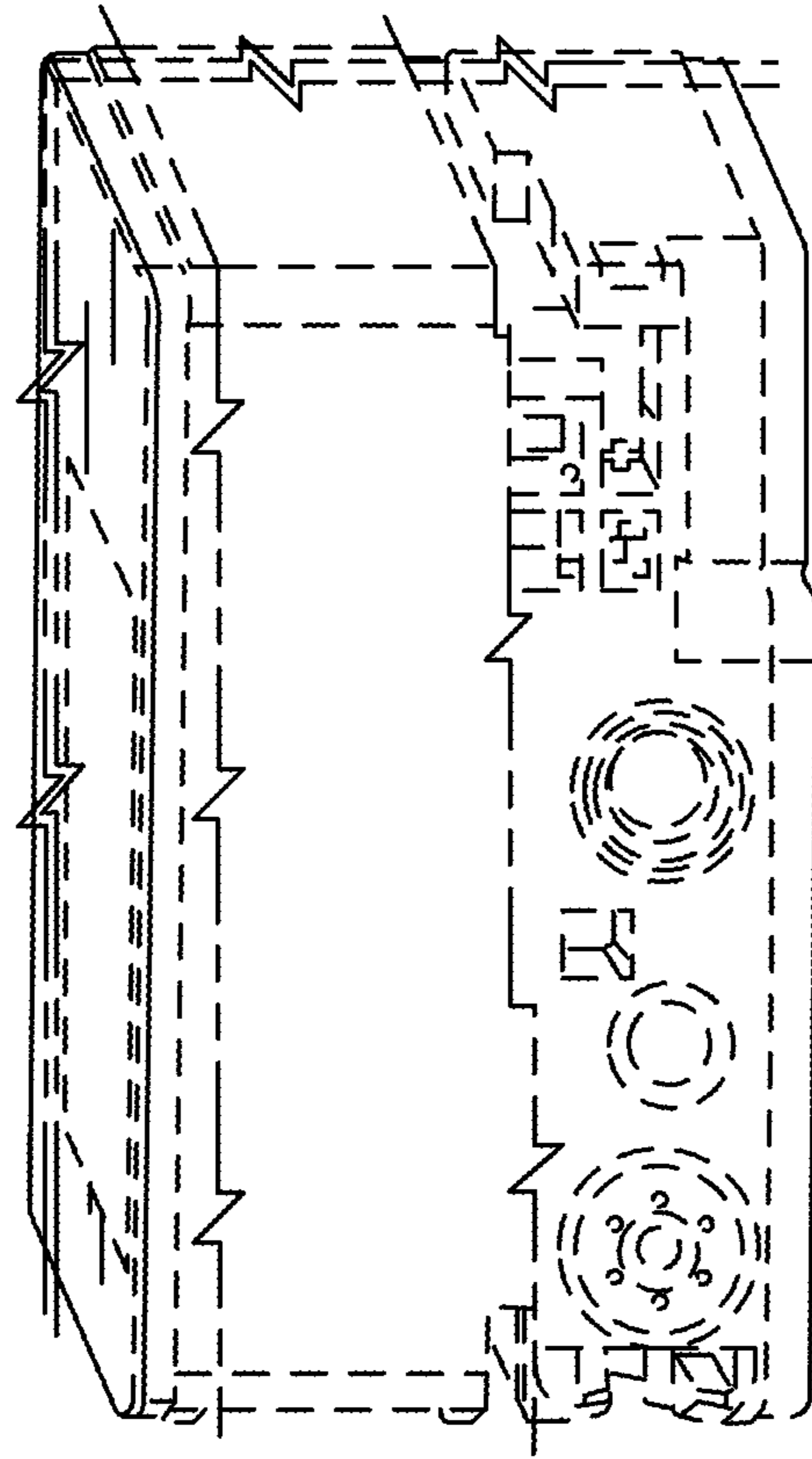

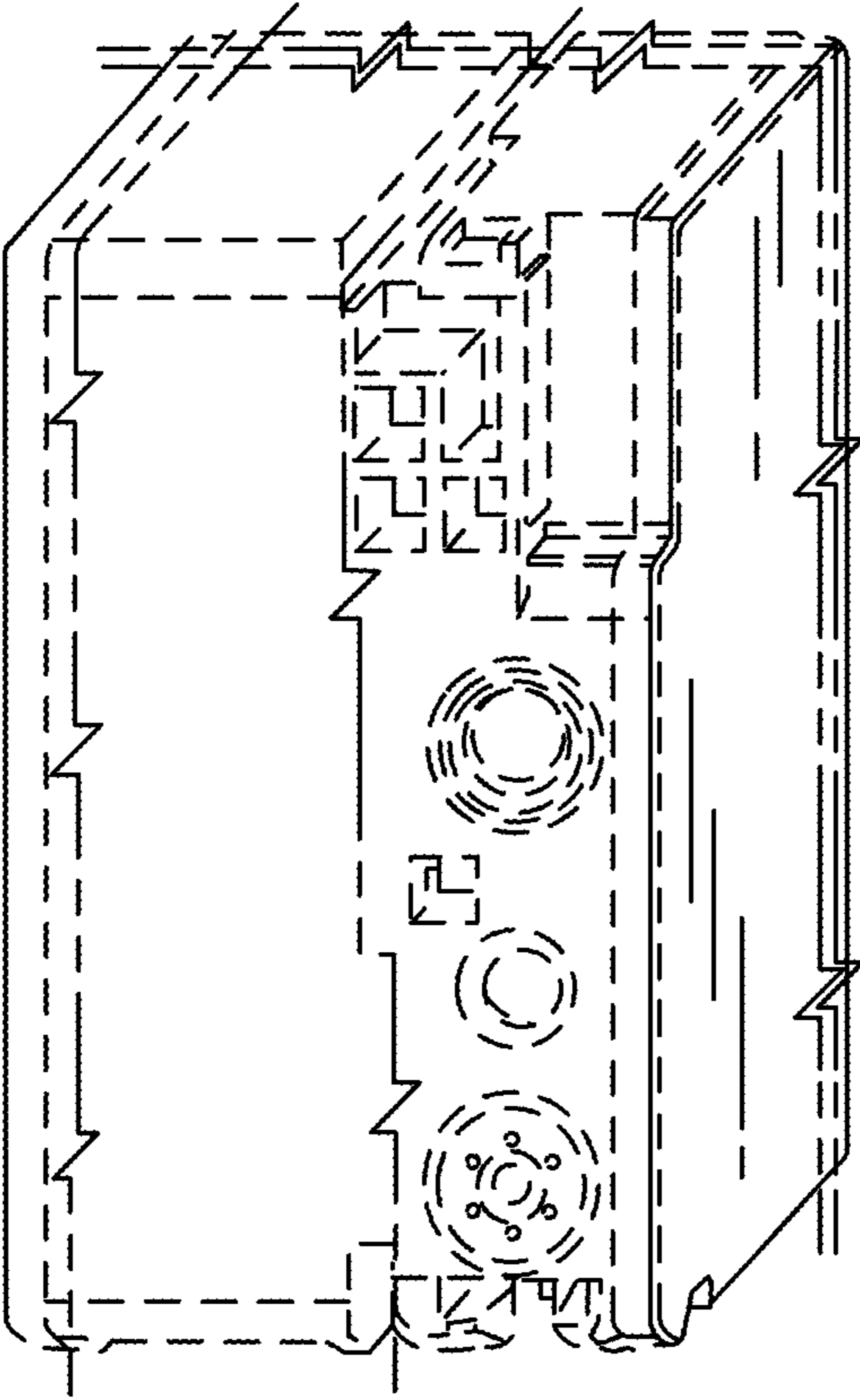

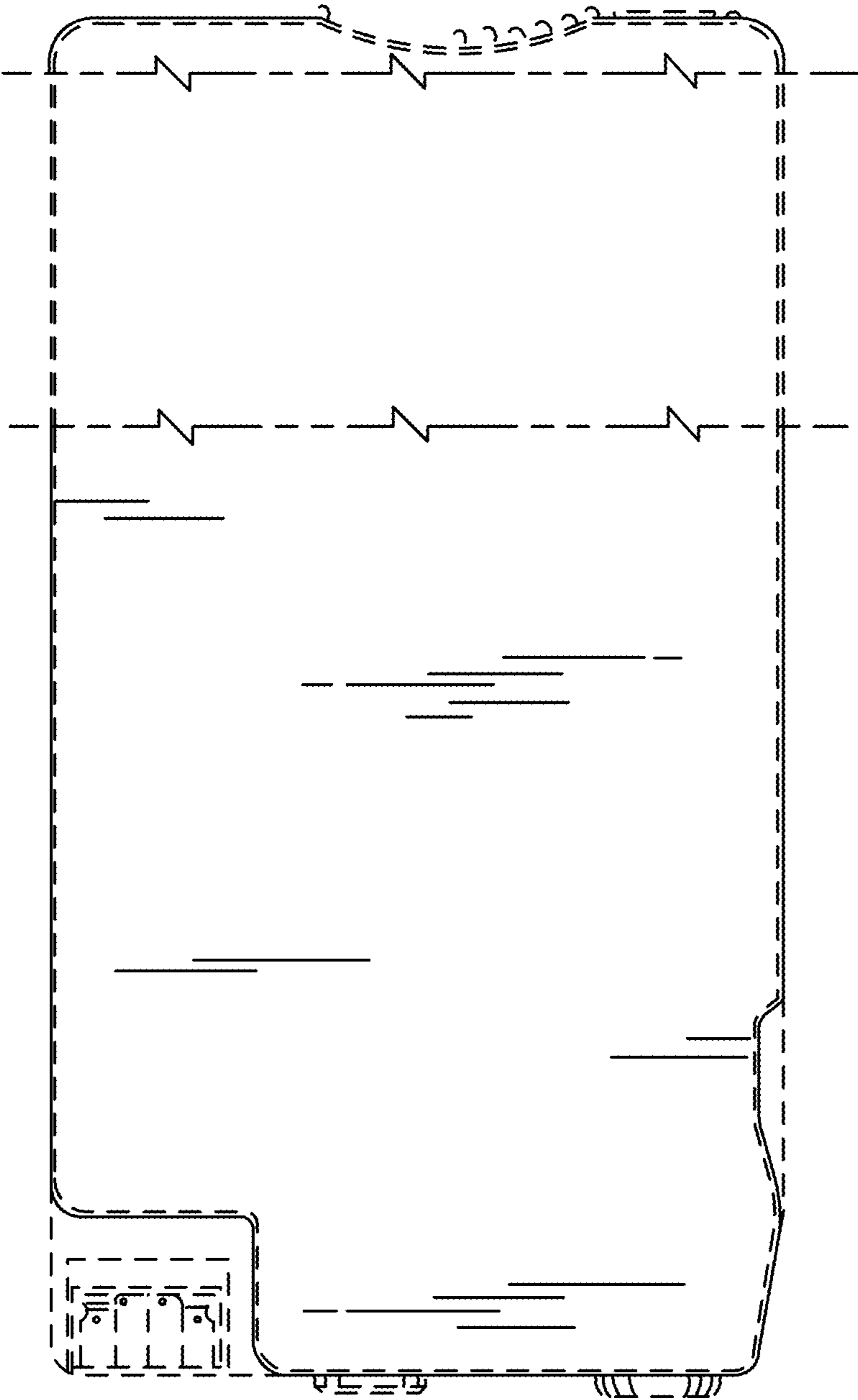

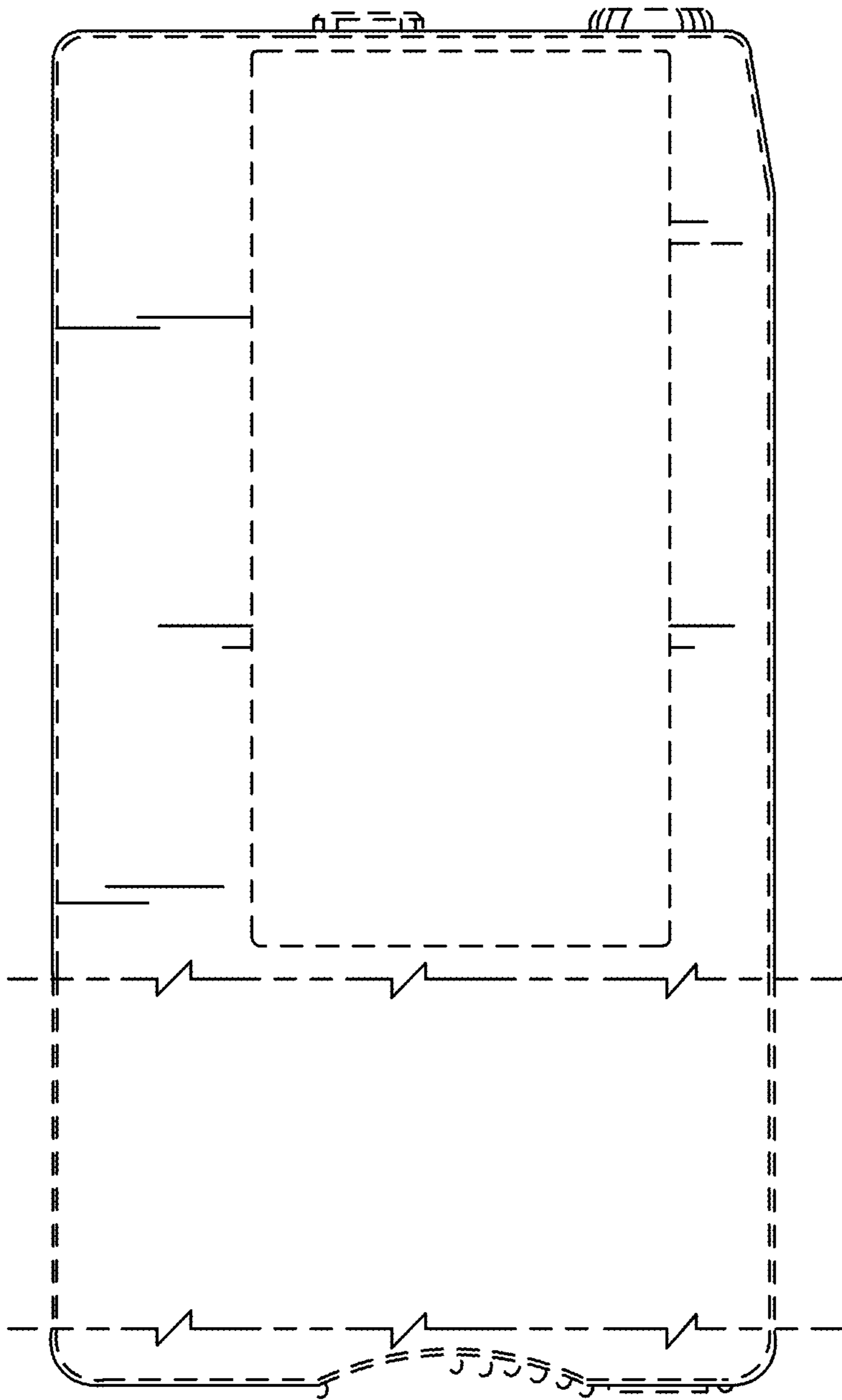
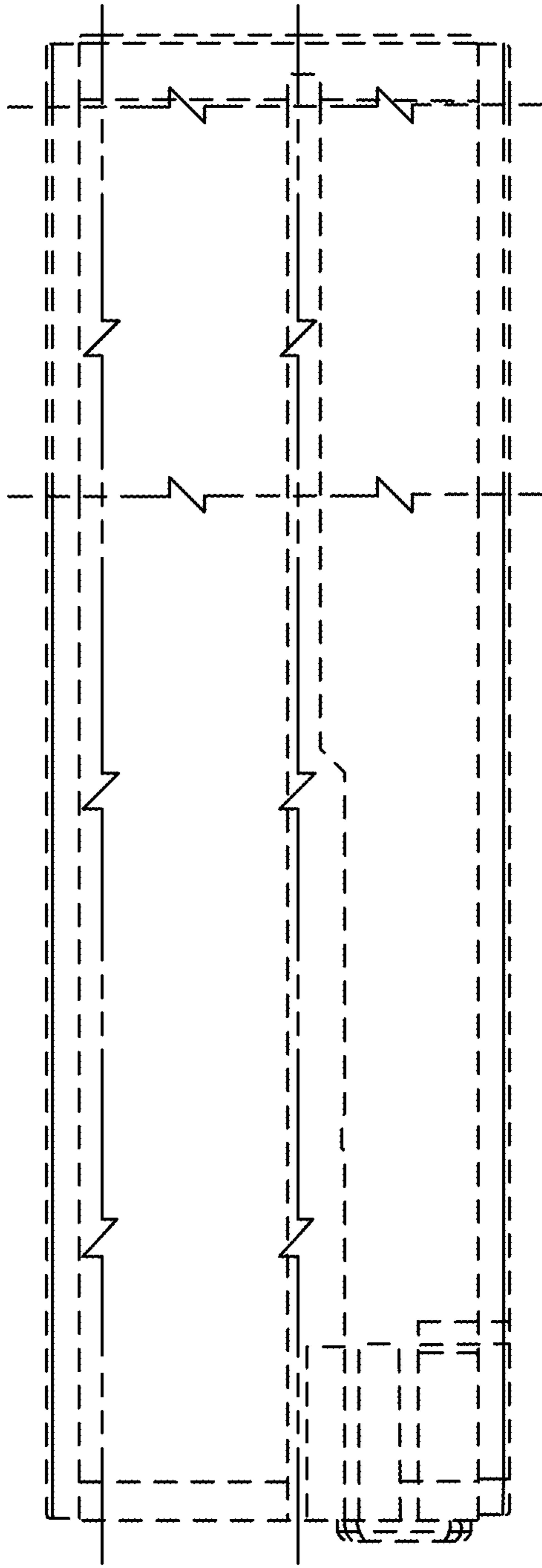

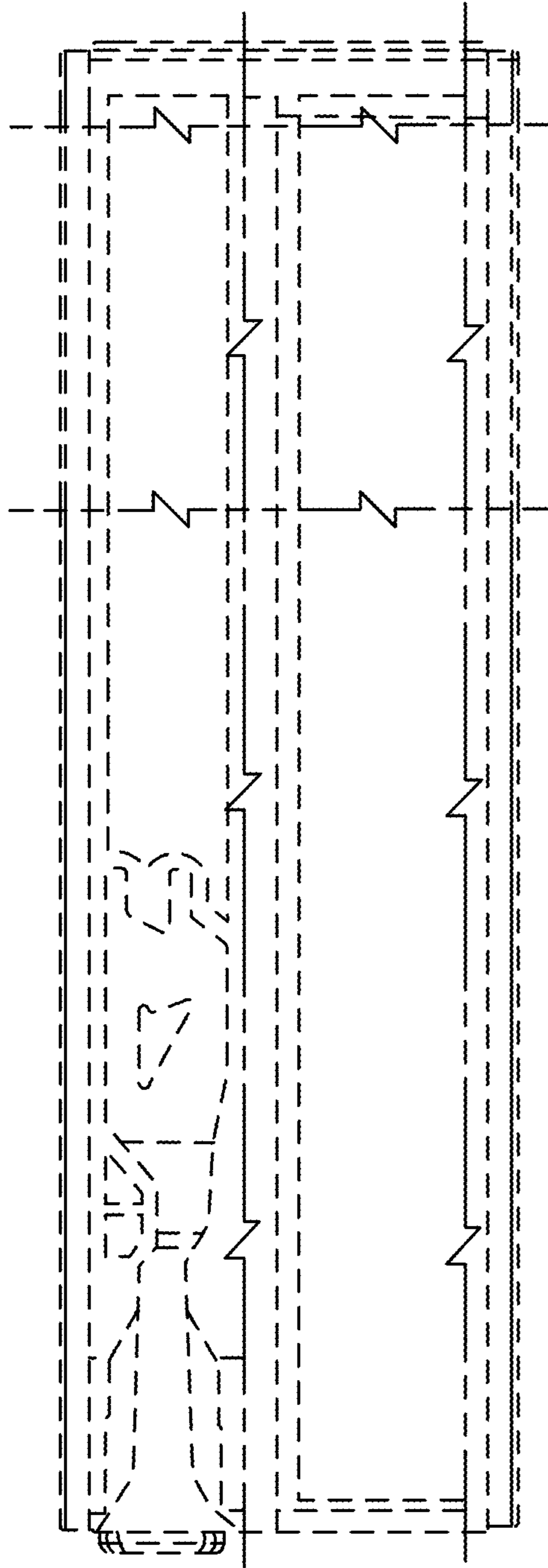

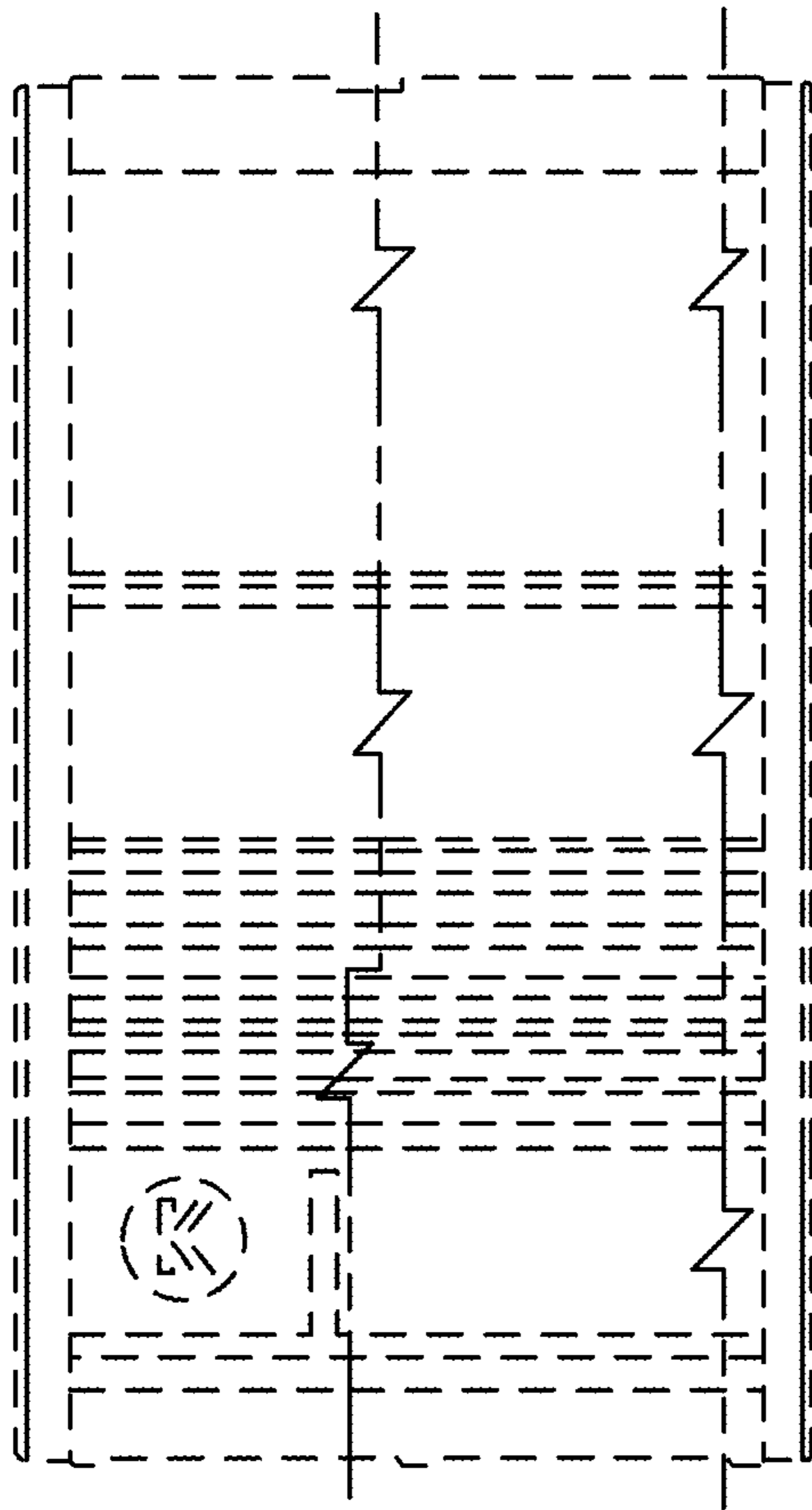

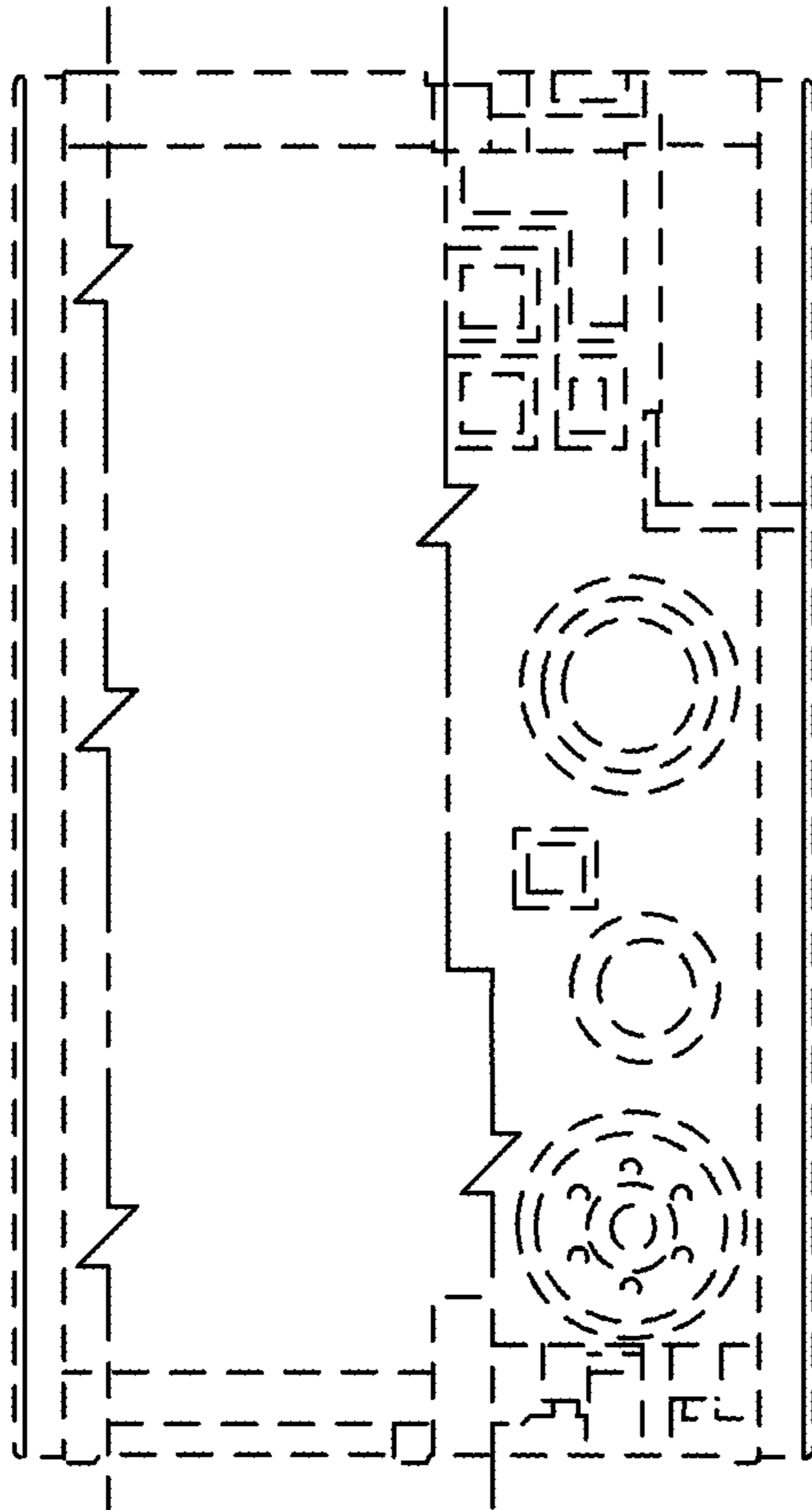
