FIG. 7 is a bottom plan view of the eraser of FIG. 2.

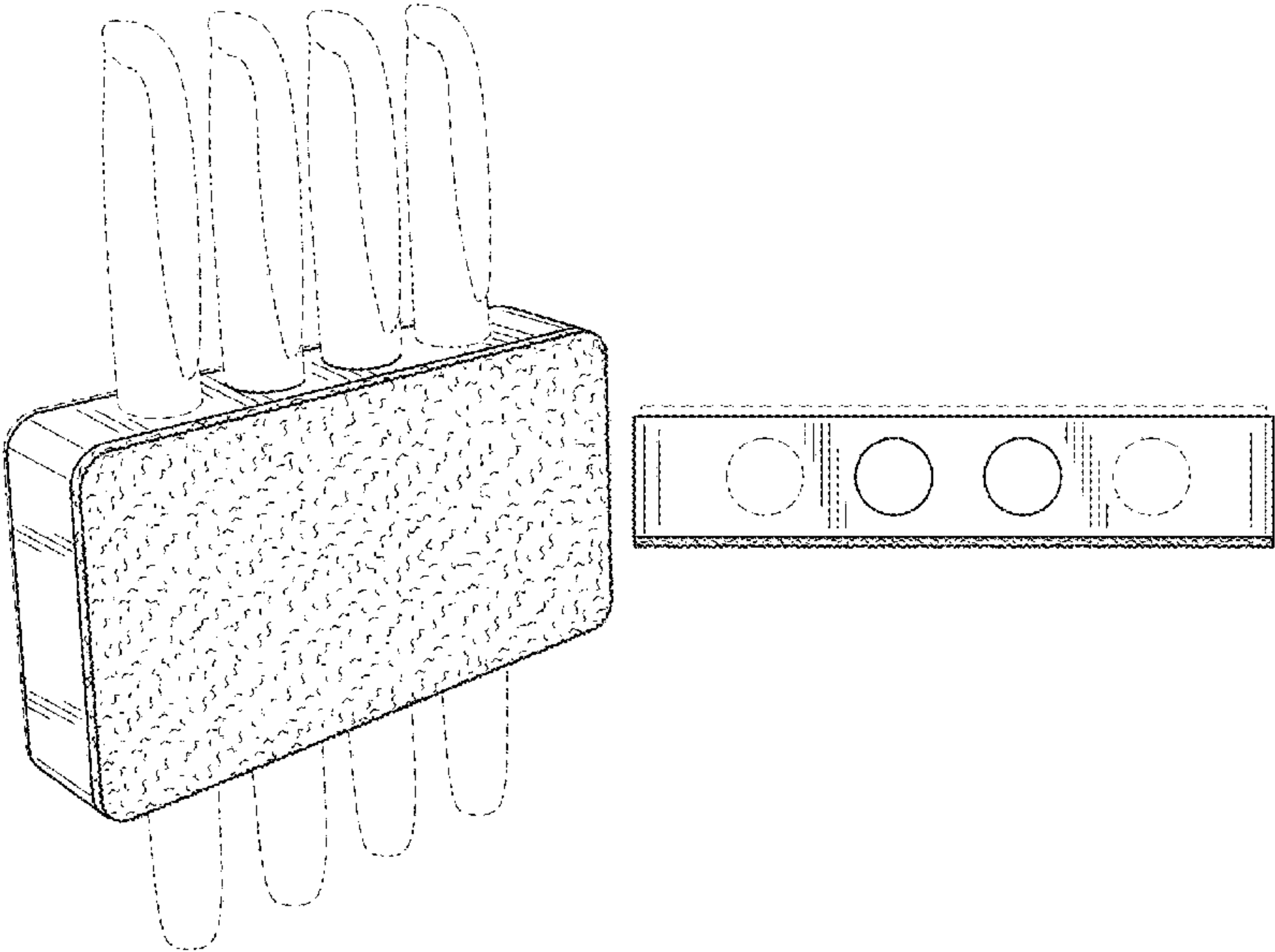
FIG. 8 is a left side elevation view of the eraser of FIG. 2; and,

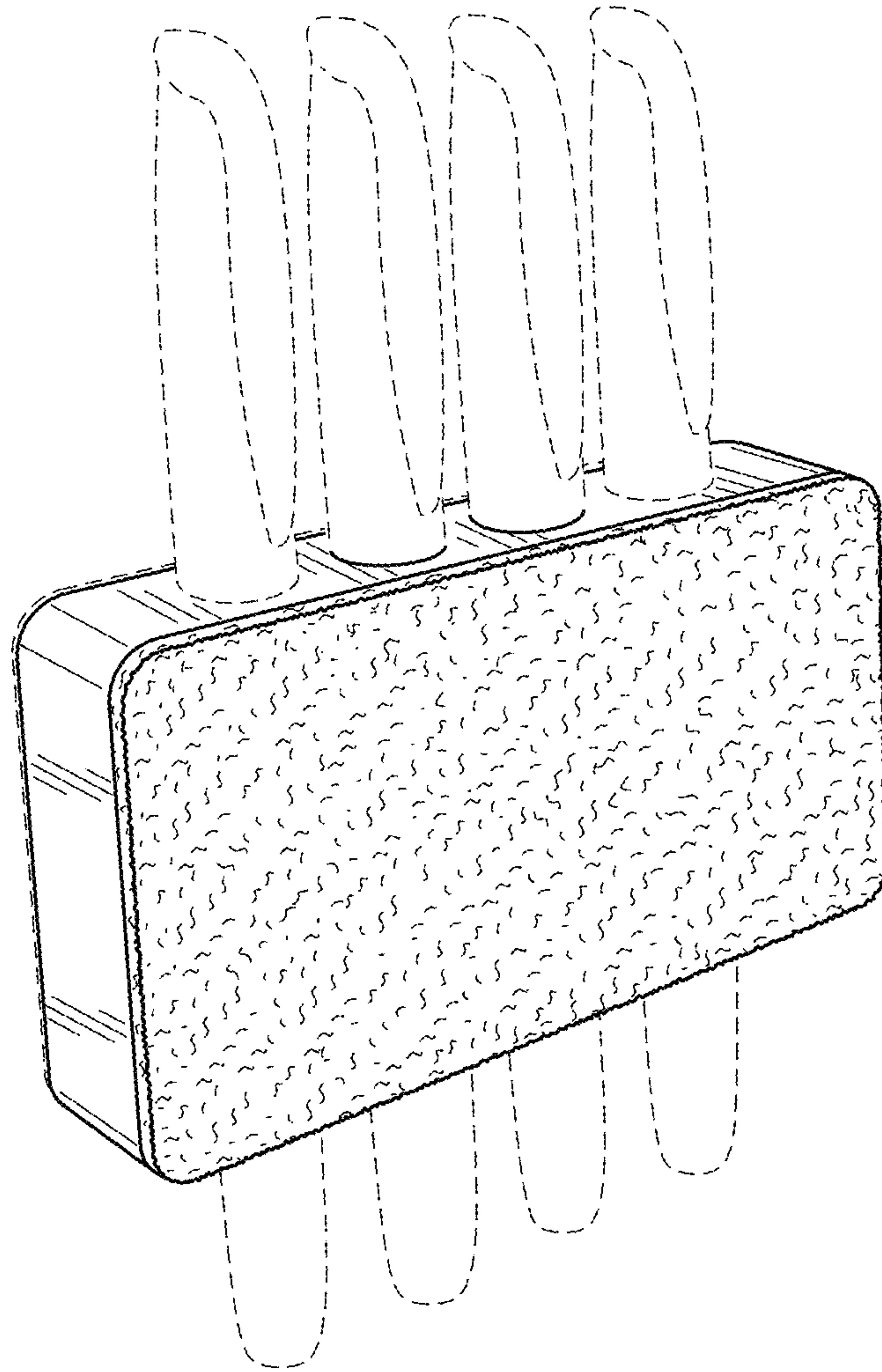

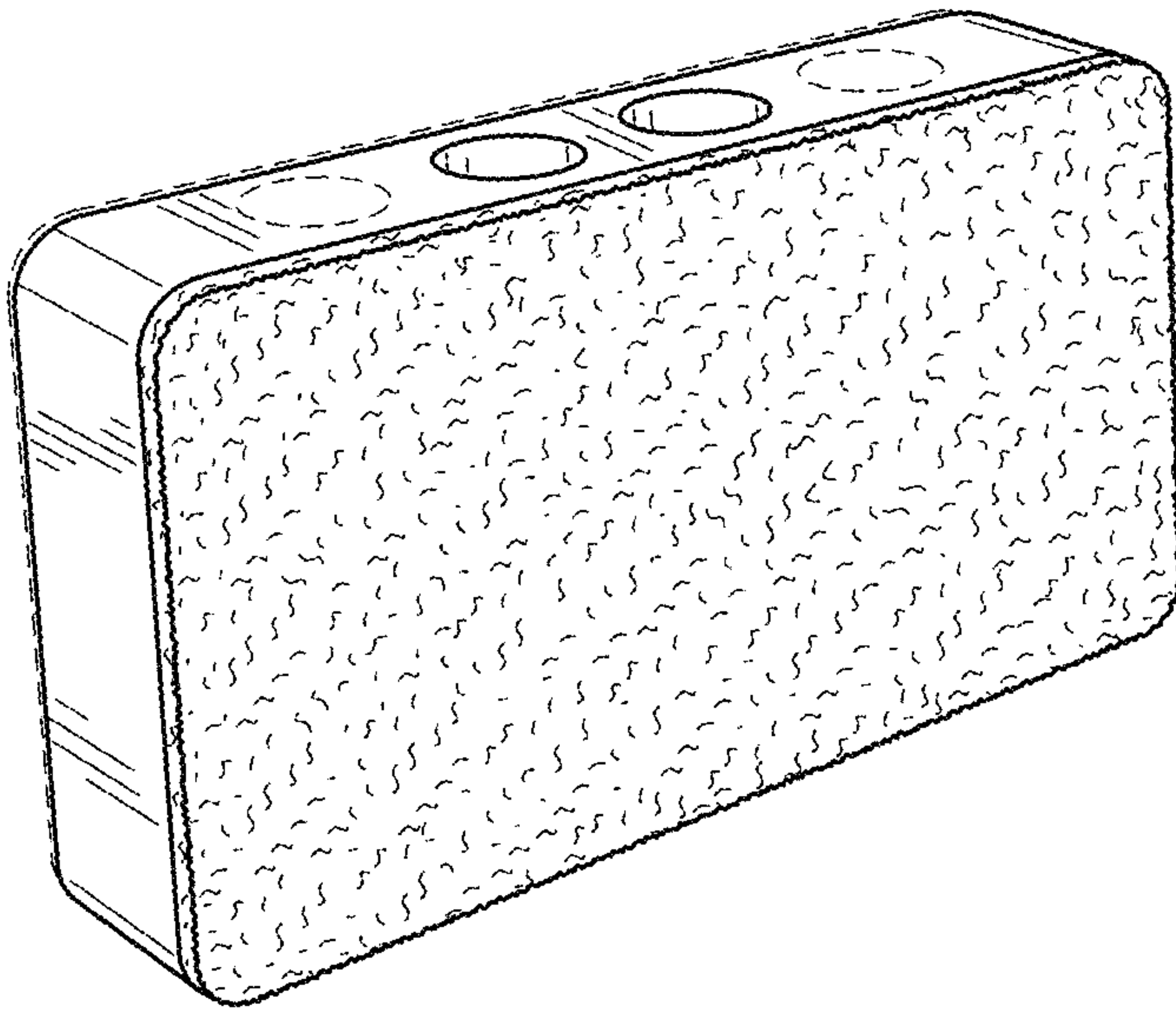

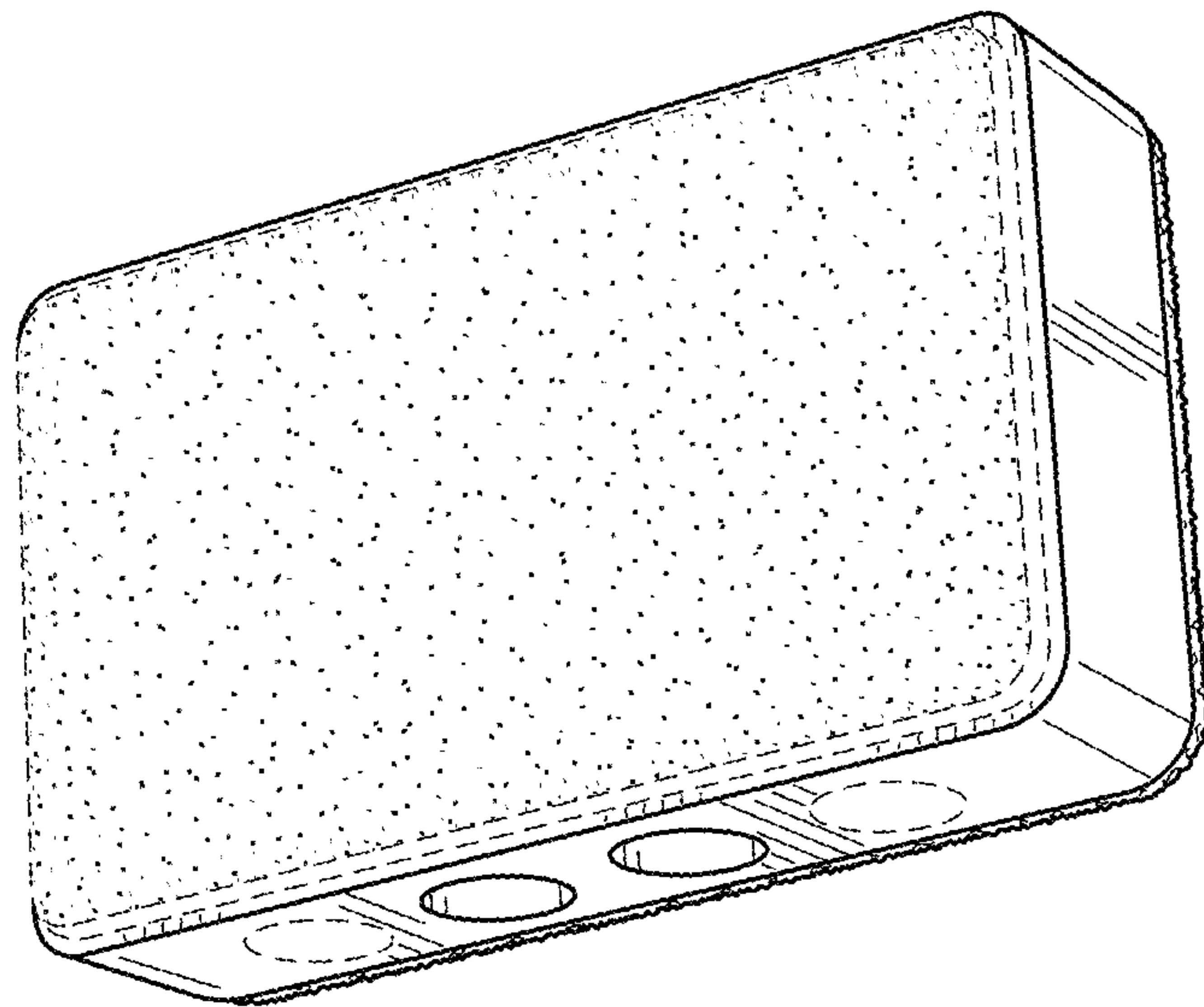

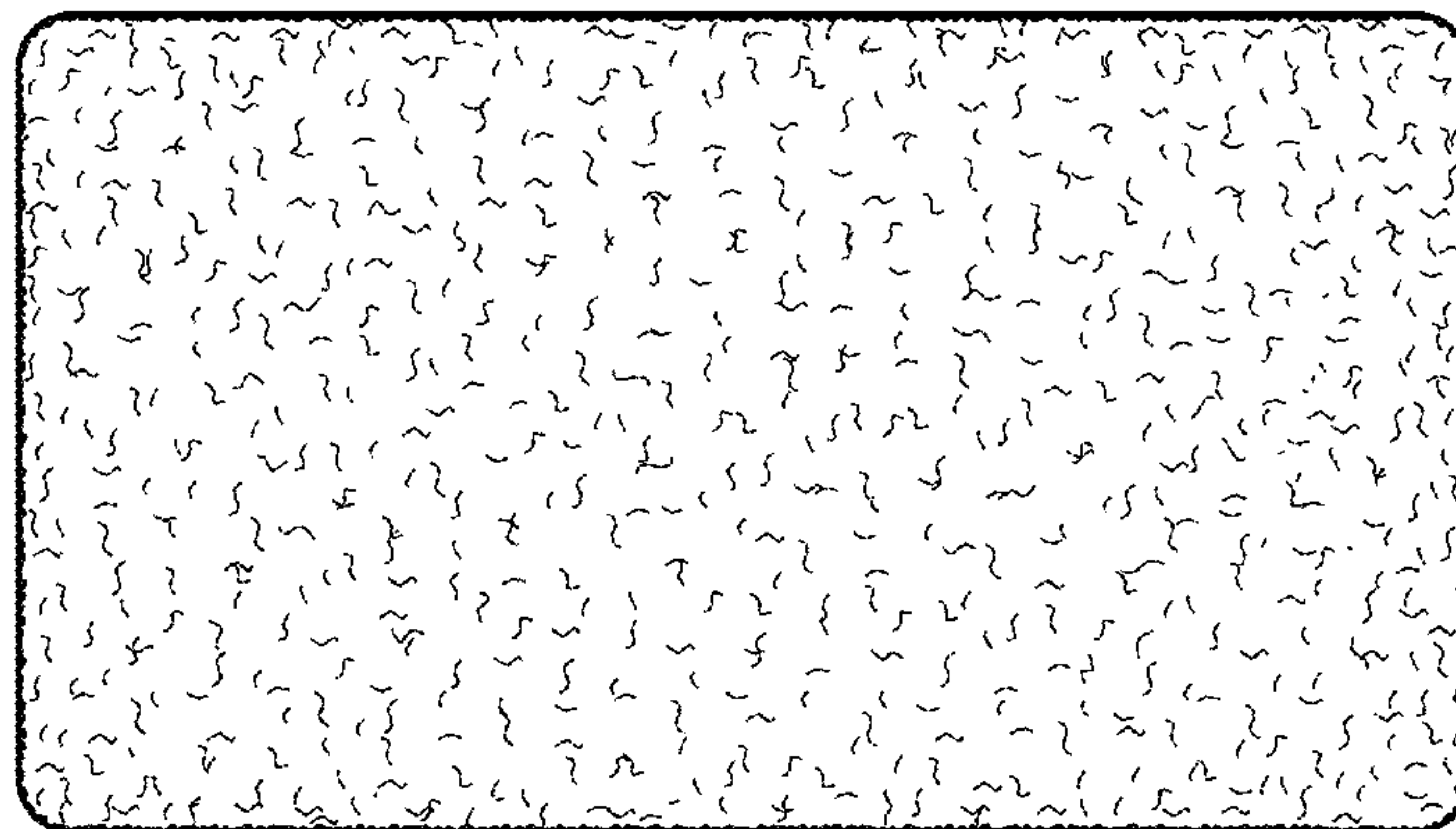

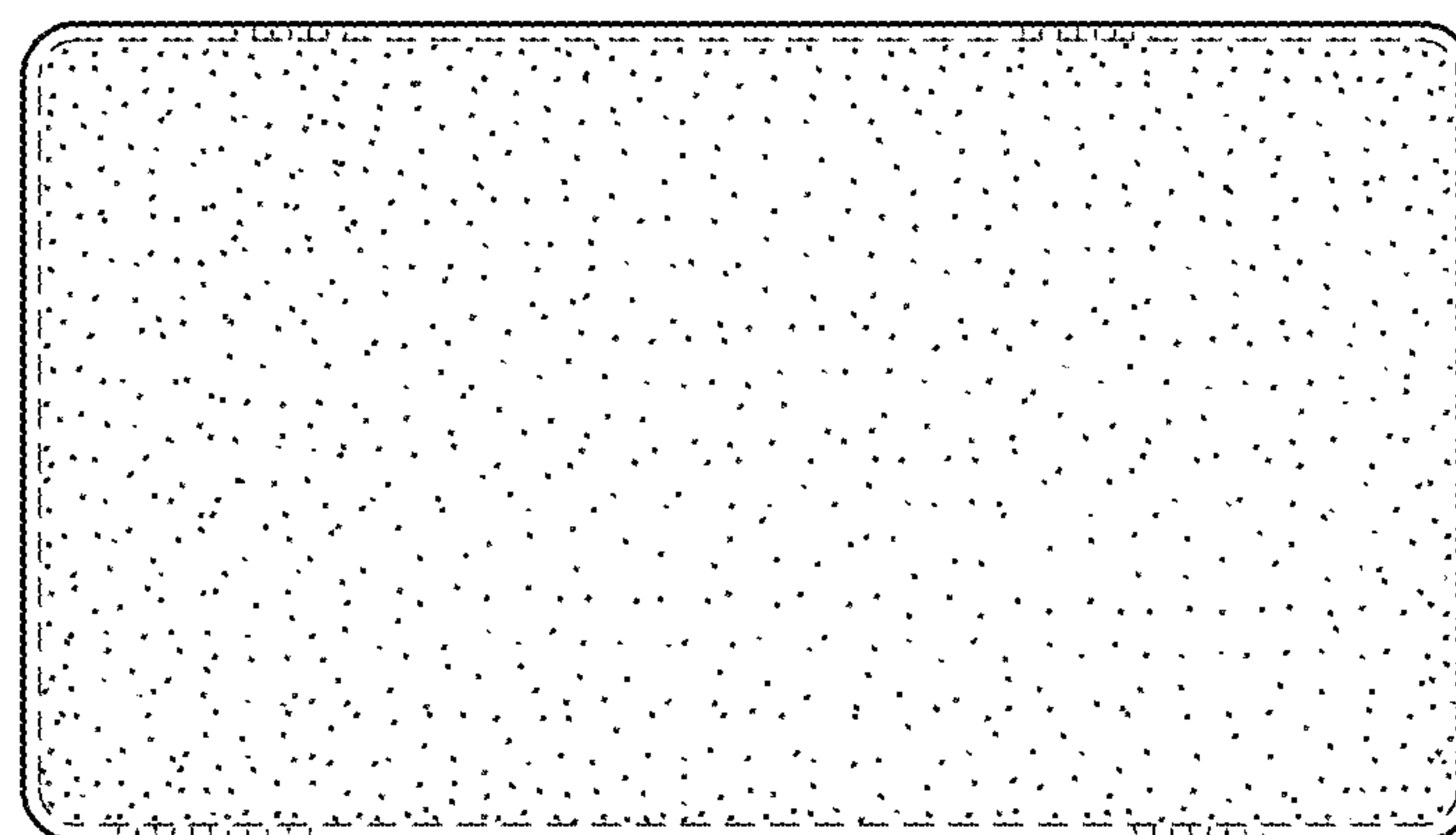

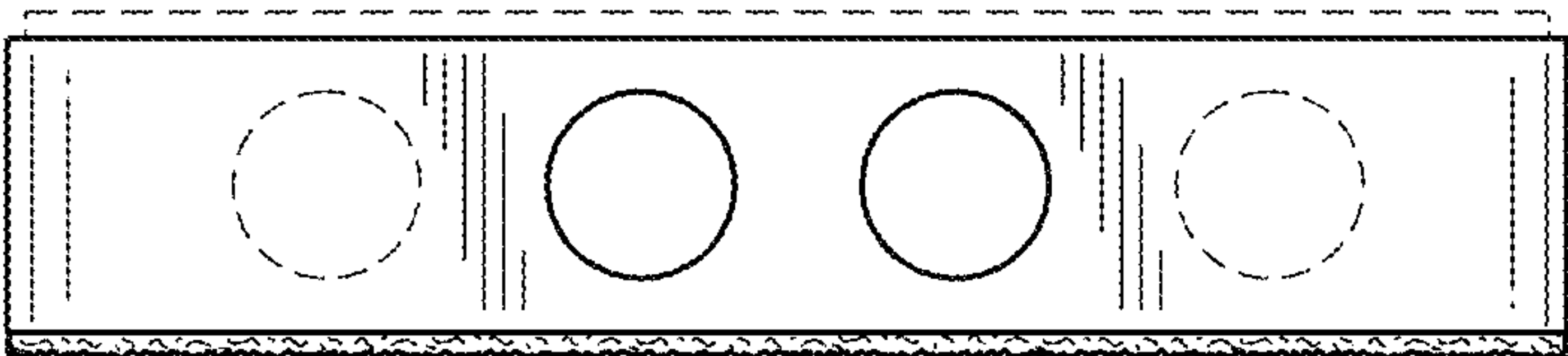

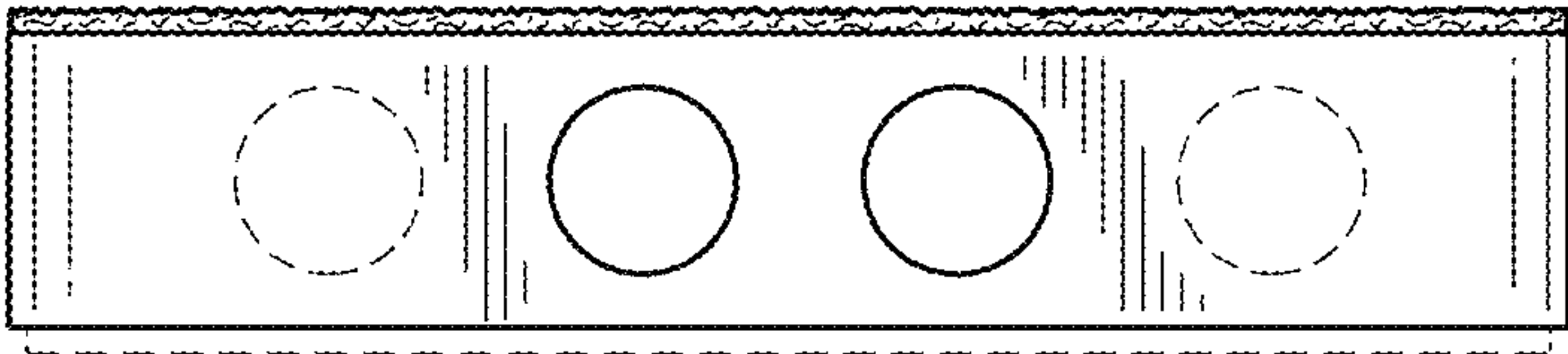

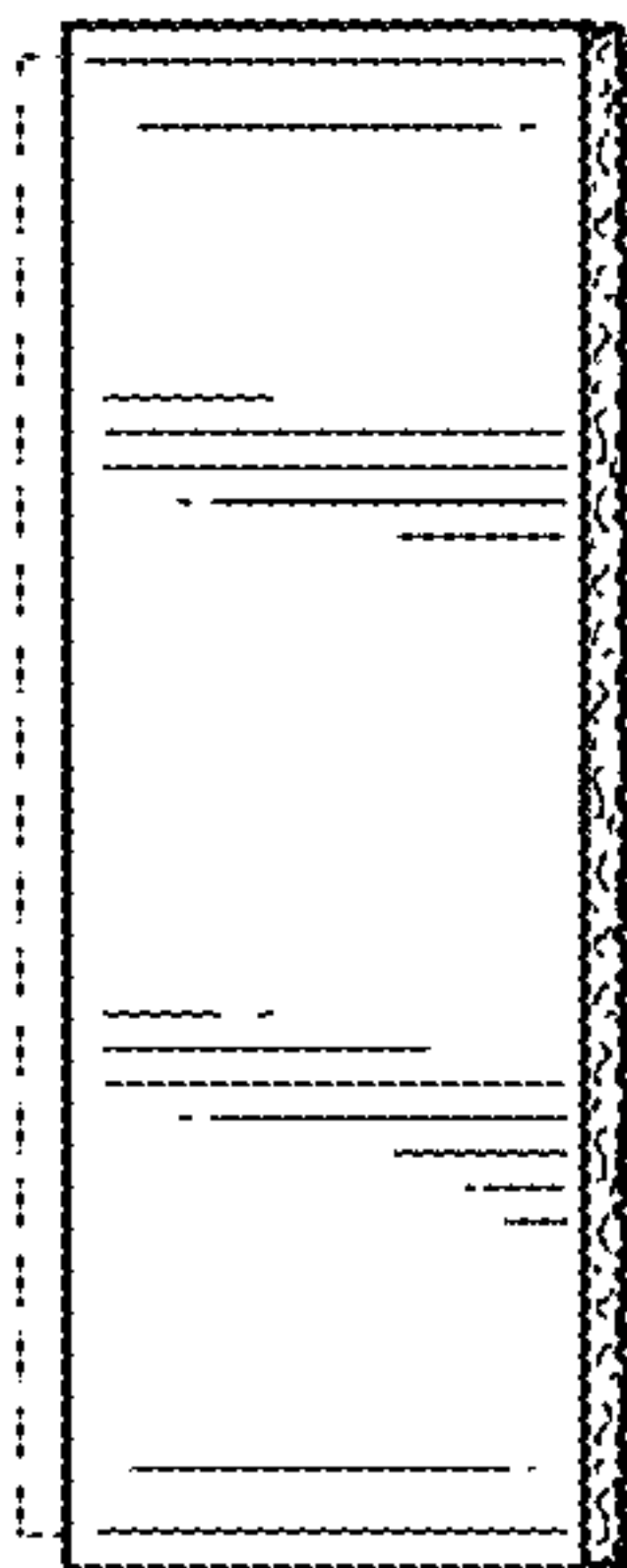

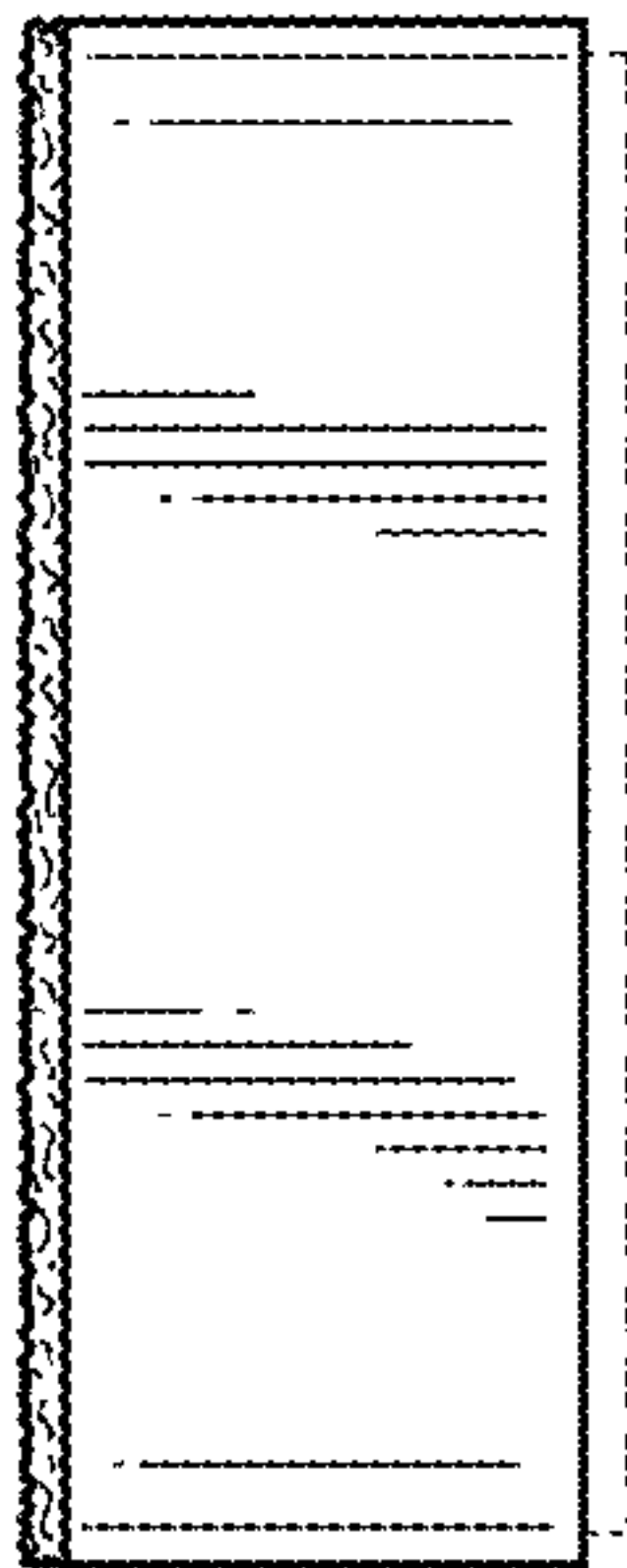
