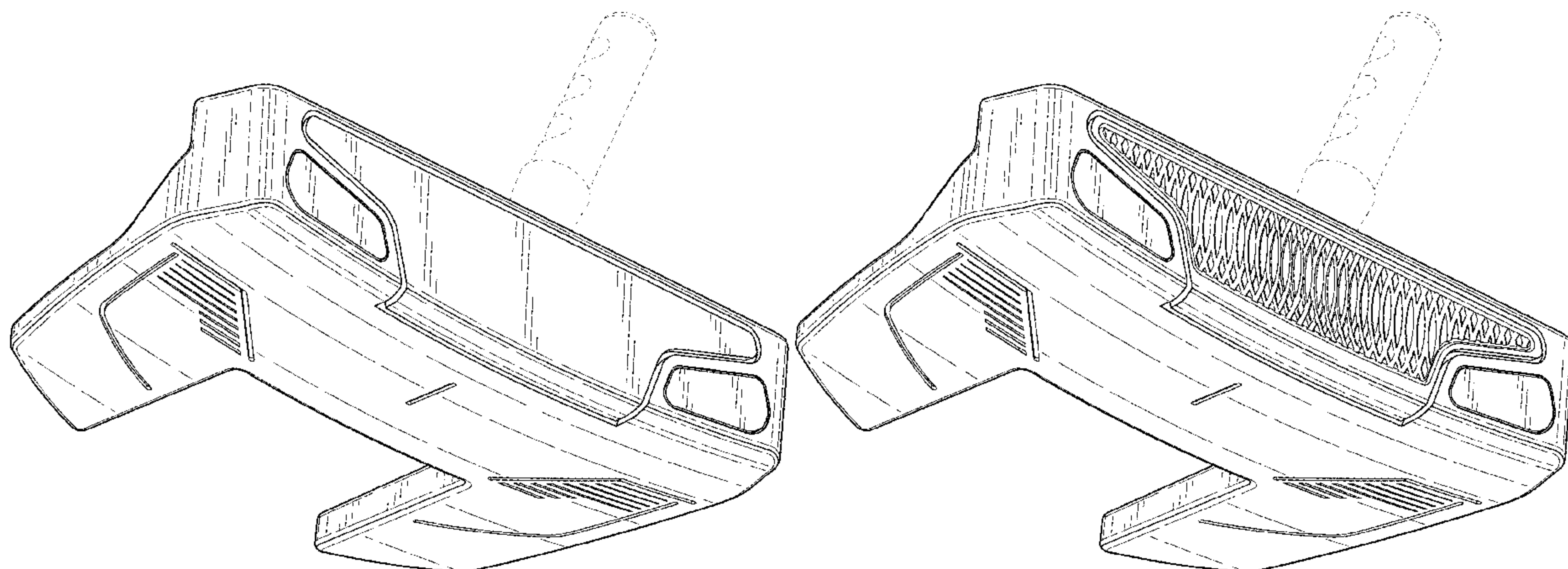
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a golf club head; FIG. 2 is a bottom perspective view of the golf club head of FIG. 1; FIG. 3 is a top view of the golf club head of FIG. 1; FIG. 4 is a bottom view of the golf club head of FIG. 1; FIG. 5 is a front view of the golf club head of FIG. 1; FIG. 6 is a rear view of the golf club head of FIG. 1; FIG. 7 is a heel side view of the golf club head of FIG. 1; FIG. 8 is a toe side view of the golf club head of FIG. 1; FIG. 9 is a top perspective view of a second embodiment of golf club head; FIG. 10 is a bottom perspective view of the golf club head of FIG. 9; FIG. 11 is a top view of the golf club head of FIG. 9; FIG. 12 is a bottom view of the golf club head of FIG. 9; FIG. 13 is a front view of the golf club head of FIG. 9; FIG. 14 is a rear view of the golf club head of FIG. 9; FIG. 15 is a heel side view of the golf club head of FIG. 9; and, FIG. 16 is a toe side view of the golf club head of FIG. 9. 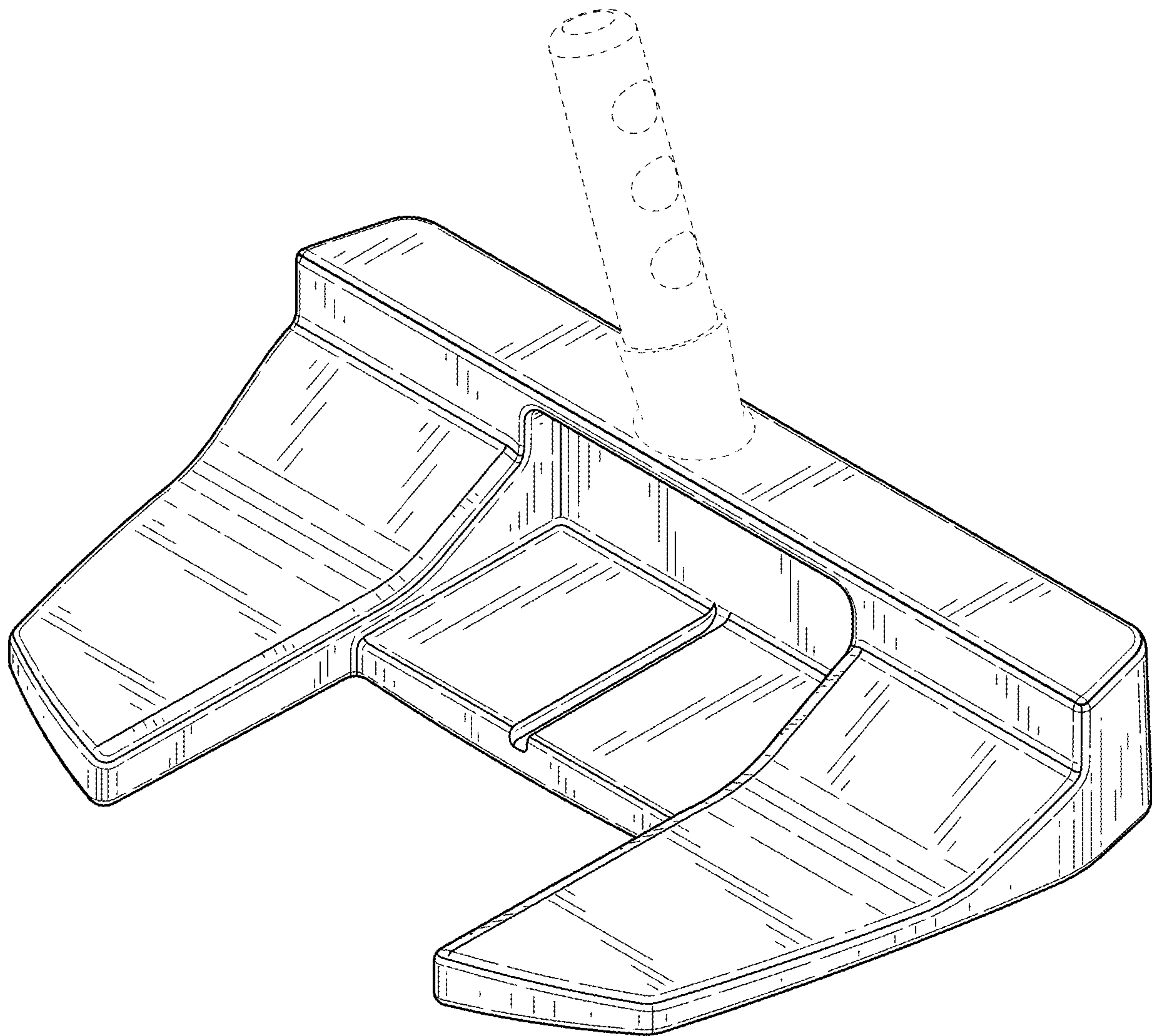

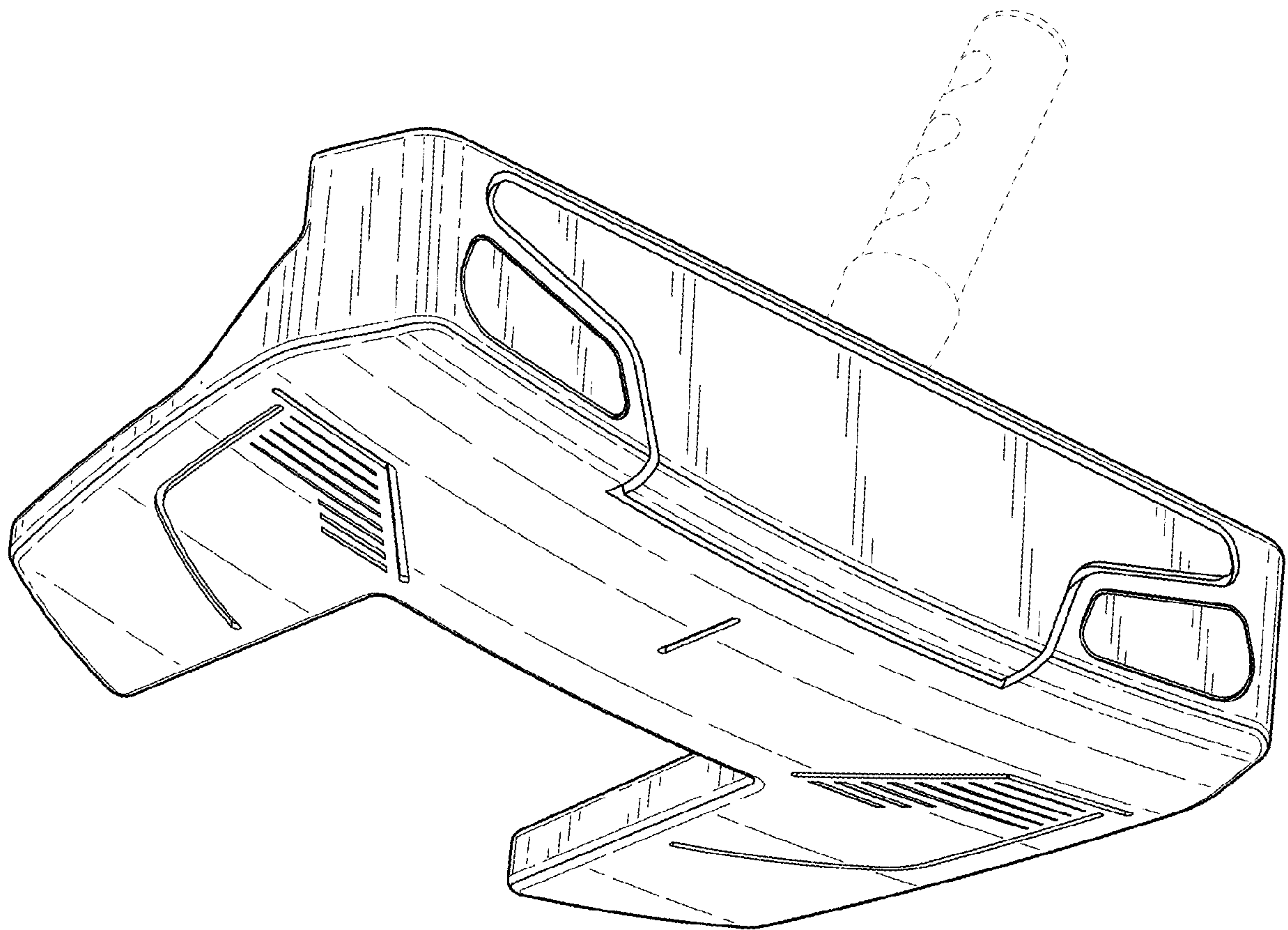

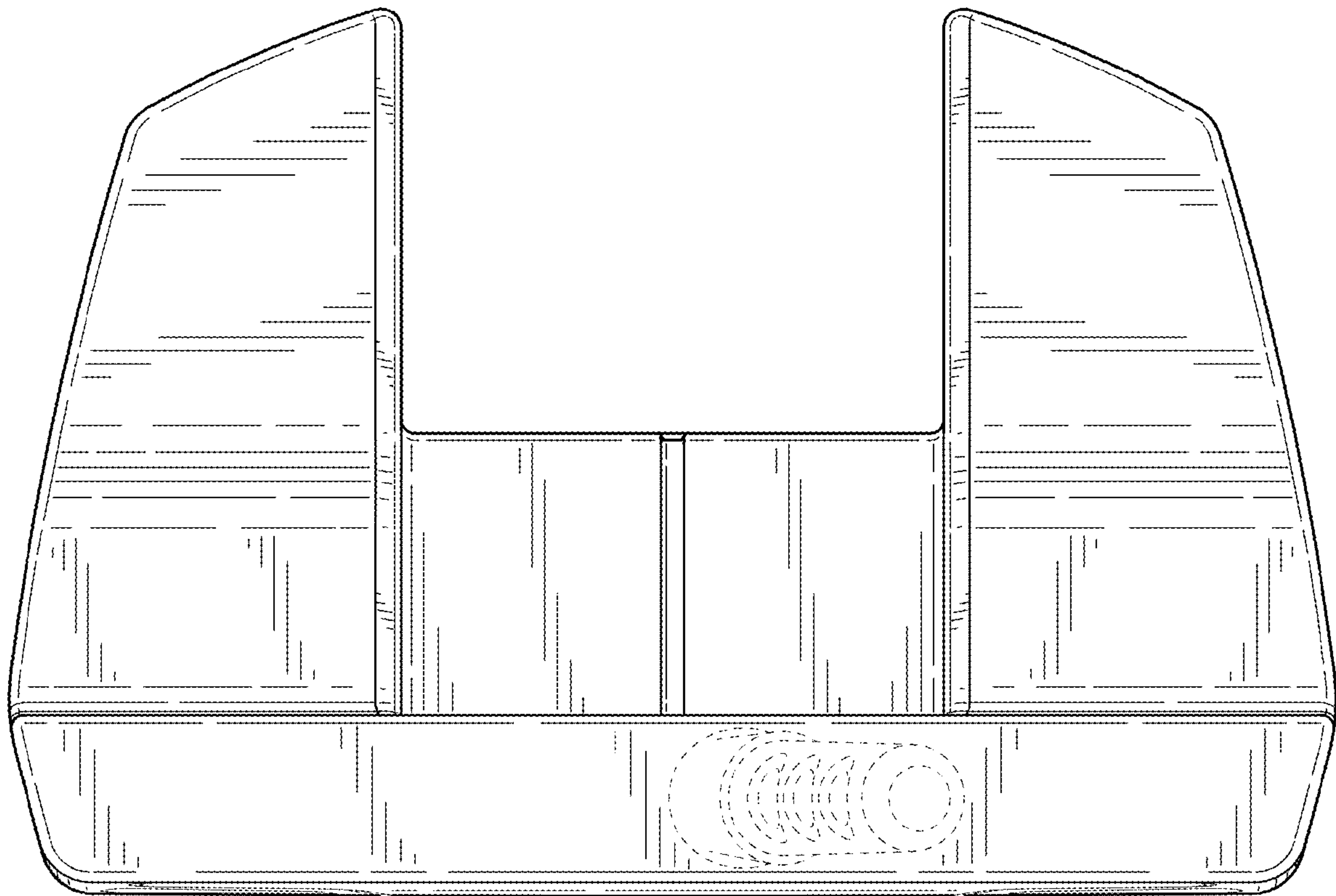

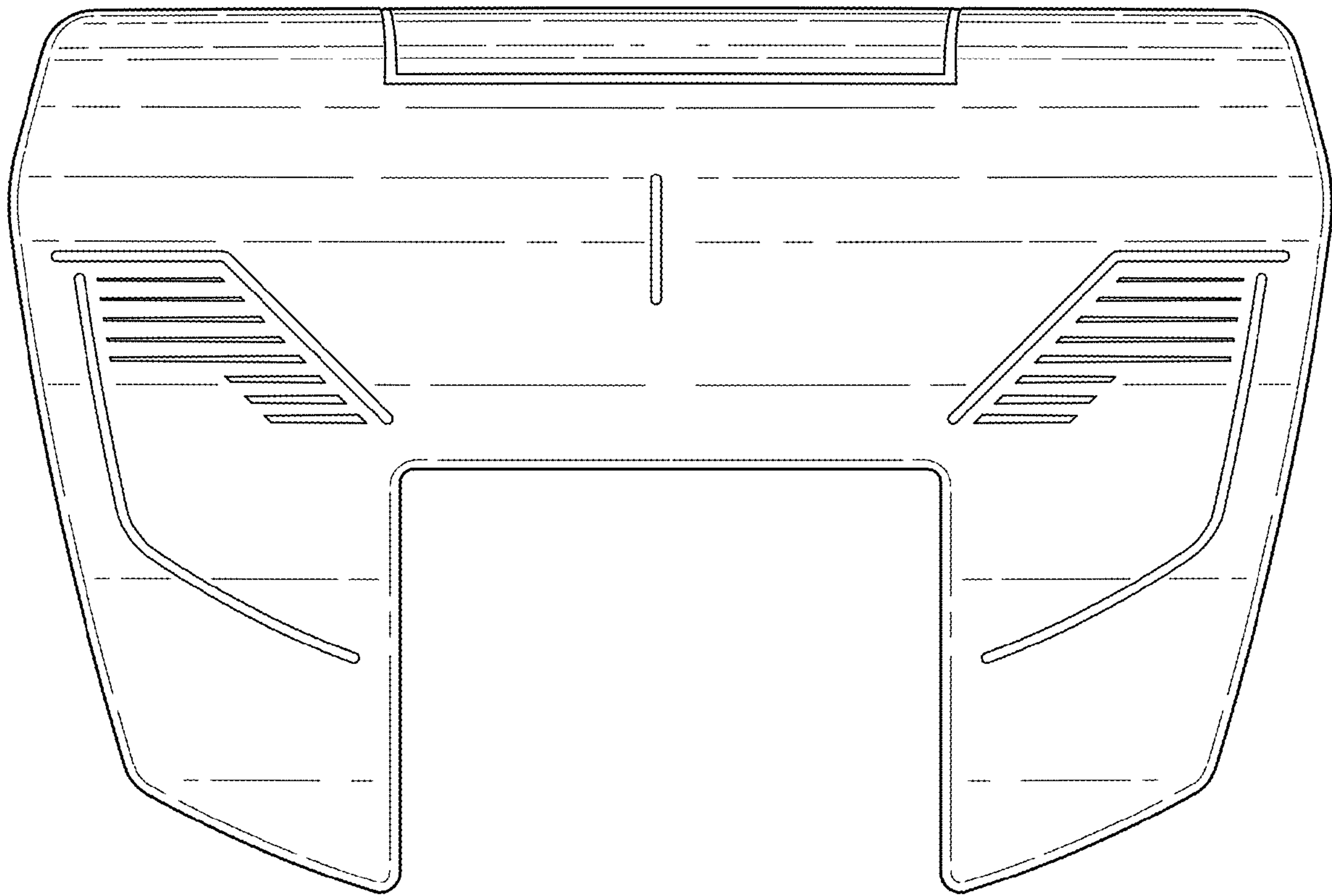

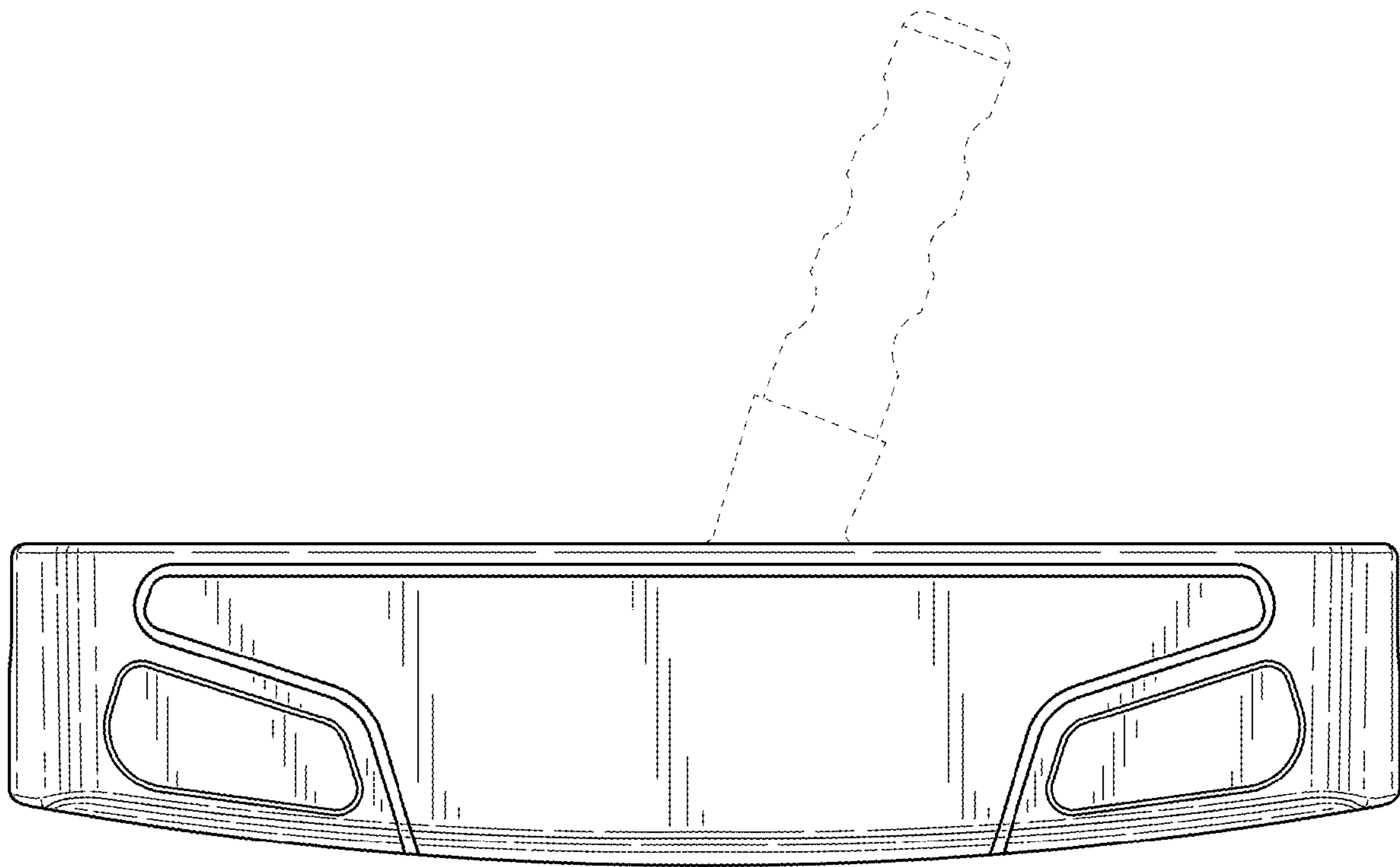

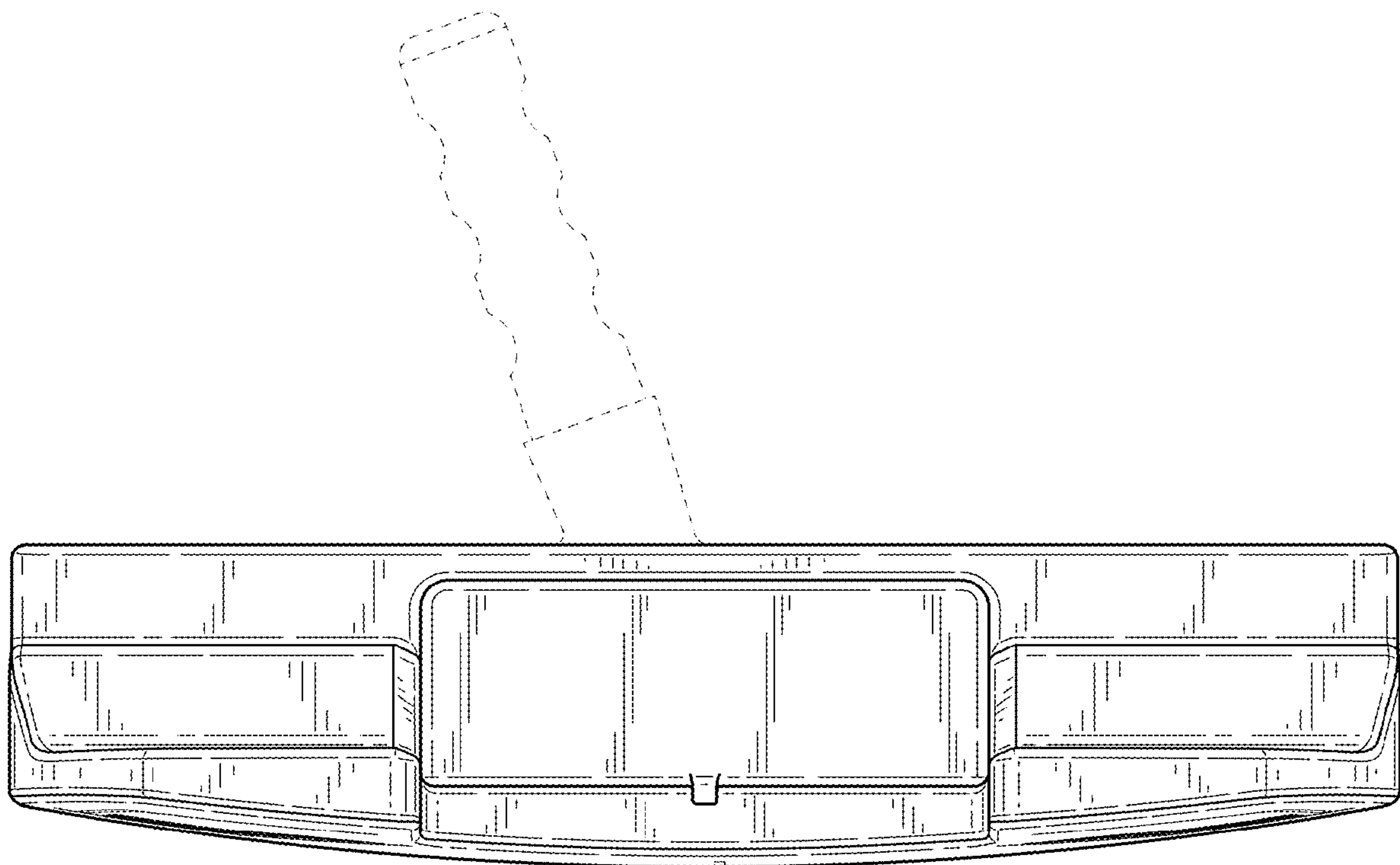

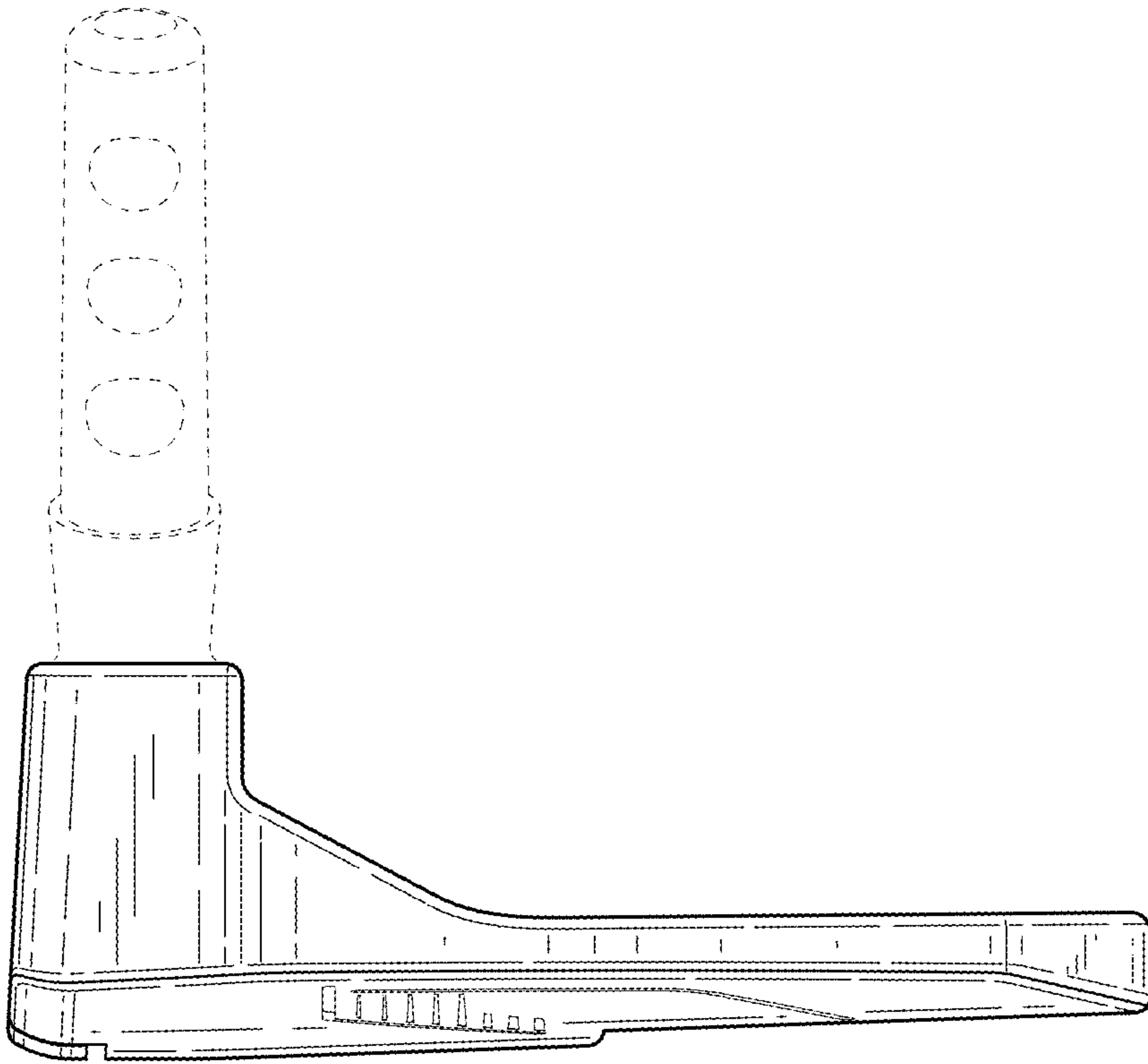

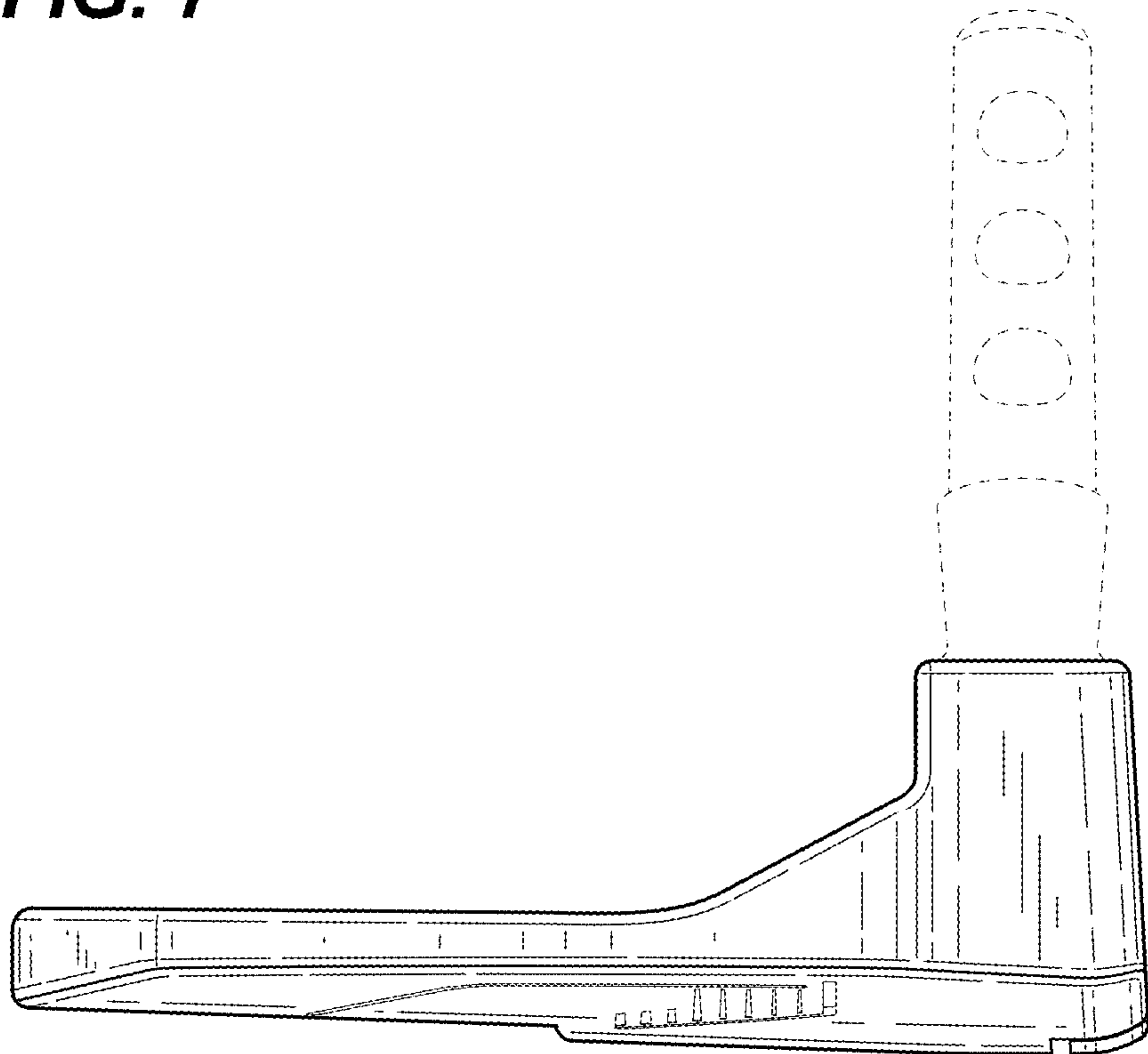

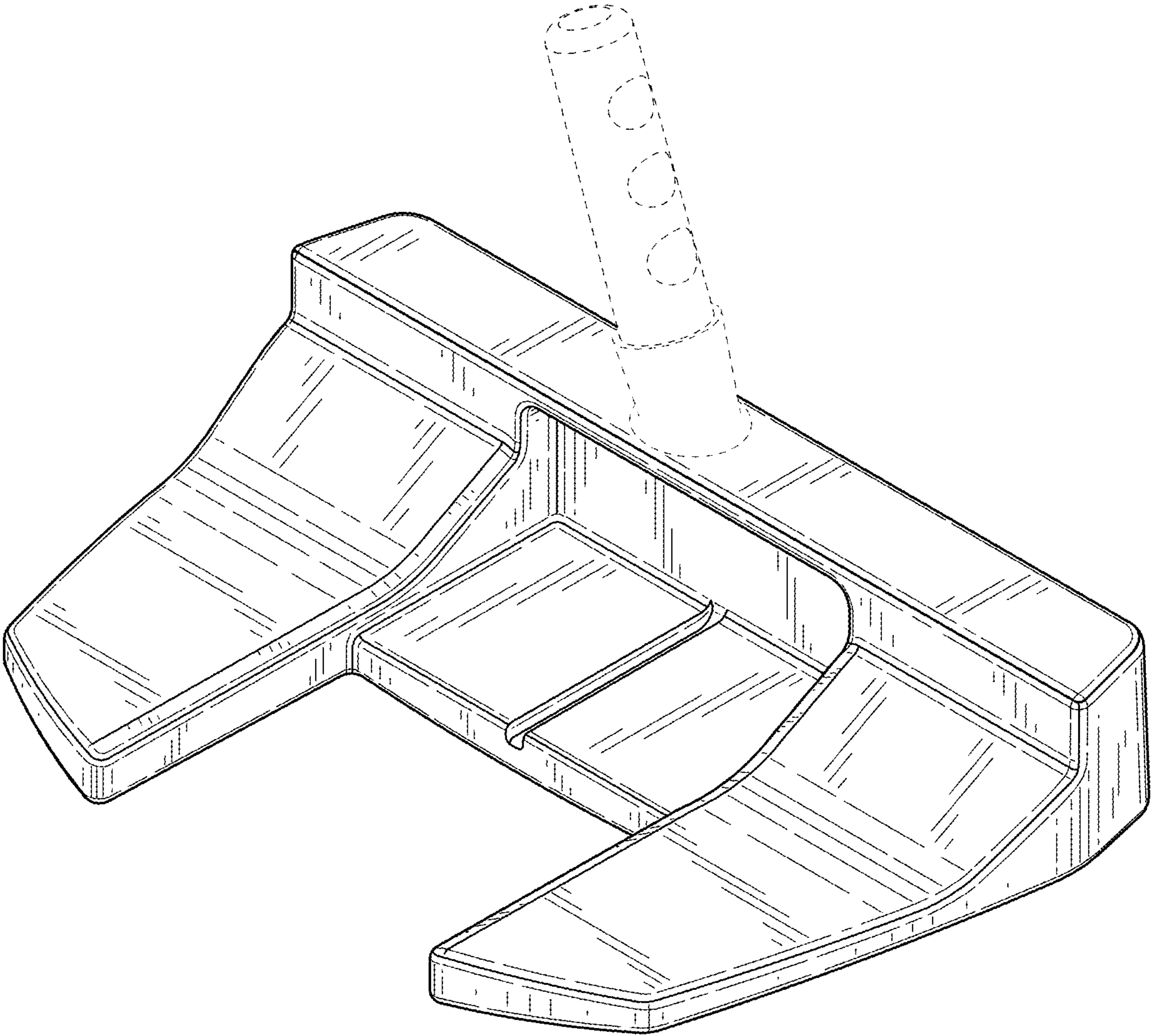

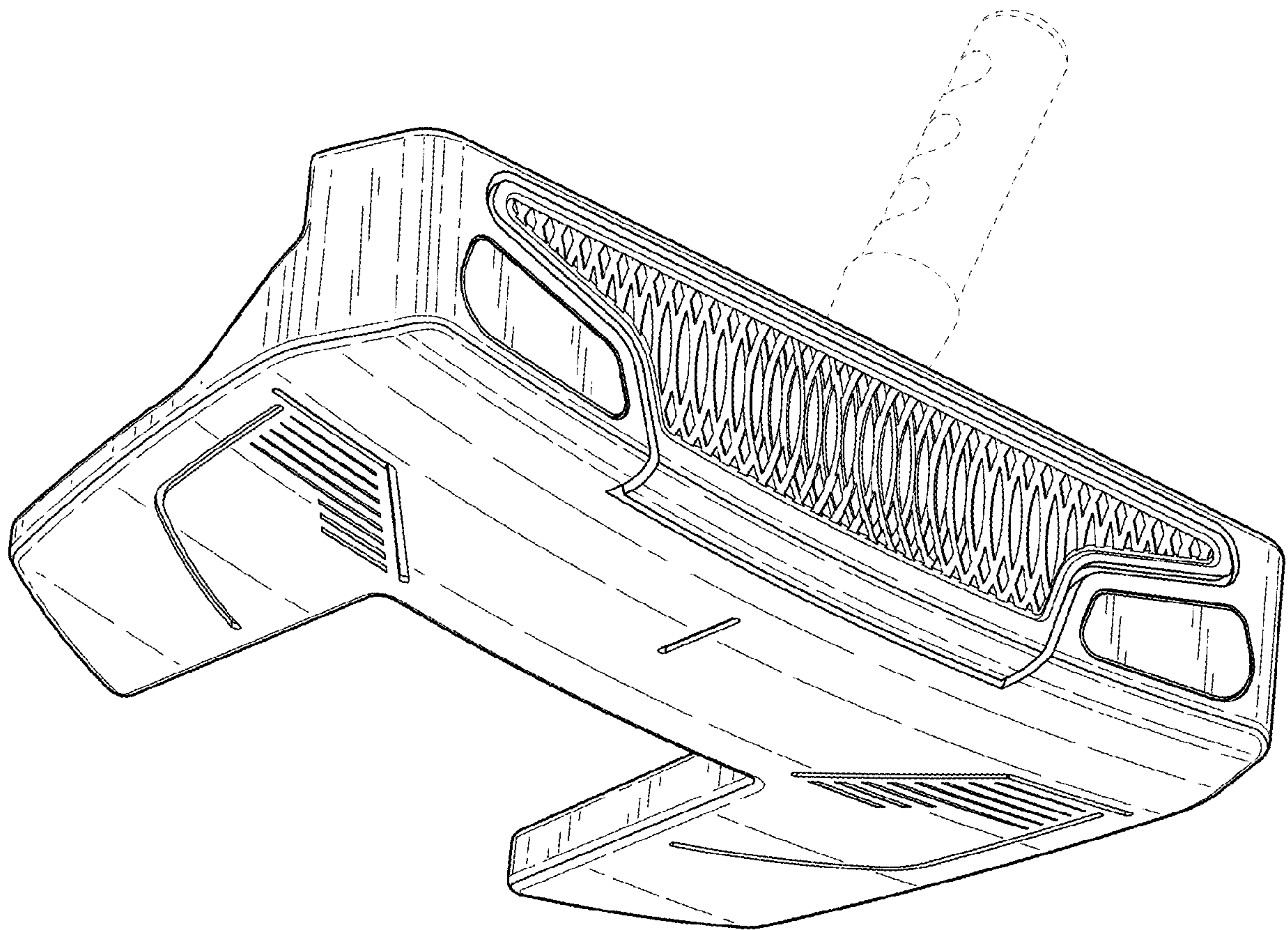

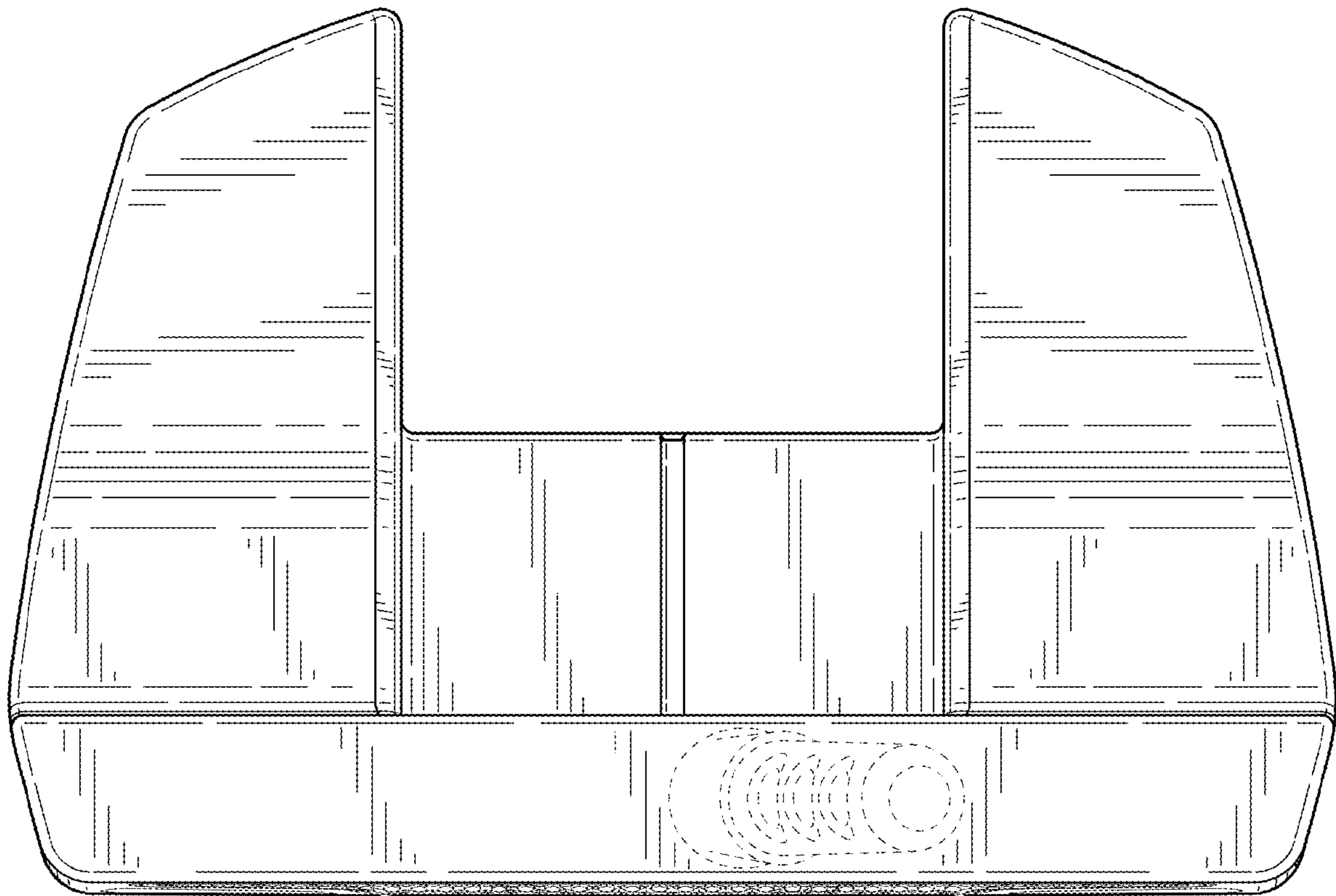

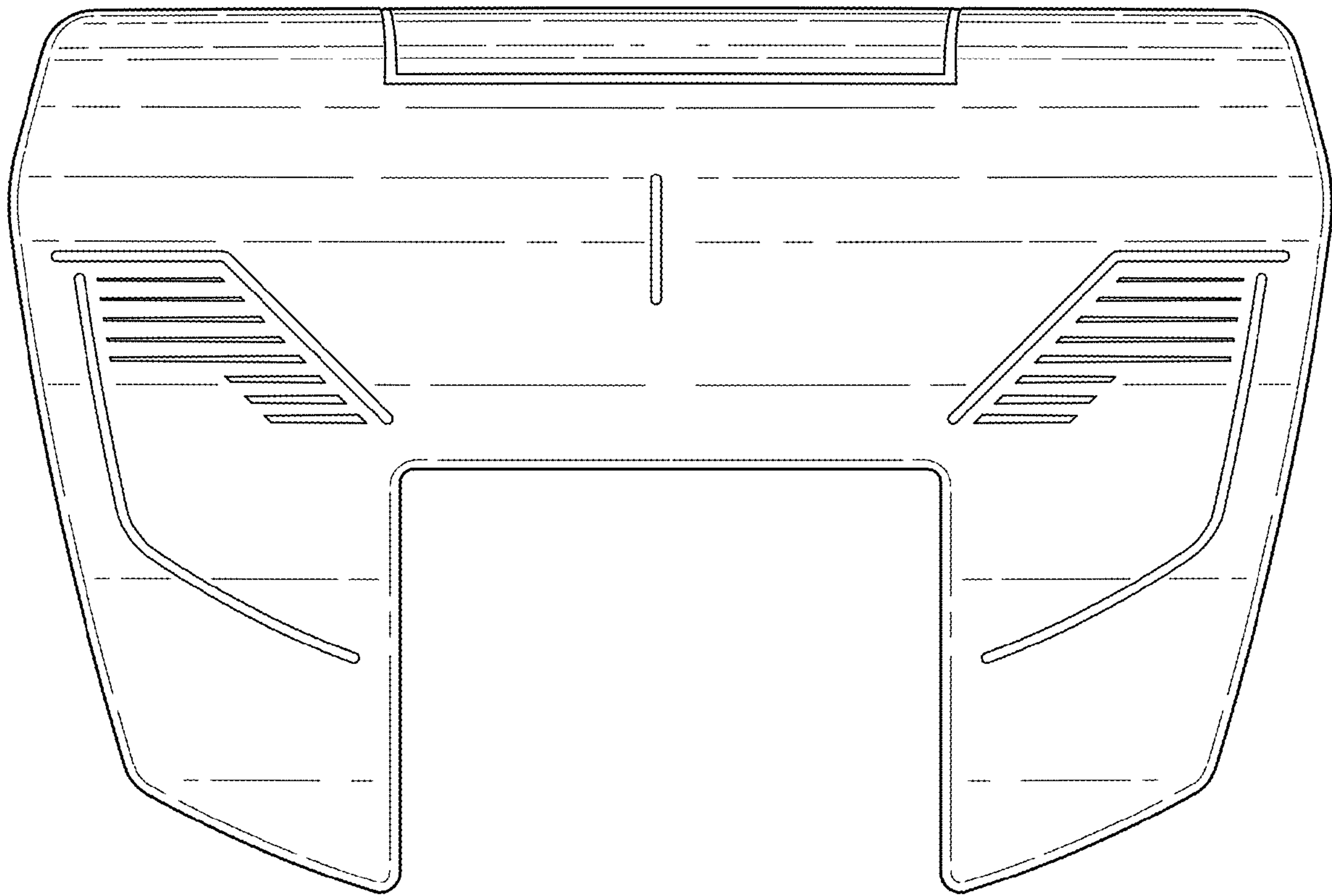

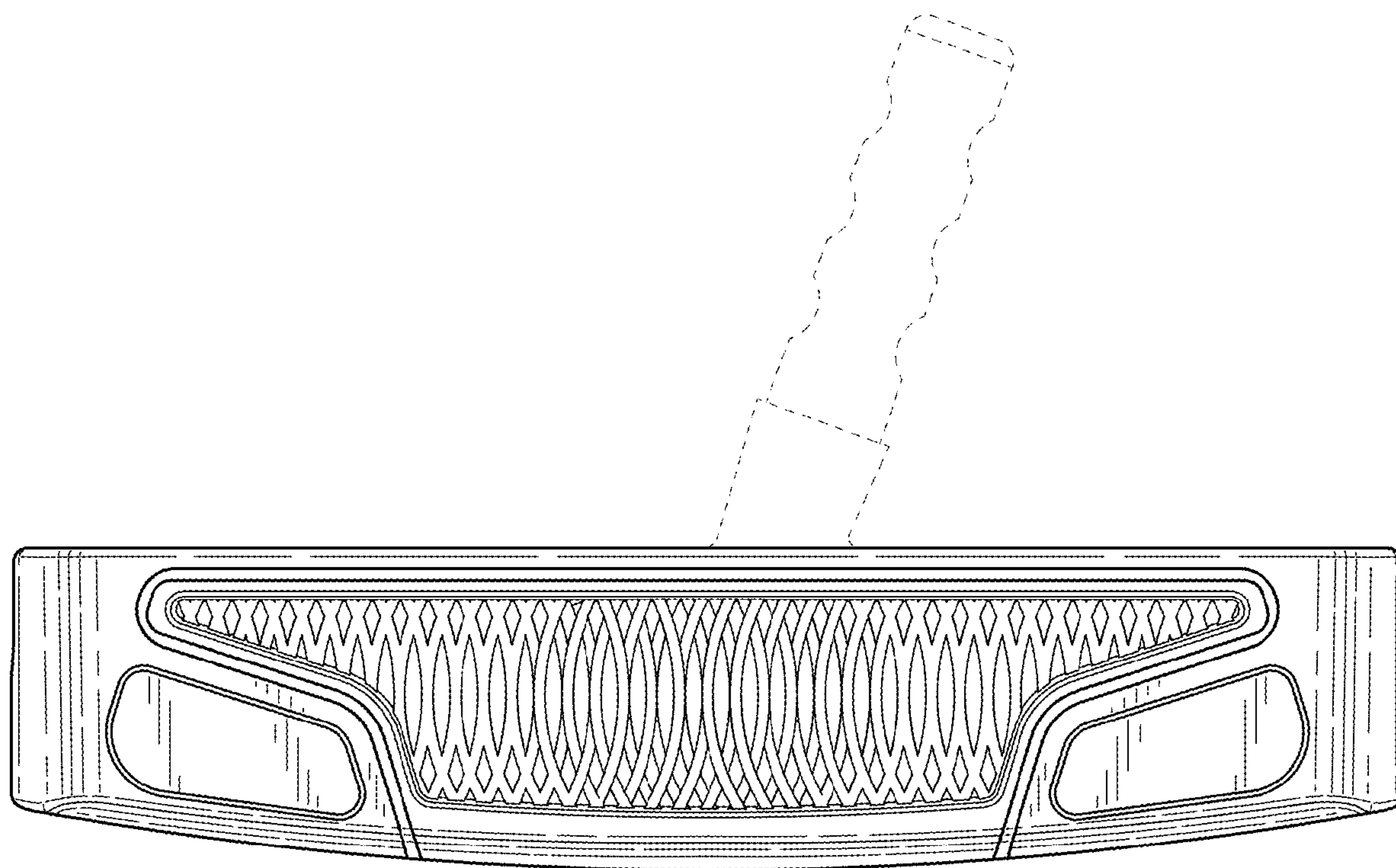

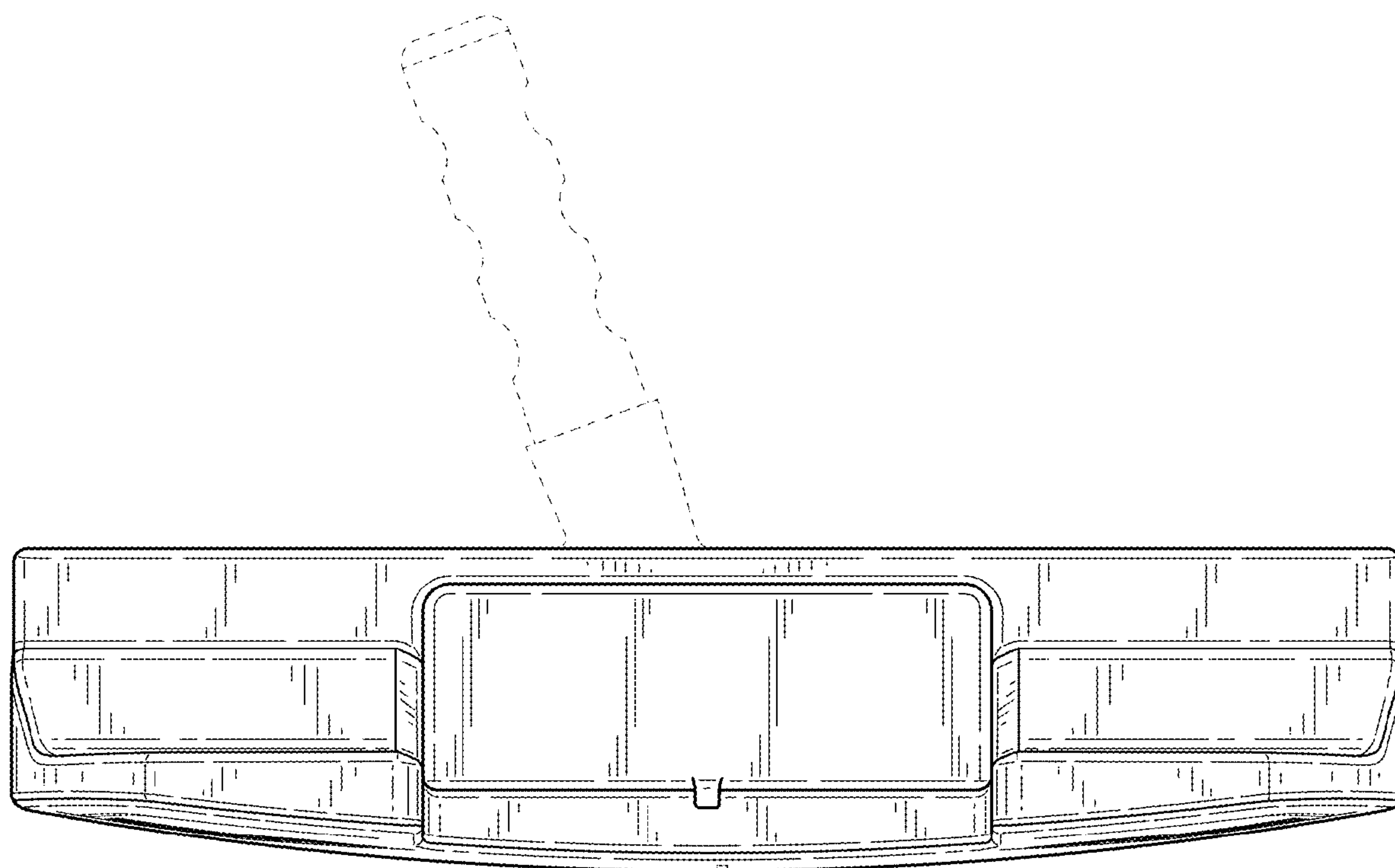

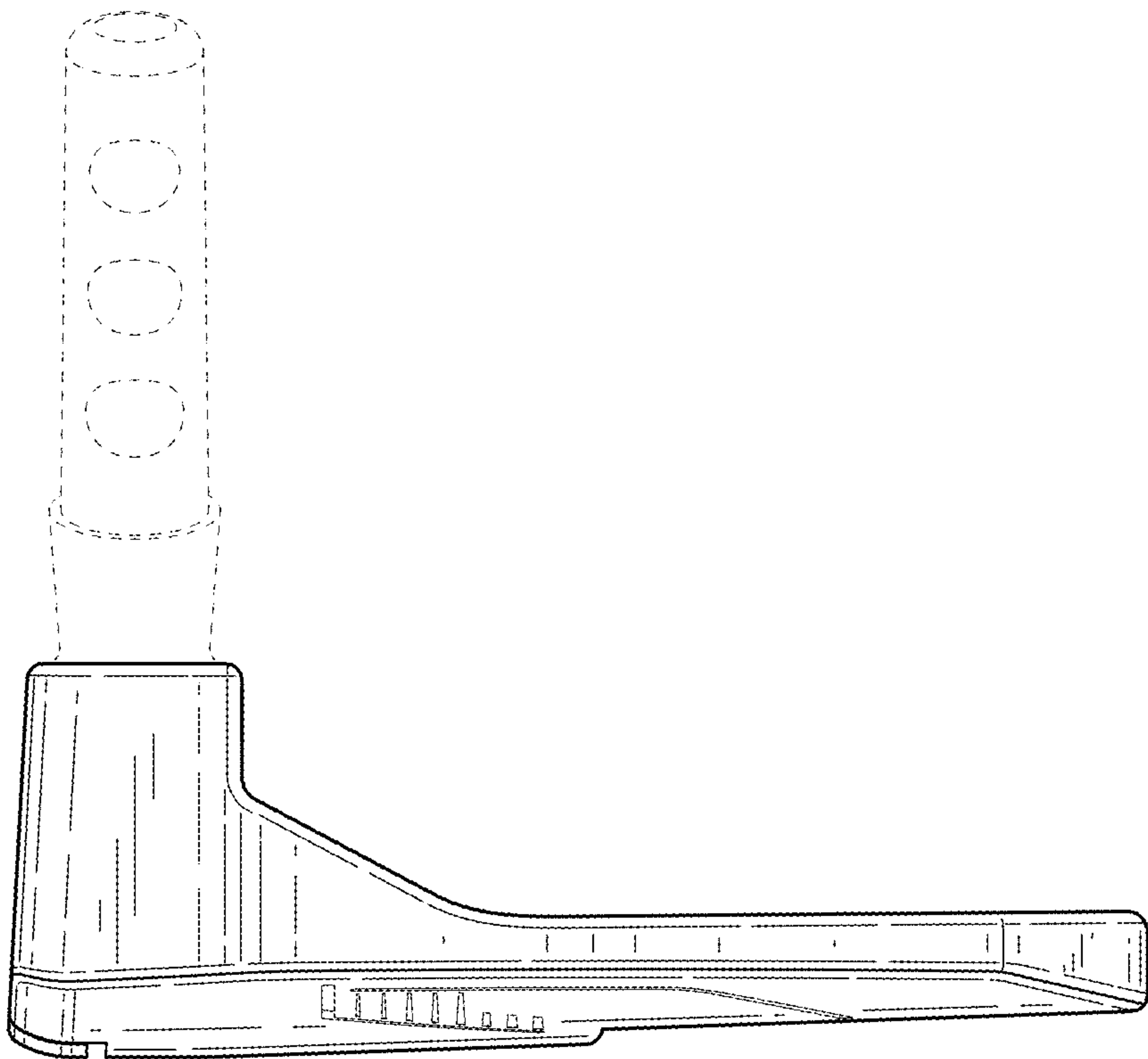

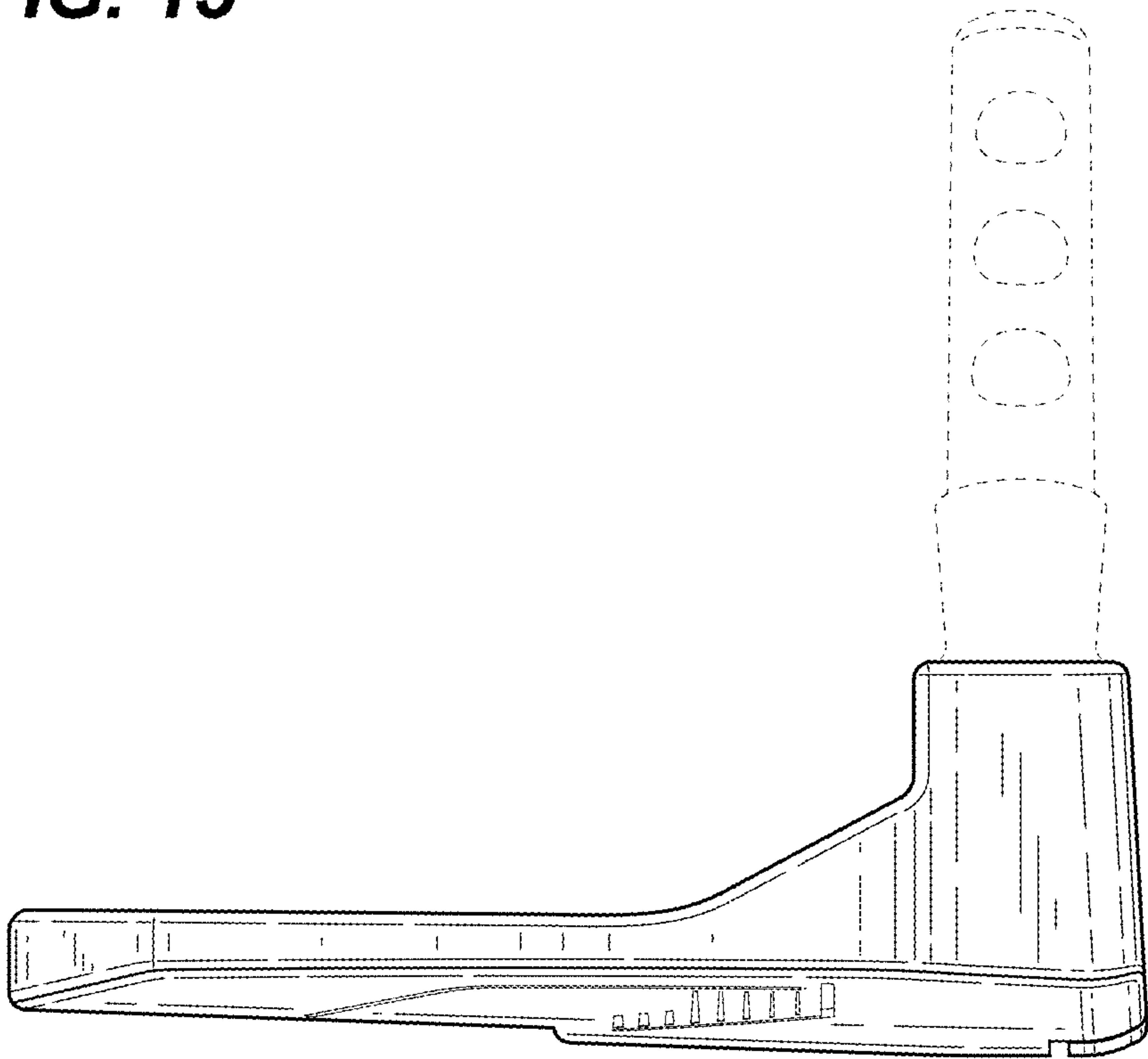
