(57) **CLAIM**

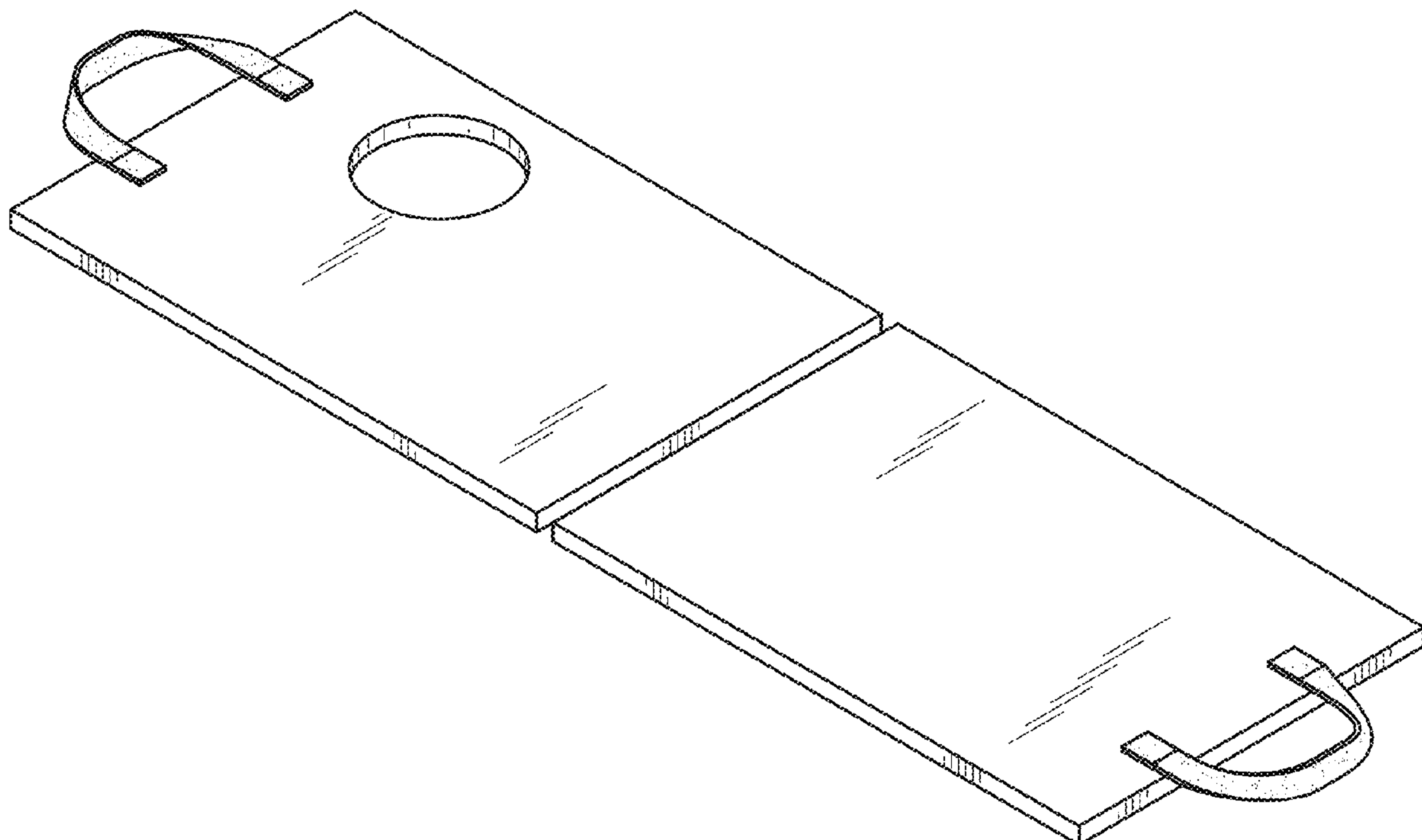
I claim the ornamental design for a sink-covering counter-

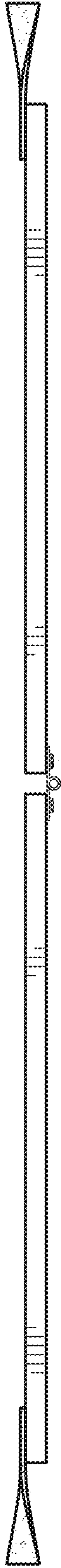

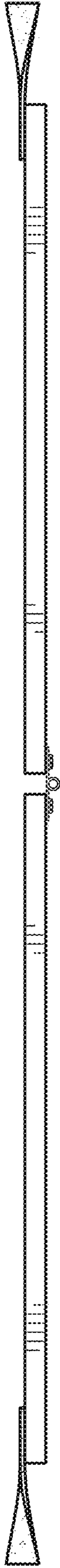

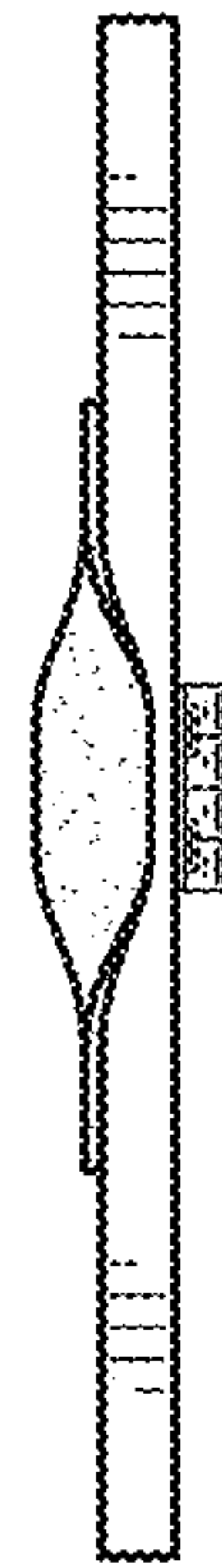

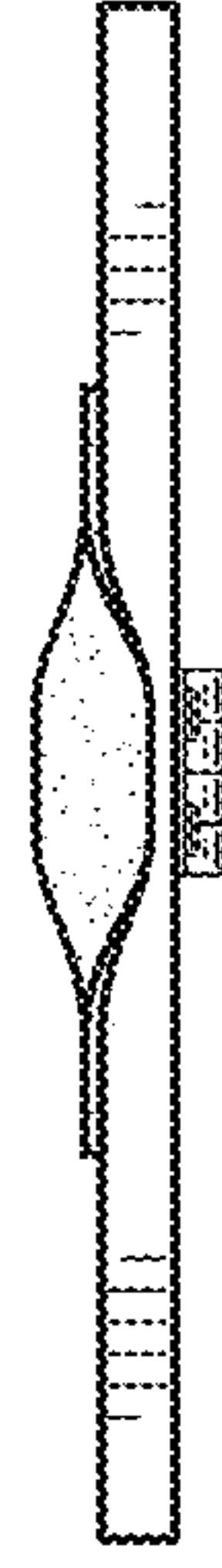

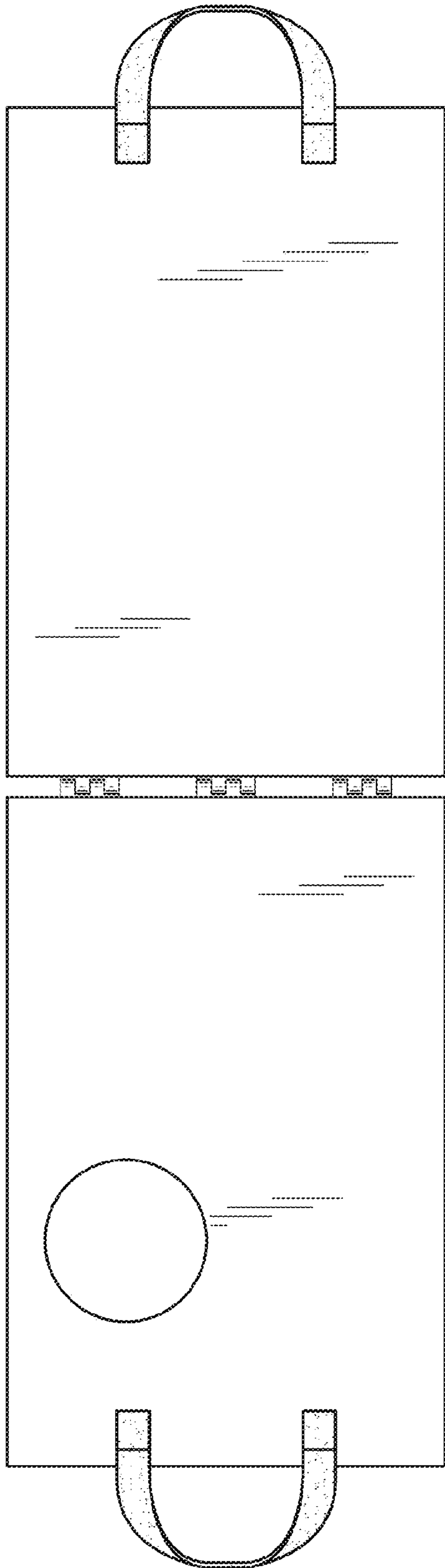

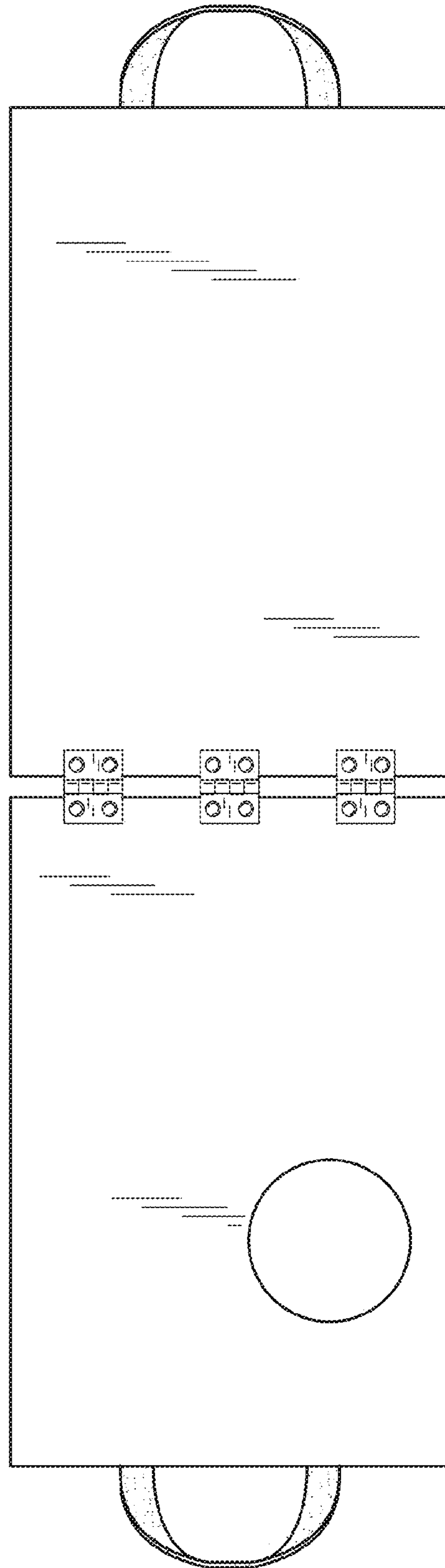

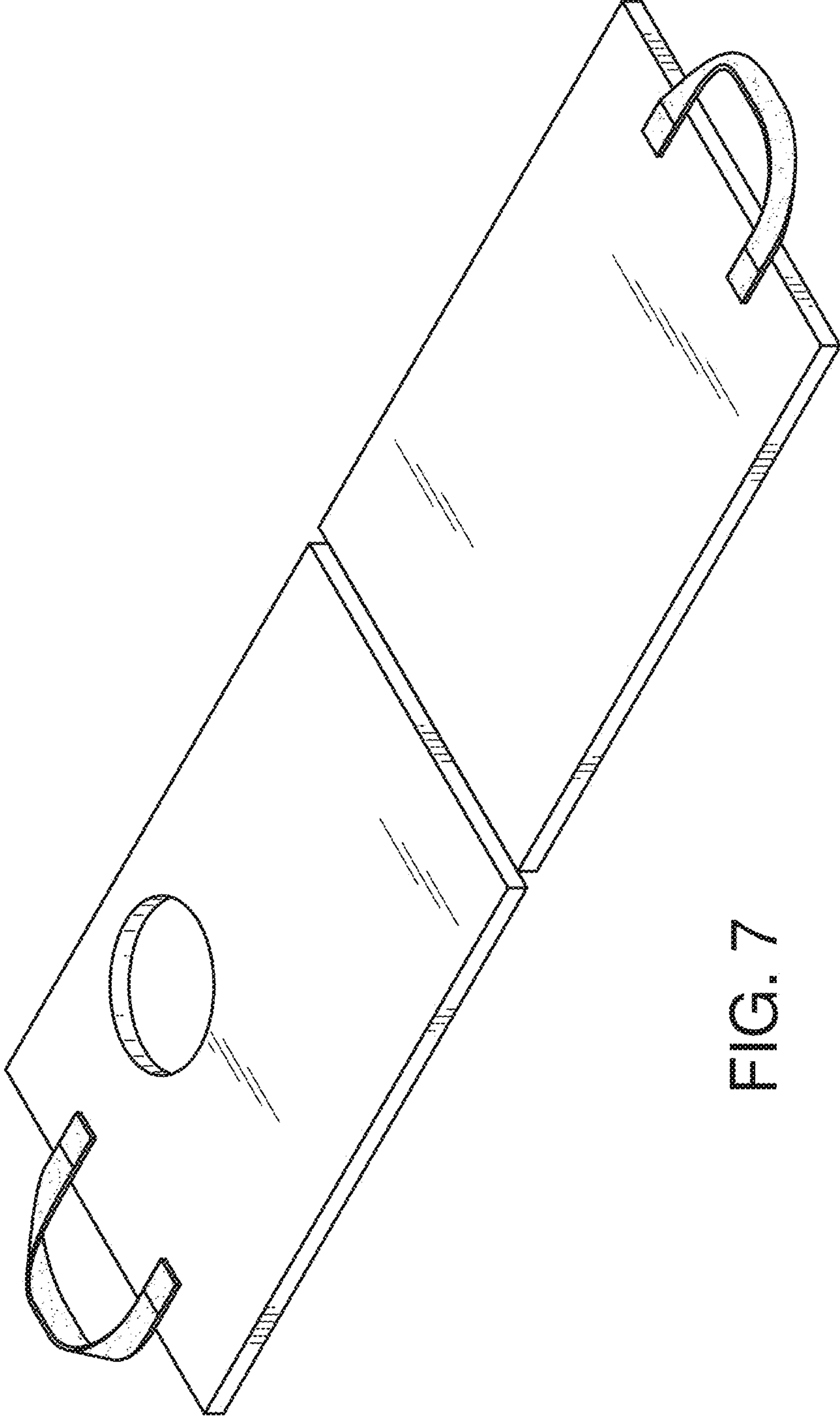
