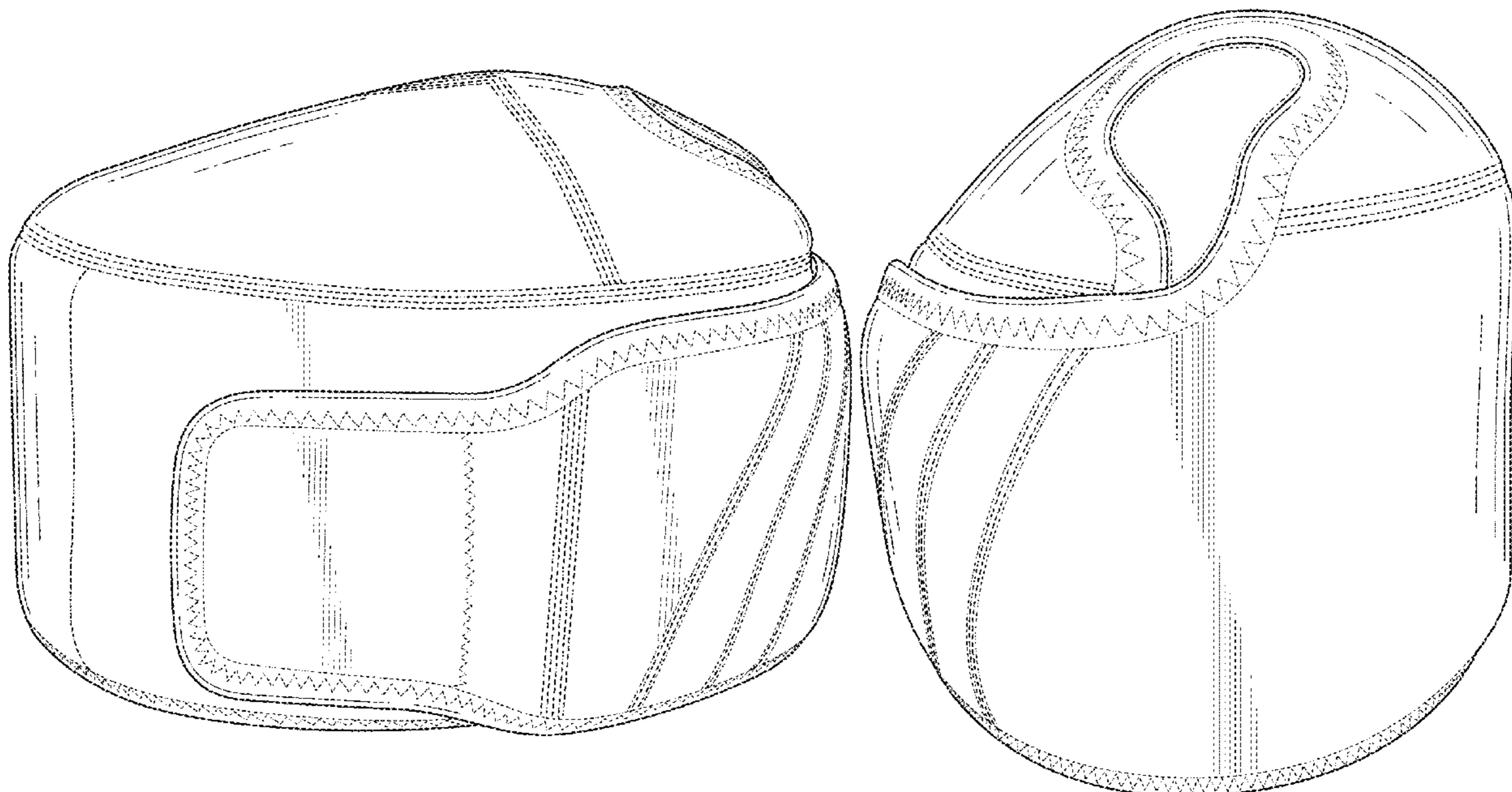
The ornamental design for a head wrap, as shown and described.

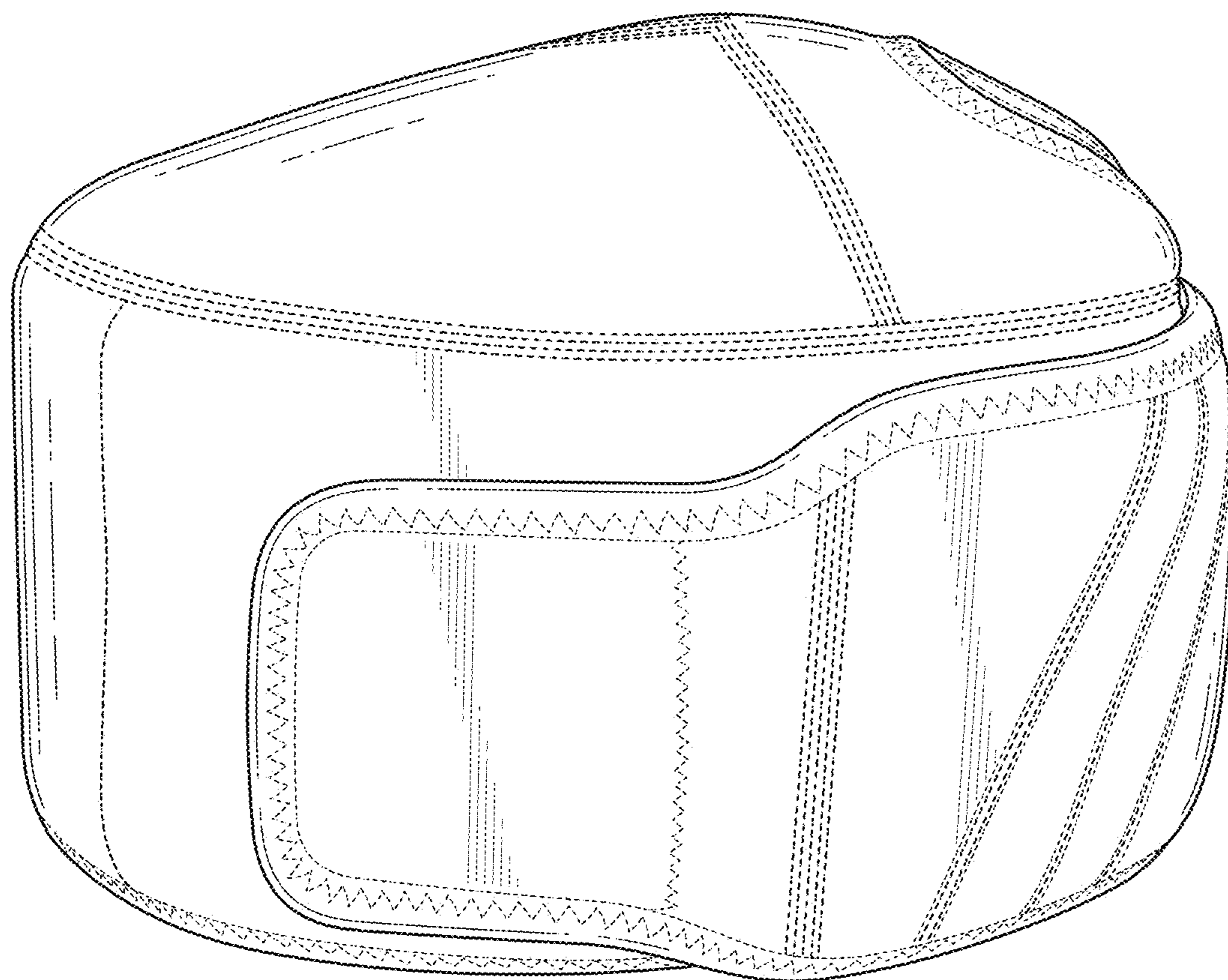

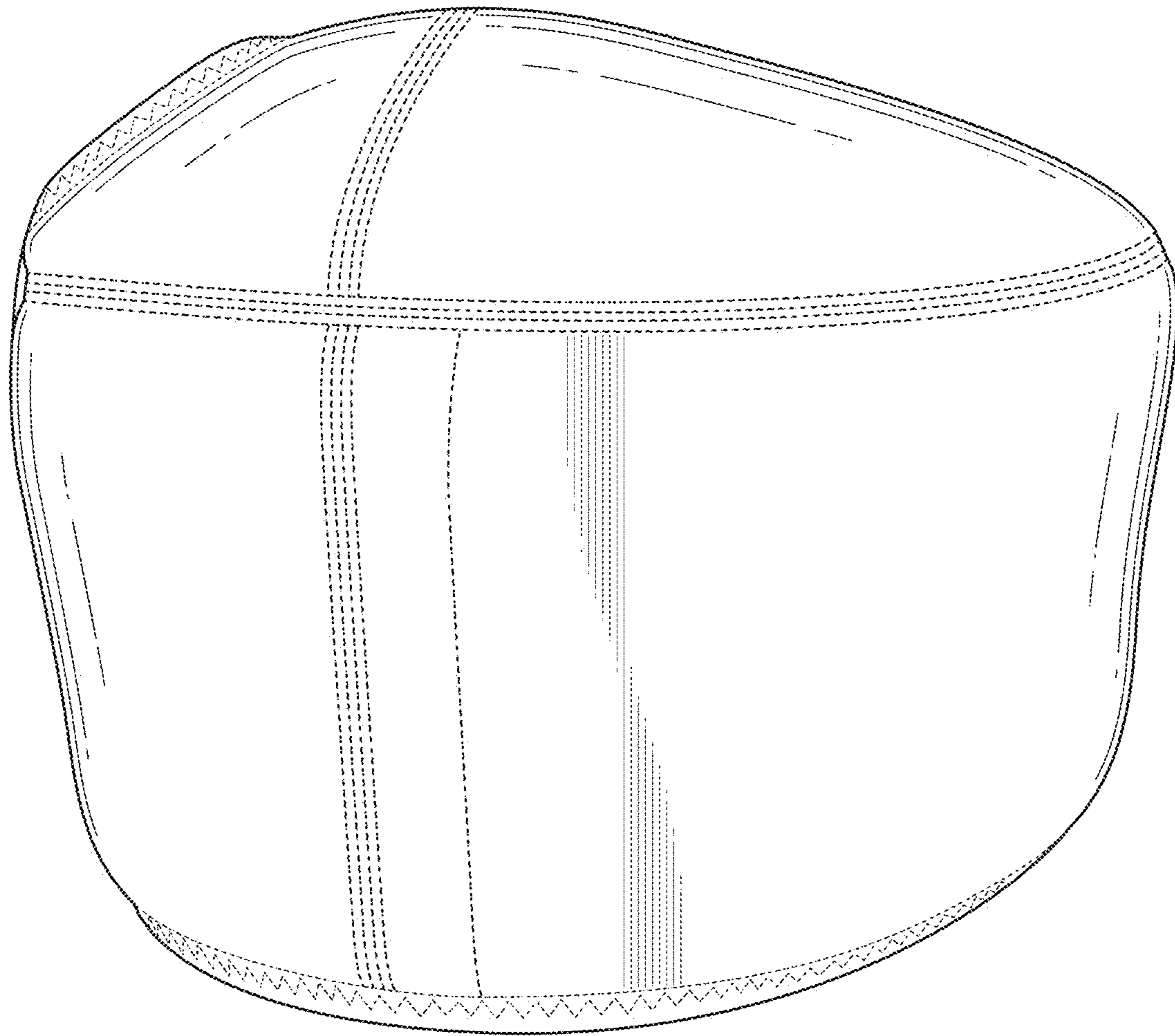

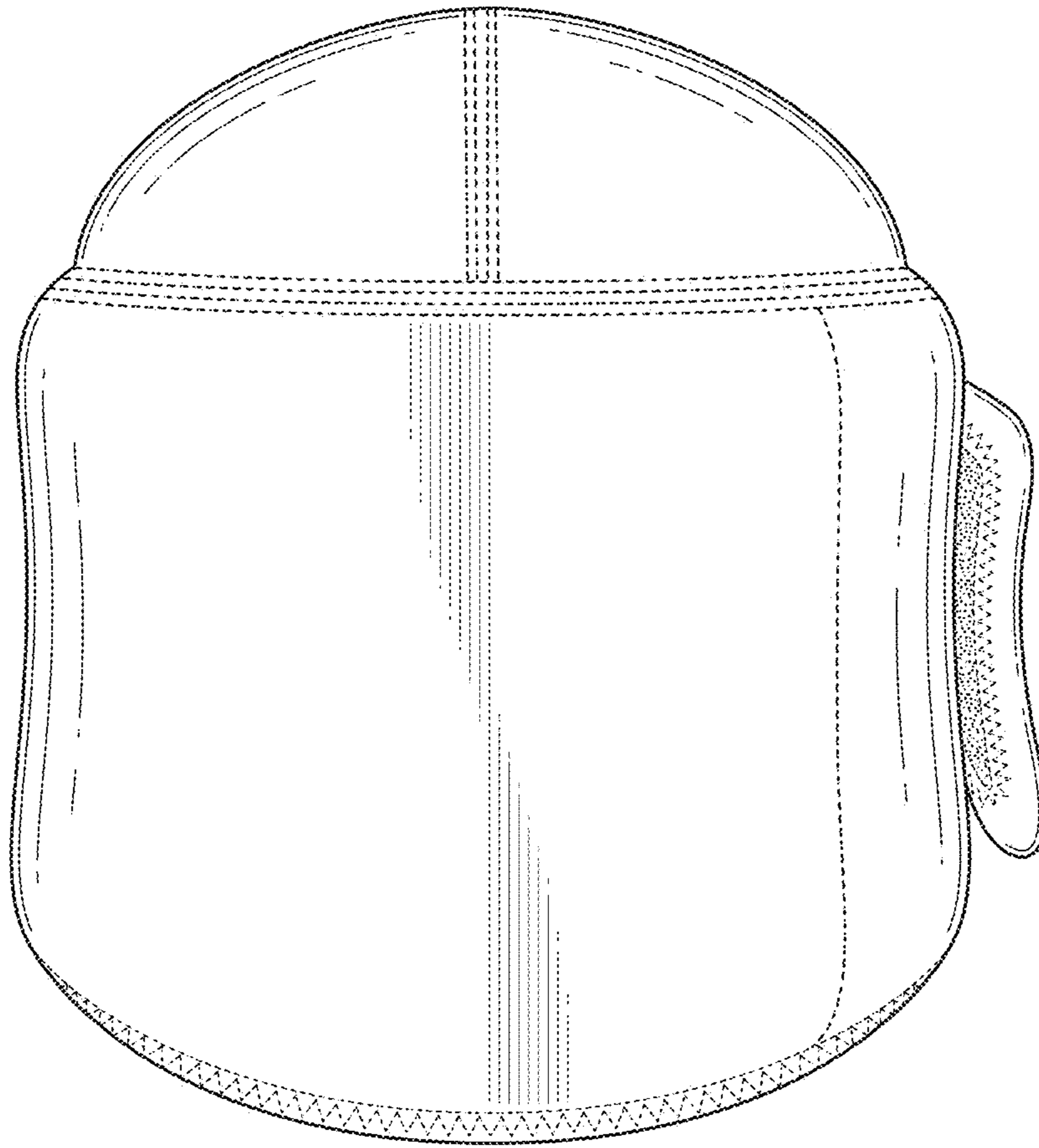

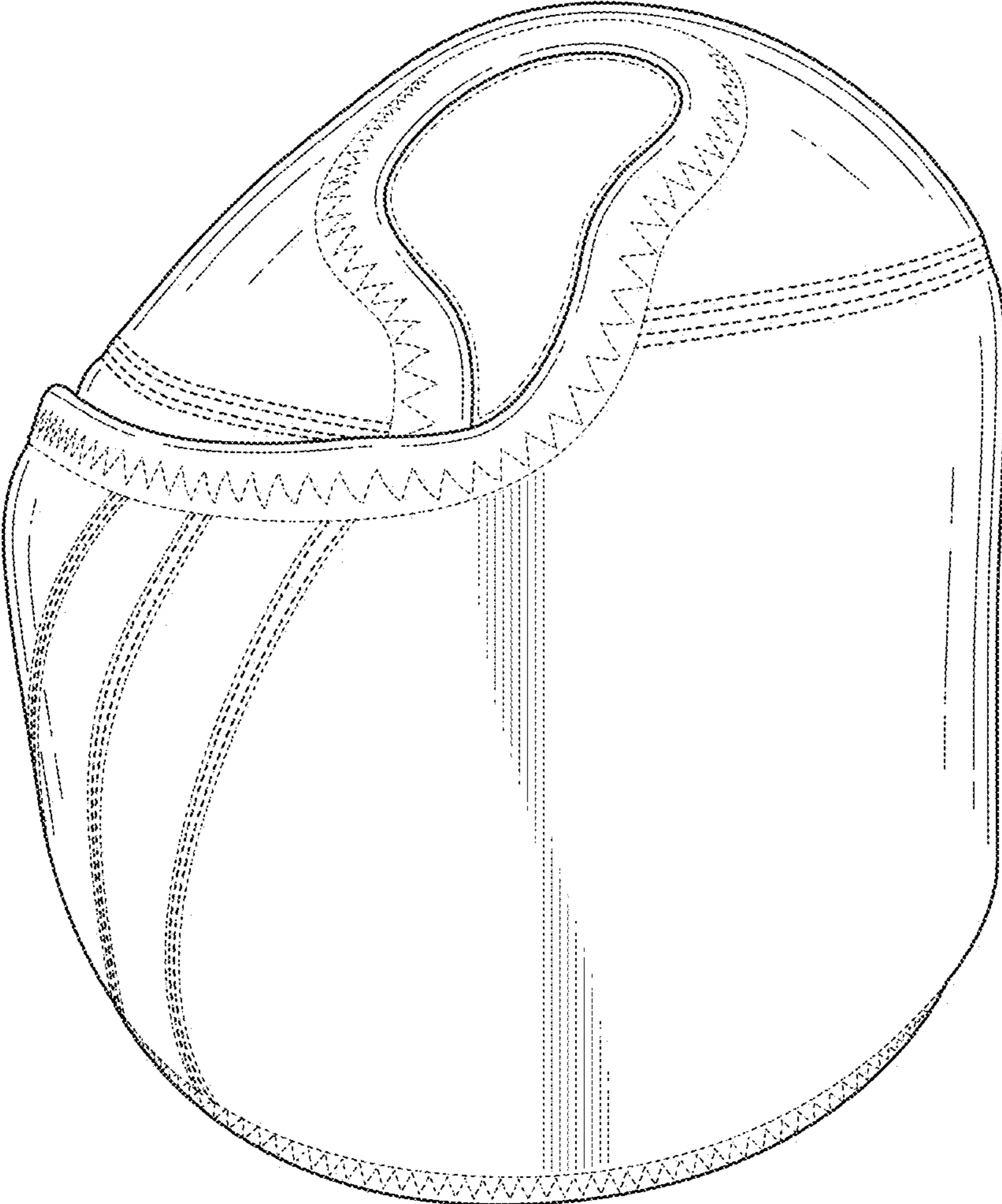

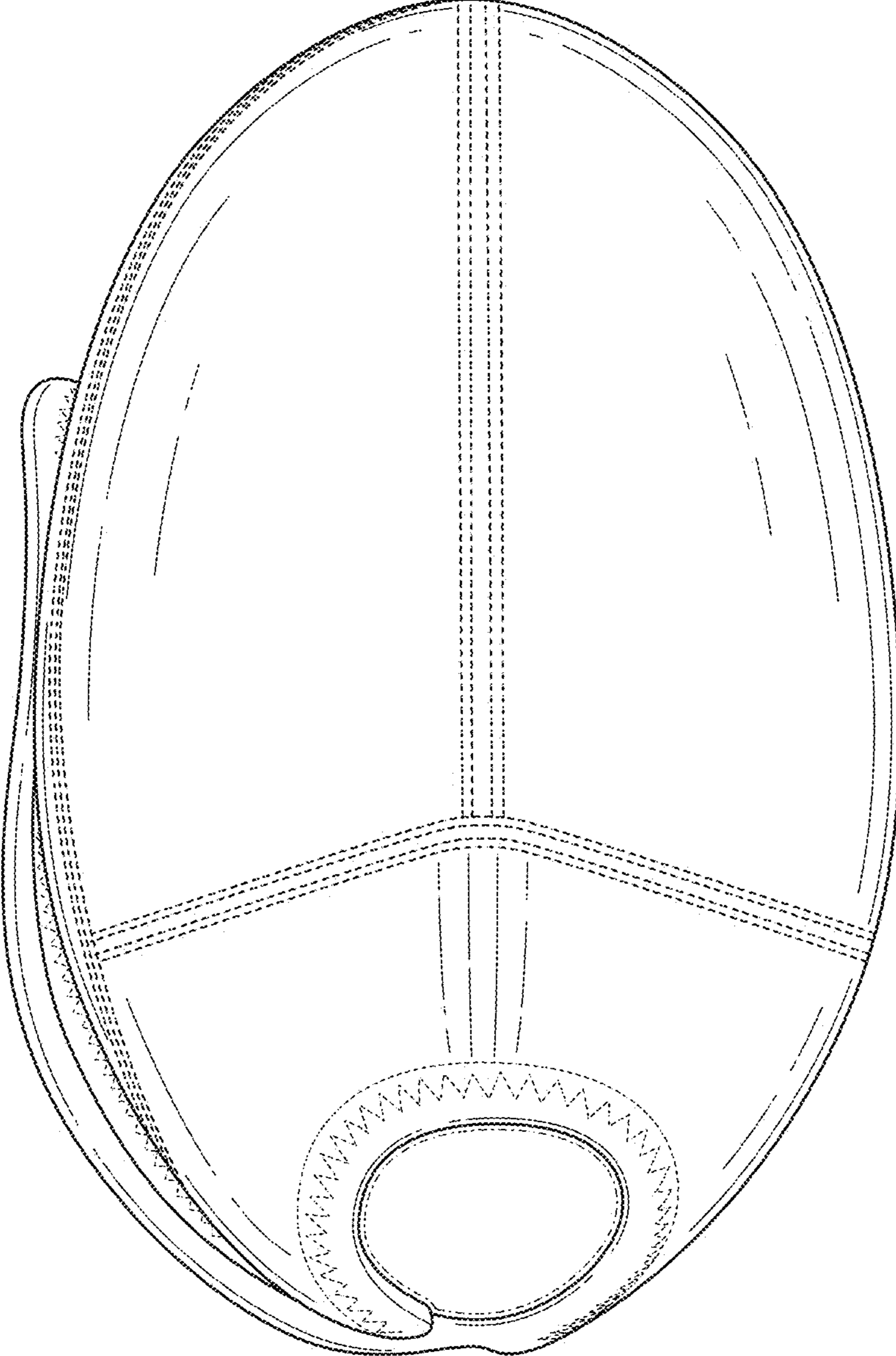

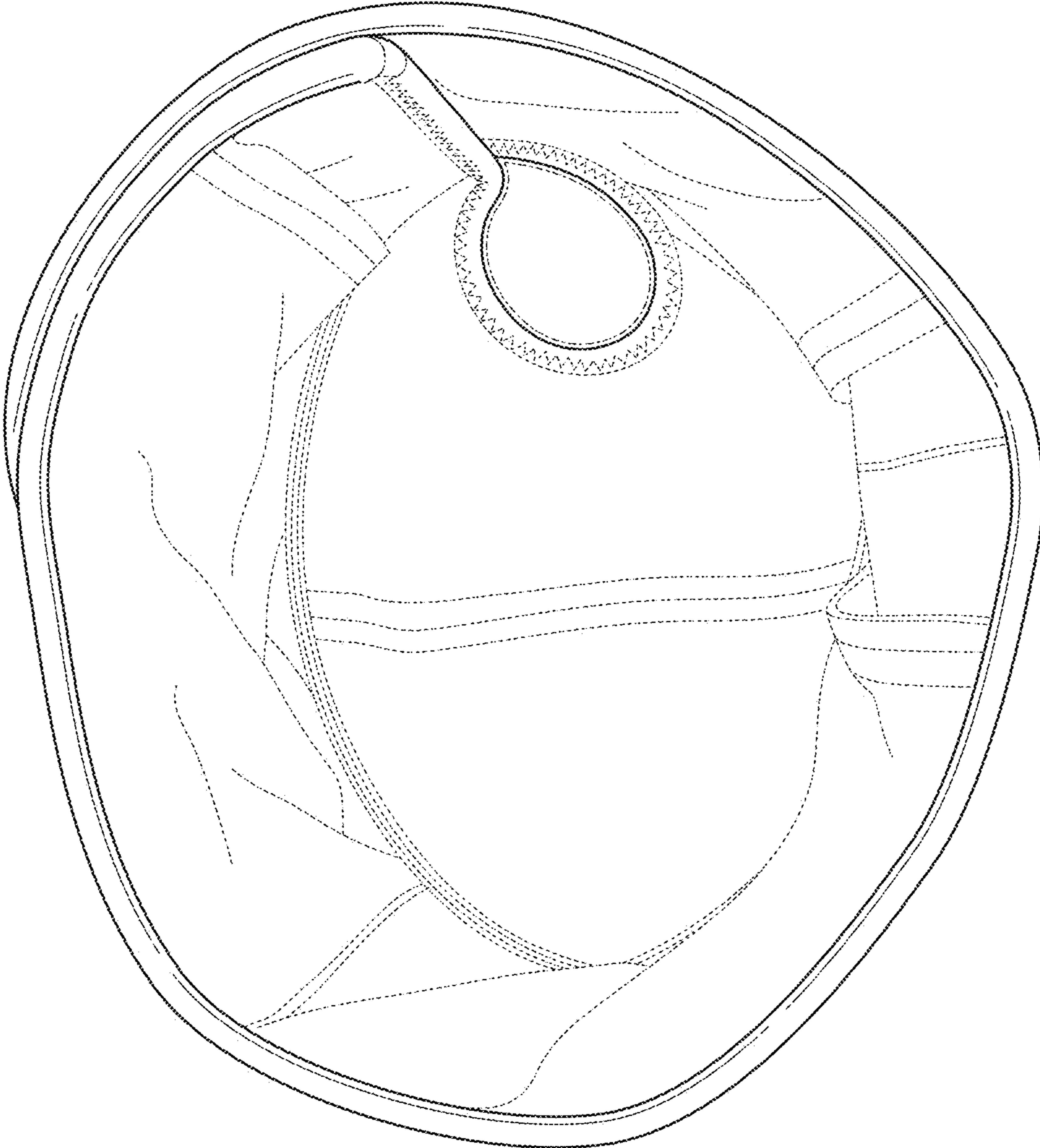
