(57) **CLAIM**

The ornamental design for a pair of lightweight running shoes, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a pair of lightweight running shoes, showing my new design for a right side shoe; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is an enlarged portion view labeled, "FIG. 9," in FIG. 2; FIG. 10 is an enlarged portion view labeled, "FIG. 10," in FIG. 2; FIG. 11 is an enlarged portion view labeled, "FIG. 11," in FIG. 4; and, FIG. 12 is an enlarged portion view labeled, "FIG. 12," in FIG. 8.

The left side shoe is a mirror image of the right side shoe shown in FIGS. 1-8.

The broken lines in the drawings depict environmental structure and form no part of the claimed design.

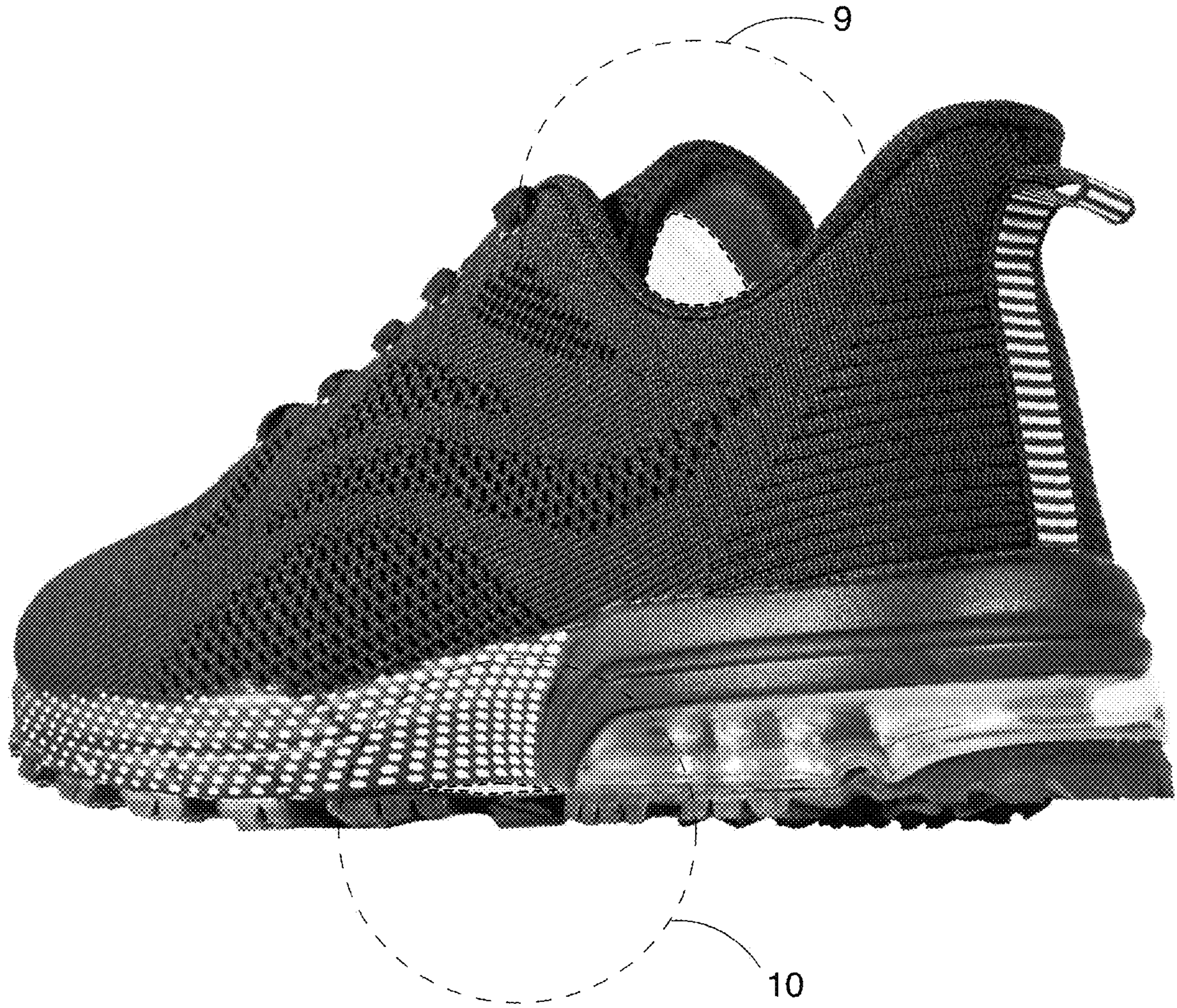

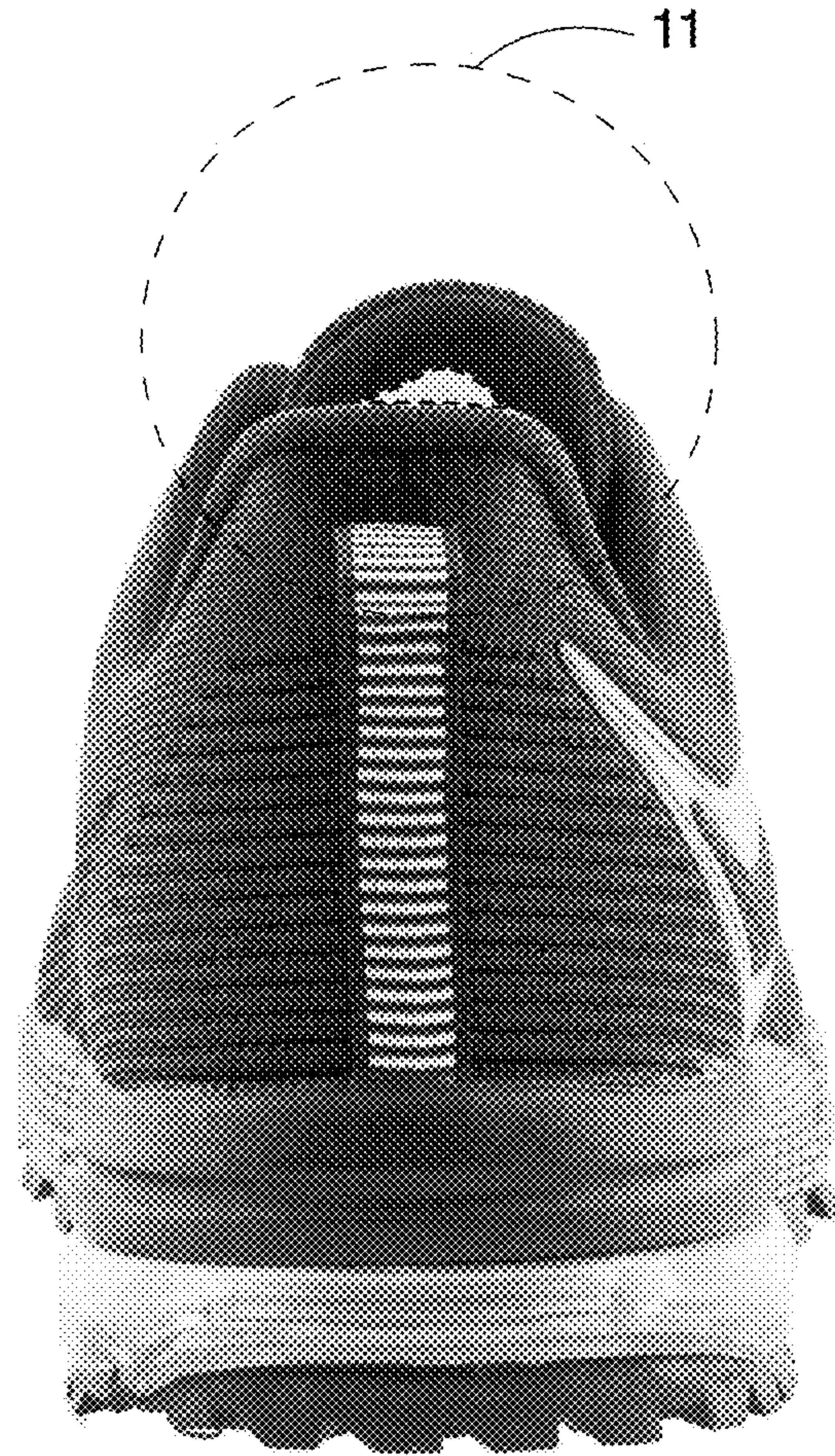

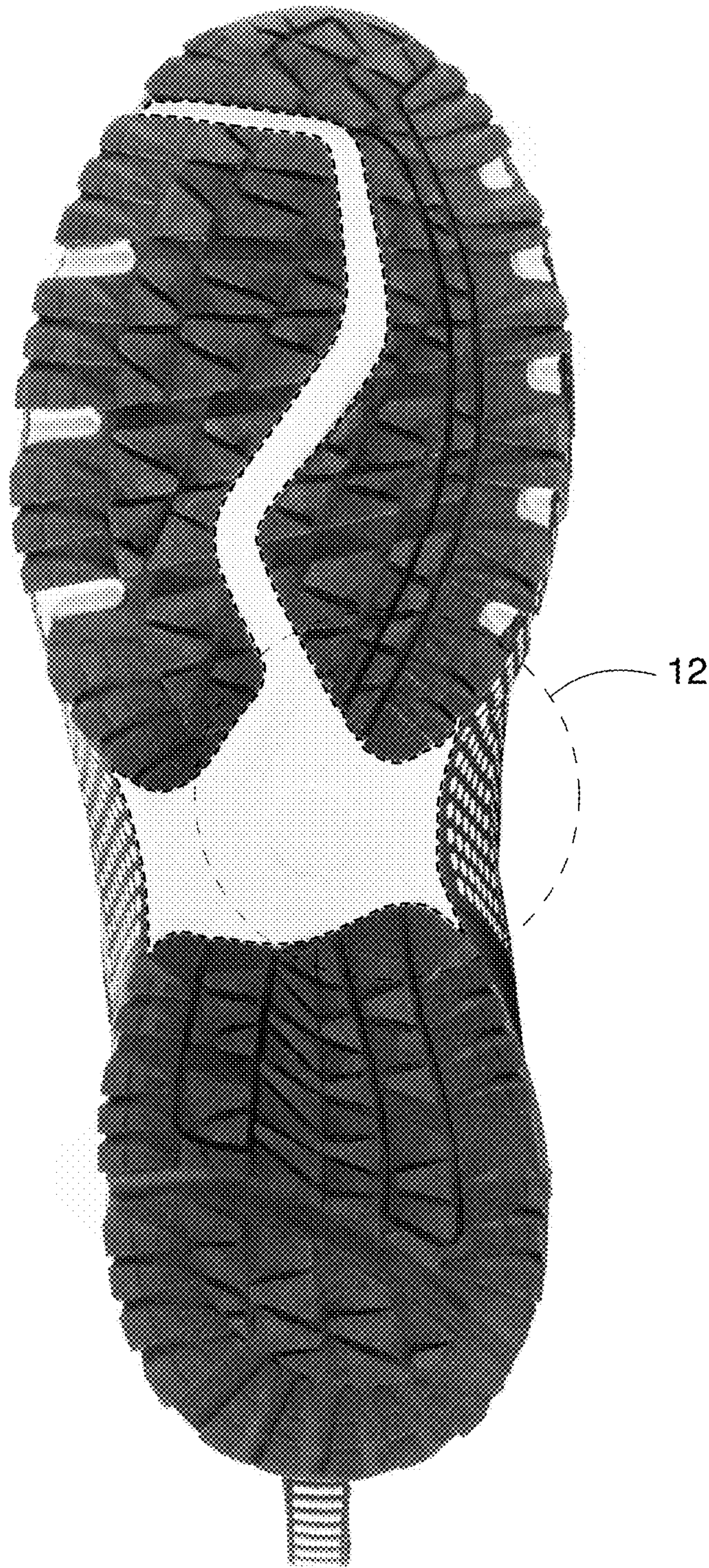

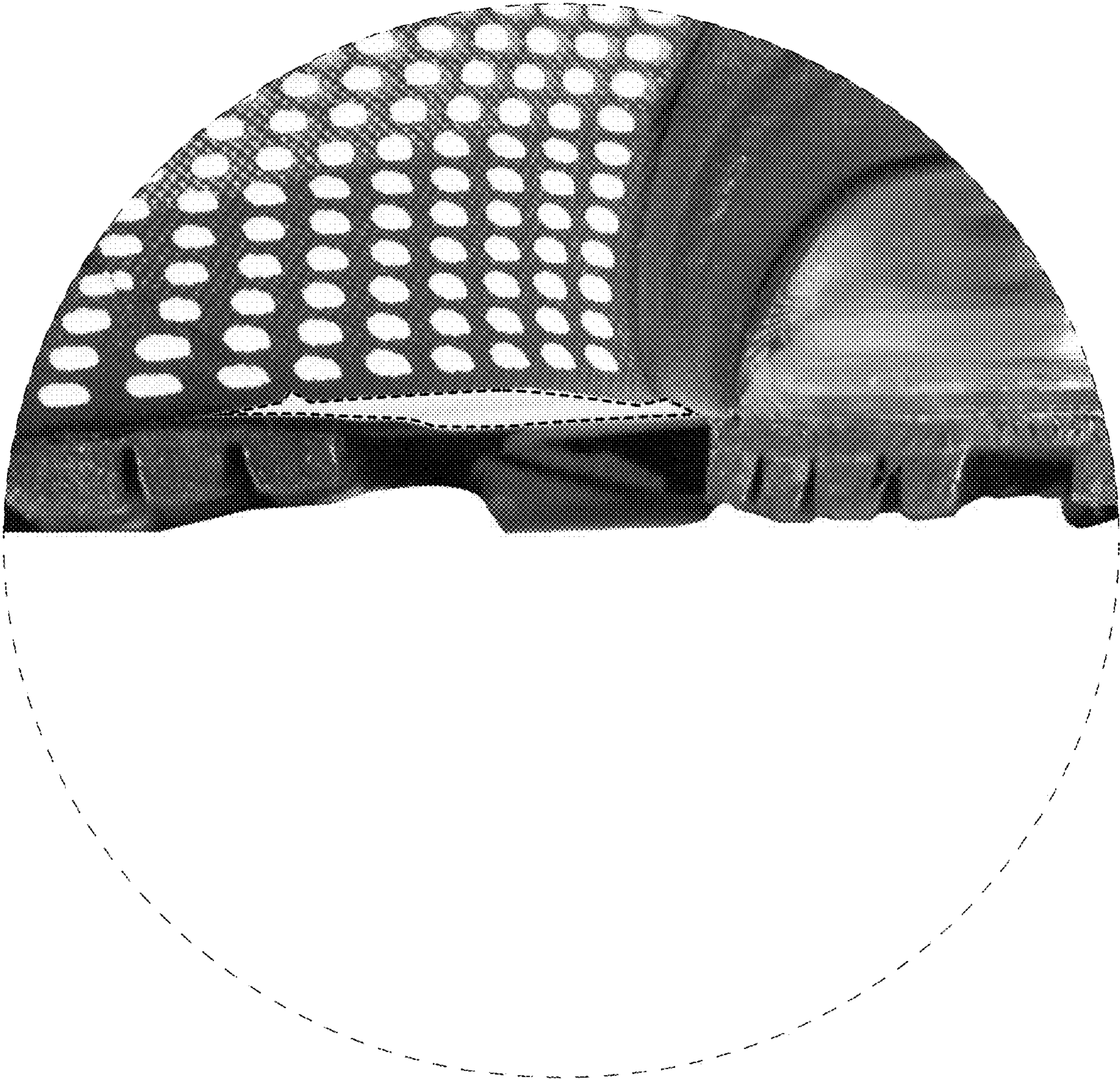

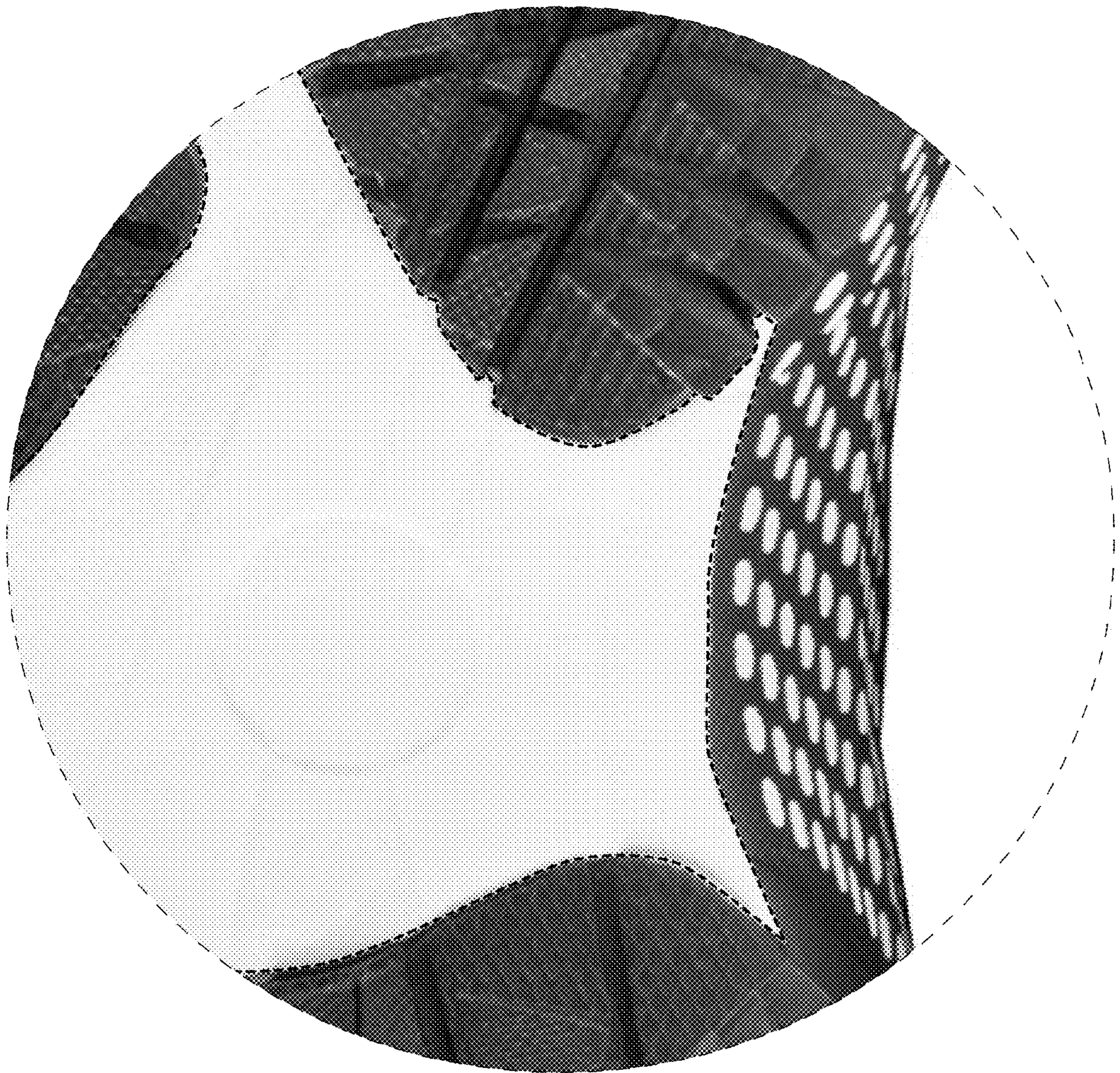
