(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a photographic bottom front perspective view of a shoe showing my new design;
 FIG. 2 is a bottom view thereof; and,
 FIG. 3 is an enlarged view of the claimed portion as shown in FIG. 2 with environment removed for clarity purposes.
 The lighter grey portions are for the purpose of illustrating environment and form no part of the claimed design. The broken lines immediately adjacent to and surrounding the dark grey photographic areas represent the bounds of the claimed design and form no part thereof.

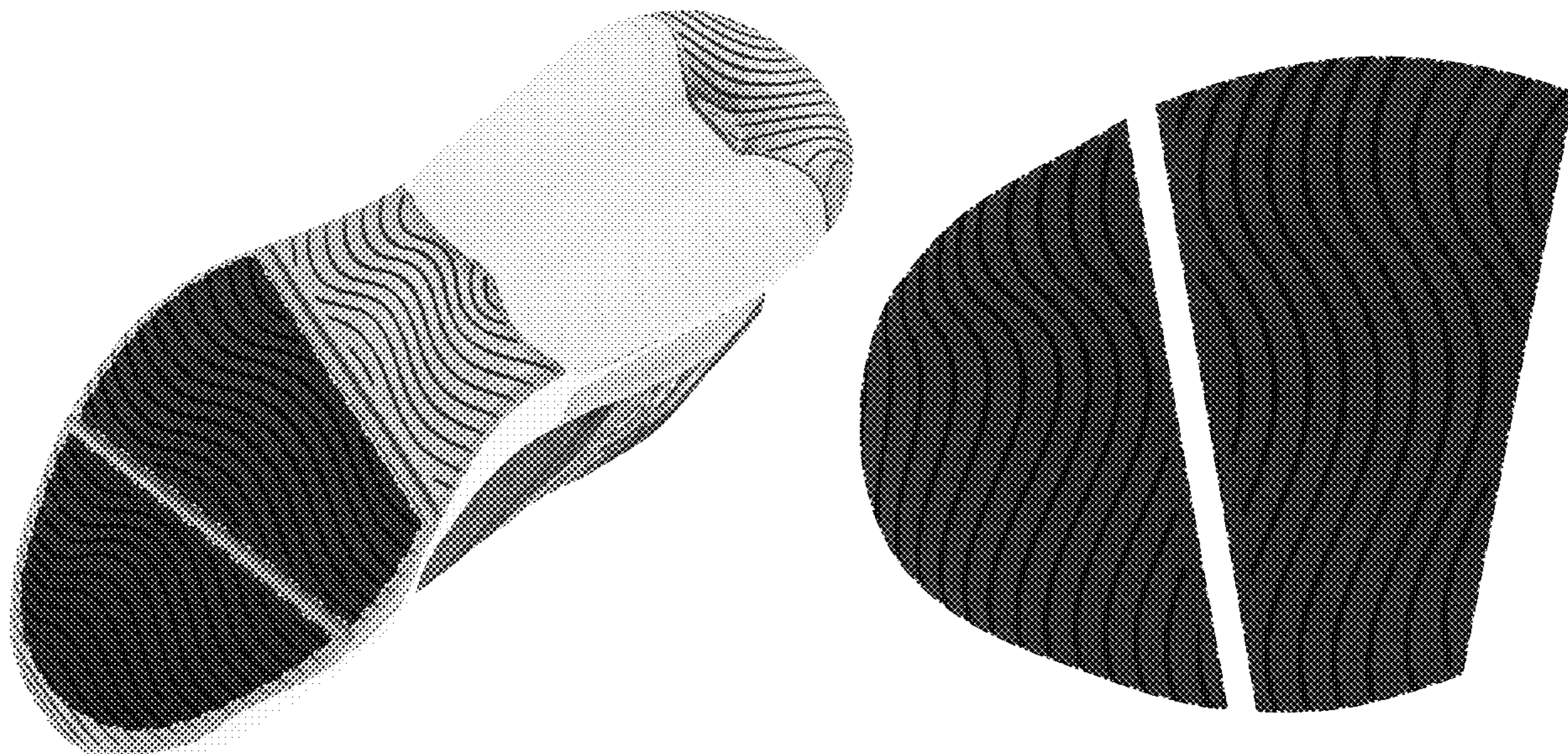

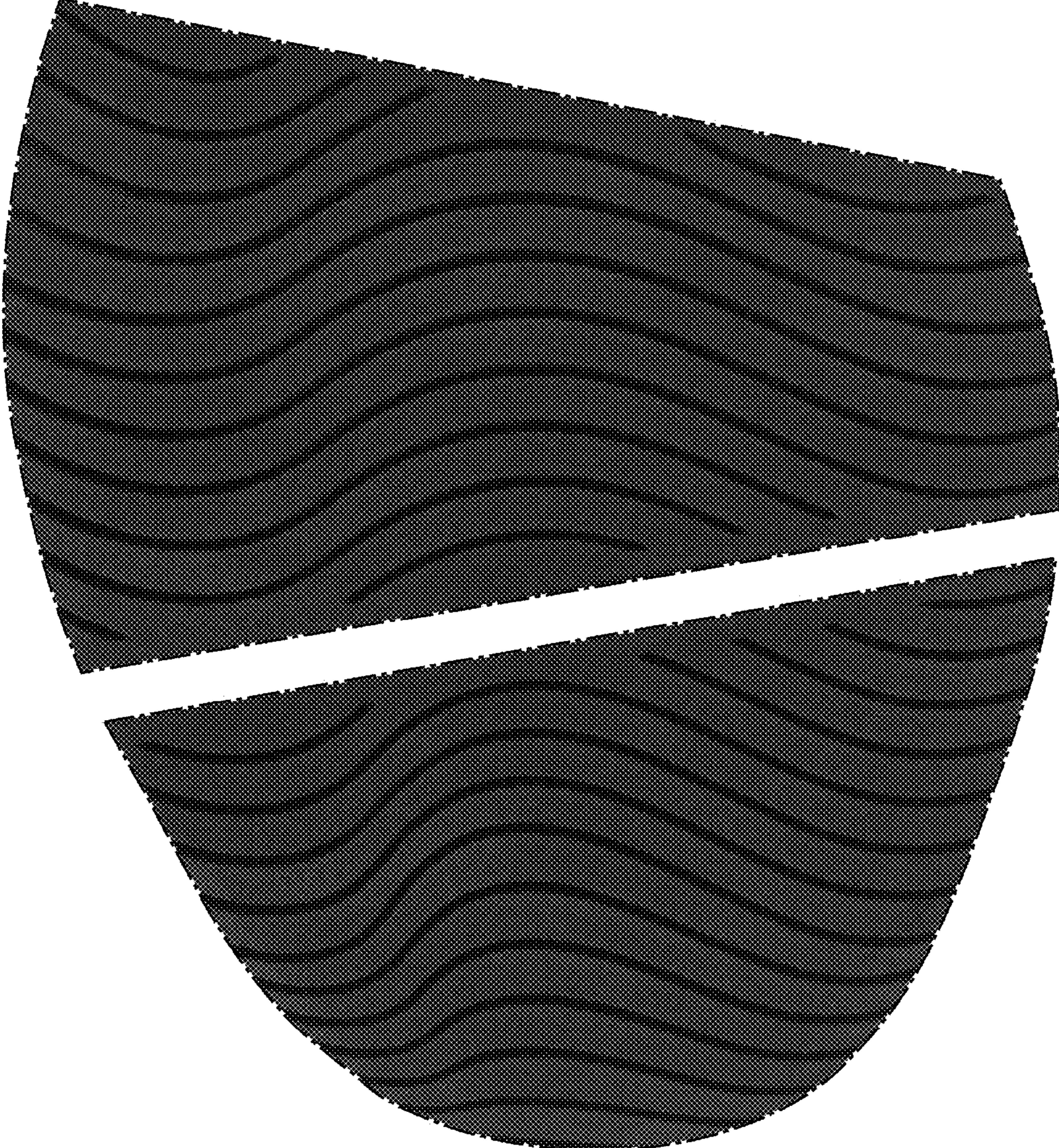
