(57) **CLAIM**

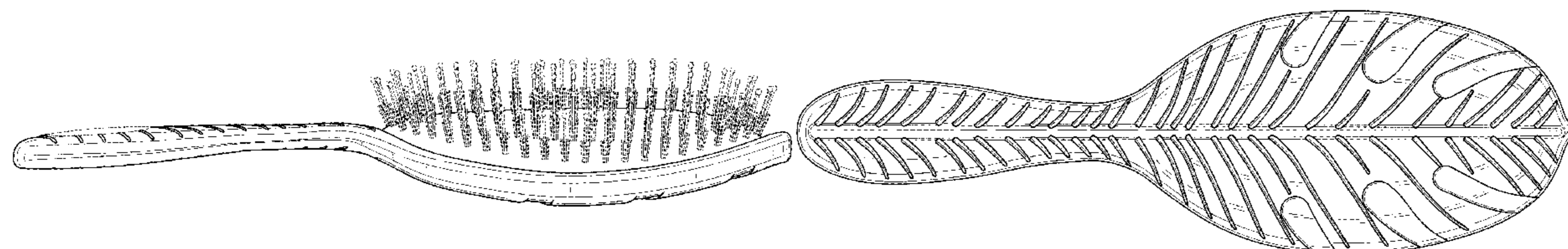
The ornamental design for a brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a brush of my new design;

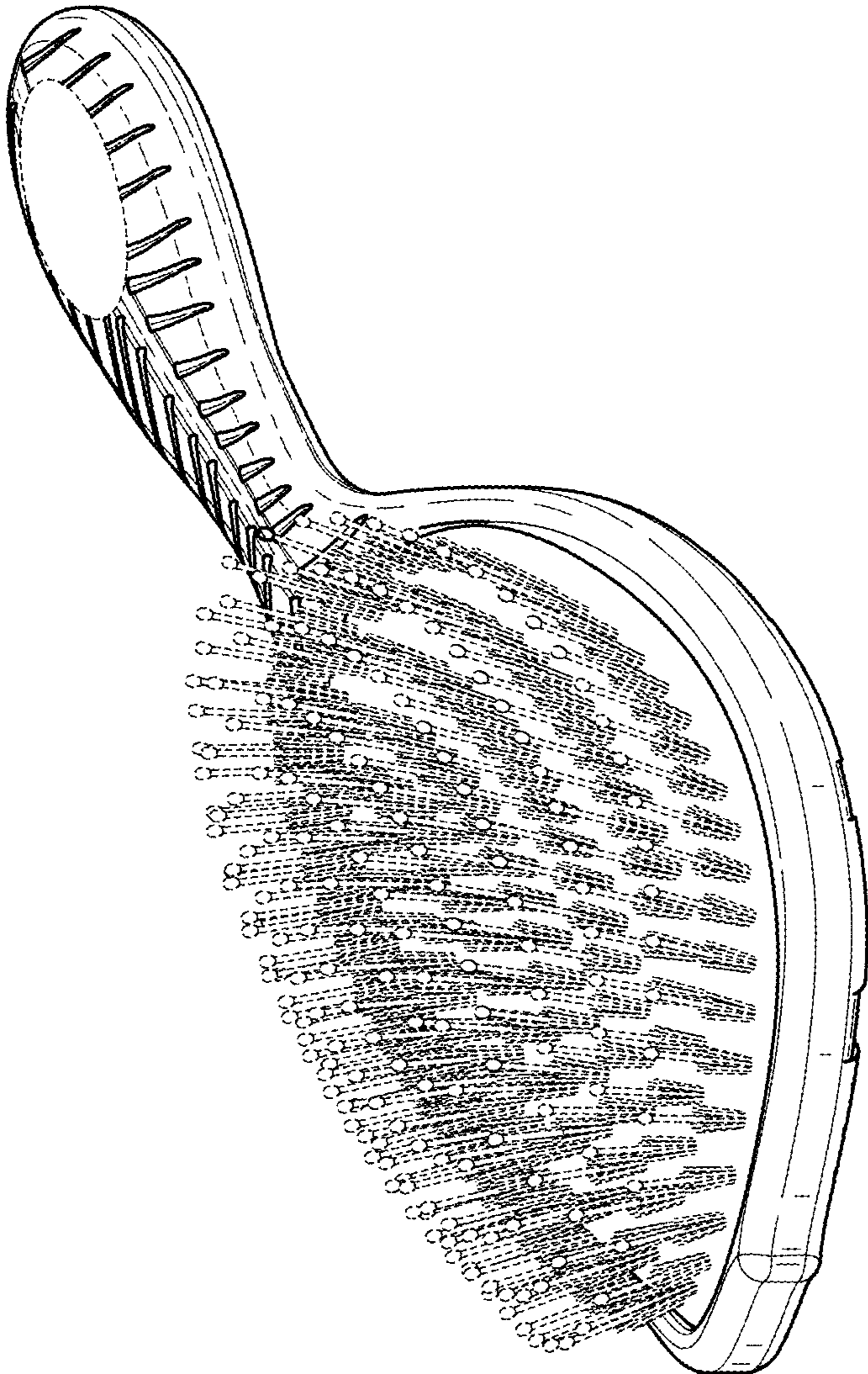

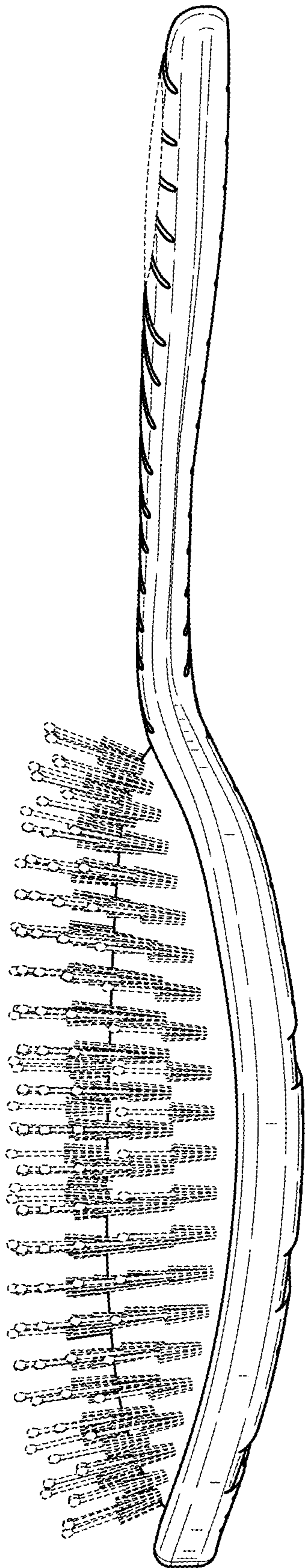

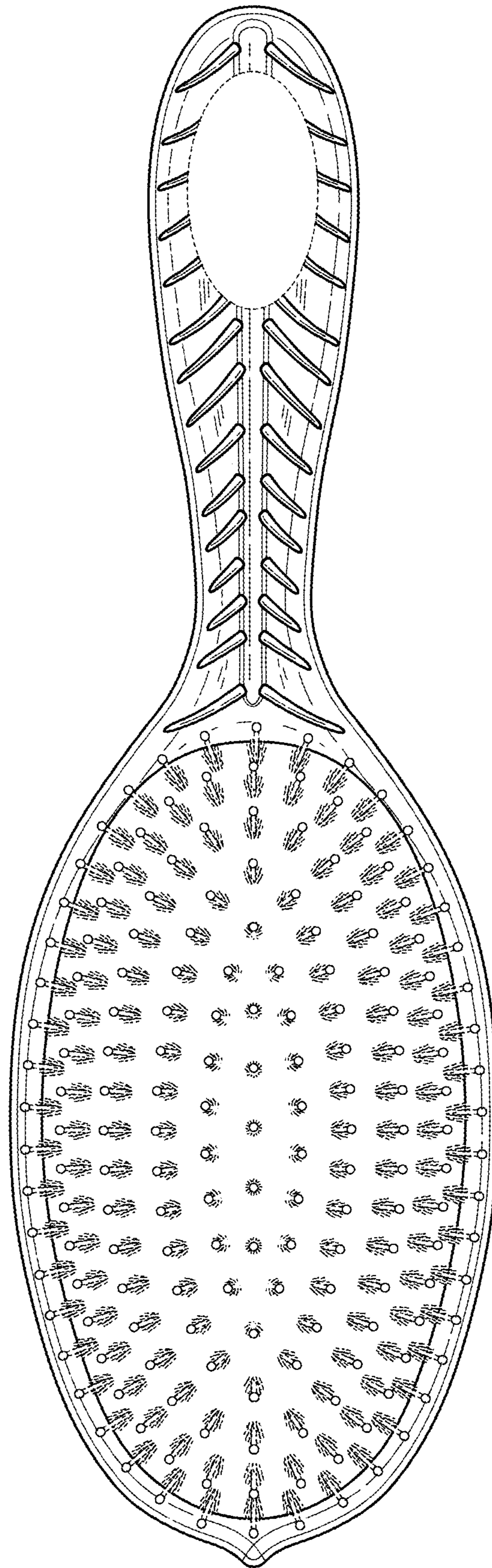

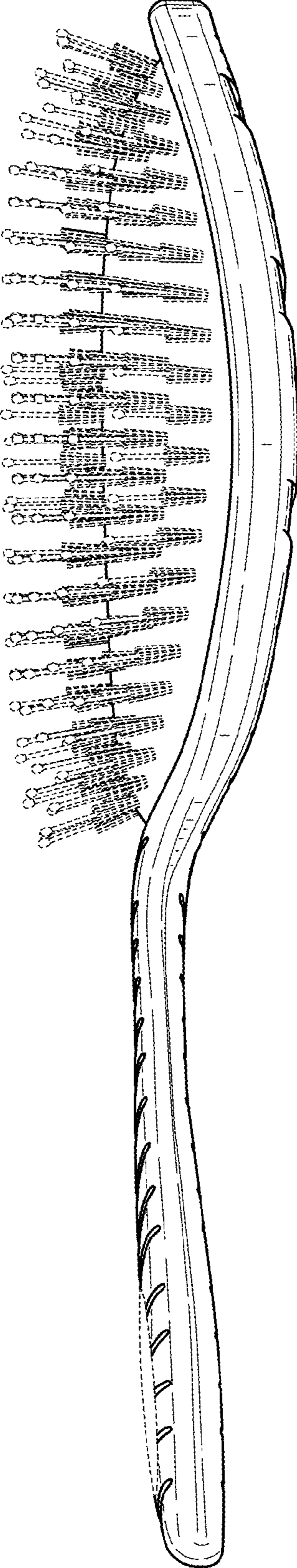

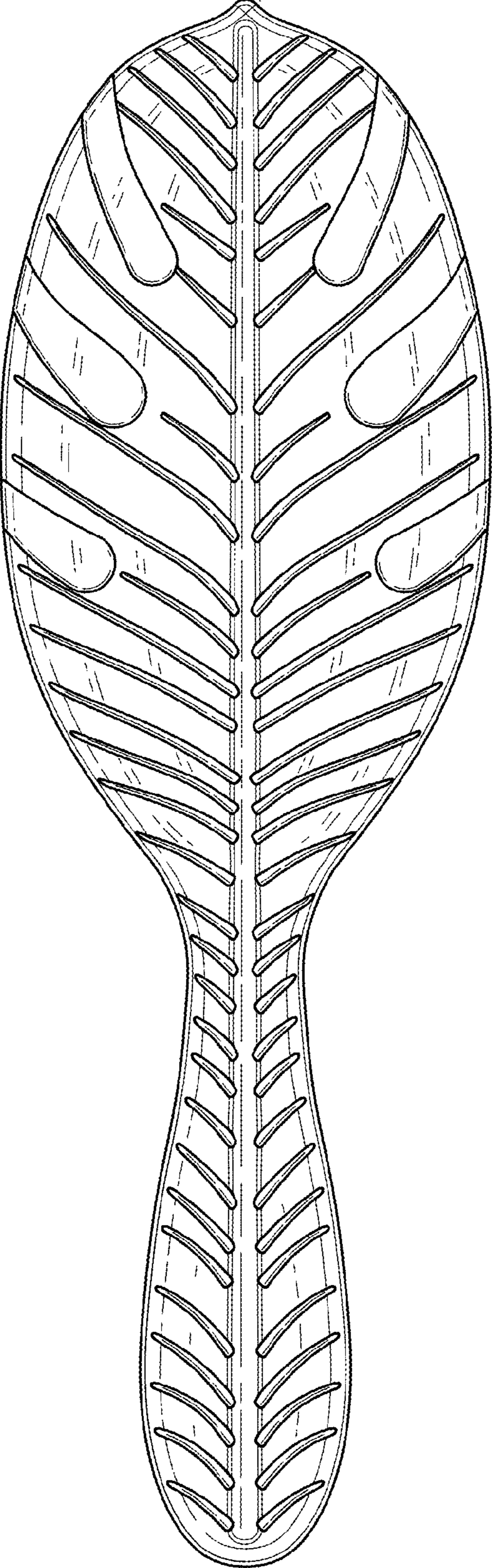

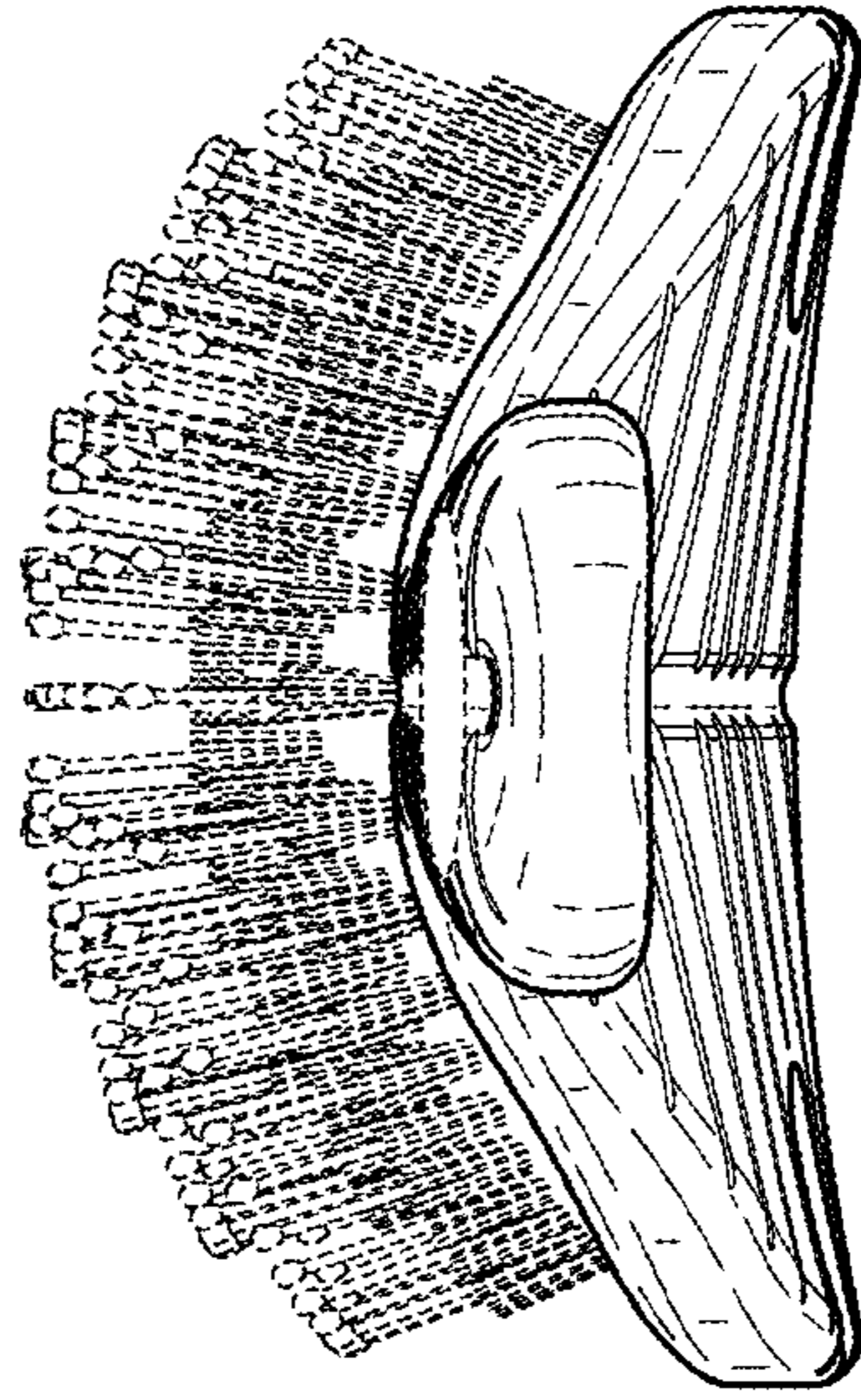

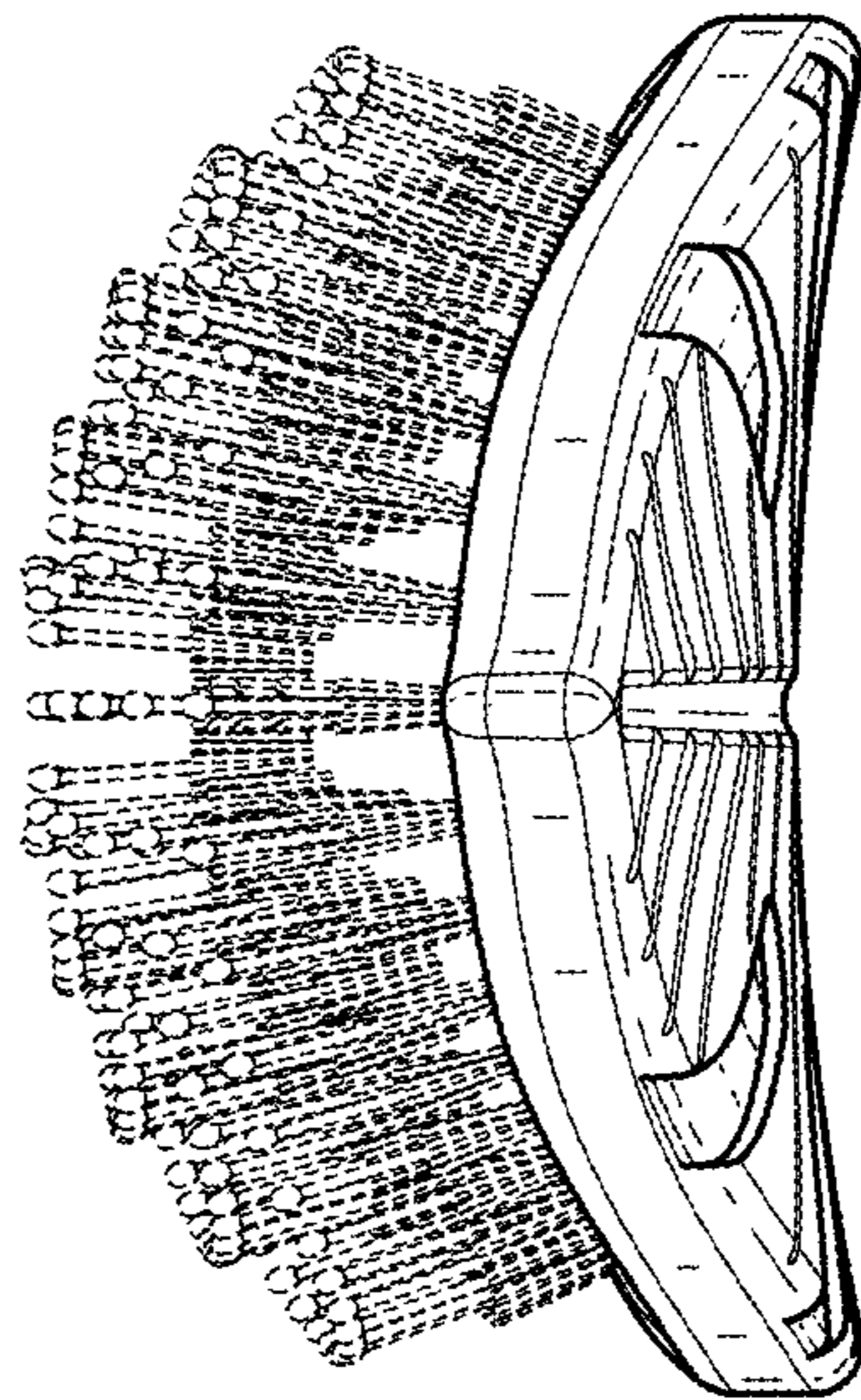

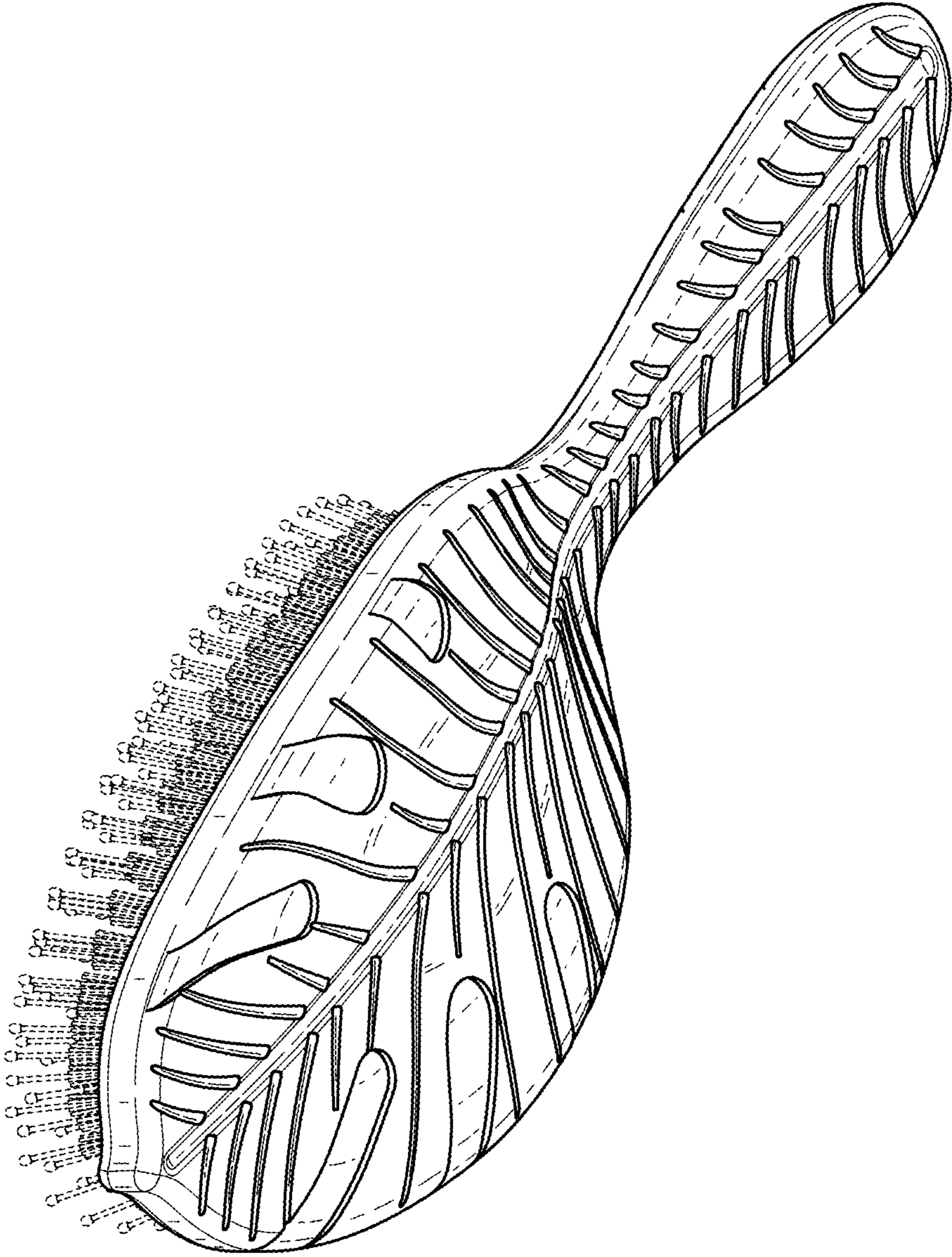
