(57) **CLAIM**

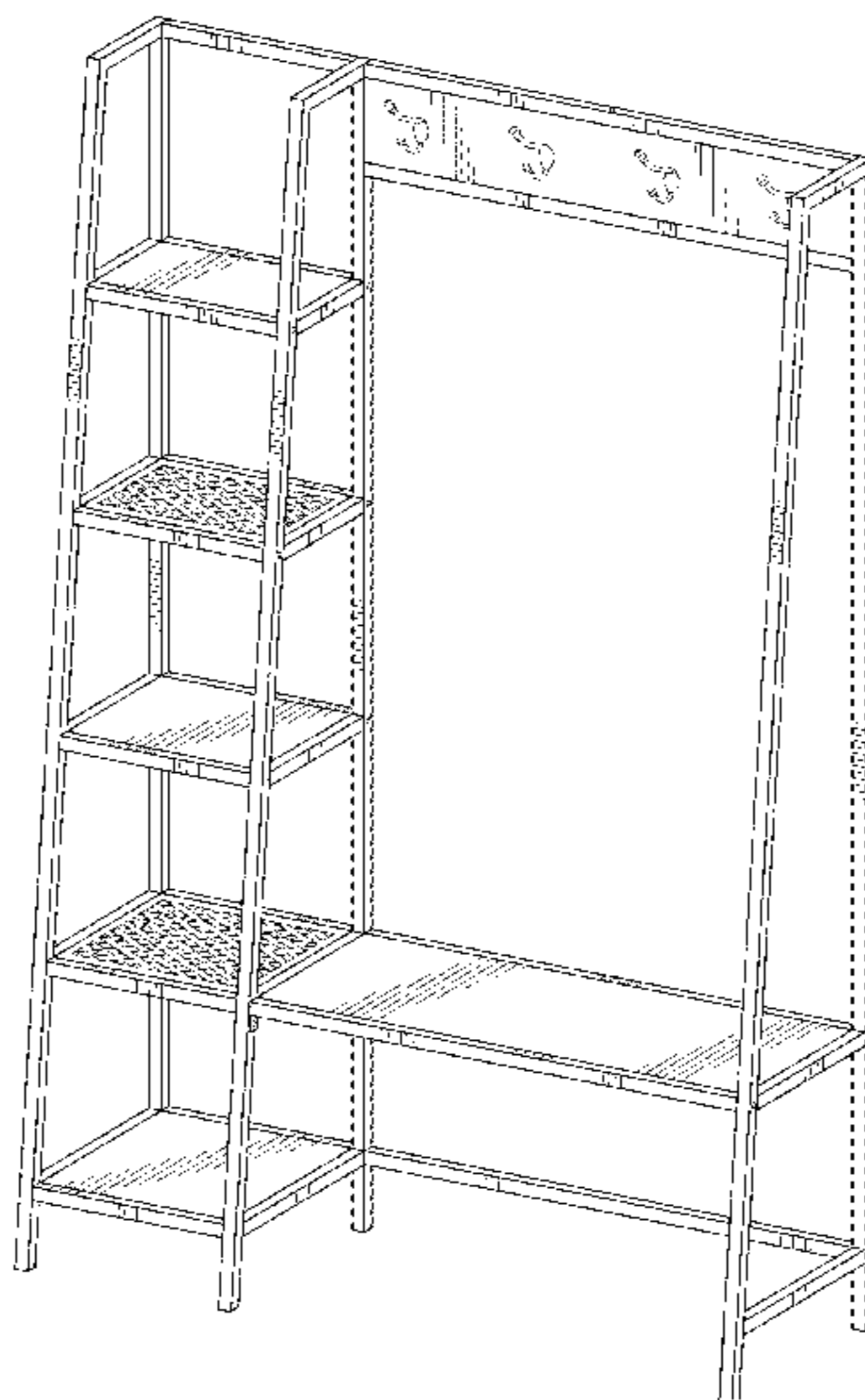
The ornamental design for a hall tree, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a hall tree showing the new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right elevation view thereof; FIG. 7 is a left elevation view thereof; FIG. 8 is another front perspective view of a second embodiment of a hall tree showing the new design; FIG. 9 is a front elevation view thereof; FIG. 10 is a back elevation view thereof; FIG. 11 is a top plan view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a right elevation view thereof; and, FIG. 14 is a left elevation view thereof.

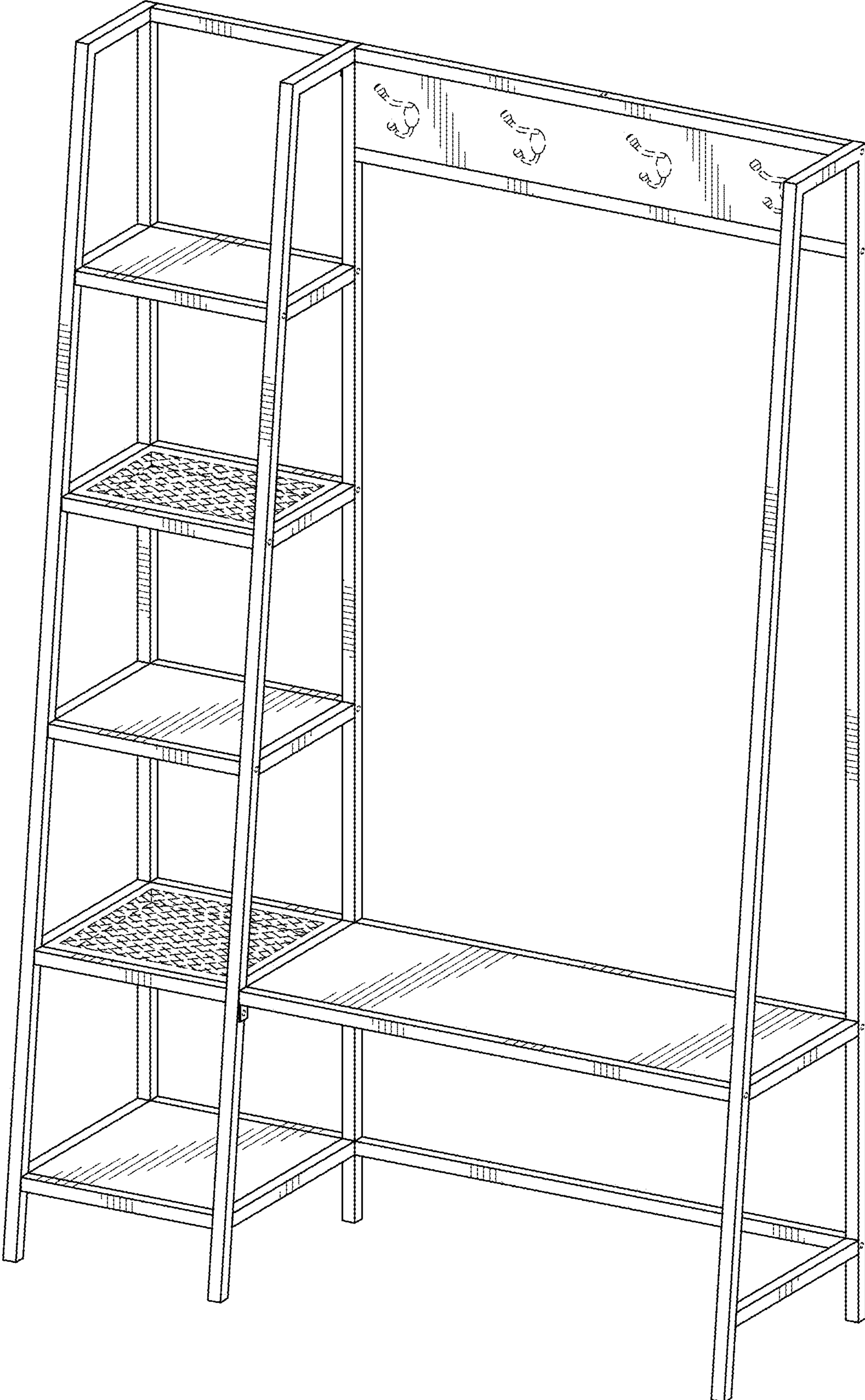

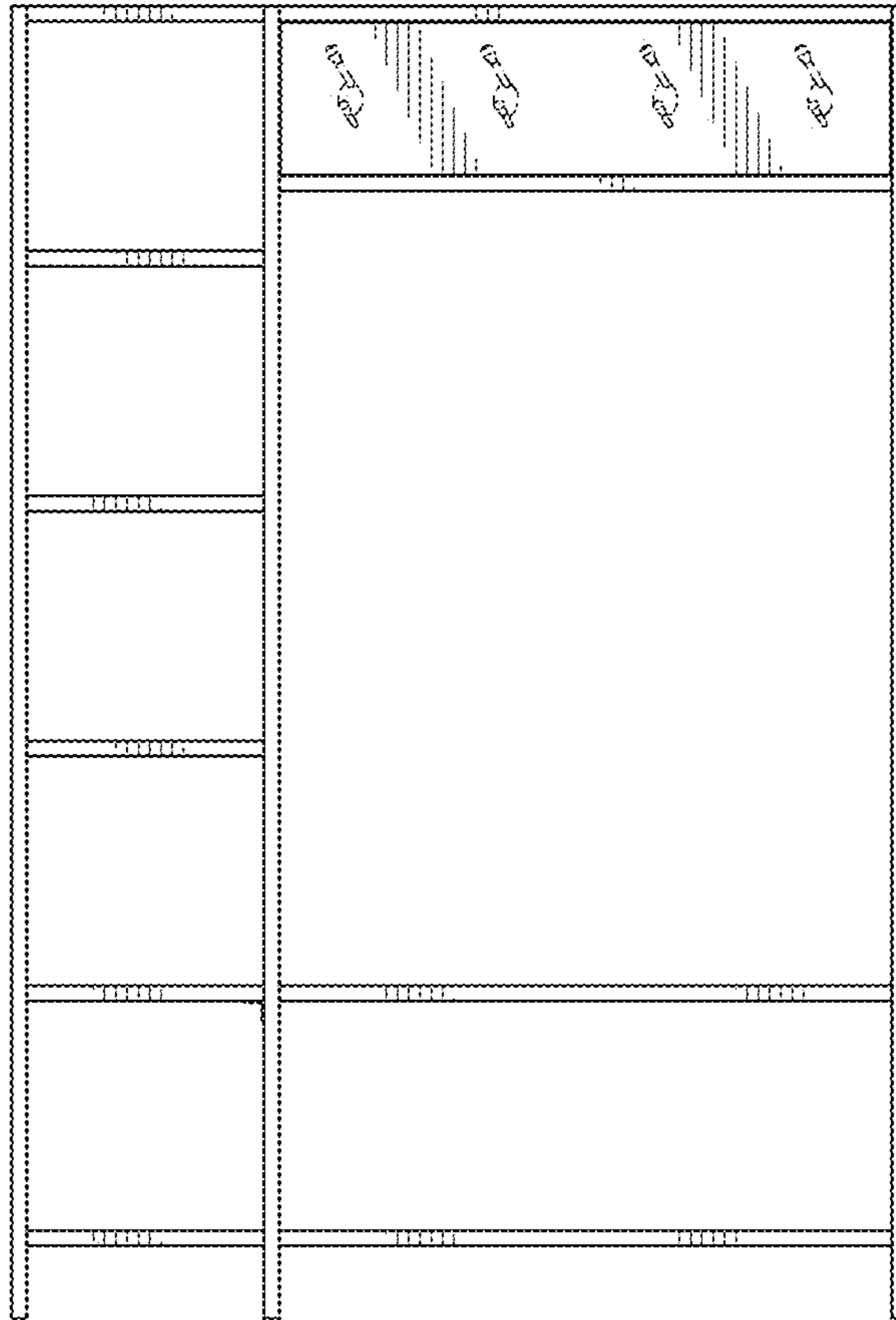
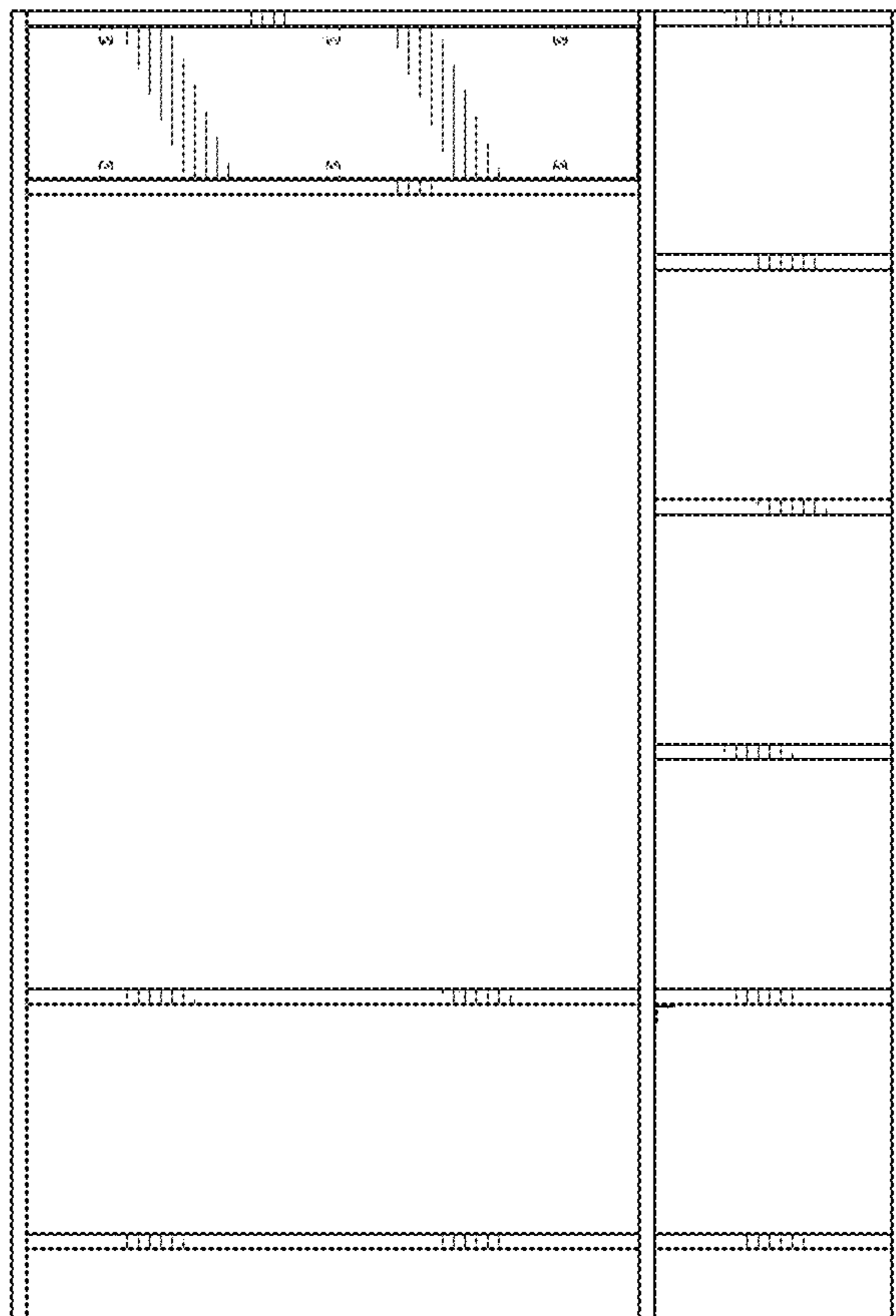

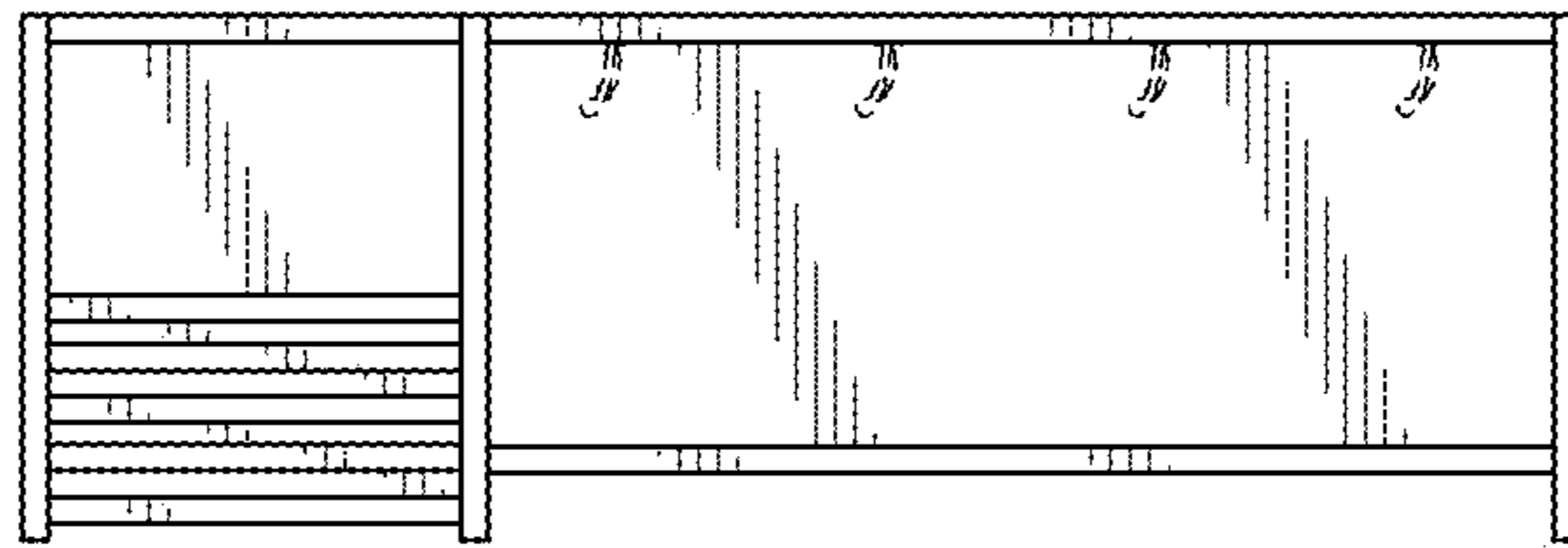

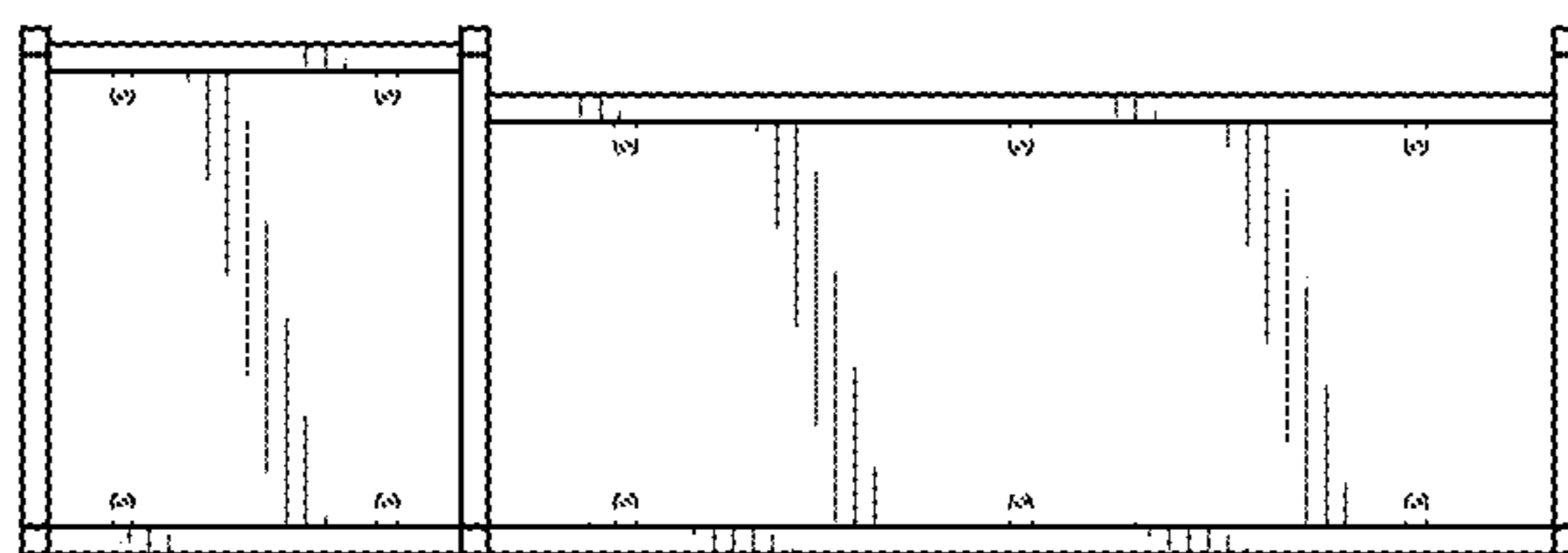

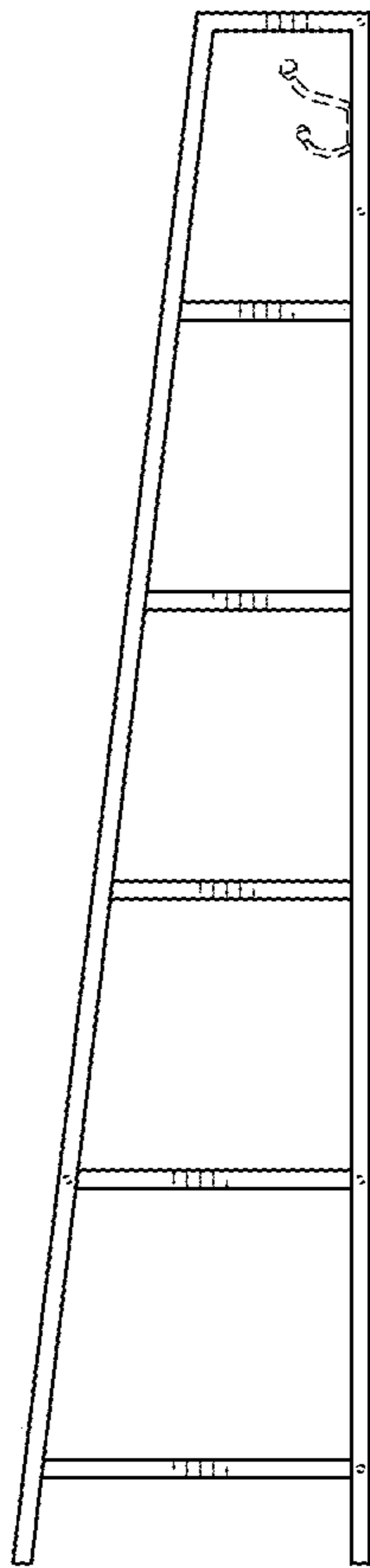

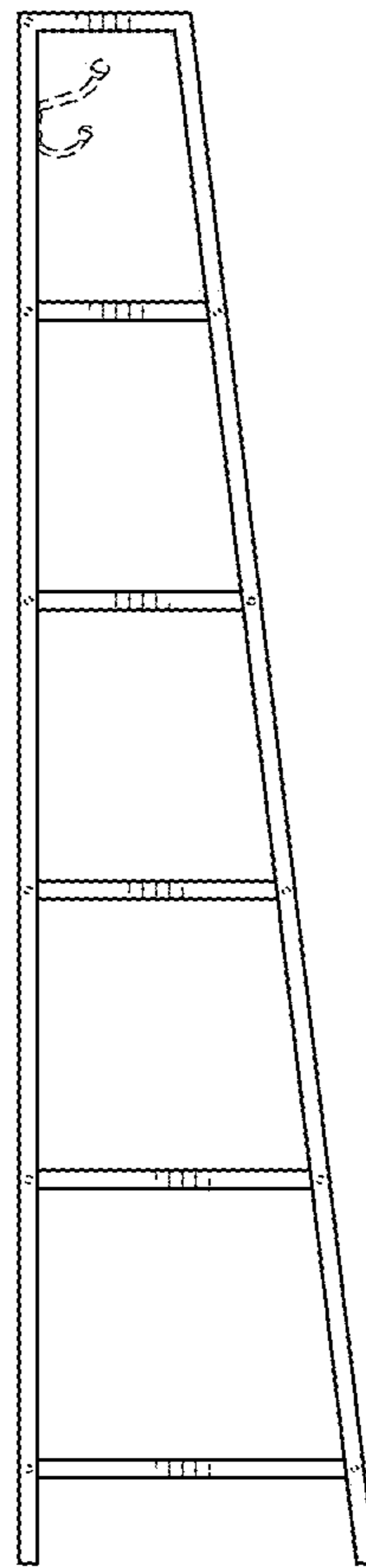

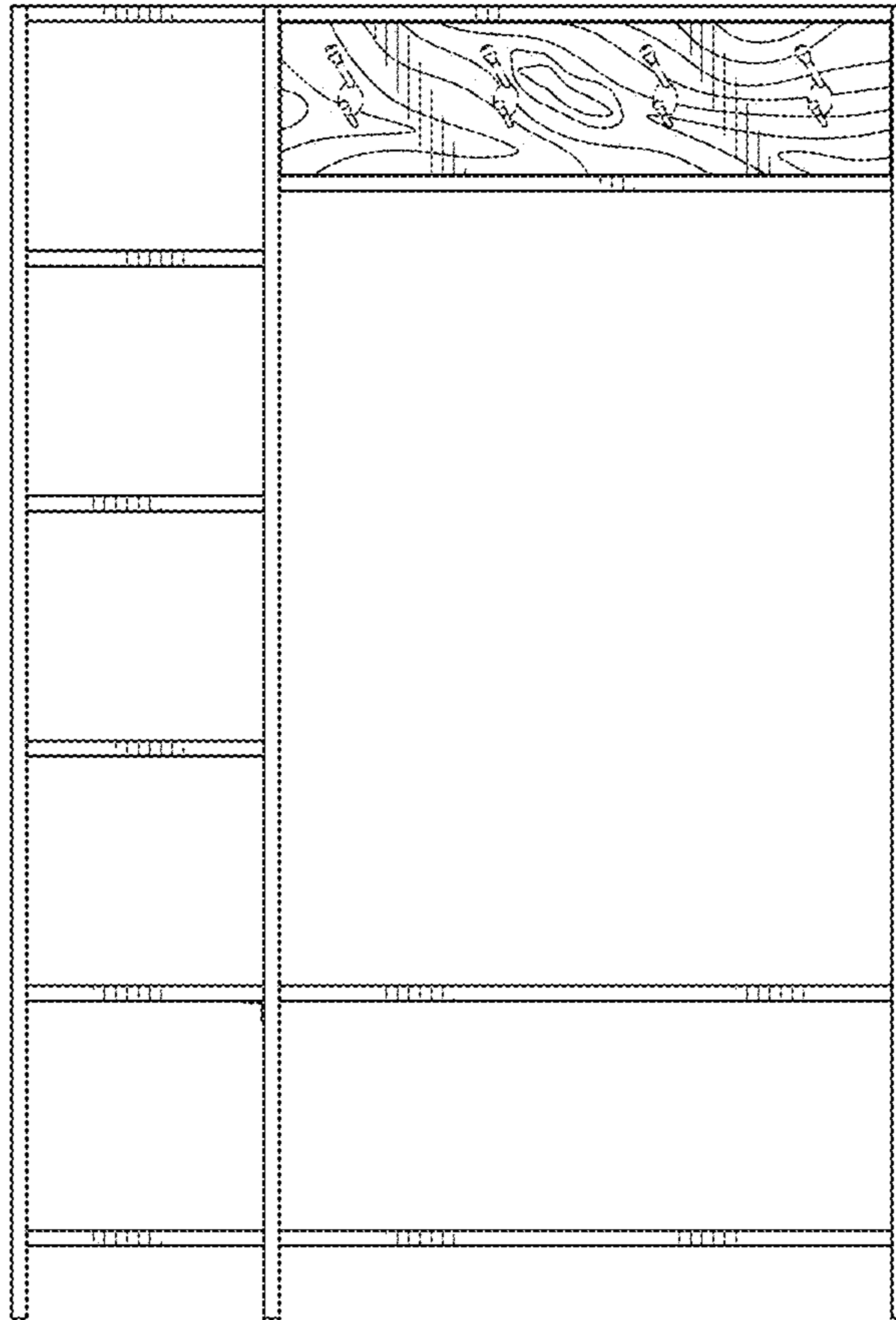
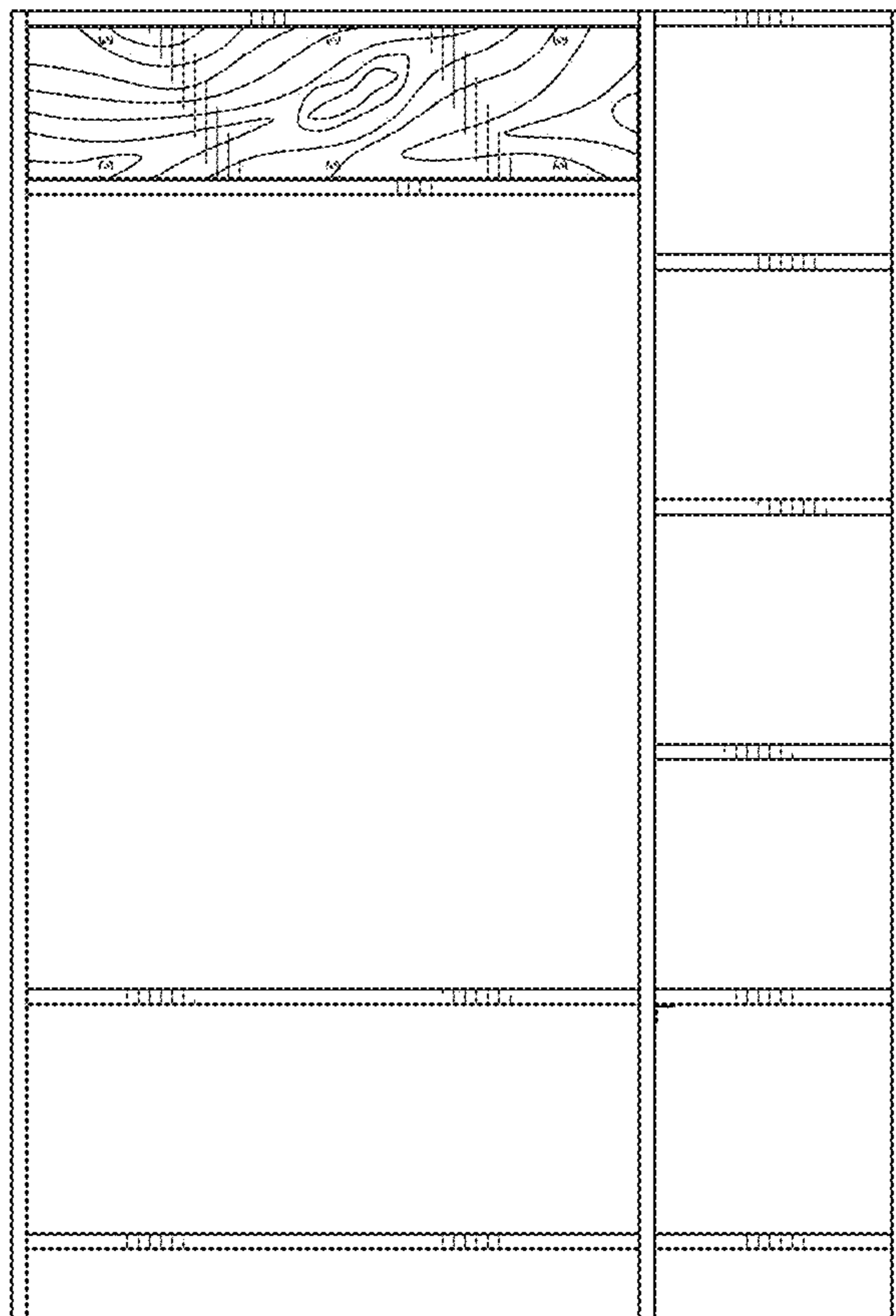

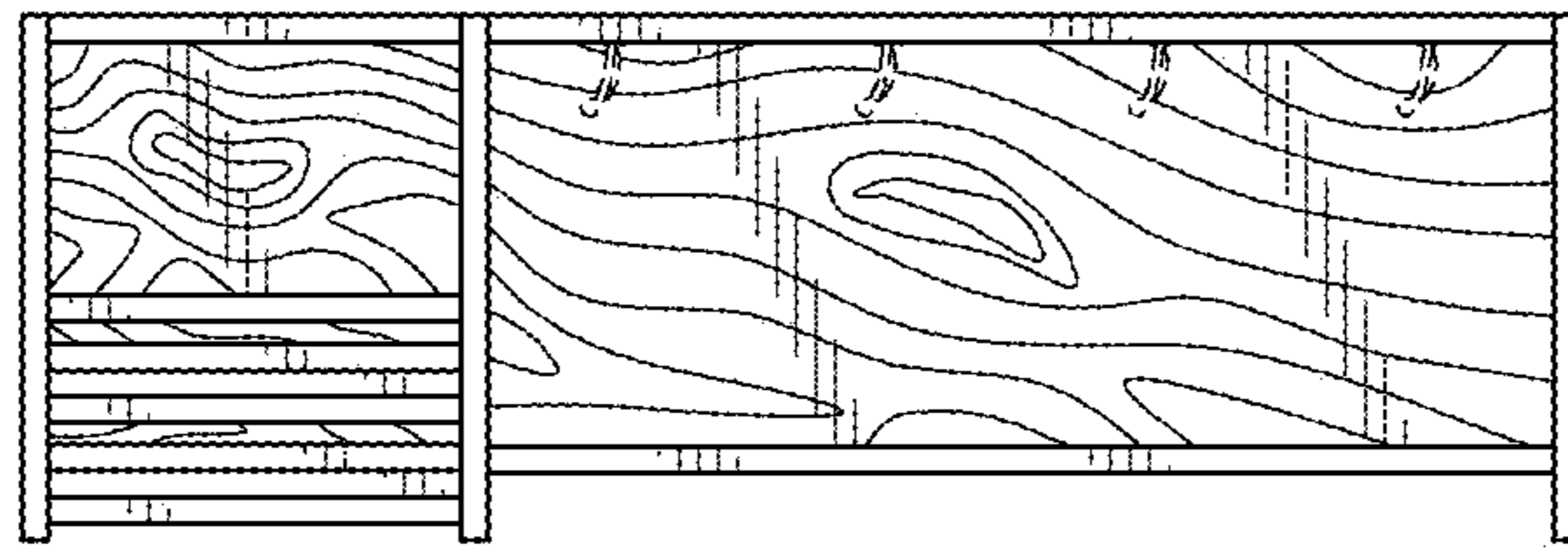

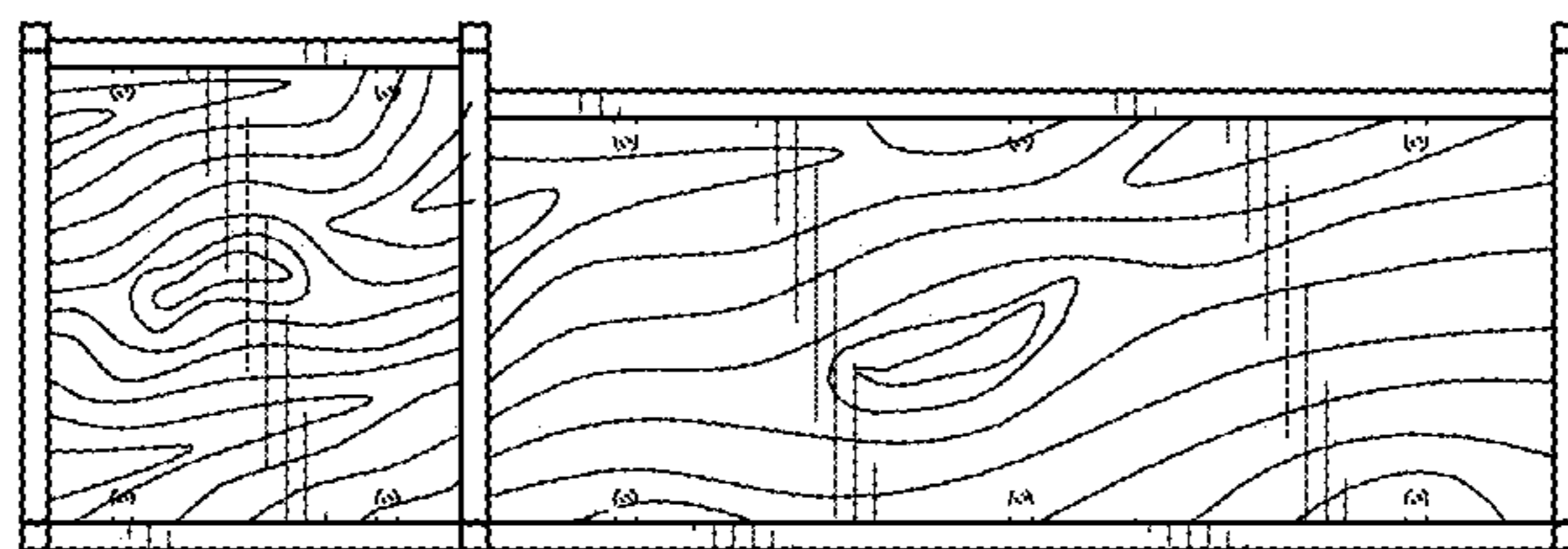

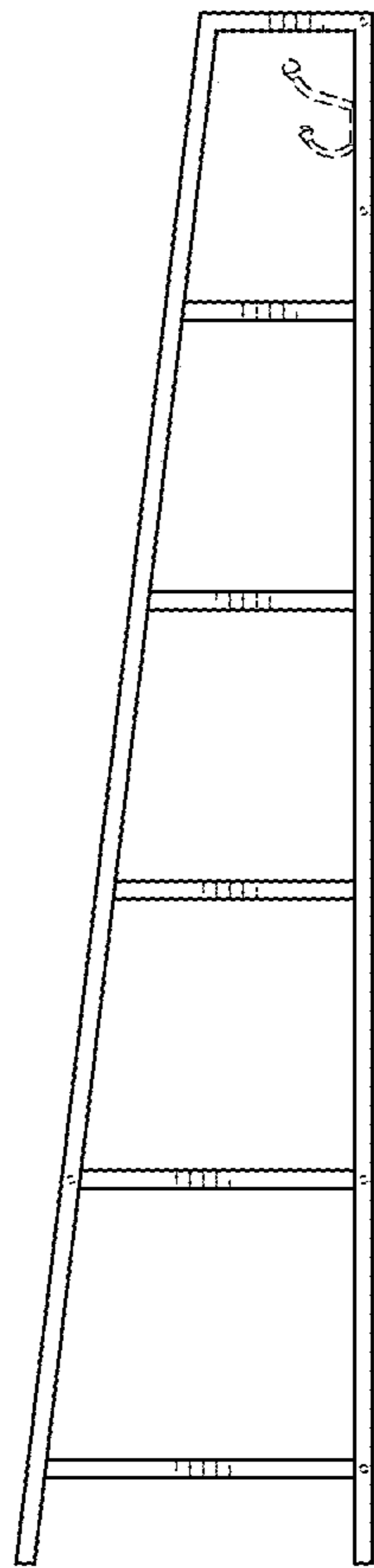

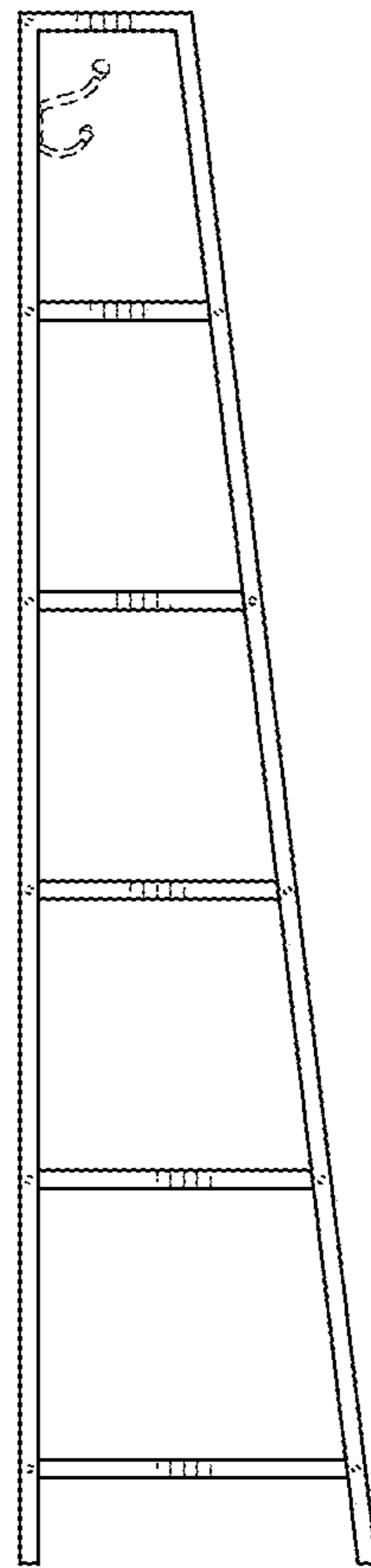
